Downtown Blacksburg had many options to help residents beat the heat at the Solstice Festival from beer and wine to non-alcoholic drinks, like lemonade, to shaved ice and ice cream. For those who worked up an appetite walking through the many

vendor booths, there was food from Cabo Fish Taco, The Cotton Candy Lab, Community Pizza Truck and much more. Downtown Blacksburg Incorporated and their partners ensured there was something for everyone at the Solstice Festival with the Family Fun Zone which housed a water slide, basketball, sun catcher crafts, face painting and multiple inflatables for the young ones to jump around in.





On June 3, 2024, Appalachian Power Company ("APCo" or "Company") filed an application ("Application") with the State Corporation Commission ("Commission") pursuant to § 56-585.1 A 4 of the Code of Virginia ("Code") for approval to implement factors to recover a decrease to its revenue requirement through its transmission rate adjustment clause ("T-RAC"). Pursuant to Code § 56-585.1 A 7, the Commission must issue a final order in this matter not more than three months after the date of filing. In its Application, APCo requests permission to recover a proposed total revenue requirement of \$380.1 million through the

T-RAC for the October 1, 2024 through September 30, 2025 rate year ("Rate Year"). The Company states that its proposed revenue requirement consists of the following: (1) a forecasted Virginia jurisdictional current-period formula rate (current) revenue requirement of \$369.8 million for the Rate Year, based on Federal Energy Regulatory Commission-approved PJM rates for transmission service that went into effect on January 1, 2024; (2) a cumulative Virginia jurisdictional actual under-recovery formula rate balance, through March 2024 (true-up) of \$7.1 million; (3) a forecasted Virginia jurisdictional under-recovery amount of \$0.6 million for the period April 2024 - September 2024 (update); and (4) a forecasted Virginia jurisdictional revenue requirement of \$2.6 million associated with the Business Park Program.

APCo states that its proposed revenue requirement is a decrease of approximately \$33.1 million from the annual T-RAC revenue requirement approved by the Commission in 2023. The Company indicates that its proposed T-RAC rates would decrease the monthly bill for a residential customer using 1,000 kilowatt hours per month by \$2.12.

Interested persons are encouraged to review the Application and supporting documents for the details of these and other

Solar panels on federal buildings should be American made

Although this week's column focuses on a matter that may seem more federal in nature, it highlights the vigilance our Commonwealth must maintain for our state's - and nation's - security.

The federal Department of Energy's "Assisting Federal Facilities with Energy Conservation Technologies" (AFFECT) program recently announced \$104 million in public funds would be devoted to clean energy projects, including installing solar arrays on the Pentagon and other secure military facilities. The announcement did not guarantee the U.S. would use solar panels manufactured in America, utilize American technology, or even use trusted supply chains for the critical minerals necessary to produce the panels. On June 10, Governor Youngkin sent a letter to U.S. Secretary of Defense Lloyd Austin, urging him to ensure that American manufacturers and technology are utilized as the department begins installing solar arrays on these sensitive assets.

Today, the dominant solar companies in the U.S. are Chinese firms with concerning ties to the Chinese Communist Party (CCP). Companies highly influenced or controlled by the CCP dominate the global solar supply chain, accounting for over 80% of global manufacturing capacity. This is underscored by the fact that China controls over 90% of the supply of some critical minerals necessary for solar panel production. The Department of Defense has been cognizant of

the national security risk posed by battery companies linked to or controlled by the CCP. In fact, the National Defense Authorization Act (NDAA) prohibits the department from purchasing batteries from certain Chinese companies and acknowledges the risk posed by energy-producing assets associated with the CCP.

Chinese solar companies are notorious for practicing anti-competitive trade behaviors and preventing American firms from competing on a level playing field. Purchasing goods from CCP-linked firms using public dollars is merely a reward for anticompetitive behavior. Chinese solar companies are also closely linked to human rights abuses of ethnic and religious minorities in China, and they emit more carbon than Americanmade panels due to their supply chain being fueled by coal-fired generation.

Given that Chinese-made solar panel companies have concerning connections to the CCP, combined with the fact that several American solar companies actively

produce these panels on American soil, Governor Youngkin has urged Secretary Austin to purchase U.S. produced panels and avoid creating a direct link between U.S. military installations and companies controlled by the CCP. In addition to the letter to Secretary Austin, Governor Youngkin has taken prompt actions to protect Virginia's economy and security from threats posed by certain CCP-backed companies. In 2023, Governor Youngkin championed legislation – which I supported – to prohibit the sale of Virginia's agricultural land to foreign entities of concern, including CCP-owned companies. Governor Youngkin also made the tough decision to halt an economic development deal that would have given taxpayer dollars to CATL, a CCPbacked battery company. Following the Governor's action, CATL was banned from Department of Defense procurement and Ford halted its partnership with the company. This underscores the Commonwealth's role in helping to safeguard national security.


