## Virginia Tech sixth among all U.S. public schools in new ranking

Virginia Tech ranked sixth among all U.S. public schools and first among all Virginia schools in the 2025 Wall Street Journal/ College Pulse ranking of the U.S. Colleges released

Overall, Virginia Tech landed at No. 19 among all 500 universities included in the ranking that focuses on two key metrics: how much a school improves students' chances of graduating and their future earnings and the overall student experience, according to the Wall Street Journal.

## Blacksburg resident shares family connection to Montgomery County history

BLACKSBURG-Life-long Blacksburg resident, Barbara Surface, 92, recently shared her family's connection to Montgomery County History in Price's Fork.

Surface's grandparents lived in Michael Price's historic home when she was a young girl. On a map published in the Roanoke Times in 1970, Surface marked

Road. The land, Surface explained, was given to Michael Price and his siblings by King George. Price Mountain was included in the land given to them.

Surface remembers, in the original part of the house, there was an opening to go down underground into the original kitchen space and her grandparents explaining that that was where

where the house was on Michael captured British soldiers were Price's land close to Walls Branch held. She remembers a big heavy door under the brick portion of the house with a slot where it was believed they'd pass food to the captured soldiers. In front of that large opening, Surface said, was where William Preston, original owner of Historic Smithfield, died, in front of Michael Price's home, where she grew up.

Blacksburg smoke testing sewer lines

The Town of Blacksburg and CHA Consulting, Inc., will perform smoke testing in the upper Harding Sewershed during the week of Sept. 9 and Sept. 16. The process blows smoke into the sewer system, which then escapes through leaks found in the lines. Leaks allow rainwater, creek water, and other stormwater runoff to enter the system. The area within the Harding Sewershed that will be impacted by this work includes the Apperson Park development and Windsor Hills. During this work, citizens may see smoke coming out of the ground, and occasionally, when household plumbing is not in conformance with code, smoke may enter residences. For this reason, CHA will place informational door hangers at residences that may be affected several days in advance of the testing. ## Virginia gas prices continue to drop

Average gasoline prices in Virginia have fallen 7.0 cents per gallon in the last week, averaging \$3.12/g today, according to GasBuddy's survey of 4,081 stations in Virginia. Prices in Virginia are 23.4 cents per gallon lower than a month ago and stand 43.7 cents per gallon lower than a year ago. The national average price of diesel has declined 4.5 cents in the last week and stands at \$3.62 per gallon- the lowest since early 2022.

According to GasBuddy price reports,

the cheapest station in Virginia was priced at \$2.66/g yesterday while the most expensive was \$3.99/g, a difference of \$1.33/g. The lowest price in the state yesterday was \$2.66/g while the highest was \$3.99/g, a difference of \$1.33/g.

The national average price of gasoline

has fallen 7.2 cents per gallon in the last week, averaging \$3.22/g today. The national average is down 22.5 cents per gallon from a month ago and stands 58.8 cents per gallon lower than a year ago, according to GasBuddy data compiled from more than 11 million weekly price reports covering over 150,000 gas stations across the country.

"Impressively, for the sixth straight week, gas prices have dropped to their lowest since winter. GasBuddy now counts 11 states and over 45,000 stations with gas prices below \$3 per gallon," said Patrick De Haan, head of petroleum analysis at GasBuddy. "We fully expect gas prices will continue to drop as Americans drive less with the onset of fall. With oil prices falling below \$70 per barrel, their lowest since 2021, there's solid room for gas prices and diesel to continue falling for some time. We expect the national average could fall below \$3 per gallon as early as October for the first time since 2021, which would be music to the ears of motorists and certainly to politicians who are angling to be elected this fall."

## Focus on stressed-out parents warranted, important

A recent surgeon general's advisory outlining an urgent need to support increasingly stressed-out parents highlights an important and growing issue, says a Virginia Tech expert.

Rosanna Breaux, a psychologist at Virginia Tech who directs the Child Study Center, said how well parents manage their emotions is crucial for their own parenting experience and for the health of both themselves and their children.

"Parents not only need to stay calm themselves, but they also need to help their children, especially younger ones, manage their emotions," she said.

Breaux said managing parental stress and decreasing emotion dysregulation is an issue that deserves attention and more research.

She noted that programs aimed at helping parents and children are often done separately, with different therapists treating the parent and child. These therapists often don't communicate much with each other due to ethical and practical reasons.

As a mom. Breaux said she

due to ethical and practical reasons.
As a mom, Breaux said she understands parental stress firsthand.

"Navigating postpartum depression, the strong emotions that result from hormonal changes,

and the feelings of uncertainty and helplessness that come with being a new parent, I was certainly overwhelmed at times; especially in trying to find a new work-life balance," she said.

Breaux says there has been growing recognition over the past decade of the need for better interventions that simultaneously consider parent and child mental interventions with specifically targeting parent mental health (e.g., depression, anxiety, attention-deficit/hyperactivity disorder [ADHD]) and emotion dysregulation through therapy or pharmacological treatment. "This is critical, particularly for disorders with high heritability such as ADHD and autism, especially since many parents of children with these neurodevelopmental conditions display both emotion dysregulation and increased risk for a range of psychological disorders."

Breaux explains that this is also important for families of adolescents with personality disorder traits such as borderline personality disorder, which has modest heritability and is often characterized by emotional regulation and challenges in the parent-child relationship.

## Radford cuts ribbon on Artis Center for Adaptive **Innovation and Creativity**

RADFORD - Radford University celebrated the opening of its new Artis Center for Adaptive Innovation and Creativity with a ribbon-cutting and dedication ceremony on Sept. 5, 2024.

The new center, which opened to students at the beginning of the 2024 fall semester, is a stateof-the-art complex that fuses the arts, health sciences and technology in modern teaching environments tailored to stimulate creativity and innovation.

"Students experience will classroom settings that are tailored to their needs, designed for maximum learning and exchange and where they can still find that out-of-the-way nook for a late-night study or a group practice session," Radford University President Bret Danilowicz, Ph.D., said at the Thursday afternoon ceremony. "We are only just beginning to understand the Artis Center's full potential, but the possibilities are endless."

The 178,000 square-feet Artis Center is the largest academic building on Radford's campus, as well as the largest capital construction project in the history the university. The Artis Center is home to the university's College of Visual and Performing Arts and benefits students in the Waldron College of Health and Human Services and the College of Nursing. Additionally, the Artis Center is a destination for regional K-12 school

groups and community members. The Artis Center houses a 500-

seat proscenium theatre, 200-seat studio theatre, a performance hub with learning stairs and a courtyard with an amphitheater.

Educational spaces include a group clinic space with six clinic spaces and observation rooms, a large active-learning classroom for nursing, recording studio, photography and ceramics labs, Maker Space, fashion and interior design studios, active-learning classrooms, dance studios, theatre studios and shops, drawing and painting studios, and music education and music therapy classrooms.

The Artis Center is named for Pat and Nancy Artis, the latter a 1973 Radford University graduate and the recipient of an honorary doctorate in 2021. Pat Artis serves as an educator in Virginia Tech's Department of Aerospace and Ocean Engineering. Pat and Nancy Artis "have

been extraordinary supporters of Radford University in all ways volunteering together on the TOGETHER Campaign Steering Committee, serving as role models to inspire others to both give back and pay it forward, and providing philanthropic funds in support of facilities, student scholarships and more," President Danilowicz said. "Pat and Nancy," the president

continued, "thank you for all you do for Radford University. You are creating a legacy at this institution that will live in perpetuity."

## Delegate laments speed of federal broadband funds to Virginia

In early August, I wrote about the exciting announcement regarding Virginia's expansion of broadband infrastructure in the form of a \$4.2 million grant to Giles County. While the Commonwealth continues to lead the way in how it handles broadband deployment in comparison to peer states, so far, the federal government has not held up to its end of the bargain. This is the troubling news that was recently reported in a Politico article titled "Biden and Harris promised billions for broadband. Here's why states are The issue at hand is the Biden-Harris administration's

handling of the Broadband Equity, Access, and Deployment Program (BEAD), which is slated to provide nearly \$1.5 billion to Virginia in order to complete universal broadband infrastructure buildout. To this point, Virginia has not received any of this funding from the federal government, even though the Commonwealth was the first state in the nation to apply for it almost a year ago. As a refresher, the BEAD program was part of the Biden-Harris administration's infrastructure package that was passed into law several years ago. As part of its passage, states accepting the grant funding have to follow vague rules, such as providers having to "plan for climate change" and

'require reasonable prices," although the administration didn't clearly lay out what these rules actually entailed. Herein lies the heart of the issue; something that other states across the nation have experienced as well. There are electoral ramifications to the ongoing

struggle of the federal government to disburse these desperately needed funds. The Youngkin administration, which has made it a focal point to expand our broadband infrastructure through the Virginia Telecommunications Initiative, is doing its part to bridge the gap until the federal funds arrive. The Biden-Harris administration is making it very easy for Virginia Republicans to make the case that - even in the face of federal government ambivalence – we still find a way to get things done.

It's no secret that Virginia is a national leader in telecommunications, and the United States relies upon our connectivity. We host important defense agencies and the many contractors that support them, as well as corporations with worldwide reach. We are also home to many people, often in rural communities like ours, who are prevented from taking part in the broader economy due to lack of consistent internet access. The lack of access can affect other things closer to home, like property values and educational opportunities. The Biden-Harris administration's failure to deliver this critical funding to the Commonwealth in a timely fashion is beginning to appear like an "over-promise, under-deliver" situation, and in the meantime, over 100,000 Virginia residents and businesses continue to suffer slow connection speeds. They must do better.

### Warner and Kaine announce Virginia cleared a major hurdle to expand broadband Approval of Virginia's initial proposal means \$1.5 billion is headed to Virginia soon

WASHINGTON — U.S. Sens. Mark R. Warner and high-speed internet access to more families and businesses Tim Kaine (both D-VA) have announced a huge step towards the deployment of \$1,481,489,527.87 in federal funding to expand access to high-speed internet in Virginia.

The National Telecommunications and Information Administration (NTIA) approved Volume 2 of Virginia's Initial Proposal under the Broadband Equity, Access, and Deployment (BEAD) Program, an important step that demonstrates Virginia has a strong plan to expand broadband and is on track to receive its funding allocation. 'Today's announcement brings us one step closer to

accessing our historic \$1.5 billion award and expanding

across Virginia," said Sen. Warner. "Virginia has a strong plan to get us closer to universal coverage, and this funding will help make that plan a reality. I'm proud to have authored and negotiated the law that made this possible, and I'm ready to work to make sure it's implemented as quickly and efficiently as possible so more Virginians have access to high-

'Broadband is a necessity for Virginians to access telehealth, online education programs, job opportunities, and so much more. Boosting access to broadband is key to building on our economic progress, which is why I'm happy that the National Telecommunications and Information Administration has approved the next step in Virginia's BEAD program plan," said Sen. Kaine. "I'm glad to have helped pass the Bipartisan Infrastructure Law that made this investment possible." Following the approval, Virginia has one year to submit

a final proposal that will detail how the Commonwealth will ensure service to all unserved locations. Once the final proposal is approved, funds will be deployed and implementation can begin. In June 2023, Sens. Warner and Kaine announced the \$1.5

billion allocation, which was made possible by the BEAD Program in the bipartisan infrastructure law - landmark legislation authored and negotiated by Sen. Warner and

Sen. Kaine. The BEAD Program seeks to expand highspeed internet access by funding planning, infrastructure deployment and adoption programs. Specifically, the funding will be utilized by the Virginia Telecommunication Initiative (VATI) to get Virginians high-speed internet, defined as 100 Megabits/second (Mbps) for downloads and 20 Mbps for uploads. VATI will first prioritize 134,000 unserved locations (those lacking internet service speeds of 25 Mbps for downloads and 3 Mbps for uploads) and then 28,000 underserved locations (those lacking 100 Mbps/20 Mbps upload/download speeds).

Also, through the bipartisan infrastructure law, Sens. Warner and Kaine secured \$65 billion in funding to help deploy broadband and decrease costs associated with connecting to the internet. As part of that funding, Virginia received \$5 million to help make a strategic plan to deploy Sens. Warner and Kaine have long fought to expand

access to broadband in Virginia, including by advocating for the accurate reporting of Virginia's connectivity status. In 2022, Sen. Warner called on Virginians to contact the Federal Communications Commission (FCC) regarding internet coverage in their communities. Following the FCC's reporting deadline, Sen. Warner called attention to a significant number of locations in Virginia that were incorrectly reported on the FCC broadband coverage map.

Through pictures from her grandparents and Surface has documentation stating that entrance under the original portion of the house is where William Preston died. The photo she has reads, "WM Preston died in yard" with the number 795. William Preston did die near Price's Fork due to what is suspected to either have been heat stroke or a heart attack in 1783. Surface explained that the


Price home that her paternal grandparents lived in, was a farm where they milled grain, and raised hogs for meat. She reminisced about playing with her siblings in the old granary by climbing up one side and sliding down the other.

When the home was owned by her family, Surface explained that local community members would come to her grandfather, John Will Shepherd, for cornmeal and flour that they milled as well as meat from the pigs they farmed, to last them through the hard times. Surface explained that the brick portion of the home was built by the enslaved people and the walls were about a foot thick. The brick portion did not have rooms downstairs, but two large rooms upstairs as it was an addition to the original part of the Price home. You had to go down in the

ground," Surface explained, "to get to the old kitchen part. It had a little window, from about two-bytwo-foot wide, under it was a slot that my dad said his dad told him that that's where they could shoot out at 'Indians'.' Surface remembers when they

plowed, they'd turn up arrowheads and flint stones. She remembers her siblings playing with flint stones and creating sparks as children. One of the porches, Surface explained, was not enclosed and the children of her family were not allowed on that porch growing up. Surface's family has since stayed

in the area, but Surface does not live on the property her grandparents once owned. She lives in a home that she and her husband built for 'eighty dollars worth of materials'






