During the Feb. 27 City Council meeting, City Manager Chad Edwards discussed taking over the Hutchinson water system payments with Council members, and he requested permission to open an escrow account for said action.

"I want to do this because Hutchinson is defunct," Edwards said. "The PSC is going to force us to take it... For now, I want to make sure that the money is secure, so it's not floating around out there... Right to pay us for the water we're selling... so that's the situation we are in right now. I know it's not ideal, but we're the heavy hitters in this part of the county, and we're the ones they're going to fall back on."

"I don't want to do it at all. No part of me wants to take over the system," Councilmember Patrick Kovalck said firmly about Shinnston taking over Hutchinson. Others agreed with him and voiced concerns and questions about what this could mean for the city to take on this extra responsibility.

However, Edwards said that if they didn't take over Hutchinson now, he felt certain it would be handed to the city anyway further down the road and wished to take it now under the city's own terms. "So, the plan is, and the PSC okayed this, what we'll do is open a separate account for this, so the moneys don't get mingled until such a time as we are taking over the system. Right now, we'll put that money to the side and the only time we withdraw from it is when we need to pay their bill. So basically, they'll have their own account and we will

this too," Edwards added. "Any improvements (to the water system) we make, such as the meters... there's a type of emergency fund, and this is an emergency... And I'd say there is almost a 100% chance that we will get it, because the PSC is aware that this isn't an ideal situation for us. But the way I look at it personally, if we are going to be a water distributor, then we are going to have to take the good with the bad."

After disagreements and continuing concerns voiced by the Council, Mayor Rodney Strait said that there were still a lot of details with taking over the system that have yet to be decided among other issues; ask upon, and the Council agreed to speak about taking over Hutchinson at a later date after the details had been written out

Another point of interest on the agenda that night was going over the budget for the year. The amount for the rehabilitation of property amounts is set to \$112,000, and Edwards believes that will get the city through the end of the year as they begin work on demolishing dilapidated structures.

Strait also spoke about the reopening of the Sunset Ellis and the ribbon cutting he attended with various Council members. "It was busy," Strait said. "People were enjoying the restaurant being reopened. Give it some time. Service was a little slow, but they got in the works and plans new people."

Testing also took place by the Council that night for the soon-tobe-released new online system that citizens will be able to access from their cellular device. This system will be used to report problems with trash, utilities, and roads,

questions; and allow locals to receive important notifications from the city. This will be available to access and use 24/7, as well as keep a continual record of issues being reported. The automated system will read citizens' texts and send reports to Edwards, who will mainly be managing the program.

Upon the release of the system, Edwards plans to hold a training at the library for those curious about how to use it.

The state auditor is coming to Shinnston with a team to audit the last four years and plans to have it complete by March 31. "They can find things we did wrong so we can fix them," Edwards said. "I'm happy about it."

The parking lot was closed in mid-February after Division of Highways officials learned initially that it lacked a permit and upon further review, that work had paved over sidewalk access.

City officials have received instruction from state transportation officials on how to meet state standards for road and sidewalk access at the closed parking area between Casey's and Main Street, which has been closed since mid-February and affecting local businesses. They hope to make the required changes to the parking area by St. Patrick's Day.

After a meeting with the West Virginia Division of Highways last week, city officials promised they will do whatever it takes to get the parking lot along Main Street re-open

for the community. "I want this to be done by the St. Patrick's Day parade. Clock's ticking," City Manager, Chad Edwards, said confidently at the Shinnston City Council meeting Feb 27.

Upon the closing of the parking lot, small business owners in the city feared how losing the parking would affect them. Options available for utility bill assistance

Sadly, many people in West Virginia have a hard time making ends meet. Utility bills are a necessity that everyone must fit into the budget If you struggle, there are resources that can help.

One of the first things to consider is budget billing. Many utilities offer this as a way to avoid sharp spikes or dips in your bill from month to month. Knowing how much your bill will be each month makes it easier to plan your budget.

If you receive financial assistance through the Department of Health and Human Resources, you may qualify for a 20% discount on your heating and water bills. The Special Reduced Residential Service Rate Program is administered by DHHR and is available from all natural gas and electric utilities, except municipal or cooperative service providers. West Virginia American Water also participates in the program.

If you receive assistance from Social Security Supplemental Security Income, WV WORKS, Temporary Aid to Needy Families, or if you are at least 60 years old and receive Supplemental Nutrition Assistance Program assistance, ask DHHR if you qualify for the utility discount program.

Another source of possible assistance is United Way's 211 program. Simply dial 2-1-1 to get contact information for agencies throughout the state that can help with utility bills and other household needs.

If you fall behind on utility bills, ask your utility about a deferred payment plan. The Public Service Commission requires that customers who have been notified their service is scheduled to be terminated for non-payment be given an opportunity to enter into a deferred payment agreement. Customers who have accrued an uncontested outstanding balance they are unable to pay may qualify for a deferred payment plan that allows them up to 12 months to catch up on their bill. However, you must request the plan before the utility discontinues your service, and current monthly bills must be paid in addition to the plan amount. Once service is disconnected the company is not required to honor the request

This Week in West Virginia History

The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www. wvencyclopedia.org.

March 9, 1832: George Robert Latham was born. At the onset of the Civil War, Latham turned his Grafton law office into a recruiting station, and he led the first Union troops in North Central West Virginia.

March 9, 1953: Football player Dennis Harrah was born in South Charleston. In the NFL, Harrah played in 168 games for the Los Angeles Rams (1975-87), was a six-time All Pro, and played in one Super Bowl.

March 9, 1965: President Lyndon Johnson signed the act establishing the Appalachian Regional Commission.

March 10, 1915: West Virginia's first Rotary International club was established in Wheeling.

March 10, 1920: West Virginia became the 34th state to ratify the 19th Amendment to the U.S. Constitution, which guaranteed the right of women to vote.

March 11, 1847: Boone County was formed from parts of Logan, Kanawha and Cabell counties and named for Daniel Boone.

March 11, 1848: Putnam County was formed

from portions of Kanawha, Mason and Cabell counties. It was named in honor of Gen. Israel Putnam, a leading commander at the Battle of Bunker Hill during the Revolutionary War.

March 11, 1856: Roane County was created from parts of Kanawha, Jackson and Gilmer counties. It was named for Judge Spencer Roane, a son-in-law of Patrick Henry.

March 12, 1835: Marshall County was created from part of Ohio County. It was named for John Marshall, chief justice of the U.S. Supreme Court.

March 12, 1850: Wheeling Hospital was chartered. During the Civil War, the institution was used as a general military hospital. The Sisters of Saint Joseph were hired as army nurses, treating wounded Union and Confederate soldiers side by side.

March 13, 2002: Herbalist and folk doctor Catfish Gray died in Huntington. Gray was known for his vast knowledge of traditional plant lore and for his quaint and engaging personality. At the height of the folklore revival of the 1970s, Gray was a frequent newspaper and television interview subject.

March 14, 1931: Noting the interest in the annual reunion of Carnifex Ferry battle veterans from the Civil War, the Legislature created the Carnifex Ferry Battlefield Park Commission.

March 15, 1882: Union leader Frank Keeney was born on Cabin Creek, Kanawha County. Keeney, who went to work in the mines as a boy, became a rank-and-file leader during the Paint Creek-Cabin Creek Strike of 1912–13.

March 15, 1952: Governor Earl Ray Tomblin was born in Logan County. He was elected as a Democrat from Logan County to the House of Delegates in 1974, when he was only 22 years old and still a senior at West Virginia University.


Gerald Parado of Lincoln High School made it to competing in the state wrestling tournament Thursday-Saturday.

Outdoor recreation expected to spike with warm weather



So far, this area is pretty fortunate as the winter months have been very kind. Yes, we have had some cold mornings but overall, we have had less than 5" of snow during the period. And as we approach spring, most have taken advantage of the warmer weather doing some outdoor activities.

Jack Cann, recreation specialist here at the Rec Complex, noticed that the parks are starting to fill up a little more than usual mostly due to the increased temperatures here as of late. "The parks have been quite busy over the past week due to the warmer weather. It is great seeing the families come and use the facilities to get some exercise and enjoy the outdoor activities that we offer here at our facility," said Cann.

Recreation does seem to increase during the warmer months. Longer days and warmer weather draw people from the confines of the TV room and allows for some form of exercise. Parks with

multiple purpose resources are those that seem to attract those wanting to get the ball rolling before the summer comes. A walking area, playground, sports zone or other areas used for recreation can give families options on things to do.

At the Recreation Complex, located on U.S. Route 19 South just outside of Clarksburg, the multiple activities offered allows Cann to believe that while there are other avenues we should enter, we still have a great product at that particular area. "While the building itself is used for our enrichment and rental opportunities, the grounds itself has the offerings of a 9-hole disc golf course, an ADA compliant playground area with outdoor facilities to host events, a beach volleyball court as well as a walking trail that allows those wanting to take a hike but still be close to civilization," he said.

Now, there are those who take advantage of recreation all season long. The Bridge Sports Complex in Bridgeport has been very busy this winter for those who go to walk the track, get in a workout, play basketball or even get in a few games of pickleball, one of the fastest growing games nationwide. The opportunity to have access to outdoor activities but in an indoor arena allows those who choose to have activities all year-round.

"The ability to get out and spend family time during the winter was somewhat limited," said Director Mike Book. "There was the YMCA where you could do plenty of activities and today you have the Bridge off Saltwell road. The motivation to go and do some activities are harder in the winter months than in the spring or summer. The idea of some bright sun on your face and getting vitamin D seems to draw more people to do outdoor stuff compared to being inside doing similar activities."

With spring and daylight saving time right around the bend, we will continue to see the increase from indoor to outdoor activities, which strategically bodes well for the parks enrichment program, Walking with Dinosaurs. You see, the later dates allows for kids to get some outdoor recreation on days with good weather. The kids can explore the exhibit during the morning, have lunch and then spend some time on the playground that includes a Dino Yard with dinosaur themed playground equipment.

"Again, it is great to see the families come and take advantage of the warmer climate," said Cann. "We have a nice piece of property here and when the weather is right, the proof is in the amount of use at the park."

Hope Scholarship application period opens

State Treasurer Riley Moore announced, in a press release, that applications to use the Hope Scholarship education savings account program for the upcoming 2023-2024 school year that starts this fall are now available online.

Applications are available online at www.HopeScholarshipWV.com. The application period will remain open from March 1 through May 15.

"We're excited to announce applications to use the Hope Scholarship are now open," Treasurer Moore said. "We saw tremendous interest in this program for the current school year, despite unfortunate legal delays in the program's implementation. We look forward to providing this program for the full school year that begins this fall."

The Hope Scholarship is an education savings account program available for kindergarten through 12th grade students. It is designed to allow parents and families to use the state portion of their child's education funding to tailor an individualized learning experience that works best for their child.

To qualify for the Hope Scholarship, a student must be a West Virginia resident and be either:

Eligible to be enrolled in a kindergarten program.

Enrolled full-time in a public elementary or secondary school program in this state for the entire instructional term during the current academic year (2022-2023) immediately preceding the academic year for which the student is applying to participate in the Hope Scholarship Program.

Or, enrolled full-time and attending a public elementary or secondary school program in this state for at least 45 calendar days during an instructional term at the time of application.

In addition to filling out the application, state law also requires participating families to fill out a notice of intent to participate in the program with their local county superintendent. A sample template for that notice is also available online at HopeScholarshipWV.com.

Important Note: Should the Legislature pass any reforms, the Hope Scholarship Board would provide updates on the program once those changes are enacted and take effect.

Burning restrictions return

The start of West Virginia's annual spring fire season on March 1 marked the return of burning restrictions. In a news release, the West Virginia Division of Forestry (WV DOF) reminds residents to confine their outdoor burning to the hours of 5 p.m. to 7 a.m. due to state law. Fires set during that time must be put out before 7 a.m.

"Since January 1 we have responded to 162 fires that have burned approximately 1144.1 acres. Even though it seems that we have had some wet weather leading up to our spring fire season I would like to remind everyone that it doesn't take much sun and wind to dry out our fine fuels that allow fires to spread rapidly," said Assistant State Forester-Fire Jeremy Jones, WV DOF.

Jones said more than 99 percent of wildfires in West Virginia are caused by people and that burning debris accounts for 35 percent of all wildfires during the past 10 years.

Statewide burning restrictions will remain in effect until the close of the spring fire season on May 31. The Division of Forestry has issued burning guidelines. Regulations include:

• All fires must have a ring or safety strip.

• The safety strip itself must be cleared of burnable material and be at least 10 feet wide.

• Any fire must be attended until completely extinguished.

Multiple pets, large pets? No problem.

• Spark-throwing machinery such as power shovels or sawmills operating on land subject to fire must contain an adequate spark arrestor.

• Inflammable waste disposal areas must annually remove all grass, brush, debris, and other inflammable material adjacent to disposal areas to provide adequate protection, preventing the escape of fire to adjacent lands.

"Our fire laws protect one of West Virginia's most valuable resources: our forests," Jones said. "We urge everyone who burns anything outside to be completely familiar with the guidelines available on our website."

Commercial burning during prohibited periods requires a permit, which are issued by local Wv DOF offices. permit is required for each commercial burning site.

Any person or company who causes a fire on any grass or forest land must reimburse the state for costs to suppress the fire. Fines for forest fires caused by negligence range from \$100 to \$1,000 with an additional civil penalty of \$200.
