Epic dreams and epic efforts can bring epic results, especially when motivated students get involved.

Last spring, Julie Yearego, a teacher at Lincoln High School, received encouragement from the West Virginia Department of Education to have her students participate in the EPIC tourism grant, a program of the WVDE and the West Virginia Department of Tourism.

This fall, they received word that their \$15,000 grant application was acfor larger and more visible Fork River. They also "met bring improvements to lo-

signage, especially at the and received input from" boat ramp. Money will also support the hosting of "multiple events utilizing rail and water trails." The City of Shinnston and Harrison Rail Trails will support the project by providing in-kind labor.

Yearego shared that her students sought out participation and partnership from a number of local and county officials and organizations. Chad Edwards, Shinnston City Manager, talked to the students and answered questions about the process.

Students engaged with

Kent Spellman, co-chair of the Harrison Rail Trails. Just as any other grant applicants, they put together a detailed request and also obtained letters of support. The request was based in part on surveys of local businesses engaged in tourism. Yearego said they "imparted that information into our request."

EPIC stands for "Economic Projects Impacting Communities." According to the WVDE, it requires "partnering with local businesses and other community organizacepted. The funds will pay the Guardians of the West tions." Although the results

cal communities, WVDE emphasizes that "the goal of the competition is to enhance students' technical skills and creativity while making an impact in their local community."

As Yearego explained, students learned a great deal about their community and the processes that go into improvements. She said that "a lot of people didn't even know it (the trail system) exists, even the students." Now they have an awareness of "underutilized resources" that when improved and publicized, can help draw in tourists.

Lincoln High School and Shinnston join a list of communities that have already benefited from the EPIC grant project. Moorefield High School in Hardy County used EPIC funds to "transform a vacant lot located beside the high school into an attractive commercial area by creating a vibrant and sustainable micro-business complex." The first two businesses will be a micro-cafe and a micro-agriculture market.

Also, the Roane-Jackson Technical Center, in conjunction with the offices of the mayors of Ripley and Spencer, will work together to improve local parks.

Harrison County Commission Supports VFW Parade, Fort New Salem Events

On Oct 4, the Harrison County Commission met at 9 AM. They opened with the Lords' Prayer, then the Pledge of Allegiance, before setting to work.

After Susan Thomas, Harrison County Commission president, started the meeting, they heard from a representative of the Meuse-Argonne Post 573 of the Veterans of Foreign Wars. Richard Iaquinta, Parade Chairman, rose to speak.

Iaquinta shared that the post would hold a veterans' parade on November 10, the Friday before the 11th and that the organization requested \$2,500 to support its efforts. He explained that "we're all setting up. We'll provide meals for veterans and anyone associated with the parade."

Funds would also help to replace the flags along the parade route that have aged.

Before Iaquinta could finish, the commission quickly made a motion and approved his request. He responded with "Thank you very much, We appreciate that."

Next, a representative from the Fort New Salem Foundation appeared to request support from the commission. Dr. Joseph Audia, board chair said "thank you for allowing us to come and talk this morning."

He described how the pandemic had shut down a flourishing public program that attracted many and helped the foundation to raise funds over the years. The most significant program was what the Spirit of Christmas event.

In 2019, the foundation said of its event "journey with us back in time to Christmas in the Appalachian frontier of the mid- 19th century. Festivities feature music provided by area choirs, dulcimer music, gifts for sale, weaving, spinning, printing, spoon carving, potting, blacksmithing, open hearth

Tips for Energy Efficiency Day

Last week, we celebrated Energy Efficiency Day. Here at the Public Service Commission, we want to helpyou find ways to save energy every day. Before we can begin to practice energy efficiency, we need to understand the ways we use energy. And that has seen some changes in recent years.

Are you the happy owner of an electric vehicle? Do you still have Mom's microwave? Are you saving money by cooking more meals at home rather than dining out or ordering in? These are all things that can increase your utility bills.

The switch to an electric car can bring a big surprise. The dollars you once spent at the gas pump will now show up on your higher electric bill. Some people forget to factor that in when considering that choice.

The age of an appliance can make a difference in the amount and duration of power it draws. Newer, more energy efficient models can bring significant savings, and will even pay for themselves over time.

It is difficult to quantify exactly, but people have been spending more time at home since 2020. Since the COVID-19 epidemic, many Americans choose to dine in and entertain at home.


Here are a few things that I found out by looking for ways to cut costs.

Air conditioning and heating generally are the highest energy cost factors in a home, according to a report by Direct Energy. The same group says lighting accounts for an average nine percent of household energy costs.


Forbes magazine, quoting figures from the Environmental Protection Agency, says it costs \$500 to \$600 a year to fuel the 10 most efficient electric cars. That's based on the cost to drive 15,000 miles annually in combined city and highway use. By the way, Forbes also says it is cheaper to charge your vehicle at home than at public charging stations.

The U.S. Department of Energy's website at https://energy.gov has an energy saver page that lets you calculate your annual electricity consumption and costs, and has loads of ideas for conserving resources. It suggests a whole-house energy monitoring system for detailed information on your home's energy use. You'll also find seasonal energy saving tips on the Public Service Commission's website at www.psc.state.wv.us. I hope these ideas will help you make your home more energy efficient.

This Week in West Virginia History

Charleston WV – The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

Oct. 12, 1877: Howard Mason Gore was born in Harrison County. He served as U.S. secretary of agriculture and the 14th governor of West Virginia.

Oct. 12, 2020: Actress Conchata Ferrell died. Born in Loudendale, Kanawha County, Ferrell was best known as Berta the housekeeper on the CBS sitcom Two and a Half Men. She enjoyed a long career on stage, film and television.

Oct. 13, 1863: The Battle of Bulltown took place. The location was valuable during the Civil War because the Weston & Gauley Bridge Turnpike crossed the Little Kanawha River on a covered bridge at this site.

Oct. 14, 1947: In a Bell X-1 rocket airplane dropped from a B-29 bomber, Chuck Yeager broke the sound barrier by flying 700 miles per hour. He set another speed record on December 12, 1953, by flying two-and-a-half times the speed of sound in a Bell X-1A.

Oct. 14, 1949: WSAZ-TV went on the air on channel 5. Early shows included the first telecast of a Marshall College (now University) basketball game on December 3, 1949.

Oct. 14, 1985: Kanawha Airport was renamed Yeager Airport in honor of Chuck Yeager.

Oct. 15, 1839: Aretas Brooks Fleming was born in Fairmont. In 1888, Fleming won the Democratic nomination for governor and then won West Virginia's most controversial gubernatorial election.

Oct. 16, 1859: John Brown and his raiders captured the arsenal at Harpers Ferry, but they were

soon besieged by local militia and federal troops. The raid galvanized the nation, further alienating North and South and drastically reducing any possible middle ground for compromise.

Oct. 16, 1922: The Rev. Leon Sullivan was born in Charleston. In 1977, Sullivan initiated the original Sullivan Principles, a code of conduct for companies operating in South Africa. The Principles were among the most effective efforts to end the system of apartheid.

Oct. 17, 1859: Heyward Shepherd, a free African-American, was killed by John Brown's raiders at Harpers Ferry. Shepherd was a porter at the local railroad station and a property owner in nearby Winchester, Virginia.


Oct. 18, 1941: William "Billy" Cox was born in Wheeling. He is one of two bassists to have played regularly with legendary guitarist Jimi Hendrix.

The entrance takes your breath away as you see an impressive row of marble pillars highlighting the entrance. The hallways were all made of marble and a large stained-glass dome is above you as you check in. The young lady said, "Welcome to the


Driskill; have you ever stayed here before?" I told her no, and was looking forward to my visit. She was telling me about the amenities at the hotel and pointed out the health club, the restaurants, and the café.

As I made my way to the elevator, it was surprisingly small, and reminded me of hotels that I had stayed in Europe. I press my floor, and when I arrived on the fifth floor, which was the top floor of the hotel, I stepped out and it felt like I was stepping back in history. It reminded me of a museum, with works of art, lining the hallways.

When I went in the room, it was actually a kingsized suite and there was an outer room, which had a desk and a sofa, and I looked up in the ceiling that was probably 20 feet high. I entered the bedroom, and it was stunning. The bed, the furnishings, all the accessories seemed like works of art. I set my bags down and looked around and was fully impressed by the beauty of this hotel room. Each morning, I would go down to the coffee shop and bakery and it was like coming out of a movie in the 1920s or 30s. The café had fresh pastries and hot coffee and was delicious. It reminded me of a Paris café, and I sat back and took in the atmosphere. The service was very good, and the waitresses would come over and were friendly and outgoing. On the first evening when I returned to the hotel, after a long day at the conference center I decided to just sit in one of the plush chairs in the lobby and watch the people coming and going.

Although it was a short stay, I made a mental note that I wanted to come back to this impressive hotel and bring my wife along to enjoy a long weekend. If you are ever in Austin, Texas, the Driskill is worth a visit to see what life was like many years ago.



Lincoln, Bridgeport, and Liberty **Claim Impressive Wins**



Just past the halfway point of the high school football season, a trio of Harrison County teams nedy Award hopeful, Gage Wright. The Tribe collected blow out wins. The Cougars, Indians, and Mountaineers outscored their opponents 152 to 39. These squads are a combined 16 and four on the campaign and find themselves deep in the playoff hunt.

Lincoln looked rather impressive on paper, and after broadcasting their lock-up this past Friday with Robert C. Byrd, can attest that they are every bit as good as advertised. The Cougars are a very talented and well coached team that has all of the 37-yard scoring play. tools needed to make a deep run in the Class AA playoffs.

Lincoln cashed in their frequent flier miles and went to the air early and often. Quarterback A. J. Bart piloted his team to five trips to the endzone, tossing more touchdowns than incompletions in the affair. Bart was 18 of 22 for 279 yards. I have never been much of a Nostradamus kind of guy, but I have a prediction concerning the sophomore signal caller. If Bart continues to develop throughout the remainder of his high school career, we could be watching one of the best quarterbacks to come out of Harrison County. Bart has the arm strength to make any throw, and the touch over the top on deep passes gives him the complete arsenal.

Seven different players caught passes from Bart. Brayden Edgell had six receptions for 133 yards and three touchdowns. Noah Sears caught three balls, including a 19-yard touchdown. Maddox Perine joined the touchdown party with a 28-yard scoring reception.

Defensively, the Cougars limited the Flying Eagles to three first downs after the initial drive. The stoppers would not allow a single yard in through the air and no points versus the starting unit. Spe-

cial teams were special as well. Kicker Liam Gallagher was a perfect six of six on extra points. Edgell finished the scoring for Lincoln on a 55-yard punt return in the fourth quarter.

The win moved the Cougars to five and two on the year and they earn the week off. Robert C. Byrd will travel to Phillip Barbour this week.

The Indians hosted Parkersburg South and Kenslowed Wright, holding the standout in check while putting on a rushing clinic en route to a 45 to 15 win.

Bridgeport's Zach Rohrig earned a game-high 178 yards on 27 carries. Rohrig also had a hat trick, scoring three times in this epic battle of Class AAA powerhouses. Jack Spatafore provided a passing punch, going three of four for 139 passing yards. Spatafore connected with Donovan Williams on a

The Tribe would punt just once in the match-up and rolled up a staggering 521 yards on the ground. The Indians moved to five and one and host Preston this week.

The Mountaineers played host to Berkeley Springs asd came away with a 62 to 20 victory this past Friday. Liberty head coach A. J. 

cooking, Belsnickeling and a traditional tree lighting with our grand processional."

The 2019 program set a record for attendance, but the foundation did not hold an event in either 2020 or 2021. It opened on a limited basis in 2022, but a full slate of programs reappeared this year along with school tours.

Audia explained that "shuttle buses are a big help" in making the event a success. With limited parking on site, Salem University allowed the use of one of its lots. Walking that distance, however, could prove a strain for seniors and families with small children.

Thomas said "it's a nice event. I've been there."

Audia presented a request for \$4,800 to pay for the shuttle buses. Commissioner David Hinkle responded by making a motion to give \$5,000, which the commission quickly approved.

The last item discussed was the previous meeting's presentation by Bearing Advisors.

Thomas stated that Bearing still had outstanding claims they had not yet paid and also that "we have employees who think they are covered." Laura Pysz, county administrator, said that county elected officials needed to be informed of the situation. Patsy Trescot, county commissioner, followed by saying "we need employees to know that we are not participating in coverage . . . that we do not have any participation whatsoever."

Thomas explained that "we have never paid any premiums to the company" and none were collected. Additionally, Bearing told one claimant that they had to pay \$1,000 of back premiums to get their claim paid.

Trescot added "don't let someone think there is money coming that is not."

Hinkle followed with "I want to go on the record as supporting what Mr. Trescot says."

Trescot also stated that the county does offer other benefit plans.

For centuries, cultures have seen Friday the 13 as an ill-starred day. From the Friday October 13th, 1307 arrest and suppression of the Knights Templar in France to the much more recent fictional tales surrounding mayhem at a place called Crystal Lake, people often regard the date with fear, or at least discomfort.

And now a group of Shinnston High School students will bring good, if somewhat spooky, doings to the day in Shinnston this year.

This is the first time that students are putting on a Halloween event on the rail trail. They are working under the name EPIC Tourism Grant Executive

crowds and even the children were crying out, "Hosanna to the Son of David" which caused the chief priests and scribes to be "indignant" (Mt 21:15). Additionally, Jesus cleansed the temple area of money changers and those who had made it into a marketplace, cutting off their monetary benefits from such a setup. Jesus took advantage of the occasion to communicate the central message: be faithful stewards of the souls under your care. This is the setup for Jesus' parable of the tenants.

The chief priests and the scribes have been given the stewardship of the vineyard full of souls that have been loved into being. God, the landowner, had cared for his vineyard with much attention: He had put "a hedge around it, dug a wine press in it, and built a tower" (Mt 21:33). Jerome interprets the hedge as holy angels to guard what is within; Hilary explains that the wine press is the prophets who proclaim the Word of God through the Spirit to produce a new wine; Jerome describes the tower as the Temple where the presence of God hovers over them. Instead of continuing the loving cultivation started by the landowner, the chief priests and scribes took advantage of their office for personal gains, taking out anyone who had been sent by the landowner to obtain a harvest; "one they beat, another they killed, and a third they stoned" (Mt 21:35). These produced no fruit and prevented others from taking on this responsibility. Jerome was precise in naming the victims of their actions: "Beat them, as Jeremiah, killed them, as Isaiah, stoned them, as Naboth and Zacharias, whom they slew between the temple and the altar." God, in his patience sent other servants, but they "treated them in the same way" (Mt 21:36). The landowner, exasperated by their hardness of heart, sent his son, thinking, "They will respect my son" (Mt 21:37). But they seized him, threw him out of the vineyard and killed him. Jesus then asks them, "What will the owner of the vineyard do to those tenants when he comes?" (Mt 21:40). They were constrained by logic to give their own condemnation, "He

This twenty-first chapter of Matthew opened will put those wretched men to a wretched death with Jesus' triumphant entry into Jerusalem. The and lease his vineyard to other tenants who will give them the produce at the proper times" (Mt 21:41). Jesus confirms this condemnation and declares, "Therefore, I say to you, the kingdom of God will be taken away from you and given to a person that will produce its fruit" (Mt 21:43).

> In the ensuing discourse, Jesus speaks directly of their hypocrisy, "Woe to you, scribes and Pharisees, you hypocrites. You lock the kingdom of heaven before human beings. You do not enter yourselves, nor do you allow entrance to those trying to enter" (Mt 23:13). They emphasize the letter of the law, but neglect its spirit. Thus Jesus declares, "Woe to you, scribes and Pharisees, you hypocrites. You pay tithes of mint and dill and cummin, and have neglected the weightier things of the law: judgment and mercy and fidelity. But these you should have done, without neglecting the others" (Mt 23:23). Jesus' judgement reminds us of the words of the psalmist, "For you do not desire sacrifice or I would give it; a burnt offering you would not accept. My sacrifice, O God, is a contrite spirit; a contrite, humbled heart, O God, you will not scorn" (Ps 51:18-19).

> You and I are given this message as a reminder of our vocation: "I have chosen you from the world, says the Lord, to go and bear fruit that will last" (Jn 15:16). It is also given as a warning for us that "God will not be mocked, for a person will reap only what he sows" (Gal 6:7). If we imitate the seeds of hypocrisy of the scribes and the Pharisees in offering external sacrifices of praise and never reflect deeply on the essence of faith, such as God's judgment, acceptance of his mercy and striving to live faithfully, then the woes that fall upon them will fall upon us. However, if we reflect upon these things and our conscience is not disturbed, then we can be sure that "the peace of God that surpasses all understanding will guard your hearts and minds in Christ Jesus" (Phil 4:9).

West Virginia University School of Dentistry is upholding the University's commitment to improve health care for West Virginians by creating opportunities for hands-on experiences that have contributed to an increase in practitioners choosing to stay in the Mountain State following graduation.

"Across WVU, we are coming together to fulfill our core mission to serve the residents of West Virginia by increasing access to care while discovering ways to better the overall health and well-being of our communities," Dr. Clay Marsh, chancellor and executive dean for WVU Health Sciences, said. "The experiences provided to students in the School of Dentistry are helping to train the next generation of dental professionals to meet the needs of West Virginians."

Of the students who begin dental practice following graduation, the number of WVU graduates deciding to start their career in West Virginia more than doubled from 19% to 41% with the Class of 2023, compared to the previous year's graduates. Additionally, 40% of graduates who have chosen to continue their education have remained in the state and are completing a residency program at WVU. Each year, the Doctor of Dental Surgery program enrolls 48 students.

The increase of graduates staying in the state to practice is much needed as West Virginia experiences a shortage of dentists. The West Virginia Department of Health and Human Resources Oral Health Program reports 49 dentists per 100,000 individuals in the state compared to the United States average of 61.

"It's imperative to the overall health of West Virginians that we train and retain high-quality oral health clinicians," Dr. Valerie Perrine, School of Dentistry associate dean for student affairs, com-

Capito Blasts NEPA Process. Asks for Clarity on Tech Hub Applications in Commerce Hearing

During her questioning, Senator Capito pressed Secretary Raimondo for answers regarding hurdles in the these resources in this country, but we CHIPS and Science Act implementation due to the burdensome National Environmental Policy Act (NEPA) which applies to large scale construction projects, and asked for clarity regarding Tech Hub requirements to benefit small and rural communities.

HIGHLIGHTS:

NEPA HURDLES: "Your agency, the Department of Commerce, has run into an unexpected hurdle in implementing CHIPS and that being the NEPA process. Well, I'm on the [Environment and Public Works] Committee, I'm the Ranking Member, and this is an issue. Doesn't matter if it's chip manufacturing, broadband development, transmission, energy exploration, everything is being held up by the NEPA process, the permitting process, and often the ensuing litigation delays that come forward."

ON NEPA EXEMPTIONS MADE FOR SEMICONDUCTOR MANU-FACTURING: "How does this administration, with you as their representative, actually square exempting one industry over another when it's holding up progress of all of it - national security, energy security, communication, everything? Why would that be a good idea? How can this administration think that's a good idea?"

ADMINISTRATION DISCON-NECT: "I would say to you, energy security is just as important as chip security. I would say transmission in

to manufacture the chips, you've got to mine them and recover them. That means you have to permit the mine. If you look at arsenic, which is used in chips, 97% of that is from China. 60% of that is from China, 10% from the United States. Titanium, 86% from Japan. Noble gases are from Russia and Ukraine, but we have can't get these mines to permit. So, how are you going to go from permitting the [Facilitating American-Built Semiconductors] when you can't get the materials permitted? There's a disconnect here."

EXEMPTION IRONY: "I just think it's rather ironic that an administration would actually make an exception for something they consider a marquee plan for them, albeit the best interest of the country, when there's these other things that I think, politically, are more difficult to touch. That they wouldn't look for the streamlining of permitting, which should be fair and even across the board, without giving up any environmental controls. I sit on the committee that does this, I've been very strong on air and water all the way through, but there's a better way to do it."

Manchin, Moran Introduce **Bipartisan FTC Redo Act**

Washington, DC - Today, U.S. Sena- certain FTC regulators can't finalize the tors Joe Manchin (D-WV) and Jerry Moran (R-KS) introduced the bipartisan Federal Trade Commission (FTC) Review of Expensive and Detrimental Overregulation (REDO) Act. The legislation would prevent the FTC from finalizing and implementing a rushed regulation change specific to automotive retailing without first conducting adequate consumer testing and cost-benefit analyses and allowing for public feedback.

"The FTC's proposed Vehicle Shopping Rule is yet another example of unnecessary and burdensome federal overreach," said Senator Manchin. "I'm proud to lead this bipartisan effort with Senator Moran to prohibit the FTC from finalizing and implementing the rule without conducting sufficient consumer testing and cost-benefit analyses. I encourage my colleagues on both sides of the aisle to support this commonsense step to protect our automotive dealers and consumers in West Virginia and across the country from this rushed federal regulation."

"The FTC's rule would create more paperwork when buying a car at the dealership and lead to more bureaucracy and red tape for small businesses," said Senator Moran. "If the FTC plans to overhaul the way Americans purchase vehicles, they should be required to ask for and receive input from the public at the very least. This legislation will make

rule without first receiving feedback from industry leaders and the general public."

"We applaud Senator Manchin for working across the aisle and sponsoring the FTC Redo Act. It is refreshing to see bipartisan support for a bill that would inhibit the FTC from burdening consumers with added costs, more paperwork and a longer sales process when purchasing their next vehicle," said Jared Wyrick, President of the West Virginia Automobile Dealers Association.

Last summer, the FTC noticed a 126page proposed rule, known as the "Motor Vehicle Dealers Trade Regulation Rule," or the "Vehicle Shopping Rule," which, if approved, would significantly change the process for consumers to purchase, trade-in and finance new and used cars and trucks. The proposed rule would re-regulate all aspects of automotive retailing and was noticed without an Advanced Notice of Proposed Rulemaking (ANPRM) – the process for the public to provide comment.

The FTC REDO Act would require the FTC to:

Issue an ANPRM for public comment; Conduct a quantitative study on auto retailing:

Conduct consumer product testing; and Publish a cost-benefit analysis based on real data.



DHHR Highlights **Resources** During **Breast** Cancer Awareness Month

CHARLESTON, W.Va. - The West Virginia Department of Health and Human Resources (DHHR), Bureau for Public Health joins partners across the nation to highlight services available to West Virginians during Breast Cancer Awareness Month.

The West Virginia Breast and Cervical Cancer Screening Program (WVBCCSP), within DHHR's Bureau for Public Health, Office of Maternal, Child and Family Health, helps low-income, uninsured, or underinsured women gain access to breast and cervical cancer screening services.

"The West Virginia Breast and Cervical Cancer Screening Program provides resources to decrease cancer incidence, morbidity, and mortality by focusing on populations who are underserved and who have increased cancer risk due to health inequities," said Dr. Matthew Christiansen, State Health Officer and Commissioner of DHHR's Bureau for Public Health. "Through the program, uninsured or underinsured West Virginians have the availability to receive screening and information on risks and preventive measures." The WVBCCSP eligible population includes those who are uninsured or underinsured, at or below 250% of the federal poverty level, aged 40 to 64 years for breast cancer services, and aged 21 to 64 years for cervical cancer services. Those who are symptomatic or high-risk under the age of 40 and those over the age of 64 who do not have Medicare Part B may also receive services through the program. Individuals who are interested in resources provided by WVBCCSP may visit dhhr. wv.gov/bccsp to view the "Find a Provider" section organized by county.

As of June 30, the SMART529 program had \$2.8 billion in assets under management, with 38,552 West Virginians invested in the program and 112,482 total accounts from individuals across the country.
