## Ramps, the Traditional and Trendy Staple From the West Virginia Hills

Generations ago, when forests covered all of eastern North America. American Indians and frontiersmen alike scoured the land every spring to find them. They used them for medicine, but also added them to foods for a rush of fresh flavor after a winter of salted meats and dried staples.

Now, every celebrity from chef Gordon Ramsay to Anne Burrell sings their praises and uses them to create robust food challenges competition programs.



Ramps have a centuries old history as both a food and a medicine in the Appalachian Mountains and surrounding areas.

once The ramp has emerged from the Appalachian hills to take its place as one of America's great ingredients.

Cherokee **Indians** created a long list of

humble uses for ramps over They centuries. used ramps to create medicinal tonics to treat coughs and colds and also used

them as an essential ingredient for bee stings salves. Historian John Alexander Williams wrote that "ramps, or wild leeks, wild vegetables that appear in the forest every spring, often poked their pungent leaves up through the snow. They have a bad odor when cooked, but are otherwise wholesome."

Williams added that "children and everyone else looked forward to their coming and they have become a traditional Appalachian food." Ramps have flavor that ranges

### **Experts Urge Calm** In Face of Avian Flu **Transmission From Cattle to Humans**

Warnings from both United States Department of Agriculture and the West Agriculture Virginia Commissioner about the transmission of avian flu from castle to humans have raised concerns.

Industry experts, however, have urged

The office of the West Virginia Commissioner of Agriculture released a statement last week from Kent Leonhardt "strongly urging farmers to enhance biosecurity practices on their farm, especially relating to wild birds in proximity to cattle."

Though the disease named "Highly Pathogenic Avian Influenza," the release stresses that the threat to humans remains low. As of last Thursday, one farmer in Texas was confirmed by the illness, including those

Centers for Disease Control as having contracted the disease. He had eye redness and no other symptoms "and is recovering."

"CDC indicates the overall risk to humans remains low," it added.

Leonhardt stated that "we want to ensure West Virginia consumers that our pasteurized milk and products made from pasteurized milk, are all safe for consumption." The Food and Drug Administration reported no disruptions of supply.

A release from the stated USDA "because of the limited information available about the transmission of HPAI in raw milk, the FDA recommends that industry not manufacture sell raw milk or raw/ unpasteurized cheese products made with milk from cows showing symptoms of

Easting a false hellebore, for example, can bring on severe symptoms within 30 minutes, such as severe nausea and vomiting, slowed breathing, weakness, numbness, tingling, and drooling." 
## Seniors Enjoy Their Own Day with the Dinosaurs


