Cork's Turkey Knob Wines, LLC Grand Opening on Friday

Rick and Dana Corcoran began their journey into wine six years ago with the guidance of Marvin "Bud" Parsons. The Corcoran's consider Bud to be the master mind of wine making and the mentor they needed to start this next chapter in their lives. Parsons also sent them to seek out Jim and Tony Kelley of Batton Hollow Winery in Lost Creek to further educate them on the full process of wine making. The Kelley's helped set them on the path to correctly making wine with the right equipment and ingredients. They also have gratitude and appreciation for their son Steven Sponaugle. Sponaugle has added a hand where needed, especially with the labeling of the bottles. Mrs. Corcoran credits her son Sponaugle in making sure the sweet wines are at their best. The Corcoran's started their life journey in marriage 17 year ago and with a combined family of six children lead a full family life. Family life being important to the both of them they set boundaries to keep the winery separate and by doing so keep family time a top priority. They make a point to stop work at 8 p.m. each evening to spend quality time together. You can see the pride and joy they take in their wine and when talking about their family.

name came about. "One day we were getting ready for church. And I happened to look out the window that looks out to Turkey Knob and it just clicked That's the name!" Cork's comes from him, his dad and granddad being called by the nickname Cork or Corky. Therefore, the new name seemed fitting for their adventure. The process of making the wine is not as simple as one would like to think. It takes a total of roughly six weeks from start to finish. The "juice" is either extracted from grapes or can be purchased from vineyards. The Corcoran's go as far as New York to get the best juice for their wine. The juice is added to a barrel and mixed with the correct amount of sugar,

yeast and water. The juice then sits in the barrel until the settlements collect in the bottom of the barrel at which time they then run the wine to another barrel until there are hardly any settlements left in the barrel. The wine is run through a machine with 16 filters to make the wine clear, at which time it is bottled and corked. The Corcoran's can bottle six bottles at once. The machine is set to fill each bottle with the correct amount of wine, once filled; they send the bottles over to the corking machine and end the process with the sealing of the cork and labeling the bottle. Each label has to be approved by the WV ABCA Commissioner. For instance they are currently waiting on the approval for See CORK'S page 6A

Tucker Community Foundation Accepting Scholarship Applications

More than 40 scholarships from the Tucker Community Foundation are available for high school and college students in Barbour, Grant, Mineral, Preston, Pocahontas, Randolph and Tucker counties, WV and Garrett County, MD. Scholarship awards will range from \$500 to \$10,000 with most in the \$1,000 to \$2,000 range.

Applications are also available at the Foundation offices located in the Board of Education Annex at 100 Education Lane, Parsons. High School guidance counselors throughout the Foundation's service area also have applications for distribution to students.

Interim Executive Director Michael Moore encourages all high school and college students to apply even if their educational needs do not align with a particular fund.

"Some of the Tucker Community Foundation's scholarships are designated for graduates of a particular high school or for a particular college while others are based on activities or intended college majors" Moore said.



2022 tax filing season begins Jan. 24; IRS outlines refund timing and what to expect in advance of **April 18 tax deadline**

WASHINGTON — The Internal Revenue Service announced that the nation's tax season will start on Monday, January 24, 2022, when the tax agency will begin accepting and processing 2021 tax year returns.

The January 24 start date for individual tax return filers allows the IRS time to perform programming and testing that is critical to ensuring IRS systems run smoothly. Updated programming helps ensure that eligible people can claim the proper amount of the Child Tax Credit after comparing their 2021 advance credits and claim any remaining stimulus money as a Recovery Rebate Credit when they file their 2021 tax return. "Planning for the nation's filing season process is a massive undertaking, and IRS teams have been working non-stop these past several months to prepare," said IRS Commissioner Chuck Rettig. "The pandemic continues to create challenges, but the IRS reminds people there are important steps they can take to help ensure their tax return and refund don't face processing delays. Filing electronically with direct deposit and avoiding a paper tax return is more important than ever this year. And we urge

extra attention to those who received an Economic Impact Payment or an advance Child Tax Credit last year. People should make sure they report the correct amount on their tax return to avoid delays."

The IRS encourages everyone to have all the information they need in hand to make sure they file a complete and accurate return. Having an accurate tax return can avoid processing delays, refund delays and later IRS notices. This is especially important for people who received advance Child Tax Credit payments or Economic Impact Payments (American Rescue Plan stimulus payments) in 2021; they will need the amounts of these payments when preparing their tax return. The IRS is mailing special letters to recipients, and they can also check amounts received on IRS. gov. Like last year, there will be individuals filing tax returns who, even though they are not required to file, need to file a 2021 return to claim a Recovery Rebate Credit to receive the tax credit from the 2021 stimulus payments or reconcile advance payments of the Child Tax Credit. People who don't normally file also could receive other credits.



Charleston WV - The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

Jan. 19, 1818: The Virginia General Assembly established Preston County from part of Monongalia County. The new county was named for James Patton Preston, then governor of Virginia.

Jan. 19, 1820: Fairmont was established by the Virginia legislature on the farm of Boaz Fleming. The original name of Middletown was changed to Fairmont in 1843.

Jan. 19, 1844: The Virginia General Assembly established Taylor County from parts of Barbour, Harrison, and Marion counties. The county was named in honor of U.S. Sen. John Taylor, a soldier-statesman from Caroline County, Virginia.

Jan. 19, 1848: Wirt County was created by the General Assembly of Virginia from portions of Wood and Jackson counties. It was named for William Wirt, Virginia statesman and a presidential candidate in 1832.

Jan. 19, 1894: Railroad worker John Hardy was hanged for killing a man in a drunken gambling dispute. The episode inspired the widely popular ballad "John Hardy."

Jan. 20-21, 1824: West Virginia's most famous soldier, Thomas Jonathan Jackson, was born near midnight in Clarksburg. When Virginia left the Union in 1861, Jackson dutifully went with his native state. He commanded the strategically important post at Harpers Ferry until being appointed a brigadier general of infantry. In the opening

21, 1861, he won the name "Stonewall" for steadfastness at the critical point in the engagement.

Jan. 19-20, 1978: An overnight snowstorm paralyzed Charleston. Unusual in that more snow fell in the capital city than in Randolph County, total snow depth in Charleston averaged 24 inches, the deepest snow on record for the city. January 1978 became the snowiest month for both Huntington and Charleston, and extended cold kept the snow cover on the ground into March, the longest known continuous snow cover for most towns in West Virginia.

Jan. 21, 1906: The first passenger train ran from Elkins to Charleston following completion of the Coal & Coke Railway. The new railroad, a project of former senator Henry Gassaway Davis, provided a much-needed north-south route through the heart of West Virginia.

Jan. 22, 1927: Confederate General John McCausland died. After the fall of the Confederacy, McCausland fled the country. He returned in 1867 and spent the remainder of his life on his large farm in Mason County.

Jan. 23, 1850: Raleigh County was established by an act of the Virginia General Assembly. The county's founder, Alfred Beckley, named the county after Sir Walter Raleigh.

Jan. 23, 1888: Union leader Fred Mooney was born in a log cabin on Davis Creek in Kanawha County. He was secretary-treasurer of United Mine Workers of America District 17 from 1917 to 1924 and was a radical leader in the West Virginia Mine Wars.

Jan. 23, 1890: The United Mine Workers was organized at a meeting in Columbus, Ohio, with John

B. Rae, a Scottish immigrant, as the first president. Just three months later, in Wheeling, UMWA District 17, encompassing most of West Virginia, held its first meeting, elected M. F. Moran as district president and immediately launched what became a struggle of more than 40 years to unionize the state's coal mines.

Jan. 24, 1968: Mary Lou Retton was born in Fairmont. She made history at the 1984 Olympic Games in Los Angeles when, at 16, she became the first American woman ever to win a gold medal in gymnastics and the first native West Virginia woman to win a gold medal in Olympic competition.

Jan. 25, 1814: Francis Harrison Pierpont was born near Morgantown. On June 20, 1861, Pierpont was unanimously elected as governor of the unionist Reorganized State of Virginia, which sat at Wheeling until West Virginia entered the Union two vears later.

Jan. 25, 1878: Activist Lenna Lowe Yost was born in Basnettville in Marion County. She held key leadership roles in the woman's suffrage movement and the temperance movement.


Jan. 25, 1889: Anna Johnson Gates was born in Kanawha County. The state's first female state legislator, Gates was elected to the House of Delegates in 1922 and served a single term.

Healthy Avocado Brownies

Ingredients

- 2 Ripe Avocados
- ³/₄ Cup Coconut Sugar
- 2 Teaspoons Vanilla
- 6 Ounces Dark Chocolate Chips
- 2 Eggs
- ¹/₂ Cup Cocoa Powder
- ¹/₂ Cup Almond Flour
- Pinch of Salt
- Healthy Avocado Brownies Frosting
- ¹/₄ Cup Coconut Oil
- 1/3 Cup Maple Syrup
- 3 Ounces Dark Chocolate Chips
- 1/3 Cup Cocoa Powder
- Pinch of Salt
- Walnuts for Topping

Instructions

- 1. In a blender or food processor, blend avocados until no lumps remain. Add coconut sugar and vanilla, blend again until creamy. About 4 minutes.
- 2. In a separate bowl, melt dark chocolate in the microwave at 30-second increments, stirring after each increment.
- 3. Pour melted chocolate into the processor and blend until smooth. You

may need to scrape the sides of the processor with a spatula to mix thoroughly.

- 4. Add eggs and blend again just until combined.
- 5. Add cocoa powder and almond flour. Blend JUST until combined.
- 6. DO NOT over-mix. Be sure to scrape down the sides of the processor.
- 7. Pour batter into a 9×9 inch baking dish lined with parchment paper. Spread the batter out evenly.
- 8. Bake in a 350° F oven for 25-30 minutes or until just set. Overbaking will result in cakey brownies.
- 9. Allow brownies to cool completely.
- 10. Healthy Avocado Brownies Frosting
- 11. In a small saucepan over mediumlow heat, melt coconut oil, maple syrup, and dark chocolate together.
- 12. Whisk until combined and smooth. Add a pinch of salt and cocoa powder. Whisk until smooth. Drizzle over cooled brownies.
- 13. Work with the frosting quickly because the coconut oil will start to harden. Top with walnuts and enjoy!

Morrisey Wins Stay of OSHA Vaccine Mandate

CHARLESTON — West Virginia Attorney General Patrick Morrisey applauded a decision by the U.S. Supreme Court to stay President Biden's vaccine mandate for private sector employers with more than 100 employees.

In November, Attorney General Morrisey and a coalition of six other states filed a petition for review with the U.S. Court of Appeals for the Sixth Circuit to stay the mandate, which the Biden Administration's Occupational Safety and Health Administration (OSHA) had issued as an emergency temporary standard. The standard requires the vaccination or burdensome weekly testing of tens of millions of citizens.

After the Sixth Circuit declined to kee a stay of the mandate in place, the group now joined by 20 additional states, aske the Supreme Court to stay the immediat effect of the mandate — which the cou did.

"As we predicted all along, the U.S Supreme Court has announced that it wi stay the OSHA employer Covid-19 man date," Attorney General Morrisey said "This is a huge win for our Constitution our freedoms, our republic and our wa of life. I'm proud of our Office's wor and the work of the entire state coalitio which helped make this happen.

"Your freedom matters. That's wh my Office will continue to fight against all of these unlawful mandates."

house, or just not knowing our ordinances and how we live in Davis. There is little doubt that Short-Term Rentals change a community; some will even argue that they destroy communities.

An online petition has been started to argue perceived advantages of unlimited and unregulated Short-Term Rentals based on the perspective of both owners and tourists. The vast majority of people responding thus far do not live here full time and we would like to respond to the points they make:

Nonresidents are complaining about rights being limited. These are the same people who live in areas with unbounded government overreach who want to pretend that we live in an area without any ordinances, regulations, or procedures. West Virginia code Section 8-12-5(44) requires that "the Council act in the interest of public health, safety and welfare." We consider it our duty to represent the residents and their wellbeing. That does not mean we are against any particular faction that wants to do business in Davis, but when economic interests threaten the very existence of our community, we must take a stand for the public good. If this is a choice between income of owners of short-term rentals or preserving the nature of our community, the town council is going to protect our residents. Completely inaccurate is the claim that "over half of real estate in Davis is owned by non-residents" based on documented services to the town. Davis is not just a "mountain sports tourism destination", but also a place where people live full time. Owners who have moved here and are now permanent residents are eligible for an exception that allows them to use their properties for Short-Term Rentals. Tourism here is based purely on activities available, sites to visit, amenities including the arts, brewery/ distilleries and food options. Short Term Rentals are here because of the tourist activity that pre-existed them.

Davis and the surrounding areas currently have more job opportunities than we have people able to work. The limitation on filling jobs is due to a lack of workforce housing which Short-Term Rentals make even more scarce. Though Short-Term Rentals might eventually provide additional low paying jobs, but they do not provide an opportunity for upward mobility in Davis.

Small Business Impact: People are willing to drive all over the county to participate in activities and patronize shops and restaurants. It is ludicrous that someone staying in Thomas wouldn't drive 2 miles to Davis. Those who provide Short-Term Rentals on William Ave are not limited by the proposed ordinance and are providing the foot traffic for Davis businesses. Based on observation, most other Short-Term Renters within the town of Davis choose to use their cars.

Blighted Properties: The Council is considering opportunities for Short-Term Rental licensing for owners that turn blighted properties, vacant property, and vacant lots into Short-Term Rentals.

Visitors: The Davis Town Council is not opposed to change. Change is inevitable but our goal is to regulate change in a fashion that allows for business opportunities AND the protection of our residential community. Contrary to a claim that infers vacation rentals are the lodging of choice for Americans, as of July 31, 2021, 72% of Americans prefer hotels and resorts to vacation rentals.

Safety: Some owners are resistant to our attempt to ensure that there are safe and healthy rentals in Davis. The Council believes that all rental property needs to be inspected and verified as safe. The Town of Davis plans to pay for inspections. We don't believe that anyone should rent, short or long term, a space where hazards exist.

We want to keep our community feel and our way of life in Davis as much as possible. The Council is creating an ordinance that is not a ban, but limits uncontrolled growth of Short-Term Rentals. To our community's Short-Term Rental owners: some think our ordinance is a bad thing. Our goal is to limit how many Short-Term Rentals can be in the residential area and encourage them toward the business area of town. We hope your neighbor is someone you know and not a steady stream of short-term renters coming and going. Davis is our community. We collectively determine where and what businesses exist. Those who do not live here full time may not agree with that, but it is OUR community and our HOME.

Second Homeowners: Davis is a community of residents and the local townspeople have indicated their desire for it to stay that way. It would be useful to see on the petition the names and addresses of the signatories to see how many are residents of Davis and how many are non-residents. We believe the majority of signers are tourists and second homeowners rather than residents. If someone would like a second home in Davis and does not meet the criteria for an exception of which there are a number, perhaps they should consider other options for funding than Short-Term Rentals.

Section 3. Such Code shall be in full force and effect as provided in Section 6, and such Code shall be presumptive evidence in all courts and places of the ordinance and all provisions, sections, penalties and regulations therein contained and of the date of passage, and that the same is properly signed, attested, recorded, and approved and that any public hearings and notices thereof as required by law have been given.

Section 6. This ordinance is declared to be an emergency measure necessary for the immediate preservation of the peace, health, safety and general welfare of the people of this municipality, and shall take effect at the earliest date provided by law.


