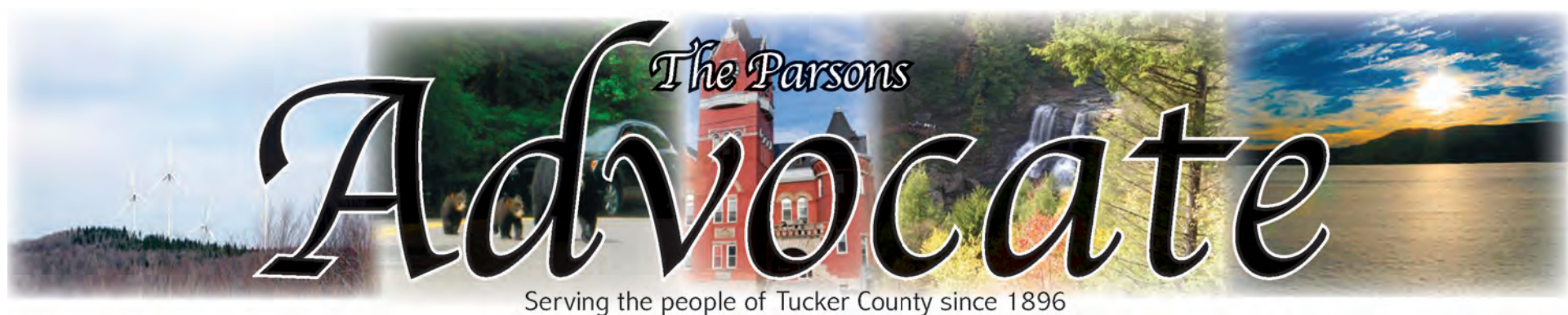

gency room nurse manager who accomplished in three months of training what most would have to train a year to complete. Goff summited Mount Kilimanjaro on the Lemocho Trail!

With the loving support of her husband, Dave, and family Goff took the trip after seeing on Facebook that the National Leukemia Foundation was hosting the hike

of her dreams. Joined by her niece, Meredith, they embarked on a seven-day adventure to honor Goff's mother, Linda B. Hockman, who is battling leukemia and her father, whom she lost in December, Jack Hock-

man, who was a Korean War veteran and the youngest sheriff for Tucker County.

Mount Kilimanjaro is a dormant volcano in Tanzania. It has three volcanic cones: Kibo, Mawenzi, and Shira. It is the

highest mountain in Africa and the highest single free-standing mountain above sea level in the world at 19,341 feet above sea level and about 16,100 feet above its plateau base. It is the highest

SALDO "Paused" for Six Months



Planning Commission members discussing new direction for an updated zoning ordinance for Canaan Valley

The planning commission has decided to place the Subdivision and Land Development Ordinance (SALDO) on a six month pause. The president of the planning commission, Tim McLean, explained that there were more pressing issues in the county at this time. All other members of the commission were in agreement and after William "Bill" Shahan made the motion to pause the ordinance for six months the motion passed with a five to one vote. Robin McClintock was the only nay vote for the motion.

McLean explained, "Our last meeting was in June, in Davis, and this planning commission's primary purpose of that meeting was for this planning commis-

sion to finally accept the final draft and submit to the county commission our subdivision ordinance. I have personally been working on the ordinance for the last 16 months and some have been working on it for over 13 years. It has been quite a process and we have taken it from 60 pages down to the 28-page current edition that is on the county website.

During the time we have worked on it, we have invested a lot for our community. Over the last 14 to 16 months, we have listened to a lot of input from the community and a lot of input from the county commissioners. A lot of back and forth agreeing and disagreeing.

We have learned how to write it in legal format thanks to John Cooper and pro-bono free work. He was able to help us keep the document legal."

McLean went on to discuss the reasoning behind his suggestion to pause the ordinance for the time being by saying, "During the latter part of June this dark cloud start floating over Tucker County, and it consumed the dialog among all of us, the media, the county commissioners, and it is called EMS, and that dark cloud is still out there.

I am a fairly well-read person and the first of July I was trying to put together an agenda for the July meeting and I was basically having trouble putting words on the page. In my opinion and what I believe is the opinion of the volunteers on this planning commission is we have done our job as far as the subdivision ordinance goes."

McLean went on to say that with all

Chaney Seeking Early Release

Former Canaan Valley State Park and Resort Director of Operations, Michael Scott Chaney, was sentenced in Circuit Court on Tuesday, March 9 by Circuit Court Judge Lynn A Nelson. Chaney, age 57, of Harmon, plead guilty to five counts of felony embezzlement. Chaney was charged with stealing from taxpayers nearly \$165,000 worth of items used for personal use, from high-end Christmas decorations and guns to having fuel delivered to his residency.

Chaney worked for the Canaan Valley State Park and Resort overseeing the day-to-day operations of the resort for the management company Regency Hotel Management. Starting in 2008, Chaney started making purchases of tangible goods, which were paid for with state money, for his own use. In October of 2020 the embezzlement was discovered when Chaney took medical leave and invoices were discovered for items purchased that were not on the resort property.

Chaney was to serve a sentence of one to ten years for each of the five counts in a state facility, with the sentences to be served concurrently but just after serving a mere five months Chaney and his lawyer have petitioned the court for early release under the Rule 35 motion.

Chaney's lawyer based the grounds for possible early release in his statement to Judge Nelson by stating that Chaney has learned his lesson, has paid back all his restitution (thanks to generous family members), and the failing health of Chaney's wife who is awaiting

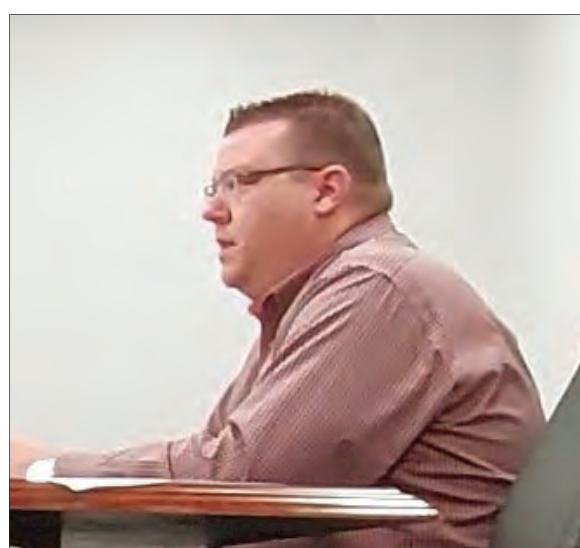
Under the advisory of attorneys Peter Markham and Tom Heywood from the firm of Bowles Rice, the Randolph County Development Authority have adopted a position statement on the Revised Original Preferred Alignment (ROPA). The position statement will highlight key speaking notes for the authority members and give a guideline on where the authority stands in the matter of ROPA. The position statement will make it clear where the authority stands and give the authority one voice for all members.

Authority member Mallie Combs said, "I think it important to know that is the position of highways (WVDOH) and I think that is important because they have done a lot of the due diligence." Combs made a motion to approve the position statement as presented. Motioned passed

with unanimous vote.

Morris said, "The talking points will be primarily developed by Peter, Tom and myself in coordination with information released from the division of highways."

The authority heard from Morris concerning the delegation of authority to officers consistent with the position statement. Morris said, "As you can imagine there is a lot of work going on, hot and heavy, with the Parsons and Davis section. And there is going to be board meetings, public meetings, information meetings and opportunities I am going to be invited to as well as others from the authority."



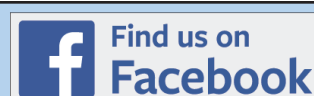
Robert C Byrd Corridor H Highway Authority Chairman Robbie Morris

The following criminal complaint has been filed in the Tucker County Magistrate office:

• **James Malcolm Southern:** of Hambleton, was charged with one count of Driving under Influence of Alcohol. According to the complaint on Sunday, Aug. 14, Tucker county Communication 911 dispatched officers to the area of 2049 Mackeyville Rd. for a UTV accident on the roadway. 911 advised the officers that the driver could possibly be intoxicated. Cpl. B.T. Zirk of the Tucker County Sheriff's office, Officer Dudley of the WVDNR and TFC J.J. Schmidle of the WVSP responded. Upon arriving on scene Zirk observed a UTV resting on its passenger side in the roadway. He observed a male subject, later identified as James Southern, standing behind the vehicle. Zirk asked him if he needed medical attention and he stated no. Zirk asked him what happened and he stated he was coming back from the gas station and took the turn too fast and hit the ditch. While speaking with him Zirk noticed his speech to be slurred and slow. When asked if he had anything to drink Southern stated no. He

was asked if he would submit to a Preliminary Breath Test (PBT) and he agreed. While walking to Zirk's cruiser He was observed to be staggering. He submitted and performed the test which he failed. Zirk asked him again if he had anything to drink to which he allegedly stated he had some earlier. He was asked if he would submit to field sobriety tests and he allegedly stated he could not do it. He was observed to be having trouble maintaining his balance. He was asked once more if he would be willing to perform FST and at this time he started shaking, fell to the ground and appeared to pass out. Zirk requested Tucker Emergency Medical Services to respond to the scene. Southern then sat up and leaned against Zirk's cruiser. Zirk again asked if he needed medical attention and Southern stated yes. At this time his wife arrived on scene. While speaking to Mrs. Southern, she advised officers that he had allegedly drank an entire bottle of vodka before leaving the house and that he drives drunk often. Southern was transported to Davis Medical Center by EMS.

We Get Letters

To the Editor:

Is there now, has there ever been, a Northern Route for the Tucker County section of Corridor H? At the recent CVB meeting, Kevin White said Travis Long of the Division of Highways called it just "a crayon mark on a map."

Really? According to the 2007 Environmental Impact Statement, the DOH had a pretty good idea what a northern route would look like on the ground.

In Table S-2, DOH compared their preferred alternative with several northern routes as to length, cost, travel time, footprint in acres, volume of earthwork, business and residential displacements, reduction in truck traffic through Thomas, effects on cultural resources and many natural resources that included wetlands (four types), floodplains, streams, and endangered species habitat. So where did they get all those numbers?

If there never was a Northern Route, really, the DOH would have failed to comply with its obligations under the Settlement Agreement:

Construction may begin following completion of an alignment shift study, which will evaluate alternatives for avoiding the Blackwater Canyon.

The study will be conducted to evaluate one or more alignment shifts for the Davis-Thomas section of the project as a four-lane divided highway.

Those alignments generally would involve shifting Corridor H to the north of Thomas, then connecting

to WV Route 93 east of Davis.

The Blackwater area includes the Blackwater Canyon from Thomas to Hendricks. This area includes all historic resources associated with coal mining and coke production in the late 19th and 20th Centuries.

Of course, the Northern Route did not reach the stage of final design. Neither has the DOH's preferred alternative. The Settlement Agreement contemplated that, "If a prudent and feasible alternative route were to be found, the new route would have to be developed. Estimated time for the various studies is 18 months."

That's 18 months—not three or four years, as the DOH says now.

The northern alternative was supposed to be explored for "the Davis-Thomas section of the project." Its route west of that, around the high school and down Backbone Mountain, can be thrown out. That design was a failure. It had no access to the high school, excessive cuts and fills, more stream crossings, etc.

The Northern Route is the Davis-Thomas section. It should be our focus now, to benefit both towns, to prevent a wide barrier between them, to relieve Thomas of truck traffic, and to preserve the Blackwater area (whether you call it the Canyon or not). It should be included in the next Environmental Impact Statement.

Update on Laneville Bridge Closure on Forest Road 19

PETERSBURG, W.Va.— The Laneville Bridge over Red Creek on Forest Road 19 is expected to remain closed this fall due to a safety concern identified during a routine inspection. Road closure signs have been installed in several locations advising local traffic only in the Laneville area.

A construction contract is in development for demolition of the existing bridge and installation of a temporary bridge across Red Creek. Incentives will be offered to expedite the work. The timeline for construction is unknown, but more details will be shared as they become available. It is our goal to have the temporary bridge in place before winter.

Visitors are encouraged to seek alternate routes to avoid the Laneville area and bridge. Parking is expected to be congested at the Red Creek Trailhead. Please respect private property adjacent to the trailhead and consider other access points to the Dolly Sods Wilderness. Contact the Petersburg office at (304) 257-4488 for travel suggestions and alternative trails.

The Laneville Bridge provides access to the community of Laneville, the Red Creek trailhead, Dolly Sods Wilderness, and other recreational facilities, and is a key connection between Randolph, Tucker, and Grant counties. The Forest Service coordinates closely with emergency management officials in those counties and will continue to cooperate and facilitate their requests to provide services in the area.

volcano in Africa and the Eastern Hemisphere.

When Goff was asked what the feeling was like boarding a plane knowing she was headed to Africa to climb a mountain Goff said, “I was so excited. I was like a little child at Christmas. I really did not know what to expect. We went to Tanzania, then to the town of Moshi. After a layover in Ethiopia, you could see the mountain when we came into the Kilimanjaro airport which is similar in size to Clarksburg. And although it looked close to us because it was so big, it was another hour and half

drive to the mountain.”

Goff said, “The best part of the trip was seeing all the stars at night and hearing nothing. We took off at 11:30 at night and climbed in the dark. My husband let me use his miner’s light and we summited around 7 a.m. and the sun was coming up. I have never seen a purple sky like that before.”

Goff explained, “It was a seven-day hike. It was like 48 miles. You hiked anywhere from four to six to eight hours a day. It took that long because they made you go slow so you can acclimate to the alti-

tude. The people that do it over four or five days have a less success rate. The people that do it over six, seven, or eight, there is 99 to 100 percent success rate. That’s why I choose that route.”

Goff explained the toughest part of the summit was coming down the mountain. After sitting for just 10 minutes once getting to the top, the air is so thin Goff began to feel dizzy and light headed. Goff and a couple of the other travelers were helped down the mountain in a rush before they could begin to experience severe symptoms of altitude sickness.

Goff said, “The porters (the ones that toted all the equipment and supplies up the mountain) were dragging me down the mountain and there was all this loose dirt and gravel. I just told them to let me down I could not do it and they said no Karen you are going to get sick. I was nauseated and I drank to keep hydrated. I never got any going up. It was coming down that was rough. Even five days later my equilibrium was off.”

After submitting Goff explained they hiked down in four hours what took eight going up to reach

the camp. They rested for an hour and hiked down another four hours up and down steep hills to the next camp. Unfortunately, some of her fellow hikers did not fair as well as she did. A few including her niece experienced altitude sickness coming down off the mountain and one 24-year-old, the youngest of the group, never made it to the top because of dehydration and low blood oxygen.

In Hemingway’s book the story opens with a paragraph about Mount Kilimanjaro whose western summit is called in Masai the “House of God”, and Goff was asked what her personal feelings she experienced she said, “The nature itself and the clouds and just the euphoria. The day we took off I got really emotional, and I said God please help me get through this. I know it is going to be rough and it was really rough. Probably the hardest thing in my life I have ever done.”

With tears swelling her eyes, Goff explained what she felt when she finally summited to the top and said, “I thought of mom and dad.” And continued by saying, “I cried the morning we went to summit. You know you want it, and you work for it. (For training) I put on a backpack every weekend and walked from my house in Blackman Flats, down through town, and out where they are doing the construction by Holly Meadows. I did eight miles of hiking and go out to the top of quality hill to see my mother and then back through town to my home.”

The hiking adventure ended in a small village with the porters and cooks dancing in celebration for all the hikers that completed the journey of a lifetime. The hikers were presented with certificates of completion for reaching the summit.

In his statement to the court Chaney said, “I stand here today with humility and with the deepest remorse for my previous wrong and illegal passive actions. I have and will continue to accept full responsibility for what I did. It was extremely wrong. I apologize to all my victims, my wife, my family, and to the Tucker County judicial system.”

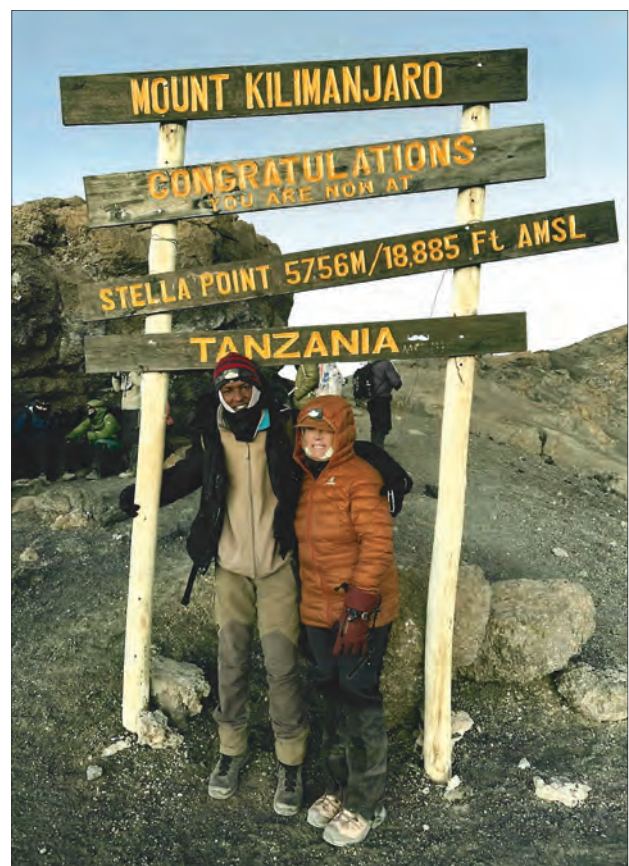
Per his plea agreement, Chaney paid \$152,426 in restitution to Regency Hotel Management, LLC. and \$20,000 to Canaan Valley Resort general fund for the cost of the audit.

Tucker County Prosecutor, Savannah Wilkins, reminded the court of the crime Chaney committed. Wilkins said, “I just want to remind the court that the first receipt we found was for Crazy Harry’s over in

Restitution of \$172,000 was paid but there were hundreds of thousands of dollars in transfers from ticket sales to inflate the profitability of the retail shop that Sam England testified to. So, \$172,000 was what we could prove but there were hundreds of thousands of dollars over the course of a decade in occurrences. Five months is not a long time when talking about this activity going on from 2008 and moving forward.”

After Wilkins motioned for the court to allow Chaney to remain in custody at least until his parole hearing in March of 2023, Judge Nelson advised Chaney and his lawyer and Wilkins that he would take all information presented under advisement and make his decision at a later date. Nelson will inform every one of his decision once he has made it.

the other issues the county commission was facing at this time and after having a phone call with Commissioner Mike Rosenau, he felt like this was the time to put aside the ordinance and focus on more important issues like EMS.

McLean then suggested to the other planning commission members and said, “I would like to recommend we pause the document. It is on the website. It is finished. There is nothing in there that we should be ashamed of, it is a pretty good document. We can pull it again at a better time when the county does not have bigger issues to handle. We as a planning commission can move onto another idea.”

Shahan said, “I was thinking the same thing. I have been approached by several people while working at Kidwell’s and the majority of the people say the same thing that they see what we are trying to do, and they fully understand it. They really have nothing against the document. They really do not want this, and my opinion is we make the recommendation, and it ought to represent the people of the county. And if the people of the county do not want it at this time, then I am in agreement that we should table it until a later date when we can come back and revisit it. Maybe they would have more time to think about it and understand it, and if they want it then fine and if not then it is what it is.”

McLean’s plan to move onto

another idea concerns the outdated zoning ordinance for Canaan Valley. McClintock asked McLean to explain that in detail to the other members of the planning commission and then said, “I would also like to hear from the county commissioners why they can not consider more than one issue at a time.” to which Rosenau answered, “Robin, I do not think that is a discussion for this meeting.”

McClintock then asked to go into executive session. When asked for the reason why she wanted to go into executive session McClintock said, “So we can talk about this. I want clarification.” Rosenau informed McClintock that it was not legal to go into executive meetings without a legitimate reason such as personnel issues or selling of land and clarification was not a legal reason.

McLean suggested the planning commission turn their focus now to the zoning ordinance for Canaan Valley that is dated from 1998. McLean would like the members of the planning committee to research the zoning ordinance and he would be working with Cooper to find out if the footprint of the ordinance could be extended to Route 93 by Thomas and Davis.

The idea is to make the ordinance enforceable for new subdivisions or industrial/commercial companies as well giving the people the option to vote on whether they would except the refreshed ordinance. Since

Canaan is in the same voting district as Thomas and Davis, residents in all three areas would vote on it. Unlike the SALDO that would just need the approval or disapproval of the county commissioners. The zoning ordinance would not be enforceable in Thomas or Davis and would only include the people that it effects.

McClintock explained that if the existing zoning ordinance could not legally be extended to include the extra areas, then a start from scratch report would have to be conducted by the planning commission. Last time the report was done it took two years to complete. McClintock asked, “Which is easier? Getting a zoning ordinance or explaining the document that we have already. There is a lot of time that is going to go by and there is a lot of development just chomping at the bit. I think zoning is more restrictive and more protective of the county, but if it takes two years to get zoning done what kind of damage can be done in two years.”

To explain why the zoning ordinance should include the extended areas towards Davis and Thomas McLean said, “The big part of the initial growth of Tucker County, and I say initial, is coming from that direction with the new highway.”

The next planning commission meeting will be held September 12, 2022, at 1 p.m. at the Davis Town Hall.

behalf of the development authority as a whole. Morris said, “I would like permission from the authority just so we are on the same page to speak on behalf of the authority regarding anything Corridor H related. It is mostly going to center around the ROPA and those comments being consistent with our position statement, not only myself but the officers of the organization as well.”

Key factors play a role in the decision of the authority and the decision is based solely on facts presented by the West Virginia Department of Highways. Morris said, “With the current things going on with ROPA there are a couple of things. One, the ROPA was established and if you look at the original settlement group that was the original line that was proposed. There was support for that alignment back between 2003 and 2007. Some where in that time frame there was support for that route and obviously it was shelved just because of funding.

Right now, there are multiyear studies on historical sites and environmental issues and looking at the engineering of it. The entire thing of it has been incredible with multiyear studying and a lot of that is ongoing. So that is a huge part from a time stand point.

The other thing is funding. You know we have the infrastructure act. We have a lot of federal money which we always knew it was going to take in order to get Corridor H complete. That money with a lot of push from the Corridor H authority started flowing again in 2018 with the first grant DOH had applied for and finally had additional money that was specifi-

cally allocated towards Corridor H come into play. We have seen the massive contracts that have been awarded over the last few years.

If the ROPA is not selected, and the northern route or any other route would have to be studied the slate is completely clear. All of that work has to start over again. And who knows what the funding scenario is going to be at that time. So why is that a problem?

Some would say yeah let us clear the slate and look for a whole new route. Guess what is not stopping, Kerens to Parsons and also what will not be stopping is Wardensville to the state line. Even if you take Wardensville to the state line out and just the construction that is going on right now comes on line; we have already increased traffic along Corridor H of the completed sections; and the section of Kerens to Parsons is completed, which will be done in the next two to three years, and GPS systems update the amount of traffic is going to increase even more. That is going to create quite a situation from Parsons to Davis. If the ROPA can be awarded in 2024, the funding started and you start that five-year build process, Kerens to Parsons comes on in two to three, you are looking at dealing with that heavier traffic situation in two or three years.

But if you have to stop and completely start over then you are looking at maybe selecting another route you could be working just on the design another seven years. And funding who knows where that is going to be but likely I have heard a minimum of 10-year delay if not 15 years. That would mean for seven to

ten years or more the area between Mackeyville and where the road ends in Davis is going to have an unbelievable amount of traffic.

That is the biggest deterrent, but time is one thing but looking at it from a safety standpoint. Tucker County High School is on that route. City of Thomas, Town of Davis where not designed with that amount of Highway-S type traffic in mind. The ROPA at this point is the only way that traffic is going to impact those areas in the shortest amount of time possible.

Some people have called and said they do not want the highway at all because they do not want traffic to increase going through their town. That ship has sailed. So, we have to get for the safety and security of that section of the highway from Parsons to Davis built as soon as possible. ROPA is the way to get that done.”

The development authority members will be attending informational meetings in the upcoming months. One will be held on August 18 from 4 p.m. to 7 p.m. in Wardensville at the War Memorial Building to discuss the Corridor H section going from Wardensville to the West Virginia state line. The next one will be held in the Blackwater Falls Conference Room on September 12 from 4 p.m. to 7 p.m. to discuss the section of Corridor H from Parsons to Davis.

The next Robert C. Byrd Corridor H Highway Authority meeting will be held on October 14, 2022, at 11 a.m. at the Randolph County Development Authority office located at 10 11th Street, Elkins, West Virginia 26241

The CEP was enacted as a result of the Healthy, Hunger-Free Kids Act and provides universal meal service to children in high-poverty areas. This is the fourth year for the option.

The CEP serves as an alternative to collecting, approving and verifying household eligibility applications for free- and reduced-price eligible students in high-poverty Local Education Agencies (LEAs). If at least 40 percent of a school’s student population are directly certified for free meal benefits, the entire school qualifies for the option.

“I am proud that Tucker County Schools will be participating in the CEP program to help meet a crucial need for many students in our county,” said, Alicia Lambert, Superintendent of Tucker County Schools. “We know academic achievement increases when our students are well-fed and ready to learn, and we must provide secure and reliable access to nutritious meals so all students have a chance to achieve at the highest level possible.”

Tucker County expects to have all 3 schools participate in the CEP. (Adding a sentence to reflect the types of schools participating, for example all elementary schools, etc). The program allows the school system to feed nearly 600 students each day.

Aug. 17, 1944: Staff Sergeant Stanley Bender earned the Medal of Honor in southern France. Bender rushed through intense machine gun fire and grenades, and knocked out two German machine guns with rifle fire. His actions inspired the rest of the company to take out a German roadblock, kill 37 enemy soldiers, and take 26 prisoners.

Aug. 17, 1976: The National Mine Health and Safety Academy opened at Beaver, near Beckley. The academy, located on an 80-acre campus, is the world's largest educational institution devoted solely to safety and health in mining.

Aug. 18, 1885: Artemus Ward Cox was born on a farm at Red Knob, Roane County. In 1914, Cox bought the George Ort Department Store on Capitol Street in Charleston. That store became the first in a chain of 21 A. W. Cox

stores in West Virginia, Virginia, Ohio and Kentucky.

Aug. 19, 1863: Union cavalry under Brig. Gen. William Woods Averell destroyed the Confederate saltpeter works near Franklin.

Aug. 19, 1997: Fiddler Curly Ray Cline died. Born in Logan County, Cline was a member of the Lonesome Pine Fiddlers and Ralph Stanley's Clinch Mountain Boys.

Aug. 20, 1851: The oldest statue in West Virginia, a nine-foot wood carving of Patrick Henry, was dedicated at the county courthouse in Morgantown.

Aug. 21, 1861: Confederate troops under Gen. John B. Floyd crossed the

Gauley River at Carnifex Ferry, Nicholas County, and began to entrench their position. It was the beginning of what became known as the Battle of Kessler's Cross Lanes.

Aug. 22, 1872: Following the Constitutional Convention of 1872, the West Virginia electorate ratified a new state constitution by a vote of 42,344 to 37,777. In the same election, the voters rejected a controversial convention proposition that would have restricted office-holding to whites.

Aug. 23, 1970: The Mormon Church established its first "stake," or congregation, in West Virginia. The stake was organized in Charleston with a membership of nearly 4,000 people.

Director and producer Morgan Miller is currently working on his newest slasher movie in the hills and rivers of Davis, Thomas and Canaan Valley titled "Tie Died." "Tie Died" started out as idea of Miller's over 10 years ago. The final draft of the screenplay was finished and ready for production in August of 2021. The movie is produced by Miller's film company called Sir Reel Pictures, LTD and has produced other films such as the awarded Best West Virginia Film "Charles the Tree" at the West Virginia Mountaineer Short Film Festival as well as commercials for hair products and music videos.

Miller has over 22 years' experience in writing, directing, and editing award winning films. Miller has a bachelor's degree in Film and Photography from Montana State University and has over 10 years of experience playing the piano and scoring music for films that have won multiple awards. Miller has worked on pieces with members of Gentle Giant, Frank Zappa's Band and Academy Award winner Erik Messerschmidt.

Miller said, "The synopsis of the movie is based on a park ranger that is investigating a series of murders that look like they

have been by a killer bear. I came up with the "Tie Died" idea around 10 or 12 years ago. At the bare minimum, the film will be aired on Troma, along with some festivals and streaming services. It would be nice to bring it out in some theaters locally."

Chris Phares is Miller's co-producer and make up specialist. A man of many talents, Phares also stars in the movie. His character portrays a beer hunter looking for a serial killer in his role. To look the part, Phares has been growing a beard and hair since December to give him the perfect look for his role. His look is similar to that of Bill Moseley that starred in the movie "The Devil's Rejects."

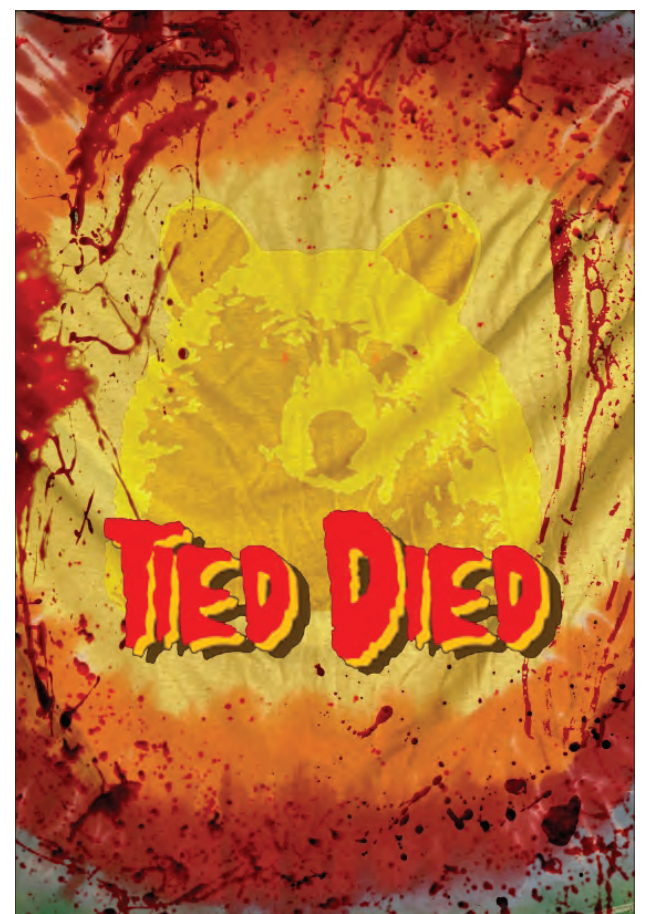
Phares has starred in other films such as *Bullseye Baby* produced by Miller. In this film Phares acts the character of "Sleazy Larry" as he deals with two home invaders who threaten his woman and manhood. This 10-minute film was completed in early 2019 and was selected into the ScareFest Horror Convention in Lexington, Kentucky.

The president of Troma Entertainment, Inc. is Lloyd Kaufman. Kaufman plays the leading role character as the park ranger. Kaufman has directed, produced, and played roles in many films such as "Class of Nuke 'Em High" (1986) and "Rocky" (1976).

The sheriff's role in the film is play by another big name in horror films, Joe Bob Briggs. According to Briggs' bio online "Briggs' acting persona is that of an unapologetic red-neck Texan with an avowed love of the drive-in theater. He specializes in humorous but appreciative reviews of B-movies and cult films, which he calls "drive-in movies".

Tucker County High School student Andie Cartwright is Miller's special effects make-up artist. Phares said, "She has been a good help and is doing an excellent job. And she got to play a dead body in the movie as well. She really wanted to work in this film, and we wanted to help her work in a couple of movies before she graduates and attends Savini's. Hopefully, we will be able to work with her a lot more and she can teach us some secrets." Miller said, "She is already pulling her own weight. She is good."

Phares said that Cartwright has plans to attend the Tom Savini's Special Make-Up Effects Program upon graduation. The program curriculum was designed by Tom Savini, the legendary horror special effects expert and make-up artist known for his

work in the *Friday the 13th*, *Dawn of the Dead*, and *Day of the Dead* movies.

Cartwright is not the only local to play a role in the film. Thomas' very own Fred Davis will also play the part of the friend to Phares' character the bear hunter as a bear hunter in his bear hunting truck and dog boxes. Miller said, "We have had an exciting time with him. He got to meet Lloyd too and they were both so different but enjoyed each other. He is a true West Virginian."

The film will host around 15 actors with all being local residents except for the two celebrity actors and filming should be concluded by the end of September. Miller hopes to have a good edit done by Christmas with the film ready for showing in the Spring of 2023. 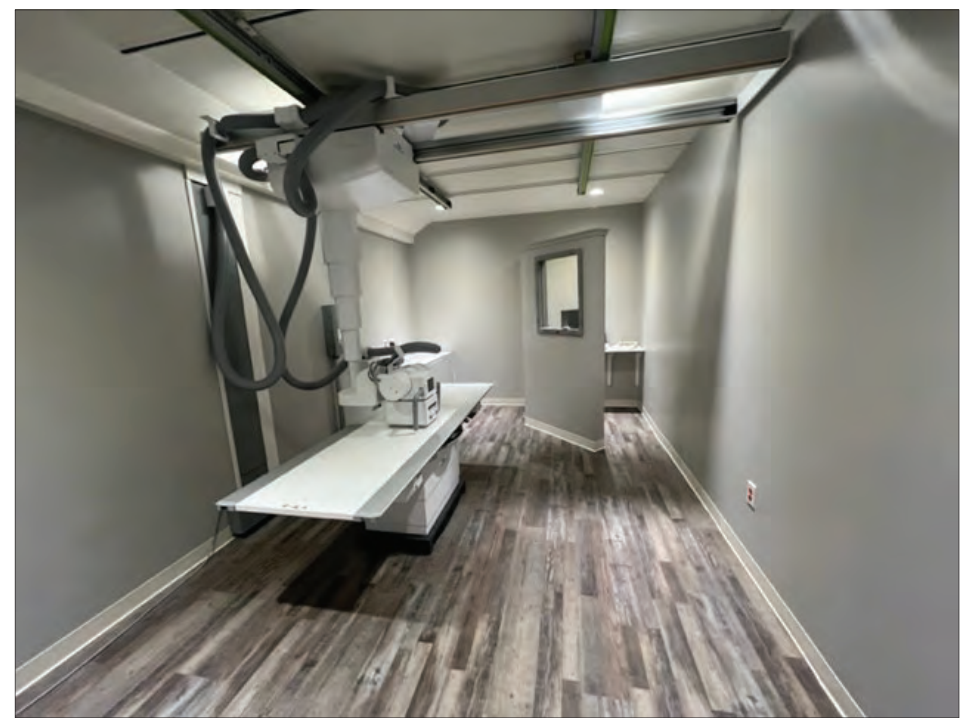
"The opening celebration is an opportunity for business leaders and invited guests to tour our newest facility," Wamsley said. "By opening a new location, we hope to
