The following criminal complaints have been filed in the Tucker County Magistrate office:

- **Jeanie Long**, of Parsons, was charged with one count of Truancy. According to the complaint the defendant did fail to cause her child to regularly attend Tucker Valley Elementary Middle School. The student has accumulated 15 full unexcused days. Records were obtained from the West Virginia Educational Information System and administrators at Tucker Valley Elementary Middle School.
- **Kenan Hatem Hossino**, was charged with one count of DUI First Offense. The complaint states that on Friday, Dec. 9 at approximately 4:56 p.m. Trooper C.A. Hawkins was dispatched via Tucker County 911 to a one vehicle MVC located at the intersection of Tuscan Ridge Rd. and Appalachian Highway.
- At the time of arrival the officer made contact with the driver, identified as the defendant, and observed the smell of alcohol on his breath.

At this time Trooper Hawkins conducted a breath test and the results were a BAC of .080. At this time he was transported to the West Virginia State Police Parsons Detachment to be processed via Live Scan.

The Sheriff's Soap Box

This section of the Newspaper is brought to you by Sheriff "Jake" Kopec as to raise awareness of the West Virginia State Law and to educate the public in laws that are set forth by legislation. This month I would like to discuss harassing phone calls. One of the key elements of this code section is intent to harass. Commonly this becomes an issue when the offender in the circumstance is told to stop calling or texting but the conduct continues.

The Code states :
§61-8-16. Obscene, anonymous, harassing, repeated and threatening telephone calls; penalty.

(a) It is unlawful for any person with intent to harass or abuse another by means of telephone to:

- (1) Make any comment, request, suggestion or proposal which is obscene; or
 - (2) Make a telephone call, whether or not conversation ensues, without disclosing his or her identity and with intent to harass any person at the called number; or
 - (3) Make or cause the telephone of another repeatedly or continuously to ring, with intent to harass any person at the called number; or
 - (4) Make repeated telephone calls, during which conversation ensues, with intent to harass any person at the called number; or
 - (5) Threaten to commit a crime against any person or property.
- (b) It shall be unlawful for any person to knowingly permit any telephone under his or her control to be used for any purpose prohibited by this section.
- (c) Any offense committed under this section may be deemed to have occurred at the place at which the telephone call was made, or the place at which the telephone call was received.
- (d) Any person who violates any provision of this section is guilty of a misdemeanor and, upon conviction thereof, shall be fined not more than \$500, or confined in jail not more than six months, or both fined and confined.

USDA Forest Service Closing Dolly Sods Roads for Public Safety January 3

PETERSBURG, W.Va., December 14, 2022 – Monongahela National Forest officials will implement the annual winter road closures in the Dolly Sods area by closing the gates on Forest Roads 19 and 75 January 3, 2023, the first business day after the holiday. These roads are closed to motor vehicle use from January to early or mid-April annually to provide for public safety due to variable road conditions in the winter months. Non-motorized use of the roads is allowed. "The road closures are put in place to ensure the safety of both visitors and employees," said Cheat-Potomac District Ranger Jon Morgan. "Forest visitors and emergency responders are put at

unnecessary risk without the road closures."

Both roads usually open again by mid-April. "We will monitor road conditions in March and April, and reopen the roads as soon as weather permits," Morgan said.

Staff from Monongahela National Forest work with local landowners and residents affected by the road closures to ensure they have access to their property. Landowners and residents who need access behind the gates should contact the Cheat-Potomac Ranger District office in Petersburg for assistance at (304) 257-4488.



on the vehicle were not registered to the truck Nuzum was driving.

Igland then obtained a search warrant for Nuzum's residence on Cheat Valley Hwy in Preston County and found Nuzum to be in possession of three firearms (two pistols, one shotgun), methamphetamines, marijuana, drug paraphernalia and a side-by-side Nuzum had been operating. One of the pistols had the serial numbers shaved off.

Nuzum's defense attorney Morris argued for the defendant to remain out on bail and that the defendant had a full-time job and placing him in custody would jeopardize that job. Judge Nelson replied, "I am not going to do it, not when you out riding around smoking meth and doing that sh*t. Not when you are on probation."

Nuzum was taken into custody with charges of failure to register with the registered sex offenders of the West Virginia State Police and violation of probation. His pre-trial is set for February 7, 2022.

Anthony Scott was not present in court for his case as there was a mix up at the jail for transportation. Scott is charged with felony harassment after violating a lifetime restraining order against his victim. According to Wilkins, Scott has continually violated the restraining order and is accused of traveling from Barbour County to physically abuse his victim. Scott's pre-trial motions date was set for January 24, 2023, and his grand jury trial is set for February 14, 2023.

Timothy Myers appeared in court after being detained for a capias issued at his

last court hearing when he did not appear before Judge Nelson. Myers was arrested one hour after the capias was issued at Community Corrections when he showed up for a drug screening.

Myers is charged with possession with intent to deliver (felony), reckless driving (misdemeanor), and driving on a revoked license for a previous DUI (misdemeanor). Myers is accused of possessing over \$5,600 worth of methamphetamine (meth) with the intent to distribute. The charge carries a one-to-15-year sentence and up to a maximum of \$25,000 fine. The reckless driving charge carries a five-to-90-day sentence with a \$25 to \$500 fine. Driving on a revoked license due to a prior driving under the influence (DUI) charge carries a \$100 to \$500 fine.

Wilkins argued that Myers should remain in custody due to him not abiding by his bond conditions, not showing up for other current court cases and the fact he has been arrested several times in recent months. Morris argued that the defendant had received head and leg trauma during his recent automobile accident and still suffers effects from those.

Nelson entertained a motion that Myers be placed on an ankle monitoring bracelet and Wilkins agreed to those terms. Myers was ordered to report the West Virginia State Police the same day he was released with ankle monitor and to return to court on January 24, 2023, for pre-trial motions.

Tammy Mook's defense attorney Easton explained to the court that Mook was not present in the courtroom because she was

receiving treatment at a clinic in Cleveland, Ohio and asked that the pre-trial be continued. Wilkins added that the counsels were close to a resolution on the case and asked for verification or documentation that stated Mook was actually in the clinic. Judge Courier stated he would continue pre-trial until January 12, 2023, at 11:15 a.m.

Courier then heard the competency argument for Herbert Bennett. After being evaluated Bennett was determined to be incompetent to stand trial. Courier order for Bennett to be placed in a state mental facility until he is competent and able to stand trial.

Bennett questioned how he was determined to be incompetent when he had refused to answer the questions presented by the state professional conducting the evaluation and said, "I refuse to go (to that

facility)! I am of sound mind. I refuse to answer any questions. You are wasting your time." Bennett declared his innocence and according to him the case should have been dismissed due to the fact that Wilkins was not present on the scene of the incident he was being charged with.

Bennett was charged with one felony count of wanton endangerment involving a firearm. According to the complaint on Wednesday, Oct. 19 Deputy C.R. Summerfield of the Tucker County Sheriff's Office received a complaint about a subject shooting one of the lights at the Family Dollar Store in Parsons.

Bennett's lawyer Timothy Gentillozzi explained that to Bennett that there was a report filed and he would make sure that Bennett received a copy of the report. No court date was set for Bennett.


rural businesses in these central West Virginia counties."

TUCKER COUNTY LANDFILL 2023 FREE DAY SCHEDULE

The Tucker County Solid Waste Authority has established the **first Thursday of each month as free disposal day**. If the first Thursday falls on a holiday, the following Thursday is designated as free day. Any person who is not a resident of West Virginia may only participate in the monthly free day upon proof that his or her state of residence would likewise allow West Virginia residents to dispose of residential solid waste in the same substantially similar manner.

The schedule for 2023 is as follows:

HOURS: 7:30 a.m. until 4:00 p.m.

Please note that closing time is 4:00 p.m. Allow adequate time to be unloaded by 4:00 p.m.

- UP TO ONE (1) PICK-UP TRUCK LOAD OR ITS EQUIVALENT PER HOUSEHOLD OF HOUSEHOLD RESIDENTIAL WASTE WILL BE FREE OF ALL CHARGES AND FEES (MAXIMUM WEIGHT OF 516 POUNDS) All loads over 516 pounds will be subject to the Landfill regular gate rate. All loads are subject to random screening and weighing. No preferential treatment will be given to either paying or non-paying customers on free day. Free day is only available to persons not in the business of hauling or disposing of solid waste.
- WE ACCEPT COMPUTER MONITOR OR TELEVISION at no charge.
- **NO DEBRIS (Lumber, Dry Wall, Paneling, Roof Shingles, Fencing, Yard Waste, etc.)** Only household residential waste is free of charges. Cost for disposal or debris is \$53.50/ton.
- **NO CHEMICALS, BATTERIES, OR FREE FLOWING LIQUIDS** including, but not limited to oil, paint, gas, and fuel oil. Paint cans must be empty, or paint dried out with lids removed.
- **NO APPLIANCES ACCEPTED CONTAINING FREON.** Customers must provide proof of Freon removal for the appliance to be accepted by the Landfill. All appliances will be accepted with the Freon removed (refrigerators, freezers, etc.) or that has no Freon (sinks, stoves, hot water heaters, microwaves, washing machines, dryers, etc.)
- **NO SCAVENGING.** Scavenging is prohibited by law and will be strictly enforced.
- DEBRIS MUST BE CONTAINED. Residential solid waste is not required to be bagged. However, all loads must be secured by a tarp or covering in a manner to present windblown material. Unsecured loads will not be permitted to dump.
- ALL LOADS ARE SUBJECT TO INSPECTION.
- TIRE DISPOSAL FEES. First ten (10) tires are free per driver's license, after that tires are priced as follows:

fication and return of their own members, and of all county and district officers, subject to regulations as may be prescribed by law.

The County Clerk responsibilities include the management of records of the county commission and election duties. The primary responsibilities center around two basic functions: to act as clerk (fiscal officer) of the county commission; and to act as the receiver of fees charged for the instruments filed and recorded within the county. To carry out the numerous duties, the clerk of the county commission may select deputies and other employees. The budget for the operation of the county clerk's office as a whole is determined by the county commission. The salary range for county clerks is from \$42,200 to \$55,440 and is required to be full-time in Class I-V counties.

The Clerk of the Circuit Court is elected in each county to carry out administrative functions and to act as record-keeper for circuit court actions in that county. The office of the clerk is authorized by Article 8, Section 9 of the West

Virginia Constitution. The Circuit Clerk is an officer within the judicial system and plays a pivotal role in that system. The West Virginia Constitution establishes a hierarchy of administrative control that gives overall authority for the entire judicial system to the Supreme Court of Appeals. Local administrative authority lies in the circuit court, including the office of circuit clerk with regard to the clerk's judicial functions but the clerk has autonomy to establish procedures and policies necessary to carry out statutory responsibilities. The salary range is \$42,240 to \$55,440 and is required to be full-time in Class I-V counties.

Tucker County Commissioners Meet with Delegate Elect John Paul Hott

Commissioners Rosenau, Moore, Davis, and new commissioner elect Knotts met with the House of Delegates Elect Hott to discuss some of the issues Tucker County faces. Rosenau went over several key items that need addressing for the county with Hott. An example of those issues included the Corridor H

from Parsons to Thomas/Davis and the minimum tax paid by big land holders like the State of West Virginia and Western Pocahontas. Rosenau said, "Half of the county is owned by the state or federal government. Then there is 30,000 (acres) owned by Pocahontas. They are paying the minimum taxes and that leaves the 42 percent of us in the county to pay it all."

Another issue discussed was the use of hotel/hotel tax monies usage and how it is being mis-handled by Air BnB. Air BnB is a company that rents out short-term rentals on-line. The county is having an issue with them because they are allocating the hotel/motel tax by zip code and with the eastern part of Tucker County using the same zip code there is mass confusion as where the tax money is supposed to go and how much is supposed to be awarded for each entity involved.

These were just a limited selection of issues discussed with Delegate Elect Hott. The commissioners covered many more with him. After the meeting Rosenau introduced Delegate Hott to the different departments in the county building. Hott joined the commissioners and county associates for the annual Christmas dinner hosted by the Tucker County Commission.



Event at Eastern marks recent CDL training program milestones

MOOREFIELD, W.Va. – Eastern West Virginia Community and Technical College's Workforce Education Department recently hosted a luncheon to mark several achievements and milestones with the college's CDL training program.

Megan Webb, dean of advancement and continuing education at Eastern, welcomed several program partners and community leaders to the celebratory event and luncheon held Dec. 14 at Eastern's campus in Moorefield. The luncheon was planned to mark significant CDL training program milestones and thank supporters, many of whom were present in the audience.

Webb introduced guests Tiffany Ellis-Williams of the West Virginia Council for Community and Technical College Education, Jim Linsenmeyer of the state's Department of Economic Development, Kyle Reedy of Pilgrim's Pride Corporation, David Workman of the Hardy County Commission, Freddie Davis of the Tucker County Commission, Greg Greenwalt of Eastern's Board of Governors, and Ward Malcolm, a Moorefield business owner who previously had been an administrator for the college's Workforce Education Department. Webb also recognized support from invited guests who were not able to attend that day, including state Sen. Randy Smith (R-Tucker), David Cooper of the Tucker County Community Foundation, and Adam Sand-

ers of the Steeley Foundation.

The luncheon's invited guests included representatives of organizations that had made significant financial contributions to the program in recent months, allowing the college to purchase two gently used tractors – one with an automatic transmission and with a manual transmission – and a pup trailer.

Webb closed her remarks at the luncheon by showing images of a co-branding project between Eastern and Pilgrim's Pride Corporation. The project, executed by LMC, a marketing agency in Elkins, features Pilgrim's Pride branding on half of the program's new pup trailer, along with Eastern's Workforce Education Department branding.

Melissa Shockey, Eastern's Workforce Education program director, then introduced Petersburg resident Mike Sites, CDL instructor, to the audience, and explained how Sites had initiated the transformation of the program by redeveloping its curriculum so the training program could be registered with U.S. Department of Transportation Federal Motor Carrier Safety Administration (FMCSA) and meet the latest federal requirements.

Sites subsequently introduced Eddie Mullenax of Petersburg as the newest CDL instructor in the program. With Sites and Mullenax working together, Sites said, they have been able to divide up tasks and spend more time with each student,

especially in the trucks, and that one-on-one instruction was improving the learning process for students. Also, based on comments from students who have earned their licenses and are driving, those students were well prepared when they entered the workforce.

Since September, Shockey said, 20 students have enrolled in the CDL training program at Eastern, with 14 finishing and earning their CDL license, and six still completing training hours. Nearly all of the program completers are employed.

The luncheon was concluded by Eastern's president, Thomas Stripplin, who credited the state's Higher Education Policy Commission and the West Virginia Community and Technical College system for supporting workforce education. Stripplin said Eastern was doing everything it could to provide workforce training, like the CDL training program, to fill workforce needs in the Potomac Highlands, and that the college valued support from its partners and the community to meet those challenges.



“We rarely get to mark a milestone such as this and celebrate a resident turning 106 at Cortland Acres,” Clevenger said. “Throughout his life, Ira has touched countless individuals, families, and organizations in Tucker County and internationally. He is such an inspiration to the staff and other residents at Cortland Acres. He is a goal-setter and an achiever, and it’s important to recognize and honor Ira on his special day.”

Staying busy is a lifestyle Miller followed when he lived at home. Luckily, he

can continue to practice a habit, as Cortland Acres offers plenty of daily activities for its residents.

On the first of each month, the Cortland Acres Activities Director Marie Grafton publishes a monthly calendar full of daily happenings along with a monthly theme dinner. Miller reviews the calendar carefully each month, highlighting the days and locations of one of his favorite activities, bingo.

“Ira never misses a bingo game,” said his niece, Marlene Lucente, with a smile.

When he isn’t playing bingo and tallying his winnings, Miller enjoys visiting with friends or members of his extended

family. He is also pursuing a new hobby, Diamond Dot painting.

“Right now, I’m making a picture of a jersey cow for my granddaughter,” Miller said. “Helen Roth (a Cortland Acres resident) taught me the art and checks in on my progress almost every week.”

Miller lived at his farmhouse in Dry Fork until the summer of 2021, when an accident caused him to lose part of his leg.

“I have been mowing my yard, my son’s yard, my church’s yard, and the cemetery for years,” Miller said. “One day, I was in the orchard, and the mower went over the hill. I hollered for my son, who was in the house. Luckily he heard me, came out, and got help.”

After surgery and a stay at an inpatient rehabilitation center, Miller arrived at Cortland Acres in September 2021. Now, he rolls around the Cortland Acres with minimal help, visiting fellow resident friends and enjoying the activities.

Miller credits God for him surviving the accident and living a long life.

“God’s been good to me my entire life,” he said, noting that his mother lived until she was 104 years old.

Miller has always been inspired to give back whenever possible. Besides bingo, one of Miller’s favorite activities is packing shoeboxes for Operation Christmas Child.

Since turning 100, Miller has packed over 1,543 boxes. He often packs the shoeboxes with the help of his daughter, Debbie Welch of Oakland, Md. Welch serves as Operation Christmas Child’s area coordinator for West Virginia’s Eastern Panhandle and has traveled overseas with the program distributing the boxes.

Miller started packing shoeboxes with his church, where the congregation filled 40 each year. He felt it was important because the shoeboxes could go to places that missionaries could not.

Miller was born on Jan. 28, 1917, in Yoder, Kansas, and grew up with 12 brothers and sisters. His family moved to Indiana when he was young and later to Delaware before coming to West Virginia.

Miller has lived in Tucker County for more than 65 years. He has seven children, 17 grandchildren, and 14 great-grandchildren. He was married to Mary Olive for 56 years before she

passed away ten years ago.

In his lifetime, Miller has been a farmer, a school bus driver, a mail carrier, a carpenter, and also did masonry work. Recently, he served as the grand marshal in the Thomas Mountaineer Days Parade.

Miller was raised Amish and fondly recalled farming with horses. “It was very economical but hard work,” he said. “We were always healthy and strong.”

He laughed as he recalled the day his father purchased his first car and took the family for a ride.

“My mother told dad that you can’t go over 20 mph; if you do, blood will come out of your nose,” he said.

A couple of times a month, Miller’s family takes him home so he can spend a few days at the farmhouse in Dry Fork. He is looking forward to returning and spending time with his family over the holidays.

The Cortland Acres campus includes a 94-bed long-term care facility, inpatient and outpatient rehabilitation programs, rental apartments in Pineview and garden and patio homes in The Pines. Holiday Impaired Driving Enforcement Mobilization Begins

GHSP Reminds Drivers: Drive Sober or Get Pulled Over



CHARLESTON, WV — The West Virginia Governor’s Highway Safety Program (GHSP) is conducting a high-visibility enforcement mobilization beginning today through New Year’s Day as part of its ongoing efforts to reduce impaired driving in West Virginia. The GHSP is partnering with the U.S. Department of Transportation’s National Highway Traffic Safety Administration (NHTSA), as well as state, county, and municipal law enforcement agencies across West Virginia for this high visibility enforcement effort. This enforcement effort aims to keep drivers who are impaired by alcohol, drugs, or certain impairing medications off our roadways so that all road users are safe this holiday season.

According to data from NHTSA, 11,654 people were killed in motor vehicle crashes that involved an alcohol-impaired driver in 2020. During the month of December between 2016 and 2020, more than 4,400 people were killed in drunk-driving-related crashes. Although it is illegal to drive when impaired by alcohol, in 2020 one person was killed every 45 minutes in drunk-driving crashes nationwide.

“West Virginia law enforcement officers have zero tolerance for impaired driving,

especially during high visibility enforcement periods like this,” said Bob Tipton, GHSP Director. “The privilege to drive carries with it many responsibilities. You, and only you, are responsible for your actions. One of the responsibilities required of drivers in West Virginia is to not drive while impaired by alcohol, drugs, or impairing medications—whether prescribed or over-the-counter, such as allergy medicine.”

In 2021, there were 280 total roadway fatalities in West Virginia. Of those, 46 involved an alcohol-impaired driver.

“The most tragic thing about the alcohol-related fatalities is that they are preventable,” said Steven Jarvis, GHSP Impaired Driving Program Coordinator. “We want the motoring public to understand impaired driving isn’t just a ‘mistake.’ Driving while impaired by alcohol or drugs is a selfish, deadly, and illegal choice—especially with the available options for ride share services and taxis.”

The decision to drive sober should not be a difficult choice. In West Virginia, it is illegal to drive with a blood alcohol concentration (BAC) of .08 or higher. Drivers need to ask themselves if the risks are worth the gamble. Not only do drunk drivers put their own lives at risk, they endanger everyone they encounter on the road. The costs can be financial, too. If you’re caught drinking and driving, you could face jail time, lose your driver’s license and your vehicle, and pay up to \$10,000 in attorney’s fees, fines, higher insurance rates, and lost wages.

The GHSP reminds West Virginia drivers to celebrate with a plan this holiday season. There are many resources available to get drivers home safely. It is essential to plan a sober ride home before you ever leave for the party. The GHSP recommends these

safe alternatives to drinking and driving:

- Remember that it is never okay to drink and drive. Even if you’ve had only one alcoholic beverage, designate a sober driver or plan to use public transportation or a ride service such as Uber or Lyft to get home safely.
- If available, use your community’s sober ride program, such as IntoxiTaxi or similar programs.
- If you were not planning on drinking but end up having one, call a trusted sober friend or family member and ask them to drive you home.
- If you see a drunk driver on the road, contact local law enforcement or dial *77 for the West Virginia State Police.
- Do you have a friend who is

about to drink and drive? Take their keys away and make arrangements to get your friend home safely.

“We want everyone to be as safe as possible on West Virginia roads this holiday season and year-round. We hope drivers will be safe and make responsible choices. Impaired driving is one hundred-percent preventable. Don’t make a selfish choice that puts yourself and others at risk,” concluded Jarvis.
