CHARLESTON – The Lady Mt. Lions opened State Tournament play against Tolsia on March 8th at the Charleston Coliseum. Tucker County got off to a slow start, but a big second half allowed the Lady Mt. Lions to win the contest 66-44.

The Lady Rebels controlled the first quarter as Tolsia led after one quarter 12-8. Tucker County fought back in the second quarter as they outpaced Tolsia in the second 14-10 to tie the game 22-22 at the half.

The Lady Mt. Lions started to pull away in the third quarter as Tucker County outscored Tolsia 20-10 in the third to give Tucker County the 42-32 lead after three. In the fourth quarter the Lady

City Council discusses concerns before approving minutes

Approval of the City of Parsons Council minutes was not an easy feat for the Council during the latest meeting. Councilwoman Kathy DiBacco started the debate by saying that she felt the wording under the "Public Comments" section was offensive and inaccurate. The section read, "Rebecca Myers voiced concerns and disrespectful treatment of a current employee, and presented awarded accolades achieved over 22 years from that employee that is working for the city." DiBacco said, "I do not like what was written. I am not sure if it should even say voiced concerns and disrespectful treatment of a current employee. I think it just maybe say Rebecca Myers. If you want to say that I think it gives too much information or just kind of negative information. I would prefer it say Rebecca Myers spoke to the

Acting Recorder Councilman Tim Auvil said, "I tried to make it as simple as possible." DiBacco said, "Rebecca Myers spoke to the Council, that would be more simple and

less offensive." The discussion led to whether there should be detail under public comment and it was stated that it had been before to explain why the guest was there. Councilman Tim Turner said, "This is the way it works. If Kathy has an objection to something, when we vote, we vote with her recommended change and if that does not pass then it does not

change and if it does it is changed."

Acting Mayor Bruce Kolsun said,
"It seems like we pick and choose
who we want to say a lot about and
who we do not want to say a lot
about." DiBacco said, "No, I think
this is giving to much credence to
what Rebecca Myers said. I think
Rebecca Myers voiced concerns and
you want to do that and end with
employee and do not have presented

accolades that is totally irrelevant."

Turner added by saying, "I do not think disrespectful treatment is appropriate because then you are saying that it did happen. Can you prove that happened? I mean this whole thing is going to head for a bad situation here shortly." Councilwoman Melissa Jones said, "My concern is that if we put that in there disrespectful treatment of employees and pre-

sented all those awards whenever she spoke you as Acting Mayor should have said something to her just make sure it did not come off as disrespectful treatment. We all understand what is going on around here."

Kolsun said, "It is not my place to stop a comment person." Turner remind Kolsun that it was his place as Acting Mayor to do so when specific Council members were mentioned to which Kolsun denied there be any mention of specific council members and Jones stated that yes there was. After more heated discussion it was voted to delete all wording and let the section be read as Rebecca Myers spoke.

Councilman James "Sam" Humphrey asked, "That night she was in here and I wanted to speak you stopped me. Why?" Kolsun answered "Because the thing is, Council is not to interact with guests. Is that so a negative thing that you are going to get into a confrontation with her to no end. I stopped you because we are not supposed to interact with guests." Humphrey said, "I appreciate you stopping me because I had a lot to say. I really did." Auvil said, "We can comment if they ask questions you

TC Commissioners not giving up on Senate Bill 429

The Commissioner gave an update on the Senate Bill 429. This bill would place a \$1 fee on entertainment tickets throughout the County to help fund EMS and fire departments. Rosenau explained, "It would help with fire companies in the state and EMS. It would be \$1 put on tickets for an amusement or recreation thing. We have had so much push back it has been unbelievable."

Rosenau explained how things worked in Charleston by saying, "A bill is presented by a Senator or Representative. Senator Randy Smith introduced this bill on the Senate side. It passed the Senate side and was sent to the House. It was assigned to two committees. The first committee it was assigned to was economic development/tourism. Gary Howell is the chairman of that committee. Until Delegate Howell says it can be brought by committee it lays there.

We called Delegate Howell's office. I called him personally every day since it was assigned to him. Not one time has he returned my call. I called his office requesting a meeting and the Tucker County Commission would go down anytime he says he is available. Well, he was out sick for two days. I called again. The secretary who is a wonderful lady and very nice said 'Commissioner Rosenau I will try my best to get ahold of Delegate Howell to see if he will be available to have a meeting with you.'

Well, the secretary about twenty minutes later called me, and she said Commissioner I am really sorry, but Delegate Howell does not want to meet with the Tucker County Commission. The delegate did not want to meet with the Tucker County Commission!

Delegate Howell represents Mineral County. Your Commission made a trip to Mineral County last week and asked their Commission directly since Delegate Howell is their state representative would you please contact Delegate Howell because he is not returning our calls. They said sure. Right in front of us they get on their phones and start texting Howell that this is a good bill please get back if there is any questions with the Tucker County Commission. Guess what? Nothing.

Delegate Howell guess he assumes that he knows what is best for our county or for any county in West Virginia that has a volunteer fire company or EMS. Like I have told the community hundreds of times, tourism is a hard thing to fight at our state capital, but if there is no ambulance there to take the tourist (if something was to happen) what reflection is that on the State of West Virginia and what reflection is that of Tucker County.

That is why we have fought so hard for years to put \$1 on amusement in Tucker County. One dollar! Our delegate told us 'Well, Mike, it does not look like it is going to the floor this year. Next year we are going to form another game plan."

Davis added by saying, "I asked Mr. Hott, our delegate, he said it is not going to go through this year, so I said do me a favor and give me a call in two months

when this is over. Let me know what we must do to make things right and make this pass. He tried to tell me it was over a \$1 for a thing of golf balls. I started laughing on the dollar. People are not going to go on vacation if it cost an extra dollar. (What Davis is hearing from other people.) When I go on my vacation to Gettysburg, I love it. I do not call and see if they raised anything for \$1. If you are going you are going. I am tired of hearing the bull crap about it.

I love tourism. I love people coming here. That pays our bills. A lot of people get aggravated about it, but we cannot have anything unless we have tourism to pay our bills. If they pull out and leave, we would be broke. That is a fact."

Rosenau said, "The only thing I am asking of tourism to do is the same thing we Commissioners do. We pay our share for emergency services out of our taxes that we receive in this county. The only thing I am asking is if you are a guest coming to this county to entertain yourself in Tucker County, please pay a portion of it. Because it is hard for us, 6,500 people, to support one million guests coming each year.

When our emergency services are on a call here and we have one squad 24/7 and they have done a wonderful job of trying to fill in the gaps of when our peak times are to have a full squad, but we have a budget that is so tight. What I am asking is they pay \$1 for their fair share. To me it is a no brainer."

Davis explained that they do their best as Commission to take care of everyone with the hotel/motel tax. Davis said, "We try to help everybody with that. We used to have coal mines that helped everybody out, but we do not have that anymore. We help our community centers, our places where we have emergency shelter, our fire departments, and when you only have so much money you try to help people with that."

Rosenau went to explain that tourism gets 50 percent of the hotel/motel tax right off the top and that there was no justification for the Commission to ask for help with what the county needs for the EMS and fire companies. They are a non-profit organization, so they do not follow the same guidelines as every other ethics commission such as the Commission has to follow. Rosenau said, "We give \$100,000 to our EMS. We give \$100,000 to our fire companies. We give \$110,000 out of our regular budget for EMS. We had extra funds out of our hotel/motel tax budget last year, so we gave the EMS \$40,000 and each one of fire companies \$10,000. We give our share."

Animal Shelter Director Bailey Falls presented her monthly report to the Commission. Rosenau asked for an update on the dog that gained a lot of attention for being tied to a tree and shot in the neck area. Falls reported that the dog was doing great and will be continued to be cared for by the vet's office until the end of the week, and thanks to the huge support of the community the shelter was able to raise \$13,000 in donations. Falls said, "We were able to pay off all of the vet's offices that we work with and it was amazing how the community came forward." The incident is under investigation in cooperation with the Tucker County Sheriff's Office.

Rosenau said, "The bad part was the dog getting injured. The next part is what Tucker County is made of and that is people coming together and helping."

The Commission then accepted with regret the resignation of Margaret "Maggie" Keane as Animal Control Officer.

Eldon Plaughter was re-appointed by the Commission to the Parks and Recreation board. His term will expire December 31,

Assistant Director Kathy Phillips spoke to the Commission concerning the budget for the Five Rivers Public Library in Parsons and the Mountain Top Public Library in Thomas. Phillips thanked the Commission for their past support of the libraries and asked for continued support. Phillips said, "Libraries are a vital part of the community, small or large. We do make a difference in the lives of many people."

Five Rivers was requesting a budget funding of \$12,000 and the Mountain Top Library requested \$14,500. Rosenau said, "Last year we gave \$12,000 plus \$3,500 from a grant that we had for reimbursement from COVID. What we need from that additional money last year as we explained to you is we need receipts. That must be justified through our grant." Mountain Top Library Director Debbie Williams stated that they were not made aware of that request but would get the needed information to the Commission.

Commissioner Fred Davis made a motion to grant both libraries the requested amounts. Motion passed. Davis also congratulated the Mountain Top Library for placing second among all the libraries in the state of West Virginia. The trailer the library is in has been there since 1978 and needs replacement.

EMS Director Amanda Simmons presented to the Commission a request for replacing EMS' cot systems. The new cot loading system will cost \$67,000. The warranty will cover three years for the cot and two years for the stabilizing plate. Rosenau explained, "The cots we have now are very old. The cot systems we have now on our ambulances they require the EMTs or paramedics to actual lift so if my fat butt is on a gurney and try to lift me up and take me down the steps it is going to be hard to do." The cots weigh about 150 pounds just by themselves but the new cots will be self-loading and can literally be pushed into the ambulance with a finger for up to a 700-pound patient.

Commissioner Tim Knotts made the motion to fund EMS \$67,000 out of the ARP (American Rescue Plan) grant fund for a new cot lift system. The motion was approved. Rosenau said, "It has been a pleasure the last couple of months working together."

Chair of Homeowners Voice Kathryn "Kathy" J. Knight informed the Commission of her partnership with West Virginia's Attorney General's office to advocate for HOA (Home Owners Association) of any type throughout the state. Knight said,

"We are partnering with the Attorney General's office to bring forth legislature in the 2024 session of some type because West Virginia has never had, ever, legal oversight of any type for HOAs.

There are two main problem areas for HOAs. We have the rogue HOAs and the zombie HOAs. The zombie HOAs are the ones that can not die. Somebody somewhere 20 years ago handed somebody in the county clerk's office a piece of paper that said they were an HOA. Delegate up and dies, moves, or goes bankrupt you can not undo that in the present scenario at all. The Attorney General's office has no oversight if something goes awry i.e., rogue HOA. We are 501c4 which means we can lobby, and we just came back from the legislature last week."

A 501c4 is a tax code identifier used by the IRS for non-profit organizations that promote social welfare causes. Examples of 501c4 organizations include civic leagues, volunteer fire companies, and tenants' rights groups. Knight explained that the Homeowners Voice is part of projects such as broadband initiative and food pan-

Development Authority Director Steve Leyh requested a funding match for the Prodigi LEAD Broadband Project. Leyh

said, "As you know broadband is a major issue for the county. This project is a state grant called the Line Extension Advancement and Development Program or LEAD program. We have an internet service provider that is interested in applying. That is how the program works. They want to run 126 miles of fiberoptic cable through Tucker County through Aurora to the central part of Tucker County.

Every address that they pass that is not identified as targeted they must pay a fee of \$500. It comes up to about \$900,000 worth of fees for those served addresses to hit the locations that are unserved. Mr. Waltrin from Prodigi is going to ask the state to waive some of that given Tucker County's remote nature and given the fact that we have a very tiny budget and we do not really have the resources to

do that. But it does look good if the County Commission has some skin in the game and contributes towards this project."

If the project was granted by the state, the total cost would be an estimated \$7.7 million. Prodigi has agreed to pay the match of \$71,000 on the 146 miles through Preston County. There is no guarantee that Tucker County will receive this grant but Leyh said, "We have a shot and this is a good project. Prodigi is based in Preston County and they have had multiple rounds of success with the program."

Rosenau said that during current work sessions with Leyh it was discussed what would be needed for a match. Rosenau motioned for a grant match of \$50,000 from the ARP grant funding contingent upon the approval of the LEAD program grant. The motioned passed. This will bring another fiber optic internet provider competitor to the county if approved.

A memorandum of understanding with Community Corrections was approved. The grant received for the Community Corrections program has saved the county thousands of dollars.


The next meeting of the Tucker County Commission will be held on March 22, 2023, at 4 p.m. and located at the Tucker County Courthouse Courtroom.



Disclaimer: this document is not speaking for Davis' Corridor H Committee. I reiterate my earlier position: DOH should be required to newly consider a Corridor H, northern alignment. Reasons: read on.

During a recent town council meeting attended by citizens of both Davis and Thomas, DOH representative Travis Long appeared and indicated DOH is proceeding with the ROPA based upon the 2003 letter of endorsement from the then Davis Town Council. He indicated no other route is being considered. He failed to consider-DOH's rationale of using Davis' 2003 letter of endorsement is no longer

Davis' 2003 letter to DOH:

Something significant has changed and other than a recent Letter to the Editor in the Advocate, few have seemed to have noticed.

ADOPTED: September 10,

Davis supported a ROPA that ran from the current 4-lane east of Davis to an interchange on the south, Elkins side, of Parsons. But, the Parsons' interchange has now been moved to the north, St. George side, of Parsons. The current ROPA is not the ROPA the Davis Town Council endorsed! Davis' 2003 endorsement is no longer valid in supporting DOH's opinion the ROPA is "...the most cost efficient and feasible route." From the current Parsons' interchange a northern route, as in the 1-D east alignment, is clearly shorter and more

direct. Travis used a recent diesel spill on 219 to bolster the dangers of building a highway over a town's water supply, yet that is precisely what DOH has proposed doing for Wardensville and has done in countless other communities. As DOH explained, with a proper highway design, concerns about a highway affecting a town's water supply are unfounded.

In summary Davis has not endorsed the ROPA as it currently exists and should make that clear to DOH. A northern alignment is shorter and does not divide the towns of Davis and Thomas. It further requires no expensive, multi-turn, truck route around Thomas and removes the need for a 175-foot-tall bridge over the Coke Ovens that Travis suggested is now even longer (and more expensive.) This northern alignment is supported by a preponderance of local businesses, citizens, and the Tucker County Chamber of Com-

merce-in 2023, not 2003! Davis or some other entity or entities should communicate promptly and legally with DOH and advise them-when DOH moved the Parsons' interchange, that change rendered Davis' original ROPA endorsement null and void. DOH should have requested a new endorsement based on the route having been changed. As DOH did not request a new endorsement, planning and construction related to the

ROPA-without current the required community endorsement-should cease. DOH should immediately proceed with an honest investigation of what may now constitute a new, locally supported "preferred-northern-route."

Reflecting the views of a recent letter, I am not adamantly advocating-GO NORTH; rather suggesting DOH be required to consider that alternate in light of 2023 realities and sensibilities. Travis indicated DOH might have an SEIS available in 2024. This NEPA mandated Supplemental Environmental Impact Statement was created to qualify design choices. The SEIS function is not to explain or justify what you have already done! If, as Travis has said, DOH is proceeding with the ROPA, a 2024 SEIS is pointless and superfluous.

This area has grown and matured: this is not the Davis and Thomas of 20 years ago. Today's decisions should reflect today's realities and priorities.

Over 5,000 individuals have now signed a Change. org petition advocating for a northern route for Corridor H between Parsons and Davis. Thomas resident and Tucker County native Rachelle Davis initiated the petition titled A Better Route for Corridor H.

Davis said that she started the petition to make it convenient for local residents to voice concerns about the West Virginia Department of Highways' (DOH) preferred route known as the Revised Original Preferred Alternative (ROPA). "When public meetings resumed with DOH representatives, we were shocked to be presented with just one route. Many of us of fully expected to see at least two options," Davis explained.

"The petition has been shared 1,365 times since June, so naturally, not

endorsed it is from the area or even the state," Davis said. "It has reached a wide audience of locals, former residents, second homeowners, vacationers, and those who have other ties to the area or who just appreciate our unique region and the road's potential impact on us. People are especially familiar with Blackwater Falls State Park and the Blackwater Canyon, great areas of concern," she added.

A paper petition also is circulating locally, and hundreds of individuals and business owners have signed that version to support a different route from Parsons to Davis. Both petitions state that the DOH-favored route would undermine the connection between the local communities and make it dangerous to travel between

the towns on foot or bicycle. "An elevated 4-lane highway through the beautiful Blackwater area is not in the interest of the local economy. Valuing our natural resources and public lands adds to our quality of life and draws people to our communities. These visitors create jobs in Thomas, Davis, and Canaan Valley."

Hendricks resident and Tucker County native Lucas Warner is one of 180 Change.org petition signers who provided a comment along with his signature. "The northern route preserves the historic and scenic integrity of the communities and landmarks through which the highway passes. It is not only my home but is, in fact, one of the primary destinations of the corridor for folks traveling from both directions," Warner stated.

Davis business owners and other individuals filled Davis City Hall to capacity during a recent meeting of the city council where project engineer Travis Long and other DOH representatives were invited to address questions. Saundra Goss, owner of a popular Davis restaurant, was on the

Charleston WV – The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

March 15, 1882: Union leader Frank Keeney was born on Cabin Creek. Kanawha County. Keeney, who went to work in the mines as a boy, became a rankand-file leader during the Paint Creek-Cabin Creek Strike of 1912–13.

March 15, 1952: Governor Earl Ray Tomblin was born in Logan County. He was elected as a Democrat from Logan County to the House of Delegates in 1974, when he was only 22 years old and still a senior at West Virginia University.

March 16, 1906: Country musician Buddy Starcher was born Oby Edgar Starcher near Ripley. In 1946, Starcher cut his first recordings on Four Star, including his best-known composition, "I'll Still Write Your Name in the Sand," which became a hit in 1949.

March 17, 1837: Mercer County was created from parts of Giles and Tazewell counties and named for Hugh Mercer, a Revolutionary War general.

March 17, 1858: William Edwin Chilton was born in Coalsmouth, now St. Albans. A lawyer, U.S. Senator and businessman, Chilton expanded Charleston's electric streetcar system and was publisher and editor of the Charleston Gazette.

March 17, 1891: West Virginia State University was founded as the West Virginia Colored Institute by the legislature. It was one of 17 Black land-grant colleges established under the Second Morrill Act

March 17, 1912: Athlete Joe Stydahar was born in Pennsylvania. A star in football and basketball at WVU, he was the first-round selection of the Chicago Bears in the first NFL draft of college players in

March 18, 1820: William Stevenson was born in Warren, Pennsylvania, but later moved to Wood County in western Virginia. In 1868, he was elected the third governor of West Virginia.

March 18, 1922: Athlete Frank "Gunner" Gatski was born in Farmington. Gatski played 11 years for the Cleveland Browns (1946-56) and one for Detroit Lions (1957). He played in 10 championship games, eight on the winning side.

March 18, 1950: Actor Brad Dourif was born in Huntington. He is best known for his portrayal of offbeat characters, including Billy Bibbitt in One Flew Over the Cuckoo's Nest and Grima Wormtongue in Peter Jackson's Lord of the Rings trilogy.

March 19, 1925: Basketball teams from 11 of West Virginia's 24 African-American high schools took the court at West Virginia State College (now University) in Institute for the first West Virginia Athletic Union (WVAU) state basketball tournament. Lincoln High School of Wheeling defeated Kimball, 25-24, in the final game to win the championship.

March 19, 1992: Four miners were killed at the Blacksville No. 1 Mine in Monongalia County while it was being sealed. Drainage pipes were being welded together, and a spark fell into the shaft, igniting methane gas.

March 20, 1849: Businessman James Kay was born in Scotland. He constructed the coke ovens at Hawks Nest, installed a cable car to carry coal across the New River, and installed a tramway to move miners and coal up and down the gorge face at Kavmoor.

March 20, 1897: Musician Frank Hutchison was born in Raleigh County. With a slide guitar sound akin to the bottleneck style, he helped instill a blues strain into modern country music and was influential among coalfield musicians.

March 20, 1936: Recurring storms led to major flooding on the Potomac River, hitting record levels in Harpers Ferry. The Ohio River at Parkersburg reached 10 feet above flood stage.

March 21, 1914: The first West Virginia boys' high school basketball tournament began in Buckhannon. The event was sponsored by West Virginia Wesleyan College, which at the time had West Virginia's largest and finest gymnasium.

March 21, 2018: Sculptor Frank Gaylord died. Born 1925 in Clarksburg, his best-known work is "The Column," a platoon of 19 larger-than-life, stainless steel soldiers comprising the central element of the Korean War Veterans Memorial in Washington.





This road was kept above an elevation of 3000 feet so the dam (proposed Canaan Valley Dam) would not flood it when constructed. The road is known as Route 32 and the work began in 1932 and ended sometime in 1937. Many folks refer to this section of road as Canaan Straight. The road did not have a hard top surface in 1936 when the first school bus ran from the Valley to Davis. As you can see, the road is not paved in the photo. Kids Kick Opioids has drawn more than 14,400 entries since its inception.

Students can work individually or in groups. Submissions may include drawings, poems, letters or anything that would promote awareness.



The winning entry will appear as a statewide newspaper public service announcement. Regional winners will be displayed in the State Capitol.

Thousands of West Virginians have lost their lives to a drug overdose, many of which were opioid related.

Reversing this trend has been a top priority for Attorney General Morrisey. He has fought the epidemic on multiple fronts, including a lawsuit against the U.S. Drug Enforcement Administration that achieved sweeping reforms to the nation's

drug quota system.

The Attorney General also has battled the opioid crisis with civil litigation, multistate initiatives, funding to target opioid abuse, criminal prosecutions, new technology, engagement with the faith-based community and education.
