
Tucker Boys' Fall in State Championship to James Monroe 66-35

CHARLESTON – The Mt. Lions Boys' Basketball team traveled to Charleston to compete in the WV State Tournament. Tucker County faced off against East Hardy in the first-round game on Wednesday March 15th. The Mt. Lions pulled away in the third quarter to get the win over the Cougars 77-51.

Tucker County got off to a good start in the game as they led after one quarter 25-10. East Hardy battled back in the second as the Cougars outscored the Mt. Lions 17-11 to make the halftime score 36-27 Tucker County.

The Mt. Lions would explode for 23 points in the third quarter, while holding East Hardy to 9 points in the period to make the score 59-36 after three quarters. The final quarter was also won by

Tucker County 18-15 to give the Mt. Lions the Quarterfinal win by the final score of 77-51.

Tucker County was led in scoring by Trevan Bonner with 17 points and Levi Bennett added

TVEMS Robotics Team Spreading Positive Message

The Honorable Judge James Courrier presided over cases for Tammy (Nelson) Mook, Bradley Henline, and Emily Heckler.

Mook was indicted on two felony counts of burglary, two felony counts of grand larceny, two felony counts of receiving, transferring, concealing stolen property, and two felony counts of conspiracy in June of 2018. Since this time, she has been convicted of one count of felony burglary and received three years of probation and ordered to pay restitution within a year. The next jury trial is set to begin on June 9 after Mook did not accept a plea bargain presented to her by Tucker County Prosecuting Attorney Savannah Hull Wilkins. The trial will hear witness testimony from three witnesses on behalf of the defense that would include an officer of law, the homeowner of the home allegedly burglarized, and a co-defendant. Pre-trail motions are set for May 18 at 1:15 p.m. Henline has been evaluated by a state approved professional and has been deemed competent to stand trial. Magistrate Court had sent the case to the Circuit Court level to get the needed evaluation and after being found criminally responsible for his actions Henline's case was referred back to Magistrate Court for further proceedings on March 22 at 10 a.m. Emily Heckler was represented, in court, by her attorney, Jeremy Cooper, to file a motion to allow E. Heckler to start community integration. Community integration would allow Heckler the privilege of leaving the Highland Acute Behavioral and Mental Health Hospital, in Clarksburg, on day trips with a group of other patients. The patients would go to places like the movies, shopping, or restaurants.

Students from the TVEMS Innovation Project Robotics Team, led by Christine Ward, presented the Tucker County Commission with their First LEGO League projects. Oliver Archuleta, Lela Wright, Shilah Jones, Lylee Jones, and Logan Kopec gave an informative presentation on renewable energy. Archuleta said, "We are one of the first LEGO League's representing Tucker Valley. Each year our robotic teams are consistently creating innovation projects. Each team in the league identifies a problem related to the theme of the challenges for the year and comes up with possible solutions for that problem. Then the team presents their projects to a group of judges at the end of the meet."

This year's theme is "Superpower". It relates to energy production, conservation, and clean energy. The administrators of the First LEGO meet wanted the students to imagine a better energy future. Their answer was to research different alternative forms of clean energy, advocate clean energy conservation, and spread awareness for the importance of clean energy. This year for their innovation project they hope to advocate some of the main ways citizens as individuals can conserve and use renewable energy. They have created flyers to spread awareness and put them up around the county.

Hydropower was introduced by the students, and they said, "One way to use renewable energy within your home is hydropower. Hydropower uses moving water to flow through a pipe or penstock (A penstock is a sluice or gate or intake

structure that controls water flow, or an enclosed pipe that delivers water to hydro turbines and sewerage systems.) to push against or turn blades in a turbine to produce electricity. We researched different ways to install hydroelectric into residential homes and found multiple things people can place in their homes to utilize hydropower. Such as a hydroelectric closet that produces electricity by the water used to wash your hands and a hydroelectric turbine generator that you can place in nearby creeks, streams, or rivers to create hydroelectric power."

The students explained how just using hydropower for half a year could save an estimated \$500. They explained that even the cheaper \$200 wind turbine could produce 600 watts of energy which would average around \$4.17 a year where it would normally average around \$1,000 a year.

The general goal for the team presenting to the Commission was

to inform and spread their message for their cause. They will continue to place flyers around the county to inform people on how to conserve energy and spread a positive message. Commissioner Mike Rosenau said, "I think you guys did a wonderful job getting your message out. We have boards throughout the courthouse and the annex, and you are welcome to put your flyers on them. I appreciate you guys coming and making us aware. I did not even know about the robotics. I did not even know the class was at the school.

I thank you for coming forward and educating the County Commission with what is going on with the school systems. So, thank you and never hesitate to come to a Commission meeting. We are here to represent everybody. Please come anytime and I mean that. Please make yourself active in your community and working together is what it is all about." In April of 2021 E. Heckler was found not guilty by reason of mental health for the 2019 stabbing and killing of her stepmother, Marion Heckler. E. Heckler, 19 at the time, allegedly slit M. Heckler's throat, and stabbed M. Heckler 42 times in her back, killing her

It is Now Time to Build Corridor H

Greetings. There was a letter to the Editor by Rachelle Davis. Unfortunately, the letter sites a petition signed by over 5,000 people that is based on outdated information, personal opinions, and erroneous information that misleads the public regarding the Revised Original Preferred Alternative (ROPA). The information has been used to create a public frenzy that at best proves to be misguided.

The first point raised by the petition: "This plan would undermine the connection between the local communities and make it dangerous to travel between the towns on foot or bicycle." This comment was wrong when originally discussed and is more factually inaccurate with the latest roadway revisions. We have used the analogy before that DOH is building an underpass NOT A WALL. Between the municipalities traffic will use a wide roadway at grade level while corridor H passes under the road. It will be extremely broad and landscaped allowing safe travel for both pedestrians and riders. It will be just as easy in the future to transit between Davis and Thomas as it is today.

Next point: "An elevated 4-lane highway through the beautiful Blackwater area is not in the interest of the local economy." The road is not "elevated," but it is shielded from view using earthen berms and vegetation. The bridge over the North Fork nor the roadway is visible from the Blackwater State Park Lodge, Lindy Point, or Pace Point Overlook. This has been verified using mapping techniques and topographical maps. All of that being true, none of that will negatively impact our tourist economy.

Another point: "Valuing our natural resources and public lands adds to our quality of life and draws people to our communities. These visitors create jobs in Thomas, Davis, and Canaan Valley." Ironically, that is all true. Corridor H will actually increase the number of visitors to our area, which in turn will create more jobs - not less. And, the corridor will make it easier, quicker, and safer for worker living in other areas to commute to their workplace.

Final point: "Thomas and Davis have become destinations in the last 20 years with a thriving diversified economy. Directing commercial traffic traveling to locations outside the county through the center of our towns would have a detrimental impact on our businesses." We agree that Davis, Thomas, and Canaan Valley are thriving destinations. Where we disagree is with the impact of Corridor H on our area. The roadway will actually make it easier to travel to the area and that will only increase, not decrease, the demand upon our area. We are the desired destination of choice.

One more point. Some argue that the historic nature of the coke ovens will be ruined by a bridge passing overhead. To that we say nonsense. All over the country and the world historic sites co-exist and integrate successfully with modern amenities. We maintain the coke ovens will remain viable and can endure in harmony with Corridor H.

Therefore, build the road now and use the ROPA.

Interagency Team Wins Forest Service Award Presented by Chief Randy Moore

ELKINS, W.Va., An interagency team including staff from Monongahela National Forest, the Forest Service's Eastern Regional Office, and the West Virginia Division of Highways was presented with a national honor award by Forest Service Chief Randy Moore in an online ceremony.

The team collaborated on the replacement of a closed bridge in Tucker County, West Virginia. The closure impacted access to about 20 homes in the Laneville area and a popular trailhead in the Dolly Sods Wilderness.

"I'm proud of these employees and their dedicated work to ensure the safe and timely installation of the replacement bridge," said Forest Supervisor Shawn Cochran. "It's always rewarding to work with folks across agencies and from other offices, and I'm grateful for the assistance of the West Virginia Division of Highways and staff from the Forest Service's Eastern Region."

The team obtained funding and environmental permits, wrote a statement of work, awarded a construction contract, coordinated closely with the contractor and residents, obtained a temporary replacement bridge, installed a temporary pedestrian bridge, and provided public information. Thanks to their efforts, the bridge was opened to the public significantly ahead of schedule and with no injuries or safety issues.

DHHR and DEP Announce Proactive Drinking Water Working Group Following EPA Proposals

CHARLESTON, W.Va. - The West Virginia Department of Health and Human Resources' (DHHR) Bureau for Public Health and the West Virginia Department of Environmental Protection (DEP) announced a new working group to collaborate with select public water systems to develop plans to treat drinking water for perfluorooctanoic acid (PFOA) and perfluorooctane sulfonate (PFOS), part of a large group of lab-made chemicals known as perfluoroalkyl and polyfluoroalkyl substances (PFAS). The U.S. Environmental Protection Agency (EPA) today proposed to regulate PFOA and PFOS at a Maximum Contaminant Level (MCL) where they can be reliably measured, at 4 parts per trillion. In addition to these two MCLs, EPA is proposing to address four additional PFAS (GenX, PFBS, PFNA, and PFHxS) as a



mixture using a Hazard Index.

"At the Governor's direction, in an effort of collaboration, our state partners proactively reached out to water systems in West Virginia in preparation of these revised EPA guidelines and have formed a work group to address any potential concerns," said Dr. Matt Christiansen, State Health Officer and Commissioner of DHHR's Bureau for Public Health.

The U.S. Geological Survey (USGS), under the direction of DHHR, tested the raw-water (pre-treated water) for 279 public water systems across West Virginia. In the USGS report, of the 279 systems, thirtyseven were identified to have detectable PFOA and PFOS in their raw-water source. Additional tests by USGS are pending on the finished drinking water for the 37 systems and will be shared when finalized. recently The EPA announced that West Vir-

The EPA recently announced that West Virginia will receive \$18.9 million in federal funding over two years to address emerging contaminants like PFAS in drinking water. That funding can be used for a wide-range of activities, including research and testing, treatment, source water activities, restructuring, consolidating, or creating water systems, technical assistance, and more. DHHR will be coordinating with the impacted communities to administer the funding.

"A collaborative approach between DHHR, DEP, and our public water systems will be the most effective way to treat PFAS in our state," said DEP Secretary Harold Ward. "By working together, we can leverage our respective strengths and expertise to protect the health and wellbeing of our citizens and the environment."

PFAS are chemicals used in thousands of applications throughout the industrial, food, and textile industries and are an ingredient in some firefighting foams, food packaging, cleaning products, and various other household items. leave the mental facility on outings.

During the trial E. Heckler testified that her and M. Heckler had gotten into an argument and during that argument she had flashbacks to a previous argument that involved a knife with her mother, which she claimed caused her to flip out and stab her stepmother.

After entering this plea, E. Heckler was committed to a secure mental health facility and will be under the court's jurisdiction for the maximum term for first-degree murder, which is life. E. Heckler will also undergo an annual evaluation to determine if she poses a danger and whether such a facility is still appropriate.

On this day in court Cooper motioned for an approval that would allow E. Heckler to go on outings. Cooper argued that

Heckler has been improving, taking her medications, and doing well with her treatments. Cooper also argued that Heckler was no longer a criminal defendant as she was acquitted of all charges and placed in a mental institution as part of her plea agreement.

Cooper presented two witnesses that work with E. Heckler during her treatment. One witness is E. Heckler's phycological doctor and the other is her social services case worker. The phycological doctor has only been working with Heckler since October of 2022 and determined that Heckler was stable enough to travel outside the facility with trained staff. The doctor stated that E. Heckler has been taking her medications and has improved. Cooper also argued that Heckler would be overseen by professionals on her excursions.

Wilkins questioned the witness as to how long they had been treating E. Heckler. The witness stated since October of 2022 for an estimated 30 minutes once a month. The witness also answered the question of whether she had reviewed the case with the crime scene photos as no. Nor was she aware of the other incidents that had occurred during E. Heckler's incarceration where E. Heckler had allegedly strangled a guard.

Mr. Hall the social services case worker basically stated that he was a part of E. Heckler's treatment by handling her discharge voucher, cash withdrawals, and keeper of her treatment plan but was not part of the transport team that would accompany E.

Heckler out on excursions. Hall did state that precautions were taken on the trips that included all the floor and transport staff being trained in crisis situations and two to three staff members accompanying an individual on an outing.

Wilkins questioned Hall as to what was the discharge voucher or plan for E. Heckler to which Hall answered none at this time until they find suitable placing. Hall stated to Wilkins that the crisis training was recertified by staff every one to two years and the training sessions were one to two hours long with testing being completed online.

Wilkins argued that given E. Heckler's past she was a flight risk and was in a facility to receive treatment for her mental issues as ordered by the courts

and allowing her to not go see a movie or eat at a restaurant was not a punishment but a safety precaution.

Judge Courrier ruled that given the evidence provided that E. Heckler was doing well with her treatments he would allow her to go outside the facility on a limited individual basis with at least two crisis trained staff members but not as part of a huge group. Courrier stated that once Heckler has proven herself, her defense could motion the court for an approval of small group outings. Courrier said, "Not going to say I will ever approve a huge group outing."

All individuals are presumed innocent until proven otherwise in a court of law.

Morrisey Reminds Consumers to Research Tax Prep Services

CHARLESTON - It's that time of the year again, so West Virginia Attorney General Patrick Morrisey is reminding consumers to be cautious and to protect personal information when preparing and filing their federal and state income taxes, particularly since some tax preparers offer remote/online assistance.

The federal and West Virginia tax filing deadline this year is April 18.

If opting for a remote or virtual transaction, make sure you're dealing with a legitimate tax preparation service. Also, make sure the tax preparer uses a secure portal to receive sensitive information involving income,

behalf. Make sure you work with the right person or business. Research their reputation, qualifications, and be on guard for any phony or dishonest preparer who would jeopardize your personal information."

Consumers can greatly reduce the risk of fraud by filing their return well before the April 18 deadline. This gives thieves less time to file a false return since Internal Revenue Service records would show a filed return in the consumer's name. Consumers also should use a secure internet connection, and never file their return via publicly available WiFi.

her IRS Preparer Tax Identification Number. Federal law requires paid tax preparers to take both steps.

Other tips to consider if hiring a tax preparer:

Research tax preparers online and/ or seek a trusted friend's recommendation.

Make sure the tax preparer offers e-file. Anyone who prepares and files more than 10 returns for clients generally must do so electronically.

Make sure the tax preparer will be available after filing the return should any questions arise about the filed tax return.

Charleston WV – The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

March 22, 1922: Physician Mildred Mitchell-Bateman was born in Georgia. She became the first Black woman in West Virginia to hold a high-level state administrative position when, in 1962, Governor Wally Barron appointed her director of the Department of Mental Health.

March 23, 2003: Private Jessica Lynch of Palestine, Wirt County, was serving as a supply clerk with the Army's 507th Maintenance Company when she was captured by Iraqi forces after her group was ambushed.

March 24, 1890: Confederate General William Lowther "Mudwall" Jackson died in Louisville. Jackson, who was born in Clarksburg, joined the Confederate Army as a private. After helping to organize an infantry unit, he was promoted to colonel. He served on the staff of his cousin, Gen. Thomas J. "Stonewall" Jackson, and was jokingly nicknamed "Mudwall."

March 25, 1878: Attorney General Armistead Abraham "Cousin Abe" Lilly was born at Jumping Branch, Summers County. Lilly appealed the Virginia Debt Suit to the U.S. Supreme Court; when settled, it was estimated that Lilly had saved the state a large sum of money.

March 26, 1863: The state's first constitution was overwhelmingly ratified by the voters, by a majority of 28,321 to 572. The constitution was drafted during the state's first Constitutional Convention at the federal custom house in Wheeling.

March 26, 1920: Aviator Rose Agnes Rolls Cousins was born. She was the first Black woman to become a solo pilot in the Civilian Pilot Training Program at West Virginia State College (now University).

March 27, 1826: Laura Jackson Arnold, the younger sister of "Stonewall" Jackson, was born in Clarksburg. During the Civil War, she was a staunch Unionist and opened her home to care for sick and injured troops.

March 27, 1917: Statesman Cyrus Roberts Vance was born in Clarksburg. In 1977, President Carter tapped Vance as his secretary of state. In 1978, Vance was instrumental in the Camp David peace accord between Egypt and Israel and in negotiating the Panama Canal Treaty.



- 1/4 cup baking cocoa (unsweetened)
- 1 3/4 cups very hot water
- Ice Cream, optional


Directions

- 1. Preheat oven to 350 degrees F.
- 2. In an ungreased 9×9 square baking dish, using a fork, mix first set of dry ingredients – flour, sugar, cocoa, baking powder and salt – mix well.
- 3. Next, stir in milk, vegetable oil and vanilla, mix until smooth. If using nuts, add them now. Spread batter evenly in pan.
- 4. Last, sprinkle batter evenly on top with brown sugar and remaining 1/4 cup baking cocoa. Pour hot water over top (do NOT mix) and bake on middle rack of oven for approximately 40 minutes, until top layer has a dry, brownie-like top.



The proposed increased rates and charges will become effective Friday April 5, 2023, unless otherwise ordered by the Public Service Commission, and will produce, on a total Company basis, \$19,740,000 annually in additional revenues, or an overall average increase in revenues of approximately 6.08%. The \$19,740,000 consists of an increase in base rates of \$37,649,000 and a decrease in the Company's Investment Replacement and Expansion Program ("IREP") of \$17,909,000. Eastern received the Perkins Reserve Grant, which supports the projects of community and technical colleges that provide students with either dual-enrollment programs, work-based learning for skills needed in workforce areas, or industry-recognized credentials. "South Branch Career and Technical Center's partnership opportunities with Eastern West Virginia Community and Technical College have been growing over the last two years," said Crites, "High school students attending SBCTC now have the opportunity to extend their education beyond high school with the addition of dual enrollment credit thanks to Eastern's strong commitment to collaborate with our facility. In addition to acquiring multiple healthcare professional skills, students who complete this program would be eligible to sit for multiple National Healthcare Association certification exams. "This grant has afforded a wonderful opportunity to offer dual-enrollment for a muchneeded area in health care. The partnership between South Branch CTC and Eastern exemplifies the importance of higher education with positive impacts on student outcomes and a bridge to post-secondary learning," said Melissa Shockey, Workforce Program Director.

\$3.2 Million to Upgrade Underground Storage Tanks, Prevent Hazardous Leaks Across West Virginia

Washington, DC –U.S. Senator Joe Manchin (D-WV), Chairman of the Senate Energy and Natural Resources Committee and member of the Senate Appropriations Committee, announced \$3,252,469 from the Environmental Protection Agency (EPA) for the West Virginia Department of Environmental Protection. The funding will support properly maintaining, monitoring and upgrading underground storage tanks across West Virginia to prevent releases of petroleum and other hazardous substances into the environment.

"Every West Virginian deserves clean water to drink and fresh air to breathe," said Senator Manchin. "I'm pleased the EPA is investing more than \$3.2 million to ensure our underground storage tanks across West Virginia are properly monitored, maintained and upgraded where necessary to protect our communities from hazardous leaks. The funding announced today will help prevent releases of petroleum and other harmful substances into the environment, as well as enhance public health and safety for all West Virginians. As Chairman of the Senate Energy and Natural Resources Committee and as a member of the Senate Appropriations Committee, I will continue advocating for resources to protect the wellbeing of communities across the Mountain State."
