# **City of Parsons Hear Updates**



The Pulp Mill Bottom Pond Restoration was discussed by the City of Parsons. The council discussed the need for cleaning out of the pond to stop the clogging of the fountain equipment. The city council also discussed the need for a trolling motor to assist in the cleanup.

The City of Parsons City Council addreseds ongoing projects and other city business. Among updates presented to the council, City of Parsons Police Chief Kevin Keplinger provided updates on law enforcement in the city and representatives from Thrasher Architecture, Engineering and Field Services provided updates on three projects. Police Chief Kevin Keplinger told the council of an incident that concerned him recently. According to Keplinger about a week and a half ago, his department received a complaint about a four wheeler in the dead end of Main Street area that had interaction with residents. "By the time we got on scene, the patrolman got on scene, the four wheeler had already left," Keplinger said. "Had a little bit of interaction with some residents down there and a baggie of a green leafy substance that to the best of my training, knowledge and experience I would say was marijuana, was recovered. When that was tested by field test kit, it tested immediately and very strongly for amphetamines. So we did not get a chance to interview this person. So I don't know if that was intentional. I don't know if we're dealing with laced marijuana, but it may not be. So just want to make people aware of that."

# 911 Center Receives First Early Warning System in State, Simmons named 911 Director

911 Director Michael Simmons informed the Tucker County Commission on that his department was receiving a first of its kind in the state early warning system to monitor the power and temperature of the 911 Center's server room. The measure was a response to recent issues the center has encountered.

Simmons informed the Commissioners of equipment issues his department has been contending with recently. "We had a couple, I call them issues of interest that have happened in the past couple of days," Simmons said. "The AC unit that feeds our server room failed and that also caused damage to the head in the server room which is the air unit on the wall in there. We have about a quarter of a million dollars of county equipment in that room and the recommended temperature is 65 to 67."

Simmons said his department was using a portable floor unit in the interim. "We had commandeered a portable air conditioning unit on wheels, a floor model," Simmons said. "So the door's propped open to the room and its sitting in there and its keeping it not quite at tolerance, but close."

Simmons said the unit should be repaired by next Friday. "They should be there by Friday of next week to replace the compressor outside and put a new head unit in," Simmons said. "We went a size bigger then what we had because we kind of felt that the old one was working too hard with the added equipment in there that we put in there recently."

Tucker County Commissioner Mike Rosenau questioned Simmons regarding an early warning system for system failures such as this. "I was going to ask you about that," Rosenau said. "We had talked earlier, you and I, about a warning system. Is that in the works with this new equipment being installed?"

"That is actually number two on my list," Simmons said. "There was a couple of issues. Every Tuesday, our generator does a half hour test. It kicks on, runs for a half an hour, when it cycles down, it kicks back on to the main power through the breaker in our server room. Everything being on battery backups, nobody knew it. Dispatchers can't hear downstairs, there was just no way to know. Once the batteries exhausted their life, everything started shutting off and it was urgent necessity to figure out what was going on."

The Tucker County Solid Waste Authority examine documents July 24th at the TCSWA Office on Landfill Road in Davis.

"First I'd like to welcome Lowell to the board," Holstine said. "Lowell is filling the seat vacated by Diane. And thank you very much for volunteering your time. I really appreciate you coming on board. We continue to have a really strong board, in my opinion. I look forward to continuing that."

According to Holstine, the Authority is on track with its Air Quality Permit. "The air permitting process is on schedule. They have to have the emissions inventory into the DEP by next Monday. They were on schedule to do that. They're supposed to have a draft of that to me and Jody this week for the rest of us to look at. Its going to be hard for me to critique. Inventory is invenSimmons said the problem has since been resolved. "They figured out the problem. We located the breaker that was tripped. We got it back on and everything back up and running within probably 25 minutes.What we did is we took certain pieces of equipment and spread them out around the room on different circuits. We kind of split the load. So we don't anticipate that happening again."

Simmons said there is no way to monitor the power levels in the server room. "We don't have a way to monitor the power levels in there," Simmons said. "And we don't have a way to monitor the temperature there. So, today we received the equipment - we are See 911 page 2

# **Hambleton Parks and Recreation Awarded Commission Funds**

President of the Hambleton Park Board Adam Cassidy addressed the Tucker County Commission on to request funds for the Hambleton City Park.

"We built a park," Cassidy said. "The folks of Hambleton came together and got the money to build a park in the early 90s, 92. We've been trying to keep up with it and not waste the effort they put into it."

Cassidy said Covid had caused the board's funds to deplete due to the stoppage of their fundraisers during the pandemic. "Then during Covid, small communities, you can't have your cake walks, fundraisers and that stuff," Cassidy said. "So we mowed the grass and tried to paint and keep up. The roof's bad on the pavilion. Its starting to leak through the sheeting and eventually develop black mold. We're just trying to keep things going and keep it up for the people of the little town of Hambleton."


"I went out and checked it and it was spotless," Commissioner Fred Davis said. "You keep it nice and by going up and seeing you keep it nice, I said we got to help you out. You do a great job, from what I can see, with what you have."

"The pavilion is used quite a bit during the summer," Cassidy said.

"I looked at your application, your funding request," Commission Mike Rosenau said, "and I saw where maintaining utilities has put a strain on you because you couldn't do fundraisers that much during the Covid epidemic. So, I've seen what you've done. Your cake walks, your other things you've had for fundraisers, but its depleted because of Covid. I appreciate this input, too. I see here you got \$2,000 from Parks and Recreation, but your overall project is going to be close to 7500."

Cassidy said he had a bid last year at this time, but suspected that costs may have changed. "I have a guy right here in Hambleton who has a contractor license," Cassidy said. "He's going to give me quote."

"That's the community working

together," Rosenau said.

"You're wanting \$5500, right?" Davis said. "I make a motion that we give you \$5500 for your park.

"The measure passed unanimously. "Keep it up," Commissioner Tim Knotts said. "Keep it looking good."

"I've been keeping an eye on

the parks," Davis said. "They're all kept up in the whole county. We should be happy with what we've got."

"What's going on in this county," Knotts said. "Tucker County is by far, by far, leading the State of West Virginia. I believe that." "We're such a small county," Rosenau said. "Such a small voice, but we work together."

# **News of Record**

The following criminal complaint has been filed in the Tucker County Clerk's office:

Marshall Dwaine Parsons, of Parsons was charged with one count of Driving while license revoked for driving under the influence of alcooffense. The complaint states that Patrolhol  $2^{m}$ man First Class N.C. Gidley received a call from Tucker County 911 in regards to a complaint at 107 Loughry St. in Parsons. Tucker 911 advised that DNR 100, L. Dudley was on scene requesting assistance with two males who were removing items from a building where one male had been given an eviction notice prior to which stated that he was to be out of the residence by July 7 at midnight.

Upon arriving on scene Gidley observed a white and black Ford pickup with a trailer attached backed up to a garage door at the residence. A green Jeep was observed parked off the roadway with a trailer attached but did not have a registration plate attached. He then met with Officer Dudley who stated that when she arrived she came into contact with two male individuals inside the garage. They appeared to be removing objects from the garage and onto a trailer. Upon making contact with the subjects they were identified as Jeremy Cussins and Marshall Parsons (DOB: 4-1-84).

Gidley was informed by Tucker 911 that Parsons' driver's license was revoked for DUI and that he had been charged in the past for driving revoked DUI  $(1^{st} \text{ offense})$  in 2018. Upon questioning Parsons, he stated that he drove the truck up to the garage to help Cussins, and he knew his license was revoked. He stated that he served 24 hours in jail and a six month probation period for the charge in 2018.

Morgan Parsons arrived on scene to drive both individuals since they could not legally drive on the roadway.

actually going to be the first people in the state to have this. It will monitor the power levels of every device in there. Let us know if power fails or gets low and will also monitor the temperature and will alert us if the temperature rises above a set temperature. We can go check and see what is going on."

Simmons said that by spending the money on the system now, he hopes to prevent damage to equipment in the future. "The thought process is spend a little money now to prevent harm to the expensive equipment that is already in there. So kind of excited about that."

Simmons said the system is monitored 24/7 by the company supplying the system. "They will monitor it 24/7 for us," Simmons said. "And I can also have it set up to send me an alert or other dispatchers, anybody we deem necessary to get an alert. Maintenance guys, whatever."

Simmons also informed the Commission of issues with the State siren tower. "The third item of interest is our State siren tower," Simmons said. "It is a hub for not only Tucker County, but surrounding counties for the radio communications. A lot of other counties utilize a microwave system, come use a different set up, but it all goes to that tower. And the other day, the air conditioning unit outside the buildcertain tolerance and it was almost at a 100 degrees in there. To the point that it was tripping the power breaker and he said you're in danger of losing this tower."

Simmons said they reached out to the state. "So we were able to get a hold of the Watts center who contacted the National Guard and they brought in one of those big outside heat pump air conditioning units they used to power their FEMA tents. They brought one of those in and its up there sitting in front of the building, the doors open and its got thick duct work ran in there, pumping air in and its within tolerance, but its a band aid."

Simmons said he received a contact number to reach out to the party responsible for replacement of the unit. "I was able to get a contact number for the person responsible for replacing that because apparently, the building is still owned by the DOH. He replied to me just before leaving work today that he was out of the office, but he would be back first thing in the morning and he would do what he could to get that expedited because I explained to him the urgency of it and it affected multiple counties. It was the only resource any of our first responders had for communication." questioned Rosenau Simmons as to how often the State has inspected and monitored the tower. "When you talk to him tomorrow, I want to know if they periodically check that building and the equipment." Rosenau said. "Its their responsibility. I want to know what schedule they are going to maintain in checking that building and the equipment."

"The siren network," "that's Simmons said, their part of the kitty, per se, for having their stuff in that building was that they maintain the watt, not the air conditioning unit. So, he makes his rounds about every 15 to 20 days, he said. He weed eats, mows, checks everything out."

"Let me ask you this, that is for their equipment," Rosenau said. "What about the heat system in the winter? What about the cooling system in the summer? Who checks that?"

"Nobody," Simmons said.

"So that's the Department of Highways responsibility," Rosenau said. "So I want to know from Mr. Shay, what their responsibilities are and how they are going to maintain that

Because that building. affects the communication of our 911 Center. Not only ours, but you explained, several counties around."

Also at the meeting, Simmons was unanimously appointed to 911 Director. Simmons had previously been Interim Director. "You to me deserve it," Tucker County Commissioner Fred Davis said. "You work hard, you've done everything we've asked. You went beyond things that we didn't know that you've done. And I know all three of us commissioners are proud of you. We appreciate you very much.

Keplinger also updated the council on the latest developments in the city. "We had 40 calls for service, 911 calls for service, CAD calls for service since our last meeting," Keplinger said. "Several of those have included rather some complex investigations that we're working right now kind of hand in hand with the Child Protective Services and Adult Protective Services on a few abuse/ neglect complaints that I think we are probably going to end up presenting to the fall grand jury."

Keplinger said his department had several successful hearing on several felony charges, as well. "We successfully had a preliminary hearing on several felony charges for Homewood St. Those were bound over for trial," Keplinger said. "So those will proceed to trial very shortly."

Keplinger also told the council that the two AED units donated to the department by the Tucker EMS are now in the vehicles and ready for use should the need arise. "There's been several times that I've been out on a call that I could have used them and I anticipate that at some point in time we probably will."

Keplinger also said he had been contacted by Tucker County Emergency Management Director Kevin White about a state program supplying Narcan and Epipens. "The Governor is going through a, I guess an emphasis on pushing Narcan for first responders. We carry Narcan. That was one of the first things I did when I came here, but there's an expiration date and ours expire January of 24. So I'm going to get together with Kevin White and we are going to pick up some fresh supply of Narcan."

In regards to the Epipens, Keplinger said he had some liability concerns about his department carrying and distributing them. "He's also getting Epipens," Keplinger said.

"I am a little leery about that and I just think maybe and reach out to me sometime. My concern is the liability. If I was to have an Epipen and I give it to somebody else and they use it, you know is that different then trying to use it myself? You understand my concern with it? So, its an absolutely important thing, but I don't want to put us in a position of liability with anything like that."

Thrasher provided information to the council on the status of the Parsons-Hamrick PSD Emergency Interconnection, Parsons Sanitary Sewer System Improvements and Parsons Water System Improvements Project.

In regards to the Emergency Interconnection project, Thrasher said they are still awaiting Bid Authorization from the WV Development Office. Other updates included that all bid documents are ready and all permits have been received as was a preliminary title

opinion. Thrasher said that both their organization and Region VII have repeatedly reached out for updates on the bid authorization documents.

The Parsons Sanitary Sewer System Improvements updates given by Thrasher included a funding application that was accepted by WVJDC and a facility plan was submitted to DEP. Other updates on the project included the sewer replacement design was in progress with the field layout complete, mapping is being updated, bid documents on the project are 60 percent complete and the design plan is 20 percent complete. Thrasher said they are going to prepare an easement list for the proposed replacement areas and the Project Team will soon begin having conference calls with DEP on the project. According the Thrasher, the estimated construction cost of the project will be \$3.1 million with a total estimated project cost of \$4.01 million.

The Parsons Water System Improvements Project updates included a funding application approved by WVIJDC, a application submitted to the DWTRF Program by Region VII, an application for \$500,000 in Earmark Funds was submitted and passed the first step of approval. Other updates on the project included information on the Waterline Replacement Design process. The field layout is 50 percent complete and the mapping is being updated on the project. According to Thrasher, the project team is discussing additional grant eligibility through the Economic Enhancement Grant Funds. Thrasher reported that the estimated project cost is \$3.184 million with a total estimated project cost of \$3.984 million. Councilman Tim Turner

West Virginia is among 45 states to receive a total of \$65 million to enhance the National Apprenticeship system. The Mountain State will receive \$465,113 with annual renewals available for an additional four years.

Registered Apprenticeship Programs (RAPs) are federally recognized, high-

quality career pathways that offer paid, on-the-job learning that is supported by coursework. The K-12 Teacher Preparation program in West Virginia is a USDOL-recognized RAP. It removes barriers to economic opportunity and time for high school students interested in a teaching career.

West Virginia implemented the Grow Your Own Teaching Pathway in the 2022-23 school year. Seven Grow Your Own counties have committed to implementing a teacher apprenticeship program. To date, nine high school students have been hired by their counties as teacher apprentices.

"This grant not only recognizes the current work in our state to address workforce needs through student preparation, but it also identifies funding that allows us to continue to grow and build the next generation of our state's great workforce," said Secretary of the West Virginia Department of Economic Development Mitch Carmichael. "This will be of tremendous assistance to the WVDED team as we continue to support West Virginia's current and future workforce needs."

"This support will allow us to expand and sustain the work that has already begun in West Virginia," said State Superintendent of Schools Michele L. Blatt. "We continue to explore ways to extend opportunities to our students while also addressing workforce demands. This grant will assist these efforts and have a significant impact for years to come."

The award provides planning funds to states, such as West Virginia, that have committed to increasing sustainability and substantially increasing the number and diversity of RAPs among in-demand industries. This allows the state to evaluate options to expand this federal distinction to other fields such as nursing, tourism and culinary industries.

"Psychiatric disease has increased significantly over the last few years, and there is definitely a need for greater access to this care, "said Dr. Chua.



To make the Honey BBQ Sauce, combine the honey, ketchup, apple cider vinegar, soy sauce, Dijon mustard, onion and paprika in a medium saucepan. Bring the mixture to a boil, lower the heat and simmer for about 15 minutes.

Pre-heat your outdoor grill, creating two different heat zones. One section of your grill should be high heat and the other section should be a little cooler, or more like medium heat.

Brush the pork chops with a little olive oil. Place the pork chops on the hot zone of the grill for 3 minutes on each side to sear the outside of the chops. Then move the pork chops to the medium zone, brush with the honey BBQ sauce and continue to cook for an additional 4 to 8 minutes, depending on the thickness of the chops. Flip and brush again with sauce. The pork chops should reach a temperature of 150°F with an instant read thermometer.

Remove the chops from the grill and let them rest for 5 minutes before serving. Transfer the chops to plates and serve. If you have any leftover honey BBQ sauce, you can bring it to a boil and serve it at the table with the chops.




