Meet the Candidate: Hillary Bright for 22nd Judicial Circuit Judge

With a new year, Tucker County will see a new Circuit Court Judge. As part of the redistricting by the State, Tucker and Preston Counties will merge into the new 22nd Judicial Circuit. As a result of this redistricting, Tucker County has new Judicial Candidates. Preston County native Hillary Bright is running for Circuit Court Judge as part of the new 22nd Judicial Circuit.

Bright said she thought that the combining of Tucker and Preston Counties into the new Judicial Circuit would be an extension of her community. Bright also said that the care she feels for the people of Preston County will translate to the residents of Tucker County, as well. "I've grown up in Preston County, I've live the majority of my life in Preston County, graduated from Preston High School, played sports at Preston High School." Bright said. "I don't have any ties to Tucker County, but with the inclusion of Tucker County into Preston County, that is going to be an extension of my community. That's the way that I am going to view it."

Bright stated her decision to run for Circuit Court Judge stems from a desire to ensure the process is fair. "We are really

limited with what we can do as an advocate," Bright said. "We are limited to our particular role in that particular case. I can't advocate for others. When you are a judge, though, you are over the entire case and you are the person who is trying to make it a fair process and as someone who wants a fair process, that has prompted me to want to be Circuit Court Judge."

Bright said she has been a practicing

Child Advocacy Center Receives County Funding

April is all about Child Abuse awareness in Tucker County, with the month being designated as Child Abuse Prevention Month by both the Tucker County Commission and the City of Parsons. The Tucker County Commission also approved a funding request by the Randolph-Tucker Child Advocacy Center for \$27,000.

The City of Parsons Council adopted the proclamation at the Council's regular April 2nd meeting. The Tucker County Commission adopted the proclamation at the Commission's April 10th meeting. Margo Evick of the Randolph-Tucker Child Advocacy Center was on hand at both meetings with April Miller from the Tucker County Family Support Center on hand during the Commission meeting.

Evick was on hand during the Parsons meeting to receive the proclamation and thank the Council. At the Commission meeting, Evick presented the organization's annual report on the Center's efforts. "Today I am just here to present our annual report so numbers from last year," Evick

According to Evick, the Center saw 154 new children walk through their doors in Randolph and Tucker Counties. The Center, according to Evick, assists children who are victims of alleged sexual abuse, physical abuse, drug endangerment and witnesses to violence, among other issues. "Anything you can think of and not think of – because I don't want you to have to think of it – that can happen to a child, we see it," Evick said.

The Center's Advocate provided 998 Advocacy Services on average every six months to 499 caregivers, according to

Evick. According to Evick the Center provides contacts to address client needs through phone calls, in person in the offices, attending medical appointments, attending court appearances, linking individuals with therapy services and assisting with transportation issues to attend therapy services, as well as food and housing needs or utility needs. "These advocacy contacts with families during the year are connections ensuring that they receive the support that they need."

Of the cases seen by the Center, 40 of the children were referred for trauma and mental health services and 17 received a required medical examination, according to Evick. "So 40 of those children that we saw in our office were referred for trauma and mental health services, which we know as soon as a trauma happens, the faster we can get them in, the better," Evick said. "17 of the children, received that medical examination, that was required because they disclosed sexual abuse penetration or there was physical abuse. There were marks on their bodies that had to be checked out, lots of reasons.'

Evick said the Center saw 25 cases with charges filed, 21 indictments, 2 offenders convicted by trial and 12 by plea, with "a lot" in Tucker County. Evick said the conviction rate was 2.39, which is well above the statewide average. Evick acknowledged that the number seems low. "Which that seems low, but the statewide average is .58," Evick said. "So we are well above what the State of West Virginia is doing in child abuse cases."

Evick also stated that the Center has been working in an awareness program that includes an advertisement at the Elkins Cinema and a second step curricu-

No Major Damage Reported From Recent Storm


Tucker County Office of Emergency Management Director Kevin White reported to the Tucker County Commission April 10th that there were no reports of major damage stemming from the April 3rd heavy rains. "We had some flooding last week," White said. "I have had no reports of major damage to living quarters, like the main story of a house or anything like that."

White said that damage to basements was excluded from damage assessments, as they are not included in the established "Unfortunately, basements guidelines. don't count in the damage assessments," White said. "That's not something that counts into the guidelines."

White said most of the damage occurred along roadways and ditch lines. "Most of the damage seems to be to roadways, ditch lines, things like that," White said.

White said that US 219 had been closed for the majority of April 3rd due to water

Sugar Camp Road Closure

Special accommodation will be made for emergency vehicles and school buses only; all other motorists will need to seek alternate routes.

Smokey Hollow Road Closure Extended

The closure of County Route 17, (Smokey Hollow Road), Tucker County, has been extended through Wednesday, May 1, 2024, beginning at approximately 1.5 miles from the intersection of County Route 17 and WV 72 near Parsons, for construc-

tion work associated with Corridor H. All motorists, including emergency vehicles and school buses, will need to seek alternate routes. One alternate route is WV 72 to WV 38 near St. George to County Route 21 (Clover

The following criminal complaint has been filed in the Tucker County Magistrate office:

• Andrew Allen Davis, of Parsons, was charged with three counts of Shoplifting. The complaint states that on Wednesday, April 3 First Class N.C. Gidley informed Tucker 911 that he would be out at BFS located at 200 First St. in reference to a shoplifting complaint he took directly from the Manager of BFS.

The manager advised Gidley that a male subject had come into the store on three separate dates and had shoplifted multiple items. She stated that the subject would put items into his jacket pocket to carry them then when he arrived at the counter to pay he would not take all the items out of his jacket. The manager provided CCTV footage of the three separate incidents. She stated she thought the subject's name was Andrew but was uncertain about a last name and that he lived in the apartments

next to McDonalds. Gidley reviewed the CCTV footage from BFS and determined that the following items had allegedly been taken: three pepperoni rolls on March 16, two pepperoni rolls on March 23 and 0ne soda and one pack of Reese's cups on March 30.

On Thursday, April 4 Gidley arrived at 300 First St. and attempted to locate the subject using a photo from the CCTV. Contact was made with a tenant who stated the subject was Andrew Davis. Gidley made contact with Davis and spoke with him regarding the alleged shoplifting. He admitted to taking the items on all three incidents and was informed that he would be receiving citations for the offenses.

At 6:46 p.m. Davis arrived at the Parsons Police Department where Gidley explained a Miranda Rights Waiver in which Davis agreed to waive and to speak with Gidley. He admitted to taking the items and was

issued three separate citations for the three incidents that occurred and informed that he must go to the Tucker County Magistrate Court on or before April 15, 2024 to answer for the citations. The monetary value for the items totaled \$21.77.

attorney for the past decade and in that time she has worked solely out of Kingwood. "I've been practicing law for almost 10 years," Bright said. "I have been based out of Kingwood for the entirety of my time as a lawyer."

Bright said she worked for a law firm after college and was based in their Kingwood office. After the firm she worked for dissolved in 2019, Bright started her own private office. Bright shares the office with her assistant and an office cat named Loki. "I officially opened my door here in April of 2019," Bright said. "So I've been a small business owner for five years."

"I have tried to be supportive of different community programs as a small business owner," Bright said. "I think it is important that people take care of their communities and take care of their communities."

Bright said she recognizes the value of agriculture and supporting school and community ag programs. Growing up, Bright said she participated in 4-H and FFA, as she came from a farming background. "I have a farming background," Bright said. "I was in 4-H and FFA. So, it was important to me, becoming a business owner, that I continue to support programs that I was a part of that meant a lot to me growing up."

Bright said she also supports school trade programs. One

of the programs Bright said was the FFA Ham, Bacon and Egg Sale in Preston County where students raise a hog, have it butchered and cured, then auction the meat. The proceeds go to the students towards college or other future agricultural endeavors, according to Bright."I think we need to look at alternatives to just college," Bright said. "Providing a lot of different programs to kids because there is more than one way to make a living or make a really good living and college is not for everyone."

Bright said her experience as an attorney is varied. According to Bright, she has handled civil litigation, abuse and neglect, as well as criminal cases in her career. "I do work in a lot of different areas," Bright said. "So my practice experience is not just one or two things, I do civil litigation cases and I've done that through the entirety of my law practice, I do abuse and neglect cases and I have also handled some criminal cases."

Bright said he knows the job will entail a lot of work, but that she is used to working hard. "I know it would be a lot of work," Bright said. "I'm used to a lot of work. Its a workload that I'm not afraid of."

Bright is a 2014 graduate of the WVU College of Law and has one daughter.

over the road. "Of course it was really inconvenient," White said. "We had 219 shut down the biggest part of the day."

Tucker County wasn't the only area to be affected, according to White, the storm impacted the entirety of West Virginia, including surrounding counties. "It wasn't just in Tucker County," White said. "It was a Statewide event, first and foremost and it was definitely a five counties all the way around us event, too."

White said that the heavy rainfall was the contributing factor to flooding in the area. White said the region received three to four inches of rain in a 10 hour period. White said the water flowing downhill from higher areas contributed to the high waters surrounding Parsons during the storm. "When you receive three to four inches of rain in about a 10 hour period and you live in the mountains, it goes one place," White said. "It goes down. Parsons unfortunately is down from everything."

White said that motorists were able to take alternate routes to avoid the flooded sections of US 219 during the event. "But we got through it," White said. "There were some alternate routes that were available."

White said his office had worked with the State to get roads closed and properly signed during the event. "We worked with the State Roads to get road signs closed and things like that," White said.

Tucker County Commission President Mike Rosenau said that with the storm occurring so early in the spring, many road crews were still in the middle of switching over from winter plowing and had not had the opportunity to properly clean ditches and culverts along roadways yet. "Its early in the spring," Rosenau said. "So they haven't

had an opportunity yet from the snow plowing into the spring cleanup and stuff to clean ditches and to clean culverts."

Rosenau thanked White for his diligence in contacting road crews during the event to get crews out to clear blocked water drainage. "With your assistance to reach out to the appropriate people, we got a lot of that taken care of," Rosenau said. "So for the job that they did, I want to thank them."

White said the Division of Highways has a plan in place to treat roads. According to White, gravel roads receive more run off and the ditches along gravel roads are cleared every year. White said paved roads get the ditches cleared every three years, unless there is a need. According to White, there is a system to report ditches and areas in need of clearing and maintenance. White also said that he was informed that once reported, the DOH has a seven day period to address the issue. "I have actually spoke with the State road Division of Highways on multiple levels," White said. "There is a plan in place. It has been in place for many, many years. Roadways get treated in a certain manner, whether it is paved or gravel."

White said that the rainfall was just too much for the area streams and ditches to handle and the flooding could not have been avoided. "There is nothing that can fix that kind of rain that we received," White said. "The streams and ditch lines just can't handle it."

White said he has faith in what the DOH has been doing to maintain the roads. "I have faith that they will make amends on everything that needs to be done and continue with the programs that have been successful in the past," White said.

West Virginia DMV offers several convenient ways to renew vehicle registrations

CHARLESTON, WV - It's that time again. It's time to renew your West Virginia vehicle registration. The West Virginia Division of Motor Vehicles will send you a registration renewal reminder postcard 60 days before your registration expires.

You can renew your registration in several ways. Make sure to have your current registration card, proof of vehicle insurance, and proof of your personal property tax payment before trying to renew your registration.

You can visit one of the West Virginia DMV's 26 regional offices, your local county sheriff's office, or go to a WV DMV Now kiosk. You can also visit the DMV website or scan the reminder postcard to renew your registration online.

The added benefit of renewing your registration online is getting a free digital registration card. The card can be stored in your smartphone wallet. Once you renew your registration online, you will receive a confirmation e-mail message with a link showing you how to download the digital registration card to your phone. You will also get a registration card in a PDF format. A paper copy and decal will be mailed to you.

More than 8,000 West Virginians have already downloaded digital registration cards.

"This is just another option for people and another step forward in modernizing the West Virginia DMV," said West Virginia DMV Commissioner Everett Frazier. "We are striving daily to be the best West Virginia DMV that we can possibly be."

West Virginia requires every motor vehicle, trailer, semi-trailer, pole trailer, and recreational vehicle to be titled and registered. Motor boats with an output of at least 3 hp/70lb thrust must also be registered. Registration fees can be found by clicking here.

lum for child body safety called Child Protection Unit in schools. In total, according to Evick, 709 children received the body safety curriculum. The curriculum is held in every pre-K, Kindergarten and elementary school, according to Evick. Evick said the course has also been expanded to the Montessori School and the Center is working on expanding the course into area church programs, as well. Evick said the Center had also expanded the education program to Elkins Middle School, with plans to expand into Tucker County Middle Schools this year. "We also spent three day at the Elkins Middle School doing the curriculum last year," Evick said. "And I am hoping that I will get to Tucker County this year."

The Commission said they would like to see the program expanded into the private schools in Tucker County, as well. Evick said the Center would like to expand the education program to as many schools as possible. "They have a private school on the mountain, too, maybe you could reach out to," Tucker County Commission President Mike Rosenau said. "I'm not sure how their curriculum works, but it may be something to check on."

According to Evick, the Center also provides an adult education course to instruct adults on what to do, how to respond, react and report abuse appropriately. "Our sexual abuse prevention programming for adults to learn what to do, how to respond, react and report appropriately, that's Stewards of Children," Evick said. "I was able to train 36 adults last year."

Evick had previously submitted a \$27,000 funding request to the County Commission for consideration on behalf

of the Center. According to Evick, the federal grant that had supplied a majority of the Center's funding had been cut by 20% this year and is anticipated to be cut 40% next year. Evick said the state has stepped in to assist with the shortfall, but funding is not stable. "Its just not being fixed the way they thought it was going to be affected," Evick said. "We were expecting a fix over the last three years and the State of West Virginia has stepped up and has been filling that gap. We have to prepare for that not to be, its just not a stable source of funding anymore."

According to Commission President Rosenau, the Commission was able to approve the request using Opioid settlement funds. The request had been tabled until this meeting to allow the Commission to examine the County finances and regulations associated with the new Opioid Settlement funds. However, the request was only approved for this year alone. The uncertainty of future funding support stems from lower future payments anticipated from the Opioid Settlement Fund. "I had to do some investigation to make sure it was covered," Rosenau said. "So, it is covered so we can draw from those funds to support a one-time thing. We can't guarantee this, I want to make sure that is clear, because we have the funds available now that can support the Child Advocacy Cen-

During the meeting, the Commission approved a resolution to transfer the funds from the Opioid Settlement for the funding request from the Child Advocacy Center. The resolution was read into the record by Rosenau. A motion on both the approval of the request and the resolution for fund-

> ing transfer were made by Rosenau and unanimously approved by the Commissioners.

"This Commission is 100% for kids," Rosenau said.

The next meeting of the Tucker County Commission will be held Wednesday, April 24th at 4 p.m. at the Tucker County Courthouse Old Courtroom.

April is Alcohol Awareness Month

Charleston, WV - April is designated as Alcohol Awareness Month to raise awareness about the dangers of alcohol misuse and help those struggling with addiction find support and treatment. Alcohol misuse is the third leading preventable cause of death in the United States, with over 178,000 people dying from alcohol-related causes each year, according to the National Institute on Alcohol Abuse and Alcoholism.

Research shows that even moderate alcohol consumption significantly contributes to at least seven types of cancer, yet at least half of US adults are unaware of this association. Additionally, alcohol use contributes to motor vehicle crashes, intimate partner violence, suicide, and of course, Alcohol Use Disorder.

Help4WV is West Virginia's substance abuse and mental health helpline. Program Director Ann Hammond says people are often surprised to learn that among helpline callers, alcohol is the second most cited substance of abuse. Last year, 1140 helpline callers cited alcohol as their primary drug. The only drug category cited more frequently was opioids, mostly heroin or fentanyl. Hammond said, "Many people don't take alcohol use as seriously as other drugs, yet it contributes to far more ER visits and deaths than opioids."

If you have any of these signs of Alcohol Use Disorder, further screening is warranted.

- Drinking alone or in secret
- Drinking in the morning or at inappropriate times

Drinking to cope with stress, anxiety, or depression

- Drinking to the point of blacking out or
- passing out
 - Increasing tolerance to alcohol Neglecting responsibilities and obligations
- Continuing to drink despite negative consequences such as problems at work, in relationships, or with the law
- Engaging in risky behaviors while under the influence of alcohol, such as driving or unsafe sex
- Having physical symptoms of alcohol abuse, such as shaking, sweating, or withdrawal symptoms when not drinking
- Developing health problems related to alcohol abuse, such as liver disease or high blood pres-

Although treatment for Alcohol Use Disorder may include in-patient withdrawal management and residential treatment, many people can find recovery through lower-level intervention, including medication assistance, outpatient counseling, and support groups. If you or someone you know is struggling with Alcohol Use Disorder, free, confidential support is available by calling or texting 1-844-HELP-4WV or chatting online at HELP4WV.com.







WARNING TO: ALL PARTIES NAMED IN A DOMESTIC VIOLENCE PROTECTIVE ORDER

A Respondent may be charged with a criminal offense for one of the following actions while this Order is in effect:

- Possessing any firearm or ammunition;
- · Abusing, harassing, stalking or threatening the Petitioner or
- Being physically present at any location where the Order instructs him or her not to be; and
- Continuing to contact, threaten or harass the Petitioner, minor children, or both, by phone, voice mail, e-mail or other means, even if he/she is not physically present with the Petitioner or minor children at the time of the threats or harassment.

ONLY the Family/Circuit Court can dismiss or otherwise change any of the conditions of the Order. A Respondent who violates any condition of the Order may also be found in civil contempt of the Court Order. Having "Permission" or a protected party's "consent" is not a legal defense for a misdemeanor violation of the Order. A Respondent may Petition the Family Court upon dismissal, termination, or expiration of a Protective Order for the return of firearms surrendered or transferred. A Petition shall be made using form FDVPFIR which can be obtained in the Circuit Clerk's office and the WV Supreme Court of Appeals website.

When a Protective Order is in effect, ONLY the Family/Circuit Court has the authority to allow the Respondent to have any type of contact with the Petitioner or to return to the residence of the Petitioner for any reason.

• If the Petitioner and Respondent wish to resume a relationship while the Protective Order is effect, the Petitioner must file a Motion with the Circuit Clerk to terminate (end) or modify the Protecive Order. The Family Court Judge will decide whether the Order should be terminated or modified. You will notified if the Family Court Judge chooses to hold a hearing on the Motion filed.

To: All Parties named in a Denial or Termination Order: The Denial, Termination, or Dismissal of a Protective Order has no effect on any related criminal charges pending against Respondent Any conditions of bond in such criminal case(s) remain in effect.

Gov. Justice, School Building Authority approve \$150 million for new schools, major renovations across 18 counties

CHARLESTON, WV — Gov. Justice, as Chairman of the West Virginia School Building Authority (SBA), announced a groundbreaking investment today as the SBA approved an award of \$149,851,553.00 for 18 new needs-based projects.

This latest funding builds upon a previous award of \$111 million in December 2023, bringing the total awards for Fiscal Year 2024 to an unprecedented \$261 million, setting a new standard for educational infrastructure support in West Virginia.

"I could not be more proud to announce another massive investment in our students," Gov. Justice said. "Our students deserve to have access to the learning environments they rightfully deserve. We continue to shatter records with SBA investments. This is proof we are committed to giving our kids the resources they need to thrive both in and out of the classroom."

Since Gov. Justice assumed office in 2017, the School Building Authority has allocated over \$643 million to county school boards in West Virginia. When combined with the \$363 million from local contributions, the overall investment in the state's educational facilities surpasses \$1 billion.

"This represents more than just a billion-dollar investment in our schools," Gov. Justice said. "It also translates into a billion dollars spent on construction jobs enhancing



these very schools throughout West Virginia. This is a win for everyone and something we are all proud of."

In total, the above projects equal \$87,565,593. Previously announced multi-year projects in Berkeley and Wood County are being funded from this award, as well, equalling \$35,285,960. An additional \$27 million was set aside for future projects, grants, and potential inflationary concerns.

These factors bring the total cost of funding required to address these critical infrastructure needs to \$149,851,553.

Homeowner Rescue Programs Marks Second Year of Helping West Virginians

Funding remains, but homeowners seeking assistance should apply now

CHARLESTON, W.VA.— As the West Virginia Homeowners Rescue Program celebrates two years of helping homeowners across the state, officials encourage qualified homeowners to apply for emergency assistance before funding runs out.

Since launching on March 28, 2022, the Homeowners Rescue Program has paid out more than \$31 million to help 6,300 West Virginia homeowners with their housing expenses, including past-due mortgages, utilities, real property taxes, and home insurance premiums. In July 2023, the program began offering up to \$10,000 to help qualified homeowners make critical repairs to their homes. To date, the program has paid out nearly \$4 million to help homeowners replace damaged roofs and worn-out HVAC systems, make accessibility modifications, or fix plumbing, electrical, and structural issues.

"The financial help we have provided to thousands of West Virginias over the past two years really demonstrates the need for this emergency assistance, especially for critical home repairs," said Erica Boggess, Executive Director of the West Virginia Housing Development Fund, which administers the West Virginia Homeowners Rescue Program. "However, this is one-time funding, meaning that once the money is gone the program will end. We urge eligible West Virginia homeowners behind in their housing costs or struggling to pay for critical repairs to visit the Homeowners Rescue website and apply today."

To be eligible for the Homeowners Rescue Program,

applicants must:

• Own and reside in the home in West Virginia as their primary residence;

• Attest to experiencing a COVID-related financial ardship;

• Be at least 60 days behind in their mortgage and/or at least one installment payment behind in their utilities, taxes, or insurance.

To qualify for help with critical home repairs, applicants must own and reside in their home as their primary residence in West Virginia and attest to experiencing a COVID-related financial hardship. Homeowners do not need to be delinquent in their mortgages to qualify for home repair assistance, but they must:

- Submit a signed bid from a licensed, insured contractor and photos of requested home repairs;
- Submit proof of identification, residency, ownership, and income, as well as statements from creditors showing past-due amounts owed; and
- Provide proof that they are up-to-date on their mortgage payments or that they do not owe a mortgage.

"For two years, we've heard from many West Virginians how this program has saved their homes from fore-closure or the auction block," said Jessica Greathouse, the Fund's Special Programs Manager. "Although we have helped more than 6,300 households, we know there are more people out there who may not have heard about the program yet or are hesitant to apply. We really encourage any eligible homeowner who has experienced a pandemic-related financial hardship to

get your documents together and submit your application. Our caseworkers are reviewing applications and approving payments every day to help West Virginians keep their homes. We want to help as many people as possible with the remaining funds we have available, so get those applications in today."

Applications generally are best completed in a single sitting and applicants should have all necessary documents ready ahead of time. Once the application is complete and documents are uploaded, applicants should be sure to click "submit" to ensure the application is fully submitted and ready for review. Applications showing a "Pending" status are not submitted and will not be reviewed until fully submitted.

The West Virginia Homeowners Rescue Program has limited funding available. Eligible claims will be paid as funding allows. The program reserves the right to close the application portal when all funds are committed.

RCHA provides Section 8 rental assistance, with federal funding from the Department of Housing and Urban Development, as well as a program that helps participants transition out of the Section 8 program and into home ownership. RCHA's Family Self-Sufficiency (FSS) program provides support to families so they can obtain employment on their path to economic independence. Working with multiple nonprofit housing partners, RCHA manages nearly 170 properties including mixed-income residential rental, commercial, and mixed-use properties.

Through the YouthBuild North Central program, RCHA serves individuals between the ages of 16 and 24 living in Randolph, Tucker, Upshur and Barbour counties. Participants in this workforce readiness program learn marketable job skills and leadership skills while building assets that benefit our communities. Participants can also earn a high school equivalency diploma.

RCHA's Supportive Services division, led by Lexi Taylor, who was recently named Supportive Services Manager, addresses the needs of individuals experiencing homelessness by promoting rapid re-housing and helping affected individuals become financially self-sufficient through job training and other assistance. In addition, Supportive Services addresses the housing and vocational needs of those who are in recovery or transitioning out of the criminal justice system.

RCHA also has announced that its First Step Heavy Equipment Training (FSHET) program will resume this spring.


The five-week FSHET training program, funded through a grant from the U.S. Department of Labor, is designed as a screening tool for potential employers and involves working with participants to ensure they have the skills and qualifications to be effective heavy equipment operators. Participants gain experience working on a heavy equipment simulator and may have the opportunity to become certified on at least two pieces of equipment.


