WVU Students Plant Trees at Camp Kidd

Just in time for Earth Day, members of the Honors Section of the Conservation Biology Class at WVU volunteered with Friends of the Cheat to plant native trees along the banks of the river at Camp Kidd. The activity was part of the Friends of the Cheat's Riparian Reforestation project in the area. Project Coordinator Garrett Richardson with Friends of the Cheat was on hand at the event. "We are doing a Riparian Tree Planting," Richardson said. "They are reforesting the area directly next to, adjacent to, water."

Richardson said he is working in collaboration with the Tucker County Commission on the project at Camp Kidd. According to Tucker County Commission President Mike Rosenau, the project is being completed at no cost to the County. "I have been working with Mike and the Tucker County Commission to do this project," Richardson said.

Funding for the program, according to Richardson comes from a grant through the USDA's Natural Resource Conservation Service (NRCS). "We have a grant program that we have been doing the last four years," Richardson said. "Its a grant through NRCS which is a Federal agency, so

they provided the grant funding and we work with private land owners in the Cheat Watershed."

The Riparian Reforestation Project, according to Friends of the Cheat, is a program designed to assist land owners, at no cost, to assist with bank loss, instability and erosion to land along the Cheat River and its Tributaries. "There are many ecological benefits to having trees planted along the banks," Richardson said. "It provides stabilization to the bank. It reduces sedimentation, it improves water quality."

According to Richardson, the project is planting native trees along the bank. The species being planted at Camp Kidd include: American Sycamore, River Birch, White Oak, Red Maple and Tulip Poplar, Richardson said. The focus, according to Richardson, is on diversity along the bank with more water tolerant species are planted closest to the river with other native species planted farther out. "Closer to the water, we like more water tolerant species like River Birch and Sycamores because the river get up so high...that's why you'll see pretty much only Sycamores really surviving up close to the river," Richardson said.

A Riparian Area is defined by Friends of the Cheat as land directly next to a body of water, such as a stream or river. Friends of the Cheat also state that mature trees in





these areas protect fields from flood waters, reduce erosion and bank loss, as well as help to filter agricultural runoff and improve water quality in the river. "Historically, in this area and many areas, we've deforested," Richardson said. "We've taken trees out for farming and for development and over time you've seen that cumulative effect and there's water quality issues and habitat issues from that."

According to Richardson the Riparian Reforestation Project is ongoing. Richardson said that the Friends of the Cheat are always looking for volunteers to assist with the project. "This isn't the only day we're here," Richardson said. "We'll be out here a few more days."

While the project cannot be completed in one weekend, Richardson said that the availability of volunteers will determine when his organization can next work at the site. "It would be nice if we could do a longer haul like a whole weekend," Richardson said. "But, right now we are just picking days and so this group was able to do it on a weekend so we took this opportunity."

City of Parsons Approves Building Design

The City of Parsons Council approved a design plan for two lots on Main Street. The approval was part of the Council's regular April 16th meeting. The building design is part of a project by Woodlands Development Group for the property next to the Veterans Memorial. The approved design is slated to include two

stories of housing in each building for a total of six two-bedroom units and two one-bedroom units, as well as commercial space on the first floor of each.

The design was one of four options presented two weeks prior to the Council by Woodlands and Architect Bryson Van Nostrand. Van Nostrand was on hand at the meeting to address any last minute questions or concerns by the Coun-

City of Parsons Discusses Need for Water Rate Increase

"You just don't just snap your fingers and make a rate change," Auvil said.

The City of Parsons Council discussed the need for a rate increase within the Water Department. The discussion came as part of the Council's April 16th regular meeting. In the meeting, City Recorder Tim Auvil discussed the need for the rate increase due to a variety of factors including rising operation costs and insufficient funds for the Department requiring the City to provide additional funding from other sources. "Water needs a rate change more than sewer does," Auvil said.

The discussion was part of a larger agenda item that approved the implementation of The Rodeheaver Group, CPA to evaluate Water and Sewer Rates and provide a proposal for any future needed rate adjustments and any possible employee pay increases.

"Frankly, I know that this is the

year that is for sewer, next year is actually for water," Auvil said. "We need to invert those because water is in worse shape than sewer was."

According to Auvil, the rate increases that the CPA group will evaluate can be implemented at different times, but by having both evaluated simultaneously, the City will save money. The dual evaluation will eliminate the need for a future CPA expense on the issue because the paperwork would already be complete, according to Auvil. "You can stagger those," Auvil said. "By having the CPA do both of those Rule 42's at the same time it will save money, but you don't have to implement the rates at the same time. In other words, Water and Sewer all at once. You can implement the Water now and six months later you can implement the Sewer."

City Attorney Tim Stranko said the City would need two rate increases on the Water. According to Stranko, the City needs a "Going Level Increase" to allow the City to break even on the Water Department and eliminate the need for the City to subsidize the budget of the Water Department with other budget categories. The second increase would come in the form of a "Project Related Increase" which

cil prior to their determination. "We're anxious to see what you all think," Van Nostrand said. "We've had two weeks to mull it all over."

Parsons City Council Member Kathy DiBacco while supporting Option C with the three stories, expressed concerns over the size of the lots the project is located on. "The one I decided I liked was (Option C)," DiBacco said. "But how's it all going to fit? I looked at it and was like, 'There's no way its all going to fit on there."

According to Van Nostrand, in the option chosen by the Council, the building would be designed further back on the lot and would structurally serve as part of the retaining wall. Van Nostrand said the retaining wall of the Memorial took up about half of the lot and reduced the space available. "Option C is where the buildings are becoming pushed back against the hill, just like the original buildings such that the building is actually part of the retaining wall, if that makes sense and that means we don't have to do how the Memorial was handled, "Van Nostrand said.

The rock analysis, Van Nostrand said, showed the hillside to be solid rock, which would further assist in the construction and lessen the load on the retaining wall portion of the building. "That hill's not going anywhere, its not clay," Van Nostrand said. "We're not putting back near the volume that was once there."

Parsons City Council Member Sam Humphrey asked about neighbor concerns regarding the height of the building. At the initial presentation two weeks prior, it was stated that a neighbor was concerned that a three story building on the corner could impede the view from their property behind. "I thought we talked last meeting that you spoke to the lady behind there and she don't want her view blocked," Humphrey said, "That's why you drew up 'Option C,' correct?"

As a result of initial neighbor concerns, Van Nostrand presented two versions of "Option C (C1 and C2)," with the main difference being one option would include two three-story buildings and the other would include one three-story building with a two-story building. City Recorder Tim Auvil discussed the differences in the options. "If we do C1 we lose a commercial spot because the building on the right would be two stories instead of three," Auvil said. "If we go C2, it would be three stories on each and we do not lose a commercial spot, correct?"

Van Nostrand said that there was an option to install a flat roof on the buildings, which would lower the height of the building and would not impact the view behind the project as much. "When we were talking about it, I said I could make a flat roof which would eliminate that high trussed roof," Van Nostrand said. "Which would help some."

Van Nostrand said that with two three-story buildings, there would be no residential space on the first floor. In the other "Option C," the two-story building would contain residential on the street level. "I think

that is a really important concern for me," Van Nostrand said. "I don't want any residential on the sidewalk level if we can help it. I certainly wouldn't want to live in it, I think as we've discussed, we want commercial space on the sidewalk. That's seemingly what the town

Auvil expressed support for "Option C." Auvil said that he felt the two building option set back from the sidewalk would better fit with the Veterans Memorial. Auvil also said he liked the option to have the parking for the ADA unit separate and near the unit. Under the proposal, a designated unit for an ADA unit would be located in the rear at the resident entrance away from street level. "Aesthetically, I think C is definitely going to be a lot more appealing to kind of go parallel to the Memorial," Auvil said. "And you don't have an open space there to stare at a blank wall."

Parsons City Council Member Tim Turner expressed concerns over the dual entrance locations. Turner asked whether the Department of Highways have expressed any concerns over the location and potential impact on traffic, especially at the nearby traffic light. "I didn't see any report from the Department of Highways on their thoughts of these two driveway entrances and exits," Turner said. "Have we even contacted them about

Van Nostrand said that the DOH was aware of the project. According to Van Nostrand, he did not foresee any negative impacts from the DOH, but the entity could regulate the flow of traffic in the area. Van Nostrand also said that he did not expect the proposal to be immediately denied by the DOH and felt the design was "workable." "They are aware of the project," Van Nostrand said. "I think the Department of Highways cannot prevent us from building two approaches. I think the Department of Highways can say we want people to only turn right, as they are coming out and I think that is a good safety feature."

Van Nostrand also said that his engineering team has been in contact with the DOH District Engineer on the project. According to Van Nostrand, his Civil Engineering Team contacted the DOH directly after his meeting with the Council two weeks prior. "They reached out the local District Engineer," Van Nostrand said. "They've made contact, they've shared these preliminary drawings with them. They are expecting to have a meeting out here, but they haven't had that yet."

A motion on "Option C" with two three-story buildings was approved by vote of the Council with Parsons City Council Member Melissa Jones a dissenting vote on the measure. The motion was made by Recorder Tim Auvil. The motion included the design of two three-story buildings, pending any further developments on the issue.

The next meeting of the City of Parsons Council will be held Tuesday, May 7th at 6 p.m. at the Charles W. "Bill" Rosenau Municipal Building located at 341 Second Street in Parsons.

would be related to bonds on any future projects."It sounds like we need a Going Level just to break even if we're in the red now and then to service the bonds that at some later time will be that second piece," Stranko said.

According to Auvil, the City has been consistently subsidizing the Water Department with its regulatory required savings for bond payments. The Public Service Commission of West Virginia, according to Auvil, requires the City to maintain 115% of the amount of the City's bond payments in savings. Auvil said the City has been having to subsidize the account to maintain the requirement. "The Sewer is kind of keeping up with it," Auvil said. "But we have to maintain 115% in reserve in our savings to cover all of our bond payments. That's mandatory by PSC regulation and that is what we have not been meeting because we have been having to take money out of the savings to pay the bills of the Water and Sewer Departments."

Auvil also said the City needed to maintain rates that met 1.5% of Median Household Income in order to qualify for grant funding. "We also want to make certain that we meet 1.5% MHI, which is Median Household Income, otherwise we don't qualify for any grants. Every half percentage you are up, you qualify for half a million dollars in grant funding in either department."

Council Member Melissa Jones asked what time frame the last vote on rates set for changing the rates. Auvil said that while staggering implementation was discussed, the three year timeframe set was for re-evaluation of rates. "Every three years," Auvil said. "It didn't mean we were going to change, it meant we're going to re-evaluate the rates on each department every three years and we were going to stagger them: one, one year; one the other year, instead of waiting eight, ten years and then just wham all of a sudden a massive increase."

Auvil said that regardless of the time that has passed since the rates were re-evaluated, the Federal funding associated with the City's Water and Sewer Projects would require the re-evaluation due to the grant funding. "Either way with the Water and the Sewer Improvements project, because you have Federal funds involved with that, it triggers an automatic rate evaluation anyway," Auvil said. "In order to use Federal money you got to re-evaluate the rates, which basically once the project is near, I think it is 75 to 80 percent, that's when the rate has to go into effect, during the completion, not during the bid process."

Auvil said that while the requirement for implementation is tied to construction of the project, a rate increase can be implemented at any time in the process. The 75 to 80 percent requirement is a benchmark for rate implementation, according to Auvil. "We can implement it at any time, but right now I know that the Water Department is really not in good shape," Auvil said.

"There's been a lot of cost increase with chemicals like chlorine," Auvil said. "

Jones asked Auvil about the Stabilization Fund for the Water Department and whether it existed to subsidize the Department's financial shortfalls. According to Auvil, rate increases take time to show improvement in the finances. "That's what that's there for because right now we have to have that," Auvil said. "Because you just don't just snap your fingers and make a rate change and even once a rate is implemented, if there's an increase, you're not going to see any good from it for months until things start getting built back up. It doesn't happen immediately just because you increase the rates today. It'll be two or three months before you finally start digging out of the hole."

A motion to approve the The Rodeheaver Group, CPA to "implement Rule 42 per PSC Regulations, to evaluate the Water and Sewer Rates and present a proposal for needed future rate adjustments, to include any upcoming bond payments for both departments and any possible employee pay increases" was passed by unanimous vote of the Council.

Residents can help protect black bears and prevent nuisance activity by cleaning up their property

bear attractants from property

BECKLEY, W.VA. — To prevent humanbear conflicts around the state, the West Virginia Division of Natural Resources is reminding residents to take extra precautions by removing bear attractants from their property.

"Deliberately feeding a black bear is illegal in West Virginia, but many people don't realize that they are unintentionally feeding bears, which can cause serious problems for people, their property and our state animal," said WVDNR Director Brett McMillion.

Common bear attractants include bird feeders, pet food and food scraps and unsecured trash. Bear activity increases and peaks in May and June, but the WVDNR starts receiving reports of human-bear conflicts in April when high-energy food sources such as serviceberries, raspberries, blackberries and blueberries are scarce.

"Once a bear becomes food-conditioned

and habituated to humans, they often have to be humanely killed for safety reasons," said Colin Carpenter, black bear project leader for the WVDNR. "That is why we remind people every year to take responsibility for their property by removing or securing food attractants before a bear finds them."

Residents can help prevent nuisance bear activity by following what Carpenter calls the bearwise basics, which are:

- Never feed or approach bears
- Secure food, garbage and recycling
- Remove bird feeders when bears are active
 - Never leave pet food outdoors
 - Clean and store grills

 Alert neighbors to bear activity

CHARLESTON, W.Va. – The West Virginia Department of Health (DH), Bureau for Public Health, Office of Nutrition Services (ONS) today announced updated U.S. Department of Agriculture (USDA) income eligibility guidelines for the Special Supplemental Nutrition Program for Women, Infants and Children (WIC).

The new income eligibility guidelines will take effect on Monday, April 15, 2024. The new guidelines allow a family of four earning \$57,720 annually to qualify for WIC program benefits, a \$2,220 increase from 2023. These guidelines are adjusted to account for recent inflation over the past year.

"Our goal is to provide nutritional services and information that help keep West Virginia families healthy," said Heidi Staats, Director of ONS. "Currently, West Virginia WIC serves more than 37,000 mothers and young children monthly. With the expanded income guidelines, we can serve more families."

guidelines, we can serve more families."

West Virginia WIC serves 70% of all babies born in the state. Enrolled families receive nutrition edu-

cation, breastfeeding support, nutritious foods, and access to maternal, prenatal, and pediatric health care services that may otherwise be unavailable.

Eligibility projections from ONS indicate as many as 18,130 residents qualify for West Virginia WIC, but are not participating. Fathers, mothers, grandparents, foster parents, or any legal guardian of a child under five are encouraged to apply. The new income guidelines are:

DoHS and WVDE Announce Launch of Summer EBT Program for West Virginians

CHARLESTON, W.Va. – The West Virginia Department of Human Services (DoHS), in conjunction with the West Virginia Department of Education (WVDE), today announced the launch of a new federal public benefit program to support school-age children residing in low-income households.

The West Virginia Summer EBT (WV-SEBT) program will provide short-term grocery benefit assistance to income-eligible households with school-age children during the summer months. The application period will open on April 22, 2024, and can be accessed at schoolcafe.com or by completing a paper application at a local DoHS county office.

"Ensuring every child has access to nutritious meals is a cornerstone of building strong, healthy communities," said Janie Cole, DoHS Bureau for Family Assistance Commissioner. "The launch of the WV-SEBT program represents a crucial step forward in supporting our state's residents by providing essential grocery assistance during the summer months, as we maintain our commitment to fostering a brighter future for West Virginia children."

Unlike Pandemic EBT (PEBT), which ended when federal emergency orders expired, not all children that attend a school where all students eat for free will automatically receive the benefit. Children will be deemed eli-

gible based upon their household's lowincome status. Eligible children include those attending a school that participates in the National School Lunch Program and residing in a low-income household that qualifies for free or reduced-price school meals.

"Summer poses a significant challenge to children who are away from school and facing food insecurity," said Michele L. Blatt, State Superintendent of Schools. "Even though students are out of school for the summer, hunger does not take a break, and this program is essential to meeting the nutritional needs of our school children. We know families continue to struggle from pandemic aftershocks, and the WV-SEBT program will fill an important nutrition gap for thousands of students."

Additionally, if a West Virginia household is already receiving certain public benefits, such as Supplemental Nutrition Assistance Program (SNAP) or WV WORKS, and has school-aged children between the ages of six and 17, those children will automatically be enrolled in Summer EBT, regardless of their method of schooling. Children in low-income households attending Community Eligibility Provision (CEP) schools, where they do not collect free or reduced-price meal applications, will have to complete an online Summer EBT application and qualify by income.

All eligible children will receive



their one-time benefit of \$120 on a brand new Summer EBT card. Benefits will not be loaded onto previous PEBT cards or existing Mountain State EBT cards. Summer EBT cards will be mailed to the address on file with the child's school or their public benefit case. Benefits are tentatively slated to reach eligible households in June 2024.

It is estimated that 202,000 children in West Virginia will be eligible for the 2024 Summer EBT benefit. The WV-SEBT program was authorized and approved by the United States Department of Agriculture (USDA).

DoHS Announces Emergency Energy Assistance Program for Low Income Residents

CHARLESTON, W.Va. – The West Virginia Department of Human Services (DoHS), Bureau for Family Assistance (BFA) today announced that applications for the Emergency Low Income Energy Assistance Program (LIEAP) will be accepted beginning Monday, April 22, 2024, to Friday, April 26, 2024, or until funds are exhausted.

The federally funded program assists eligible West Virginia residents in paying home heating bills. To qualify, households must meet all program guidelines and be in an emergency situation that will disrupt the primary heating source if not met.

Residents whose primary source of heat is either gas or electricity must provide a shut-off notice when applying for Emergency LIEAP. Those using other primary heating sources or bulk fuel may qualify for assistance if their heating fuel is at a critically low level during the application period.

Households that received direct payment of regular LIEAP benefits must verify that the payment was used for home heating by submitting a current receipt with the Emergency LIEAP application. Failure to submit verification of payment may result in a denial of the application.

Eligibility for LIEAP benefits is based on income, household size, and whether the household is responsible for paying its heating bill. Income limit for fiscal year 2024 is 60% of the state median income. In these situations where a heating emergency exists, applicants must be seen by a

DoHS worker.

*For each additional person, add \$642. Households whose countable income exceeds the maximum amount are not eligible. However, some types of income may be excluded for LIEAP.

Hosted by West Virginia University and supported by the West Virginia Department of Education's Division of Instruction and Career Engagement, the Governor's School for Tourism will provide students the opportunity to experience their home state as a visitor for 10days. Students will visit many of the state's travel regions and meet with dozens of industry professionals who will offer a glimpse into careers in outdoor recreation, arts and culture, hospitality and lodging, and culinary arts.

The traveling classroom will provide students with a wide range of experiences and lessons

including:

- Adventure tourism instruction at WVU Adventure Outdoor Education Center in Morgan-
- West Virginia history lesson at Blenner-

 First-hand off-roading experience and discussion of trail-based economic development
- with the Hatfield-McCoy Trails
 Exploration of the whitewater rafting industry and an opportunity to paddle down the New River in the nation's newest National Park
- Culinary tourism lesson with James Beard nominated chef
- A trek through Summersville Lake State Park, the state's newest addition to the state parks system
- Insider look at destination marketing highlighting the West Virginia Waterfall Trail
- Hands-on lesson on trail building at Cacapon Resort State Park

Overnight accommodations will include a resort, campus dormitory, state park lodges, hotels, and glamping tents, exposing students to a diverse range of hospitality business models.

The Governor's School for Tourism will accept one student from each county, as well as one student from each of the state's five charter schools and a student from the West Virginia Schools for the Deaf and the Blind. These students must be currently enrolled freshman or sophomores, during the 2023-2024 school year. After completing the program, students will serve as the Governor's official tourism ambassadors for the year following their participation in the School. The curriculum and educational components will be led by West Virginia University's esteemed Hardy Family Hospitality and Tourism Management program within the John Chambers College of Business. Charleston WV - The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

April 24, 1865: McNeill's Rangers surrendered to Union troops at New Creek (now Keyser). The Confederate guerrilla force probably never numbered more than 100 men at any time but managed to inflict regular damage on Union operations.

April 25, 1863: About 1,500 Confederate soldiers under Gen. William "Grumble" Jones advanced through Greenland Gap, a deep pass through New Creek Mountain in present Grant County. The Confederates encountered 87 Union soldiers who held off several assaults before finally surrendering.

April 25, 1923: Union leader Arnold Ray Miller was born at Leewood on Cabin Creek in Kanawha County. In December 1972 he defeated Tony Boyle to become president of the United Mine Workers.

April 26, 1816: General Alexander Welch Reynolds was born in Lewisburg. He served in both the U.S. and Confederate armies. After the war, Reynolds accepted a commission as a colonel in the forces of the khedive of Egypt, which ruled Egypt under the Ottoman Empire.

April 27, 1978: An accident at the Willow Island Power Station on the Ohio River killed 51 men. The scaffolding that had been erected for use in the construction of a new cooling tower collapsed, sending the workers plunging to the ground.

April 28, 1884: Musician Henry Reed was born in Peterstown, Monroe County. Reed was a legendary West Virginia fiddler whose repertory contributed to the old-

April 26, 1900: Baseball great Lewis Robert "Hack" Wilson, whose 1930 single season runs-batted-in record stands today, was born in Pennsylvania. He started his pro career with the Martinsburg Blue Sox. He returned to Martinsburg after his retirement and is buried at Rosedale Cemetery.

time music revival in the last half of the 20th century.

April 28, 1914: An explosion at the Eccles No. 5 mine in Raleigh County killed 174 men. The mine connected with Eccles No. 6, operating in another coal seam. Nine men in No. 6 died of injuries and of afterdamp, the deadly gas left after a mine explosion.

April 28, 1920: The Monongahela National Forest was created by presidential proclamation. It is the only national forest completely within the boundaries of West Virginia.

April 28, 1924: An explosion ripped through the Benwood coal mine south of Wheeling, killing 119 min-

April 28, 1948: Watt Powell Park opened in Charleston. About 8,000 people, including Governor Okey L. Patteson, attended the city's inaugural game in the Class A Central League. After the 2004 season, Watt Powell Park was replaced by what is now known as GoMart Ballpark, and the old park was demolished in 2005.

April 29, 1863: Confederate General William E. "Grumble" Jones waged a battle at Fairmont that

involved a force of 500 regulars, home guards and volunteers. The Confederates prevailed, burning the personal library of Francis Pierpont, governor of the Restored Government of Virginia, and exploding an iron railroad bridge across the Monongahela River.

April 29, 1924: Playwright, teacher, and actress Ann Kathryn Flagg was born in Charleston. She is best remembered for her play Great Getting' up Mornin', which was broadcast by CBS-TV in 1964.

April 30, 1871: Coach Fielding "Hurry-Up" Yost was born in Marion County. He was a tackle on West Virginia University's football team in 1895 and 1896, while earning a law degree. In 1901, Yost's first season as coach at University of Michigan, the Wolverines compiled an 11-0 record, including a 49-0 defeat of Stanford in the first Rose Bowl.

April 30, 1927: An explosion roared through the Federal No. 3 mine owned by New England Fuel and Transportation Company of Everettville, Monongalia County. The explosion, subsequent fire and gas in the mine killed 97 men.







NOTICE OF PUBLIC HEARING AND ABSTRACT OF BOND ORDINANCE
Notice is hereby given to any person interested that on April 10, 2024 the Town Council of the Town of Davis, West Virginia (the "Town") adopted an ordinance which, among other things:

1. Authorized the acquisition and construction of certain extensions, additions, betterments and improvements to the sewerage portion of the existing combined public waterworks and sewerage system of the Town of Davis and the financing of the cost thereof, not otherwise provided, through the issuance by the Town of Davis to upgrade the existing lagoon with the installation of surface aerators and construction of a baffle wall, of not more than \$300,000 in original aggregate principal amount of Combined Waterworks And Sewerage System Revenue Bonds, Series 2024 A (West Virginia Infrastructure Fund); (the "Bonds").

2. Directed that the Bonds be issued in such principal amounts, bear interest at such rate or rates, not exceeding the then legal maximum rate, mature on such dates and in such amounts and redeemable, in whole or in part, as prescribed in a supplemental resolution.

3. Directed the continuation of a revenue fund and the disposition of the System revenues; provided for the payment of operating expenses of the System and debt service on the Bonds; directed the creation of a sinking fund and a reserve account for the Bonds and creation of the renewal and replacement fund; and directed the creation of a bond trust fund and the disbursement of Bond proceeds.

4. Provided that the Bonds shall not be or constitute a corporate indebtedness of the Town within the meaning of any statutory or constitutional limitations, but shall be payable solely from the Gross Revenues of the System; pledged the Gross Revenues of the System to payment of the Bonds and established the rights of the registered owners of the Bonds to such Gross Revenues; provided certain conditions for the issuance of additional bonds.

5. Provided for insurance coverage on the Project and the System, enforcement of collection of fees, rates or other charges for the System and other covenants in favor of the registered owners; established the events of default and the remedies of the registered owners; and provided for the modification or amendment of the Ordinance upon the terms and conditions set forth in the Ordinance.
The Town contemplates the issuance of the Bonds described in, and under the conditions set forth in the

Ordinance abstracted above. Any person interested may appear before the Council of the Town of Davis at a regular meeting on Wednesday, May 8, 2024 at 6:30 p.m., in the Council Chambers, Davis Town Hall, 505 Williamson Ave. Davis, West Virginia, and present protests and be heard as to whether the above-described Ordinance shall be put into effect.

A certified copy of the Ordinance as adopted by the Council of Town on April 10, 2024, is on file with the Recorder for review by interested persons at the Town Hall during regular office hours.




