Meet the Candidate: Ben "Travis" Hamrick for **Tucker County Commission**

Ben "Travis" Hamrick has thrown his hat into the ring in Tucker County. Hamrick, a carpenter by trade, is running for Tucker County Commissioner against incumbent Fred Davis. Hamrick is a resident of Canaan Valley who describes himself as a conservative Democrat. "I'm a Democrat, but I feel that I am a Conservative Democrat."

According to Hamrick, transparency and the inclusion of the community in decisions is an important component to the Commission. Among his proposals, Hamrick presented the idea of holding County Commission meetings in multiple locations such as in outlaying communities like Davis, Thomas and Canaan Valley. "I think transparency is important to the County residents," Hamrick said. "I think (it is important) to be invited to be involved in the decisions that affect them."

Another of Hamrick's proposals includes the establishing of a quarterly Tucker County Roundtable. Hamrick said he felt the creation of the Roundtable would create another layer of transparency in local government. "This would be a good thing to create a Tucker County Roundtable where members of every County board, or example Planning Commission, Parks and Rec, Board of Education, Convention and Visitors, just a few to mention, can sit down together and discuss goals, achievements and current activities," Hamrick said.

Hamrick said he felt he was a good listener and independent thinker. According to Hamrick, if elected, he would focus on protecting Tucker County identities and values. "If I was elected," Hamrick said, "I would work with coming up with solutions to protect our Tucker County identities and values."

Hamrick said he has been a carpenter since graduating high school in Tucker County in 1981. According to Hamrick, he has been employed by Miller Contracting for 27 years. Hamrick attributes his decision to become a carpenter to his carpentry teacher and mentor Jared Parsons. "He was my vocational teacher and a great mentor and the reason I became a carpenter," Hamrick said.

Besides his work as a carpenter, Hamrick said he also obtained a permanent teaching certificate to teach vocational and carpentry and had previously taught at the Rubenstein Center School as

Hamrick said he has also volunteered as a coach of various sports in Tucker County over the years. According to Hamrick, he has been a coach for Junior High Boys and Girls Basketball, Little League Baseball, Babe Ruth, an Assistant High School Baseball Coach and Assistant Girls Basketball Coach. "Probably 16 years of coaching, at least," Hamrick said.

Hamrick also said if elected, he would strive to manage the County budget and direct County funds to projects that benefit the whole of Tucker County. Hamrick said he would have the dates and times of Commission meetings posted in multiple places.

Hamrick said in his free time he enjoys such outdoor activities as hunting, fishing and golf. According to Hamrick, he is a member of the Holly Meadows Golf Course in Parsons.

Hamrick is a 1981 graduate of Tucker County and has resided in Tucker County since his family moved from Randolph County in 1970, according to Hamrick. Hamrick lives in Canaan Valley with his wife Kim and a Golden Retriever named Beau who accompanies him to work. Hamrick has two sons, two step-daughters and their families.

Davis Volunteer Fire Department Chief Allen Cosner addressed the Davis Town Council to discuss the need for the adoption of a Fire Fee by the Town Council. Under the proposal, residents and businesses would see a flat rate fee on their water and sewer bill that would be allocated to

for funds," Tomson said.

According to Cosner, the Fire Department is in need of the Fire Fee due to not only the rising cost of materials and operating costs, but without a Fire Fee, many grant opportunities are not available to the Department. "I have brought you a copy of a rough draft for a Fire Fee Ordinance due to everything growing, prices tripling," Cosner said. "We got a donation now for the Fire Department on the Water bill but we're restricted on grants. They are changing many of our grants and you have to have a Fire Fee in place to be eligible to get these grants."

Cosner said the Fire Fee would supply a long term separate the funding, but also has a plan in place for full accountability of the public funds. The funding record, according to Cosner, will be public information and his department will maintain records of transactions from the account that will be available for public review if requested. "Once it gets changed over to fee, it will be in its own account," Cosner said. "As of now, the State doesn't have stipulations on it, but all that money will be in its own account and everything that it is spent on will be kept a record of where it went and when it was spent. That way if anyone needs to know, its all public information."

Cosner said that he had been in touch with Fire Departments in the City of Parsons and the City of Thomas about the Fire Both municipalities have a fee in place, according to Cosner. "I've talked with Parsons, I've talked to Thomas because they have both put these in place," Cosner said. "Thomas' goes into effect in July."

Town of Davis Mayor Al Tomson said he had spoken with Thomas Mayor Jody Flanagan and that Mayor Flanagan was a supporter of a Fire Fee and was pleased that a fee had been implemented in Thomas. "He is really pleased that they had did this in Thomas," Tomson said. "Because he sees this as being a big benefit to the Fire Departments that historically struggle for funds."

Tomson said that he had also discussed the structuring of Thomas' Fire Fee with Flanagan. According to Tomson, the fee in Thomas is structured differently depending on the use of the building with different fees for residential and commercial structures. Tomson gave the example of a residential unit having a fee of \$5 a month, with a non-residential structure such as a business or Airbnb fee of \$8 a month, a multi-family unit structure fee of \$8 and an industrial structure fee of \$12 a month. Tomson said by scaling the fee structure, the residents were not impacted with the largest fee. "The other thing that they view over there as

being very beneficial is that the fee structure is different depending on what category your dwelling is in."

According to Cosner the cost of a fire truck has gone up 123% in the last three years due to inflation. Cosner said that the cost of a new truck has gone from \$580,000 three years ago to just under \$1 million today. Cosner also said the cost of gear for fire fighters has also risen in recent years. Cosner also noted a cost of \$14,000 a year for Workman's Comp Insurance for his volunteer department. "Its getting ridiculous on the prices," Cosner said. "We're at \$20,000 just to put somebody in gear and its got to be replaced every 10 years due to State and Federal mandates."

The fee, according to Cosner would be only for the Davis Fire Department. When asked by Council Members if EMS would be included in the Fire Fee, Cosner said it only impacted the Town Fire Department, as EMS was its own entity and would be responsible for their own funding.

Council Members also voiced concerns over citizens refusal or inability to pay the additional fee. Tomson said that if it becomes a mandatory fee, citizens would have to pay. Cosner said he has been in touch with Parsons about an exemption program they have implemented for low income residents and those on fixed incomes. According to Cosner, Parsons only has applied for the exemption program. Tomson said that the Town would likely implement a similar program should the Fire Fee be adopted. "We would like to do that, too," Tomson said. "We are going to have some people in the same situation."

acknowledged Tomson that the Town is implementing raises in utility rates and the pressures these financial measures have on residents. "We're raising water rates, we're raising sewer rates, everythign is going up," Tomson said. "And incomes are not keeping up with (that)."

Town Council Member Carrie Hawkins said that Fire Departments are closing due to increased financial pressures. "There's a number of Fire Departments that are closing," Hawkins said. "I mean we can't let that happen, but it could."

According to Cosner, the effective date for a Fire Fee would be determined by the Council should a Fire Fee be approved. No determination on the issue was made at the April 10th meeting of the Council. The issue was further addressed at the Town Council's April 24th meeting. "I think that we need to keep thinking about it and talking about it and decide sooner than later that we're going to do something about it," Tomson said.

The Town of Davis Council meets the second and fourth Wednesdays of the month at Davis Town Hall in Davis.

Prodigy Purchases Land from County

The Tucker County Commission authorized the sale of 1.48 acres of land to Digital Communications, Inc., also known as Prodigi. The Commission approved the sale at the April 24th regular meeting.

The land is located along the northeast side of Butts Farm Road, County Road 72/7, in St. George District near the intersection of County Farm Road, according to documents supplied to The Parsons Advocate. The land acquired by Prodigi was a part of a larger 174 acre parcel owned by the County Commission in the area of the former "County Farm," according to the documents.

A Memorandum of Understand (MOU) was approved by the Commission. In the document, the details of the land sale were outlined. In the MOU it was outlined that should Prodigi no longer have need or use of the land at a future date, the land and any improvements to it would be deeded back to the County Commission.


The MOU document also stated that Prodigi would prepare and gravel a parking/landing area between the road and the parcel of land owned by Prodigi. The parking area would be for use by the County Commission. The document also contained an agreement for Prodigi to provide free internet to the County Commission. The County Commission agreed in the document to a right of way that would allow ingress and egress to the parcel and a through gated road to the parcel of land.

The Real Estate Sale and Purchase Agreement stated that Prodigi purchased the property for \$9,500. Also included in the document, it was noted that there are currently no utilities connected to the property.

Tucker County Commission President Mike Rosenau read the MOU into the record. The matter was approved unanimously by the Tucker County Commission.

The next meeting of the Tucker County Commission will be held Wednesday, May 8th at 9 a.m. at the Old

News of Record

The following criminal complaints have been filed in the Tucker County Magistrate office:

Brandon Tyler Streets, of Parsons, was charged with two counts of Child Neglect with Risk of Injury. According to the complaint, on Sunday, April 14 at approximately 7:47 a.m. Sheriff J.E. Kopec was traveling along WV72 in front of the Annex when he was flagged down by off duty Parsons PD Chief Keplinger. Kopec pulled over and was informed by Keplinger that he was traveling to church when he found two young children in the roadway on the double yellow line. The children appeared to be about four years old. Kopec noticed one of the boys was in his boxer under-wear and an unzipped hooded shirt with no t-shirt. He asked the boys what they were doing and they said they were going to the park. They were cold so Kopec put them in his vehicle to warm them up and keep them safe.

Kopec contacted 911 to see if they had the boys' parent's names in their system, in an attempt to locate them. He then attempted to find their home by driving around the Parsons vicinity going off their direction, which was skewed at best. The boys did not have the best speech or knowledge of where their home was. This went on for 40 minutes until Kopec overheard one of the boys talking with his brother and state "Big Sam". He asked the boy what he meant and he said, "Big Sam with the Big Truck." Kopec knew of a Big Sam and called Sam Humphrey, who owns an apartment complex along Smokey Hollow Road. He informed Kopec the boys' father rents from him in the apartment complex. He then brought the boys to a residence at the apartment complex and they took him to an apartment where the front door was wide open. The boys walked in and Kopec asked them to go get their dad. Kopec talked to the father, identified as Brandon Tyler Streets, outside.

Streets informed Kopec that he had a long night that he had to go out to pick someone up at 2 a.m. and had recently worked a long shift. Streets informed Kopec that this had happened about a week ago and a neighbor brought the boys back that time. The boys were left in care and custody of their father because it was his visitation time. The children were .2 miles from their residence.

After informing the Tucker County

Prosecutor of the incident it was decided charges would be presented due to neglect and danger the two children were in. The fact they were found in the center of a busy lined road where they could easily have been run over by a vehicle and unaccounted for for at least 40 minutes with no call to 911, no searching parent is what appears to be neglectful in the welfare of the two boys. The children's age is another factor in this complaint at 4 ½ years old.

Timothy Wayne Myers, of Parsons, was charged with one felony count of intent to manufacture, deliver, or possess a controlled substance. On Sunday, April 7, Deputy C.R. Summerfield of the Tucker County Sheriff's office was dispatched by Tucker County 911. 911 advised that an individual showed up at the caller's residence to buy a light bar and a crossbow. Before leaving the individual left a bag of meth in the shed. Summerfield and Senior Trooper C.A. Hawkins of the WVSP arrived on scene and were met by the caller and her husband. They directed officers to the shed and they discovered a clear plastic bag on top of a red toolbox. The bag contained a crystal substance that is consistent with methamphetamine. Summerfield obtained photographic evidence of the scene and seized the substance. Officers tested the substance with a Mobile Detect field test kit and results revealed that the substance tested positive for methamphetamine.

While talking to the husband, he stated that after calling 911 Mr. Myers called him saying that he heard what was going on from the scanner and the caller stated that Myers allegedly told him to flush the substance and get rid of it. The caller showed the officers where Myers had called his phone. Summerfield obtained a digital voice recorded audio statement from the caller and in summary he stated that Myers called him wanting to buy his crossbow and light bar for a truck. Myers took the items and the caller walked back onto his porch. Myers then allegedly came onto the porch to see if the caller had a tire tool and he was told it was in the shed. Myers retrieved the tool and got into his truck and left. The caller stated he began looking around because he didn't receive the cash for the items he was selling. When he returned to the shed he found a bag of meth on his toolbox.

On the same date Summerfield obtained

a digital voice recorded audio statement from the wife. In summary she stated she was in the house and she received a notification on her home security camera that someone was there. When she looked at the camera she observed her husband talking to someone. She stated she observed Myers take the light bar from the shed. After the individual left she walked outside to ask her husband what was going on. She stated her husband told her he had sold his crossbow and light bar for \$150. When she questioned her husband about the money for the items, he stated he didn't know the individual had left. They walked to the shed to look for the money because that was the last place the man was. While looking in the shed for the money she stated she discovered the bag of meth on the toolbox. She stated she has home security camera that face toward the shed.

Summerfieldrequested to view the cameras and observed a male subject, Timothy Myers, talking to the husband outside the residence. Myers put a crossbow into a vehicle, and was observed walking toward the shed where the substance was located. out of the camera's view.

These crimes occurred in Tucker County and all individuals are presumed to be innocent until proven otherwise in a court of law.

Dear Editor and Eligible Town of Davis Residents,

I'm addressing the Special Election for a Zoning Ordinance ONLY for the Town of Davis on June 8, 2024.

"Zoning" angers many. The Planning Commission of the Town of Davis has been working on this document for 16 months. It could not be addressed until a Comprehensive Plan was adopted for the Town which occurred in early 2023. We have written, rewritten, and adapted sections of the proposed Ordinance with open meetings for Town residents to discuss issues; few residents attended.

A petition, signed by 71 persons in Davis, asked residents if the Town Council SHOULD have the power to adopt the Zoning Ordinance or be DECIDED by the resi-

As a Planning Commission member since 2017, I want residents to understand why it would be Favorable to

Davis is not the same Town it was 50 years ago, 20 years ago, not even 10 years ago. Opportunities for employment have decreased in many areas, young people have moved away, and residents are mostly low-to-middle income families. Tourism is important and we welcome visitors, but we need to preserve what we can of Our Community.

Many homes are older, lived in by family members, or owned by family members living elsewhere. Several buildings have been purchased and turned into Short Term Rentals.

The Planning Commission found it necessary to divide the Town into Districts as a result of the changes rapidly occurring in our Community.

These Districts are:

- Single Family Residential
- Town Residential
- Recreational Central Business
- Commercial
- Industrial

Detailed Zoning Maps are at the Town Hall/Meeting Room showing districts. The Ordinance includes District maps and many informational definitions for the public.

My goal: to help residents understand WHAT and WHY we encourage acceptance of this Ordinance.

The document will address the future with minimal amendments. Most important issues are threefold:

24 Short Term Rentals are in the Town of Davis; many are within the residential area. The Commission determined that total to remain at 24;

NO additional Short-Term Rentals in the Residential District. Short-Term Rentals are also in Central Business and Commercial Districts.

In a Summary of Davis Survey (06/2022), 69% of 147 Respondents Encouraged A Zoning Ordinance to Protect Residential Areas.

- Zoning Ordinance would control Signage throughout the Community.
- Zoning Ordinance would minimize Businesses within the Residential areas. Summary of Survey (06/2022), 54% of 14 7 Respondents Encouraged Limiting Businesses From Operating in Residential

Eligible Residents within the Town of Davis have a voice to have control within our Town.

If you vote NO for Ordinance:

- Short-Term Rentals will be on every Street/ Avenue with inadequate parking. The Town will have no control.
- Businesses can be established on every Street/ Avenue.
- Signage/Billboards could be erected on every

Street/Avenue. Remember:

Understand Your AEP Electric Bill

I would like to explain to you today how to understand your electric bill from Appalachian Power and Wheeling Power.

When you open your bill, your eyes are going to be drawn to that colorful bullseye on the left column, about half-way down the page. Like the statistics box that stays on the TV when you watch a ball game, this circle gives you the full and simple breakdown on your bill. So, I'd like you to focus on that blue bullseye.

Take a look at the center of the circle. It is divided into a black top and a white bottom. In the white lower-half is the amount of money you currently owe for last month's service. Just above that is a black halfcircle. The portion of the circle includes "kWh" and a number. That tells you the amount of electricity you used, shown in kilowatt hours, for the billing period.

Let's now move to the circle's outer rim. It is divided into three colors: dark blue, light blue, and purple or maroon. The dark blue part reflects the cost of purchasing and supplying your electricity and should be the largest part of the bill. This shows the charges for the cost of the production and transmission of electricity you used.

Next, the light blue area should be the second-largest part of the circle. This reflects the cost for delivering electricity to your home or business. Finally, the purple or maroon section of the circle shows you what taxes and fees you must pay on your electric service. These are pass-through charges from local government. And the company says this money is often used to benefit schools and city and county services, such as emergency 911.

The remainder of the bill is fairly straightforward. The amount due and the date its due should be prominent at the top of the right-side of the page in a light blue field. What you owe is the bold black number. This box also tells you when the bill was mailed and your 11-digit account number. The next line in white on the left is the address being billed for service.

I know these bills can sometimes be confusing and appear to be very complex. I hope I have helped simplify this process a little for you.



Our miners have been pillars of strength for this country. They've given us so much, and they ask for so little. I cannot thank them enough for their work, and we will never give up on them, especially not now.

I refuse to accept that thousands of hard-working West Virginians in our plants and mines are expendable. I promise you, not under my watch.

History shows that when America needs dependable energy, it turns to West Virginia. As we face unprecedented demand, the idea of decommissioning coal and natural gas facilities will unquestionably destabilize our energy grid.

For every plant that closes in the United States, nations like China and India are rapidly expanding their coal-power capacity and building two in its place. This destructive strategy undermines our national security and energy independence.

We also need to consider the broader implications of weakening our energy infrastructure. Any disruption not only compromises our grid but also our national defense. Why would we blow our legs off at a time like this?

NASA-sponsored Solar Eclipse Day at the National Youth Science Academy

The National Youth Science Academy (NYSAcademy) in Tucker County on Route 48 just outside of Davis hosted a solar eclipse event on Monday, April 8th. About 450 people attended the event throughout the day. Students from Tucker Valley Elementary Middle School, Davis Thomas Elementary Middle School, the Mountain Laurel Learning Cooperative, homeschoolers, and other visitors participated.

Students enjoyed numerous activities - including an inflatable dome planetarium show, homemade pinhole cameras to view the eclipse, and a talk by Dr. Ryan Haupt, Executive Director of NYSAcademy, on women in STEM featuring WV's own Katherine Johnson in particular. Students also made science-related projects in the MakerSpace - including eclipse masks on the laser engraver and bracelets that helped demonstrate the Purkinje effect, where red colors appear darker relative to other colors as the light levels decrease during an eclipse event.

Jerod Caligiuri, Assistant Professor of

Mathematics and Physics at Davis and Elkins College, led instruction and handson demos on the science of eclipses, including viewing the eclipse through a telescope with a sun filter for safety. Astronaut snacks such as cured meats from The Charm Farm in Beverly, local jerky, and dried fruits were provided for all to enjoy.

"We couldn't think of a better way to spend such an important astronomical moment!" said April Miller of the Tucker County Family Support Center, who helped organize the event and make it such a success.

Ryan Haupt commented that: "Solar eclipses provide a rare opportunity to really feel our place in the universe. They're a great chance to put our phones away and experience a cosmic event as a brief moment of shared awe and we are so grateful to have been able to enjoy this time with the local community."

DRYFORK, W.Va.—The West Virginia Highlands Conservancy is seeking volunteers to support Dolly Sods Wilderness Area by welcoming and educating visitors to the wilderness, as part of its Dolly Sods Wilderness Stewards program.

The Trailhead Stewards is the signature program of the Dolly Sods Wilderness Stewards, and it has helped thousands of visitors have a successful, low-impact experience of Dolly Sods. Trailhead Stewards greet and assist visitors who are embarking on a hike in Dolly Sods, offering resources, Leave No Trace practices, values of the wilderness and helpful tips. Trailhead Stewards are stationed at the busiest trailheads on weekends, holidays and other times of high visitation.

and other times of high visitation.

On Saturday, May 18, interested volunteers are invited to Seneca Rocks Discovery Center in Seneca Rocks, West Virginia, for a Trailhead Stewards training. The Wilderness Stewards' Annual Picnic will follow the training. New volunteers are invited to join the training and participate in the picnic.

"Trailhead Stewards use the 'authority of the resource' technique to reinforce Leave No Trace principles," said Dave Johnston, coordinator of the Dolly Sods Wilderness Stewards. "This approach leverages the inherent goodwill of most people toward natural areas and gives them reasons and methods for practicing low-impact hiking and camping to protect this special area of the Monongahela National Forest."

In view of the rapidly increasing visitation to Dolly Sods Wilderness Area, the West Virginia Highlands Conservancy teamed with the Monongahela National Forest in 2021 to establish the Dolly Sods Wilderness Stewards



program, which is the first of its kind in the state. The partnership allows for volunteer action to supplement the Forest Service's wilderness management activities, engage in visitor education, and support the long-term health of the wilderness.

"By educating visitors about the values of

"By educating visitors about the values of wilderness and low-impact practices, the Wilderness Stewards hope to preserve the wilderness for the enjoyment of future generations and avoid the need for restrictions on visitor access that have been implemented in other popular natural areas across the country," Johnston said.

Trainers from the Forest Service and West Virginia Highlands Conservancy will teach how to apply this technique, as well as the history of Dolly Sods, the issues it faces, and the key messages visitors need to know to enjoy the wilderness safely and sustainably.

No special skills or background are required for volunteers, though familiarity with Dolly Sods and hiking experience will be helpful. There is no minimum time commitment, and those who live far away or can only occasionally volunteer their time are welcome. The West Virginia Highlands Conservancy provides a convenient method for Wilderness Stewards to schedule themselves online for trailheads and shifts that work for their schedules.

Volunteers are also invited to join in the other Dolly Sods Wilderness Stewards activities, including the Crosscut Sawyer and Trail Maintenance teams, solitude monitoring, and campsite restoration.

 - 8ozs ricotta salata cheese optional RED WINE VINAIGRETTE:
 - ½ cup red wine vinegar
 - 1tsp Dijon mustard
 - 1 tbsp sugar
 - 1 tbsp lemon juice
 - 1 tsp salt
 - freshly ground black pepper
 - 1/4 cup chopped parsley
 - ³/₄ cup olive oil

Instructions

1. Pre-heat the outdoor grill for at least 10 minutes or pre-heat the stovetop grill pan over medium-high to high heat. Cut the

bread into 1-inch thick slices. Generously brush both sides of the bread with olive oil. Grill the bread, getting good grill marks on both sides and set the grilled bread aside.

2. Make the dressing. Whisk the Dijon mustard, red wine vinegar, sugar, lemon juice, salt and pepper together in a small bowl. Slowly pour the olive oil into the vinegar mixture and whisk until the dressing comes together and thickens. Stir in the fresh parsley.

3. Combine the tomatoes, cherry tomatoes, peppers, onions, and cucumbers in a large bowl.

4. While the bread is still warm but not too hot for your fingers, tear it into large pieces and add them to the vegetables. Drizzle the dressing over the top, add the capers and toss everything together to coat the bread. Stir in the basil and crumbled ricotta salata (if using). Season with salt and freshly ground black pepper to taste.

5. Let the Panzanella salad set for 10 minutes to allow the bread cubes to absorb the dressing and then serve.

Charleston WV - The following events happened on these dates in West Virginia history. To read more, go to e-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

May 1, 1788: Pendleton County was created from Rockingham, Augusta and Hardy counties. The county was named for Virginia statesman Edmund Pendleton (1721-1803).

May 1, 1930: Labor leader and child welfare activist Mother Jones celebrated her birthday in Maryland. Jones, who was 100 years old by her count, appeared before newsreel cameras to condemn the Prohibition Act "as a curse upon the nation" that violated her right to have a beer instead

May 2, 1900: State founder Waitman Willey died in Morgantown. He is remembered for the Willey Amendment, which provided for the gradual emancipation of slaves as a precondition for the creation of West Virginia.

May 2, 1925: Flying saucer investigator Gray Barker was born in Riffle, Braxton County. Barker became interested in unidentified flying objects in the 1950s after investigating sightings of the Flatwoods Monster.

May 3, 1843: U.S. Postmaster General William Lyne Wilson was born in Smithfield, Jefferson County. Wilson joined President Cleveland's cabinet as postmaster general in 1895. The following year, he introduced Rural Free Delivery in Jefferson County, an experiment which was quickly instituted nationwide.

May 3, 1917: Fire destroyed the West Virginia Preparatory School in Keyser. The school was rebuilt, and it evolved into the institution now known as WVU Potomac State College.

May 3, 1948: The plane of test pilot Howard "Tick" Lilly, a Raleigh County native, crashed on takeoff in California. Lilly was the first of many government test pilots to die in the line of duty. Six weeks earlier, he had become only the fourth person to break the sound barrier.

May 4, 1896: The Children's Home Society of West Virginia was formed by a group of Charleston ministers. Their goal was to place orphaned and neglected children with caring families rather than crowd them into county poorhouses.

May 5, 1923: A fire started by welders working on a new

swimming pool destroyed most of Luna Park, an amusement park in Charleston. Although Luna's owners announced they would rebuild, the park never reopened.

May 5, 1923: Golfer Bill Campbell was born in Huntington. He won more than 30 championships over a sevendecade career and is considered one of the best amateur players in history. May 6, 1968: A continuous

miner machine at the Gauley Coal & Coke Saxsewell No. 8 mine at Hominy Falls, Nicholas County, cut into an adjacent mine, which was filled with water. The resulting flood drowned four miners and trapped 21 others.

May 6, 1968: Newspaper publisher and Bluefield native John S. Knight received the Pulitzer Prize for his long record of service and his series of columns opposing the Vietnam War.

May 7, 1824: Logan County was created by the Virginia General Assembly from parts of Giles, Tazewell, Cabell and Kanawha counties. The county seat was first known as Lawnsville, then Aracoma, and finally Logan.

May 7, 1857: William A. MacCorkle was born in Rockbridge County, Virginia, on his father's plantation. He served as West Virginia's



May 6, 1812: Activist and physician Martin Robison Delany was born in Charles Town. In February 1865, he was commissioned as a major in the U.S. Colored Troops. He was the only Black Civil War officer to be given a field command.

ninth governor.

May 7, 1928: The Keith-Albee Theatre opened in Huntington. The opening program featured a comedy called "Good Morning, Judge," a newsreel and five stage acts. But the theater itself, with its elaborate interior, clearly was the star of the evening.

May 7, 1983: The New River Gorge National Park and Preserve began operations when the first visitor center opened near Fayetteville.



Notice is hereby given to any person interested that on April 10, 2024 the Town Council of the Town of Davis, West Virginia (the "Town") adopted an ordinance which, among other things:

1. Authorized the acquisition and construction of certain extensions, additions, betterments and improvements to the sewerage portion of the existing combined public waterworks and sewerage system of the Town of Davis and the financing of the cost thereof, not otherwise provided, through the issuance by the Town of Davis to upgrade the existing lagoon with the installation of surface aerators and construction of a baffle wall, of not more than \$300,000 in original aggregate principal amount of Combined Waterworks And Sewerage System Revenue Bonds, Series 2024 A (West Virginia Infrastructure Fund); (the "Bonds").

Directed that the Bonds be issued in such principal amounts, bear interest at such rate or rates, not exceeding the then legal maximum rate, mature on such dates and in such amounts and redeemable, in whole or in part, as prescribed in a supplemental resolution.

Directed the continuation of a revenue fund and the disposition of the System revenues; provided for the payment of operating expenses of the System and debt service on the Bonds; directed the creation of a sinking fund and a reserve account for the Bonds and creation of the renewal and replacement fund; and directed the creation of a bond trust fund and the disbursement of Bond proceeds.

4. Provided that the Bonds shall not be or constitute a corporate indebtedness of the Town within the meaning of any statutory or constitutional limitations, but shall be payable solely from the Gross Revenues of the System; pledged the Gross Revenues of the System to payment of the Bonds and established the rights of the registered owners of the Bonds to such Gross Revenues; provided certain conditions

Provided for insurance coverage on the Project and the System, enforcement of collection of fees, rates or other charges for the System and other covenants in favor of the registered owners; established the events of default and the remedies of the registered owners; and provided for the modification or amendment of the Ordinance upon the terms and conditions set forth in the Ordinance.

The Town contemplates the issuance of the Bonds described in, and under the conditions set forth in the Ordinance abstracted above. Any person interested may appear before the Council of the Town of Davis at a regular meeting on Wednesday, May 8, 2024 at 6:30 p.m., in the Council Chambers, Davis Town Hall, 505 Williamson Ave. Davis, West Virginia, and present protests and be heard as to whether the above-described Ordinance shall be put into effect.
