Parsons PD Gets New Body Armor

The City of Parsons Police Department will be getting new Kevlar body armor vests following a vote by the City of Parsons Council August 6th. The unanimous vote authorized the purchase of three soft armor point blank vest for the department to replace old and outdated equipment currently in use by the department. City of Parsons Police Chief Kevin Keplinger spoke to the Council on the matter at the meeting.

According to Keplinger, the National Institute of Justice recommendation is that body armor be replaced every five years, but the City of Parsons has equipment that was purchased in 2018 and 2010, according to Keplinger. "The National Institute of Justice recommends that body armor be updated every five years or replaced every five years," Keplinger said.

According to Keplinger, the body armor for the City was purchased in 2018. "Now, I'm not naive enough to think that Kevlar is going to magically drop its protection level, we've got a couple of issues we're facing, number one is that the armor that we currently wear was purchased is 2018 so it is outside of the five year replaceMatter of fact, I was thinking they may have been purchased in 2010," Keplinger said.

Keplinger said that he had issue with the style of armor that the current vests utilized. The current armor used hard plates that provide limited protection. "Another issue I have is whoever bought the armor in 2018, bought hard plates. I don't necessarily have an issue with hard plates. They provide protection for the immediate front, and that's it and the immediate back. There's no protection to the sides . They're hard plates," Keplinger said.

Keplinger said he wants to upgrade to soft plate armor that provides a more complete protection for him and his staff. "3A Soft Armor provides protection higher, it provides protection to the sides, an updated carrier and this is the armor and carrier that I would like to go to," Keplinger said.

The quote of \$3,346.42 from Witmer Public Safety Group, Inc. includes the vests, plates and a concealment vest, according to Keplinger. "Along with this it will provide an outer vest, to be worn like we normally wear, it will also provide a vest that you can take the soft panels out of, place them on, place a shirt on top of, if you need to wear concealed," Keplinger said.

Keplinger said the purchased was anticipated and was budgeted for. According to Keplinger the request was needed due to the amount of the expense exceeded \$500. The purchased was approved by the council by unanimous vote. "This is a purchase that I had anticipated," Keplinger said. "I just need permission to go forward."

Eastern Tucker County Designated Extreme Drought

With half of Tucker County in Extreme Drought, according to the U.S. Drought Monitor and Governor Jim Justice declaring a State of Emergency on July 26, the County has found itself severely impacted by the prolonged lack of rain.

According to the U.S. Drought Monitor, the eastern half of the County is most severely impacted by the lack of rain with that half being designated as in Extreme Drought. The western half of the County is designated as in Severe Drought.

The City of Thomas have been dealing with water issues that have been exacerbated by the low water level of the Blackwater River. Reports from various news outlets have reported that residents have been unable to use the water from their taps and have relied on bottled water. The Parsons Advocate will be on hand at the next City Council meeting in Thomas to follow the story.

Other municipalities in the area has not had to greatly restrict water usage due to the drought yet. Town of Davis Water Clerk Tina Wood said that Davis had not had to restrict water usage due to the drought due to the Town's two water sources. The town draws water from the primary source of the Wymer Spring and the Blackwater River. "We haven't had to ask anyone to conserve water or anything yet," Wood said.

Wood said the Town is doing well as far as water supply from both water sources and the Town continues to pull from both well. "So far we are doing well. We haven't had any issues, so we're pulling from both sources," Wood said.

It has also been reported by the media that State officials have trucked 5,000 gallons of non potable water to Thomas from Huntington.


Auvil Confronts Council Over Removal from PPRC

Former City of Parsons Recorder Tim Auvil addressed the City of Parsons Council during the public comment portion of the August 6th meeting regarding his removal from the Parsons Parks and Recreation Commission (PPRC). Auvil read from a prepared statement.

In the opening to his statement, Auvil addressed his 17 years of service to the City of Parsons and how much he enjoyed his time on the PPRC. "During my 17 year tenure on City Council, diligently and tirelessly served this City of which also included nearly 15 years proudly serving on the Parsons Parks and Recreation Commission, commonly known as the PPRC, or which I thoroughly enjoyed during during that time. I personally coordinated with engineers, contractors, regional and state officials affiliated with any and all projects of improvements to the parks systems and all other projects within this city. I have attended a multitude of meetings, received and responded to "thousands" of emails and phone calls pertaining to all city projects. I gave my time freely, believing I was serving a purpose for my hometown, in hopes of creating more job opportunities and additional recreational possibilities," Auvil said.

In his statement, Auvil said he had not violated any ethics or judiciary offenses that would have warranted removal and believed that the reason given that he was no longer on the City Council



was not warranted. "This Council, by a majority vote, with the exception of Councilman Greenlief, voted to remove me as a member of the PPRC during the July 16th, 2024 meeting. This action was without cause, as my term does not expire until December 31, 2025. I have not violated any ethics code nor have I incurred any judiciary offenses. Therefore, no reason exists to dismiss me from the PPRC other than personal reasons among this council," Auvil said.

Auvil said that the fact that he was no longer a City Council Member did not matter when it came to his position on the PPRC. "It was stated, since I was no longer on City Council, I could no longer serve as a member of the PPRC and,or be a liaison. This is and always has been a "pronoun" affiliated to "any" Council member on the PPRC. It HAS NOT, nor has it ever been an appointed position," Auvil said

Auvil went on to say that as a Commission, commission protocols must be maintained unless legally changed. "The PPRC is a Commission, NOT a council committee, established by City Ordinance. All protocols to ordinances MUST be maintained by council unless otherwise changed via three readings of

Ambulance Authority Receives Grant

Senator Joe Manchin recently announced that the Tucker County Ambulance Authority is one of two North Central West Virginia emergency service organizations to receive grants from the U.S. Department of Home-

land Security's Federal Emergency Management Agency (FEMA). The Tucker County

Ambulance Authority Grant has been announced to be in the amount of \$68,301.

Tucker County Ambulance Authority Director Amanda Simmons said her office is very excited about the opportunity the grant affords. "(We are) Very excited about the opportunity." Simmons said.

According to Simmons, the grants will fund education efforts through the Ambulance Authority. "We have been granted \$30,000 for a state of the art mannequin and another 38,000 to give us assistance in funding for college for Paramedics through the local colleges

and EMT Classes in Tucker County to be held," Simmons said. "In total we have \$3,717.00 that we will have to provide for our 5% portion. The Grant is through AFG American Firefighter Grants."

Simmons said the Ambulance Authority had also applied for grants for two additional ambulances, but had not had

> received word on the status of the applications yet. "We have also sent in an application for 2 ambulances as well and

the awards have not been released yet so we do not have word if they have been accepted," Simmons said.

Simmons said the Authority are very thankful for the grant opportunities that are presented. "We are very thankful for the opportunity," Simmons said.

The FEMA grant was part of \$1.2 million dispersed between seven fire departments and EMS organizations throughout West Virginia, according to WDTV. The other NCWV agency to receive funding according to Manchin's office was Bunners Ridge Volunteer Fire Department in Fairmont.



a legally prepared document. The third of which, must be a public hearing," Auvil said.

Auvil also addressed the wording on the agenda item in which his removal was listed. "My unjust removal from the PPRC was done on an agenda item simply stating 'Removal of Park and Recreation board member – Councilman Tim Turner'. The wording on this agenda item, that evidently targeted me, was a public violation of my rights, this prohibiting me the opportunity to address council in my defense for this unjust act. My name was not shown on the agenda item to remove me personally from a COMMISSION, and was not posted in the timely manner until late Friday afternoon July 12th, which was less than the required : As I quire, 'Three business days before regular meetings,' unquote, as per State regulations," Auvil said.

Auvil called the action a "slap in the face" and said he refused to remain silent. "This action was not only a slap in my face, but frankly a stab in my back! Not only is this an unethical action taken against me by this council, it is a defamation of my character and an insult to my name and reputation. It is a violation of city ordinance and I refuse to remain silent and allow the record to show that I was removed from 'any' office and/or position I ever held, without the ability to speak on my own behalf," Auvil said.

Auvil said he put his personal life second to the city and attempted to guide the city in a financially responsible manner. "This is the thanks I get for putting my personal, professional and fiscal life, behind my dedication to this city throughout my tenure I have consistently provided the majority of the logistics, financial research, homework and protocols needed to inform councils how to move each and every one of this city's project and improvements forward in a fiscally responsible manner," Auvil said.

Auvil said the Council cannot make up the rules. "You cannot make up rules, move and/or pass motions without properly adhering to city ordinances simply because you want to. There are established State regulations and guidelines all councils must adhere to," Auvil said.

In his closing, Auvil said the Council has brought adversity to a body that did not exist before and said he was concerned for the future of Parsons and the possible instability the Council could cause. "In closing, you have brought adversity to council that did not exist before. You're leading our city toward instability that will diminish the progress of Parsons. The sad part is, non of it was necessary and this deeply concerns me about my home's future," Auvil said."

Council Member James "Sam" Humphrey told Auvil that he was not at the meeting. "Just so you know, I was not at that meeting," Humphrey said.

As he left, Auvil said he was hurt by the act. "That hurt, that hurt a lot," Auvil said.

As previously reported in the Parsons Advocate July 23rd, the Parsons City Council voted four to one to remove Auvil from the PPRC. Council Member David Greenlief was the dissenting vote and Council Member James "Sam" Humphrey was absent. In a separate vote, it was voted to replace him with Council Member Seth Rosenau as Council liaison to the Commission.

The national average for a gallon of gas dipped three cents since last week to \$3.47. The drop comes as Hurricane Debby has made landfall today in Florida but so far, has had no significant impact on oil production. Today's national average is four cents less than a month ago and 36 cents less than a year ago.

According to new data from the Energy Information Administration (EIA), gas demand slid from 9.45 million barrels per day to 9.25 last week. Meanwhile, total domestic gasoline stocks fell from 227.4 to 223.8 million barrels. Gasoline production decreased last week, averaging 10.0 million barrels per day.

At the close of Wednesday's formal trading session, West Texas Intermediate rose by \$3.18 cents to settle at \$77.91 a barrel. The EIA reports that crude oil inventories decreased by 3.4 million barrels from the previous week. At 433.0 million barrels, U.S. crude oil inventories are about 4% below the five-year average for this time of year.

GC adventure camps livened up summer

Mountain biking, climbing, and paddle sports all offered

McHenry, MD - July was a month full of adventure at Garrett College especially if you were a kid ages 8-16 looking for something fun to do.

Garrett College offer three rounds each of mountain biking, paddle sports, and climbing camps. Each sport offered camp sessions for kids 8-10, 11-13, and 14-16. There were 20 mountain bikers, 19 in the climbing sessions, and 18 paddle sport participants.

"This was the first year we were able to implement our full progression by age group for the climbing camps," said Professor Andy Hershey, who serves as program director for GC's Outdoor Leadership & Adventure (OLA) program.

"The 8-10-year-old group did a four-day daycamp," added Hershey. "The 11-13-year-old group had two days of day camp and finished camp with a two-day overnight camping trip. The 14-16-yearold group completed a five-day 'climbing and caving road trip' with four nights of camping in West Virginia."

Hershey said the road trip for the 14-16-yearolds included climbing at Coopers Rock and Seneca Rocks, caving in Stillhouse Cave and the sinks of Gandy, and climbing the Via Ferrata at Nelson Rocks.

Scott Richardson, GC's Adventure Equipment Center manager, said the annual mountain biking camps included a new twist: riding the recently developed Deep Creek Lake Lions Club dirt pump track in Accident. Richard-

son noted the pump track was included at the end of the first day of camp.

"The participants loved applying their new skills riding the pump track and having a blast with the pump track elements," he said.

Richardson said another camp highlight was riding the single-track trails at Oakland's Broadford Park. "The trails are fast, flowy, and provide really cool wooden features, like wooden bridges and rail tracks, that challenge camp participants," explained Richardson.

Richardson said the mountain bike camps participants helped improve their riding skills on single-track trails in addition to exposing participants to the "amazing mountain bike trails that are available in Garrett County."

"The most important part of our camps are for participants to make new friends and have fun mountain biking," added Richardson. "We also hope they get a taste of the 'mountain bike bug.'"

Hershey said all of the camp offerings addressed a growing, 21st-century problem.

"As a society, we're slowly but steadily losing our connection to the natural world," said Hershey, noting outdoor industry statistics indicate outdoor recreation participation "has steadily declined among children."

Hershey noted the camps directly relate to OLA's mission to "expand opportunities to experience the benefits of participation in outdoor adventure recreation."

CHARLESTON, WV - The West Virginia Governor's Highway Safety Program (GHSP) reminds drivers that law enforcement officers will be targeting motorists who fail to stop at red traffic lights and stop signs during a high visibility enforcement mobilization that runs August 1 through August 15, 2024.

"Nationally, drivers running a red light is a serious and extremely dangerous problem; locally it is no different," said Jack McNeely, director of the GHSP. "Yellow signal lights caution motorists that the red signal is about to appear and does not mean to 'go fast'," McNeely said.

Drivers need to always be aware of traffic signals and be prepared to stop should the light begin changing. Officers will be focused on drivers that fail to stop at red traffic lights or stop signs. The traditional "rolling" stop will result in a citation.

From 2016 to 2020, intersection-related crashes accounted for 18 percent of all crashes in West Virginia, accounting for 14% of all fatalities and 19% of all serious injuries, according to the West Virginia Department of Transportation. Speeding and aggressive driving were the number one causal factor in intersection-related crashes during this time frame.

The Target Red campaign was first presented in the Beckley area in 2008. Prior to the campaign, red light violations and resulting crashes, injuries, and fatalities rose to alarming levels.

When targeted enforcement and education began, incidents were reduced by 60%

Fraud Alert to area residents

The West Virginia State Police Parsons Detachment has been notified of an ongoing scam which has recently targeted residents of Tucker County. The scam is related to gaining a check through U.S. Mail. The check will display the name of a legitimate company but is not valid. If you should receive a check in the mail and do not know the origin or hadn't been expecting any funds from a business, you are urged to contact the company on the check direct to see if the check is legitimate.

It is imperative to be vigilant when receiving checks through the mail. If you are being given money for an unknown reason, it can very well be a scam. Recently, a check was mailed to an area resident which included a Walmart letterhead. This is a request to deposit the check at Walmart and do an evaluation in return for money. The instructions advise you to buy Apple Cards with the supplied money (deposited in your account) and send photographs of the card details along with the receipt. The cards will be drained of money and the check you deposit will not clear due to it being fraudulent. You will end up losing the amount of money you paid for the cards from your own account. Attached will be the instructions you may receive. The letterhead may vary from one person to another. If you should gain something suspicious you should contact law enforcement in your area and alert the Attorney Generals Office in Charleston, WV.





- ¹/₄ cup brown sugar
- ¹/₂ teaspoon salt
- ¹/₄ teaspoon nutmeg
- ¹/₄ teaspoon dried thyme

1. Peel and wash the carrots. You can leave the ends on or trim them off.

Check to be sure the carrots fit into your air fryer before wrapping with bacon.

2. Dry the carrots with a paper towel. 3. Wrap one piece of bacon tightly around one carrot. Lay the carrots end-side down on the air fryer grate, to keep the bacon from curling up while cooking.

4. In a small bowl whisk together the brown sugar, salt, nutmeg, and dried thyme. For less of a texture top, you can add 1/8 cup of olive oil and make this a brushable topping.

5. Air Fry at 385F for 11 minutes. After 6 minutes, open and sprinkle the carrots with your brown sugar mixture - or brush if using the brushable version.

6. Bring back to the air fryer and continue to cook until finished. Top with fresh thyme if desired.

Aug. 14, 1894: Entertainer Ada Beatrice Queen Victoria Louise Virginia "Bricktop" Smith was born at Alderson. She performed in Paris in the 1920s and opened her own clubs, the Music Box and Bricktop's, a favorite hangout of songwriter Cole Porter.

Aug. 14, 1943: Astronaut Jon Andrew McBride was born in Charleston. McBride became an astronaut in 1979 and piloted the space shuttle Challenger on an eight-day mission in 1984.

Aug. 15, 1867: The cornerstone was laid for the Fairmont Branch Normal School (now Fairmont State University).

Aug. 15, 1906: The Niagara Movement began a fiveday meeting at Storer College in Harpers Ferry. The organization was founded in 1905 by a group of Black intellectuals, including W. E. B. Du Bois. Aug. 15, 1946: The first FM radio station in the state, WCFC of Beckley, began regular programming. Aug. 16, 1851: William Hope "Coin" Harvey was born in Buffalo, Putnam County. Harvey, a social reformer, was nominated for president of the United States by the Liberty Party in 1932. Aug. 16, 1913: Helen Holt was born in Illinois. In 1957, Governor Cecil Underwood appointed her to fill the secretary of state's unexpired term, making her the first woman to hold statewide office in West Virginia.

Aug. 20, 2004: Eldora Bolyard Nuzum died in Elkins. While working for the Grafton Sentinel in 1946, she became the first female editor of a daily newspaper in West Virginia. For three decades, she was editor of the Elkins Inter-Mountain.



Aug. 20, 1851: The oldest statue in West Virginia, a nine-foot wood carving of Patrick Henry, was dedicated at the county courthouse in Morgantown.
