

## Landfill Fire Sparks Battery Discussion

A small landfill fire sparked a discussion among the board regarding the safety of lithium ion batteries and the disposal of the batteries by the general public. The fire, according to Tucker County Solid Waste Authority Presiding Chair Mark Holstine was small and occurred over a month prior to the August 19th meeting. "We did have a fire," Holstine said. "Just to kind of let you know how lithium ion batteries are a problem, especially for us in the waste industry," Holstine said. Holstine acknowledged that the batteries were not definitely determined to be the cause of the fire and that any correlation was pure speculation without further investigation. "We don't know that, that is what happened," Holstine said. "But we can almost bet that it was that started the fire in the field. Its just a problem." Holstine said he knew that customers place lithium ion batteries into the trash. Once in the landfill, Holstine said, the batteries are subject to the same process as the rest of the refuse such as the tracks of the compacter. "People throw them away," Holstine said. "You crack them, you run over them, we all run a compacter over them, so most likely they will get cracked, they will get exposed to water all that." Tucker County Solid Waste Authority Vice Chair Dennis Filler said that the batteries did not combust due to exposure to water, as many people think. "So contrary to popular belief," Filler said, "a lithium battery does not catch fire by getting wet. Raw lithium metal does catch fire that way because that's how the chemistry works,'

Filler said. "But these are not only lithium ion."

Filler said he learned the science behind the batteries when he was Director of Research for the FAA. "Where I learned all this stuff is I used to be the Director of Research for the FAA. So I dealt with this


## Parsons Place Devices in Effort to Curb Speed

The City of Parsons Police Department has begun placing speed detection devices at key points around the City in an effort to combat speeding in residential areas, according to City of Parsons Police Chief Kevin Keplinger. Keplinger updated the City of Parsons Council during their regular meeting August 20th on the measure his department has undertaken to curb speeding in residential areas with the start of the school year. "Realizing that it is that time of year again, I am adjusting the schedule. I'm going to probably start coming out at six in the morning to start hitting the school zones, the bus areas, the kid pick up areas pretty heavily," Keplinger said.

Keplinger said the Department currently has two signs in use in the Quality Hill area.. "I have two of them right now," Keplinger said. "We have them up right now on Quality Street to kind of monitor that situation."

The units are mobile, according to Keplinger, which makes them able to be placed anywhere around the City and moved when deemed "What we necessary. are going to be doing right now is putting mobile," them out Keplinger said. Keplinger said the the units were not convential speed cameras and do not take pictures, issue or mail citations. According to Keplinger, the units only record speed and log what time and what speed was traveled, not what specific vehicle it was. "I just want to reinforce, they do not take a picture," Keplinger said. "They do not mail a ticket. What they do is

According to Filler, water is how the fires are extinguished. "Water is generally how you put it out because it cools. It also smothers the thing, Filler said. "That's the misnomer. Guys, that's the only way of putting it out. Its what we do whenever they catch fire on aircraft."

Filler said the fire is caused by damage to the plates and internal components. "What does cause it catch fire is the way the plates are or the substrates are rolled or packaged," Filler said. "When you puncture those things or short them, then it starts spontaneous combustion inside it. It will catch fire."

Filler also said the devices themselves can build up shorts over time that will generate heat and build to combustion. "Likewise the battery will build internal shorts inside of it." Filler said. "That generates the heat that it takes to generate the process."

Holstine said he was surprised that there weren't more issues at transfer stations from discarded lithium ion batteries. "I'm surprised they don't have more trouble over at the transfer station," Holstine said.

Holstine said the best way to dispose of the batteries is through an approved recycling program. "The best way is through some recycling program," Holstine said.

## SBA makes drought relief funds available in WV including Tucker County

The U.S. Small Business Administration (SBA) has declared Economic Injury Disaster Loans (EIDLs) available for businesses and organizations affected by the severe drought that began on July 16, 2024. This declaration, under SBA Disaster Declaration WV-20007, impacts several counties across West Virginia including Tucker County as well as neighboring states.

The City of Parsons has begun to place speed detection devices around town in an effort to curb speeding. The efforts come in conjunction with the beginning of the school year and the rise in speeding in residential neighborhoods, according to officials.

they record the speed and record the time in fifteen minute increments."

Keplinger said the units are designed to run 24 hours a day for seven days before needing recharged and placed back on site. During that time, Keplinger said, the units will record traffic patterns. "What it will do for that seven day period is to take a look and determine when traffic, the speed that traffic is flowing and sometimes you can get some anomalies," Keplinger said. "We've had it out on Webbers Lane before and recorded some rather extreme speeds and then go back to 911 and then realize that was an ambulance."

There was no word on when the initiative would conclude.

## **City of Thomas Lifts Boil Order**

The City of Thomas has lifted its long standing boil order. The order, which has been in effect since late June, was lifted effective August 23rd at 11:30 a.m., according to a notice provided to the Parsons Advocate by Thomas Mayor Jody Flanagan.

In the statement, Flanagan writes, "The City of Thomas is pleased to announce that the boil water advisory issued on 06/29/2024 has been lifted effective immediately 8/23/2024 at 11:30 a.m."

The announcement follows extensive testing by the City, according to the statement. "Following extensive water quality testing, the District Health Department in Fairmont, W.V. has confirmed the water supply now meets all safety and regulatory standards," the statement reads. According to the statement, the water in Thomas is now safe for the residents and businesses to resume normal use. "Residents and businesses in the affected areas can now resume normal use of tap water for drinking, cooking, and other purposes without the need for boiling," the statement reads.

The statement concludes by thanking the residents, businesses and public for their support and patience during the crisis and the City assurance that the safety of the City is of utmost importance. "We would like to thank all residents for their patience and cooperation during this time. The safety and health of our community remain our top priorities, and we appreciate your understanding as we worked to resolve this issue."

## **News of Record**

The following criminal complaints have been filed in the Tucker County Magistrate office:

- Joshua David Poling, was charged with a felony of Possession of Child Sexual Abuse Material < 50 images. The complaint states that on Feb. 21, 2023 Sr. Trooper C.D. Harper of the West Virginia State Police was assigned CyberTip#151796180 from the National Center for missing and Exploited Children (NCMEC). Said tip alleged that juvenile complaint with the initials of SJ reported that, "A man claimed to be 20 but admitted to being 32 is sending me sexually graphic images and messages and he claims that some of the pictures are of a 15 year old girl. He also tells me he has a 13 year old son whim he can show me nude photos of. Please help." He told NCMEC that this man's first name was "Josh" and he had an Instagram account.
- He also told NCMEC that, "This man is named Josh or Joshua and he lives in West Virginia, he has been consistently asking me for nude photos and I have proof and pictures of the messages he sent. He has been very cautious by not showing me what he looks like, telling me his last name or exact location, but I have reason to believe he resides near Parsons, WV.
- OnFeb.22,2023harperobtainedoneadministrative subpoena from the Magistrate Court of Braxton County for the Instagram username used in these correspondents. On this same date Harper served same to Meta Platforms, Inc.
- On March, 31, 2023 Harper obtained the results of said subpoena from Meta Platforms/Instagram. This account was created on Sept. 16, 2021 and linked to an email address.
- Harper was able to locate a WV Driver's license for a Mr. Joshua David Poling, suspect, but He was unable to locate poling at address on license.
- OnAug.24,2023Harperobtained an administrative subpoena for the Google Email address that was used to create the suspect Instagram account. On same date Harper served same to Google, Inc.
- On Sept. 9, 2023 Harper obtained the results of said subpoena. Google Inc. records indicated that the account belonged to Josh Poling of Elkins. Said account had multiple current credit/debit

cards linked to the account. On the same date Harper spoke with WV DHHR and obtained a current address for Poling.

- On Sept 19, 2023 Harper along with STPR EW Clark and Trp. Hawkins went to the address to speak with Poling. Harper spoke with Poling about the complaint and allegations. He asked Poling if he had a mobile application Instagam and Poling responded that he did not. Harper asked him if he has ever had an Instagram account and Poling stated, "Not in years." Poling showed his phone that the mobile application was not installed on the phone. Harper also obtained Poling's email address.
- Harper explained the Instagram account from NCMEC account to Poling and he stated that the last time he used his Instagram account it acted like it had been hacked.
- Trp. Clark asked Poling about his "trash" gallery and Poling said that there was just deleted "Porn." Clark asked Poling if he was into Child Porn and Poling stated "nope." Poling scrolled through his trash folder but neither officer was able to view the contents due to sunlight glare. At this time Poling appeared to become nervous.
- Due to the allegations mentioned above Harper did seize the cell phone as evidence with the intent to seek a search warrant for the phone.
- On Oct. 2, 2023 Harper obtained two search warrants from the Magistrate Court of Tucker County for the cell phone seized from Poling and for the Instagram username. He served said warrant to Meta/Instagram but Meta was unable to produce anything in relation to said account. Harper delivered the cell phone to the West Virginia State Police Forensic Lab located in Morgantown.
- On March 28, 2024 Harper obtained a WVSP forensic Lab Report for Poling's cell phone and said analysis discovered thirty four (34) images of child sexual abuse material on Poling's phone.
- The issuance of an arrest warrant is being requested from the Tucker County Magistrate Office.
- Audley John Riley, of Davis, was charged with one count of Aggravated DUI. On Saturday, Aug.

17 Trp. G.P. Hahn was dispatched by Tucker 911 for a vehicle in the caller's yard. The caller stated they believed the driver to be intoxicated, spinning his tires while being hung up in the yard.

- Upon arrival Hahn observed the vehicle in the caller's yard. He made contact with the driver, later identified as Audley John Riley. The officer observed the suspect to have slurred speech and could detect the overwhelming odor of an alcoholic beverage emitting from the vehicle and the accused's person. He also observed several open beer cans inside the vehicle. Once the accused exited the vehicle he had to lean on his car and was unable to maintain his balance. He then had to use the officer's marked state police cruiser to hold himself up. The accused allegedly stated he had 5 or 6 beers. Hahn asked the accused to submit to field sobriety tests to which he refused. Hahn placed the suspect under arrest and transported him to the Parsons Police Department to be read his West Virginia Implied Consent and the suspect was instructed to submit to an approved secondary chemical breath test to determine his blood alcohol content. Upon completion of said test it was determined that the accused's blood alcohol content was .343, with the legal limit being .08.
- The above crimes occurred in Tucker County and all individuals are presumed innocent until proven otherwise in a court of law.

## **Five Rivers Public Library to Celebrate** 50 years with Sept. 8 Open House

It started as a dream 50 years ago this month, back when you still signed a little paper card to check out a library book, the first portable computer was the size of a suitcase, and the internet was still just a baby. Today, that dream has become the Five Rivers Public Library in Parsons, a lively community hub in a modern facility with a wide range of books, magazines, audiobooks and e-readers, along with an impressive array of popular programs and services throughout the year.

It all began in April 1973, when the Parsons City Council appointed five library board members (H. Dale Ridgeway, Francis "Fritz" Wagner, Mrs. Mary Shiflet, Edward McDonald, and Stanley Hehle) and asked them to secure a site for a new library.

The following April, after much hard work and determination, a ground breaking took place for the new 1200-square-foot "carousel" library on the corner of Third and Walnut Street in Parson. The new library was named Five Rivers Public Library after Tucker County's five rivers: Cheat, Black Fork, Shavers Fork, Dry Fork, and Blackwater. The distinctive, eight-sided, 1,200-square-foot building, which suggests the fun of a carousel, was part of the West Virginia Library Commission's "instant" library program, which placed small, prefabricated library buildings in select rural communities with limited access to library services

after one in Logan County, was completed in July 1974 library. Come and meet the staff and see what the library and officially opened in September. Helen Gilmore was the first director, overseeing an initial inventory of 10,000 books. Jane Leard was director from 1991 until 1993, when the current director, Nancy Moore, assumed the role.

In 1984, a building fund was established, adding an additional 850-square feet to the back of the existing carousel and expanding the total footage of the library to 2,050 square feet.

Sadly, only five short months after opening in November, 1985, the devastating flood of Parsons inundated the library with more than six feet of water, leaving only three books and a few pieces of furniture salvageable. Volunteers, the Library Board, and staff pulled together to clean up. After an incredible amount of hard work during an extremely difficult period in the county's history, the

FROM THE MOUNTAINS TO THE VALLEYS

The Commission encouraged communities to find sites and secure annual funding, in return providing the building, furnishings, library materials, professional assistance, and state funding to help support operations. By 1996, there were 39 instant libraries across West Virginia.

The Parsons building, the state's second instant library

library was once again back open for use.

In October 2011, Five Rivers added an additional 1600 square feet, including an ADA-accessible meeting room.

Today, Five Rivers Public Library is grown to meet the vision of its organizers 50 years ago. It provides a range of services, including Pre-School Story Time Class/Toddler time (starting in the fall through the spring), teen programs, the Summer Reading Program for children (up to 5th grade), VITA (free tax assistance for the public), wireless internet access, internet access computers, online data bases, DVDs, audio books, exchange books, Kindle Paperwhites, inter-library loans, meeting/conference room available for public use, movie days, craft sessions, faxes, copies, laminating, Accu-cut, and more.

## Forest Service Seeks Feedback on Tea Creek Bridge Replacement Project

Marlinton, W.Va., August 20, 2024 - Monongahela National Forest is seeking feedback on the Tea Creek Bridge Replacement Project on the Marlinton Ranger District in Pocahontas County. This project is in the beginning stages of development and is located at the intersection of Forest Road 86 (Williams River Road) and Forest Road 135 where it crosses the Williams River, 11 miles northwest of Marlinton.

The project will replace the existing bridge with a new structure that will better meet access needs and ensure continued safe public access to Tea Creek Campground and nearby trails. Construction associated with this work will occur over 1-2 years, between July and October 2025 and 2026 (during the low-water season). During construction the campground might experience short term closures for work crew efficiency and public safety. Information on the closure(s) will be posted under Alerts and Warnings on the Monongahela National Forest's webpage linked here: https://www. fs.usda.gov/mnf/.





## **Gov. Justice, DoHS announce** increase in provider waiver rates and IDD waiver expansion

CHARLESTON, WV — Gov. Jim Justice and the West Virginia Department of Human Services (DoHS) announced today that providers have been notified that the Bureau for Medical Services (BMS) will increase provider waiver rates by 15% on October 1, 2024, the amount as recommended in the service cost and rate review conducted by Myers and Stauffer LC and released on December 8, 2023.

The Governor discussed the expansion during his weekly administration briefing.

A waiver rate increase will also occur for family support, as well as personal care rates on October 1. In addition to rate increases, BMS will remove an additional 50 Intellectual/Developmental Disability (IDD) members off the waitlist. This is in addition to the 99 members who were removed from the waitlist on July 1, 2024. The total cost to remove 50 members from the waitlist is \$3.9 million per year.

"Ensuring that our providers are compensated fairly and that more West Virginians can access the services they need is a top priority," said Cindy Beane, DoHS Bureau for Medical Services Commissioner.

tives of West Virginia Senate Bill (WV SB) 617. BMS expanded the review to include the Aged and Disabled (AD) Waiver, the Traumatic Brain Injury (TBI) Waiver, and the personal care (PC) state plan service. The project responds to WV SB 617, which provides a directive to determine recommended levels of reimbursement for home and community-based services (HCBS) providers serving individuals with IDD. The rate review and recommendation process included a provider cost survey, significant stakeholder engagement, geographic review, and peer state research.

Issues raised by waiver and state plan service providers have included workforce pressures, staffing shortages, turnover, and reimbursement levels. The expansion of this rate rebase initiative to include the AD and TBI waivers and PC service allowed BMS the opportunity to review rates for a larger population of service recipients, examine the alignment of rates for similar services across waivers, and provide consistent rate change recommendations that do not create an imbalance that may lead to workers favoring employment in one type of services



## **Mixed Berry Cobbler with Cake Mix**

#### Ingredients

#### **Berry Filling**

- 6 <sup>1</sup>/<sub>2</sub> cups mixed frozen berries
- $\frac{1}{3}$  cup granulated sugar
- $\frac{1}{4}$  cup water
- 2 tablespoons cornstarch
- 1 teaspoon vanilla extract
- Zest and juice of 1 small lemon Cobbler Topping

- 1 box Yellow Cake Mix
- $\frac{1}{2}$  cup butter, melted

#### Instructions

• Preheat the oven to 350°F (180°C). Lightly butter a 9×13-inch baking dish and set aside. To Make the Berry Filling

• In a large bowl, combine the frozen berries, sugar, water, cornstarch, vanilla extract, juice and zest of the lemon until well coated, then spread evenly into the prepared baking dish. To Make the Cobbler Topping

· In a medium bowl, combine the cake mix with the melted butter until it clumps together. Crumble this over the berries.

• Bake for 40-45 minutes, or until the topping

is golden brown and the berries are bubbling thickly.

· Let cool for about 10 minutes before serving while still warm with a big scoop of vanilla ice cream.

• This is best the day it is made but you can store leftovers covered in the refrigerator for up to 2 days. Reheat in the microwave or in a 300°F oven for about 10 minutes.

#### **Recipe Notes**

• You can use fresh berries instead of frozen berries for this recipe, but we recommend this only if the berries are in season. Otherwise. frozen berries will give you the best flavor.

• You can make this with a single berry (instead of mixed) if you wish.

• Make sure the berries are bubbling before you remove the cobbler from the oven; otherwise, it will not set properly.

• If the topping gets too brown before the berries are cooked, cover the cobbler with foil for the remainder of the baking time.

• This cake mix cobbler would be delicious with a dollop of whipped cream or Vanilla ice cream!







## **Mental Health Awareness for Back-To-School**

## Permits Available for the 2024 Ginseng Season on Monongahela National Forest

ELKINS, W.Va., August 19, 2024 – Monongahela Elkins, Monday to Friday from 8 a.m. to 4:00 p.m. National Forest will begin selling ginseng permits for the 2024 harvest season on Monday, August 26. In addition to following all state laws, a Forest Service permit is required to dig ginseng on National Forest System lands.

You can purchase a permit at the ranger stations in Parsons, Petersburg, Richwood, Bartow, Marlinton or White Sulphur Springs, or the Supervisor's Office in

Monongahela National Forest ginseng permits cost \$20 each. A separate permit is required for each district on the Forest. This year, you may only buy one permit per district at a time. Each permit allows you to collect up to 95 plants from one ranger district during the West Virginia ginseng season, Sept. 1 through Nov. 30. You can purchase an additional permit for the same district

after you return each completed permit, as supplies allow.

Ginseng plants must have three or more prongs and have produced fruit this year to be legal for harvest. When harvesting, plant the fruit on-site and then keep the rest of the plant intact. Harvest no more than 24 plants per day and have no more than 24 plants in your possession while on national forest land.

## **USDA Offers Disaster Assistance to Agricultural Producers in West Virginia Impacted by Drought**

MORGANTOWN, W.Va., August 21, 2024, Agricultural operations in West Virginia have been significantly impacted by recent drought. The U.S. Department of Agriculture (USDA) has technical and financial assistance available to help farmers and livestock producers recover from these adverse weather events. Impacted producers should contact their local USDA Service Center to report losses and learn more about program options available to assist in their recovery from crop, land, infrastructure, and livestock losses and damages.

USDA Disaster Assistance

Livestock producers who suffered grazing losses for covered livestock due to drought on privately owned or cash leased land may be eligible for the 2024 Livestock Forage Disaster Program (LFP). To participate in LFP producers must own, cash lease, or contract grow eligible livestock, provide pasture or grazing land to eligible livestock on the beginning date of the qualifying drought, certify that they suffered a grazing loss due to drought, and submit an acreage report to the Farm Service Agency (FSA) for all grazing land for which a grazing loss is being claimed. FSA maintains a list of counties eligible for LFP and makes updates each Thursday.

Meanwhile, the Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish Program (ELAP) provides eligible producers with compensation for above normal costs of hauling water and feed to livestock as well as transporting livestock to forage or other grazing acres. For ELAP, producers are required to complete a notice of loss and a payment application to their local FSA office no later than the annual program application deadline, Jan. 30, 2025, for 2024 calendar year losses. Additionally, eligible orchardists and nursery tree growers may be eligible for cost-share assistance through the Tree Assistance Program (TAP) to replant or rehabilitate eligible trees, bushes or vines. TAP complements the Noninsured Crop Disaster Assistance Program (NAP) or crop insurance coverage, which covers the crop but not the plants or trees in all cases. For TAP, a program application must be filed within 90 days of the disaster event or the date when the loss of the trees, bushes or vines is apparent.

"Once you are able to evaluate the drought impact on your operation, be sure to contact your local FSA county office to timely report all crop and livestock damages and losses," said John Perdue, State Executive Director for FSA in West Virginia. "To expedite FSA disaster assistance, you will likely need to provide documents, such as farm records, herd inventory, receipts and pictures of damages or losses."

FSA also offers a variety of direct and guaranteed farm loans, including operating and emergency farm loans, to producers unable to secure commercial financing. Producers in counties with a primary or contiguous disaster designation may be eligible for low interest emergency loans to help them recover from production and physical losses. Loans can help producers replace essential property, purchase inputs like livestock, equipment, feed and seed, cover family living expenses or refinance farm-related debts and other needs.

Additionally, FSA offers several loan servicing options available for borrowers who are unable to make scheduled payments on their farm loan programs debt to the agency because of reasons beyond their control.

cial and technical assistance to implement emergency water conservation measures, restore fencing, remove debris, replace damaged irrigation system, land leveling and more.

USDA's Natural Resources Conservation Service (NRCS) can help farmers make their operation more resilient in the face of drought in future years. Through conservation planning and practices that will improve soil health and water conservation, farmers can reduce future crop loss due to drought and enhance resiliency to changing climatic conditions. Financial help for implementing conservation practices may be available through the Environmental Quality Incentives Program.

Long-term damage from drought can include forage production loss in pastures and fields and decreased crop yields on fields not protected with soil health practices. Producers can visit their local USDA Service Center to learn more about these impacts, potential recovery tactics and how to take steps to make their land more resilient to drought in the future.

"The Natural Resources Conservation Service can be a very valuable partner to help landowners with their recovery and resiliency efforts," said Jon Bourdon, NRCS State Conservationist in West Virginia. "Our staff will work one-on-one with landowners to make assessments of the damages and develop approaches that focus on effective recovery of the land.'

Producers who have risk protection through Federal Crop Insurance or FSA's NAP should report crop damage to their crop insurance agent or FSA office. If they have crop insurance, producers should provide a notice of loss to their agent within 72 hours of initial discovery of damage and follow up in writing within 15 days.

For NAP covered crops, a Notice of Loss (CCC-576) must be filed within 15 days of the loss becoming apparent, except for hand-harvested crops, which should be reported within 72 hours.

"Crop insurance and other USDA risk management options are offered to help producers manage risk because we never know what nature has in store for the future," said Alexander Sereno, Director of USDA's Risk Management Agency (RMA) Regional Office that covers West Virgina. "Times of disaster can be a trying time for producers, and they should stay in close contact with their crop insurance agent. Producers can be assured that the Approved Insurance Providers, loss adjusters and agents are experienced and well-trained in handling these types of events."

Exercise is great for the body. Scholastic and recreational sports is one of the primary ways children and adolescents get the exercise they need. Even though sports participation is relatively safe, there's no guarantee athletes won't suffer an injury. However, there are ways for student athletes to reduce their risk of getting hurt while playing the games they love.

<sup> $\pm$ </sup> Maintain flexibility. Mount Sinai says it is extremely important for athletes to perform dynamic stretches before starting any activity. Cold muscles are vulnerable to injury, so it's best to do some sort of physical warm-up, including jumping jacks, butt kicks, running in place, or arm circles.

¥ Practice proper technique. Athletes should learn and implement the proper techniques for whatever sport they are playing to lower their injury risk.

¥ Don't push through pain. Pain is one way the body communicates that something isn't right. At the first sign of pain, an athlete should take a break

¥ Wear the right gear. Johns Hopkins Medicine emphasizes using proper, well-fitting gear. Certain gear may be cumbersome and athletes may be tempted to forego it, but that can result in greater injury risk.

¥ Get a sports physical. Most programs mandate an updated sports physical examination. This pre-participation physical allows for the screening, prevention and treatment of any conditions that can affect play and contribute to injury.

¥ Gradually increase training intensity. The American Orthopedic Society for Sports Medicine indicates athletes should always build up their training gradually. One way to do so is to follow the 10 percent rule, which advises against increasing training activity, weight, mileage, or pace by more than 10 percent per week.

¥ Rest and take breaks. Athletes who play sports year-round have a greater tendency than others to suffer overuse injuries because their bodies are not given an opportunity to rest and recover. Athletes should take at least one season off per year.

¥ Play different sports. By participating in different sports, an athlete can avoid using the same muscle groups all the time. For example, the muscles used for swimming may be different from those used for playing field hockey. Utilizing different muscles reduces the risk for overuse injuries.

¥ Strengthen the core. Mount Sinai notes a strong core, which is the abdominal area of the body, can help athletes avoid injuries. Exercises that strengthen the core can improve balance, stability and strength.

Student athletes may want to get ahead in the sports they play, but it should never be at the expense of putting their bodies at a greater risk for injury.
