## Virginia Western Community College launches Great Expectations program to help students attain success after foster care

ROANOKE - In Virginia, Great Expectations applies to an outreach program for youth and young adults who have experienced foster care and need specific supports to attain higher education. Virginia Western Community College announced last week it is launching its branch of the program Great Expectations Student Success Coach JW

Taylor has been laying the groundwork to launch

the program. "I want to make sure is that there is a safe place on campus for a student to feel like they can come and have that emotional support and have an advocate on campus that can help them navigate the system," Taylor said. An on-campus launch event Monday, Aug. 7, will offer an opportunity for Roanoke Valley public and private agencies to learn more about

Great Expectations, with speakers from Central Virginia Community College sharing about ways the program has been successful there. Participants will have an opportunity to tour Virginia Western's campus after hearing from speakers during a lunch Great Expectations is funded through the Virginia Foundation for Community College

Education, as well as with state funding. The grant to launch Virginia Western's Great Expectations Program runs through December 2025. Any Virginia Western student who is currently in

foster care or who has experienced foster care after the age of 13, as well as those who were adopted from foster care as part of a special needs adoption, are eligible. Expectations coaches help guide

participants to apply for tuition grants that can cover tuition and fees for credit or noncredit workforce programs. They also help students access resources to cover housing, food insecurity, child care needs, and transportation concerns. Taylor's role begins long before someone enrolls,

and he has spent time reaching out within the foster care community. This includes local Department of Social Services offices, child placing agencies, extended foster care/independent living programs and former foster parents, since students who were adopted as part of a special needs adoption would qualify for Great Expectations. Taylor's goal is to spread the word so this network will "know that there's a guy here who helps foster kids get enrolled."

Research from the University of Chicago has revealed that of people aged 17-25 who experienced foster care as a teenager, 54% of former foster youth experience homelessness by the age of 21, with 20% becoming homeless on their 18th birthday; 60% face incarceration; 58% earned a high school diploma by age 25; and less than 8% earned a college degree or certificate.

In Virginia, the city of Roanoke currently has the most children currently in foster care, with approximately 40 more than Fairfax County despite having only 8% of that county's population. Eleven percent of all foster children currently in foster care are from localities serviced by Virginia Western. Virginia has one of the highest percentages of teens turning 18 and "aging out" of foster care, with 35% of all children leaving foster care being emancipated in 2021 (compared to the 9% national average).

There are more positive numbers because of Great Expectations. Throughout the Virginia Community College System, Great Expectations has helped more than 870 students earn degrees. Students enrolled in Great Expectations graduate at three times the national rate for foster youth.

Elizabeth McKey has served as Great Expectations coordinator at Brightpoint Community College in Chester and Midlothian since 2017. "Our ultimate goal is that we want to see them cross that stage at graduation. We want to see them achieve that credential and not only do that, but move into the adult world independently," McKey said. McKey has formed a network of about 25 volunteer

mentors, many of whom work at Brightpoint. Great Expectations helps participants with life needs such as transportation, or through smaller gestures such

as snacks McKey keeps in her office. The program holds a fall kickoff event with school supplies and has an array of community-building activities for Great Expectations students that ranges from business workshops to dinner together at Cracker Barrel the night before Thanksgiving.

"Every step, every service, every resource that we can provide for them makes a difference, and helps them to continue to put one foot in front of the next," McKey said.

Once eligible students are enrolled at Virginia Western and part of the Great Expectations program, Taylor plans to help them connect with college resources and draw support from one another. "Virginia Western hopes to create an environment where all students can succeed. This program will supply extra resources and safety to help students from hard places build those skills," Taylor said.





While Secretary Becerra's comments seem to suggest that moving children out of ORR facilities quickly is more important than protecting them, the Secretary claimed that was not the case and his comments were more about overall ORR efficiency.

I also questioned the Secretary about ORR's unacceptable vetting practices of family members and sponsors.

In regard establishing claimed familial relationships between an adult and unaccompanied minor, I asked if the agency does DNA Secretary testing. Becerra said that the agency verifies the identity of the family member mainly through documents, like birth certificates.

This is not enough. Documents like certificates or passports can be forged!

testing is DNA the only way to be completely sure there actually is a family connection.\*

Additionally,

questioned Secretary Becerra about ORR continuing to waive background checks not only for people claiming to be family members, but also for unrelated adults who live in the house where a child is being placed – practices that were approved by the Secretary in ORR Field Guidance 10 and 11.

Further, ORR does not generally conduct background checks of sponsors.

The Secretary's responses to questions about ORR's vetting process were far from satisfactory. I was hoping to hear that ORR would start doing FBI background checks on sponsors and DNA tests on those claiming to be family. Unfortunately, that was not the case.

These issues with have been ORR ongoing since the start of the Biden Administration.

In 2021, I visited the Emergency Intake operation at Fort Bliss, Texas, and was shocked by what I I learned. There was

no collaboration with law enforcement for background checks when vetting sponsors and the "background check" "public records check" they were using were merely widely available internet search engines.

In my opening, I placed into the record a report by a statewide grand jury in Florida, charged investigating with ORR. It said:

"If any resident of Florida exposed U.S. born children to this process, they would be justifiably arrested for child neglect or worse. We do not think children should be less-protected simply because they were born outside our borders and brought here by a government agency.

I agree. In my view, as a former domestic relations attorney in Virginia, ORR's practices and actions to child neglect. A child's legal status is irrelevant, ORR must

### WHAT ARE CAPITAL CREDITS?

A cooperative does not earn profits in the sense that other businesses do. Instead, any revenues (called margins) remaining after all expenses have been paid, are returned to members in proportion to their usage of the co-op's services through capital credits allocations and retirements. Capital credits represent each member's share of the cooperative's margins and ownership of the co-op.

## WHAT DO COOPERATIVES DO WITH **CAPITAL CREDITS?**

Every business needs to maintain a suitable balance between debt and equity to ensure its financial health and stability. Capital credits are the most significant source of equity for most electric cooperatives. Equity is used to help meet the expenses of the co-op, such as paying for new equipment to serve members and repaying debt. Capital credits help keep rates at a competitive level by reducing the amount of funds that must be borrowed.

### HOW DOES THE COOPERATIVE DETERMINE WHO RECEIVES CAPITAL CREDITS?

Capital credits are allocated to each member of the cooperative every year based on participation in the cooperative. The board of directors determines the basis for the allocation. Frequently, the allocations are based on such measures as the total dollar amount of services purchased or kwh of electricity consumed.

### HOW DOES THE COOPERATIVE NOTIFY MEMBERS AROUT CAPITAL CREDITS **ALLOCATIONS AND RETIREMENTS?**

CBEC has notified its members of annual capital credit allocations and retirements through letters, on your monthly power bills, our CBEC website, in Cooperative Living Magazine, local newspapers and via social media.

## WHAT CBEC MEMBERS WERE INCLUDED IN OUR **MOST RECENT CAPITAL CREDIT RETIREMENTS?**

Eligible co-op members from 1992 and 1993 were mailed checks, but many were returned to us due to incorrect contact information and other factors.



## BUSCH WINS IN STAR-STUDDED FIELD IN PULASKI CO., CRAIG'S LOONEY WINS FOR SEVENTH TIME SATURDAY

at Pulaski County Motorsports Park. Following Thursday night's Superstar Experience Racing debut, the NASCAR Advance Auto Parts Weekly Series returned to the track on Saturday and New Castle's Mike Looney picked up another win.

The biggest night of stock car racing to ever roll into the New River Valley was last Thursday, July 27, and it ended with a two-time NASCAR Cup Series champion parked in victory lane. In his Superstar Racing Experience (SRX) debut, Kyle Busch earned the victory with an impressive performance at the .416-mile Motor Mile Speedway inside of Pulaski County Motorsports Park.

A star-studded field of 12 drivers included some of the world's best to ever get behind the wheel. The premier group, handpicked by SRX owner Tony Stewart, combined for 200 NASCAR Cup Series wins and 59 Indy Car Series wins. The list of competitors also held a combined six NASCAR Cup Series championships and one Daytona 500 victory as well as three Indy Car titles and five Indy 500 wins.

The SRX series came to southwest Virginia for the first time and put on a show in front of a packed house. A pair of 20-lap heats opened the night's festivities before the 100-lap main event. Marco Andretti won the opening heat before the field was inverted, leading to a victory for 10-time NASCAR Cup Series winner Clint Bowyer in the second sprint.

A century of laps around the 15-degree banked oval highlighted the night. Kyle Busch worked his way up to the top spot, as he held off a quickly approaching Bowyer, who had found some serious speed on the bottom groove. A late-race crash involving Paul Tracy and 2023 Indianapolis 500 winner Josef Newgarden

the field was bunched back up, Busch maintained his lead for the final handful of laps to secure his first-ever SRX victory.

Earlier in the evening, fans were treated to a 50-lap feature for the Collision Plus Sportsman Series. Brad Foy led the majority of the race, starting the night off by parking his black and orange machine in victory lane.

Current points leader Kyle Barnes started on the front row and defending late model track champion Kyle Dudley started one spot behind him. Early mishaps at the start of the race sent the duo to the tail of the field.

Foy proved to be the class of the field, jumping out to an early lead that he never surrendered. Karl Budzevski stayed within reach of the race winner but was never able to make the final pass.

A strong showing of perseverance from Dudley pushed him back up through the field, a run good enough for the final podium spot.

On Saturday, after a brief battle with Mother Nature, the on-track action began just minutes after the scheduled start time. Shively Electric sponsored the evening and welcomed the Super Cup Stock Car Series to the .416mile short track for the first time this season.

Pole-sitter Brian Harrison lost his transmission just a handful of laps into the race, which gave the lead to Brent Nelson. The Petersburg, W.Va. native led the remainder of the race to earn the first victory of the

The second race of the evening belonged to the Price's Body Shop Late Model Stock Car Series. Dudley started in the third position, and it took the defending track champion just three laps to get to the top spot. A tight battle with current points leader Mike

Saturday marked the end of a busy and historic week also collected Ken Schrader and Hailie Deegan. After Looney of New Castle resulted in contact coming off Turn 2. While Looney was forced to pull his car off the track, Dudley regained a lengthy advantage and earn

the checkered flag in the first 50-lap twin of the night. The DCT Towing Super Streets took to the track next. Tristen Barnes picked up his second victory within a week while Ray Sowers tallied his second consecutive podium finish. Despite the early mishap,

Bell fought A 25-lap sprint for the Blue Ridge Church Pure-4s was the next race of the night. After starting at the back of the pack, Kirby Shipman quickly got to the front and crossed the line first to build on his already sizeable points lead.

The second half of the evening started with the second twin for the Super Cup Stock Car Series. The race was shortened to just 30 laps this time but resulted in the same three podium finishers as Nelson earned the double after another strong outing.

The second 50-lapper for the late model stocks went the way of Craig County's Looney this time. After failing to complete the first twin, his team pieced his machine back together as the veteran led every lap enroute to his seventh win of the season.

The nightcap belonged to the Stock-6 Series. Caleb Sowers jumped past Phillip Miller at the drop of the green flag and led all 20 laps to secure the victory. Houston Miller worked his way

The weekly racers will have this Saturday off before returning to action on Saturday, August 12, for their first races of the month. The Tour of Destruction monster truck show and motocross experience will be in the New River Valley this weekend. Action begins at 5 pm.
