# Early voting underway for March 5 Craig County Super Tuesday primaries

Craig County, like other Virginia localities, will hold a 'Super Tuesday' dual presidential primary elections on March 5. All precincts and polling places in Craig County will be open from 6 a.m. to 7 p.m. on that day.

Virginia conducts open party primaries and does not register voters by party affiliation, which means that every qualified voter is entitled to participate in the single party primary of their choosing.

In a dual party primary, all Virginia voters are eligible to participate in either the Democratic Party primary or the Republican Party primary but may only vote in one or the other. As a result, all voters are required by law to indicate to an Officer of Election present at the polling place whether they would prefer to mark a Democratic ballot or a Republican ballot.

Candidates on the Democratic Party ballot are Marianne Williamson, incumbent Joseph Biden, and Dean Benson Phillips.

Candidates on the Republican Party ballot are Chris Christie, Ryan Binkley, Vivek Ramaswamy, former president Donald Trump, Ron DeSantis and Nikki Haley.

Early voting for the March 5 presidential primary elections began Jan. 19 at the Craig County Voter Registration Office located at 155 Main Street in New Castle, next door to the county health department office.

The last day to vote early is March 2. Virginia law requires all voters to present an acceptable form of registration when voting early or when voting at a precinct.

Joanna Ryan, Craig County's voter registrar, said her office will also be open for early voting on Saturday, Feb. 24 and Saturday, March 2 from 9 a.m. to 5 p.m. It will not be open on Saturday, Feb. 19.If you have questions concerning local elections, you wish to register to vote, or would like to serve your community on election day, please call Ryan at: (540) 864-6190 or email: vote@craigcountyva.gov

The deadline to register to vote or to update your address on your existing voter registration for the March 5 primary is Monday, Feb. 12.

Any citizen needing to register to vote or update their address may do so by appearing in person at

the county voter registration office, mailing a completed application to PO Box 8, New Castle, VA 24127, or by using the citizen portal at https://vote.electons.virginia.gov/voterinformation

If you are not a registered voter, you have until Feb. 23 to do so in order to participate in the March 5 primary.

You can register online, in person at the registrar's office or through the mail. A Virginia Voter Registration Application can be found online at https://www.elections.virginia.gov/registration/voter-forms/

# Program to educate families about mental health

Craig County schools are offering a unique program early next month to help educate families about the mental health and well-being of their children.

'Your Child's Anxiety' is the name of the Feb. 7 program, which begins at 6:30 p.m. at Craig County High School. Participation is free.

It will be the first workshop planned during what the school system is calling a 'Mental Health Series.'

Of the workshop, the school system says parents can "learn simple strategies that will help parents respond to their children's anxiety. When applied, these skills will help the child and parent bond, allowing the child to identify

and work through their anxiety more effectively."

The program is being conducted cooperatively by Craig County Public Schools and a national mental health organization called parentguidance.org. It is affiliated with a Utah-based non-profit called the Center for Human

Connection.

"Parenting is hard," says parentguidance.org on its website. It also quotes statistics stating 50% of parents worry that their child is struggling but don't know what to do; 32% of parent feel their child is unhappy; and an estimated 10-20% of adolescents experience mental health conditions.

"The mission of the Cook Center for Human Connection is to bring together the best organizations, programs, and products to prevent suicide, provide mental health support, and enhance human connections essential for people to thrive," according to the center's website.

"The foundation's current focus is on supporting children, families, and schools in eradicating suicide, as well as offering resources and support for those with mental health issues and their caregivers. This is done through a variety of grants to schools, programs for parents, and global resources to bring greater awareness to the support needed for those affected by suicide," according to the center's mission statement.

"We are proud to partner with this organization to help provide important information and support to our parents and community. We hope to see you

there as we continue to strengthen the ties between school and home to be the best we can be for our children," according to a statement from Craig

County schools.

The school system says everyone is invited to attend the event, either in

person or remotely via Zoom.

Also, a dinner will be held at the high school at 6 p.m. on Feb. 7 before the event. There is no cost to attend this meal and attendees will be entered into

a drawing.



# Recipe of the Week

According to Pennsylvania Dutch superstition, if a groundhog emerges from its den on Feb. 2 and sees his shadow he will go back inside and there will be 6more weeks od winter weather. If he does not see his shadow, spring will be early. The days in February seem the same, very monotonous. As winter drags on, we all get tired of the cold and dark days. Groundhog Day Syndrome is the feeling that you're reliving the same day repeatedly. Nothing has changed, and it seems as though you're doing an identical routine every single day and week. This feeling of sameness is called Groundhog Day based on the 1993 movie with Bill Murray. His

character Phil has fallen into a rut.

rut includes covering Groundhog Day for the past four years. Within the first few minutes the movie premise is set up. Phil is a jerk doomed to repeat the day until he learns compassion, empathy, and love. Food shows up all through this movie. Day to day the meals are on repeat. But as the movie progresses Phil changes things up and makes eating interesting. He gets to eat with no consequences. The way he handles this always makes me laugh.

I find that in the winter I tend to make recipes on repeat. Usually because it's a good recipe and it's very easy to make. A go-to repeat recipe is great for hurried nights or a need for a potluck dish. Make ahead meals to freeze or a meal for someone in need. This week's recipe is one I make often. This is a very basic recipe. But it can be changed and added to as needed. You can use sausage, ground beef, ground turkey, cooked chicken, or no meat at all in this recipe. I have added pepperoni, tiny meatballs, or

browned ground beef. Vegetables such as spinach, bell pepper, mushrooms, and onion added are good too. I change the cheese out with whatever I have on hand. I have used a four cheese Mexican blend many times. Do NOT cook the pasta. Add the pasta uncooked to the casserole mixture. It will cook along with the rest of the ingredients. This recipe can be made in advance. You can assemble the casserole and refrigerate overnight, then bake. This recipe freezes well after baking and reheating when ready to serve. Store leftovers in an airtight container in the refrigerator. Reheat leftovers in the microwave.

Life can seem to be on repeat, but we can change it up and make it better. Life is meant to be lived. Make a repeat recipe and enjoy Groundhog

#### Baked Penne (basic recipe)

#### Ingredients:

1(16 ounce) box pasta (Rigatoni,

Penne, Rotini or Ziti) DO NOT **PRECOOK** 

1 (24 ounce) jar tomato sauce

1 full jar water (24 ounces)

cheese, 2 cups mozzarella

#### Instructions:

Preheat oven to 400 degrees. Lightly grease 9x13x2-inch casserole dish; set aside.

Combine uncooked pasta, 1 jar of Sauce and 1 jar of water in a 13 x 9 inch baking pan. Cover tightly with aluminum foil. If adding other ingredients, add to pasta, sauce, and water now. BAKE 50 minutes. Uncover and stir well. TOP with mozzarella cheese. Sprinkle with parmesan cheese to help with browning and add more cheese flavor. Bake uncovered for an additional 10 minutes or until cheese melts and pasta is tender.





# Book review of 'The Girls: A Novel' by Emma Cline

Evie Boyd is living in her ex-boyfriend's rented house to figure out what she should do with the rest of her life. One night the ex-boyfriend's son and his girlfriend show up unannounced and start bringing up her unpleasant memories of the summer of 1969. When Evie was 14 years

old she was involved with a group of hippies that are the fictionalized versions of Charles Manson and his family. During that time, she was dealing with loneliness and depression from her parent's divorce, her best friend rejecting her, and everyone being too wrapped up in their problems to care about her. That's when she meets Suzanne and goes out to the ranch where she feels special and needed. However, over time what started as a peaceful and friendly community ends up becoming more crazed and sinister until something snaps. Evie will try anything to fit in with her new family, but at what cost?

This historical fiction of the Charles Manson family and the horrific crimes they've committed is more concerned with character growth than with what truly happened. There is a lot of information and dialogue that have been done and said by Charles Manson and others, but some characters, events, and other facts are rearranged and ignored for the sake of the narrative and probably to respect the real-life people that many of these characters depict. Nevertheless, the book does a great job of showing how someone could get mixed up in situations like this and has the reader question what their actions would be if they were in this scenario. This book is not going to be for everyone as it depicts situations involving sexual abuse, violence, and drug use. However, it can be

enjoyable for those who want to explore the mindset of victims of cults and how they can be devastating to not only the communities they destroy but also the individual's sense of self. A good companion piece to go along with the reading of this book would be the Helter Skelter documentary which is also available at the Craig Library. This documentary goes into great detail about the event and will help contextualize the material after you finish reading.

# News from the 9th: Sweden set to join NATO

The Kingdom of Sweden was a great power in Europe, controlling much of the Baltic region during the 17th and early 18th centuries.

Its decline was marked by Sweden's loss at the Battle of Poltava. In July 1709, King Charles XII and the Swedish army lost to a superior Russian force.

The Battle of Poltava was Sweden's greatest military disaster and began the rise of Russia as a European power.

The Russian Empire continued to expand over the next 200 years and during World War I, communists took over the country and formed the Soviet

After World War II it was clear the Soviet Union was going to attempt to continue to expand their empire and control over puppet governments. To counter that, many countries in Europe and the United States formed the North Atlantic Treaty Organization (NATO).

Once the Soviet Union collapsed in the early 1990s, many countries in Eastern Europe (Estonia to Bulgaria) joined NATO in an effort to prevent future Soviet (now Russian) control.

Following Russia's invasion of Ukraine in February of 2022, both Finland and Sweden formally submitted applications for membership to NATO. In order for a new country to join

NATO, each of the existing members must vote in favor of the new members. While almost all of the NATO member countries voted in favor of both Finland and Sweden in 2022, Hungary and Turkey did not.

Turkey initially opposed both countries joining NATO as they had provided support to Kurdish groups seeking a Kurdish homeland (deemed as terrorist organizations by Turkey).

While Finland did eventually receive approval by all member countries, and formally joined NATO in April 2023, it is taking a bit more negotiation for Turkey to approve Sweden's membership.

This included Sweden tightening their anti-terror legislation and agreeing to work closely with Turkey on concerns of national security. Separately, the United States must also approve the sale of F-16 fighter jets to Turkey.

Now that Turkey's Parliament has voted in favor of Sweden's membership, the last step is for Turkey's President Erdogan to sign the protocols.

Though Hungary technically has not yet ratified Sweden, Hungary's Prime Minister released a statement saying the government supports Sweden's membership.

Russia's rhetoric towards Ukraine prior to invasion is very similar to Russia's rhetoric regarding NATO members

Latvia, Lithuania, and Estonia. This rhetoric creates a concern they want to reconquer these NATO countries and a Russian versus NATO war in the region would destabilize Scandinavia and the

Further the border between Poland and Lithuania, known as the Suwałki Gap, is another flashpoint between Russia and NATO countries. While Belarus is to the east, there is a Russian enclave to the west of the Gap, the Kaliningrad Oblast, created after World War II when Russia took the territory from Germany, which formally was East Prussia. Today, it is heavily militarized by the Russians, including warships, warplanes, and nuclear weapons.

Sweden's membership in NATO could prove to greatly benefit the alliance as Sweden's military strength significantly increases NATO's capabilities in Scandinavia and the Baltic.

Sweden's defense industry is one of

# Sen. Chris Head offers legislative update from Richmond

The General Assembly is now in high gear. Committees are meeting, and hundreds of bills are being considered. Full sessions of the Senate are getting longer as more legislation comes to the floor for consideration. The halls are filled with constituents and advocates seeking meetings to share their views and concerns. In short, everything is moving fast, including me. CHILD SAFETY BILL BLOCKED BY DEMOCRATS My Republican colleagues

and I were both dismayed and puzzled by Democrats killing a bill to protect children from sex offenders. Senator Danny Diggs

offered what seemed to me a commonsense idea. Keep convicted child sex offenders at least 100 feet away from State Parks where children congregate. Children and their families deserve to be able to enjoy Virginia's parks without worrying that a known sex offender might be lurking in the park or just outside of it. Democrats decided to focus

on the concerns of the sex offenders rather than the safety

of children. They claimed the bill was overly broad. One supporter of the Democrats' position even testified that it was "pointlessly cruel" to bar sex offenders from public parks—as if that outweighed the cruelty they caused to the children they assaulted.

Republicans sought to return the focus to where it belonged—the safety of children and their ability to play without fear, but the Democrats would have none of it. They decided that the "cruelty" to sex offenders was more important than child safety and killed the bill. DEMOCRATS DRIVE

INFLATION WITH MINIMUM

To keep Virginia a top place for business, the General Assembly needs to pass laws that lower costs for families, reduce red tape, and encourage entrepreneurs and economic growth. Senate Democrats seem committed to doing the opposite. One example? The

minimum wage. In their first bill of the session—SB 1 they proposed a 25% increase in the minimum wage over just two years. If this becomes law, many struggling small businesses or companies will be forced to come up with money they do not have by raising prices. And we all know that higher prices are another

earn a good living, a business forced to close cannot pay anyone any wage. And raising costs results in higher prices for everyone. Virginians cannot afford any additional inflation at this point.

Besides, as Governor Glenn Youngkin noted, the market is taking care of this. Wages are rising on their own due to more competition for workers. The government does not need to pile on when the market is already doing the job.

I will update you on this as the legislation moves through the General Assembly.

Del. Terry Austin offers legislative update from Richmond

To the Constituents of the 37th House District: The second full week of the

General Assembly hasconcluded, and the House of Delegates has hit full stride. Committees are working through the more than 1,500 bills introduced. Policy differences are becoming apparent as debate unfolds, with disagreement on the value of family farms, housing policy, and our constitutional rights on full display. I remain concerned about the

legislation passed out of the House this week that makes major changes to the way family farms will be required toconduct business. Instead of trusting farmers and their employees to agree on terms

of employment, this legislation mandates wages and will likely drive a significant number of our remaining family farms out of business. Seasonal workers come to the U.S. because they can earn more money than they can in their home countries. If this bill becomes law, the system that provides this opportunity will no longer be sustainable. Rather than have difficult jobs, there will be no jobs. I oppose this work with my colleagues to protect the farmers who put food on our tables. Generational family farms will become a relic of our past if policies like these are implemented.

bills that would increase the cost of housing. This includes legislation creating rent control in Virginia and permitting localities the ability to mandate the installation of sprinkler systems in new residential construction. Rent control is a power given to local government to either set maximum housing rents or limit the amount of rent increases over a fixed period. While

Democrats have also introduced

this may sound good in theory, the practical effect is that price controls create shortages and disincentivize property improvements. A study on rent control in San Francisco determined that it reduced available rental properties by 15 percent and "likely drove up citywide rents, damaging housing affordability."

Mandating the installation of sprinkler systems in new townhome and apartment construction is well meaning but will only serve to exacerbate the high costs of purchasing a home. Townhomes are often the best option for new home buyers, and this mandate would further diminish the ability of someone who wants to build equity from having the opportunity to do so. As for legislation mandating sprinkler systems in new apartments, I was successful in leading the committee to kill this bill. New materials, technology and building standards continue to improve as it relates to fire detection and prevention. The reality is that housing affordability will not improve across Virginia if

Europe's largest, producing some of the best defense equipment on the market. One example of this is the Saab JAS 39 Gripen, a supersonic fighter aircraft, produced by Swedish aerospace and defense company Saab AB. The Gripen is designed to take off and land on short runways and can be refueled and rearmed in a matter of minutes.

As a result, Sweden's Air Force is one of the largest in Europe, which possesses at least 100 fighter jets. These fighter jets provide critical support to Army and Navy forces as they conduct operations in the Baltic and Arctic regions.

Sweden's strategic position in Northern Europe and powerful submarine force are also key to keeping waters navigable in the Baltic Sea. The Baltic Sea is a shared waterway with Russia, and it bottlenecks, limiting access to ports in eight countries. Sweden's knowledge of navigating the Baltic Sea and their submarines which work well in the Sea's shallow water, could all prove to be important for

NATO's future success.

Russia's invasion of Ukraine brought into sharp focus Russia's desire to expand far into Europe once again. The importance of the NATO alliance, and bolstering its capabilities, has become clear and with Sweden in the alliance, it looks to become stronger than ever

this week! SB 133 will help physician assistants across the Commonwealth by allowing PAs who are employed by a hospital or employed in certain facilities operated by the Department of Behavioral Health and Developmental Services or in Federally Qualified Health Centers designated by the Centers for Medicare and Medicaid Services to practice without a separate practice agreement if the credentialing and privileging requirements of the applicable facility include a practice arrangement.

I also had two other bills clear the Senator floor and now head over to the House of the Delegates for consideration.

SB 134 will help the Craig County Economic Development Authority continue to operate at full capacity by allowing the Craig County Board of Supervisors

to appoint one of its members to its EDA. SB 134 passed the Senate on a 39-0-1 vote and moves over to the House.

SB 154 will assist Virginians with their advance health care planning by streamlining existing processes on Virginia's Advance Health Care Directive Registry and by expanding the types of documents that are eligible to be included on the registry to now include any other document that supports advance health care planning, including Durable Do Not Resuscitate Order or portable medical order forms. SB 154 passed the Senate unanimously (39-0) and heads to the House.

Several of my other bills are making their way through their respective committees and on to the Senate floor.

SB 156 will assist in facilitating the Wells Fargo expansion in Roanoke County through post-performance

grant funding after meeting metrics for capital investment and the creation of at least 1,100 new full-time jobs at the facility.

SB 132 will help expedite

assessments of the Health Insurance Reform Commission (HIRC), by requiring that whenever the Chairman of the House Committee on Labor and Commerce or the Senate Committee on Commerce and Labor requests that the Commission assess a legislative measure containing a mandated health insurance benefit or provider, the HIRC is to complete its assessment and submit a report for each such request within 24 months. SB 132 successfully reported from the Senate Committee on Rules (11-1) and will be on the Senate

floor next week.

More of my legislation will be heard in committee next

week as everything moves through the legislative process. You can follow my legislation as it makes its way through the General Assembly HERE and all 2024 bills introduced by members of the Senate of Virginia and the House of Delegates HERE.

There are also a significant number of bills that have been filed that would impact our Second Amendment rights, including bans on certain typesof firearms. I will continue to join my Republican colleagues in voting against these bills and advocating for common sense approaches for those wanting to possess firearms. This includes a bill carried by one of my Republican colleagues to extend a tax credit for gun safes, something once considered bipartisan. Unfortunately, it did not make it out of subcommittee.

As for my bills, I am pleased to report that three have reported unanimously out of their respective sub and full committees. Two bills, HB839

and HB840, support the VA250 Commission's efforts to celebrate and promote our nation's 250th birthday in 2026. The third bill, HB237 implements recommendations from the Joint Legislative Audit and Review

Commission (JLARC) to improve the GO Virginia program. GO Virginia encourages regional collaboration to identify, establish, and foster high paying job opportunities, and has been successful in doing so since being implemented in 2015. HB237 adds the Secretary of Labor, a position created after the establishment of GO Virginia, to the state board and reduces the local match so that funds to support these efforts can be more quickly deployed. Successful projects include

establishment of the Blue Ridge regional health sciences talent pipeline, the Alleghany Drone Zone, and numerous CTE workforce and continuing education training programs.

This week local Treasurers and Commissioners of Revenue came to Richmond to discuss their respective office priorities. These Constitutional Officers provide a vital service for our local governments and are a great resource for constituents who have questions related to taxes and assessments. I also had the pleasure of meeting with members of the Alleghany and Craig 4-H and FFA Chapters. It is always refreshing to hear these young men and women talk about their passion for farming and volunteer experiences.

These visits are always a great reminder that our younger generations do have the desire and capacity to work hard and serve others. **Interstate 81** INTERSTATE WIDENING LANE CONSTRUCTION PROJECT EXIT 137 TO EXIT 141 – The \$179 million design-build project to widen both directions of I-81 between mile markers 136.6 and 141.8 from two to three lanes is underway. Work is being performed along a five-mile section of both northbound and southbound Interstate 81 in Roanoke County and the city of Salem. Barrier wall is in place along the shoulders. Two lanes of I-81 traffic in each direction are expected to remain open during the project with periodic lane closures scheduled during nighttime hours or outside of peak travel times as needed. Drivers can expect the following lane closures and upcoming

WORK ZONE SPEED: Drivers should adhere to posted 60 mph speed limits in the work zone and allow space when following a vehicle. Narrow spacing in lanes due to barrier walls, lack of shoulders and lane shifts in various locations, are present.

TRAFFIC SHIFTS On WILDWOOD

ROAD: Expect a work zone with traffic shifts and narrow width on Wildwood road after exiting I-81 southbound on exit 137 heading towards Salem. Southbound and northbound I-81 exit and entrance ramp narrows are possible at Route 311.

TRAFFIC SHIFT ON EXIT 140: Drivers may experience a periodic quick merge into traffic onto Thompson Memorial Drive from the southbound exit ramp of exit 140. Work zone located at bottom of the ramp for work on the I-81 bridge at the underpass.

R A M P CLOSURES: Ramp closures are possible during nighttime hours, 12 a.m., to 5 a.m. Drivers should watch for message boards dates and times the ramp will be closed.

L A N E CLOSURES: Alternating left and right lane and shoulder closures during nighttime hours between 8 p.m. and 6 a.m., Sunday through Thursday, are possible. Lane widths will be reduced to 11 feet. Nightly lane closures may be in place along the right lane with possible nightly ramp narrows as needed for guardrail and shoulder strengthening.

The project also includes replacing six bridges, widening

two bridges, installing approximately 2.6 miles of sound barrier walls along northbound I-81, improving the southbound exit 137 off-ramp intersection at Wildwood Road and adding interchange lighting at exits 137, 140 and 141. Expected

completion in early 2026. I-81 NB & SB **BRIDGE** REHAB OVER ROUTE 100 AT EXIT 98 - Beginning late March 2024, work will begin on I-81 rehabbing the northbound and southbound bridges over Route 100 at Exit 98. Lane and shoulder may be in place on Route 100 north and on I-81 northbound and southbound, 8 p.m. -6 a.m. Flagging operations may also be in place on Route 100 north for up



to eight-minute slow rolls. Both northbound and southbound on and off ramps at exit 98 for I-81 traffic will remain fully operational for the duration of this project. Estimated completion

date is summer 2024.



On Saturday the Rockets will host Bland County for a tripleheader. A boys' jayvee game will tip off at 1 pm, followed by the Craig girls against Bland at 2:30 pm. The Rocket boys will then take on the Bears at approximately 4:30 pm for "Senior Night."

Craig will also have a girls-boys varsity doubleheader next Monday, February 5, at Highland County. The girls will play at 5:30 pm with the boys to follow at around 7 pm.

The boys have two games this week prior to the weekend. On Tuesday they were scheduled to host Eastern Montgomery and on Thursday they head to Buena Vista for a Pioneer District game with Parry McCluer.

The Rockets come into the week at 4-10 after splitting two Pioneer District games last week. On January 23 they played host to a tough Narrows team and lost, 83-28. The Green Wave is undefeated in Pioneer District play.

On Friday in Hot Springs the boys bounced back with a 74-54 win over the host Chargers. Craig had lost the previous meeting in New Castle by 11 points, but the Rockets were able to turn the tables on the Chargers Friday.

"A lot of credit to the players," said Frazier. "We had a team meeting to try and get our play moving in the right direction. The boys bought in and worked really hard in the two practices leading up to Bath. Everyone on the team worked hard and did their job, it was a true team effort.'

Lucas and Reynolds combined for 50 points, Matthew with 30 and Hayden with 20. Hayden went 11 for 12 from the free throw line and Matthew went seven for seven from the line to help secure the win down the stretch. Jaycob Wolfe added 14 and Potter had 10.

"Having four guys in double figures just shows how well they worked together, and they did it on both ends of the floor," said Frazier. "This was a great team win that showed a lot of heart, redeeming the home loss at Bath. Very proud of this win, but we need to keep this momentum heading into the last few games of the season and the district tournament."

# Wagner will speak at Salem-Roanoke Baseball Hall of Fame Banquet Sunday

Former Major League Baseball and Ferrum College pitcher Billy Wagner will be the guest speaker for the Salem-Roanoke Baseball Hall of Fame's 32nd hot stove banquet and induction ceremony at the Salem Civic Center this Sunday night, February 4. The Class of '24 includes Tommy Bayrer, Larry Bowles II, Mikey O'Brien and Paul Siple.

Wagner is a 2003 inductee in the Salem-Roanoke Baseball Hall of Fame, and last week he was just five votes shy of being inducted into the Major League Baseball Hall of Fame. A 1990 graduate of Tazewell High School, he drew national attention with his mid to high 90s fastball while pitching for Ferrum College. In the 1993 draft the lefty fireballer was the first round, and 12th overall, pick of the Houston Astros. He made his Major League debut in 1995 and in '99 he was the recipient of the Rolaids Relief Award, presented to the outstanding closer in the National League. That season he had 39 saves with a 1.57 earned run average and 124 strikeouts in 74 innings.

A seven time all-star, Wagner pitched nine seasons for Houston, two for the Philadelphia Phillies, three with the New York Mets, and also had a stop in Boston before concluding his career with the Atlanta Braves in 2010, saving 37 games in his final season. Wagner finished a 16 year big league career with 422 saves while appearing in 853 games, all in relief. He struck out 1,196 batters in 903 innings and thrilled fans with a fastball that often reached the 100 mph

Bayrer is a Roanoke native and graduate of Cave Spring High School, where he was a standout outfielder. He went on to play at Campbell University and hit .415 his sophomore season before being converted to a pitcher. Throwing in the 90s with a wicked knuckle curveball, he was a 17th round draft choice of the Astros in 2001. He pitched two seasons in the minor leagues for Houston, including a stint with Martinsville in the Appalachian League.

Bowles II is a Franklin County product who was a standout pitcher and firstbaseman for Franklin County High School, graduating in 1997. He was all-state his senior year and the recipient of the Salem-Roanoke Baseball Hall of Fame Ray Bellamy Award as high school Player-of-the-Year. He went on to play at Virginia Tech, where he earned All-American honors in 1999 on the Collegiate Baseball, Baseball Writers Association and Mizuno All-American teams. Larry played for the USA National team in 1998 and was

drafted by the Anaheim Angels organization in 2000, where he played one year before his career was cut O'Brien is another former Ray Bellamy Award winner, earning Player-of-the-Year honors in 2008 after a standout career at Hidden Valley High School.

Following that season O'Brien, a righthanded pitcher,

was drafted in the ninth round by the New York He pitched professionally until 2018 with stints for the Yankees, Orioles, Reds and Rays' organizations, reaching the AAA level in three different seasons. He finished his professional career with a 3.87 ERA over 770 innings pitched, striking out an average of 7.1 batters per nine innings.

Siple, a 1938 graduate of Clifton Forge High School who died in March, 2015, was a player, teacher, coach, professional scout and umpire. A four-year letter winner as a shortstop at Bridgewater College, he competed in the National Semi-Professional playoffs in Wichita, Kansas, then played and managed in semi-pro baseball in leagues throughout Virginia. He coached high school baseball for 24 years and became a professional scout in 1960. Siple scouted for 40 years, first for the Pittsburgh Pirates, then with the Reds and the Phillies. He was also a Virginia High School League umpire for 25 years and is a member of the Bath County High School, Boys Home and Bridgewater College Halls of Fame.

Mike Ruth, owner of the Shoe Doctor and supporter and coach of the Cave Spring Little League program since 1997, will be the recipient of the Wayne LaPierre, Sr. Service Award.
