





Dear Mr. D’Orazio

For the Wood Festival colors I have chosen green and gold. Green is to represent the wealth and beauty of the trees and gold to represent the pagentry.

The following are the instructions for the actual coloring of my Wood Festival Emblem entry: The quotation is from Deuteronomy, 20:19. The central symbol is a map of calhoun county with a crown overlay in gold. The map is green. The green on the map symbolizes the wealth of trees, and the gold crown to symbolize the pagentry and the crowning of the annual Wood Festival Queen. The crown is inscribed with the year the Wood Festival began in 1962. The shield used as a backing is red, white and blue in order left to right. I chose these colors to show the influence of patriotism and the love of our country in which such a festival can thrive.



Wood Festival Committee Honors the Late Tony Morgan

CURIOSITY CORNER

Question: We have always used BC and AD to denote calendar years. Now, we commonly see BCE and CE. Why and what is the difference? (Asked by Jan Rushton, Instructor, Rock Steady Boxing Class, YMCA.)

Reply: Jan has a lot of interesting questions in class. Rock Steady Boxing (RSB) is a Parkinson's disease physical therapy program of which I am a member. We don't box each other, but punch bags and do a variety of beneficial boxing exercises.

First, let's define these acronyms.
- BC = Before Christ
- AD = Anno Domini, Latin for "Year of our Lord"
- BCE = Before Common Era
- CE = Common Era

Now a little history. In ancient times, yearly tracking was done in terms of an event or rule of an emperor. For example, the year 25 of Caesar Augustus. But as time went on, seasons and events were getting out of whack with the calendar dates. (The calendar year and astronomical year are not the same.)

Determining the date of Easter was a particular problem for the Church, and in the 6th century the Pope directed a monk to determine an exact date and method of timing. He started a movement to define yearly time as "before Christ" and "after Christ," rather than based on an emperor's rule. This set the standard for "Year of our Lord" instead of whoever the emperor happened to be. So, the origin of the monk's counting system was the birth of Christ. BC was so many years "before Christ," and AD was so many years after the birth of Christ. For example, the time from 10 BC to AD 15 would be 25 years. It took a long time for the system to catch on and we still use it today.

Now back to BCE (Before Common Era) and CE (Common Era). The specific source is not recorded, but the BCE/CE format is found in manuscripts dating back to the 1700s. Basically, this format is a nonreligious alternative to BC/AD, and is preferred in scientific and academic writings. It has increased in general use, as well. So, to answer the question of the difference in formats... basically there is none. For example, either of the following statements could be used:

- The Roman Empire lasted from 27 BC to AD 476
- The Roman Empire lasted from 27 BCE to 476 CE

(Note that AD appears before the year number in general writing.)

The formats may seem to be a little confusing at first, but to help remember you can use the words "Before" and "After." BC starts with a B like "before," and AD starts with an A like "after." Then on the common era side, BCE starts with B. So in both formats, B is before.

I hope this helps you to keep your years straight. Let's see if you got it. Is there a year 0 BC or a year 0 CE?

C.P.S. (Curious Postscript): "Don't be fooled by the calendar. There are only as many days in the year as you make use of." -Charles Richards

1923, 100 YEARS

1948, 75 YEARS

In the Golden Horseshoe test on May 3rd, 23 eighth gradestudents from the schools of Calhoun

County participated. The possible score was 185 points and the highest score made was 163. All the contestants' scores were above average which shows that West Virginia history has been taught well in the county during 1945-1946.

The highest score went to the White Pine School. The second highest to the Grantsville Graded School. Two other places were won by the students of White Pine School.

The winners are: Mary Lee Whipkey, White Pine School; Patricia Ann Hathaway, Grantsville; Gene White, White Pine; and Yvonne Whipkey, White Pine.

As a reward to the four highest point students a golden horseshoe was given. This is a pin, which is made in the shape of a horseshoe with the words "West Virginia Club" written on the outer part. In the center a seal of the State of West Virginia is placed on which is found the state motto.

The following events happened on these dates in West Virginia history.

June 8, 1893:

Entrepreneur Donald F. Duncan was born in Ohio but grew up in Huntington. Duncan founded the Duncan Yo-Yo Company and the Duncan Parking Meter Corporation.



June 9, 1927:

Karl Dewey Myers was named the state's first poet laureate by Governor Howard Mason Gore. Myers held the post for 10 years.



June 9, 1957:

T. D. Jakes was born in South Charleston. As a boy, he preached to imaginary congregations and carried a Bible to school, which earned him the nickname "Bible Boy." He is the senior pastor at the Potter's House, a nondenominational church in Dallas, Texas.



June 10, 1775:

The Berkeley County Riflemen were organized by Capt. Hugh Stephenson of Shepherdstown, in

response to a call for Revolutionary War soldiers by Gen. George Washington.

June 10, 1921:

Labor leader Daniel Vincent Maroney was born on Cabin Creek, Kanawha County. Maroney served as international president of the Amalgamated Transit Union from 1973 to 1981.

June 11, 1866:

Architect Elmer Forrest Jacobs was born in Preston County. His work can be seen particularly in downtown Morgantown, in residential South Park, and on the West Virginia University campus.

Most of his Morgantown buildings are now listed in the National Register of Historic Places.

June 12, 2006:

Robert C. Byrd became the longest-serving United States senator in history. He served in the Senate from 1959 until his death in 2010.

His record was broken in 2013, by Congressman John Dingell, a Michigan Democrat, but Byrd still retains the Senate record.




June 13, 1861:

The Second Wheeling Convention began in the federal courtroom of the Wheeling Custom House.

This convention declared the Confederate state government in Richmond illegal; created a Reorganized Government of Virginia loyal to the United States; elected Francis Pierpont governor of Virginia; and called for the western counties to be formed into a new state.

June 13, 1928:

Mathematician John Forbes Nash Jr. was born in Bluefield. In 1994, Nash was honored with the Nobel Prize in Economics. He was the subject of a best-selling biography, A Beautiful Mind, which was later made into a movie.



June 14, 1912:

Botanist Elizabeth Ann "Betty" Bartholomew was born in Wheeling. Bartholomew was instrumental in building the dried plant collection at West Virginia University from 30,000 to 140,000 specimens, and she initiated a 2,000-plant seed collection.

Michael A. Ayers-- A Calhoun Native In the Civil War

H'Qrs 11th WVa Vols
Deep Bottom Va.
March 27, 1865
My Dear Girl:

I wrote to you a letter a few days since, and stated that we expected to march the next morning. We did not leave that day, but on Saturday last we broke up camp and started on an expedition.

We went out to Long Bridge on the Chickahominy River with a pontoon train to meet Gent Sheridan's force. He however did not come that way. We came back yesterday, did not meet with any enemy while we were out, which was about ten miles.

We are now laying at Deep Bottom expecting to march or take transports. I do not know where we are going. Some think its to the left of Petersburg, it may be; the whole of the 24th Corps are under marching orders, and I presume active operations are about to commence, and that we will not be permitted to remain in camp any more except on the move.

We may possibly move this evening, if we do not I will write again tomorrow.

The weather is warm in the day, but cold and frosty at night, and it affects me a good deal, causing soreness of my throat and lungs, but I will soon get used to the change.

I would like to hear from you again and you must continue to write as usual. I will write again the first opportunity. And believe me I am still your true affectionate and loving friend.

My Dear Girl,

I write you a short note to night which will let you know, that I am well at this time and fondly hoping that this may find you enjoying the same good blessing.

We left Deep Bottom last evening and marched nearly all night, stopped about 3 o'clock this morning and lay by till 10 AM and then moved on, we are now near the extreme left of our lines, and will move on at 4 o'clock in the morning, nearly the whole of this army will be in motion, and you may expect important news from this quarter soon, and I hope I may be spared to get back safe.

If otherwise I hope you may ever cherish a kind thought for your dearest and best friend, could I leave this scene of action and fly away how soon would I exchange it all for the happy days of home life.

The above tariff is net On all current billing not paid in full within twenty (20) days, ten percent (10%) will be added to the net current amount unpaid. This delayed payment is not interest and is only to be collected once for each bill where it is appropriate.

SEWER SERVICE CHARGE

A charge of \$25.00 will be made for re-establishing a disconnected service having been cut off to collect a sewer bill.

TAP FEE

The following charges are to be made whenever the utility installs a new tap to serve an applicant:
A tap fee of \$300.00 will be charged customers who apply for service outside of a certificate proceeding before the Commission for each new tap to the system.





Creston continues to have dry weather which one might consider the start of a drought with dry weather showers.

The rain in Creston Saturday evening did not settle the dust. Hay harvest both locally and elsewhere is going well and some suggest that even abandoned fields need to be harvested for it might be such a thing that many will have to feed hay this summer as pastures dry up.

Kathleen Cervone went up in Ohio to visit her sister who is undergoing chemotherapy.

Levi Jordan Ferrell, age 29, passed away. He was the son of Christie and the late Albert "Bub" Ferrell.

Charles Edward Postalwait, age 83, of Reedy passed away. His mother Mabel Molloyhan Postalwait Courtney Justice formerly lived in Creston as did his grandfather Lanty Molloyhan and other family members. He was a door gunner on helicopters in Vietnam "tossing warm metal" at some of Jane Fonda's "friends".

Local folks were calling on John Bingman and Florence Sandy, both of whom are at Worthington on 36th Street in Parkersburg.

The facility at Willow Island in Pleasants County is now "on idle" as a local up there noted. It is "not shut down" while the present owner "looks for a buyer".

One needs to make sure that the home generator works and that the natural gas system is up and working. Gravity flow water systems don't need electric and wood stoves and Rumford fire places work well when there is no electric.

Hope Gas, part of the John D. Rockefeller empire, announced that the firm has purchased 900 miles of pipeline

from Equitrans (EQT). Mother Hope CEO Morgan O'Brien noted that many of their existing supply wells "were at the end of their productive lives" and that now they had access to more wells. He also noted that the pipelines were old and needed to be replaced and such would provide employment for 400 men for a few years.

The company also purchased Peoples Natural Gas & Southern Public Service Company. He hoped that the improvements would bring more natural gas customers and cause the drilling of more gas wells to supply the need.

It was reported that Ireland plans to kill 200,000 cattle to "save the planet" but no concerns about what folks there are to eat. Humans can't eat grass but ruminants can take grass, corn stalks and hay and convert it into meat, milk, butter, cheese, whey, hides, etc.

This isn't a first. Back during Roosevelt's "New Deal" farmers were told to kill all the little pigs and then farmers would have more money as pork prices would go up. They also had no hogs to sell to generate cash. The federal government is still going after farmers as polluters.

One is reminded of what Al Gore Jr. said when he was VP. "To end pollution we (America) should get all our food from third world countries." The Henry Hub (Louisiana) price of natural gas is \$2.17 while gas produced on Owl Hill sold for less than a dollar. Local Pennsylvania grade crude fetched \$70.74/bbl. with condensate, formerly called Appalachian Light Sweet was \$54.74/bbl. Marcellus & Utica light brought \$61/74 & medium \$70.74/bbl.

Almost forgot to mention the following: The comely Hadley Propst who is a regular caller in Creston was named Little Miss Woodchuck as part of the Wood Festival.

As they say, "Goin' up the holler, whistle up the dogs, we're gonna go catch us a ground hog - ground hog. . . ."

Food For Thought

This week it's two of my favorite vegetables – broccoli and cauliflower my third one would be tomatoes, yeah – yeah it's not a fruit.

I don't put fruit in my chili. Some people like raw broccoli and cauliflower but I like mine cooked.

There are a few ways to fix raw broccoli. Salads come to mind. If it's for a gathering or a large family I would use 2 large bunches of broccoli.

If it's for a salad added to a meal for a family use 1 bunch. Make sure that you wash it thoroughly. Don't forget to peel the tough outer layer off the stem.

Cut the broccoli in small pieces and toss it with some cut up extra sharp, cheddar cheese cubes.

While you are doing that some bacon should be frying and you should be dicing red onion.

When the bacon is crispy, drain on a paper towel, cool and crumble into broccoli, cheese. Add the onion and toss. Adjust how much bacon, cheese and onion you need for the salad size.

The dressing is up to you. How about the same one you use for wilted lettuce. Bacon grease, water, sugar and vinegar, or try mayonnaise, so sugar and white vinegar mixed to your taste.

For a variation of the salad use hard boiled

eggs, cheese, crispy bacon and green onions all chopped and tossed together. Dressing is your choice.

I like my broccoli and cauliflower cooked. I also like them both with cheese sauce. Cheese sauce is so easy.

Just melt 3 tablespoons of real butter in a double boiler or a plain pan. Keep the heat low so it doesn't burn. Slowly add all-purpose flour stirring constantly.

When it looks like paste then start to add milk, keep stirring to get rid of any lumps. I use a small block of extra sharp cheddar cheese.

If it gets too thick stir in more milk. You may adjust how much cheese you want for your taste.

I like broccoli and cauliflower together but I cook them separate and mix them after I drain them. I either pour cheese sauce over them or just add butter, salt and pepper.

Now for cauliflower after you cook it or steam it and drain it, put it in a skillet that has butter melting over on a low heat.

Sprinkle some Italian bread crumbs on it and stir it until it's just lightly browned.

It's really good. For broccoli or cauliflower casserole or the two


together cook until tender and drain.

The water goes in the chicken mash. Combine 1 can of cream of mushroom or cream of chicken soup, 1 cup of mayonnaise, 1 small onion (chopped up), 2 eggs and mix thoroughly.

Pour over the vegetables of your choice in a casserole dish, that is lightly greased with butter. Bake at 350 for 1 hour.

Next week is cabbage. Yummmmy!

Gov. Justice Announces Free Fishing Weekend June 10-11

CHARLESTON, WV — Gov. Jim Justice announced today that West Virginia's Free Fishing Weekend will return June 10-11, 2023, and encouraged anglers and their families to plan a trip.

West Virginia's Free Fishing Weekend is part of a nationwide effort to make fishing more accessible to the public.

During these two days, residents and nonresidents are able to fish for free in West Virginia's public lakes, streams, and rivers without having to buy a license.

"As a lifelong angler, I know firsthand that fishing in West Virginia

is one of the most joyous things you can do in this world," Gov. Justice said. "I want to encourage everyone to take advantage of this opportunity to try fishing out or to introduce someone you know to the sport we all love so much."

West Virginia's Free Fishing Weekend isn't limited to giving new anglers a chance to try the sport out.

People who have fished in the past but haven't renewed their license in years are encouraged to participate.

"Whether you're a seasoned angler or a beginner, our Free Fishing Weekend is a great time to cast a line and have some fun," WVDNR Director Brett McMillion said. "We hope this event will encourage people to try fishing for the first time

or to rekindle their love for the sport."

As part of Free Fishing Weekend, the WVDNR will host its annual fishing derby for kids at Little Beaver State Park on June 10. The event gives children an opportunity to receive basic fishing instruction and to enjoy time outdoors with friends and family.

The event is free to attend, but anglers will need to register to participate. Registration will take place on-site from 9-10:30 a.m. on the day of the derby.

Gov. Justice: W. Va. breaks all-time state record for revenue collections through May

CHARLESTON, WV – Gov. Jim Justice announced on that, 11 months through Fiscal Year 2023, year-to-date collections of more than \$5.9 billion are a record \$1.72 billion above the YTD estimate and 12.9% ahead of last year, breaking the all-time state record for total collections and total YTD surplus through the month of May.

"This is another historic accomplishment – setting all-time records for total collections and total surplus in state history," Gov. Justice said. "I am beyond proud of the hardworking West Virginians who made these numbers possible, and of all the companies far and wide who have invested in W.Va., providing good-paying jobs for our people. We're blessed beyond belief in our state, and it's a testament to the world continuing to realize that W.Va. is the true diamond in the rough that they all missed."

"This incredible surplus will allow us to continue making wise investments in our roads, schools, water systems, broadband, economic development, and much more. All West Virginians will see the benefit of these dollars, and should be incredibly proud of this accomplishment today."

West Virginia's General Revenue collections for May 2023 came in at \$134.5 million over estimate.

The following is a summary of the four major components that accounted for 92% of the year-to-date surplus and 85% of the year-to-date 12.9% revenue gain.

May Personal Income Tax collections totaled more than \$185.5 million. Collections exceeded the monthly estimate by \$43.1 million. Record year-to-date collections of more than \$2.463 billion were \$482.6 million above the official estimate and 8.5% ahead of prior year receipts.

Consumer Sales Tax collections of \$155.0 million were \$16.2 million above estimate in May and 2.8% ahead of prior May collections. Cumulative collections of more than \$1.553 billion were \$205.8 million above the official estimate and 6.2% ahead of last year.

Corporation Net Income Tax collections totaled nearly \$14.0 million in May. Monthly collections were nearly \$11.0 million above estimate. Year-to-date collections of \$344.8 million were \$216.8

million above the official estimate and 17.0% ahead of prior year-to-date collections.

May General Revenue Fund Severance Tax collections totaled nearly \$67.9 million. Monthly collections exceeded the official estimate by nearly \$47.9 million. Record year-to-date general revenue fund severance tax collections of \$890.4 million were 37.4% ahead of last year and \$670.4 million above the official estimate.

Under Gov. Justice's leadership, W.Va. continues to enjoy an unprecedented era of success and prosperity.

After inheriting a \$500 million budget deficit, Gov. Justice has led the state to a string of consistent budget surpluses by using his lifelong experience as a businessman to make W.Va. a more business-friendly state and by standing behind the energy industry.

Earlier this year, he signed into law the largest tax cut in state history, returning over \$750 million to hardworking West Virginians through income tax reductions, with triggers built in for more cuts in the future.

At the same time, W.Va. has achieved record-low unemployment rates. The state's seasonally adjusted unemployment rate decreased to 3.3% for April 2023, notching below the national rate.

West Virginia is finally competing on the world stage and recruiting world-class companies to our state as shown in several major economic development announcements. Nucor Corporation announced that they selected Mason County as the location for a state-of-the-art sheet steel mill. This record investment will exceed \$2.7 billion, making it the largest in West Virginia history, as well as the largest single investment Nucor has ever made.

GreenPower Motor Company announced an agreement with the state to manufacture zero-emission, all-electric school buses in South Charleston, bringing hundreds of new jobs and millions of dollars in economic impact to West Virginia. Owens & Minor, a Fortune 500 company that provides medical supplies, is going to expand on a deal they previously had with WVU Medicine and create over 125 jobs at a healthcare products preparedness and supply center in Morgantown. Omnis

Building Technologies will build a \$40 million, 150,000-square-foot facility in Bluefield to manufacture housing materials that will revolutionize the future of residential construction, creating 150-300 jobs in the process. Klöckner Pentaplast has announced a multimillion-dollar expansion of their West Virginia facility. PepsiCo is building a pair of new distribution facilities this year, representing a combined \$32.5 million investment, while providing 185 jobs in W.Va. Veloxint, a manufacturer of nanocrystalline metal alloys, is moving to Touchstone Research Laboratory Ltd. in Triadelphia and is expected to create another 200-300 new jobs over the next four years.

Meanwhile, the Governor's Roads To Prosperity program is the state's largest-ever investment in road maintenance and improvement; after 50 years of neglecting its roads, the state has committed more than \$2 billion dollars to fixing them. Teachers and state employees have received four of the largest pay raises ever. Thanks to Gov. Justice, Veterans with military pensions now live in West Virginia tax-free and senior citizens do not face state taxes on social security. The Governor has also led West Virginia through a once-in-a-century pandemic, protecting the state's most vulnerable citizens.

People are more excited than ever to be in West Virginia. From April 2010 to July 2019, more than 43,000 people moved out of the state. However, from 2020 through 2021, net migration is up in West Virginia for the first time in decades, with over 2,000 people moving into the state, making West Virginia one of the top states in the entire nation that people are moving into on a percentage basis.

Increased investments in the state's tourism efforts have visitation and intrigue in W.Va. through the roof. West Virginia was recently named a top-10 travel region in the world to visit by Lonely Planet; the only state to earn this prestigious distinction and the state was also recently selected as one of the Best Places to Go by Condé Nast Traveler. W.Va. was also recently named as the best family trip in the U.S. by Outside Magazine.

How a Rate Case Works

With several rate cases pending before the Public Service Commission (PSC) this year, I thought

it might be helpful to explain what happens when a utility applies for a rate increase.

The original rate case filing consists of testimony from utility officials and documentation to justify the amount requested. That information includes an accounting of money the utility hopes to recoup and the estimated cost of future projects.

The Commission orders the utility to publish a legal notice stating the proposed new charges. It then issues an order that suspends the proposed rates until a certain date, so the utility cannot change its rates until the Commission rules on the case. The case must be decided by that date.

As soon as the case

is filed, Commission staff begins to audit the information provided. PSC staff includes accountants, engineers and attorneys who have specialized knowledge of the ratemaking process. Engineers assess whether proposed projects are viable and review completed projects and works in progress. Our accountants, who we refer to as utilities analysts, closely examine the utility's reported costs and projections. They analyze whether any reported under- or over-recovery of revenue is accurate. Once the audit is complete, staff files their recommendations to the Commission.

Meanwhile, the Commission and other parties begin reviewing all of the materials filed. Staff, the Consumer Advocate Division and other intervenors ask the utility for more information and those questions and answers are reviewed by all of the parties. In some

cases a settlement may be proposed and considered.

During this phase of the process, the Commission draws up a procedural schedule and arranges the time and place for any public comment hearings. Throughout the process, we receive and read written and online comments from the public.

Finally, an evidentiary hearing is held. All the evidence is entered into the record and the witnesses for the utility and the other parties are questioned and cross-examined.

After all the information is received, the Commission analyzes all of the testimony, staff recommendations, and public comments. We discuss all possible solutions and finally make a decision that is set forth in our Final Order. If the rates change, the utility files a new tariff and the new rates go into effect.

Gov. Justice authorizes W.Va. National Guard deployment to Southern Border

CHARLESTON, WV – Gov. Jim Justice announced May 31st, that he has approved up to 50 West Virginia National Guard (WVNG) Soldiers and Airmen to deploy to Texas for up to 30 days to support Operation Lone Star (OLS) as a part of an Emergency Management Assistance Compact (EMAC) from Texas.

"In response to a letter requesting aid from Texas Governor Greg Abbott, I have approved the deployment of members of the West Virginia National Guard to help secure our border, reduce the flood of fentanyl, and combat the human trafficking crisis. Several governors are

doing this because the situation on our Southern Border is terrible, and I want to make sure we're doing our part. So, I'm very proud to support our friends to the south. I know our National Guard will do incredible work, and we'll wish them Godspeed to get home safe and sound. I thank them all for their incredible bravery and for stepping up yet again to answer the call."

The WVNG members will work alongside the Texas National Guard and Texas law enforcement partners to detect, deter, and interdict transnational criminal activity between points of entry. In coordination with the Texas National

Guard, the WVNG will send the personnel in August and they will fall under operational control of the Texas National Guard Joint Task Force for OLS.

The Soldiers and Airmen are all volunteers. No units are being mobilized for this support.

Earlier this month, Texas Governor Greg Abbott sent a letter to the Governor requesting support in responding to the ongoing border crisis through the Emergency Management Assistance Compact, which enables states to provide assistance and share resources with another state in response to a disaster or emergency.

Capito Statement on Vote to Pass Fiscal Responsibility Act, Preventing Default

WASHINGTON, D.C. – U.S. Senator Shelley Moore Capito (R-W.Va.) tonight released the below statement after voting to pass the Fiscal Responsibility Act. The legislation, which passed the Senate on a bipartisan vote, will prevent the U.S. government from defaulting on its debt, cut unnecessary government spending, complete the Mountain Valley Pipeline, and implement permitting reforms.

"I am very glad we did the responsible thing and took action to prevent our nation from facing default. In doing so, we were also able to advance policies, including SNAP work requirements, clawing back unspent COVID funds, and the cut to the IRS budget, which are all responsible and necessary actions good for W.Va. and the entire country. This package also includes a provision to expedite the completion

of the Mountain Valley Pipeline, something I personally fought to include, as well as language to help streamline projects and make it easier to build in America— another area I have advocated for and worked on for years. This effort was truly a bipartisan one and demonstrates that Congress, as a whole, can work together to avoid default, which was the ultimate goal."

Crystal Mersh grew up in Calhoun County and says her whole experience of growing up there is exactly what led her back. In fact, she lived all over the world and, 40 years later, decided it was time to come home and invest in the county that helped her develop and grow.

Mersh's first job was with Mylan Pharmaceuticals, and she chose to grow her career in that field. After 26 years in the corporate

world, 10 years ago, it will be self-funding with vacation rentals, management consulting retail and office spaces firm. She formed the West Virginia-based American Medicines Company, where she focuses on bringing generic medicines back to the U.S. for manufacturing.

"I have a passion for the underdog, and anything I sink my teeth into is related to that," Mersh says. "If I see something that's wrong, that needs to be fixed, I am in there to fix it."

Mersh is also the president of the 1982 Foundation—a nonprofit in Calhoun County working to convert the old high school into a self-funded, mixed-use space for everyone.

"Our plans there are to take this beautiful 100-year-old building and turn it into a community center." She says it will have a daycare facility, fitness center, and commercial kitchen, and

Possibilitarian Crystal Mersh—Creating a Hub for Her Community

All it takes is a kernel of an idea. From there, a Possibilitarian can turn frustration to hope, stagnation to vitality, "Why bother?" to "How can I help?"

That's what you'll see in these stories: West Virginians whose love for their communities turns out to be fertile ground where ideas sprout, thrive, and fertilize the imaginations of those around them. Sometimes to their own surprise, their purposeful action is catalyzing lasting change.

Crystal Mersh left Calhoun County after graduating from high school in 1982. She traveled the world, made her home in many different places, and cultivated a long career in the pharmaceutical industry. She eventually started her own company, which grew rapidly.

But Mersh never forgot her Calhoun County roots. So, in 2021, she and her family started the 1982 Foundation to give back to the community that made her what she is. Its first project? Purchasing and transforming the old Calhoun County High School—a beautiful building that has long sat vacant—into a community center for all to enjoy. "The school was the lightning bolt for everything we're doing," Mersh says.

As the 1982 Foundation's website reminds visitors, when rural high schools close due to drops in the local population, the folks who remain don't just

lose a school—they lose an essential hub where they once could gather, socialize, host programs, and more. Mersh and the 1982 Foundation, with the help of outside funding they're securing through donations and grants, aim to revitalize the school and return it to the community as a mixed-use space boasting eateries, Airbnb rentals, office spaces, a children's learning center, a fitness center, and even a swimming pool.

Mersh started a Facebook page in the early stages of planning to learn what the community could really use. "I wanted to listen to people," she says. "I just asked questions, you know? What's going good here? And what's not so good?" She says she consistently heard that things in Calhoun County were stagnant because residents were "apathetic," but that didn't sit right with her. "The people I know from this county were anything but apathetic," she continues. "They were grounded in right and wrong, they had extremely strong work ethics, they were intelligent. And so the apathetic thing didn't square with me. And the more I talked to people, it became obvious that it wasn't apathy, but they had lost their hope. They still cared, but they had lost their hope."

That dialogue led to a plan for a community center that is carefully designed to be self-sufficient, to cater to the needs the community members themselves are voicing, and to be a

haven for generations to come. Mersh hopes that the revitalization of the school, with construction beginning this spring, will be a spark of inspiration that people can place their hope in and build upon in the future. It appears to be working: Since the foundation's inception, its volunteer base has reached around 150 people, all looking to make their home a bit brighter for themselves and their neighbors.

Mersh has other big hopes for Calhoun County as a whole as well, believing it can be a hub for business, recreation, and more. "Building a building is the easy part," she says. "It's about revitalizing this community back to what it was, so that the children can stay here when they graduate or come back from college if they want to stay here." The new building may not be the be-all and end-all of a total county transformation, but it is the first step in reminding the community what it's capable of when its members come together for a cause. "We've really got a lot of people excited and energized and doing the work," she says. "We're steadily getting there."

Mersh's leadership has given this project life, but it means just as much to her to be able to come together with friends new and old to achieve a common goal in the place where they all grew up. "No matter where I've lived, when people ask me where my home is, I always say West Virginia," Mersh says. "This will always be home to me."

Free Cybersecurity Workforce Training Planned at GSU

GLENVILLE, WV – Glenville State University is planning a free cybersecurity training through a joint effort with the Appalachian Regional Commission (ARC) in the form of a Partnerships for Opportunity and Workforce and Economic Revitalization (POWER) grant for Glenville State’s Cybersecurity and Safety Workforce Development Initiative. The Initiative aims to create a more vibrant economic future for West Virginia’s coal-impacted North Central region. Job demand for employees with cybersecurity skills, in West Virginia and the United States, has seen a swift climb in recent years and the trend is projected to continue.

Currently, a class for CompTIA Network+ is scheduled at Glenville State University and will take place Saturday, June 24, Sunday, June 25, and Saturday, July 1. The free course is for those who want to design and implement functional networks; configure and manage essential network devices; create resilient networks; and implement

network security, standards, and protocols. No prerequisites are required. The course will be held from 9:00 a.m. – 5:00 p.m. each day. Seating is limited.

“Our POWER grant with ARC allows for the development of free boot camps, and will provide each participant with all the training materials, study guides, and exams at no cost. Counties in North Central West Virginia that are defined as ‘distressed or ‘at-risk’ have a unique opportunity to receive training and eventual certification in cybersecurity-related fields. We are making strong efforts to bring the training to the people in these counties,” said Peggy Runyon, Glenville State’s Project Director for the Initiative. “This training would cost several thousand dollars if you were paying for it out of pocket, so I sincerely encourage individuals to take advantage of this exclusive opportunity.”

West Virginia counties defined as ‘distressed’ or ‘at-risk’ include Barbour, Braxton, Calhoun,

Clay, Doddridge, Fayette, Gilmer, Grant, Greenbrier, Harrison, Lewis, Mercer, Nicholas, Pocahontas, Ritchie, Roane, Summers, Tucker, Upshur, Webster, and Wirt. Other WV counties will be considered as well.


