





This Week In Calhoun History

The following reports are taken from the Calhoun Chronicle Archives.

1923, 100 YEARS: (Contributed) The Minnora "Braves" and the Wayne White Sox met again on the field of the battle Oct. 12th. Charles Chenoweth renown twirler for the Braves failed to execute properly on account of nervous disability. The Braves went away on the former meet singing the old time jubile and Yankee Doodle; but Friday, October 12th at 4 p.m. found them with eyes blared, leads drooped and hardly able to locomote. The score stood 9 to 5 in favor of the White Sox and all on account og the marvelous fade-aways and ocean waves pitched by the veteran twirler Rhinehart. The main feature of the game was the argument between the much beloved empires, Professors, Hamrick and Bailey. At one time the excitement ran so high that many of the spectators were on the verge of hysterics, but the excitement gradually receeded and the game went on. Nineteen of the Braves laid the paddle and two of their 5 scores were made on errors. We feel sorry for the poor "Braves" and extend to them our heartfelt sympathy and we truly hope they will recuperate and be in first class condition for their game, November 2nd.

Mr. Gunn is no stranger in the merchandise business here, having owned the same store a few years ago until forced to retire from the same account of ill health. He is an obliging and courteous merchant and there is no doubt of his ability to hold his trade and gain new customers. Mr. McDonald has not announced his plans for the future but it is hoped that he will not move away from Grantsville.

1948, 75 YEARS: Three Local Doctors Nationally Recognized: The three physicians at the Boling clinic, Drs. T. R. and J.S. Boling and Dr Ralph Frazier, have been made charter members of the newly organized American Academy of General Practice. This is a single honor as there were only 14 doctors in the state so honored.

One of the three, Dr. T. R. Boling, was selected a few months ago by the National Academy to organize the general practitioners of the State of West Virginia. This is a rapid growing organization in the country, there being 7,000 members belonging to the organization. The standards to be met are high and the physicians accepted must be well trained and of good character and maintain contact with scientific advances in the field of medicine and must do certain required post graduate work each year.

Oct. 19, 1894: Historian and illustrator Julius Allan DeGruyter was born in Charleston. A self-taught painter and illustrator, DeGruyter's art appeared in numerous exhibits and is represented in the collections of the State Museum. The artwork includes scenes of early Charleston.



Oct. 20, 1990: The current USS West Virginia (SSBN-736) was commissioned.

The USS West Virginia is an Ohio Class Trident ballistic missile submarine that is 560 feet long, 42 feet wide, and displaces 18,750 tons when submerged.

Oct. 21, 1865: Bishop Matthew Wesley Clair Sr. was born in Union.

He was one of the first African-Americans elected as a bishop in the predominantly white Methodist Episcopal Church.






Oct. 21, 1918: Hulett Smith was born in Beckley. In the 1964 gubernatorial primary Smith carried 53 of the state's 55 counties, receiving more votes than his three opponents combined.

Oct. 22, 1693: Lord Thomas Fairfax was born in Kent, England. He inherited five million acres in Virginia, land that included much of present West Virginia's Eastern Panhandle.

Oct. 22, 1734: Frontiersman Daniel Boone was born in Pennsylvania.

In 1788, Boone and his family settled near the mouth of the Kanawha River at Point Pleasant.

He represented Kanawha County in the Virginia General Assembly in 1791.



Oct. 22, 1821: Collis P. Huntington was born in Harwinton, Connecticut.

In 1869, untington purchased the Chesapeake & Ohio Railway and set about extending its tracks from Richmond across southern West Virginia to the Ohio River.

There, in 1871, he established a new city bearing his name.

Oct. 22, 1977: Construction of the New River Gorge Bridge was completed after three years of work. Fayette County's New River Gorge Bridge is one of West Virginia's best-known landmarks. It is the third-highest bridge in the United States and third-longest steel span in the Western Hemisphere.





CURIOSITY CORNER by Dr. Jerry D. Wilson, Emeritus Professor of Physics, Lander University



Often, I'm asked about the meanings of words and phrases. The questions are genuine, and the definitions and origins are interesting. Yet, on their own, they're too short to make up a full column. Last week, I began grouping these shorter ones together. Here's Part II of "Miscellaneous Meanings!"

Half empty and half full. Don't these mean the same thing? If you say so, but you are playing with an oxymoron... figures of speech that have seemingly self-contradictory effect, like "cruel kindness." A container can't be empty and still have something in it. So, to be correct, you could say that the container is "half empty." Or, one might say "half full." Sure, we use these terms understanding them to mean that the container is, more or less, at half of its holding capacity. But think about that phrase. It's sort of like saying "half dead."

Hysteria and hysterectomy. Are these terms related? As a matter of fact, they are related in as much as both are derived from the Greek hystera, meaning "womb." So as the name implies, a hysterectomy is the surgical removal of the womb. There was an outdated (and sexist) belief that the womb was an unfixed organ in the abdomen. When moving about, it would upset women and produced hysteria. Since men don't have wombs, their tantrums were not thought to be hysterical, but just displays of "manly" character.

Italics in the Bible (KJV). These aren't used for emphasis, but to indicate that words were inserted by the translators in order to make meanings clearer. See I Kings 13:27. "And he spake to him saying, Saddle me the ass. And they saddled him." (To give "him" emphasis might be a bit misleading for a modern reader as to whom was saddled.)

Coffee break and coffee "klatch." What's the difference? Well, there are some implications, other than cream and sugar. A "break" implies an interruption from work... a period of semi-relaxation where you get caffeinated up for the next stint of work. Of course, there may be a bit of conversation along with this and the break might be extended. The "klatch" in coffee klatch comes from the German word "klatch," which means gossip... gab fest. The German klatchen means to "chatterbox." So, you get the gist. I guess you could have a "coffee klatch break." I don't know - I don't drink coffee. I tried it once when I was young, and then again 25 years later (to re-enforce the memory that it tasted terrible even with all the additives). But, I know about your coffee addicts... my wife is one!

Lazy Susan. This is a revolving stand with travs for food and snacks. Basically, "Susan" was once the general name for a maid, like "Jeeves" being a general name for butler. Take your choice, but they are quite convenient gadgets that have been applied to a bunch of other applications.

Lukewarm. Not too hot, not too cold. But, why Luke? The term doesn't have anything to do with a person, like "Cool Hand Luke," but "luke," or "lewk," originally meant "tepid." Here's a biblical reference, Revelation 3:15-16 (KJV): "I know thy works, that thou art neither cold nor hot: I would thou wert cold or hot. 

After World War II my Mom's two brothers had Whitworth Farms in Florida There were three planting seasons, any one of which or all three could be wiped our in one hurricane. We were just as aware of the weather in Florida as of the weather here in West Virginia. Being a slow starter, three chances sounds good to me. People have crop insurance now. It replaces the expense - it doesn't replace the crop! In a storm recently some local farm gardens were flooded out. Till then it seemed many had an abundance of produce, especially tomatoes. Home grown eggs increased as the store prices rose The generosity of others was a special blessing as usual.

The last garden Mom planted was at the east end of her house catching the best sun and shielded from the worst heat. Actually she sat in a lawn chair and directed the operation. Toward the end of the season she was in physical therapy for a month. I felt like the deer were peeking around the corner of the house to supper at Roane General with Mom. There was less and less garden every day. This year it took forever, one quart at a time, to fill the planters on my deck. The planters have side doors so my plan was one baking potato, one sweet potato and one peanut. Proverbs 16:9 says "A man's heart deviseth his way but the Lord directed his steps." So much for my plan. The sweet potato slip wasn't ready so I planted two baking potatoes and onions. Onions always do well. By the time the third planter was filled – one quart at a time - I found some strips of wood eight feet long and set my hopes on at lest having a chance for Scarlet Runner beans to bloom – just bloom. Meanwhile the potato plant was beautifully shaped because the wind blew-it east and the sun drew it west. The large white bloom had yellow centers and eventually produced 3 seed pods.

The colony will be healthier and no longer producing unwanted kittens. At 4 months old a female kitten can start breeding, and can have 2 or 3 litters per year.

A mother cat nursing a litter of kittens goes back into heat when the kittens are only 3-4 weeks old.

Removing cats from an area (catching and killing) is useless.

When cats are removed from an area, then new, unsterilized cats move in to take advantage of available resources - and begin reproducing.

This welldocumented natural trend is known as the "vacuum effect."

Trap-Neuter-Return stops the breeding cycle and eliminates mating behaviors, such as spraying, yowling, roaming, and fighting. Trap-Neuter-Return also benefits public health because community cats are vaccinated against rabies.







Public Service Commission of W.Va: Natural gas heating prices to fall this winter CHARLESTON, WV – Most West Virginians who heat their homes with

natural gas will see lower gas bills this winter. The Public Service Commission has issued its rulings on how much the various natural gas utilities may charge to purchase gas for this heating season.

Each year, natural gas utilities must file purchased gas adjustment cases (PGA) with the Commission, indicating how much they anticipate they will pay for gas in the coming year. The price utilities pay their suppliers is not regulated by the Commission nor the federal government. Rather, it is determined by the market. The Commission reviews the amounts requested and often adjusts the amount it will permit the companies to charge their customers.

The purchased gas component typically makes up less than half of the total amount of a residential gas bill. Last year, however, the market was particularly volatile, which resulted in a significant increase in the purchased gas component of residential bills.

This year, the market has begun to settle and the prices requested have decreased. The amount approved for Mountaineer Gas is down by almost 20 percent, and Hope Gas saw a decrease of nearly 40 percent for their respective PGAs. Those two companies serve almost 89 percent of gas customers in the state. Of the 12 gas utilities in the state, only Peoples Gas and Standard Gas requested increases in their PGAs. Across the board, the average amount requested decreased by 11.30 percent, while the average amount granted decreased by 19.29 percent.

"It is gratifying to see the wholesale prices coming down this year," said PSC Chairman Charlotte Lane. "I know this will make a big difference to West Virginia families this winter, and that means a lot."

From The Office of WV Secretary of State **Mac Warner October is Domestic Violence Awareness** Month

by Chuck Flannery, WVSOS Chief Deputy Secretary & Chief of Staff Each year, the month of October sheds light on a reprehensible truth we continue to face, as many Americans are no strangers to domestic violence. According to the National Resource Center on Domestic Violence, one in four women and one in nine men have experienced domestic violence in their lifetime. Many times, the first abuse experience happens before the age of 18. It is a horrible reality. While law enforcement should always be the first point of contact for victims in danger, there are measures state government can take to prevent abuse from happening. Individual efforts can become even more impactful when combined with others as part of a team. The Secretary of State's Office facilitates the West Virginia Address Confidentiality Program (ACP). The ACP provides a substitute mailing address and mail-forwarding service to survivors attempting to escape from domestic violence, sexual assault, stalking, or human trafficking. Participants are able to conduct business with government agencies and other entities without having to risk disclosing their physical address, which helps prevent abusers from using public records to locate their victims. The ACP is not a crisis center or direct service agency. It works by teaming up domestic violence and sexual assault programs throughout the state. Advocates who work in the programs can voluntarily register with the Secretary of State's office as an application assistant, who assesses the benefits of the ACP for their clients' overall safety plan. When it fits, it can be an important tool. Once enrolled in the program, a survivor can use the substitute address to do things like apply for and receive child support, enroll their children in public school, get a West Virginia driver's license or ID card, and vote. When it comes to utilizing some of these services, it once again becomes a team effort. It requires cooperative support from other agencies, the schools, the DMV, and the county clerks. Each of us plays a role in the safety of a survivor. A program participant once shared a harrowing experience she had with a member of our office. She was on her way home from work and needed to make a quick stop at the grocery store before picking up her children. At a distance, she thought she saw her abuser. She immediately panicked. Her legs felt weak, but she slowly backed up and left the store. She said she was glad she did not have her children with her, because she didn't want them to see her fear. She was never sure if the person she saw was her abuser. Most of us take for granted the ability to do routine tasks without incident. This keeps me mindful that there are people living in fear of being found on a daily basis. There are simple things we can all do to make a difference. Some tips from the National Resource Center on Domestic Violence include providing nonjudgmental support to a friend or family member who is being abused, listening to them, letting them know the abuse is not their fault; supporting your local domestic violence program with donations of financial support or volunteer time; speak up about abuse; and educate yourself and others. Each small effort will add to the greater good. Please join me and the Secretary of State, Mac Warner, in recognition of Domestic Violence Awareness Month this October. Show support to a survivor in whatever way you can. I would also like to express appreciation for the dedication and tireless efforts of the staff and volunteers at the domestic violence and sexual assault programs in West Virginia. CHARLESTON - West Virginia Attorney General Patrick Morrisey on Monday filed his office's objection to the 15% attorneys' fees adopted by the Mass Litigation Panel based on the recommendation by the commissioner of the Common Benefit Fund in the state's opioid litigation.

So far, opioid settlements are currently \$940,386,000, but may very well exceed \$1 billion with the resolution of the remaining matters currently in bankruptcy courts. The combined effort of the Attorney General's Office, the cities and counties in West Virginia resulted in the highest opioid settlements per capita in the country.

The attorney general raised "serious concerns" on the amount, writing in the objection, "While we believe that a substantial amount of time, effort, and work by numerous firms has led to the recovery in these matters, the payment of 15% of the gross settlement amounts in attorney fees is not appropriate in this matter."

The matter was filed in the Kanawha County Circuit Court.

"I am troubled by the aggregate amount of attorneys' fees that will be paid from the settlements, which includes cities and counties," Attorney General Morrisey said. "It was my hope that the people of West Virginia would benefit from the money we were able to save by negotiating for lower fees.

"Unfortunately, by awarding fees totaling 15% of the settlements, the full value of those negotiations will not be realized."

From the beginning of the opioid litigation, Attorney General Morrisey was concerned with the amount of hard-earned settlement money that would fall into the hands of the attorneys. That is why the office negotiated with its outside counsel for a contingency fee far below the standard set forth in W.Va. Code §5-3-3a for all work performed for the state.

That negotiated number is 7.76%--the state negotiated one of the lowest (if not the lowest) attorneys' fees in the nation.

The 15% would place the attorneys' fees at \$141,057,900. That figure may balloon to more than \$150 million under the current recommendation.

That amount does not include the additional Multi District Litigation (MDL) assessment of 7.5% of the \$400 million aggregate settlement reached with the distributors. Taken together, the real amount being paid in fees and costs for the state's opioid litigation becomes \$171,057,900 (18.2%).

"Such an amount is wildly excessive and will directly reduce the amount of money that can be used to save people's lives," according to the Attorney General's objection.

The Attorney General's Office has consistently pushed for an amount of attorney fees well below the 15% that is now being recommended, an amount far more consistent with the negotiated contract with our outside counsel.

DHHR Secures Federal Funding for Mental Health and Substance Use Services

CHARLESTON, W.Va. – The West Virginia Department of Human Resources (DHHR), Bureau for Behavioral Health (BBH) was awarded more than \$33 million in federal funding from the Substance Abuse and Mental Health Services Administration (SAMHSA) to sustain or enhance mental health and substance use prevention, early intervention, treatment, and recovery services for West Virginians of all ages.

"BBH and its partners are seizing every opportunity to meet our state's behavioral health needs," said Dawn Cottingham-Frohna, Commissioner for DHHR's Bureau for Behavioral Health. "With this funding, we are not only addressing the immediate needs of our communities but also investing in the long-term well-being of West Virginians."

The Promoting the Integration of Primary and Behavioral Health Care grant will provide \$1,678,044 annually over five years to serve adults with serious mental illness who have co-occurring physical health conditions or chronic diseases and adults with a substance use disorder (SUD). Three provider partner agencies have been identified to work on this project including Seneca Health Services Inc., Southern Highlands Community Behavioral Health Center, and United Summit Center, covering 16 counties in the state.

The First Responders – Comprehensive Addiction and Recovery Act Grant will provide \$800,000 annually for four years to build upon the Police and Peers (PNP) program implemented by DHHR's Office of Drug Control Policy (ODCP). The activities will be administered by the Bluefield Police Department, Fayetteville Police Department, and the Logan County Sheriff's Office in collaboration with Southern Highlands Community Mental Health Center, Fayette County Health Department, and Logan County Health Department.

The Projects for Assistance in Transition from Homelessness grant will distribute \$300,000 annually for two years to support the system of care for adults in West Virginia and promote access to permanent housing and referral to mental health, substance abuse treatment, and health care services. Grantees are located in areas of the state with the most need, based on the population of individuals experiencing homelessness, including the Greater Wheeling Coalition for the Homeless, Prestera Center, Raleigh County Community Action, the West Virginia Coalition to End Homelessness, and Westbrook Health Services.

The Screening and Treatment for Maternal Mental Health and Substance Use Disorders (MMHSUD) program will provide \$750,000 annually for five years from the Health Resources and Services Administration to expand health care providers' capacity to screen, assess, treat, and refer pregnant and postpartum women for maternal mental health and SUD. BBH is partnering with the West Virginia Perinatal Partnership's Drug Free Moms and Babies Project to implement the program.

The Cooperative Agreements for States and Territories to Improve Local 988 Capacity will provide \$1,251,440 annually for three years to enhance the capacity of West Virginia's single 988 Suicide & Crisis Lifeline center, which is funded by BBH and operated by First Choice Services, to answer calls, chats, and texts initiated in the state. In addition to this award, First Choice Services received \$500,000 from Cooperative Agreements for 988 Suicide and Crisis Lifeline Crisis Center Follow-Up Programs and a National Chat and Text Backup Center award from Vibrant Emotional Health to help answer overflow chats and texts from more than 200 local 988 centers nationwide.

The Children's Mental Health Initiative (CMHI) will provide \$3,000,000 annually for four years to provide resources to improve the mental health outcomes for children and youth up to age 21, who are at risk for or have serious emotional disturbance (SED) or serious mental illness (SMI) and their families with connection to mobile crisis response and stabilization teams and other community-based behavioral health services through the 24/7 Children's Crisis and Referral Line (844-HELP4WV).

The Behavioral Health Partnership for Early Diversion of Adults and Youth will provide \$330,000 annually for five years to establish or expand programs that divert youth and young adults up to age 25 with mental illness or a co-occurring disorder (COD) from the criminal or juvenile justice system to community-based mental health and SUD services.

Attorney General Morrisey Joins Coalition in Demanding Biden Fix Unlawful Immigration Policies and Secure the Border

CHARLESTON — West Virginia Attorney General Patrick Morrisey joined a coalition of 27 attorneys general in a legal filing demanding President Biden fix unlawful immigration policies and secure the border.

The Biden administration's intentional dismantling of border security has resulted in more than seven million inadmissible immigrants surging across the border.

Despite a court victory earlier this year against the U.S. Department of Homeland Security's catch-and-release policies, the agency continues to release inadmissible immigrants into the country. The coalition is demanding that DHS amend its unlawful policies to expressly prohibit the mass release of inadmissible immigrants into the U.S.

"This administration's callous open-border policy is endangering the lives of millions of Americans, it's a matter of national security," Attorney General Morrisey said. "Here you have the fentanyl coming from China and being pedaled through the southern border, human trafficking, and the potential of terrorists infiltrating the country."

"There's no excuse for the lack of security. American lives are at stake."

The coalition of attorneys general submitted a Petition for Rulemaking to amend the DHS's catch-and-release policies, stating that the policies are blatantly unlawful and have horrendous effects on the security of our country.

In addition to unlawfully releasing inadmissible immigrants into the U.S., DHS is giving the migrants released under the unlawful practices a court date many years in the future. DHS's unlawful decisions are allowing millions of unauthorized immigrants to remain in the U.S. for 15 years or longer before ever approaching a judge's bench.

The coalition is urging DHS to amend its regulations to expressly prohibit the unlawful releases.

Attorney General Morrisey joined the Florida-led petition with Alabama, Alaska, Arkansas, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Mississippi, Missouri, Montana, Nebraska, New Hampshire, North Dakota, Ohio, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia and Wyoming.

DHHR to Participate in Federal Partnership for Family Support & Child Welfare Prevention Strategies

CHARLESTON, W.Va. – The West Virginia Department of Health and Human Resources' (DHHR) Bureau for Family Assistance and Bureau for Social Services have been selected to participate in a federal program to develop innovative prevention strategies that reduce families' involvement with the child welfare system through partnerships between Temporary Assistance for Needy Families (TANF) and child welfare programs.

The one-year "Families Are Stronger Together (FAST): TANF & Child Welfare Partnering for Prevention Learning Community (FAST-LC)," hosted by the U.S. Administration for Children and Families, Office of Family Assistance, in partnership with the Children's Bureau, will provide DHHR with individualized training and technical assistance, group learning activities and sessions, and the opportunity to form relationships with peer programs.

Through participation in the program, DHHR aims to have strengthened staff skills, capacity, and knowledge in service delivery, as well as to increase the agency's leadership and organizational capacity.

"Strengthening the connection between family assistance programs and child welfare programs is a top priority for the Department," said Cynthia Persily, Ph.D., Incoming Secretary for the West Virginia Department of Human Services. "This learning opportunity will enhance our efforts to support families with resources to avoid or reduce involvement with the child welfare system and ultimately facilitate an improved quality of life."

The program includes on-site visits from FAST-LC coaches, as well as state-to-state peer visits to examine best practices and learn from other states across the nation. The FAST-LC Initial Convening, which is scheduled for October 18-19, 2023, will bring leaders from participating states together to build community and organize and prepare for effective and successful FAST-LC engagement. Benefit Increase for 2024

Social Security and Supplemental Security Income (SSI) benefits for more than 71 million Americans will increase 3.2 percent in 2024, the Social Security Administration announced today. On average, Social Security retirement benefits will increase by more than \$50 per month starting in January.

More than 66 million Social Security beneficiaries will see the 3.2 percent cost-of-living adjustment (COLA) beginning in January 2024. Increased payments to approximately 7.5 million people receiving SSI will begin on December 29, 2023. (Note: some people receive both Social Security and SSI benefits).

"Social Security and SSI benefits will increase in 2024, and this will help millions of people keep up with expenses," said Kilolo Kijakazi, Acting Commissioner of Social Security.

Some other adjustments that take effect in January of each year are based on the increase in average wages. Based on that increase, the maximum amount of earnings subject to the Social Security tax (taxable maximum) will increase to \$168,600 from \$160,200.

Social Security begins notifying people about their new benefit amount by mail starting in early December. Individuals who have a personal my Social Security account can view their COLA notice online, which is secure, easy, and faster than receiving a letter in the mail. People can set up text or email alerts when there is a new message--such as their COLA notice--waiting for them in my Social Security.

People will need to have a my Social Security account by November 14 to see their COLA notice online. To get started, visit www.ssa.gov/myaccount .

Information about Medicare changes for 2024 will be available at www. medicare.gov.

For Social Security beneficiaries enrolled in Medicare, their new 2024 benefit amount will be available in December through the mailed COLA notice and my Social Security's Message Center.

The Social Security Act provides for how the COLA is calculated. The Social Security Act ties the annual COLA to the increase in the Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W) as determined by the Department of Labor's Bureau of Labor Statistics. WVDNR News: Upcoming youth, Class Q and senior citizen special split antlerless deer seasons

Special season is open on public and private land in 51 counties open to firearms deer hunting.

SOUTH CHARLESTON, W.Va. — The first segment of West Virginia's special antlerless deer season for youth hunters, Class Q permit holders and senior citizens with a Class XS license will be open Oct. 21-22 on public and private land in the 51 counties open to firearms deer hunting. A second segment is scheduled for Dec. 26-27.

"This special season is an excellent opportunity for youth, seniors and other eligible hunters to pursue antlerless deer when deer hunting pressure is significantly lower," said Brett McMillion, director of the West Virginia Division of Natural Resources. "Providing opportunities like this is just one of the ways we are making sure that hunting in West Virginia is inclusive and accessible to everyone regardless of their age or ability. We hope eligible hunters will take advantage of this time to get out and enjoy a hunting adventure."

Youth hunters ages 8-17 may participate in this special antlerless deer season. Hunters 8-14 must be accompanied by a licensed adult who may not hunt or possess implements for the taking of wildlife. Hunters 15-17 must comply with all licensing requirements. Hunters 65 and older who have a lifetime hunting, trapping and fishing license (Class XS) may participate in this special antlerless deer season. Hunters with a disability must have a Class Q permit.

Hunters who still need to purchase a license may do so at WVhunt.com.

All hunters participating in this season, accompanying adults and all other hunters afield during these four days must wear at least 400 square inches of blaze orange. The daily bag limit is one antlerless deer per day and no more than four antlerless deer may be harvested during the season. Deer harvested during this special season do not count toward the hunter's annual deer season bag limit. Class N/NN licenses are not required for this antlerless deer season.

Each harvested deer must be field tagged and electronically registered within 24 hours of the close of each segment of this split season and before the pursuit of additional deer. Deer can be checked online at WVhunt.com, by calling 844-WVcheck or by visiting a license agent.

Marshall University celebrates new rural surgery residency program

LOGAN, W.Va. – The Marshall University Joan C. Edwards School of Medicine, Marshall Community Health Consortium and Logan Regional Medical Center celebrated the nation's first separately accredited rural surgery residency program with a ribbon-cutting ceremony for a new residency suite Oct. 10 at Logan Regional Medical Center. The residency program was established in 2021 and welcomed its first three residents in July 2023. The program addresses the growing need for general surgeons trained to serve rural communities through a training model that incorporates specific benchmarks unique to surgeons practicing in a rural setting.

"To truly be a rural health care leader, we must identify scalable solutions with a lasting impact," said David Gozal, M.D., M.B.A., Ph.D. (Hon.), vice president of health affairs and dean of the Joan C. Edwards School of Medicine. "Rural residency programs are one such solution where we're already seeing immediate results. We look forward realizing the full impact this training program will have in southern West Virginia and beyond in the coming years."

More than 100 physicians, staff and community leaders, including state and local elected officials, gathered Tuesday for the ribbon-cutting ceremony. The residency suite includes a LapAR simulator, which uses state-of-the-art technology that allows surgeons to practice a range of general surgery procedures. Funding for program planning and development was provided by a 2021 grant from the U.S. Department of Health and Human Services' Health Resources and Services Administration (HRSA 20-107). "I am extremely proud of our outstanding general surgery faculty who have embraced the opportunity to provide high quality surgery training in a rural medical center," said Paulette S. Wehner, M.D., vice dean of graduate medical education at the Joan C. Edwards School of Medicine. "The program would not have been possible without HRSA support and the hard work of countless individuals."

The program earned initial accreditation from the Accreditation Council for Graduate Medical Education (ACGME) in 2022, making it the nation's first officially designated, separately accredited rural residency training track program. The five-year training program is approved the program to accept three residents per year for a total of 15 residents.

"We are very excited to be part of the first separately accredited rural track general surgery residency program in the nation. Rural hospitals like Logan Regional Medical Center are great places to train physicians and other health professionals. What better way to meet the challenges of getting physicians and surgeons into our rural communities than to train them there," said David Brash, chief executive officer at Logan Regional Medical Center. In addition to the rural general surgery residency, the Marshall Community Health Consortium, composed of the School of Medicine, Marshall Health, Cabell Huntington Hospital and Valley Health Systems, has rural programs in internal medicine and psychiatry

INSTITUTE, W.Va. -- West Virginia State University's (WVSU) Energy and Environmental Science Institute has received \$750,000 from the United States Department of Energy (DoE) to research bioenergy and climate change with the goal of enhancing crop improvement on reclaimed surface mine lands.

The competitive grant award will provide hands-on research and training for undergraduate students and establish a collaborative partnership for faculties with the Brookhaven National Laboratory.

"We are thankful to the United States Department of Energy for supporting the WVSU Energy and Environmental Science Institute through this grant award to support their cutting-edge research," said WVSU President Ericke Cage. "This will give our students the opportunity to be involved in meaningful, hands-on research that has tremendous potential to impact the state and region."

Principal Investigator Bagyalakshmi Muthan, who will serve as the lead research scientist on the project, said she hopes the research will ultimately attract industry and academic partners to the region, enhancing economic development and workforce opportunities.

"This research will advance knowledge in the field of plant biotechnology by characterizing previously unidentified mechanisms regulating oil biosynthesis in plants, and unlock new and creative avenues for enhancing molecular engineering of energy crops," Muthan said.

The \$750,000 award from the DOE to the WVSU Energy and Environmental Science Institute will be split among the partnership institutions on the project with \$600,000 awarded to WVSU and \$150,000 to Brookhaven National Laboratory.

WVSU launched the Energy and Environmental Science Institute in 2014 with the mission of enhancing the University's capacity to participate in evolving opportunities in energy and environmental research, teaching and outreach.

Biden-Harris Administration Selects West Virginia University to Receive \$800,000 Pollution Prevention Grant to Advance Environmental Justice

PHILADELPHIA (Oct. 12, 2023) - Today, the U.S. Environmental Protection Agency (EPA) announced West Virginia University has been selected to receive a \$800,000 pollution prevention grant through President Biden's Investing in America agenda, a key pillar of Bidenomics. The funding is made possible by President Biden's Bipartisan Infrastructure Law and will go to develop and adopt practices that prevent pollution at the source in local communities.

West Virginia University's proposed project will provide technical assistance to industrial facilities in disadvantaged communities in the state to encourage businesses to promote reducing and preventing pollution at the source. Technical assistance will include onsite and remote assessments and assistance with pollution prevention (P2) recommendations, training, and development of P2 best practices, toolkits, training videos, self guided modules, and interactive media. The proposed project will improve human health and the environment in disadvantaged communities by improving energy efficiency, minimizing waste streams, and reducing air pollution and the facilities' carbon footprint.

"Achieving lasting environmental justice requires community-driven solutions boosted by federal resources," said EPA Administrator Michael S. Regan. These dollars have supercharged our ability to empower a wide range of businesses from across the country to deploy solutions that prevent pollution while strengthening economic growth."

EPA's Pollution Prevention Grant Program advances President Biden's Justice40 Initiative, which aims to deliver 40 percent of the overall benefits of certain federal investments to disadvantaged communities that are marginalized by underinvestment and overburdened by pollution.

EPA anticipates awarding the grants once all legal and administrative requirements are satisfied.

Background: The United States generates millions of tons of pollution each year and spends billions of dollars per year controlling this pollution. Once in our environment, this pollution harms human and environmental health, which disproportionally impacts underserved communities. Preventing pollution at the source, also known as P2 or source reduction, rather than managing waste after it is produced, is an important part of the solution landscape, and advances a sustainable infrastructure that supports local economies while better protecting public health and the environment. P2 practices can reduce exposure to toxic chemicals, conserve natural resources, and reduce cleanup and financial costs for businesses, particularly for waste management and environmental liability. Practicing P2 is essential for protecting public health and improving environmental conditions in and around disadvantaged communities that have long been overburdened by pollution.

Between 2011-2021, EPA's Pollution Prevention program has issued nearly 500 grants totaling more than \$50 million, which have helped businesses identify, develop and adopt P2 approaches. These approaches have resulted in eliminating 19.8 million metric tons of greenhouse gases, saving 49 billion gallons of water, reducing 917 million pounds of hazardous materials and pollutants, and saving more than \$2.2 billion for business. President Biden's Bipartisan Infrastructure is boosting these efforts by providing a historic \$100 million to support the program's continued efforts. Thanks to the Bipartisan Infrastructure Law, state and Tribal programs that are awarded grants will not be required to provide matching funds, which has helped expand access to these resources and broadened the applicant pool.

Counties in West Virginia, which are defined by the State of West Virginia as depressed or at-risk counties, have a unique opportunity to receive training and eventual certification in cybersecurity-related fields.

We are making strong efforts to bring the training to the people in these counties." said Peggy Runyon, Project Director for the Cybersecurity and Safety Workforce Development Initiative. "This training would cost an individual several thousand dollars, if they had to pay for it out of pocket. I sincerely encourage individuals to take advantage of this exclusive opportunity."

Currently, a class for CompTIA A+ is scheduled to be held for 3 days at the Pierpont Community & Technical College space at Braxton County High School, October 21-22-23, 2023, from 9am-5pm daily. The course will be instructed by Mark Wray. The course is for those who want to learn the basic functions and management of computers. Individuals with this certification will be able to assist in helping others diagnosis computer problems and repair problems encountered. A class for CompTIA Network+ is scheduled to be held for 3 days at the Pierpont Community & Technical College space at Braxton County High School, November 4-5-6, 2023, from 9am-5pm daily. The course will be instructed by Mark Wray. The course is for those who wish to learn how to configure and manage essential network devices and create resilient networks.

No prerequisites are required. The classes are open to anyone 16 years of age and older. This is a free class for participants. Seating is limited for these courses.
