Letter For Readers

Dear Citizens:

Last week there was a letter to the Editor questioning why a voter did not receive a new voter's card when they went on line and changed their political party. That voter received a letter indicating their party change and I have attached an example letter for reference. The author of the letter said they received confirmation from the WV Secretary of State's Office about their registration change, but in reality the letter came from the Calhoun County Clerk's office, as the WV Secretary of State's office does not change a voter's registration. If you look at your voter's card, your political party is NOT on your voter's card, but if a citizen comes in to our office and change their party and requests a new voter's card we are happy to print one for them.

If you are a new voter or move to our county from another county in WV and registered through GOVOTEWV.com, we are required to mail a 10 day card to verify that you live at the address you submitted. After the 10 day notice, we can mail you a voter's card. If you register to vote in our office and have proof of residency, we can provide you with a voter's card that day.

When a voter goes on line and changes their address or political party it is entered into the Statewide system. Each night the system forwards any changes to the county where the voter resides. The same thing occurs at DMV, the Secretary of State's office does not make changes, the local

county clerk's office does.

The first thing we do every morning is check the online system to see if anyone has gone online and changed their voter registration or has gone to the DMV and either registered or changed their voter's registration.

Regarding the postcards that were questioned, I have attached a news release from WV Secretary of State Mac Warner regarding the post cards which are being sent from all 55 county clerks. This process

is mandated by code. The WV Secretary of State's office runs a report checking the addresses of voters in our statewide voter's registration system against the National Change of Address (NCOA)

The generated list of voters with changes are then sent to the county clerk to mail out the postcards to allow a voter to either verify that their address is correct, that they have moved to another county in WV or have moved out of State. The letter stated: "I'm not saying the county clerk is deliberately singling one party over their addresses not being correct." I hope the WV Secretary of State's news release and my explanation clears up that statement we mailed postcards to the voters flagged by the change of address database ONLY.

The letter also stated "I think it is time to have a closer look into what is going on in the County Clerk's Office." Well, please do! We're open from 8:00-4:00 every day – come in and ask any question you want, we don't want there to be any cloud of doubt over this 2024 election and my office which is what this letter was trying to accomplish.

Do you need to update your Voter Registration? Routine voter list maintenance continues in West Virginia

Charleston, W. Va. - Voter list maintenance has been a priority for the WV Secretary of State's Office since Secretary Mac Warner first took office in 2017. Warner is asking voters who may need to update their current voter registration or who haven't voted recently to check their status.

Working closely with all 55 county clerks, Warner says that his office provides the tools necessary to operate a uniform, non-partisan voter registration list maintenance process. Since 2017, Warner reports that over 400,000 deceased, duplicate, out-of-state, outdated, convicted felons, or otherwise ineligible registration files have been removed from the Statewide Voter Registration System. At the same time, more than 333,000 new voters have been registered to vote, which includes more than 100,000 high school students.

Ovér 109,000 instances of possible abandoned voter registrations in West Virginia have been identified recently by an updated address comparison with the United States Postal Service (USPS), the WV Department of Motor Vehicles (DMV), or by official election mail that was returned as undeliverable. Of those, 88,000 addresses will soon, or already have, received an important confirmation postcard from their county clerk's office.

"West Virginia State Code and federal laws require election officials to send a postcard to each address of a voter who is identified as possibly abandoning their registration.," Warner

"These voters were identified when they provided a newer address to the USPS, DMV, or when official election mail was returned which indicated a voter may have moved. If the voter moved to another West Virginia county, we can help them update their registration. If they moved out of state, they are no longer eligible to vote and we encourage them to cancel their voter registration," Warner said.

County clerks have been sending postcard notifications to citizens identified as potentially abandoning their voter registration over the last several weeks. The postcard asks the voter to confirm that they are still a resident of the state and county at the address on their voter registration record.

Secretary Warner encourages every voter who receives the confirmation postcard to confirm

that they still reside at the address on file or to update the address to keep their registration in "active" status. Voters can check and update their registration information online at ovr.sos.wv.gov, or by returning the pre-paid postage postcard to their county clerk.

Regular maintenance on voter registration lists is mandated by the National Voter Registration Act and West Virginia law. Voters who confirm their address by returning a postcard will remain "active.

Voters whose postcards are not returned, or are returned by the USPS as "undeliverable," will be categorized as "inactive." Voters who are "inactive" still remain eligible to vote in the next two federal election cycles. However, if a voter's registration address remains unconfirmed for the next two federal general elections after receipt of the confirmation notice, and the voter fails to vote in any state or local election during that time period, state law mandates that the registration be canceled.

"The law is in place to make sure voters on West Virginia's voter registration rolls are still residents of West Virginia at the address on file with their county clerk," Warner said. "Many times, we find that these voters moved and simply forgot to cancel or update their registration," Warner said.





Last October, President Biden asked Congress for nearly \$106 billion for Ellen Hedge is said to be on the mend and may get to come home after Ukraine, Israel and US border security. Mike Johnson, MAGA Republican leader in the House, refused Biden's request without major changes in border

Build the Wall!

The line continues in a southeast direction crossing CR 27 Linden Bright Rd, and continues into Calhoun County near CR 20/8 Sang Run Rd, crossing CR 20/9 Big Run Rd, CR 1/5, Beech Fork, White Oak Rd, CR 17/2, and CR 28 Mud Fork Rd. The line then enters into Clay County crossing CR 38/1 W Fork Rd, CR 38 Clinic Dr, SR 16, Interstate 79 and Big Otter Creek, CR 19 Ossia Rd, Deadfall Run Rd, CR 16/2 Otterlick Rd, James Dunfield Rd, SR 4 Duck Rd, the Elk River, CR 11 Widen Ridge Rd, CR 11/4 Lantz Rd, Rock Camp Rd, CR 15/2 Swandale Rd, CR 52 Rush Camp, Buffalo Creek, and CR 15/4 Taylor Fork Rd. The line then enters Nicholas County and runs along Turkey Creek, crossing CR 19/26 Spruce Run Rd and US Rt 19, terminating at the Powell Mountain Substation off CR 19/41 Hookersville Rd north of Muddlety West Virginia.
