Allen Brannon appeared before Magistrate Lora Davis (pictured left) for a scheduled preliminary hearing in cases 24-M07F00004 charging DUI Causing Serious Bodily Injury and Child Neglect with Serious Bodily Injury. The charges were dismissed at the onset of the hearing with Brannon now facing the charges of 24-M07F-00007 The new charges as detailed in the criminal complaint filed

by Brian E. Young are: DUI Resulting in Serious Injury (3 counts); Gross Child Neglect Resulting in Risk of Death (16 counts) and Child Neglect Resulting in .Serious Bodily Injury (3 counts)

Brannon appeared with court appointed counsel Daniel Minardi of the Public Defenders Corporation, Prosecuting Attorney, Michael Hicks and surrounded by Deputy Hannah Stephen's, DNR Jonathan Holcomb, Trooper Brian Young, Deputy Jeff Hunt and DNR Charles Stephens. Security was tight at the courthouse with the front entrance requiring all courthouse visitors to step through the metal detector. It was an expected concern that families of the bus accident victims would attend the hearing with officers prepared for confrontations. However, only one victim and her mother appeared and sat quietly through the hearing directly across from Jeffrey Brannon.



With a delay in arrival, Ridgeview News had the time to speak with the victim and her mother, who came to face the bus driver and see what would happen with the hearing. The mother and daughter both set anxious, waiting more than thirty minutes for the jail transportation crew to deliver Brannon to the hearing. The mother said that March 4th was the worst day of her life as she heard from her sister that her daughter was in the accident and waited for her sister to arrive on scene and to find out how seriously her daughter was hurt. The 17 year old suffered injury to her arm and ankle, as well as the emotional side of the incident. Today was the first day she had been able to return to riding the bus to school.

Following the advisement of the new charges and penalties he would be facing, Jeffrey Brannon's bond was increased from the former \$200,000 to now \$750,000. Attorney Daniel Minardi informed Magistrate Davis that he would likely file a Preliminary Hearing Waiver allowing the case to be sent to Calhoun Circuit Court for further action.

If convicted of Child neglect resulting in injury Brannon will face a fine of not less than \$300 nor more than \$3,000 or imprisoned in a state correctional facility for not less than one nor more than ten years, or both for each offense.

If convicted of child neglect resulting in risk of serious bodily injury or death for each of the 16 counts, Brannon will face a fine of not less than \$1,000 nor more than \$3,000 dollars or imprisoned in a state correctional facility for not less than one nor more than five years.

For the charge of driving under the influence of alcohol causing serious bodily injury Brannon faces imprisonment in a state correctional facility for not less than two nor more than 10 years and shall be fined not less than \$1,000 nor more than \$3,000 dollars and shall have his license to operate a motor vehicle revoked by the the Commissioner of the Division of Motor Vehicles test and lock program.

For their selfless acts of caring for their classmates the two were awarded the "Distinguished West Virginian" Award that has only been given to a little greater than twenty people in the seven years that Governor Justice has been in office.

This Week In Calhoun History

The following reports are taken from the Calhoun Chronicle Archives.

1924, 100 YEARS AGO: Another Engine For Cabot Station

Chief Engineer Ernest Wilson, of Cabot Station, was here a few hours Saturday, it being one of his few visits to Grantsville this winter. He informs us that a requisition has been sent in for another engine and pump for the same size and capacity as those now in his plant. It is expected that the engine will be shipped here shortly and that work will be begun on the construction of an addition to the plant to house it. This will furnish employment for several men, the work being done mostly by local laborers.

This will be the eighth engine of its kind to be installed in the local plant. Cabot Station is now the second largest of the kind in the country being exceeded in horsepower and capacity only by the monster plant at Hastings, Wetzel County. Although the capacity of the local plant has been doubled since it was first installed in 1921, it will have to travel some to catch up with the Hastings plant. The latter has one engine that will develop more power than all those of the local plant combined.

1949, 75 YEARS AGO: Legion Observes 32 nd Birthday

1974, 50 YEARS AGO: West Fork And Leading Creek Dams Rejected Again By Engineers: The Long-proposed West Fork and Leading Creek dams on tributaries of the Little Kanawha River has been shelved again by the Army Corps of Engineers, due to a change in cost-benefit ratios.

The West Fork and Leading Creek projects had been expected to be started after completion of the now underway Burnsville Lake. The plan for the two lakes was tentatively approved in February, 1973, pending final concurrence by the Environmental Protection Agency. The EPA stated that storage for water quality control flow releases should not be included in wither project. Without the water quality control storage taken into consideration, the two dams were said to be economically unjustified.

A change in the cost-benefit ratio, raising the amount of property protected in relation to the cost of the reservoir, along with this decision that water quality control who have no economic benefit, caused postponement of any further consideration of the proposals at this time, with the exception of a study for a dry reservoir for West Fork. That proposal is to have further study this spring. Preliminary results, a Corps spokesman said, however, indicate that even the dry reservoir alternative, with a lower construction cost, will also be ruled infeasible.

Harold W. Beamer, chief of the Engineering Division of the Corps of Engineers, said that should the dry reservoir prove feasible, a public hearing would be held later in the year.

Latest inquiries about the two proposals were made by the Little Kanawha Resource Conservation and Development Project, with William B. Morrison, chairman of the steering committee. He cited the need for flood protection, plus the benefit of water based recreation in the area as reasons for interest in the two lakes.

The Burnsville Lake project is under construction now. Its main purpose is for flood control on the Little Kanawha. The decision on West Fork and Leading Creek lakes will evidently have no effect on the Burnsville Lake, according to Morrison. The three projects have been proposed, studied, surveyed, and discussed every since 1936.





What is a hero?

According to vocabulary.com a hero is: Definitions of hero (noun) someone who fights for a cause. synonyms: champion, fighter, paladin (noun) a person distinguished by exceptional courage and nobility and strength.

"RAF pilots were the heroes of the Battle of Britain." (noun) (classical mythology) a being of great strength and courage celebrated for bold exploits; often the offspring of a mortal and a god.

(noun) the principal character in a play or movie or novel or poem.

(noun) a large sandwich made of a long crusty roll split lengthwise and filled with meats and cheese (and tomato and onion and lettuce and condiments); different names are used in different sections of the United States.

None of these versions of hero really applies to two Calhoun students who became real life heroes recently when their actions went well above and beyond the action of normal.

The version of hero I ascribe to is when normal people put in abnormal circumstances perform extraordinarily.

And that's exactly what two young Calhouners did when they were hit with abnormal circumstances.

Back on March 4, people were settling in for what was supposed to be an ordinary evening. Folks were cooking dinner and heading home. Some people, me included, had settled in to witness a contentious town council meeting here in Grantsville.

Our Mount Zion students were filing onto school buses to head home. All was normal. Moments later things were no longer normal. While heading south on West Virginia 16 the bus rounded a turn and ran into a ditch striking a culvert and, in an effort, to correct things the bus over corrected and rolled onto its side dumping the children from their seats injuring all – some slightly and some greatly. Two of the children on the bus then did extra ordinary things in extra ordinary circumstances.

Meanwhile the rest of the people were just finding out about the horrendous accident.

Where I was at the town council meeting Shari Johnson of the Ridgeview news stood up and excused herself saying there had been a school bus accident on Mount Zion and she was going to have to leave. A hush fell over the town council meeting crowd, and I mumbled to Roger Propst who I was sitting beside "well that puts all this is perspective doesn't it?" And it did.

Following that the meeting became much less contentious with people, frankly I think, just wanting to get everything over and to get the heck out of

there. The meeting was no longer that important.

Meanwhile on the school bus panic reigned except for a couple of students who were performing extra ordinary things in extra ordinary circumstances.

One was freshman Charter Cottrell who was trying to get people safely out of the bus. The other was junior Lauren Lovejoy who was tending to the injured students who were unable to leave the bus going so far as literally taking the shirt off her back to use to quell the bleeding of others.

By definition in those minutes following the tragic bus accident both of those students became heroes and were justifiably honored by the state and the folks in Calhoun.

The two were rightfully presented Distinguished West Virginian Awards by Governor Jim Justice at an assembly before the school about a week later.

It was a well-deserved honor.

I have talked with both students through our basketball ties as Charter played varsity basketball for the Red Devils this year while Lauren was on the girls' team.

My conversation with Charter was mostly me telling him not to hang on the rim when he dunked the basketball because the referees would give him a technical foul. That was joking advice I gave to all the shorter players as they sat in front of the scorer's table getting ready to go into the game.

On the other hand, I talked with Lauren about her grandfather, who after some thought about the bus accident and things, was also a hero way back when. Lauren's grandfather is Roger Chenoweth and when she told me that I said, "man he was ornery back then" and he was. Not malicious but ornery. There is a difference. After Lauren did her heroic things, I remembered back to a night up on the West Fork when I had been pulled over by a couple of cars who wanted to beat the hell out of one of the people in my car and hey were doing it as I stood there with a pistol being held under my nose. That's when a car with Roger and a few other people showed up and Roger got out and was able to break up the fight.

In that instant he was a hero. And I was happy to see him.

Calhoun County superintendent of schools Michael Fitzwater has been thrown into the middle of the school bus accident and the surrounding controversy involved with it. Thus far he has done an admirable job of handling things despite this being his first year at the helm of the school system.

But this does not surprise me a bit because I knew him way back when when he did extra ordinary things in an extra ordinary circumstance.

He and his brother Ryan (Goob) were at a distant field cutting grass when his brother rolled a tractor over on himself causing serious if not fatal injuries.

That's when Michael sprang into action running two or three miles to get help since this was the time before wall-to-wall cellphones. Personal contact was all there was and to have personal contact Michael had to run and get

Help arrived in time and Goob was rushed to a hospital in Charleston where they basically said not only would he probably not ever walk again he may not

Michael's heroism saved his brother no doubt but in the long run his brother Goob displayed great heroism too.

Not only did he survive he worked so very hard that at the Calhoun-Wirt football game in Grantsville Goob was able to walk onto the field as fans cheered and cried overcome with emotion.

It went on and Goob played some basketball on the Calhoun team that went to the state tournament and later played a little football at Glenville State as a long snapper showing another kind of courage and heroism. The willingness to keep fighting when all odds say it won't matter.

We are lucky here in Calhoun and all central West Virginia that we have heroes among us. We had two such heroes on March 4, 2024, and I thank God we did. Until next time stay safe but don't live life in a bottle.

Some new holes have appeared in the Little Kanawha River bridge at Creston. Those who had occasion to go down to the Mouth of the Elk reported that I-77 has "imperfections in the surface of the roadway". With the ditching of the entirety of the Ann's Run road local folks now hope that there will be an upgrade to the surface. It has been many years since any consequential attention was given. (maybe over two decades)

The buzzards have returned from the sunny south.

Ralph Bandy gave a talk at the SPE (Society of Petroleum Engineers) meeting at the Mouth of the Elk. A major survey is being conducted to locate sources of rare earth minerals and other valuable minerals like lithium. Oil field produced waters that he tested had no rare earths but there is lithium which is used in fancy meth labs and for cell phones, etc. Presently lithium is being recovered from mine waste at Mount Storm in Grant County. Brine from Marcellus wells in Lewis & Taylor counties have 125 ppm of the valuable highly reactive metal.

The big cupcake theft at Shade Tree was solved.

Pittsburgh based EQT has announced that the firm is "buying back" Equitrans Midstream which was/is its pipeline subsidiary and includes Mountain Valley Pipeline. One can then "sell" the natural gas to the subsidiary and avoid paying the market price and cheating royalty owners and taxing authorities such as county ad valorem taxes, state severance tax, etc. Who do our state government officials answer to?

Because of the historically low natural gas prices CNX, part of the John D. Rockefeller Standard Oil empire announced a cutback of 30 bcf/day of gas production and a slowdown of putting new wells on line. The current Henry Hub (Louisiana) price is \$1.65 with much lower prices locally "since we have a glut."

HG Energy announced that certain wells in Lincoln, Kanawha, Putnam & Roane Counties were sold to Delta Helix Energy which appears to be owned by B. Douglas Haught from Smithville and the El-Rayess Family Trust from Tuxedo Park, New York. Speaking of HG which has funding from Quantum Capital Group has had a change in that Elliott Management, a part owner is to put an additional \$one half billion into the firm that has been drilling Marcellus

Naomi Toler who carries most of the Creston mail has been vacationing at the beach. Since the river has been up it was obvious that she did not choose Munday beach, a local favorite. Her sub, like Naomi before her, started out with getting a flat tire on the Richardsonville Road.

The price of local Pennsylvania grade crude oil is \$80.04/bbl. with condensate fetching \$62.04/bbl. and Marcellus & Utica light bringing \$71.04 & medium \$80.04/bbl.

Recipe Corner

Savory Mushroom Beef Casserole

Ingredients:

1 pound ground beef

1 finely chopped onion

2 cloves minced garlic

8 ounces sliced mushrooms

1 can (10.75 ounces) condensed cream of mushroom soup

1 cup sour cream

1 cup shredded cheddar cheese

½ cup milk

½ teaspoon salt

½ teaspoon black pepper ½ teaspoon paprika

1/4 dried thyme

½ teaspoon dried rosemary ½ teaspoon dried parsley

4 cups cooked egg noodles

Fresh parsley for garnish (optional)

Directions: Preheat your oven to 350 F. In a large skillet, brown the ground beef over medium-high heat. Drain any excess fat. Add the chopped onion, minced garlic, and sliced mushrooms are tender, and the onions are translucent. Stir in the condensed cream of mushroom soup, sour cream, shredded cheddar cheese, milk, salt, black pepper, paprika, dried thyme, dried rosemary and dried parsley. Mix well and let it simmer for a few minutes. In a large mixing bowl, combine the cooked egg noodles with the beef and mushroom mixture. Transfer everything to a greased 9x13-inch baking dish. Cover with aluminum and bake for 25 minutes. Remove the foil and bake for an additional 10 minutes or until the casserole is bubbly and the top is golden brown. Garnish and serve.

Grandma's Biscuits

Ingredients:

2 cups all-purpose flour

1 tablespoon of baking powder 1 teaspoon salt

1 tablespoon white sugar

Half a cup of margarine

1 cup milk

Directions: Preheat the oven to 425 F. In a large bowl, mix together flour, baking powder, salt and sugar. Chop the margarine until the mixture resembles a coarse meal. Stir the milk gradually so that the dough folds off the side of the bowl. Turn it over on a floured surface and knead 15-20 times. Roll or roll dough to 1 inch thick. Cut the biscuit with a large piece or a cup of juice dipped in flour. Do again until dough runs out. Discard in excess flour, and place the biscuits on an ungreased baking tray. Bake for 13 -15 minutes in a preheated oven, or until the edges begin to turn brown.





PSC Urges Consumers to Fix Household

CHARLESTON, WV - A simple household leak can cost you a lot of money. Most are simple to fix once you locate them, but leaks can be sneaky. The Public Service Commission of West Virginia is participating in Fix a Leak Week, March 18-24 by encouraging everyone to be vigilant in finding and repairing leaks in household plumbing fixtures.

"American homes waste more than a trillion gallons of water every year," said Charlotte R. Lane, Chairman of the Public Service Commission. "The average home loses almost 10,000 gallons of water per year to simple leaks. That is the amount of water it takes to wash 300 loads of laundry. The money you will save on your water bills will more than pay for the small cost of fixing these leaks."

To help save water, the Commission offers the following tips:

-Look at your water bill. If a family of four uses more than 12,000 gallons per month, you could have a serious leak. Turn off all water, then read the meter at the beginning and end of two hours. If the meter changes, you likely have a leak.

-Monitor possible toilet leaks. Squeeze a few drops of food coloring in your toilet tank. If you see color in the bowl after 10 minutes, you have a leak. Worn flappers often cause silent toilet leaks, but they are inexpensive and easy

If your faucet drips, tighten connections and replace the aerator with a WaterSense labeled model to save water without a noticeable difference in

Leaky showerheads caused by a loose connection between the showerhead - Preventative Health Screen with dental check and hemoglobin test and the pipe stem can usually be fixed by wrapping the pipe stem with pipe tape.



Feral Cat Colonies

The Welfare of Animals Group (WAG) is asking Calhoun county residents to help us address a long-observed problem with our animal community - feral or community cats. If you feed a feral cat colony in your neighborhood, or know someone who does, please call Linda at 304-354-7506 or notify us via our email calhounwag@yahoo.com.

Our humane and effective Trap-Neuter-Return (TNR) program's volunteers will live trap the cats, take them to the vet to be spayed or neutered, vaccinated for rabies, respiratory disease, worms, and fleas, and returned them to their outdoor home, at no cost to the colony's caretaker. The colony will be healthier and no longer producing unwanted kittens.

At four months old a female kitten can start breeding, and can have 2 or 3 litters per year. A mother cat nursing a litter of kittens goes back into heat when the kittens are only 3-4 weeks old. Removing cats from an area (i.e. catching and killing) is useless. When cats are removed from an area, then new, unsterilized cats move in to take advantage of available resources – and begin reproducing. This well-documented natural trend is known as the "vacuum effect." Trap-Neuter-Return stops the breeding cycle and eliminates mating behaviors, such as yowling, spraying, roaming, and fighting. Trap-Neuter-Return also benefits public health because community cats are vaccinated against rabies. We car only trap once a month, so please contact us soon if we can help with a colony. Thank you.

Katie Britt wasn't talking to you.
