## **Circuit Court Cases before** Judge Anita Harold Ashley on April 11th By Shari Johnson

Judge Anita Harold Ashley held Circuit Court on Thursday, April 11, 2024 for three criminal cases pretrials and several juvenile

Ryan and Ellio Hardman, charged with Gross Neglect Of Child Creating Risk Of Injury Or Death, appeared with their Attorney

John Balenovich and Daniel Minardi. The case had been set for trial during the Calhoun County Wood Festival dates and out of concern for trial interruptions the trial was rescheduled for August 20th, 2024 at 9:00 a.m., with a July 18th Pretrial at 11:30 a.m.

David and Dylan Little also appeared before Judge Ashley for a Pretrial. The two were facing the charges of Transferring Stolen Goods and scheduled for Jury trial next week. Due to a misunderstanding of trial dates, Attorney David Richardson stated that he was not prepared to move forward and that he had continued to receive discovery from the State, even as late as today.

Attorney Daniel Minardi who is also council from one of the Little's did not object to the continuance. The recent disclosure of seven State witnesses by Prosecutor Michael Hicks, and a jail call log that exceed 1,000 calls was making it difficult for the attorney's to prepare their case. Attorney Richardson, speaking to the Judge, stated that this was a 2022 case where discovery had been provided by then Prosecutor Nigel Jeffries, case was continued until August 20th at 9 a.m. for trial

### Fields Arrested for Grand Larceny and **Entering a Building Other than a Dwelling**



In a complaint filed by Trooper Brian Young of the West Virginia State Police, he stated that on the morning of Sunday, December 18, 2022, between the hours of midnight and 6:30 a.m., the accused, Edward Fields, did break and enter the outbuilding, located at 4033 Arnoldsburg Rd., Arnoldsburg, Calhoun County, WV, by force, and commit the larceny of one (1) red 2007 Honda 420 Rancher ATV, with the value of \$3500, of the victim, Robert Randolph, with the intent of depriving the victim of permanent use of said vehicle.

The accused was working for the victim prior to this event and was doing repairs on the same vehicle. When the accused failed to come to work

repeatedly, the victim fired the accused the day prior to the ATV being stolen. The original investigator had listed the accused as the suspect in the original

investigation and attempted of locate the ATV in the area during that time.

March 20, 2024, Trooper Young located and identified the same ATV located in the front yard belonging to the accused. The ATV had been spray painted green and partly covered by a tarp.


The sole occupant of the residence stated the accused had been the one who acquired the ATV approximately a year prior to the recovery. No bill of sale or titles could be produced.

Edward fields has been charged with Grand Larceny and Entering a building other than a dwelling. He was arraigned and released on a \$20,000 property surety bond in the Magistrate Court of Calhoun County.

#### Metheney facing Felony Strangulation and **Domestic Battery Charges**

In a complaint filed by Sgt. K.M. Williams of the West Virginia State Police, the officer stated that on March 10, 2024, at approximately 6:36 p.m. he had received notice from Calhoun County 911 who had received a call from an individual stating that her and Parks Metheney were in an altercation but he had left the residence, located at 1086 Nobe Road, Big Springs, WV 26137, Calhoun County.

Upon arrival the officer spoke to the victim and, observed marks on her left neck. She advised that they had gotten in an argument while driving to the store and Mr. Metheney started braking and



The victim was able to break free and took the child inside the residence and had a family member watch the child and told them to lock the doors. When she came back outside Mr. Metheney had a rake and was busting the rear window out of the red Pontiac G6. Mr. Matheney then came to the front window of the vehicle striking the vehicle with the rake before it came logged in the front glass.

A family member then took Mr. Metheney from the residence to West Fork where he was released from the vehicle. A Criminal History Check shows an arrest and conviction for Domestic Battery on April 10, 2023, in Calhoun County. Parks Metheney has been charged with Domestic Battery and Strangulation and is being held on a \$45,000 cash only bond in the West Virginia Central Regional Jail.

1924, 100 YEARS AGO: Who's Who & What's What in Calhoun High School The teacher's preparatory school began this week at the Calhoun County High School. The teacher, Miss Petty, was unsuccessful in making the connection for her arrival Saturday, but was received cordially by all, Tuesday morning. Ten teachers have enrolled and are progressing very nicely so far.

It is thought that the Calhoun County High School will soon receive the Chevrolet speed wagon, as the girls have been appointed to make sales of the remainder of the Fire Extinguishers and Steering wheels for the Grantsville Garage & Supply Co.

The ball ground looks like an ant hill these days. About thirty-five men reported for practice for the first day, but some of them have fallen out.

After school Monday evening several of the boys made a rush to a radio to hear the scores of the opening game in the Big League.

Work on the State Roud had been started this week, which has made quite a change in the coming and going from school.

**1949, 75 YEARS AGO**: Local Seniors At Glenville--Sixty Calhoun County high school students will attend the second annual Senior day at Glenville State College, Thursday April 21. These Calhoun County high school seniors will be part of some 600 students who are expected to attend Senior day on the Glenville State campus, representing 16 high schools from 10 counties.

Schools which have indicated to Register Michael E. Posey, director, that they will attend Senior day activities are Cowen, Calhoun County high school, Wirt county high school, Burnsville, Widen, Tanner, Walkersville, Normantown, Sand Fork, Glenville, Troy, St. Marys, Cairo, Sutton, Spencer and Clay.

Beginning at 10:30 a.m., Thursday, a general assembly will be held in the college auditorium featuring a program of music presented by the college music department. President Harry B. Heflin will speak to the 600 members of the class of 1949, and Registrar Poey will welcome them to a "Day of College."

Luncheon will be served to the visitors in the dining rooms of Kanawha Hall beginning at 11:30 a.m. Classrooms, laboratories, offices, dormitories, will be open for inspection by the seniors and their faculty sponsors. Displays are being planned, exhibits are in readiness, and laboratory work will be open for visitation by the guests. Concluding the day of visitation which attempts to provide the high school senior with a better concept of the nature and purpose of college life, Glenville State Pioneers will play West Virginia Tech in a baseball game at 1:30 p.m., at Rohrbough stadium.

The line then enters Gilmer County crossing SR 5, the Little Kanawha River, CR 15 Grass Run Rd, Cedar Creek, CR 17 Lower Cedar Creek Rd, Tower Dr, the Little Kanawha River, and SR 5, and then terminates at the Glenville Substation off of SR 5 north of Glenville West Virginia.

April 18, 1756: The a number of children's clawhammer banjo style, largest French & Indian books, including Carry un-accompanied present West Virginia occurred about two miles Award. northeast of U.S. 50 and County Route 15 in present Capon Bridge, Hampshire County.



April 18, 1849: State Supreme Court Justice Marmaduke Dent was born in Monongalia

County. He received the first bachelor's and master's degrees from West Virginia University. A populist judge, he ruled against railroads supported Carrie Williams in an 1898 case finding that Black schools were entitled to the same length school terms as other schools.



April 18, 1861: At the beginning of the Civil War, retreating U.S. troops set fire to the national armory and arsenal at Harpers Ferry to keep them out of Confederate hands. However, Virginia militia extinguished the flames and sent much of the weapon-making equipment south before destroying the site in June 1861.



April 18, 1912: The Paint Creek-Cabin Creek Strike of 1912-13 began when coal operators rejected the demands of their unionized workers for a wage increase. The strike that followed was one of the most dramatic and bloody conflicts in the early 20th century labor struggles in southern West Virginia known as the Mine Wars.



**Must Calhoun Flood?** by Aryeh White

Calhoun County floods. We all know this. Worse, we have accepted this.

Every time we have heavy rains, the waterways swell, roads are closed, homes and businesses damaged, God-knows-what gets washed downstream, school is closed, and countless other injuries and inconveniences are suffered by our community. After each flood the injured look to the Commission, the State, the Feds, NGOs, and charities to be made whole.

This reactive mindset has become entrenched and accepted. A proactive Commission would be preventing a future flood even as they make citizens whole from the last flood.

While there's little to be done directly on the Little Kanawha, with its flow and level controlled by the dam in Burnsville, there is much that can be done on its tributaries. The West Fork at the Arnoldsburg Y, for example, is a full 50' higher than the Little Kanawha in Grantsville and over 100' higher than its confluence with the Little Kanawha at Creston. No, the Little Kanawha would be lapping at the parking lot behind the Dollar General in Grantsville before it reached the same elevation as the banks of the West Fork in Arnoldsburg.

Passive flood control structures such as weirs are proven, long-lasting, effective, safe, and inexpensive methods to control riverine flooding. A weir, like a dam, is a structure that holds back some water in a stream, but it differs in two critical ways.

First, a weir is designed to have water flow across its entire top, not just a small spillway. Second, a weir is totally passive, requiring no operator to manage water release for its safe operation. These two differences make weirs

In the oldest settled areas of the Eastern Seaboard stone weirs dating from the 18th and 19th centuries are a key part of the current flood control systems. Originally constructed to raise water levels to provide power for mills, these structures have been modified for flood control and remain sound and operational centuries later. In the UK, there are truly ancient weirs still in use that were present prior to the Domesday Book of 1086. With maintenance a few times a century, these structures can function indefinitely.

A weir can be used a few ways to manage flooding. One arrangement, the top-flood pond, has a pond held back by a crenelated weir. In normal conditions, the water flows over the weir in the low places between the crenelations. When flow increases, water builds up behind the crenelations, increasing the height of the pond by up to several feet. If the water exceeds the capacity of the weir, it simply flows over the top, and the flow rate returns to the level it would have been if the weir weren't present.

Another arrangement is a dry weir, in which a drainage culvert flows under the weir. In normal conditions, the culvert allows the stream to pass unimpeded. When flow increases to, say, twice normal flow, the water begins to build up behind the weir, limiting flow to twice the normal rate until the weir reaches capacity, after which the flow over the top of the weir is about what it would have been if the weir weren't there.

In either arrangement, the idea is to build a temporary storage capacity into the waterway. This way, an hour of extreme downpour might be drained downstream over several hours, limiting the flooding. By working upstream and building a series of small weirs across the tiny creeks, runs, and other tributaries, we can reduce the frequency and severity of the flooding downstream.

The exact form any flood control system Calhoun County might develop will require much research and discussion. As candidate for Commissioner, I have already begun very informal initial talks with state and federal agencies regarding the possibility of such projects and been met with a lot of enthusiasm. In a relative sense, top flood ponds and dry weirs offer a very inexpensive solution to an expensive problem. Controlling flooding is of interest locally; controlling the pollution that results from flooding is of interest nationally. Everything that goes into our water here is felt all the way to the end of the Little Kanawha, Ohio, and Mississippi rivers.

Houners shouldn't accept the status quo of flooding. Together we can address this issue, improving our quality of life and making this county more attractive for opportunity.

### Recipe Corner by Emma Howell

Baked Spaghetti IN Garlic Bread

1 Loaf Rhodes Bread Dough or 12 Rhodes Dinner Rolls, thawed to room temperature

6 oz spaghetti, cooked 1 cup thick spaghetti sauce

8 oz mozzarella cheese, cut into 1/2 –inch cubes

1 egg white

Parmesan cheese

Parsley flakes

Garlic powder Optional- 1/2 lb cooked sausage or burger

Spray counter lightly with non-stick cooking spray (or use parchment paper). Roll loaf or combined dinner rolls into a 12x16-inch rectangle. Cover with plastic wrap and let rest for 10-15 minutes.

Cook spaghetti according to package instructions. Drain and let cool

slightly. Remove wrap from dough. Place spaghetti lengthwise in a 4-inch strip down the center of dough. Top with sauce and cheese cubes. (Or, mix spaghetti

and sauce together and added cooked meat) Make cuts 1 ½-inches apart on long sides of dough to within ½-inch of filling. Begin braid by folding top and bottom strips toward filling. Then braid

strips left over right, right over left. Finish by pulling last strip over and tucking under braid. Lift braid with both hands and place on large sprayed baking sheet. (or transfer parchment paper to baking sheet).

Brush with egg white and sprinkle with Parmesan cheese and parsley and

garlic powder). Bake at 350 for 30-35 minutes or until golden brown. Cool slightly and slice to serve.


