On April 25th, 2024, Deputy C.R. Stephens, assisted by other officers, executed a search warrant

at the Justin Bordas residence. During the search, the officers located three plants believed to be, based upon training and experience, marijuana. Two of the plants were in a hydroponic device in the lone bathroom of the residence. The third plant was more mature and in a self contained indoor greenhouse type device in the garage.

Among other items taken were two smoking devices and several prescription cannabis containers containing product outside of the thirty day supply allowed to be possessed in WV Code Chapter 16A.

Bordas had previously stated during a home confinement check that his medical cannabis card allows him to have two marijuana plants, however, he has no permit from the bureau as required by WV Code 16A-3-3(b)(3). Bordas is being charged with three (3) counts of cultivation of marijuana. These crimes occurred with in the geographical limits of Calhoun County, West Virginia.

Bordas was arrested and taken to the WV Central Regional Jail where he is being held on a \$5,000 cash or surety bond on the charges of Manufacturing a controlled substance as well as a capias.

West Fork Town Hall Meeting gives The West Fork Hope for Water Extension

The Mt. Zion Public Service District hosted a town hall meeting at the Upper West Fork Park on Saturday, April 27th, 2024 to allow the public to weigh in on the possibility of an extension of the water line from the current ending location of Chloe to the Clay County line. Once there, the line would be tied into a Clay county project that is currently underway extending their service to the Calhoun line.

Mark Sankoff, of Protesta Engineering told the crowd of about 30 people that the PSD had asked them to look into the extension from the southern end of the county. By extending into Clay county the PSD will have another source of water available should the source from Grantsville Municipal's system happen to have an issue supplying water to the West Fork area.

I'm a the future, it would currently require booster stations costing an average of mother of 3 children and a grandmother of seven \$250k to \$300k which is not feasible with their current expectation of funding available. The projected project will cost over \$5 million dollars, depending upon how many customers agree to sign up for service. An ongoing issue has been providing enough water to turn over the line and keep the chlorine residual up to a legal limit at the end of the line in Chloe. The new extension would not only stabilize pressure but would allow residents to lessen the concern of losing water during a power outage which is experienced by well owners and allow residents to receive a reduction in home insurance costs. As a part of the plan they'll be building a water storage tank that will help pressurize the line as it travels south. Mr. Sankoff readily answered questions by the residents attending regarding the amount of costs that would be incurred by those willing to sign on for service. The three year contract for new customers on the extension would include a \$100 tap fee, which will be \$250 after the construction phase, and a monthly water bill that currently runs \$44.16 for the base bill of 2000 gallons of usage. The funding for this project is hoped to come from a few sources. One of which has already been submitted to Senators Shelley Moore Capito and Joe Manchin, and is soon to be submitted to Congresswoman Carol Miller for Congressional spending grants. If approved 80% of the project costs could be covered; but Mr. Sankoff warned that the grants were very competitive and even if approved would have to pass through the approval of the federal budget this year. Two of the three Commissioners attended the meeting, Roger Propst and Kevin Helmick. Commissioner Helmick asked about a prior petition that had obtained 117 signatures of residents desiring water. Mr. Sankoff said that they'll visit that, but a new petition needs to be signed to find out the current need. He also said that although a petition is important, it is the signed user agreements that show commitment to the project and will carry the greater weight. Commissioner Roger Propst told those attending that he believed that the commission is in full agreement to go to the end of the road to get them water saying that there is also money set aside in the county budget to extend water service in the County. He encouraged them to speak to their neighbors about the opportunity knowing that their voice would potentially go further on increase interest in the extension. County Commissioner candidate Eric Lupardus spoke up during the meeting and informed the community members that he had spoken with and met with House Speaker Roger Hanshaw on several occasions to discuss the water issue. He is currently in the process of coordinating a meeting with the PSD and the Engineer at the capital to discuss the water project to the areas of the county that are in need. My Home Among the Hills

The countdown has officially begun. As I sit to write this article, I have four weeks of school left until summer vacation. The school calendar includes two days off during election week, so this means the count stands at 18 days.

I know once I flip the calendar to May on Wednesday the days will start to fly. Still, there is a lot to get accomplished in those 18 days. Therefore, I will follow my Grandma Haught's advice to take one day and task at a time until my list is complete.

I was able to cross one item off my list this past Friday. It was a beautiful day to take the first and fourth grades from Pleasant Hill to the Calhoun County Park for a field trip.

It was a good thing I wore comfortable shoes because I was kept busy wearing two hats on this trip. I was a 4th grade teacher but also a member of the historical society welcoming students to Heritage Village.

We unloaded the students at the barn, which we had rented for the day, and unpacked our lunches and other supplies. Then the first grade set out to explore the park while the fourth grade hiked over to Heritage Village. I led the pack so I could quickly enter the Stevens School and slip into my one room schoolhouse costume while the 4 th graders were entering the village and looking around. I started "school" by ringing my teacher bell and calling the students to class.

For the first hour of our visit, I taught my students what it would be like to be a student attending a one room schoolhouse. I explained that students of all ages would be learning together, and that many of them walked long distances in all types of weather to attend. We also talked about how students could only come when they weren't needed at home. After a tour around the room and some explanations about items such as the inkwells in some of the desks and the water jug and ladle in the back of the room, I started class. We had a spelling bee, did some multiplication problems on the chalkboard, wrote letters on notecards, and read a Laura Ingalls Wilder picture book.

When I dismissed class, the 4 th grade split into two groups and began to visit the other buildings in the village. I took off my costume and joined my group at the Jarvis Store. The students learned about all of the tasks that could be accomplished at a general store and how people would often trade what they had to purchase items they needed. Students also got to see an old cash register, scales, a bottle opener, and a turpentine container that would travel down the river on a riverboat.

Our next stop was the Freed Post Office. The students collected the mail from the night deposit, sorted it, and then delivered it to some of the other buildings in the village. They also received a little lesson about the airmail delivery that once took place in Calhoun County. Then we were off to the Cain Chapel where we made a God's Eye craft out of sticks and yarn.

At this point, we switched sides of the village, and we went on to Stemple Cabin while the other group went in the chapel. The students watched Riley weave on her loom before heading into the cabin to see how pioneers once lived. The bear rug on the wall upstairs was definitely the most popular attraction. The Starcher Blacksmith Shop was our next destination. Here we learned about what a blacksmith would do and how he go about doing it. We saw a forge and got to try our hand on an anvil. Our last stop was the Toolshed and Gristmill where we learned about a number of antique tools and machines and tried our hand at mowing the lawn with an old push mower. On our way out of the village, every student received a bag of homemade kettle corn made that day in the village. We hiked back over to the barn for lunch, and then I raced back to the village to do my part for the first graders in the schoolhouse. Once that was complete, I hiked back to the barn and rejoined the 4 th grade. We spent the rest of the day hiking and playing in the park. The weather was perfect, and a great time was had by all. We are so blessed to have such a great park in our county. Field trip two is in the books with one to go in May. Four weeks and counting.....and only three school night Sundays!



A few years ago, I lived in Alexandria, La., where I worked for The Town Talk as the sports editor. I also wrote a few non-sports for the publication and what's going on here in Central West Virginia brought back some memories.

I remember writing one about EMT/ambulance services.

Rapides Parish, where Alexandria is located, is in the central part of the state on the banks of the Red River. It is said that south of the Red River is Cajuns and Catholics while north of the river it is protestants and cowboys, and the truth of the matter is that is pretty accurate.

You know how Louisiana looks a bit like a boot well Alexandria is about when the ankle bone would be. Enough of a geography lesson.

At the time the Rapides Parish Police Jury (Louisiana's version of a county commission) was debating whether to fold its EMS service and award a contract to Acadian Ambulance to exclusively provide ambulance services. Both Rapides EMS and Acadian provided services in the parish

At that time Rapides Parish was the only parish south of the Red River to not have awarded an exclusive contract to Acadian Ambulance since it had not shut down its local squad.

Rapides Parish also had the cheapest ambulance rates in the state at the time because of the competition between the two services.

My column at the time was against shutting down the local ambulance service because if they shut it down ambulance rates would go up.

It had nothing to do with Acadian not providing a good service because it did provide a good service as was an extremely well-run and respected service. It also had nothing to do with contacting Acadian since that company was in Lafayette which is a mere 90 miles south on I-49.

No, it had nothing to do with any of that it had to do with nothing more than good business practices of competition and local control.

Eventually the police jury did shut down the local ambulance service and guess what – rates went up. A lot. And the citizens of Rapides Parish no longer had a voice in how things were run. It was a step down a slippery slope.

Here in Calhoun County, we took a step down that slippery slope a while back when the Town of Grantsville decided to close its trash department and allow Waste Management to take over.

So far it has been OK with only a slight rise is costs to the individual customer. But part of that may be because of competition in other locations in the area-wide pickup area -- competition seems to have that effect.

The newest give away (sale) the town is considering is selling the water department to West Virginia Water, a company headquartered in Germany with local offices in West Virginia. The town says this needs to be done because the citizenry of Grantsville balked at a 60 per cent rate hike asking for the state's public service commission (PSC) to step in and take a look.

So, failing to go with a huge rate hike the town threatened instead to sell the water company to West Virginia Water. It basically is some kind of a threat that unless people do what they say something worse will happen. That's just wrong.

What should happen is that any decision on the water problems of the town should be tabled until after next year's town election when the new city government will have an opportunity to work on the problem. It's only fair, and the people of Grantsville and both public service districts the water plant supplies – Mount Zion and Pleasant Hill – should demand that is what happens.

There is a town council meeting scheduled for Monday at 6 p.m. at the city building and I think people affected by this should show up en masse to demand that they have the final say in what happens with the water department. It is your right and responsibility so be there.

HACKED: I guess one of my Facebook profiles may have been hacked recently because one of my friends contacted me asking if this plan I suggested for them to make money actually worked.


What plan I asked? You didn't recommend a plan? Uh, no. They told me I must have been hacked so I posted a thing saying I may have been hacked.

Recipe Corner by Emma Howell

Breakfast Sausage Ring

1 roll of bulk Jimmy Dean sausage (any flavor)

2 7.5 oz cans of Pillsbury Buttermilk Biscuits

2 cups shredded Cheddar or Monterey Jack cheese

Preheat oven to 350. Brown sausage in frying pan, drain. Open one can of biscuits and flatten each biscuit into larger circle.

Place in bottom of greased bundt cake pan, overlapping each biscuit so that it makes a ring around bottom of pan.

Top biscuits with 1 cup of shredded cheese, next place cooked sausage on top of cheese then top sausage with remaining 1 cup cheese.

Open second can of biscuit dough and flatten out each biscuit, repeat placing dough around the top of bundt pan so it looks like a ring.

Cook for 25 min or until golden brown. Let sit in pan for 5-10 min before inverting onto a plate. Slice and serve.

This makes a gorgeous centerpiece for a breakfast buffet! Note: If you like spicey....choose Jimmy Dean spicey hot sausage and use Pepper Jack Cheese!

Heaven In A Bowl

1 package fudge brownie mix

2 packages miniature Reese's

4 cups cold 2% milk

2 packages instant vanilla pudding

1 cup creamy peanut butter

4 teaspoons vanilla extract

2 8 oz thawed cool whip

Step 1: To make the brownie batter, just follow the directions on the box. Then pour the batter into a 12x9 inch pan that has been buttered.

Step 4: In a large bowl, beat the pudding with the milk for 2 minutes. A thick mixture is the desired consistency. Put in the vanilla extract and peanut butter. And combine thoroughly. Mix in $1\frac{1}{2}$ cups of whipped topping.

Step 5: Place 1/3 of the brownies in a glass dish that holds 5 quarts. Top with the remaining peanut butter cups and 1/3 of the pudding.

Step 6: Layer again, and again.

Finally, sprinkle the remaining topping and the saved peanut butter cups on top.

Put in the refrigerator for a few minutes to chill before serving.

Charleston, W. Va. - A verbal complaint was made today to the WV Secretary of State's Office calling attention to inaccurate election information being sent to West Virginia voters by a statewide candidate or committee.

According to WV Secretary of State Mac Warner, it appears as if thousands of West Virginia voters received text messages communicating the incorrect dates for early voting and Election Day.

By state law, Warner reminds voters that early voting in West Virginia begins Wednesday, May 1, and the Primary Election Day is Tuesday, May 14.

Secretary Warner said that voters should rely on only trusted sources for election information. Those sources are the county clerks and the WV Secretary of State's Office.

'Even well-intended organizations and candidate committees encouraging voters to participate in the election process get the information wrong sometimes," Warner said. "Those organizations, candidates, political parties, and political action committees should always refer voters to their county clerk or Secretary of State's website."

In a complaint filed in the Magistrate office of Lora Davis, Trooper J.D. Richards stated that on or about Sunday, August 27th, 2023 at approximately 1:30 p.m. Trooper Richards was contacted by Calhoun County Dispatch regarding an incident where a female juvenile had been shown genitals of an adult male via a FaceTime video.

The Trooper traveled to the address of the 17 year old juvenile and spoke with her. The victim stated to Trooper Richards that the male had contacted her via facetime earlier on the same date at approximately 8 a.m. The victim also disclosed to the Trooper that the male, Terrence Jason Holey DOB: 05/21/1986 of Lizemore, WV, Clay County, showed his genitals to her. The victim stated

that the accused's genitals were shown out of nowhere shocking the victim and causing her to drop her phone, letting out a scream. The victim stated that this awoke the other residents in the house up. Trooper Richards inquired of the victim if any act like this had happened before to which she replied that the accused had acted "weird" towards her recently.

All acts in this complaint, including the receiving of these messages and facetime occurred in Calhoun County, WV.

With all facts considered, this Trooper requested an arrest warrant for the accused for the charges of soliciting a minor, distribution of obscene material to a minor, and use of obscene matter with intent to seduce minor.

Holley was arrested on April 22, 2024 and taken to the WV Central Regional Jail where he awaits trial on a \$100,000 bond.



Safe Digging: Call 8-1-1 before digging; it's the law.

Although excavation damage is the leading cause of serious pipeline incidents, it is easily preventable with one call. With construction sea-son in full swing, Domi-nion Energy West Virginia reminds homeowners and excavating contractors to dig safely and comply with state law by calling WV811, toll free, at 8-1-1 or 1-800-245-4848 before excavating. You can also get information by going to www. WV811.com

To prevent potential injuries from accidental utility line dig-ins, state law requires customers and contractors to call WV811 at least two working days before digging. Third-party damage is the leading cause of accidents involving utility lines.

WV811 will alert Dominion Energy West Virginia and other parti-cipating utilities of custo-mer and contractor plans to dig.

WV811 will ask these utilities to mark the approximate location of their underground gas lines and utility cables, so that customers won't find them by accident. Also, for safety's sake, customers and contractors should only dig around utility lines by hand.

If you do come in contact with a pipeline or smell natural gas (though natural gas is odorless in nature, mercaptan, a non-toxic chemical odorant that smells like rotten eggs, is often added to make it easier to identify), be alert and follow these steps: Stop work and evacu-ate to a safe distance

--Alert everyone on the premises; Do not strike a match; use a telephone; operate engines and motors; or switch on/off appliances, lights, or even a flashlight in the area where you smell gas. These items can produce a spark that might ignite.

--Once safe, call 911 if there is blowing gas.

--Call the emergency number provided by the natural gas operators in your area: DEWV custo-mers call 800-934-3187.

--Do not try to fix the pipe or slow the rate of leaking gas.

--Do not try to extin-guish a gas-burning fire unless there is a threat to life.

--Do not operate any of the gas company's valves.

WAG ASKING FOR HELP FINDING FERAL CAT COLONIES

The Welfare of Animals Group (WAG) is asking Calhoun county residents to help us address a long-observed problem with our animal community - feral or community cats.

If you feed a feral cat colony in your neighborhood, or know someone who does, please call Linda at 304-354-7506 or notify us via our email calhounwag@ yahoo.com.

Our humane and effective Trap-Neuter-Return (TNR) program's volunteers will live trap the cats, take them to the vet to be spayed or neutered, vaccinated for rabies, respiratory disease, worms, and fleas, and returned them to their outdoor home, at no cost to the colony's caretaker.

The colony will be healthier and no longer producing unwanted kittens.

At four months old a female kitten can start breeding, and can have 2 or 3 litters per year. A mother cat nursing a litter of kittens goes back into heat when the kittens are only 3-4 weeks old.

Removing cats from an area (i.e. catching and killing) is useless.

When cats are removed from an area, then new, unsterilized cats move in to take advantage of available resources – and begin reproducing. This well-documented natural trend is known as the "vacuum effect."

From Whence Jobs, Calhoun?

Over the course of this campaign, I have talked about flood control and water expansion, about roads and about commissioners keeping office hours at the courthouse.

But the subject I have discussed the most with voters, about which they have the most questions, is bringing opportunity to Calhoun.

They are used to, but dissatisfied with the same old refrain. Charleston! Charleston!

How are we going to bring jobs here? Charleston, Charleston, gee how you can shuffle!

How are we going to save the county from running out of children in four decades? That dance called Charleston. Politicians talking to

politicians isn't going to bring us a factory. There are only so many jobs at the school, at State Highways, and at the Hospital. We need solid, career-grade, private-sector jobs. Jobs that stand on their own, not subsidized to the gills to provide a critical service.

Where are these jobs? Not in Charleston. That is for sure. Getting jobs in Calhoun County is a sales problem. If you're looking for new customers, you don't go and talk to the customers you already know. You go out and talk to new people.

Here's how to go about getting the opportunity we need to Calhoun County. First, what do we have to offer? To a business, the most attractive aspect of this county is inexpensive and abundant natural gas. We are also largely free from the burdensome regulation and excessive taxation that stymies business in other jurisdictions. Other fine features are the solid work ethic of the people of this county and inexpensive land.

Unfortunately, where we excel in the quality in our people, we lack in quantity. Similarly, every red cent you'd save on Calhoun land would be lost in pushing the clay into something the slightest bit flat. Drawbacks? Certainly, but we can work around them.

The next thing is to identify industries that would find our offering most attractive. To dothis, we would trawl through industry publications and journals and the like to find complaints about rising energy costs making businesses struggle.After industries are identified, we'd next go to the Thomas Register and start looking up businesses in those industries. We start with a wide net, with thousands of prospects, and begin to narrow our focus for the best suited prospects.

Ideally, we are looking for energy-intensive businesses that are profitable, employ 25-75 people, and are located in expensive, high-tax areas such as the West Coast or Northeast which also often have high energy expenses, burdensome regulation, and exessive taxation. Here, hopefully, we narrow things down to hundreds of candidates.

Further research will give us organizational charts and other particulars about these companies so we can begin to adjust the presentation of our offering for particular business. Once we know what decision maker in the business we need to talk to, we call and send brochures. This cold calling is where we will lose the most potential candidates, but that is just the nature of sales.

We might get a dozen or so responses out of hundreds of calls, but from here a dialog is open. We can ask the customer questions to further tailor the offering and to teach the business just how much they would benefit from relocating here.

Finally, there would be face-to-face meetings and bringing a team from the company to visit Calhoun and look at potential locations and meet with local leaders. Workforce WV has already expressed interest in being at the table. The Independent Oil and Gas Association and the Gas and Oil Association would probably also be there, as would be various community leaders, associations, and even businesses that would service the new factory.

We might only get one from a thousand, but we have to start with that thousand to have a hope of getting that one. All we need is one to three, and we will be alright.

Voters have asked me a lot of questions about this process, so I will try to highlight some of the most frequently asked questions. Why are we looking for one to three businesses employing 25-75 employees each? The county population and the population of surrounding counties is unlikely to support more than 500 new jobs.

Every job at a large business results in additional jobs in the community and the influx of funds diffuses through the area. A single employer of 500 would not only create a struggle for services in an area, as was seen in the Bakken Shale region during their oil boom, but would represent a single point of failure where the county would be very dependent upon that business, creating a disparity of power that would not be to the long-term benefit of the county. If such an opportunity arrived, I would probably seize upon it as a man drowning, but I would not seek it out before trying to find businesses that would be a better fit. How are businesses going to come here without good roads? The county line is just 4-1/8 miles from the I-79 interchange at Big Otter. Businesses try to locate within 5 miles of an interstate. The increased traffic should result in road improvements to WV-16 in Clay County that will see more of the interior of Calhoun County become accessible to business. If all this is public knowledge, why aren't businesses coming here already? Public knowledge isn't necessarily common knowledge. Just as Houners are often surprised when my wife talks about how well behaved the students are here compared to other parts of the country, just as people here are surprised to find out how low their taxes actually are, people in the Northeast and West will be surprised at how much we have to offer compared to their current locale. As the Declaration of Independence says, "...(A)ll experience hath shewn, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed." A large part of salesmanship is circumventing the human tendency to suffer the known rather than risk the unknown. Salesmen do this by making the unknowns known. "For the child that does not know to ask, you must teach him to question." What is the role of a commissioner in this? The inventory tax in West Virginia is a barrier to business, but the County Commissions have the power to exempt some forms of property from that tax. If a business comes in, it would be good to tax their land and building at the going rate, but to exempt their production equipment, inventory, and raw materials from property taxes. Aside from that power, the Commission is best placed to exercise the soft power of bringing the various stakeholders together to make and present a coherent and cohesive offer for the county. What will this do to taxes? At the worst, it will do nothing to your taxes. At the best, it will lower them. The added revenue from factories being taxed at the going rate will improve the county budget. The improvements to the homes of the employed and the new small businesses that will spring up around the new big business will bring still further revenues. With an increase in revenues, there may well be enough to lower the taxes across the board. In my decade of doing electric motor repair, I've been in all sorts of factories. I've learned a lot about what makes them tick, what they need to survive and to thrive. I've sold a lot of things to factories over the years. A county or, at least, the idea of a county would be the biggest thing I've ever sold to a factory, but I am sure I can make that sale.

Grantsville Water Rate Injcrease Delayed Once More Because of Missing Information

In a report received yesterday from the PSC, sent to all parties concerned with the recent appeal against the Town of Grantsville's rate increase request, the WV Public Service Commission stated that the current hold on consideration was continued until May 1, 2024.

This was done to allow the Town of Grantsville to make any objections that it may have to the initial staff memorandum filled April 24th, 2024.

The Procedural Order stated that the Commission suspend a rate ordinance passed by the Town of Grantsville and tolled the statutory deadline.

The commission also tolled the statutory deadline related to the wholesale appeals filed by Mount Zion Public service District and Pleasant Hill Public service district. The commission concluded that Grantsville did not provide the necessary financial and engineering information necessary for the commission to establish rates.

On April 12, 2024 Grantsville was ordered to file the necessary documents to enable the Commission to make a meaningful review of its ordinance as soon as possible.

By April 24th, 2024 the PSC staff concluded that Grantsville had not yet provided sufficient information to restart the statutory clock. Staff listed certain financial and engineering documentation it believed was necessary to start the statutory clock.

Once the items missing are addressed and received the Commission will advise all parties of the case being placed on the docket for further proceedings.
