

The Calhoun High School alma mater. How many remember the lyrics? Probably not too many but people who attended the school while it was still located in Grantsville will have memories of the school that they may wish to share with others.

Currently about 170 people have signed up for the July 6th Calhoun High School All-Classes Reunion which will be held at the New Calhoun Middle/ High School at Mount Zion. The earliest classes are 1948 and 1949.

This will be the first All-Classes Reunion in five years.

That means there is not much chance of anybody remembering the 1942 student unrest, court case or fire that hit the high school leaving only its stately cutstone exterior standing.

Students had to attend class all over the town while the school was rebuilt.

According to an article in the Parkersburg News and Sentinel in 2021 in February 1942, the school caught fire and the whole interior was destroyed. But with the strong structure from the sandstone, Former CHS teacher and principal and historian Robert Bonar said the outside was not damaged.

After the fire, students relocated to other buildings for their classes. Within

Another piece of the building's history involved a Supreme Court case which happened at the same time as the fire.

11 months, the school reopened.

"There's an interesting court case where they fired the principal (Don Mc-Glothlin) because some Jehovah's Witness students would not salute the flag," Bonar said.

To respect their religious beliefs, Bonar said the principal

would allow the students to step outside into the hallway whenever the Pledge of Allegiance was recited.

The board of education wanted the principal to force the children to say the pledge and it led to a Supreme Court case (West Virginia vs Barnette) which the principal won.

In a February 13, 1988, Chicago Tribune article: "Donald McGlothlin, who lived in suburban Wheeling, died of undetermined causes Wednesday at the Veteran's Administration's Lakeside Medical Center in Chicago, said his son,

"In that decision, the court reversed its own 1940 ruling and said public schools violated some students' religious freedom by forcing them to join in the Pledge of Allegiance each morning.

"Before the ruling, West Virginia schoolchildren were subject to expulsion and delinquency proceedings for being "unlawfully absent" if they refused to participate in the flag salute.

"At a patriotic assembly on Dec. 8, 1941, a student, Lavaughn Kelley, a Jehovah's Witness, refused to salute the flag based on her religious beliefs.

"Paul McGlothlin said that after his father did not force her to salute the flag and did not expel her, he was brought before the Board of Education and forced to resign.

"He believed that everybody should salute the flag, but not because they're forced to. He felt that would undermine democracy," Paul McGlothlin said.

"Several families of Jehovah's Witnesses then challenged the school board policy, and the case went on to the nation's highest court.

"McGlothlin enlisted in the Navy in 1942 and served in the Pacific during World War II. He moved to Chicago in 1954 and was hired as a teacher and remained in education until his death."

Instead of remembering the fire and landmark case most attending the reunion will be remembering friendships, sporting events, long rides on a school bus, going to the local stores or sitting on the pipes in front of the school.

Update for Avalon and 1982 Foundation projects

A new day dawning in Calhoun Coun-

It has been a while since my last update. We have a lot going on here at home, as well as abroad for our other businesses. It is getting very busy on all fronts. Robin is off to Japan today and another team is doing a 10 day tour of India. Meanwhile I will be right here if they need me. If I never have to get on a plane again, I will

be able to manage my disappointment lol. We have a lot going on at the site. Construction is in full swing with contractors everywhere. The Appleseed Children's Learning Center is under way with foundations poured and block going up.

You can now get a good feel for the size from the footprint of the footers. Cold form steel for this section will arrive in July and the building will go up quickly once the contractors start.

The steel for the Varsity Restaurant

section will arrive first and begin installation very soon. We will then be able to enclose this section of the building and install the roof. We have also decided to reroof the main building with long lasting polymer material before the HVAC RTUs are installed. This is an incremental \$280,000 that we had not planned on this early but thanks to some of the grants

we can offset this expense. The elevator arrived last week, and it will take a few weeks for the installation. Once it is in, it will be used to aid in construction.

The masonry restoration began last week and will last for some period of time. All surfaces will be cleaned and cracks in mortar removed and replaced. The entrance to the end of the main building will have to be fully restored to the original design as some of it was removed when the gym section was con-



We would appreciate it if you would not put food out for them on Wednesday, in Orma and Big Springs as we will be trapping on Thursday morning. Once the cats have recovered from

anesthesia (at least 24 to 48 hours) we will return them to their exact location. They will be healthier, happier, and not reproducing and fighting. Thank you for your cooperation. So far, we have spayed and neutered 902 community cats (490 females and 412 males). Please keep your personal cats indoors or put a collar on them on Wednesday the 26th in Orma and Big Springs. Is a Calhoun Hall of Fame worthwhile?



June 27, 1897: Musician Maceo Pinkard was born in Bluefield. The cowriter of "Sweet Georgia Brown," Pinkard was one of the most successful songwriters of the 1920s Jazz Era.



June 27, 1961: Honey in the Rock was first performed at Grandview near Beckley. The play by Kermit Hunter depicts the founding of the Mountain State in 1863.



June 28, 1936: Athlete Chuck Howley was born in Wheeling. A standout in college at WVU, Howley played linebacker for 12 seasons for the Dallas Cowboys. The six-time All-Pro was inducted into the Pro Football Hall of Fame in 2023.

June 28, 2010: Robert C. Byrd died at the age of 92. He was first elected to the U.S. Senate in 1958, and he served until his death.



June 29, 1845: George W. Atkinson was born in Charleston. In 1896, Atkinson was elected governor in an upset victory over Cornelius C. Watts of Charleston, ending 26 years of Democratic rule.



June 29, 1952: Writer Breece D'J Pancake was born in South Charleston and grew up in Milton, Cabell County. Many of Pancake's stories are set in Milton, fictionalized as "Rock Camp."

June 29, 2012: A violent storm called a derecho

raced across West Virginia, leaving downed trees and damaged homes in its wake. About 688,000 homes and businesses lost power for a week during a widespread heat wave.



June 30, 1914: State-wide prohibition of alcohol sales became law years before it was enacted for the whole nation.



June 30, 1929: The Wheeling Symphony Orchestra gave its first concert at Oglebay Park.

June 30, 1944: Harpers

Ferry National Historical Park was authorized as a national monument, the first in West Virginia.

July 1, 1861: Francis Pierpont, governor of the Reorganized Government of Virginia, called the legislature into session. The general assembly reestablished governmental functions, provided for the raising of military units, and elected new U.S. senators and representatives.

July 1, 1937: Watoga State Park was opened to the public. The Pocahontas County park is the largest of the state parks and among the oldest.



July 1, 1971: Southern West Virginia Community College was formed by joining the Marshall University branch campuses at Logan and Williamson. In 1995, the name changed to Southern West Virginia Community and Technical College.

July 2, 1829: Potter and businessman Alexander Polk Donaghho was born. He began a pottery operation in Parkersburg, creating hand-thrown, salt-glazed crocks, jars and other pottery that are avidly collected today.





Gov. Justice signs bill allocating \$50 million for new agriculture lab at West Virginia State University

Gov. Justice recently ceremonially signed Senate Bill 1003, which allocates \$50 million to construct a new state-of-the-art agricultural laboratory at West Virginia State University.

The cutting-edge facility will house laboratory space for both West Virginia State University and the West Virginia Department of Agriculture. It will provide valuable laboratory and classroom space for WVSU faculty and students and play an important role in creating a new School of Agriculture, Food, and Natural Resources at WVSU.

"Agriculture is a core piece of our state's history," Gov. Justice said. "The immense need for a state-ofthe-art agricultural lab is something I discussed during my State of the State Address. I'm glad to see this project finally get across the finish line, and I cannot think of a better home than West Virginia State University. I thank the West Virginia Legislature for agreeing on the importance of this project. We all know this is something that will create a huge impact for the agricultural industry and community in the Mountain State for generations to come."

"This is truly a milestone day in the history of West Virginia State University, and we are grateful to Governor Jim Justice, Senate President Craig Blair, and House Speaker Roger Hanshaw for their vision and dedication in bringing this state-of-the-art agriculture research laboratory to fruition," said WVSU President Ericke S. Cage. "West Virginia's economy is in a strong position for growth in the agricultural fields and WVSU stands ready to help meet the growing demand for a skilled workforce in these areas."

West Virginia State University is the only land-grant school in the country without a School of Agriculture. The laboratory will build on WVSU's expansive agricultural research portfolio and provide students with experiential learning opportunities as they can engage in hands-on research projects.

Gov. Justice first announced the project during his January 2024 State of the State Address and the West Virginia Legislature passed it during the most recent special session.

"This is a proud day, and it's an exciting day for



all West Virginians," House Speaker Roger Hanshaw said. "This new facility will strengthen the WVSU mission to provide support for the state's agriculture community as a land-grant university. Both Governor Justice and President Cage have big visions, and it's no exaggeration to say this state-of-the-art facility will have a positive effect on every single person in this state, as we know a country's food supply is one of the two ways it provides a safe and free economy. Excellent agricultural research is already taking place at WVSU, as well as a strong partnership with the West Virginia Department of Agriculture, and I'm especially proud that in 2023 the Legislature corrected years of inadequate funding for our 1890 land-grant institution to ensure it will always be able to pull down matching funds to continue its robust transformation and growth."

"I'm proud to be with Governor Justice as he signs the bill that will enable us to build a new, state-ofthe-art lab facility for our Department of Agriculture at West Virginia State University," Senate President Craig Blair said. "West Virginians rely on so many critical functions of our ag labs - from food safety to biosecurity – and this new facility will ensure their scientists have the best tools available to continue those jobs. Locating this new lab at West Virginia State will provide a tremendous training ground for students and provide a pipeline of well-trained technicians who can move right into these jobs after graduation."

West Virginia State University is a public, landgrant, historically black university that has evolved into a fully accessible, racially integrated, and multigenerational institution located in Institute, W.Va. As a "living laboratory of human relations," the university is a community of students, staff, and faculty committed to academic growth, service, and preservation of the racial and cultural diversity of the institution. Its mission is to meet the state and region's higher education and economic development needs through innovative teaching and applied research.

Carr Selected for Barr Professional Development Award

Glenville State University Director of International Student Services, Bridget Carr, has been selected to receive the 2024 Pete and Betsy Barr Professional Development Award.

The award, which was first established in 2010 by former GSU President and First Lady Drs. Peter and Betsy Barr, is rotated annually between Glenville State faculty and staff and must be used within eighteen months of being awarded. The award is designed primarily for the recipient to further their professional growth; however, the awardee can use the money to further their area of interest in lieu of traditional professional development activities.

As recipient of the award, Carr had the opportunity to attend the 76th annual NAFSA: Association of International Educators Conference and Expo in New Orleans, Louisiana at the end of May. NAFSA is the world's largest nonprofit association dedicated to international education and exchange, with more than

11,000 members across 4,300 institutions. Attending many informative sessions, Carr learned ways to increase campus and community support for the international student population at Glenville State University. In addition to student support, she was updated on the best practices and rules for admissions, immigration laws, and international student recruiting

"It was wonderful to connect with so many educators from around the world who support international education. I am grateful to the Glenville State University Foundation for supporting this amazing opportunity that allowed me to learn, grow and connect with the international community," Carr said.





Gas prices heading up for July 4th holiday

Average gasoline prices in West Virginia have risen 2.1 cents per gallon in the last week, averaging \$3.34/g today, according to GasBuddy's survey of 1,154 stations in West Virginia. Prices in West Virginia are 14.4 cents per gallon lower than a month ago and stand 7.9 cents per gallon lower than a year ago. The national average price of diesel has risen 2.4 cents in the last week and stands at \$3.76 per gallon.

According to GasBuddy price reports, the cheapest station in West Virginia was priced at \$2.92/g yesterday while the most expensive was \$3.72/g, a difference of 80.0 cents per gallon. The lowest price in the state yesterday was \$2.92/g while the highest was \$3.72/g, a difference of 80.0 cents per gallon.

The national average price of gasoline has risen 0.3 cents per gallon in the last week, averaging \$3.41/g today. The national average is down 18.8 cents per gallon from a month ago and stands 14.4 cents per gallon lower than a year ago, according to GasBuddy data compiled from more than 11 million weekly price reports covering over 150,000 gas stations across the country.

But the good news is that instead of the national average jumping to follow the rising price of oil, it's holding steady. The bummer is that the decreases we hoped for will have to wait, thanks to oil's climb."



Fairmont State University's College of Science and Technology awarded \$2,000 in grant funding



Fairmont State University's College of Science and Technology has been awarded \$2,000 in grant funding from the NASA WV Space Grant Consortium (WVSG): Support for Student Organizations and Higher Education Student Projects in STEM. The funding will support the Falcotronix Robotics Club, a STEM-focused student organization that aims to help Fairmont State students learn about STEM principles through practical engagement with ro-

Falcotronix members participate in VEX U competitions organized by the Robotics Education & Competition Foundation, a STEM curriculum-based robotics engineering competition organization.

"Falcotronix has had its fair share of competitions and events," said Arrington Bucklew, Falcotronix Robotics Club President and Electronics Engineering Technology senior. "We have attended three regional competitions and the VEX U Semifinals this year, where we received the Excellence Award—a qualifying award that invites us to the VEX U Robotics World Championship in Dallas, Texas."

Funding from the NASA WVSG will pay for future travel costs for Falcotronix members to compete nationwide.

"A faculty member's dream is to see

their students engaged in high-level, international competitions related to the domains they teach," said Musat Crihalmeanu, Associate Professor of Electronics Engineering Technology, Falcotronix faculty mentor, and principal investigator on the grant. "Advising students and ensuring they have the best conditions to compete and win in robotics—that is a dream come true."

Students in robotics learn about different aspects of STEM through handson interaction.

"The action of building robots is complex and incorporates assembling hardware pieces like electronic motors, valves, and sensors, which is present in the engineering component of STEM. The science and technology components are present in physics and computer sciences used to design code to produce the programs downloaded in the 'brains' of the robots," said Musat.

"There is no better way to understand the material in my textbooks than to engineer and create something from scratch," said Bucklew.

WV Space Grant Consortium is a NASA-sponsored organization comprised of West Virginia academic institutions and corporate and scientific partners. WVSGC is dedicated to building research infrastructure and promoting STEM education in West Virginia.

According to a story at WVMetronews.com Toney, who makes the chili often for the Calhoun County High School Band, said the recipe spans generations in her family.

"My mom was band director, her mom made gallons, so since the 40s, this recipe has been around being made as the Band Boosters hot dog sauce. It's quite old," Toney said after being presented with the top prize at the state Culture Center. "It may be older than that, we're still looking but we know at least the 40s."

The recipe, which is made up of countless ingredients, has seen some changes over the decades including the base tomato sauce which was later replaced with ketchup. Toney says the chili has a great taste but can't be made in just an instant.

"It's the taste, it is. It's a very great taste

but it's got so many things in it," Toney said. "It's not something you can throw together quickly. You've got to cook."

The chili was by no means exclusive to the confines of the family's home, as Toney shared the impact of the sauce around her area over the years.

"We'd make gallons and gallons of it," Toney said. "You'd get together, and we would make it, and freeze it, and have it for the football games. Now we serve it at the Calhoun County Wood Festival."

Toney and her mother (Jacqueline Pitts Blankenship) were happy to see people from all over the state try their chili on Thursday, and now they want to see it served in more areas.

"This is amazing," Toney said. "We've gotten it in a couple of other counties because some of us have branched off, but now, maybe when we go to events in other counties, we'll see this sauce being sold at the athletic boosters."

Toney received \$500 as the winner of the contest.
