Candid update on AMC-Calhoun County going forward

Grantsville, West Virginia 26147

I promised you that I would give you a detailed update on the visit from the American Medicines Company (AMC) executive team last week.

We attended the West Virginia Chamber of Commerce Business Summit to see if we might be interested in locating in West Virginia. Long story short in December of that year we met with Governor's Office, Economic Development, Commerce, and a few more groups in Morgantown and the team decided right then on the spot that the first location would be West Virginia. We received a very, very warm welcome and many ideas on how to partner to bring American made medicines for Americans to my home state of West Virginia.

AMC as many startups do operated in stealth mode for about a year for competitive reasons. We then announced the project at the Wes Virginia Chamber's Women's Conference shortly thereafter.

AMC in the meantime has been doing engineering design and product development, commercialization and go to market strategies, securing the capital stack, and of course searching for a site.

Our team visited Calhoun two years ago with a less than optimistic view on the possibility of locating here. I was heartbroken, but I knew what they had seen was true and problematic.

I also knew we were on the beginning of a journey here to restore hope, optimism and life to our community. We addressed many issues head on. Some which were not well received and some that will never be acknowledged as problems by those who caused them. This is unfortunately typical of change efforts and to be expected. The good news is that those folks don't have an impact sooner or later. In our case, it was sooner.

We have had much change in the last two years. Many changes in leaders and many new leaders and influencers have emerged who are not on the payroll but who genuinely want to be part of the change effort. It is an effort. It takes a plan, focus, resources, heart, and hard work. Nothing worth having comes easy, but that is OK here because we are not afraid of hard work.

Fast forward to last week ... in fact, to the feedback session on Wednesday after the all-day meeting the day before.

The first comment was from one of the other owners, her response was that the transformation is obvious, clear and exciting to see. She saw hope and optimism that she did not see three years ago.

My other business partner's comment was the excitement and passion for the change effort is palpable. He was very impressed with all the people he met and could see how we can put together a strong workforce by building our own with a technical training program in partnership with the Calhoun-Gilmer Career Center and Glenville State University work force development programming.

Then for the tough one ... our start up CEO. On Tuesday while looking out the back of the armory onto some of the most beautiful rolling hills in West Virginia, I got her to conclude that the question is if we locate here what will we be missing?" Then and there I knew I had her. I said nothing but let her ponder on her own question. She is a brilliant lady. Her education is in biotech engineering and an executive MBA. The daughter of a world diplomat. She is as polished as I

team can easily do that as much of the plans are ready but just need consolidated to a simple document. They also suggested to continue to work on the areas where we have already made huge progress like the cleanup. They were very impressed with how clean the road ways looked and just in general that everything was much tidier. Of course, they were glad to hear that there is state money for dilapidated abandoned structures as well for building new homes both of which we know we need and are planning accordingly. They were pleased with the infrastructure investment and could easily see that this

and we anticipate another visit from the team as they make progress down the path for funding. This executive team are experts, and they have connections at the highest levels of government. They are working tirelessly with our strategic advisors to secure the funding, customers, suppliers, and all that is needed. They also make me very proud. I hope that all of Calhoun can commit to continued progress, because if something happens and we don't get the funding or this plant, then we will go after another. Our destiny is in our own hands. It is in the hands of people who make things happen.

Concrete poured for foundation of child care center at Avalon





Work is continuing and even speeding up on the Avalon campus with groundwork nearing completion for the childcare center and its cafeteria.

This past week 150 cubic yards of concrete was poured to serve as the foundation for the childcare center and cafeteria which, as soon as the concrete is cured, will allow construction for that facility to

At the same time concrete was poured at the gymnasium entrance which will allow work to be done on that building.

The childcare center and cafeteria will be located roughly on the same spot as the vocational agricultural center and the old cafeteria and band room of the old high school.

Meanwhile work has been ongoing on the back side of the high school where classrooms and a vacant part of the building were located. This is an area where the Varsity Grille will be located. Currently girders are being installed and work has been done to install an elevator in this area.

General refurbishing work is also con-





tinuing in the main building of the old Calhoun County High School and will continue until completion.

Other than the work on the campus itself other things are under way such as setting up a Farmer's Market.

"We have great news," Crystal Laughlin Mersh said, "Avalon will be opening our Farmer's Market this season. We want to focus on fresh produce first and then expand from there. We are very excited that Jennifer Holland will be leading the Farmers' Market. Jennifer will be announcing soon the plans for starting and the process."

The market will be held on Saturdays from 9:00 to 1:00 at the pavilion on Wayne Underwood Field. There is no charge to participate.

Also, the purchase of swimming tickets for the youth of the community is nearing 1,000 passes and should exceed the hoped for goal of 1,100 soon.

And, on top of all that, the menu at the pool's restaurant - Tiki Taco - has been enlarged several time.

Justice announces State of Emergency for all 55 counties due to dangerous drought conditions

Despite some rain that some of us may have received in the past few days Calhoun County and the surrounding counties of Clay, Braxton, Gilmer, Ritchie, Roane and Wirt are all under a state of emergency because of drought conditions.

To support West Virginia's farming community, Gov. Jim Justice declared a State of Emergency for all 55 counties due to a prolonged shortage of rainfall that has

caused dangerous drought conditions. The U.S. Drought Monitor indicates extreme, severe, and moderate drought conditions have impacted the entire state.

This drought has plagued West Virginia farmers, putting them at risk of losing everything," Gov. Justice said. "We cannot and will not stand by and watch our hardworking farmers suffer from this severe lack of rain. We understand the immense stress and hardship this drought has caused. Right now, our Emergency Management Division is working tirelessly to secure disaster assistance for those in need. Until then, we are committed to doing everything we can to support our agricultural community during this chal-


lenging time." With this proclamation, Gov. Justice has activated the Emergency Operations Plan,

instructed personnel and resources to be ready to respond to any emergencies, and granted specific administrative powers to the Director of the West Virginia Emergency Management Division to ensure essential emergency services are provided efficiently.

This State of Emergency will remain in effect for thirty days unless terminated earlier by another proclamation.

LETTER TO THE EDITOR Water proposal

Long Term West Virgina Water Management and Training Proposal West Virginia, especially its rural counties, have had a history of water issues, including, but not limited to, water quality, supply vulnerability and contamination along with training and retaining trained work-

It is our belief that we can overcome and manage these issues, in cooperation with state input and funding, to the benefit of all West Virginians.

Calhoun County is in what we feel to be, in a unique position to help. Again, this is just a proposal to gauge interest and if it is deemed feasible, we can put together a detailed plan with hard numbers and all the required parties consent.

In that vein, we will only interject briefly some of the main idea: Calhoun County, like most rural communities, struggles to train and retain qualified water personnel. But Calhoun is well positioned in several respects. We have Glenville State University and the Calhoun-Gilmer Career Center. By using either one or both, we can develop a water training program that will allow prospective employees and students to choose the career path of their choice.

For the most immediate impact, we propose to develop with the career center to train both current workers and prospective students in all phases of water and wastewater plant operations, including but not limited to water treatment and sewage plant maintenance, leak detection and pipe replacement, water main installation and repair, and all other skills necessary to maintain and keep the plant in operation.

For those interested in going beyond, we suggest that we partner with Glenville

State and or WVU to develop a program in Water and Waste Water Science. Those students could, depending on career objectives, pursue either an A.A. degree or bachelor's degree. Thesis students would still get the benefits of attending the career center by having to complete their curriculum but would also complete advanced studies. Courses could include engineering related to water delivery and chemical treatments, etc., as well as managerial other support deemed by professional educators and trainers.

By training students on site, part of their training would include hands on operation in the actual plants, plus possible summer jobs working as operators in training gaining valuable hours which could be applied to certification. For seasoned workers, classes could be offered that could train in the latest technology and legalities. For university students, a minor in Water Science could also be possible. West Virginia has the highest water rates in the country, in part, due to lack of trained workers and infrastructure.

This basic proposal is just that -- a starting point to address long-term solutions to issues that water facilities face daily.

It will take the cooperation and coordination of governmental institutions and lawmakers to the educators and water plants. If feasible, our county, with governmental affirmation, would be privileged to enter the above named entities to gauge their interest in such an endeavor. We leave that up to those who have that decision making ability.

And all I can say is I am sorry.

I do not blame the post office because the situation does need to be rectified and it will be. I am just sorry our customers had to get caught in the middle.

I must be honest I have years or newspaper experience, but it all has been in the editorial end of things. I have never worked in circulation or advertising and my lack of experience there can quickly

Now, I guess, I will need to learn how the circulation department and advertising department work too.

Lord, please help me.

HALL OF FAME CANDIDATE NO. FIVE: This one is a little personal to me since he was my teacher, my coach and, whether he knew it or not, my friend. That was because the lessons he taught became many of the tenets of my life.

Dick Sturm, also a coach, teacher and mentor, said of Ivory Wayne Underwood "he was not a great man because he was a great coach, he was a great coach because he was a great man."

And nothing could be truer. He was both a great coach and a great man and anyone who knew him is better off for it.

He started his head coaching roll at Calhoun High School in 1946 and posted a 125-33-7 record with undefeated teams in 1948, 1950 and 1959. Despite being undefeated here it was a different time, the Red Devils never made the playoffs because at that time only two teams in each division made the playoffs and Calhoun was in the same division (Class A) as schools such as Parkersburg, Beckley, Charleston and Huntington.

"Lots of nights he would get of out bed and work on plays he was devising," said

his son Sidney in an interview with the Hur Herald. "They were always offering him deals to leave Calhoun, but we all liked it here."

"Coach Underwood was a different individual. Very mild-mannered. He didn't rant and rave," said former player Dick Sturm and also a hall of fame coach. "He traveled around the county conducting summer activities for young men and so on. We played baseball and he would take kids from one area over to another area to play and spend time with those, not only the participation in athletics but it gave us knowledge of kids in other areas."

Sturm says Underwood was truly ahead of his time.

"Defensively, he developed a pattern that was later picked up secondary rotations and things like that it was later picked up by the New York Giants. A couple of years before that, Coach Underwood installed it there at Calhoun.

Friday nights at old Underwood Field in downtown Grantsville were special.

"Probably that was one of the largest gathering of people in Calhoun County was on Friday night football," Sturm said. Lives changed in Calhoun County on

October 26, 1967, when Underwood passed away suddenly of a heart attack at the age of 53. He was at the school he loved.

"That was devastating to the whole county. He was so well-respected and admired by people," Sturm said. "He had chances to leave, but he and his family just loved Calhoun County."

He was born in West Union and attended Doddridge High School before going to Davis & Elkins. He transferred to Marshall when his coach Cam Henderson left D&E to become head football and basketball coach at Marshall.

From the Marshall Hall of Fame "Henderson's first Marshall football team turned in a 4-6 record, but things changed quickly. With Wayne paving the way along the line and Forest as an assistant coach, Marshall went 6-3-1 in 1936 and then in 1937 won the Buckeye Intercollegiate Athletic Conference title with a 9-0-1 record.

"Wayne won All-Buckeye Intercol-

legiate Athletic Conference honors in 1936 and 1937 and received honorable mention on the 1937 Associated Press Little All-America Team. After graduating from Marshall Wayne - and Forest played professional football, Wayne with the Nashville Rebels of the American Football League in 1938, the Cleveland Rams of the National Football League in 1939 and the Cincinnati Bengals of the American Football League in 1940."

Wayne's older brother Forest became the football coach at Huntington East High School and was named the West Virginia Coach of the Year in 1946, served as an assistant coach at Marshall from 1955-65 and later was a delegate in the West Virginia legislature from 1975-81. Forest and Wayne's younger brother, Ted, was a football player and later head coach at Salem College and is a member of that school's hall of fame.

Wayne Underwood was inducted into the West Virginia Sports Hall of Fame in 1982 and the Marshall Athletic Hall of Fame in 1987.

The Little Kanawha Conference (LKC) coach of the year award is the Wayne Underwood Award as is the award given to the top male athlete at Calhoun High School.

If you ever were a sports fan in Calhoun County you have heard the name Wayne Underwood and I am here to tell you "He was not a great man because he was a great coach, he was a great coach because he was a great man."

Aug. 1, 1921: Baldwin-Felts detectives shot and killed Sid Hatfield and Ed Chambers as they approached the McDowell County Courthouse in Welch. As Matewan's police chief, Hatfield had assisted the United Mine Workers' campaign to organize Tug Fork miners.

Aug. 1, 1940: Justice Franklin Cleckley was born in Huntington. In 1994, he became the first Black justice to serve on the West Virginia Supreme Court. The Supreme Court once referred to Cleckley's handbooks on evidence and criminal procedure as "the bible for West Virginia's judges and attorneys."



Aug. 2, 2009: Golfers Sam Snead and Bill Campbell became the first two inductees into the

West Virginia Golf Hall of

Aug. 3, 1897: Fire destroyed much of downtown Lewisburg. The town rebuilt and evolved in the next century into the hub of one of the state's major farming areas and a center for education and the arts.



Aug. 3, 1907: Harley Orrin Staggers Sr. was born in Keyser. Staggers served in the U.S. House of Representatives for 32 years.



Aug. 4, 1824: John Jay Jackson Jr. was born near Parkersburg. Jackson was

a prominent judge who became notorious among those trying to organize labor unions in West Virginia. He blocked an effort by Mother Jones and United Mine Workers leaders to organize the miners of northern West Virginia.



Aug. 4, 1897: Musician William Jennings "Billy" Cox was born near Charleston. Cox, known as the "Dixie Songbird," ranked as one of West Virginia's premier country music vocalists and songwriters during the 1930s.

Aug. 4, 1930: Lewisburg set the record for the state's hottest temperature ever: 112. Six years later, Martinsburg would tie it.

Aug. 5, 1958: Jennings Randolph defeated former governor William Marland in the Democratic primary for U.S. Senate. Randolph soon became the senior senator from West Virginia and served for 26 years.



Aug. 7, 1864: In what became known as the Battle of Moorefield, Union troops under Gen. William W. Averell attacked the headquarters of Gen. Bradley Johnson. The Confederates were routed and fled south into the town; the Union captured 500 men and 400 horses.

Aug. 7, 1877: West Virginia voters chose Charleston as the state capital over Clarksburg and Martinsburg.

Aug. 7, 1893: Parsons became the county seat of Tucker County. Parsons was named for Ward Parsons, a prominent resident and the largest landholder.







Warner and County Clerks to celebrate August 1 as National **Poll Worker Recruitment Day**

The state of West Virginia has teamed up again this year with the county clerks, the U.S. Elections Assistance Commission (EAC), and other states in a national poll-worker recruitment effort heading into the 2024 General Election.

According to Secretary of State Mac Warner, National Poll Worker Recruitment Day is a national effort to address the ongoing need for poll workers and to inspire civic engagement. Warner's administration has been recognized nationally for its efforts over the last seven years for working with veteran's groups, the WV Board of Realtors, and students to recruit poll workers.

"Poll workers are critical to facilitating the election process and instilling confidence in voters," Secretary Warner said. "To ensure that we have accessible, safe, and accurate elections we need to fully staff every polling place with trained poll

Since 2020, the WV Secretary of State's Office has teamed up with the EAC and other stakeholders to promote National Poll Worker Recruitment Day and encourage registered voters to be poll workers for early voting and on election day. Currently there are 1,704 voting precincts throughout West Virginia, which requires more than 8,000 poll workers to

adequately, safely, and securely manage those precincts on election day.

"Being a paid poll worker is a great way to participate in our democracy right here in West Virginia," Warner said. "The most secure way to cast a confidential election ballot, free and clear of any undue influence or intimidation, is to do so at a polling place staffed by trained poll workers selected by the political parties. Ensuring there are enough poll workers to assist voters is always a priority for the Secretary of State's Office and the county

Poll workers in West Virginia must be registered voters. Individuals who volunteer to be poll workers in their home county are paid an amount set by the county commission for their services.

Secretary Warner is asking any registered West Virginia voter who would like to learn more about becoming a poll worker for the upcoming November 5 General Election to complete the short and easy Poll Worker Application on or

The selection was made by a National Board that is chaired by the U. S. Department of Homeland Security's Federal Emergency Management Agency and consists of representatives from American Red Cross; Catholic Charities; National Council of the Churches of Christ: The Jewish Federations; The Salvation Army; United Way Worldwide. The Local Board was charged to distribute funds appropriated by Congress to help expand the capacity of food and shelter programs in high-need areas around the

A Local Board made up of local service agencies in the area will determine how the funds awarded to Calhoun County are to be distributed among the emergency food and shelter. The Local Board is responsible for recommending agencies to receive these funds and any additional funds available under this 15, 2024.

Under the terms of the grant from the National Board, local agencies chosen to receive funds must: 1) be private voluntary non-profits or units of government, 2) be eligible to receive federal funds, 3) have an accounting system, 4) practice nondiscrimination, 5) have demonstrated the capability to deliver emergency food and/or shelter programs, and 6) if they are a private voluntary organization, they must have a voluntary board. Qualifying agencies are urged to apply.

BUILD WV – Housing Development Tax Credit

Passed in the 2022 Legislative Session, the BUILD WV Act aims to assist West Virginia's growing communities in attracting much-needed housing development projects. The credit offers a State Sales and Use Tax exemption for building materials and a 10-year property value adjustment refundable tax credit to offset building costs. West Virginia is one of the fastest growing in-bound states, and the demand for new, residential properties has never been higher.

The West Virginia Department of Economic Development (WVDED) oversees the program and reviews all applications. A non-refundable application fee of \$5,000 is required to apply. Projects must apply and be approved prior to the completion of construction.

The BUILD WV Act allows for the following incentives for approved BUILD WV Projects:

Sales Tax Exemption – Purchases of building materials, tangible personal property, and services by a construction contractor or subcontractor directly used in the construction of a certified BUILD WV project are exempt from consumer sales and service tax.

Property Value Adjustment Credit (PVAC) - PVAC credit can be taken against personal or corporate income tax of the eligible taxpayer, beginning in the tax year in which construction of the project property is completed and ending in the 10th taxable year thereafter. This tax credit is refundable, up to \$100,000 per project.

Potential for B&O Tax Exemption – To

be determined by individual municipalities, authorized by an ordinance.

Attorney General Morrisey: Federal Court Halts Biden's **LNG Export Ban**

West Virginia Attorney General Patrick Morrisey, along with a collation of 16 states, has won a stay of the Biden administration's ban on new liquefied natural gas (LNG) exports.

The U.S. District Court Western District of Louisiana Lake Charles Division granted the coalition's motion for preliminary injunction and ordered the LNG export ban "be stayed in its entirety, effective immediately."

"This is a big win for the country's energy industry and the millions of jobs it supports against the attacks from the Biden administration to further its radical climate change agenda at the expense of our economy," Attorney General Morrisey said. "This administration's Energy Department has no such authority to justify this ban— authority on matters like this lies with Congress and Congress alone."

The Attorney General also co-led a 22-state letter in February urging the administration to end its pause on LNG ex-

On Jan. 26, Biden halted all new approvals of LNG exports to non-Free-Trade Agreement countries effective

immediately. That decision ignores the Natural Gas Act's presumption in favor of exports, decades of Department of Energy policy and state and private reliance on exports.

West Virginia is the country's fourth largest producer of natural gas. As the coalition's motion explained, the LNG ban threatens the tens of millions of dollars of severance taxes that West Virginia derives from natural gas and the thousands of jobs supported by the industry in the state.

The court's order noted that the states had shown "evidence of harm" from the ban "specifically to Louisiana, Texas, and West Virginia in the loss of revenues, market share, and deprivation of a proce-

dural right." International trade in LNG has spiked in part because of the abundant natural gas resources in the U.S.

The U.S. is the world leader in natural gas production and became the top exporter of LNG in 2023—exporting an unprecedented 86 million metric tons. There are also nearly 187 million Americans using natural gas, supporting more than four million jobs.


