Rebound? Yes, we are seeing it a little

Is there an economic rebound in Calhoun County under way?

Well, yes, especially where the 354 meets the 655. It is happening where the southern end of the northern part of the county meets up with the northern end of the southern part of Calhoun.

To wit look at where the new businesses have opened in the last three or four years. Starting at Mount Zion the old National Guard Armory was repurposed into two stores and a laundromat and has provided employment and services for the community.

About a mile further south on South Calhoun Highway (Route 16) the Kwik Stop is a convenience store, restaurant and gasoline station providing needed services for the middle-high school students and staff and visitors.

Going down Route 16-33 there is new ownership of the old Y Restaurant, and it is now Circle S Farms and features fresh meats and cheeses and various light meals, there is new ownership at the Arnoldsburger Restaurant.

In Arnoldsburg proper the Family Dollar has been open a short while and is doing a brisk business and a new Dollar General Mart will soon open.

There is a new Arnoldsburg Elementary School with the old school being used as a Minnie Hamilton Health Center. And Roane County General Hospital has also built a clinic.

There is a bakery and a new restaurant – Big Daddy D's – at the Roane County line. And in downtown Arnoldsburg there is a new auto repair shop.

On the northern end of the county despite the tremendous impact of Avalon on the community new businesses have not started to develop on a massive bases and the Town of Grantsville had its Dollar General close and is looking to have another Dollar General store built to replace it.

According to an e-mail from Dollar General on Monday: "DG is currently under construction on a new DG Market location at 845 Arnoldsburg Road in Arnoldsburg, W.Va. At this time, the store is slated to open within the next month but understand that construction progress may alter this date. Please feel free to check back with us on a periodical basis for updates.

"We can confirm our previous location at 341 Main Street in Grantsville, W. Va. permanently closed in May 2024. We apologize to our Grantsville customers for any inconvenience this may cause and plan to continue evaluating additional Grantsville areas for future locations to live out our mission of serving others."

Also, one store – Jen's Thrift Store – closed its doors in Grantsville and moved out of town to a new location. Currently on Main Street there are six open storefronts and five government buildings leaving several locations open to development.

It is a process that may take time.

But things are poised for that rebound especially if Calhoun can attract the phar-

The blistering early August sun beat down on the Calhoun High School football practice field as a small group of athletes were going through their first official day of practice as members of the 2024 Red Devils football team.

Despite temperatures in the mid-90s they were undergoing a West Virginia ritual as the fall sport season officially got under way.

This fall teams in football, cross country, volleyball, golf and cheer will represent the Red Devils. The same is true on the middle school side.

The Red Devils will play some scrimmage games, but the official schedule does not get under way until Aug. 30th when they entertain Gilmer County.

The golf team has already got the 2024 season under way as the Red Devils competed in the LKC Scramble at North Bend State Park Tuesday. The Creston area received some of the showers that have been dampening the local area. The drought is far from being over. Other parts of West Virginia, especially up in the mountains, are much worse.

Now that EQT's MVP (Mountain Valley Pipeline) is open and transporting one bcf/day (billion cubic feet) of natural gas there was an increase of 9.5% for West Virginia Marcellus gas production. The pipeline can do 2 bcf/day and Toby Rice intends to add more compressor stations to up transmission another 1/2 bcf/day. Of course, gas sent elsewhere does not generate local jobs such as was the case when W. Va. Had glass plants with many skilled workers & artisans. Speaking of EQT, the headquarters have been in a skyscraper at 625 Liberty Avenue in Pittsburgh. Now most of the office workers are elsewhere [cheaper rent] and the name is to come off the structure. How times do change.

The Henry Hub price of natural gas fell to \$1.97 while Wirt County natural gas sold to Mountaineer, the local gas utility fetched just \$1.53/mcf and on the Dominion System (DTI) gas was worth, at the well head, \$0.9346/ dekatherm.

The hearings and investigations into the attempted assassination in Butler Pennsylvania seems to be leading to a conclusion many feared was true at the time. 





WAG Trap-Neuter-Return on August 25

On Sunday, August 25, 2024, the Welfare of Animals Group (WAG) will be humanely trapping feral cats in the Orma area to have them spayed/neutered, vaccinated, and ear tipped (the universal sign that a cat has been part of a Trap-Neuter-Return program). We would appreciate it if you would not put food out for them on Saturday, August 24 as we will be trapping on Sunday morning. Once the cats have recovered from anesthesia (at least 24 to 48 hours) we will return them to their exact location. They will be healthier, happier, and not reproducing and fighting. Thank you for your cooperation. So far, we have spayed and neutered 954 community cats (516 females and 438 males).

Please keep your personal cats indoors or put a collar on them on Sunday the 25th. If you have any questions, please call Linda Buchanan at 304-354-7506. If you are aware of a feral cat colony in your area, please let us know. Female kittens can begin breeding at four months old, so the best time to spay/neuter a colony is when there are only 5 or 6 cats. Trap-Neuter-Return is provided to Calhoun County residents at no cost to the caretaker. Partial funding for Trap-Neuter-Return is provided by The Oakland Foundation, The Bernard McDonough Foundation, the West Virginia Department of Agriculture, and the Calhoun County Commission.

WVDNR announces dates for statewide deer spotlight surveys in August and September

The West Virginia Division of Natural Resources (WVDNR) announced that its personnel will be conducting deer spotlight surveys in all WVDNR districts during the months of August and September.

ing the months of August and September. During the survey period, WVDNR personnel will be driving designated routes and using spotlights at night to count deer from county roads. This method allows personnel to estimate the deer population, which is essential for making informed decisions regarding wildlife conservation and management.

This year's surveys are scheduled from

July 29 to Aug. 12 and Aug. 26 to Sept. 11 and will begin one half hour after sunset.

Residents may notice clearly marked WVDNR vehicles with spotlights along these routes during the survey period. The spotlight surveys are conducted in a safe and controlled manner, with all necessary precautions taken to minimize any disruption to residents and wildlife. Angler Caught the 43.51-Inch, 46.70-Pound Channel Catfish in Wayne County

The West Virginia Division of Natural Resources (WVDNR) announced that an angler from Wayne has caught a state record channel catfish, marking the sixth state record catch of 2024 so far.

"West Virginia's incredible fishing opportunities continue to amaze and attract anglers from near and far and this record-breaking achievement showcases the worldclass fishing adventures our state has to offer," said Gov. Jim Justice.

John Tyler Rutherford caught the 43.51-inch, 46.70-pound channel catfish in his father's farm pond in Wayne County on July 21, breaking the length record set in 2022 and the weight record set in 2023. Both records previously were held by Alan Burkett of Moorefield in Hardy County, who caught his fish at South Mill Creek Lake

in Grant County.

"I want to congratulate John Tyler Rutherford on his outstanding catch," said WVD-NR Director Brett McMillion "This remarkable achievement highlights the superior quality of West Virginia's fisheries and the dedication of our team in maintaining and enhancing these aquatic resources."

Rutherford reeled in his record catch using worms. WVDNR District Fishery Biologist Jeff Hansbarger and Assistant Fishery Biologist Jake Whalen traveled to the site to measure and weigh the record fish.

In addition to this channel catfish, record tiger trout, redbreast sunfish, bowfin, redear sunfish and black crappie have been caught this year.

Gasoline prices slightly lower this week

Average gasoline prices in West Virginia have fallen 6.9 cents per gallon in the last week, averaging \$3.33/g today, according to GasBuddy's survey of 1,154 stations in West Virginia. Prices in West Virginia are 6.0 cents per gallon lower than a month ago and stand 24.1 cents per gallon lower than a year ago. The national average price of diesel has fallen 2.3 cents in the last week and stands at \$3.76 per gallon. According to GasBuddy price reports, the cheapest station in West Virginia was priced at \$2.99/g yesterday while the most expensive was \$3.59/g, a difference of 60.0 cents per gallon. The lowest price in the state yesterday was \$2.99/g while the highest was \$3.59/g, a difference of 60.0 cents per gallon. The national average price of gasoline has fallen 3.5 cents per gallon in the last week, averaging \$3.44/g today. The national average is down 5.6 cents per gallon from a month ago and stands 37.2 cents per gallon lower than a year ago, according to GasBuddy data compiled from more than 11 million weekly price reports covering over 150,000 gas stations across the country. "With oil prices plummeting due to new concerns over the U.S. economy after a poor jobs report, gasoline prices have seen downside in many states, with potential for more to join that trend this week as previous refinery disruptions in the Great Lakes region fade away and the restart process begins," said Patrick De Haan, head of petroleum analysis at GasBuddy. "Diesel prices have also continued to drop, and while Tropical Storm Debby drops buckets of rain on Florida and the Southeast, it poses low risk to refineries or refined product pipelines, so the storm is not a major concern. With the Middle East on alert after Israel's attacks on Hamas and Hezbollah, there could be an impact on oil prices; however, with an inability to predict the outcome, I for now expect gasoline prices in most states to gently decline in the week ahead, with the Middle East situation being a wildcard."
