

# **WVPSC** hearing held in Grantsville to determine jurisdiction

A short hearing was held in Grantsville with the West Virginia Public Service Commission, before Administrative Law Judge Keith George.

Attorney Jonathan Stanley appeared on behalf of the Town of Grantsville, with Mayor Robert Petrovsky present and Eric Lupardus representing the citizens of Grantsville to determine if the West Virginia PSC had jurisdiction to hear the complaint filed by the residents of the Town of Grantsville to remove the proposed nearly 60 per cent water increase.

Stanley requested that the case be dismissed stating that the town believed that the required number of signatures contesting the rate increase had not been met, (25 per cent of the customer base) but then stated that they would disregard that issue after more signatures were collected within the 30 days.

They did however want a dismissal stating they did not believe that Lupardus had the right to file the complaint, because he was not a customer of the Town of Grantsville water system, nor was he an Attorney. Lupardus, stated that he was there to

represent many of the elderly residents in the town who did not feel comfortable filing such a complaint.

The Judge informed Stanley that the PSC did not require complainants to be attorney's but requested that an actual customer be present to offer up the petition. At that time, Crystal Mersh, who is a customer on the Grantsville water system offered to present the petition and was accepted.

Stanley requested a continuance on the hearing to which Judge George responded that he did not make a persuasive enough

argument for that to occur. It was then determined by the judge that the West Virginia PSC had jurisdiction to hear the case. and it would continue.

The town will now be required to provide evidence that the emergency rate increase was justified. If it is proven that the increase was not justified the town will be required to repay any money collected as a part of that increase.

To do that the PSC can inspect all of the town's records.

The hearing was adjourned in less than 20 minutes.

# Town council meeting devolves into political argument

The Grantsville Town Council met Monday, October 7th, 2024, at the City Office for their regularly scheduled meeting

First to address the Council under Citizens Complaints was Robin Mersh of the 1982 Foundation regarding water service on the Avalon Campus. Mersh, Dennis Spaur and the mayor have been in conversation regarding the cost responsibility of the taps, line and other issues around the Children's center side of the Foundation's building.

Mersh opened by thanking the mayor for following through on the flow meter installation which was great help to the project. He then stated that, after research, he had come up with a compromise on the tap and line installation with a shorter stretch of area that would reduce the cost of this part of the project as well as address the issue of having the line in the proximity of the building to give the necessary safety issue regarding fire protection. His agreement was for the purpose of keeping the project moving and not holding up the construction which could prove quite costly for the 1982 Foundation.

Mersh cited code as to his understanding of whose responsibility it was to pay for what, to which the mayor took offense to and began citing his own sources of code. Again, Mersh tried to help the mayor understand that The 1982 Foundation "didn't mind paying for things, but in the spirit of cooperation, and to aid in the costs for the project, he requested that the City taken into consideration the location when determining direction.

Councilwoman Cheryl Sturm asked if the retaining wall would be compromised by the digging of line to which both sides stated that it would not.

Mersh again stated that he understood the town's issue with money, and that the 1982 Foundation wanted to cooperate, but they needed to establish an agreement as to what was needed, expressing that time was a concern and the matter was about fire suppression and cost. It was determined that the 1982 Foundation and city staff were to meet to discuss the project on Tuesday, Oct. 8th, 2024, at 1:00 p.m.

The concept of Pandora's Box, as it is commonly known today, has its origins in this story: "According to the myth, Pandora was the first human woman created by the gods, specifically by Hepha-estus and Athena. She was given various gifts and traits by different gods, making her irresistible to men. Prometheus had previously angered Zeus by stealing fire from the gods and giving it to humans, thus empowering them. In response, Zeus devised a plan to create Pandora and give her the jar as a gift. "Zeus presented Pandora to Epi-metheus, Prometheus' brother, as a

#### Nina Carolyn Lane



Oct. 10, 1774: Shawnee warriors led by Cornstalk were defeated at the Battle of Point Pleasant. It was the only major engagement of Dunmore's War and the most important battle ever fought in present West Virginia.



Oct. 10, 1872: Architect Rus Warne was born in Parkersburg. Warne designed many notable buildings in Charleston, including City Hall and the Masonic Temple.



Oct. 10, 1878: Blanche Lazzell was born in Maidsville, Monongalia County. She was one of West Virginia's most notable artists and is recognized as one of America's leading abstract painters and print makers.

**Oct. 10, 1948:** During a boat-racing event in Charleston, Chuck Yeager flew a Lockheed P-80 Shooting Star under the South Side Bridge, surprising boaters, audience

and news media at the event.



Oct. 11, 1811: State founder and U.S. Senator Waitman T. Willey was born near Farmington. Willey proposed the West Virginia Statehood Bill in the Senate and saw to its passage and later signing by President Lincoln. He was then elected as one of West Virginia's first two U.S. senators and served from 1863 to 1871.



**Oct. 12, 1877:** Howard Mason Gore was born in Harrison County. He served as U.S. secretary of agriculture and the 14th governor of West Virginia.



Oct. 12, 2020: Actress Conchata Ferrell died. Born in Loudendale, Kanawha County, Ferrell was best known as Berta the housekeeper on the CBS sitcom Two and a Half Men. She enjoyed a long career on stage, film and television.



Oct. 13, 1863: The Battle of Bulltown took place. The location was valuable during the Civil War because the Weston & Gauley Bridge Turnpike crossed the Little Kanawha River on a covered bridge at this site.

Oct. 14, 1943: The army began transforming parts of Dolly Sods into an artillery range to train military troops bound for duty during World War II. The operation ended on July 1, 1944.

**Oct. 14, 1947**: In a Bell X-1 rocket airplane dropped from a B-29 bomber, Chuck Yeager broke the sound barrier by flying 700 miles per hour. He set another speed record on December 12, 1953, by flying two-and-a-half times the speed of sound in a Bell X-1A.

**Oct. 14, 1949:** WSAZ-TV went on the air on channel 5. Early shows included the first telecast of a Marshall College (now University) basketball game on December 3, 1949.

Oct. 14, 1985: Kanawha Airport was renamed Yeager Airport in honor of Chuck Yangor

Chuck Yeager. Oct. 15, 1839: Aretas Brooks Fleming was born in Fairmont. In 1888, Fleming won the Democratic nomination for governor and then won West Virginia's most controversial gubernatorial election.



Oct. 15, 1952: During the Korean War, Greenbrier County native Ralph Pomeroy was killed in action near Kumhuwa, Korea, while helping his unit contain an attack. The next year, he was posthumously awarded the Medal of Honor for his actions.



Oct. 16, 1859: John Brown and his raiders captured the arsenal at Harpers Ferry, but they were soon besieged by townspeople, local militia and federal troops. The raid galvanized the nation, further alienating North and South and drastically reducing any possible middle ground for compromise before the Civil War.

Oct. 16, 1918: Dale Troy "Stoney" Cooper was born in Randolph County. He, his wife Wilma Lee and the Clinch Mountain Clan played country music on WWVA radio in Wheeling for a decade before spending the next 20 years on the Grand Ole Opry.



**Oct. 16, 1922:** The Rev. Leon Sullivan was born in Charleston. In 1977, Sullivan initiated the original Sullivan Principles, a code of conduct for companies operating in South Africa. The Principles were among the most effective efforts to end the system of apartheid.

# **Red Devils buffaloed by the Bisons, 46-22**

Buffalo Stadium in Putnam County was the site for Calhoun County's fifth football game of the season last Friday night. The Red Devils dressed only 13 players for the game. For a brief time, it seemed as though 13 would be a lucky number that would earn Calhoun its first win of the season. Unfortunately, the homestanding Bisons dominated the third quarter and took the win by a 46-22 score.

Calhoun's offense started the game sluggishly, running only 9 plays that netted -1 yards. Fortunately, the defense kept the Red Devils in the game. Calhoun gave up a touchdown on Buffalo's first possession but recovered a fumble inside the Red Devil 20 to stop the Bisons' next drive.

Both teams treated the ball like a hot potato at the beginning of the second quarter. On the first play of the period, Buffalo fumbled the ball away to Calhoun County. Two plays later, the Red Devil ball carrier coughed the ball up and the Bisons regained possession. The Buffalo quarterback attempted a pass on first down, but Coby Staples snared the ball and returned it 51 yards to finally put an end to the turnover parade.

Staples' return set the Red Devils up in Bison territory, and it didn't take long for the visitors to notch their first points of the evening. Two big plays - a 21-yard pass from Brennen Carpenter to Gavin Hicks and a 23-yard run by Carpenter - moved the ball inside the Buffalo 5. Carpenter crossed the goal line for a Red Devil touchdown, and then ran for the extra points to tie the game at 8-8.

Buffalo's return man muffed Calhoun's kickoff, handing the ball right back to the Red Devils. Calhoun embarked on a methodical drive, featuring mostly short runs by Carpenter and Rome Riddel. The Red Devils made it as far as the Buffalo 6 before throwing an interception.

With only 29 second remaining, Buffalo scored their second touchdown on a 45- yard run, and the half ended with Buffalo in the lead 16-8.

The third quarter proved disastrous for the Red Devils, with the Bisons scoring three times to take a commanding 38-8 lead. Nearly 14 minutes of game time prior, Calhoun County had seemed poised to take a lead, but now the Red Devils found themselves facing a 30-point deficit.

The Red Devils did not give up, however. On Calhoun's next possession, two long passes from Brennen Carpenter to Logan Tingler - 57 and 33 yards - were the big plays of a seven-play, 85-yard scoring drive. Carpenter again tallied the touchdown on a short run, then passed to Tingler for the extra points.

Buffalo scored once more toward the end of the game, but Calhoun County answered immediately. Rome Riddel took Buffalo's kickoff at the 26 and ran it back 74 yards for the final score of the night. Buffalo took a knee to end the contest, with the final score reading 46-22.

The contest was Buffalo's annual Homecoming, but it seemed to those in the stands that it was more like the Zebra

Bowl. The officials called a total of 21 accepted penalties between the penalties. Nothing escaped their gaze, and some of the flags were for infractions that the coaching staff and press box crew didn't even know existed.

Buffalo drew the most attention from the officials, getting flagged for 14 official penalties and another five on tries for points after touchdowns. The Bisons had three consecutive flags thrown after one touchdown, so when they attempted to convert the extra points for the fourth time, the did so from the 23-yard line.

This Friday, The Red Devils invite the Clay County Panthers to the Calhoun County after an absence of seven years. Kickoff is at 7:00.



#### Spring-flowering bulbs for colorful accents

When it comes to planting schemes, flower bulbs are a useful addition to extend the flowering period. With their vibrant colors and wide variety, they have great ornamental value and create color accents in green cities from early spring onwards. Flower bulbs also boost biodiversity and contrib-ute to people's well-being. Biodiversity

Flower bulbs increase the quality of urban green spaces, from verges, parks, and gardens to bowls or containers at prominent points in neighborhoods or shopping streets. In green connection zones, bulb types with plenty of nectar and pollen are particularly welcome, such as Galanthus nivalis (snowdrop), Eranthis hyemalis (winter aconite), and Crocus tommasinianus (early crocus). mowing once in spring and then only checking for litter and weeds along the edges. Naturalizing bulbs also thrive in grass. There are special planting machines for this very purpose.

#### An explosion of color

You could plant just a single variety, or a mix of varieties on every site. The latter will result in months of flowering with ever-changing shapes, heights, and colors. After that, summer bulbs will take over the task of providing the explosion of color. Research has shown that plants with striking colors, fragrances, shapes, and structures positively affect our health and wellbeing.

Tip

The growing condi-tions in tree beds are not suitable for many plants since the tree drains water and nutrients. However, flower bulbs will thrive there, resulting in small oases dotted around the city. Combine them with seeds to extend flowering in summer.

## TOWN COUNCIL

Business owner Alice Holmes asked if the rate increase was going to be addressed saying "Just in case people don't understand what the position of a business owner is in the town, and the reason we cannot be a board member and vote on things like that is so I can't come in and buy up every business on the street and then come in here and run over the town. That's the whole purpose of saying it's not for the business, but for the citizens to vote and make the decisions. But as far as having opinions, I pay almost \$3,000 a year in property taxes in the town and I do have a right to have a voice be heard. And my concern is we have all this rhetoric and stirring the pot and negativity about it but I don't hear anyone coming up with any resolutions other than the town coming up with the water increase. There's a lot of pot stirring, a lot of name calling and the only other thing that's happening is an answer of what to do is remove the mayor. So my question to Mr. Mersh and the people opposing is the other answers, other than fighting and getting petitions against raising the water rate. But I don't see see anyone coming up with solutions or making constructive answers to these things. To which if anyone has had business courses that's the route you take, you don't tear everybody apart. You come up with a solution for it.

Since Mersh's name was mentioned he requested a time to respond to Holmes statements.

Mersh said "I did actually say there was a few things that could be done. I don't dispute that there aren't issues within the city. There actually are issues. The financial situation might well be difficult, and I'm not disputing that. But what I said the last time is, one, be open and very clear about financials. Two is to communicate what the bigger plan was. In terms of maintenance, all kinds of leakage issues, have a plan as to what to do about it. And then maybe what would happen as a third sort of step would be that the increase might be the right thing to do. But the problem is because those other

two things weren't in place it just wasn't clear. The other solution is it might have been a 60% emergency increase, that might have been the conclusion, but the other conclusion might have been instead of doing one hit, you take it in two hits, or three hits, another way of doing things. There are other solutions."

The mayor then spoke under Mayors Communications saying that "He loved the word transparency. I want to say that you (speaking to Mersh) had a Go Fund me for \$100,000 for operational costs and there was nothing listed there as to what that cost was, who you were going to pay, what that money was going to be for, but give us a \$100,000 for operational costs. But I've been doing this for three years, we've been fighting this battle, and when you say you want to see the project costs, A. For a big project cost it takes engineers, but that's not even the towns problem. Our problem is operational costs. So, the last water increase that we had, and when Bennet and Dobbins submitted for the rate increase, they informed me that we need a 78.5 per cent of an increase. And I said I want to do the 60 that we did before because I don't want to hit everyone with that. He said that will give you a shortfall, which you've seen in the proforma, which for some reason you all get everything from the PSC, not even because it was posted, but in advance, because there's a big game going on or whatever. Just like having a hearing before the 30 days was up so you guys could be notified that you needed more signatures. Neither here nor there, that \$30,000 is just based off the water report and operational costs and keeping the lights on and putting away the reserves for the bonds. But, that's not enough for everybody, they want to see... I can put together as many projects as you'd like to see and that 60 per cent ain't going to cover it. It's going to keep the lights on, just like you all do, operational costs. So, it costs to buy electric, it costs to buy pumps, we have no parts, we have no trucks, we have no leak repair items on hand, we have to go get them

when we need them. Thank God the county helped us with the excavator and the trailer so we can work all these at the drop of a hat rather than waiting until we can rent an excavator. But this is not good enough for you. And so at the end of the day, I'm going to say, I'm going to pursue the PSC's assistance, and really, there's a good chance the PSC will come back say, no, you need a 70 per cent increase, and at which case, everybody who decided to use this for political fanfare, because really that's what this has been, that and to keep costs down in certain areas, because we have already implemented the rate increase and have had not one customer call in to say their bill was outrageous. But all this other hoopla to stop everything and we are at 1990 rates when the whole surrounding area is way above us. We can't repair our own things. So, I'm going to let the PSC, I'm not going to jump through any more hoops about it. I'm not going to put together anything else, I submitted all the financials that were required to do the rate increase. And I'm not going to keep on jumping through hoops, 'cause now by law I can let the PSC do all the examining. And then if they come back and say you need 78, we'll get 78. And I'll be fine with that. If they say I need 40, I'll take it. It's not going to be enough. I'm still at a shortfall of \$30,000 a year at 60 per cent. But see, the political fodder, that's all this has been. Yeah, it has been. And I'm not going to turn it into an argument I'm just going to move onto committee reports. Because I just go through the process. That's what we'll do. The rest of it is just to bog the town down, bog the town down, bog the town down. You know the comments about lawyers getting spanked. No, they didn't, it's so nefarious to me that we would even be forced to contest the petition before the 30 days was up."

The mayor then said the WVPSC said that the 1982 Foundation called them every day. To which Mersh responded that they did not. The mayor again stated that the PSC said that Mersch, and Eric Lupardus, had called them every day.

Eric Lupardus then informed the mayor that "Before you go on with your political stuff, I spoke to them one time. They called me three times. There's your answer.'

Councilwoman Rissa Staples asked Mr. Lupardus why the WVPSC would call him. To which Mr. Lupardus answered, "because his name was listed on it (the complaint) but now it's not listed on it. And just to be clear things up, the only reason I was involved was because there are elderly people who were not able to send the petition in and they asked me if I could do that. So, I did that for them."

The mayor's response was "That's neither here nor there, we'll just follow through with the PSC's guidelines and I'll do what I'm required to do but I'm going to put a little more 'ownness' on the PSC." He then commented that when this was just citizens, they didn't have this problem and that it was disgusting what is happening in this community and it's sad, and that he "can't wait until November 6th, when the election is over, and without saying any names he is of the opinion that this town could be lost on Nov. 6th. This county could be lost."


Ironically the town does not have an election until next year.







Gov. Jim Justice announced that the West Virginia

Division of Natural Resources (WVDNR) has reported the state's ninth record catch of the year — a blue catfish reeled in by an Indiana angler on the Ohio River in

"With record-breaking catch after record-breaking catch, it's no surprise that West Virginia's world-class fishing continues to attract anglers from all over," said Gov. Jim Justice. "I want to congratulate Kimberly Feltner on this amazing catch. It's yet another example of why folks love coming to West Virginia to fish."

Kimberly Feltner of Madison, Ind., caught the 50.82inch, 64.15-pound blue catfish at the R.C. Byrd Pool on the Ohio River using cut mooneye bait. She was accompanied by local fishing guide Chris Souders. WVDNR Apple Grove Hatchery Manager Ryan Bosserman certified the record-breaking catch. Feltner's catch surpasses the previous length record of 50.7 inches set by Steven Price in 2022. The weight record (69.45 pounds) is still held by Michael John Drake of St. Albans, W.Va.

"Anglers have broken West Virginia's blue catfish record multiple times over the last few years, which is a testament to the successful management efforts we've implemented," said WVDNR Director Brett McMillion. "We're excited to see what other records might be broken as resident and non-resident anglers continue to hear about our waters consistently producing trophy fish."

With this catch, the WVDNR has reported nine record-breaking catches so far in 2024. In August, two anglers fishing together at Woodrum Lake in Jackson County each caught record-breaking black crappie. In July, an angler landed a record-breaking channel catfish in Wayne County. In June, anglers caught a recordbreaking black crappie and redear sunfish at Woodrum Lake in Jackson County and Plum Orchard Lake in Fayette County, respectively. In March, an angler caught a record-breaking bowfin on the Ohio River in Mason County. In February, anglers caught record-breaking redbreast sunfish and tiger trout at New Creek Lake in Grant County. All anglers 15 and older must have a West Virginia fishing license, which can be purchased online at WVfish.com. Anglers are reminded that a trout stamp is required when fishing for trout. They are also encouraged to upgrade their fishing experience by opting for a physical license card when they purchase their 2024 fishing license.
