# Contentious 2024 election finally here

The highly contentious 2024 election is finally upon us.

This election is being called the most important election in our lives nationally and to a lesser extent locally where a change in leadership has been tied to an economic development plan currently being formulated by a group in the coun-

ty working to bring a pharmaceutical manufacturing plant here.

While nationally there has been unwarranted name calling, massive rallies and two assassination attempts on Republican Presidential nominee Donald J. Trump the local election has not been that divisive or explosive it has nonetheless had some controversial things take place.

The biggest of which was "Sign Gate" where large red and white signs attacking the two Republican commission candidates Roger Propst and Eric Lupardus, Calhoun business owner Crystal Mersh and the Calhoun School Levy mysteriously appeared at various locations Saturday morning (Oct. 26) and by that evening had just as mysteriously disappeared.

The Republican Executive Committee contacted the West Virginia Secretary of State about the signs regarding their legality and an investigation was ongoing.

On top of that some governmental

meetings were tinged with combative political rhetoric and the internet has been alive with claims and counter claims.

In other words, it has been very contentious.

But that will all come to an end soon as early voting closes Saturday and in person voting takes place Tuesday when the polls close at 7:30 p.m.

And then all that is left is the final count and the declaration of winners and the certification of results to follow.

# Former Calhoun Chronicle Editor Newton Nichols passes away

He was a quiet and unassuming man, but he was one of the most powerful and knowledgeable persons in the last 50 years of Calhoun County history.

Milford Newton (Newton) Nichols the former long time editor of the Grantsville News and the Calhoun Chronicle passed away leaving a void that won't soon be filled.

Newton moved to Grantsville from Clay when he was in grade school after his parents bought the Grantsville News back in the 1950s. As the son of a newspaperman and printer learning the trade fell upon him if for no other reason those were the chores his father gave him.

But it turned out he loved doing those things.

He also loved

sports, and he ended up being an expert in both fields.

At least when it came to Calhoun ounty.

In high school he worked as the Red Devils official statistician and kept the scorebooks including in basketball. He was so good at it that Calhoun basketball coach Joe Virden recommended him to Glenville State College coach Jesse Lilly to serve as the Pioneers scorekeeper.



After graduation he began his long and loving relationship with Calhoun County in general and Calhoun High School athletics in particular. It was a relationship

# Lisa Cooper and CSWA for 'REAP Group of the Year'

Christopher Cartwight with WV DEP REAP PPOD program (REAP: Rehabilitation Environmental Action Plan), (PPOD: Pollution Prevention Open Dump) announced the winner of this year's Statewide REAP Group of the Year, Calhoun's own "Make it Shine" at a ceremony on Monday, Oct. 29th, 2024.

Lisa Cooper, Executive Director for Calhoun County Solid Waste Authority, began getting involved in a community wide cleanup effort in 2021 and after four years of involvement has managed teams who have brought in 13 tons of litter from Calhoun County roadways and over 300 tires dumped along the roads.

Lisa is the first to pilot and adopt a stream for the Little Kanawha Highway, organizing volunteers who have pulled over 800 tires from the Little Kanawha River since 2022. This effort has brought Calhoun County to receive their first Make it shine Group of the year.

Va. are experiencing a lack of natural gas supply. Charity should start at home one would think. While the Henry Hub of natural gas price rose to \$2.56, natural gas in W. Va. Has been selling for less than one dollar.

Peanut spread sone lime on the historic dePue farm at Creston. Lime was also spread on fields on Straight Creek.

The price of local Pennsylvania grade crude oil rose to \$70.78/bbl. With condensate fetching \$52.78/bbl. And Marcellus & Utica light bringing \$55.78/bbl. The surgical strikes by Israel against Iran caused some panic in the oil markets. Israel humiliated Iran because the mullahs were helpless in trying to stop the planes, bombs and rockets. No doubt the Big Eared One and the Iran spies in the US State Department and DOD are irate. Mordecai would be proud as no civilians were impacted, only terror targets.

Within the next few days, the contentious 2024 election will be over, and America, West Virginia and Calhoun County will be on a new course for the future and if anyone is wondering about the Calhoun Chronicle's endorsements in the election, well, officially there are two. the Calhoun County school levy. While we know that asking for money when money is mighty tight is hard to do,

we still feel the overall good of the levy greatly outweighs the cost. Questions about the levy were an-

swered in an earlier story in the Chronicle by Calhoun County School Superintend Michael Fitzwater The question he heard most often is

how long will the levy be in effect if the levy passes? And the answer is the proposed years to which the additional levy shall apply are the fiscal years beginning July 1, 2025;

July 1, 2026; July 1, 2027; July 1, 2028; and July 1, 2029. Another often asked question is what will my additional taxes be if the levy is

approved?

And the answer is that this is a level two levy which means the rate is \$.02 (two cents) on each \$100 valuation of

Another question is what will the monies raised be used for?

Here's how the levy will benefit our schools and community:

Employ a Prevention Resource Officer for added safety.

Employ a School Nurse to support student health.

Provide transportation for extracurricular events to ensure all students can participate.

Fund summer school programs for additional learning opportunities.

Cover supplemental salaries for staff Pay for county-wide athletic facility upgrades.

Fund facilities and operational improvements at schools.

Support the Art Cart for Pleasant Hill and Arnoldsburg to enhance arts educa-

And while we always regret asking for money, we do feel this time passing the levy is the right thing to do.

Our recommendation is VOTE FOR THE LEVY.

Our other and last endorsement is Donald J. Trump for President.

If you must ask on this one ... sorry.

Check these figures out.

A Gallon of Gas When adjusted for inflation, Trump's

average is \$3.18 in 2024 dollars, 21 per cent less than Biden's inflation-adjusted price of \$3.86.

A Dozen Eggs

Goodbye my old friend, I shall miss Until next time stay safe but don't live



Oct. 31, 1877: Herman Guy Kump was born in Capon Springs, Hampshire County. Hewas the 19th governor of West Virginia, serving from 1933 to 1937.



Oct. 31, 1940: Gale Catlett, West Virginia University basketball player and coach, was born in Hedgesville. Catlett coached WVU to 13 20win seasons before he retired in 2002.



Oct. 31, 1946: Labor leader Cecil Edward Roberts Jr. was born on Cabin Creek, Kanawha County. A sixth-generation coal miner and a fiery orator, Roberts has served as president of the United Mine Workers of America since 1995.



Oct. 31, 1951: Football coach Nick Saban was born in Fairmont. As a quarterback, he led Monongah High School

to a 1968 state championship. He went on to coach Louisiana State University and the University of Alabama to seven national championships (six with Alabama), the most of any coach in history.



Nov. 1, 1688: Morgan Morgan was born in Wales. Traditionally, Morgan was considered the first White settler of West Virginia, but others were likely here first. He settled in the Bunker Hill area in 1731, building a log house that still remains.



Nov. 1, 1848: Israel Charles White was born in Monongalia County. White was West Virginia's first state geologist, appointed in 1897 and serving until his death in 1927, working without pay for all but two of those years.

Nov. 1, 1961: The first non-commercial station in West Virginia, WMUL-FM at Marshall University, began broad-

Nov. 3, 1947: Kanawha Airport (now Yeager International Airport) was dedicated. World War I ace Capt. Eddie Rickenbacker was among the dignitaries present.



Nov. 4-5, 1985: Heavy rains led to devastating floods in parts of West Virginia. Forty-seven people were killed, and several towns were severely dam-



Nov. 5, 1891: Alfred Earle "Greasy" Neale was born in Parkersburg. He was one of West Virginia's greatest all-around ath-

Nov. 5, 1922: Cecil Underwood was born at Josephs Mills in Tyler County. Underwood, West Virginia's 25th and 32nd governor, served as the state's youngest and oldest chief executive.



Nov. 5, 1927: Musician "Ellie" Mannette was born in Trinidad and helped popularize steel drum music worldwide. In 1992, he became an artist-in-residence at WVU, coordinating the school's steel drum program. In 1999, he was named a National Endowment for the Arts National Heritage Fellow, the nation's highest arts honor.

Nov. 6, 1863: Confederate troops led by Brig. Gen. John Echols were defeated at Droop Mountain by a larger federal force led by Brig. Gen. William W. Averell. This was one of the most important Civil War battles fought on West Virginia soil.



Nov. 6, 1923: A methane gas explosion killed 27 men inside the Glen Rogers coal mine in Wyoming County. The mine, which opened in 1921, became one of the state's largest. A total of 160 fatalities over a 31-year period occurred at the mine before it was closed.

# **Diabetes Education Week is Nov. 3-9**

November is Diabetes Awareness Month and Nov. 3-9 is Diabetes Education Week. The Mid- Ohio Valley Health Department wants everyone to know the symptoms of diabetes, the difference between type 1 and type 2, and what you can do to help protect your health.

"Diabetes happens when your body doesn't make enough insulin or can't use it as it should," said Malcolm Lanham, Community Health Director. "When there isn't enough insulin or your body stops responding to the insulin, too much blood sugar stays in your blood and over time can cause serious health issues

like heart disease, kidney disease and vision loss." There are two types of diabetics, Type 1 and Type 2. With Type 1, the person's body doesn't have insulin and is thought to be caused by an autoimmune reaction. Type 1 diabetics must take insulin every day. In Type 2 diabetics, their body doesn't use insulin well and can't

control the body's blood sugar level properly. The CDC reports that about 38 million people in the U.S. have diabetes, about 1 in every 10 people, and 1 in 5 do not know they have it.

Symptoms for diabetes include severe thirst, frequent urination, blurry vision, being tired and weak, having slow healing wounds and unexpected weight changes.

Risk factors for having diabetes include having a family history of it, over the age of 45, being overweight, if you have had diabetes when pregnant, and have high blood pressure. Lifestyle changes, such as eating a healthy diet, exercising and losing weight can help. Checking blood sugar levels is important to make sure they are staying in the correct range.

that lasted a lifetime.

"I have been out of high school 33 years and my brother 36 and he was there when we played so not sure how long before that," Calhoun realtor and former girls' basketball and volleyball coach Angela Hershman said. "It's still hard to believe he is gone ... I worked upstairs for 20 years in realty office, and we had a lot of good times besides all the sports we shared."

Hershman remembered how he made the athletes feel when he covered their games.

"When I think about the people in

my youth that were important for me to be successful today, Newton is at the top of that list," W. Gregory Collins wrote, "His pride in Calhoun athletics and the words he wrote about us as athletes, made us believe we were bigger than life. Made me believe I was someone worthy of succeeding. He treated me so very well starting in elementary school and I looked at him with the same respect I did as a coach. That's saying something coming from a kid. RIP good man. You made me believe in myself."

Along with his love for athletics and

the athletes' love for him he was also a successful journalist with the seeming ability to take any situation and make it go smoothly. That's what he did when the Grantsville News was bought out and closed by the Calhoun Chronicle and he was put in charge of producing the newspaper.

He did it quietly with respect, professionalism and dignity.

"He was my best friend back in school," Gaylen Duskey the current editor of the Calhoun Chronicle said. "He did what he was born to do, trained to do and had to do. He did it the right way and always with class."

Duskey said it was his friendship with Nichols that got him interested in a career in journalism.

"He had a much bigger impact on his profession, his county and his athletes than people will ever imagine," Duskey said.

Kevin Yeager Sr. perhaps summed up Nichols' impact on those around

"Such a great man I first met him in the late 70s early 80s was always at all the sporting events," Yeager wrote, "he will be really missed."

# **Braxton County pounds Red** Devils, 43-0, for first win of season

FLATWOODS -- The Braxton County Eagles hosted the Calhoun County Red Devils in the eighth game of the season last Friday night and the trip to Flatwoods proved to be a rough one for the Red Devils, as Calhoun County dropped the battle of winless teams by a 43-0 count.

The game started well, with the Red Devils forcing a punt after a three-andout on the Eagles' first possession. The Calhoun offense suffered the same fate on its first possession, but disaster struck in the form of a low snap on the punt attempt. The Red Devils had to down the ball at their own 11-yard line, and within two plays the Eagles had taken a 6-0 lead.

The Red Devils muffed the Eagles' kickoff after the score, giving Braxton the ball again. Less than three minutes later, the Eagles scored again to make the score

Braxton County scored twice more in the second quarter. At that point, the Eagles put their JV backfield into the game, which put a halt to the offensive scoring.

However, the Eagle defense notched three more scores. The first came on a Calhoun fumble as the second half clock expired, the second on an interception return on the first play of the third quarter, and lastly on a safety shortly after the final touchdown.

After the safety, the two teams agreed to roll the clock for the remainder of the game. Rain began shortly before the end of the third quarter, putting a damper on a thoroughly dismal evening for the Red

Offensively, the game was the roughest ever experienced by a Calhoun County football team. The team ended with -67 rushing yards, eclipsing the previous low of -44 against Williamstown in 2011. This also marked the first time a Red Devil team finished with negative yards in total

There were a few bright spots for the Red Devils.

Freshman Nic Butler, pressed into emergency duty during the first quarter, punted four times for an average of 38.8 yards per kick. Charter Cottrell picked off a Braxton County pass in the third quarter, and Gavin Hicks returned a missed field goal attempt 12 yards near the end of the game.

The play, coming on Braxton's second missed field goal of the evening, is the first such return by a Calhoun player in recent memory.

Despite the loss, Calhoun County has historically had success in Flatwoods, owning an 8-5 record at the Eagles' field since first playing there in 1985. The game was the Red Devils' first against

Braxton County since 2010, and the first visit to Flatwoods since 2007. The 2009 game, a 21-7 Red Devil victory, was to have been held at Flatwoods, but was moved to Glenville due to poor field con-

ditions in Braxton County.

This Friday, Calhoun County makes the long trip to Upper Glade to face Webster County in the final road game of the season. Kickoff is scheduled for 7:00.
