A record number of West Virginia voters participated in person for the November 5 General Election according to a report released by WV Secretary of State Mac Warner.

Early voting for the November 5 General Election has surpassed the previous record for early voting set in the 2020 General Election. Early in-person voting began in West Virginia is 2002.

"Confidence and interest in West Virginia elections is at an all-time high," said Secretary Warner. "We're working closely with all 55 county clerks to make sure that elections are safe, secure, accessible, and transparent."

According to Warner, as of Saturday evening, a total of 332,081 voters have already cast a ballot statewide. Early inperson voters accounted for 310,421 of the ballots cast. 21,660 voters participated by absentee ballot. A total of 4,640 absentee ballots have not yet been returned to the county clerks.

At the 11th hour on the 11th day of the 11th month of 1918, the Great War ends. At 5 a.m. that morning, Germany, bereft of manpower and supplies and faced with imminent invasion, signed an armistice agreement with the Allies in a railroad car outside Compiégne, France. The First World War left nine million soldiers dead and 21 million wounded, with Germany, Russia, Austria-Hungary, France and Great Britain each losing nearly a million or more lives. In addition, at least five million civilians died from disease, starvation or exposure.

In 1954, after World War II had required the greatest mobilization of soldiers, sailors, Marines and airmen in the Nation's history; after American forces had fought aggression in Korea, the 83rd Congress, at the urging of the Veterans service organizations, amended the Act of 1938 by striking out the word "Armistice" and inserting in its place the word "Veterans." With the approval of this legislation (Public Law 380) on June 1, 1954, November 11th became a day to honor American Veterans of all wars.

According to www.history.com and department.va.gov that is how Veteran's Day came to be as one of only four holidays always on a specific day joining Christmas (Dec. 25), New Year's Day (Jan. 1) and Independence Day (July 4).

It is a very special day and one that has touched virtually every community in The United States and Calhoun County

is no exception. In this edition we want to run pictures of some of our veterans including a Med-

cal forces in the Middle East in the first Gulf War, the man the Army Intelligence School at Fort Hauchuca, AZ, is named after, the man who was the inspiration of the movie and television show MASH, heroes we have heard about and heroes we have not, some who gave part and some who gave all.

Pictured are Bernard Pious Bell who won a Congressional Medal of Honor; Clovis Drexel who had a military intelligence named after him; Dr. Larry Godfrey who oversaw medical forces in the Middle East during the first Gulf War; Dr. Curtis Artz whose exploits led to the creation of the movie MASH; Ron Blankenship and Dick Jarvis both who rose to the rank of Colonel; Glen Fowler who was a fighter ace in World War II and Steve Mowery who was a fighter ace during the Mediterranean Conflict; Edward 'Buster' Hoskins who won three Bronze Stars while fighting in Burma; George Duskey Jr., who was interviewed by Ernie Pyle right before Pyle was killed; Charles Duskey Jr. who lost a leg in WWII and Dean Starcher who was the only casualty from Calhoun during the Vietnam War.

Early voting has set records locally, as elsewhere. The Big Eared One has made it clear that he wants his fourth term. Presently it is clear to all that neither #1 nor #2 are running the country at present.

The state of West Virginia announced that October tax revenues fell far below estimates. Income tax revenue was less reflecting the economic malaise impacting most of the nation. Nov. 7, 1775: The historic Forks-of-Cheat Baptist Church was organized about six miles north of Morgantown. It is the oldest church with continuous records west of the Alleghenies in West Virginia.



Nov. 7, 1943: During World War II, Medal of Honor recipient Herbert J. Thomas Jr. was killed in the South Pacific. Thomas, who grew up in South Charleston, died by throwing himself on a grenade, saving his fellow squad members. WVU Medicine's Thomas J. Memorial Hospital in South Charleston is named in his honor.





Nov. 8, 1936: "It's Wheeling Steel," a halfhour musical variety radio

program, debuted over WWVA in Wheeling. The program was an instant success with local audiences and later became a nationwide sensation.



Nov. 9, 1874: Matthew Mansfield Neely was born in Doddridge County. He was the 21st governor of West Virginia.

Nov. 9, 1952: The Huntington Museum of Art opened as Huntington Galleries. The museum is located on more than 50 acres in the Park Hills section of Huntington.



Nov. 10, 1777: Cornstalk, his son Elinipsico, and the sub-chief Red Hawk were murdered in captivity by enraged settlers who blamed them for two recent killings. Cornstalk, a Shawnee leader who lived in what is today southeastern Ohio, had commanded Indian forces at the Battle of Point Pleasant.

Nov. 10, 1861: A Confederate cavalry force of more than 700 attacked a Union recruit camp at Guyandotte in Cabell County. Nov. 10, 1978: The

New River Gorge National River was established by Congress. It was designated a National Park and Preserve in 2020.



Nov. 10, 1979: The last home game was played at Old Mountaineer Field at West Virginia University. More than 38,000 people attended the game, in which WVU nearly upset highly ranked Pitt.

Nov. 11, 1922: Jane Taylor Cox George was born in Possum Hollow, Roane County. As a 4-H leader, she introduced young people to traditional crafts and dance in Kanawha, Putnam, Mercer, Monroe, and Roane counties, helped oversee the first Mountain State Art & amp; Craft Fair in 1963, and was a longtime contributor to the Vandalia Gathering and other festi-

Nov. 11, 1929: The Memorial Arch was dedicated on Armistice Day in Huntington. The Memorial Arch stands at the intersection of 11th Avenue and Memorial Boulevard. The arch pays tribute to

DoHS opens applications for low income energy assistance program

The West Virginia Department of Human Services (DoHS), Bureau for Family Assistance (BFA) announced that applications for the Low Income Energy Assistance Program (LIEAP) will be accepted starting Monday, Nov. 4, and continuing through Wednesday, Nov. 27. This federally funded program helps eligible West Virginians cover home heating costs, aiming to alleviate financial strain during the colder months.

LIEAP eligibility is based on household income, size, and responsibility for heating costs. For fiscal year (FY) 2025, applicants must meet income guidelines set at 60% of the state median income, or 150 per cent of the federal poverty level for households of eight or more members. To qualify, all members of the household must collectively

meet these income thresholds.

To apply for LIEAP, residents can pick up applications at their local DoHS offices, participating community action agencies, or senior centers operated by an Area Agency on Aging. For convenience, applications are also available online at wvpath.wv.gov.

Completed applications must be submitted to the local DoHS office in the applicant's county by November 27, 2024, or postmarked by this date. A directory of DoHS local offices is available at dhhr. wv.gov/bms/Pages/Field-Offices.aspx or by calling 304-356-4619. Submitting applications to other locations, such as utility companies, will delay processing and affect eligibility.

Gov. Justice issues proclamation banning outdoor burning statewide

To reduce the risk of catastrophic wildfires due to dry weather conditions, low water levels in communities, and fire activity, Gov. Jim Justice has issued a proclamation that bans all outdoor burning throughout West Virginia, effective, Nov. 4, 2024.

The ban, which is necessary due to the continuation of dry weather conditions and low water levels, will be in effect until circumstances improve and the Governor rescinds the order by further proclamation.

The Governor's order makes it unlawful for any person in the state to engage in outdoor burning, including fires built for camping, the burning of debris, or warming.

The following items are excluded from the restrictions:

Fires for the purpose of chemical production, where fire is essential to operation.

Fires for commercial land-clearing, such as mining, highway construction, and development: Provided, that a permit is obtained from the Division of Forestry prior to burning.

Training fires conducted under the direct control and supervision of qualified instructors at a training facility operated by a fire department or government entity: Provided, that a permit for such training fires is obtained from the Division of Forestry prior to burning.

Fires for outdoor cooking conducted for fundraising events and charitable organizations: Provided that a water source capable of extinguishing the fire must be present and a permit is obtained from the Division of Forestry prior to the opera-

tion.

Liquid fueled gas grills, lanterns or liquid-fueled gas fire stoves.

The Governor has instructed the Division of Forestry to enact a forest fire readiness plan and to enforce the ban on burning as outlined in W.Va. Code §20-1-1, et seq.

The proclamation orders the Division of Forestry and the Division of Homeland Security and Emergency Management to provide continuous information to the Governor and the public regarding forest conditions.

Additionally, the proclamation orders the Division of Natural Resources, the Office of the State Fire Marshal, the Department of Homeland Security, and the State Police to cooperate in the enforcement of this ban.

Calhoun falls to Webster County, 44-13

UPPER GLADE -- The Calhoun County football team concluded the road portion of their 2024

season last Friday night at Highlander Field. The Red Devils broke a nine-quarter scoring drought by notching two touchdowns in the fourth quarter, but still fell to the Webster County Highlanders by a 44-13 score.

Both teams struggled with ball security early in the game. Calhoun County muffed the opening kickoff and gave the ball to Webster County. The Highlanders returned the favor with a high snap on their first play, handing the ball right back to the Red Devils.

Calhoun County was unable to move the ball, and a terrific Nic Butler punt pinned Webster County at their own 3-yard line. Unfortunately, Webster scored on a two play drive - runs of 20 and 77 yards - to take a lead it would never relinquish. The Highlanders scored three more times in the first half to take a 28-0 lead at intermission.

The Red Devils made a goal-line stand to prevent the Highlanders from scoring on the opening drive of the second half, but then fumbled the ball in the end zone to give Webster a safety.

Following another Webster touchdown, the Red Devils finally dented the scoreboard early in the fourth quarter. Starting at midfield following a great kickoff return, the Red Devils moved to Highlander sevenyard line, with most of the yardage coming on three passes from Brennen Carpenter to Gavin Hicks. Carpenter found Hicks open in the end zone on the next play, but the ball was tipped by a Webster defender.

Hicks caught the ball after the tip and managed to keep his feet in bounds long enough to secure the touchdown.

The Highlanders answered immediately with a 49yard run, but the Red Devils countered with a five-play scoring drive. That possession was capped with another Carpenter-to-Hicks pass in the same location in the end zone. This time Hicks was all alone, and made the routine catch to give Calhoun 13 points.

Webster ate up the remaining 8:36 of the fourth quarter by running the ball, thus securing the victory.

Friday night's contest marked the 40th anniversary of the two teams' first meeting in 1984. Calhoun County won that inaugural game by a 14-0 at old Wayne Underwood Field, but have not been able to emerge victorious in any subsequent game with the Highlanders.

This Friday, Calhoun County wraps up the 2024 season by hosting the Ritchie County Rebels. Kickoff is scheduled for 7:00.



Hope maintains that the pipelines can no longer provide safe, reliable, and economical gas service to the farm-tap customers or are in jeopardy of being unable to continue providing service. The pipelines are no longer necessary or useful to Hope's provision of service to Hope customers and are uneconomical to continue to operate, maintain, or replace.

Hope estimates that the cost to operate and maintain the pipelines will far exceed \$10 million per year, and replacing the lines with new plastic pipelines will cost over \$600 million. Hope projects that if approved, the cost to convert customers to propane or electric service will be approximately \$6 million, or \$10,000 per customer, plus \$2,000 for propane storage and house lines.

Hope does not seek a rate increase in this proceeding. Hope anticipates recovering the ongoing cost of supplying propane to the converted customers through Hope's purchases gas adjustment (PGA) mechanism and PGA rates. Hope proposes to defer and recover the expenses incurred to convert customers to propane or electric service under W.Va. Code § 24-3-7(d).

A hearing will be held by the Public Service Commission, which will begin at 9:30 a.m. on December 9, 2024, in the Howard M. Cunningham Hearing Room at the Commission's offices at 201 Brooks Street, Charleston, West Virginia. The Commission may cancel the hearing for good cause shown. Interested persons intending to attend the hearing should monitor the web docket.

Glenville State University BOG Approves new BA in Health Sciences to help combat the rural healthcare crisis

GLENVILLE -- Glenville State University Board of Governors met and approved the new Bachelor of Science in Health Sciences program. This program is a reformulation of existing degree programs within the College of Health Sciences to more transparently prepare students for professional degrees. The concentrations include Pre-Medical, Pre-Dental, Pre-Pharmacy, Pre-Physician's Assistant, Pre-Physical Therapy, Pre-Occupational Therapy, Pre-Chiropractic, and Pre-Athletic Training

University President, Mark A. Manchin, wants to see Glenville State University as the *Beacon of Rural Healthcare* in the state. "I am extremely excited about this opportunity to improve healthcare in central WV," Manchin said. "The ultimate goal is to prepare students to continue their healthcare education so that, one day, they will return to their rural communities and serve their friends and neighbors."

Dean of Health Sciences, Dr. Kevin Evans is proud of the opportunity to serve not only West Virginia, but also rural communities throughout the Eastern United States. "Developing this essential pipeline of prepared, driven students into strong graduate level programs throughout the East Coast could change the trajectory of medicine in these rural areas" Dr. Evans said. Evans has been an integral part of this process, working with Dr. Meri Clements, Provost of GSU, to develop a challenging program to prepare and inspire GSU students to continue

their education as seamlessly as possible.

Dr. Evans has worked to develop memorandums of understanding with multiple professional schools in each concentration to ensure that, upon graduating with a 3.0 or higher cumulative GPA, GSU students will have guaranteed spots waiting for them. "This fantastic opportunity will not only equip our students and grow the

university, it will also make great strides in improving rural healthcare – making quality healthcare available to

all West Virginians," said Clements.

The Bachelor of Science in Health Sciences program will be available to students beginning in fall 2025 and is designed to provide a smooth transition into the respective degrees in medicine and allied health. It will

provide 44 credit hours of core foundational knowledge in healthcare, 32 credit hours of coursework to meet the typical prerequisite requirements for the specific professional health-related program, and 14 credit hours of electives (general and/or restricted) for any unique requirements and to strengthen their academic preparation
