

## Thundersnow rings out 2024 and rings in 2025 with a bang

Yes, that was lightning and yes that was thunder and yes it was just about high noon on Dec. 31, 2024.

Mother Nature decided to close out the old year with a bang.

And bring in 2025 with a bang too.

Actually 2025 did not come in so much with a bang as it did with a brrrrrr ...

According to the web site www.howstuffworks.com seeing lightning and hearing thunder in the winter not only meant you passed a military physical back during the Vietnam War days it also was a usual portent of things to come, like snow.

The website asked:

### "What does it mean when it thunders in the winter?

"There's an old saying that states, "Thunder in the winter brings snow in seven days," While that's not entirely accurate, thunder in the wintertime is an indication of a cold weather front. Though there's no way to tell exactly how soon it'll come in, the thunder may indicate a dumping of snow is on its way.

### "Is it normal to have thundersnow lightning in winter?

"Winter thunderstorms, called "thundersnow", are not a common occurrence. Though they do happen occasionally, copious thundersnow occurrences are a rare phenomenon.

### "How rare is a thundersnow storm?

"Thundersnows are rare enough that The Royal Meteorological Society found that they only account for 0.07 percent of snowstorms in the U.S. However, thundersnow occurs more often in the elevated provinces of Jordan and Israel and around the Great Lakes. When lightning strikes there, heavy snowfall could be on the way."

While Calhoun County is a good ways from the Great Lakes and a real good ways from Jordan and Israel, we did have a winter thunderstorm and a few days later we had one heckuva snowstorm – about two or three inches on Friday – followed by an even bigger snowstorm on Monday so there must be something to this thundersnow stuff.

The first round of snow following the end of the year Friday a rain and ice storm dumped about three inches of snow on the area and wreaked havoc on transportation before backing off.

The second round of precipitation was a lot bigger and bolder and completely blanketed things with six or more inches of snow before changing briefly to freezing rain which layered everything with a beautiful yet deadly mix before changing back to snow. This round of storms also brought about the closing of many businesses and governmental agencies on Monday. The weather forecast for the rest of the week called for a chance of precipitation for just about every day and falling temperatures reaching single digits on some nights.

## Noah Tribioli goes before judge for formal hearing

Steve Tribioli had been a community leader in Pennsylvania as a Cornwell Borough Councilman in Lebanon, Pa., according to the web site LebTown

Tribioli had moved to Grantsville, West Virginia, earlier this year with his wife, Jo Dee, whom he married in January.

According to West Virginia State Police, Jo Dee Tribioli, 51, and her aunt Carol Heagy of Mount Gretna, 71, were killed in the shooting.

Steve Tribioli, 55, was shot and is currently in critical condition.

Claude Heagy, Jo Dee's uncle, 66, of

Mount Gretna, was also shot and is currently in stable condition.

Carol Heagy was an employee at the Lebanon VA Medical Center, retiring in 2015.

Steve Tribioli is a former Cornwall Borough councilman who worked for eight years as a school resource officer at Cornwall-Lebanon School District, serving from December 2015 to October 2023.

Noah Tribioli is reported to have lived in Columbia, Lancaster County.

Calhoun Sheriff Graham Knight was first on the scene and discovered the two women's dead bodies and injured men.





Jan. 10, 1846: Wetzel County was created from a part of Tyler County. It was named for Indian fighter Lewis Wetzel.

Jan. 10, 1860: Webster County was created from parts of Braxton, Nicholas, and Randolph counties. The county was named for Daniel Webster. Jan. 10, 1923: Musician 'Curly' Ray Cline was born in Baisden, Logan County. He was one of the most significant bluegrass fiddlers from West Virginia from 1938 until his retirement in 1993.



# Snow Thrower Safety Tips: Keep Best Practices in Mind This Winter

Clearing snow and ice from driveways, sidewalks and parking lots is no small job. You rely on your outdoor power equipment to do the heavy lifting, and it's important to keep safety in mind. The Outdoor Power Equipment Institute (OPEI) reminds home and business owners to use snow throwers, often referred to as snow blowers, safely and offers tips to help.

"Weather today is unpredictable. You need to have your snow thrower serviced and ready to power up," says OPEI President and CEO Kris Kiser. "Review your owner's manual so you can use your equipment safely." Kiser says preparation is key and that home and business owners should consider the following:

**Review the owner's manual.** Check the owner's manual for safe handling procedures. If the manual cannot be found, look it up online, and store a copy on your computer so it's available to reference in the future. Review how to operate controls. Be able to shut off equipment quickly. **Check equipment.** The snow thrower should be powered off when being checked over. Adjust any cables and check the auger.

**Charge batteries.** Locate the batteries for your snow thrower and charge them fully before it snows.

Purchase fuel. Be sure to use the correct fuel recommended by the equipment>s manufacturer. For most gasoline-powered snow throwers, that is E10 or less. Often fuel stations are closed after a storm so buy gasoline in advance of storms. Fuel that is more than 30 days old can phase separate and cause operating problems. For more information on fueling properly see www. opei.org/programs/ethanolwarning Store and use fuel properly. Place gasoline in a proper fuel container and label it with the date purchased and the ethanol content. Store fuel safely and out of the reach of children. Fill the fuel tank outside before starting the engine and while the engine is cold. Never add fuel to a running or hot engine.

Clear the area. Snow can sometimes hide objects. Doormats, hoses, balls, toys, boards, wires, and other debris should be removed from areas you intend to clear. When run over by a snow thrower, these objects may harm the machine or people.

**Dress for winter weather.** Locate safety gear now, and place it in an accessible closet or location. Wear safety glasses, gloves and footwear that can handle cold and slippery surfaces when operating the snow thrower.

KEY SAFETY TIP: Never put your hands inside the auger or chute. Use a clean out tool to unclog snow or debris from the snow thrower. Your hands should never go inside the auger or chute. Turn OFF the snow thrower if you need to clear a clog. If you need to remove debris or unclog snow, always turn off the snow thrower. Wait for all moving parts to come to a complete stop before clearing any clogs or debris. Operate in visible conditions. Never operate the snow thrower without good visibility or light. Aim with care. Never throw snow toward people or cars. Keep children or pets inside and away from your snow thrower when it is operating. Use extreme caution on slopes and hills. Use caution when changing directions on slopes. Do not attempt to clear steep slopes. Know where the cord is. If using an electric powered snow thrower, be aware of where the power cord is at all times. Avoid tripping.

# of Health warns of Serious Health Risks From Freezing Temperatures

The West Virginia Department of Health is urging residents to prepare for dangerously cold temperatures over the coming days. Prolonged exposure to the cold can lead to serious health issues, including hypothermia and frostbite, which can result in severe injury or even death.

"It's essential that all West Virginians take the necessary precautions to stay safe during this period of freezing temperatures," said Dr. Sherri Young, DO, MBA, FAAFP, Secretary of the Department of Health. "Temperatures this low, combined with wind chill, can cause frostbite in less than 30 minutes. Protecting yourself, your family, and even pets is vital during these extreme conditions."

Hypothermia can occur when the body's temperature falls below 95°F. Warning signs include uncontrollable shivering, memory loss, confusion, and drowsiness. Children should avoid playing outdoors in such conditions, and pets should be brought inside to ensure their safety. Frostbite primarily affects extremities like fingers, toes, earlobes, and the tip of the nose. Protective clothing, including hats, gloves, and insulated footwear, is crucial for prevention.

Residents without adequate heating sources are encouraged to contact their local Emergency Manager or health department for information on the nearest shelter or warming station. "Stay safe, stay warm, and check on your neighbors during this extreme weather event," added Dr. Young.

To assist residents, communities have opened warming shelters. Local emergency managers and community groups are working to report open shelters to West Virginia 211. Those in need of assistance should visit wv211.org or call 211 for information on nearby shelters and resources.

Space heaters are a popular way to stay warm during cold weather, but they come with risks if not used correctly. To minimize hazards, keep space heaters at least three feet away from flammable items like furniture, bedding, or curtains. Never leave a space heater unattended while it is running and always turn it off when leaving the room or going to sleep. Plug space heaters directly into wall outlets rather than extension cords or power strips to prevent overheating and fire risks. For gas-powered heaters, ensure proper ventilation to avoid carbon monoxide buildup.

Improper use of space heaters can lead to fire hazards, carbon monoxide poisoning, and electrical overload. Space heaters are a leading cause of house fires during the winter, and plugging a heater into an extension cord or power strip increases the risk of electrical fires. Fuel-burning heaters can also produce dangerous carbon monoxide levels if ventilation is inadequate.

To stay warm and safe, layer clothing and use blankets to retain body heat. Limit outdoor activities and cover exposed skin when going outside. Monitor updates from local authorities and prepare emergency supplies, including food, water, and flashlights, in case of power outages. ## MyHealthEVet and VAApp are Transitioning Sign-On Partners, Veterans encouraged to make the switch by Jan. 31 deadline

On Veterans Day 2003, the Dept. of Veterans Affairs launched a new tool to help Veterans control their healthcare decisions and have in-depth access to their medical records online. MyHealthEVet has been helping Veterans ever since, it is an irreplaceable website that allows them to schedule medical appointments, communicate with their provider teams, order prescription medication online, request medical records within 24-hours of visits, and much more.

Since the site launched in 2003, 5-million Veterans have used MyHealtheVet to refill more than 148 million prescriptions, send an excess of 86 million secure messages, download more than 37 million health data reports, and view upcoming VA appointments over 74 million times.

In July of 2021, the VA also released the VA App for mobile phones, increasing Veteran access to some MyHealthEVet features such as the prescription refill requests and live communication, and including some non-healthcare features such as tracking service-connected disability claims and payments. More than 300,000 Veterans have downloaded the VA Mobile App to their cellphones.

In order to enhance security, protect Veteran's data, and consolidate Log-in info, the VA has decided to reduce the amount of sign-in partners for these vital online tools. Going forward, the VA has partnered with both ID.me and Login. Gov to provide Veterans with a secure, 2-step authentication process for all of their online applications. Veterans who have used other methods of logging on, such as the VA.gov website log-in and password or DS Logon will no longer be able to access MyHealthEVet, the VA App, or VA.Gov website without transitioning to one of the two secure sign-in partners. The effective date for this transition is set for Jan. 31, 2025.
