Calhoun commission holds first meeting of 2025

The very lengthy first Calhoun County Commission meeting of 2025 was held on Monday, January 13th, 2025 and the very first meeting of Commissioner Eric Lupardus. The first matter of business was the election of Craig Arthur as Commission President upon the nomination of Eric Lupardus, seconded by Jacob McCumbers.

Following the approval of the December minutes, Commissioner Lupardus stated that moving forward he wanted the agenda approved by all three commissioners to avoid mishaps, such as that of the December meeting, where two agendas were prepared, one by Commission President Craig Arthur and a second by Clerk Jean Simers who was out of her office for medical reasons.

Under delegations was Carrie Decker who serves as the Community Liaison for the Pioneer Community Network. Ms. Decker works to reduce barriers to participation in federal programs, assist in preparing successful funding applications, and work to increase investments in Braxton, Calhoun, Clay, Gilmer, Nicholas, Roane, Webster, and Wirt counties. She presented her programming to the Commission and offered future assistance by USDA, RPN which combines

Mayor Petrovsky/Town Council has heated discussion with GVD members

Although delayed a few days by weather, the Grantsville Town Council met Friday evening at 6 p.m. on Jan. 10th, 2025, for their first meeting of the new year.

Winter weather was likely the cause of low attendance with the exception of the Grantsville Volunteer Fire Department members.

Recorder Emily Collins presented the list of State holidays and the meeting schedule for 2025 to the four council members present: Cheryl Sturms, Linda Staton, Emilee Morgan and Rissa Staples and Mayor Robert Petrovsky.

At the beginning of the meeting one council seat remained vacant.

Every position is open for Grantsville citizens to file for the coming June 2025 Town Government Election. Filing opened Monday, Jan. 13th through the 25, 2025. Individuals can file from 8 a.m. to 4 p.m. during business hours in the Town Office on Main Street in Grantsville. Filing Fees are \$15.00 for a Council seat, \$25.00 for Recorder and \$50.00 for Mayor and must be filed in person. Under Committee reports Cheryl Sturm informed those present that a list of donors to the City Park effort had been delivered to the Calhoun Gilmer Career Center to create a 4' x 4' galvanized steel

sign as well as a 2'x 4' sign with the park rules cut out of the steel.

There was no new or unfinished business, however the mayor did say that the committee working on the O&M agreement between the county and city utilities would meet again on Friday, Jan. 17th, 2025. No time was provided.

Grantsville Volunteer Fire Department members appeared before the council regarding recent interaction with the mayor and alleged threats that the Town of Grantsville was suing the Grantsville Volunteer Fire Department over illegal use of water, by providing water to a private citizen to fill a cistern.

Members of the Grantsville Volunteer Fire Department, who donate thousands of hours and dollars of their own families' budgets to provide fire protection to the citizens of Calhoun County stood before the Grantsville City Council having to defend helping a citizen while being accused of theft of a public utility. Courtney Alexander, who was later appointed to the vacant seat of the town council, addressed the Fire Department members regarding the law and their lack of respect for officials. 1982 Foundation director speaks out on 2025 goals

Crysal Laughlin Mersh the Director of the 1982 Foundation in an online post outlined the 2025mgoals of the 1982 Foundation and her hopes and aspirations concerning the Foundation, the future and the people of the county.

According to Mersh 2025 will be a pivotal year but she believes it will turn in a positive way because of the resilience and makeup of all those involved.

Her thoughts and comments:

"There ALWAYS was a method to the madness.

"This project has been and continues to be a very interesting journey in change management.

"In many ways it's the archetypal case study of the change roller coaster: excitement to questioning to denial to anger to depression to realization to success ... and more success. At the beginning of 2025 we are firmly parked between realization and success which is a great place to be. "I know we have had some rocky roads. I also am keenly aware that some of my methods and means were not conventional to our community. I also know that I personally bear the brunt of that. I accepted this before the contract ink was dry.

"Why? Because I by profession, am a leader of change. That is what I have done my whole life. So I knew it was possible and because I knew the people I am dealing with ... in fact I knew it was likely.

"Why? Because I knew the cloth that you all are cut out of because it's the same one that I am cut out of. Our basic values of compassion, honesty, integrity, hard work and love of family/friends is material you can build from.

"I realized early on our people had lost their hope. I talked to so many people who described it as apathy which it was not. Apathy means a lack of caring. Our



And that's a lot.


Quite honestly, I can't believe the 46th President could have done all the bad things he did accidentally and that he had to do them on purpose. I honestly believe that.



Jan. 16, 1850: Lawman Dan Cunningham was born in Jackson County. His remarkable career involved him in the Hatfield-McCoy Feud, the West Virginia Mine Wars, and the destruction of moonshine stills.



Jan. 16, 1869: Ephraim Franklin Morgan was born in Marion County. Morgan, a Republican, was governor during the tumultuous West Virginia Mine Wars.





Jan. 17, 1918: The War Department hired a powder plant and a complete town with houses, a civic center and a hospital were completed.



Jan. 17, 1956: Musician Blind Alfred Reed died. He was a street singer, fiddler and songwriter from Pipestem, Summers County, and is a member of the West Virginia Music Hallof Fame.

Jan. 18, 1842: Wayne County was established from part of Cabell County. It was named for General "Mad Anthony" Wayne, a Revolutionary War hero who later defeated Ohio Indian tribes at the 1794 Battle of Fallen Timbers.

Jan. 19, 1818: The Virginia General Assembly established Preston County from part of Monongalia County. The new county was named for James Patton Preston, then governor of Virginia.

Jan. 19, 1820: Fairmont was established by the Virginia legislature on the farm of Boaz Fleming. The original name of Middletown was changed to Fairmont in 1843.

Jan. 19, 1844: The Virginia General Assembly established Taylor County from parts of Barbour, Harrison and Marion counties. The county was named in honor of U.S. Sen.

John Taylor, a soldierstatesman from Caroline County, Virginia.

Jan. 19, 1848: Wirt County was created by the General Assembly of Virginia from portions of Wood and Jackson counties. It was named for William Wirt, Virginia statesman and a presidential candidate in 1832.



Jan. 19, 1894: Railroad worker John Hardy was hanged for killing a man in a drunken gambling dispute. The episode inspired the widely popular ballad "John Hardy."



Jan. 20-21, 1824: West Virginia's most famous soldier, Thomas Jonathan Jackson, was born near midnight in Clarksburg. When Virginia left the Union in 1861, Jackson went with his native state. He commanded the strategically important post at Harpers Ferry

July 21, 1861, he won the name "Stonewall" for steadfastness at a critical point in the engagement.

Jan. 19-20, 1978: An overnight snowstorm paralyzed Charleston. Unusual in that more snow fell in the capital city than in Randolph County, total snow depth in Charleston averaged 24 inches, the deepest on record for the city. January 1978 became the snowiest month for both Huntington and Charleston, and extended cold kept the snow cover on the ground into March, the longest known continuous snow cover for most towns in West Virginia.

Jan. 21, 1906: The first passenger train ran from Elkins to Charleston following completion of the Coal & amp; Coke Railway. The new railroad, a project of former senator Henry Gassaway Davis, provided a muchneeded north-south route through the heart of West Virginia.

Jan. 22, 1927: Confederate General John McCausland died. After the fall of the Confederacy, McCausland fled the country. He returned in 1867 and spent the remainder of his life on his large farm in Mason County.

West Virginia Attorney General Patrick Morrisey, through the office's Consumer Protection and Antitrust Division, has sent letters to the state's 55 counties and 229 cities, informing officials of their share from a settlement between the state and pharmaceutical companies Pfizer Inc. (and related companies) and Ranbaxy Inc. (and related companies) in an antitrust lawsuit involving a generic version of cholesterol drug Lipitor. The lawsuit alleged the two companies conspired to delay the introduction of a generic version of Pfizer's Lipitor that was produced by Ranbaxy. "The money for the counties and cities are to partially recover their excess payments or reimbursements for the medication," Attorney General Morrisey said. "The political subdivisions do not need to take any action in receiving their share." The amount each county and city would receive depends on the size of their population-the counties will receive a total of \$1,630,000; cities, \$1,855,000.

The lawsuit was filed in 2013 and alleged the two companies created a scheme that prevented a generic, cheaper version of the cholesterollowering drug to be introduced on the market for 20 months-Lipitor's original patent expired on March 24, 2010. "This is a big victory for the free market and consumers who may have paid more than what they should have for the much-needed medication," Attorney General Morrisey said. "In all aspects of business, and that includes the pharmaceutical business, competition is key to a healthy marketplace."

applicants, while the Calhoun Sheriff's Department and West Virginia State Police are forced to provide protection and not given renumeration by

all. Mayor Petrovsky swore her in and she took her place at the council table.

The Grantsville Volunteer Fire Department building has one meter at the building logging the water use of the department meeting area. The other unmetered area is the one providing water to fill the fire trucks. The meter to the inside of the building is mechanically unreadable. The two inch meter inside the truck bay does not get read.

The wholesale value of 2,000 gallons of water is probably about \$20.00.

There is a risk of the loss of every volunteer fire department member because they're tired of the community's failure to recognize their value. the Town of Grantsville.

The members of the Grantsville Volunteer Fire Department Board questioned the mayor as to his intention against them, because they would be in need of hiring an attorney. The mayor informed them that he was unsure of where the "investigation" would lead for which he was "forced to pursue by a citizens complaint."

The complaining citizen was not named.


"So, we have arrived at the make or break year of the project. And I know

WVDNR announces return of trout stockings *Anglers are reminded to purchase a 2025 fishing license and trout stamp*

The West Virginia Division of Natural Resources (WVDNR) announced the return of trout stockings to select lakes and streams around the state.

"Whether you're casting a line for the first time or you've been fishing these waters for years, our stocked lakes and streams offer the perfect opportunity to experience the thrill of fishing and the natural beauty of West Virginia," said WVDNR Director Brett McMillion. "We encourage everyone to get their 2025 fishing license and stamps and plan a fishing trip this winter."

Lakes and streams receiving a stocking during the week of Jan. 2 include:

Anthony Creek Cranberry River Gandy Creek Glady Fork James P. Bailey Lake Knapps Creek Laurel Fork (Randolph) Little River West Fork Greenbrier River Shavers Fork (Bemis) Shavers Fork (Upper Section) Spruce Knob Lake West Fork Greenbrier River Williams River

While daily trout stockings are not announced in advance, the WVDNR publishes a list of recently stocked waters at WVdnr.gov/fish-stocking. Anglers may also find out what waters have been stocked by calling the stocking hotline at 304-558-3399. In inclement weather, missed stockings are made up by either additional stock-



ing runs or additional fish are added to upcoming stocking events. For more information about trout stocking locations, anglers should check pages 6–7 in the 2025 Fishing Regulations Summary, available to download at WVdnr.gov/fishing-regulations. All anglers 15 years and older are required to have a West Virginia fishing license and a valid form of identification while fishing in the state of West Virginia. federal, state and local resources to create jobs, build infrastructure, and support long-term economic stability in rural communities. In West Virginia, Community Liaisons like Ms. Decker help advance local priorities and projects in the state's two community newworks. Each Community Network receives dedicated community development support to help them navigate federal and other programs, build relationships, and identify community-driven solutions.

Jason Wilson, EMS Director for Minnie Hamilton reported to the Commission the number of calls and statistics of the ambulance service. He further stated that they were currently down one Paramedic due to a fall on the ice in front of their station which fractured her leg. Wilson commended the volunteer Fire Departments for their assistance during medical emergencies in getting crews to the scenes when roads were heavily covered in snow. He then requested that the County consider providing protective vests for ambulance crew members to have when traveling to an area where there are possible shooters which recently happened. Wilson believed the crews could be at risk as they were often the first responding to a scene of uncertainty. Wilson suggested that multiple sizes be purchased for crew members to put on their trucks each day but that the director and supervisors should have their own. It was agreed that a work session would be held with Emergency Services and the Calhoun Commission on January 30th, 2025 at 4 p.m.

The Calhoun Wood Festival Committee reported that several members recently attended the WV Fairs and Festivals Convention where they listened to several bands and made contact with fireworks providers in preparation of the 2025 Wood Festival. and Pleasant Hill Church for crisis situations. The FRN also keeps MRE's (Meals Ready to Eat) and other shelf stable meals to help families throughout the year.

Sheriff Graham Knight reported to the commission that Home Confinement continued with little change. He also announced that he had been working on trying to get a community service option for sentencing but currently the County's insurance didn't allow it. Sheriff Knight believes that it should be revisited with the insurance and has spoken to Magistrate Lora Davis. Davis said that the community service option would offset the defendant's fines but not their court costs which is State mandated to be paid. Should this option be made available, defendants would be monitored by the Home Confinement officer.

Sheriff's Knight expressed that it had been a rough couple of weeks for emergency services. But he felt the need to say that through the snow even with trucks down, the Calhoun Department of Highways worked 24 hours a day and have done all that they can do. Regarding the vests request by Jason Wilson, the Sheriff said that "we all wish we lived in a Mayberry but we don't. Every year we have more escalations. Neighboring counties see it all the time. There is a chance that something could happen to a first responder because they're often first on scene. They're alone a lot." He described a Dementia patient, that had a loaded fire arm in their home and had informed control that they had shot an intruder twice (which was not actually true), but the possibility is there that they could have. Since the last meeting the Sheriff's Department has had a retirement of Deputy Jeff Hunt, and the department continues to. Have a high call volume. Everyone is short on staff, when the time comes he warned that the budget may have to be revisited regarding the hiring of additional staff. Knight brought to the attention of the Commission that the current WV State Code books available to them were out of date. A full set would cost the county \$2,500. It was determined that the Commission would investigate what books needed updated in the Courthouse and the County would look into making sure there was a complete set available to all staff.

Regarding the O&M Agreement, itemized receipts were presented with a balance of funding. The O&M Committee paid 20% down on the building that will house the consolidated agencies. In addition the Commission agreed to pay the January Bonds for Mt. Zion PSD, Pleasant Hill PSD and the Town of Grantsville.

Ridgeview News Publisher, Shari Johnson, questioned the Commission about a recent report that she had received that certain members of the O&M Committee were monopolizing equipment purchases as if one entity had governance over another. The Commission assured that they'd look into the matter.

The Commission voted to host two meetings monthly – one morning and one evening meeting to allow the community better access to local government. Monthly meetings will continue on the 2nd Monday at 9 a.m., with the addition of a meeting on every 4th Monday at 6 p.m. January 27th would be the next meeting of the Calhoun County Commission. Changes may occasionally occur due to other commitments

It was also voted that the Calhoun County Commission agendas be published one week in advance of each meeting in the Calhoun Chronicle and the Ridgeview News.

For many years Calhoun County has been supposed to partner with Roane County for an LEPC (Local Emergency Planning Committee). But because of their failure to attend the meetings, Roane County was in the process of removing Calhoun County from their organization. However, Eric Lupardus attended their last meeting and it was agreed that Calhoun would once again become active with the LEPC. Applications will be made available for various agency representation through the Commission. The next LEPC meeting is January 22nd, 2025 at 1 p.m. at Roane General Hospital. Commissioner Lupardus requested that access to the courthouse, which has been the responsibility of the Calhoun County Clerk's office, be turned over to the Calhoun Sheriff's Department for security reasons. Commissioner McCumbers questioned the reasoning behind the change of command to which Lupardus and Sheriff Graham Knight explained that at a recent Security meeting with the State it was brought to their attention that as a matter of security the Sheriff should know who has access and when, and should be the determining factor because the accountability fell to his office. The matter was voted on and passed that Sheriff Knight will now govern courthouse accessibility. Under old business the Commission decided to work on an advertisement for an administrator and it will be on the next agenda to approve an advertisement and post it. They also approved posting an advertisement for a County Surveyor.

Calhoun Park Board President Donnie Pitts reported that their December Christmas light show was successful with the help of Ricky and Debbie McGuire who provided a very nice computer light show. Mr. Pitts stated that the park is hoping to get school, churches, businesses and community involved to expand the show next year throughout the park encouraging visitors to travel to the area.

The Calhoun Park Board requested \$500 for a Seestar Telescope that will be made available to park visitors. The telescope is packed with \$4,000 in technology making it a bargain for what it will allow visitors to experience with ease. The computerized telescope can be used for imaging, tracking, stacking, planetary, solar and even bird watching! The Park Board is in contact with Marietta College in Ohio and Glenville State University in hopes of encouraging those schools to host astronomy programs and utilize what Calhoun County Park has to offer them. A second funding request was made for the astronomy portion of the Park by requesting the County cover the the costs of reimbursement for the star parties hosted at the park which would include the cabin rental and other expenses totaling \$500-\$1,500 for two events. A third request for funding was for the consideration purchasing side by side utility vehicle for park staff to use when traveling over the multi-acreage park. Mr. Pitts suggested a used, low cost model or even one that could be shared with Calhoun Sheriff's Department. Storage could be done at the tractor shed on the park.

Tina Persinger, Director of the Calhoun Family Resource Network informed the Commission that the FRN would be partnering with the WVU Extension office to host a cooking class for 12 students which have already been booked. She also announced that Trinity Yeager will be providing holiday pictures for Valentines Day and other holidays. The photograph cost will be by donation allowing local residents to capture their families in affordable photos. FRN continues to provide food pantry deliveries and recommends the community watch their Facebook page and website for dates and times.

Mrs. Persinger encouraged the commission to work with Carrie Decker and the USDA and HUD housing with a focus on housing for recovering addicts. She told the Commission that they'd recently had several people displaced because of the weather. FRN has four apartments that are currently rented, Grantsville Manor housing is full as well as Calhoun Homes and the Red Devil Inn. According to statistics, housing availability drops the addiction rates in a community. Calhoun FRN is working on getting a generator to allow their building to become an emergency shelter. Currently two shelters are available being the Arnoldsburg Community Park Sheriff Knight presented several receipts for the Animals Fosters in the county who requested reimbursement for food and other things that apply to the welfare of the animal. Six dogs and two cats were currently being fostered by the County.

Sheriff Knights final request from the Commission was for the purchase of signage to discourage semi trucks from going onto roads that do not allow large trucks passage. This endangers not only the truckers but citizens when emergency services cannot get through due to the long periods off time it takes to remove the trucks, sometimes taking 5-6 hours, involving wreckers and emergency crews to assist. The WV State Highway will not place signs on roads until there are a certain number of incidents. Knight would like the county to take precautionary measures in preventing it by placing the signs themselves. The Commission plans to look into the legality of placing signs on the State's right of ways.

Sheila Burch, Director of the Little Kanawha Area Development Corporation made a recommendation to the Commission that the County get back to work on the Comprehensive Plan with a meeting in the month of March to set goals for the coming five years. The Commission agreed with Eric Lupardus stating that it the Comprehensive Plan was a living document that need to be given attention. Lupardus also asked where the LKADC was at with their micro funding. Mrs. Burch stated that the LKADC has their own revolving loan fund tat caps at \$25,000 for which they've funded three businesses in Calhoun and Wirt Counties over the past year. MOVRC (Mid Ohio Valley Regional Council) provides funding opportunities of larger amounts. She noted that neither agency is in competition with the Banking industry but encourages businesses to seek funding through the bank when feasible, and if funding is not available come to LKADC and MOVRC for help.
