

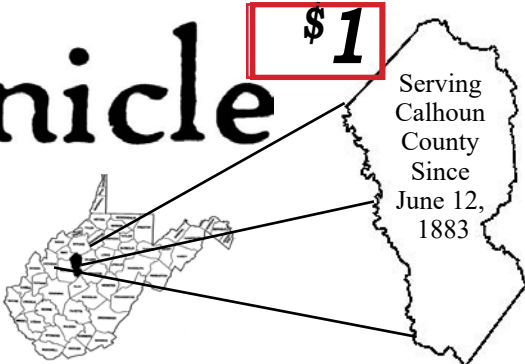

Some day when she is older Abi Waldron should never have to step back and say “what if” when it comes to her high school athletic days.

That’s because the Calhoun High School senior is participating on five sports teams for the Red Devils.

She is doing it this spring juggling two sports – softball and track – and doing well in both.

Saturday, she slammed the first home run hit by a member of the Red Devils as Calhoun beat South Harrison for its first victory. The Red Devils beat the Hawks 5-4 en route to a doubleheader split as the Hawks won the second 15-12.

Earlier in the she hit new personal records in the 100-meter dash and the shot-put in something of an unusual combination.

She also participated in cross country, volleyball and basketball and was one of the leading performers in each sport.

“This young lady keeps me busy,” her mother Shannon Waldron said. “This year

she decided to go out for five sports and does a fantastic job in every one. Whether it’s participating, helping her teammates or volunteering to show her support for other teams.

“Abigail Waldron sure keeps me on my toes keep it up Abi, very PROUD of you!”

Another mother, who knows exactly how busy she is is Donna Schoolcraft whose son played four sports including football, basketball, cross country and track while also participating in FFA and while playing in the band, dancing and acting.

“He may not have been the greatest athlete, but as far as school pride, I would rival him against anyone,” she said. “Josh also did theater and performance in dancing with the girls he lived at that school.”

“Do it all because he did and looking back. He now loves his high school years and appreciates every opportunity that he had,” she said. “Abi is a wonderful young lady and will do whatever she sets her mind to.”

Waldron announces write-in candidacy for town recorder

Shannon Waldron announced her candidacy for town recorder as a write-in in the June 2025 Grantsville Municipal Election. Her opponent in the election is current recorder Emily Collins who had been unopposed.

Waldron graduated from Calhoun County High School in 1986. She went to Calhoun-Gilmer Career Center, earning her CNA in 1990, and to Arch A. Moore Vo Tech (now Roane-Jackson Career Center), where she obtained her LPN in 1991. She graduated from Glenville State University in 2023 with a bachelor’s degree in criminal justice forensic science and an associate’s degree in general studies.

She is a mother of five children: Kevin Yeager Jr., Zachary Yeager (state wrestling champion), Justin Yeager, Gabriel Waldron, and Abigail Waldron. She is also a grandmother to five grandchildren: Joselynn Yeager, Liam Yeager, Payden, Elijah Yeager, and Ella Yeager.

She has 14 years of experience in nursing.

Her extended family includes notable figures such as Samuel Tanner, her 5th great-grandfather from Roane, WV, and Ernest Weaver, her grandfather who served as a Master Chief in the Navy. Her father, Freddie Helmandollar, also served as a Master Chief in the Navy from Pocahontas, WV.

Shannon’s siblings include Mary Johnson, who served in the Navy, and Jason Rider, a Wayne Underwood recipient in 1996. Her granddaughter, Joselynn Yeager, is also in the Navy. Shannon’s uncle, Donald Weaver, was a biology teacher and football coach at Calhoun County, and her great-uncle, Bob Weaver, is associated with the Hur Herald.

She said she prefers to stay under the radar, though she acknowledges the need to step into the spotlight occasionally. Running for recorder she says is one of those times.

Fireworks expected at Monday (April 7) town council meeting

The agenda has not yet been posted for the April 7, 2025, Grantsville Town Council meeting but almost assuredly fireworks are very possible.

That’s because questions have arisen about finances, water and fire hydrants and answers are being demanded.

Grantsville business owner Crystal Mersh wrote Grantsville Mayor Robert Petrovsky the following letter:

“Good morning, Mayor,

“I and others have had a number of calls and contacts related to the concern for the inoperable fire hydrants and your and the council’s lack of action to remedy the situation. The council was informed on Jan. 10 and as you can see on the video at 19 minutes a council member spoke up and expressed great concern and indicated this was the first time the town council had been informed of the failing tests from October 2024. You promptly shut that concern down and reverted to a discussion accusing the GVFD of stealing water (which is also incorrect as you are responsible for having an operational meter there). The attempts to distract and derail focus on critical topics such as operational fire hydrants are over. The people have had enough.

“There will be a call to action for the people of Grantsville to attend the next council meeting on April 7 and get a detailed update on the fire hydrant situation. You should be prepared to accommodate a large crowd and press, including TV.

“The following information is requested to be presented in a clear, precise and professional manner. Please add this to the agenda:

- Inventory and location of fire hydrants in town
- Specifications for how many there should be location with proximity to each other and any other code requirements
- Date of last test for certification
- Results (and specifications) of the last test
- Final assessment of pass or fail for each hydrant
- A plan of action for remedy to bring all up to code
- A risk mitigation plan until such time as they are all in compliance.
- A detailed list of all actions taken to ensure the safety of the people of Grantsville since the Jan Council meeting when the council was stunned to learn of the failing results from tests from last fall. Please provide evidence of these actions.

“People’s lives and safety are at risk and they deserve real answers not just a few papers flung at them and no action plan by the governing body.

“We look forward to hearing your detailed overview which illustrates your willingness, capability and commitment to the safety of the town.

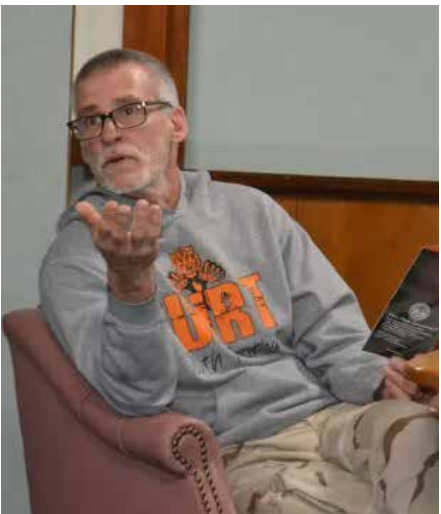

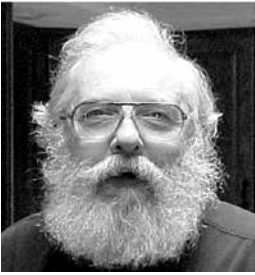

A big crowd was on hand at city hall in Ellenboro for the meeting on the abandonment of 1100 miles of Hope Natural Gas Company [Rockefeller] gas gathering lines. These are what they call the “red lines”. The “news” was that Mother Hope now intends to transfer/sell all the lines to Rusty Hutson Jr.’s Diversified Gas & Oil. To say that the natives were “restless” would have been a very mild understatement as answers were not really forthcoming. When asked why Diversified was not represented at the meeting there was no answer since it was obvious that the Alabama based firm would have a very significant impact. Earlier the PSC had ruled that Mother Hope could start changing folks over to propane and the PSC had a man there, but he never opened his mouth. It should be noted that he did talk at the Grantsville meeting. There were 3 Tee Vee stations at the gathering and the affair made national news with a report on Marcellus Drilling

News. Ritchie County commissioners were instrumental in having the meeting there and seeing to having a good crowd. Earlier the Hope man, Mr. Jeff Nehr, said the lines would be given to “any taker” but now the sum of \$18 million seems to be on the table. [Peasants mind your own business!]

The Creston Community Building meeting was Tuesday, April 1 at 6:30 P. M. At the Creston Community Building.

There was a meeting in Wirt County to set up a Christian school since the government school[s] are obviously failing since they do not have to compete or encourage students to learn and learn to think.

Finally, he received a letter from SS saying that he did not have to pay back those checks and he kept that letter. A few years later he received a terse letter demanding that he repay “all he owed” or else there would be a deduction from his check. “Pay or else”. A very ‘blunt’ letter was sent to the SS folks along with a copy of the prior letter stating that he did not have to repay anything. The man was lucky as he had a helpful postmaster and folks who could craft letters for him. It is obvious that fraud has infested the agency for a long time. Those who would prey on the vulnerable need to “earn” long vacations in “nice places”. Perhaps the Bureau of Prisons could take some lessons from the folks in El Salvador.

When the April 7th Grantsville Town Council meeting gets under way do we need Michael Buffer?

For those who may not know Michael Buffer is an American ring announcer for boxing, professional wrestling, and National Football League events. Pioneering a distinct announcing style in which he rolls certain letters and adds other inflections to a fighter’s name and known for his trademarked catchphrase: **“Let’s get ready to rumble!”**, he was inducted into the International Sports Hall of Fame in 2019.

So, do we need him when the meeting gets under way and Grantsville Mayor Robert Petrovsky and Grantsville business owner Crystal Mersh get down to business on the business of Grantsville?

“MARK YOUR CALENDARS FOR APRIL 7! COME OUT TO THE TOWN COUNCIL MEETING FOR DETAILED UPDATE SUPPORTED BY DATA. WEAR YOUR SUNDAY BEST AS WE ARE INVITING THE PRESS. THE PEOPLE DESERVE ANSWERS AND THE TRUTH!

“STAND YOU FOR YOURSELVES, YOUR NEIGHBORS AND OUR TOWN.

“PS SINCE COUNTY TAXPAYERS HAVE INVESTED MORE THAN \$160,000 IN THE TOWN ... YOU NOW HAVE A DOG IN THE FIGHT. COME AND SEE HOW YOUR MONEY HAS BEEN UTILIZED.”

And there is this:

“Confirmed by the Mayor ... there is no plan to fix the nonoperational fire hydrants. They will be fixed as “maintenance when it can be conducted.”

“He is unwilling to provide the code. He has no plans. He has no interim safety measures to protect the people and property until the hydrants are operating and meet specs. And he has no list of actions taken since the January meeting when this was reported to the council.

”And he put it all in writing ... now you know.”

An attached note from the mayor does seem to indicate upgrades and repairs will only be done when repairs are necessary.

There there is the matter of the amount of money the town owed for bonds which went from \$317,000 to more than \$4 million.

There is also the alleged theft or loss of water at or by the Grantsville Volunteer Fire Department.

The list could go on.

But we (myself and the Calhoun Chronicle) have a few basic questions.

They are: Are we safe? Do the fire hydrants function properly? How much money do we owe? And how did it get there? Is the VFD guilty of loss of water or theft? Or is this just another straw dog meant to muddle the situation?

Frankly here are the answers:

Every fire hydrant needs to be fixed NOW.

Every little “Mickey Mouse” fire hydrant needs to be replaced with a bigger sized fire hydrant NOW. And they all need to be painted red with white trim including the hydrant number. And this includes every fire hydrant in town and on lines maintained by the Mount Zion Public Service District and the Pleasant Hill Public Service District.

The amount of money owed needs to be determined NOW.

And if the amount of money owed is more than the \$317,000 we need to know how in the hell it got to the higher amount NOW. No more pussyfooting around with the financial records there has to be an accounting made or heads need to roll. This is not only misfeasance and malfeasance it may be criminal.

We need an answer to the missing or stolen water NOW.

Is it for real or a mistake? Or is it worse a straw dog? And if it is a straw dog the one putting it out there needs to apologize and probably step down. If it is not a straw dog the one putting it out there needs a pat on the back for calling our attention to it.

Frankly we have one hell of a mess and it needs to be fixed now. If that means getting better volunteers we need to do that NOW.

But it looks as if the better solution would be to go to a metro government with a trusted and competent professional administrator giving our volunteer leaders help and guidance so we never get in a mess like this again.

Until next time stay safe but don’t live life in a bubble.

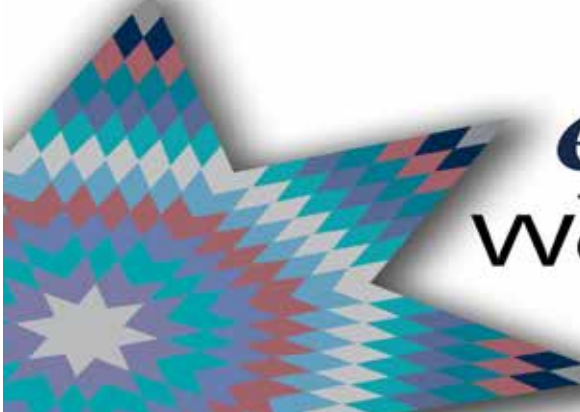

April 3, 1755: Frontier scout and "long hunter" Simon Kenton was born in Fauquier County, Virginia. Upon leaving home, Kenton first traveled north through present West Virginia to Pittsburgh and then explored, hunted and trapped through much of the Ohio Valley.



April 3, 1908: Samuel Starks died in Charleston. Starks became the first Black state librarian in the nation when he was appointed to the position in 1901 by Governor Albert B. White.



April 4, 1948: Renowned gospel singer Squire Parsons was born in Newton, Roane County. A graduate of Spencer High School and West Virginia Tech, he is best known for

his song "Sweet Beulah Land."



April 4, 1980: Musician Red Sovine died in Nashville. Sovine, born Woodrow Wilson Sovine in Charleston, gained country music fame for his recitations, especially those incorporating sentimental truck-driver themes.



April 5, 1856: Booker T. Washington was born enslaved in Virginia. In 1865, he moved with his family to Malden, in Kanawha County, to join his stepfather, who had escaped from slavery during the Civil War. He became one of the most influential educators in U.S. history.



April 5, 1920: Gifted hand weaver Dorothy

Mayor Thompson was born. She taught generations of people about fiber arts. For her dedication to preserving folklife traditions, she was named a National Heritage Fellow in 2000. She died in Tucker County in 2008.

April 5, 2010: An explosion at the Upper Big Branch Mine in Raleigh County killed 29 workers. Only two men escaped from the mine alive. It was the state's worst coal mining disaster since 1968, when the Consol No. 9 Mine at Farmington exploded, killing 78 workers.

April 6, 1938: The Civilian Conservation Corps (CCC) established Camp Kanawha in Kanawha State Forest. The CCC removed all the abandoned houses, coal tipples, and other structures no longer in use, and constructed roads, the forest superintendent's residence, office, maintenance building, and picnic shelters.



April 6, 1944: Guitarist and singer David Morris was born in Ivydale, Clay County. With his brother John on fiddle, the Morris Brothers founded music festivals, supported union and environmental causes and promoted West Virginia traditional music nationwide. He died in 2016.

April 6, 1964: Brad Smith, the former head of Intuit, was born in Huntington and then grew up in Kenova. In 2021, he became the 38th president of his alma mater, Marshall University.

April 7, 1927: A. James Manchin was born in Farmington. In 1984, the longtime secretary of state was elected state treasurer but soon fell into trouble. With a stock

market downturn in 1987, Manchin bore much of the blame when the state lost nearly \$300 million in investments. He died in 2003.

April 7, 1947: Medal of Honor recipient Thomas W. Bennett was born in Morgantown. Believing it was wrong to evade the draft while others had to serve in Vietnam, he volunteered as a noncombatant medic. He was killed by gunfire while dragging a wounded soldier to safety.

April 7, 2004: Gov. Bob Wise signed legislation that transformed four colleges into universities: West Virginia State, Shepherd, Fairmont State and Concord.

April 8, 1891: The town of Paw Paw was incorporated. Strategically located on the Potomac River, the Baltimore & Ohio Railroad and the C&O Canal, Paw Paw was named for the banana-like pawpaw fruit that grows in the area.

April 8, 1951: An Air National Guard transport plane crashed near Kanawha (now Yeager) Airport, killing 21.

April 9, 1817: John Nuttall was born in England. He was one of the first operators to ship coal on the Chesapeake & Ohio Railway in the early 1870s and founded the town of Nuttallburg in the New River Gorge.



April 9, 1900: Physician Margaret Byrnside "Dr. Maggie" Ballard was born. She actively pursued her interest in genealogy and local history and was a founder of the Monroe County Historical Society.

to consider.

During my tenure as Mayor, not once has the fire department approached the city in any way to address any issues they may have had with their process of training or familiarization with the hydrants they use. Previously, the Chief Water Plant Operator tasked with testing the hydrants as well as being fire Chief for many years. (See 2023 Dave Johnson hydrant test report. A considerable difference in quality of reporting from 2023 and 2024). Never brought any issues to light about hydrants.

As for the hydrant that the fire department is currently saying was inoperable during the fire, that hydrant is a two inch blow off hydrant. Fire departments are not allowed to hook to them as the lines are not designed for that. Had they hooked to it, it would have drained lines in homes, hot water tanks and damaged underground lines. Something all volunteer fire fighters should be trained in on their level. The town does not conduct firefighting training.

This issue solely arose since the town confronted the fire department for selling water to certain folks for a donation, which is illegal.

In the January meeting, I spoke with Carl Brannon who was going to sit down with me, get a copy of the report and discuss the various issues that needed ironed out to include the placement of a working 2-inch meter, which has been purchased by the town, to monitor the water usage for lost water reporting issues. From the January meeting until Mrs. Brannon came to get the report the morning of the fire, the Chief never called or met with the town.

The monitoring of the hydrants will be conducted annually and really biannually as required, by the new plant operators and soon the O&M management team. Until such time as the O&M is up and running, the town will continue to repair those identified hydrants utilizing the additional funds it now has secured through the much needed 60% rate increase.

The resale rates increased 18.62%, from \$5.37 to \$6.37 per 1,000 gallons.

Commission Staff reviewed the District's application and recommended that the Commission approve Staff Recommended Rates effective on an interim basis. By Order issued March 28, 2025, the Commission approved the Staff Recommended Rates on an interim basis, that increased rates by \$1.23 per thousand gallons metered water usage for all bills issued on and after March 28, 2025.

The average monthly bill will be changed as follows over current rates:
