## WVBOE approves Clay County Special Circumstance Report; **Removes Lincoln County State of Emergency**

The West Virginia Board of Education (WVBE) addressed Special Circumstance Reviews in two counties during its January meeting in Charleston at their latest meeting. The state of emergency for Lincoln County Schools was lifted, and the county was granted full approval status. Additionally, the WVBE approved a Special Circumstance Review report for Clay County Schools, the result of an investigation late last year.

The West Virginia Department of Education (WVDE) initiated the review of Lincoln County in March 2020 citing several areas of non-compliance. The WVBE declared a state of emergency in the county in November 2020 to provide additional supports to address persistent deficiencies.

After extensive involvement, the WVDE Office of Support and Accountability found, while work remains, corrective practices and procedures have been implemented in the county office and with the Lincoln County Board of Education.

"We are returning the keys to Lincoln County and allowing them to drive the car and govern county operations independently," said WVBE President L. Paul Hardesty. "However, I caution the County Board of Education to not resort back to the practices that caused State Board action because we will step in again if

The WVDE initiated a Special Circumstance Review of Clay County Schools at the request of the State Superintendent of Schools David L. Roach. The Office of Support and Accountability conducted the review beginning Nov. 30, 2022, to investigate Clay County Board of Education actions, complaints submitted to WVDE, and student performance as indicated by the West Virginia Balanced

The review outlines nine findings and three non-compliances in the areas of Central Office and Local Board Leadership; Principal Leadership; School Im-

provement Processes and Instruction; Financial Indicator and Purchasing Procedures; and Operation of Federal Pro-

"Clay County has been exceptional in the past, and I believe with the support of our team it will rise again," said WVBE Member Debra Sullivan. "This area has suffered from the loss of jobs, increased poverty, and other challenges. ## Gov. Justice announces petition for the designation of Boone, Clay, Hampshire, Monroe, and Preston Counties as HUBZones

Gov. Justice announced that he has petitioned for Boone, Clay, Hampshire, Monroe, and Preston Counties to be Governor-designated HUBZones.

The Historically Underutilized Business Zone (HUBZone) program gives participating small businesses access to exclusive federal contracting opportunities and preferential price evaluations when bidding on at-large federal contracts. West Virginia is one of the first ten states to petition for expanding access to this program through Governor-designated HUBZones.

"I am so happy to announce that I have spearheaded this petition," Gov. Justice said. "Our great state's small businesses deserve a fighting chance to show the nation the competitive advantage of West Virginia. We remain ready and able to compete for federal contracting opportunities and help revitalize our rural communities through continued hard work and dedication."

If approved, small businesses would now have access to markets where they were previously excluded or where they suffered a competitive disadvantage. Gov. Justice's designations are in addition to existing WV HUBZones where businesses are already bringing federal dollars into the state.

Three percent of all federal contracts are to be funded through this program. In 2020, West Virginia small businesses contracted for \$48 million worth of goods and services. In 2022, WV small businesses contracted for an estimated \$99.7 million.

"The Governor's decision to seek HUBZone designation for five additional West Virginia counties is further evidence of the State's commitment to its small business community," WV Department of Commerce Secretary James Bailey said.

"The HUBZone program presents a great opportunity for businesses to not only increase revenue and diversify income streams but to also continue driving economic growth and job creation locally."

"This petition demonstrates support from state and local leaders, economic development groups, and interested businesses - all of which shows our commitment to assisting and catalyzing our more rural communities," said Mitch Carmichael, WV Department of Economic Development Secretary. "We are excited for this opportunity and think that this access to federal dollars would be incredibly beneficial to the continued economic growth of the Mountain

Jocelyn is also one reason why Lizemore School won the coveted Clay County Schools attendance trophy last school year with an overall attendance rate exceeding 94%. The trophy, given annually, is presented at opening ceremonies in August of each new school year.

Principal Britni Ramsey explained that students like Jocelyn are the reason Lizemore prevailed in the attendance race. "It's been a tough year so far with the flu and other respiratory illnesses, but Jocelyn and dozens of other students with perfect or near-perfect attendance are keeping us in the running for a repeat first-place performance."

Like all Clay County schools, Lizemore uses a variety of incentives to encourage students to pursue faithful attendance. Each teacher plans for weekly and monthly incentives that might include 'treasure box' prizes, popsicles or lunch with the teacher. Students with perfect attendance for the week are eligible to be randomly chosen to win a Hot Wheels car. Winners are announced every Monday. At the end of each grading period the 45 winners race their cars in heats on a six-lane racetrack. The final heats are run before the entire student body, where the winner walks away with a trophy.

As for Jocelyn, she credits her grandparents for her accomplishments. "My grandparents want me to come to school every day to learn, so I'm here every day."

## WV Legislative Interims: 2022 flood appeals package soon headed to FEMA

Just days before the start of West Virginia's regular legislative session, members of the Interim Joint Committee on Flooding met to hear updates on various flood mitigation and recovery projects throughout the state.

G.E. McCabe, director of the West Virginia Emergency Management Division, was the first to speak before the committee.

He said that an appeals package will soon be submitted to the Federal Emergency Management Agency (FEMA) following their denial of public assistance flood relief to certain counties. These denials came after a series of heavy rain events caused significant damage between July 12 to Aug. 15, 2022.

He explained that FEMA classified those storm events as four separate disasters. This prevented certain counties from receiving relief because they didn't meet specific state and county monetary damage thresholds.

After an October review, Mc-Cabe stated the state threshold is now over \$3.1 million in damages while each country threshold varies

depending on population. The event from July 26-Aug. 1, which impacted Fayette, Mingo, McDowell, and Wyoming counties was denied, as was the Aug. 10 storm event which impacted Doddridge and Jackson counties, he said. For the Aug. 15 event, which impacted Fayette and Kanawha counties, only Fayette County met both the state and county monetary thresholds for public assistance.

He said they are working with FEMA and the National Weather Service to classify those events into one single disaster.

He concluded that WV Voluntary Organizations Active in Disaster, the state Department of Highways and others are continuing to assist those who need flood recovery while the state follows the appeals West Virginia State Resiliency

Officer Bob Martin spoke next.

Martin said that through the recent congressional passage of the Water Resources Development Act of 2022, the city of Milton (Cabell County) flood risk management project may be moving forward.

The act increased the federal share of project costs from 65% to 90%, he noted, but it is a roughly

4,000 page document they are "still trying to weed through." Additionally, Martin said that

after 18 years, the statewide Flood

Protection Plan has been updated. It

will be submitted to legislators the first week of their session.

Martin also stated that a study to find ways of alleviating flooding throughout the 97-mile Kanawha River basin is ongoing.





Unction



"That preacher's got unction!" I should hope so, and I hope that you have it too. What does the Bible say about "unction." It's in the King James Bible one time in 1 John 2:20. The Greek word translated unction is found three times in the same chapter. The other two times, it is translated as "anointing," which is what it means in any language.

In 1 John 2:18, John warns the church about the wickedness of false prophets and antichrists. John endearingly calls these Christians "little children" and says they had heard that the antichrist should come, but now, antichrists are running all around, spreading their false gospel. They went out from among the Christian community because they never were part of Christ to start with, and their leaving made it manifest they never knew Christ at all. But, he says in verse 20, you have an unction from the Holy One and know all things.

To understand unction, we need

to recognize the function of the conjunction "but." He contrasts those who depart from Christ with the "little children" who don't. The believers who abide in Christ have something the antichrists and their followers don't. They have the truth, and they have Christ. They have this unction. As John goes on, it's evident that this unction or anointing is not only for preachers but for all those who abide in Christ. It is related to knowing Christ, knowing the truth, abiding in the truth, and not being deceived or seduced by false teaching. Nothing about working up a sweat behind the pulpit.

Unction, as used in the Bible, is God's gift to all believers. Any Christian, born of God and united to Christ, has this unction, the blessing of the New Covenant, indwelt, sealed, kept, and taught of the Spirit of God. All Christians abide in Christ and are safe in him. Unction isn't an emotional feeling, ecstatic fever, a second blessing, or subjective standard of a good sermon. It's

abiding in the Spirit of Christ, and it is the gift of God to all believers. Nowhere are we told to seek an unction, cultivate it, maintain it, pursue it, or that we are in danger of losing it.

We can talk about boldness, zeal, or passion in preaching, but to conflate that with unction doesn't make preaching better, but makes true unction worse. In 1 Thessalonians 1:4-5, the word came, not in word only, but "power and the Holy Ghost." Ironically, there was nothing in Paul's language that one would have particularly found powerful (1 Corinthians 2:3-4; 2 Corinthians 10:10) except when the Holy Spirit came in power to the hearers. And this is by His sovereign grace and pleasure. Not all sermons are the same or are received because God does what He pleases with His Word and people. Rather than subjectively judging or trying to bottle the wind to use on Sunday morning (John 3:8), let's be faithful and pray

## THIS WEEK IN **West Virginia History**

The following events nappened on these dates in West Virginia history. To read more, go toe-WV: The West Virginia Encyclopediaat www.wvencyclopedia.org.

Jan. 18, 1842: Wayne County was established from part of Cabell County. It was named for General "Mad Anthony" Wayne, a Revolutionary War hero who later defeated Ohio Indian tribes at the 1794 Battle of Fallen Timbers.

Jan. 19, 1818: The Virginia General Assembly established Preston County from part of Monongalia County. The new county was named for James Patton Preston, then go ernor of Virginia.

Jan. 19, 1820: Fairmont was established by the Virginia legislature on the farm of Boaz Fleming. The original name of Middletown was changed to Fairmont in 1843.

Jan. 19, 1844: The Virginia General Assembly established Taylor County from parts of Barbour, Harrison, and Marion counties. The county was named in honor of U.S. Sen. John Taylor, a soldier-statesman from Caro-

line County, Virginia. Jan. 19, 1848: Wirt County was created by

Virginia from portions of Wood and Jackson counties. It was named for William Wirt, Virginia statesman and a presidential candidate in 1832.

Jan. 19, 1894: Railroad worker John Hardy was hanged for killing a man in a drunken gambling dispute. The episode inspired the widely popular ballad "John Hardy."

Jan. 20-21, 1824: West Virginia's most famous soldier, Thomas Jonathan Jackson, was born near midnight in Clarksburg. When Virginia left the Union in 1861, Jackson went with his native state. He commanded the strategically important post at Harpers Ferry until being appointed a brigadier general of infantry. In the opening battle at Manassas on July 21, 1861, he won the name "Stonea critical point in the engagement.

Jan. 19-20, 1978: An overnight snowstorm paralyzed Charleston. Unusual in that more snow fell in the capital city than in Randolph County, total snow depth in Charleston averaged 24 inches, the deepest on record for the city. January 1978 became the snowiest month for both Huntington and Charleston, and extended cold kept the snow cover on the ground into March, the longest known continuous snow cover for most

towns in West Virginia. Jan. 21, 1906: The first passenger train ran from Elkins to Charleston following completion of the Coal & Coke Railway. The new railroad, a project of former senator Henry Gassaway Davis, provided a much-needed

the General Assembly of wall" for steadfastness at north-south route through the heart of west virginia.

Jan. 22, 1927: Confederate General John McCausland died. After the fall of the Confederacy, McCausland fled the country. He returned in 1867 and spent the remainder of his life on his large farm in Mason County.

Jan. 23, 1850: Raleigh County was established by an act of the Virginia General Assembly. The county's founder, Alfred Beckley, named it after Sir Walter Raleigh.

Jan. 23, 1888: Union leader Fred Mooney was born in a log cabin on Davis Creek in Kanawha County. He was secretary-treasurer of United Mine Workers of America District 17 from 1917 to 1924 and was a radical leader in the West Virginia Mine Wars.

Jan. 23, 1890: The Mine was organized at a meeting in Columbus, Ohio, with John B. Rae, a Scottish immigrant, as the first president. Just three months later, in Wheeling, UMWA District 17, encompassing most of West Virginia, held its first meeting, elected M. F. Moran as district president and immediately launched what became a struggle of more than 40 years to unionize the state's coal mines.

Jan. 24, 1968: Mary Lou Retton was born in Fairmont. She made history at the 1984 Olympic Games in Los Angeles when, at 16, she became the first American woman ever to win a gold medal in gymnastics and the first native West Virginia woman to win a gold medal in Olympic competition.

Next, Michelle Penaloza, program manager for the Community Development Block Grant Disaster Recovery Program (CDBG-DR), WV Development Office, presented an end-of-year update on progress made from the \$150 million grant from the U.S. Department of Housing and Urban Development to address recovery following the June 2016 floods.

So far, 99% of the housing projects have been completed as well

as 95% of bridge projects and 74% of the demolition projects, according to Penaloza. Also, construction on two multi-family housing projects, Joseph's Crossing in Nicholas County and Stockton Greene in Kanawha County is expected to be completed in April 2023.

Construction bids on 10 family units, as part of the Restore Riverview Program, in Clendenin are expected to go out soon, with construction complete by April 2024, she continued. Construction on Monarch Village rental units in Clendenin is expected to be complete in April 2023, and construction on the 30-unit Patriot Village in Elkview is expected to be complete (cont. from page 1)




