Perhaps the best thing we can do is to pay less attention to those reflections in the mirror and more to the reflections of our lives. We are all here to reflect back the love of God to everyone here on Earth. And when we do we remain both joyful and forever young.

THE BAPTIST CLASSROOM*Pastor Doug Newell, IV***Sunlight**

God's design of the human being is remarkable. We know a lot about the body and the mind, but we have only begun to scratch the surface. I recently listened to Andrew Huberman, professor of neurobiology at Sandford University, where he discussed how sunlight dramatically impacts the body and mind. He detailed how different wavelengths of light can "improve sleep, enhance alertness, modulate hormone levels, and improve mood."

Its incredible how going outside can improve our mental and physical health. There is also research that certain light can be used to heal the body and reduce pain. But we are not just body and mind. Humans also have a soul, and our health can impact our inner life. Being inside too much can hurt your mood, leading to doubt and anxiety. Too little sleep can overload the part of the brain that controls willpower, making us vulnerable to temptation. It

also works the other way. Sin can and does negatively impact the body, leading to sickness or lack of control (1 Corinthians 6:18; Proverbs 23:19-20). Sin destroys.

If we only look from the biological perspective and ignore the spiritual, we are missing a big part of what it is to be a human being. I have no issue with true psychology and psychiatry as long as it doesn't ignore the spiritual. For example, I believe that some people battle social problems, such as anxiety and low self-esteem, where they need help. But if we ignore what the Bible says about sin, guilt, shame, and pride, we may actually be trying to cure the symptoms rather than the disease. Not all anxiety and self-esteem issues result from sin, but sometimes it is.

A person could be depressed because of their work hours, and they never see the sunshine. They may be socially anxious because they

were never given the tools how to interact with people. They just might need a little help. How we feel doesn't define us. But, on the other hand, we may have sinned in our life and are living with the consequences of our past. Does our past sin define us? No, I don't believe it does. The answer here is found in Christ. Our value, worth, and dignity as Christians is not derived from who we used to be but who we are in Christ. There is no condemnation for those in Christ Jesus, and the blessed reality of the gospel is the blood of Christ makes us pure. Our dear and precious Saviour gives rest and peace to all who come to him. The value of a Christian is not based on who they used to be or what they have done but who they are in Jesus Christ.

Sometimes our problems might just be we need to see the sun, and sometimes it's because we are not looking at the Son.

THIS WEEK IN West Virginia History

The following events happened on these dates in West Virginia history. To read more, go to *WV: The West Virginia Encyclopedia* at www.wvencyclopedia.org.

Feb. 1, 1832: Education reformer Alexander Lurk Wade was born. Wade reorganized rural Monongalia County schools to require progress through eight prescribed levels with a graduating exercise and receipt of a diploma. Wade's system worked so well it was copied in other counties and states.

Feb. 1, 1901: Frank Buckles, the last known American veteran of World War I, was born in Missouri. Buckles purchased a farm in Charles Town in 1954 and continued to live there until his death in 2011.

Feb. 2, 1908: Justice Marion Chambers was born in Huntington. Chambers was awarded the Medal of Honor for his actions in the World War II Iwo Jima campaign in February 1945.

Feb. 3, 1825: Confederate General William Lowther Jackson was born in Clarksburg. He was one of at least three Southern officers to bear the nickname "Mudwall."

Feb. 3, 1845: Gilmer County, located in the heart of West Virginia, was established from parts of Kanawha and Lewis counties. It was named for Thomas W. Gilmer, a governor of Virginia.

Feb. 3, 1923: Broadcast announcer Jack Fleming was born in Morgantown. He was the long-time "Voice of the Mountaineers."

Feb. 3, 1961: The West Virginia legislature passed a resolution adopting "The West Virginia Hills" as an official state song. "The West Virginia Hills" is the best-known of four official state songs.

Feb. 4, 1845: Doddridge County was formed from parts of Harrison, Lewis, Ritchie, and Tyler counties. It was named for Philip Doddridge, a Western Virginia congressman, state legislator, and member of the Virginia Constitutional Convention of 1829-30.

Feb. 4, 1945: The hotel at Minnehaha Springs was destroyed by fire. Built in 1914, it was the first facility in Pocahontas County built strictly for the tourist business and was a forerunner of today's local tourism economy.

Feb. 5, 1889: Fiddler and self-taught physician James Franklin "Doc" White was born near Ivydale, Clay County. White served the community as doctor, dentist and midwife, delivering more than 1,800 babies.

Feb. 5, 1890: Coach Eli Camden "Cam" Henderson was born in Joetown, Marion County. He is a revered figure in Marshall University sports history.

Feb. 5, 1941: Actor David Lynn Selby was born in Morgantown. His stage and screen credits include the outdoor drama *Honey in the Rock*, and the television shows *Falcon Crest* and *Dark Shadows*.

Feb. 6, 1882: Poet Anne Spencer was born Annie Bethel Bannister in Henry County, Virginia. In 1886, she and her mother moved to Bramwell, where she spent most of her childhood and adolescent years.

Feb. 6, 2007: Selva Lewis "Lew" Burdette, a native of Nitro, died in Florida. Burdette was an outstanding major league baseball player who spent most of his career with the Milwaukee Braves. In 18 major league seasons, he won 203 games and lost 144.

Feb. 7, 1867: West Virginia University was established by an act of the West Virginia legislature. The college, originally called the Agricultural College of West Virginia, opened its doors in September 1867.

Feb. 7, 1889: Nell Elizabeth "Pistol Nell" Walker was born at Sewell Mountain. Known as the "First Lady" of Fayette County, she served 12 terms as a member of the House of Delegates.

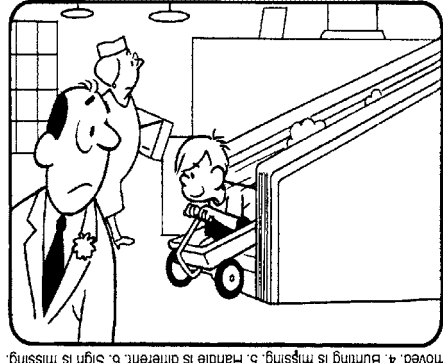
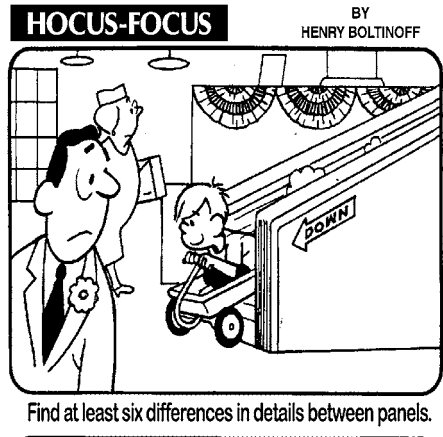

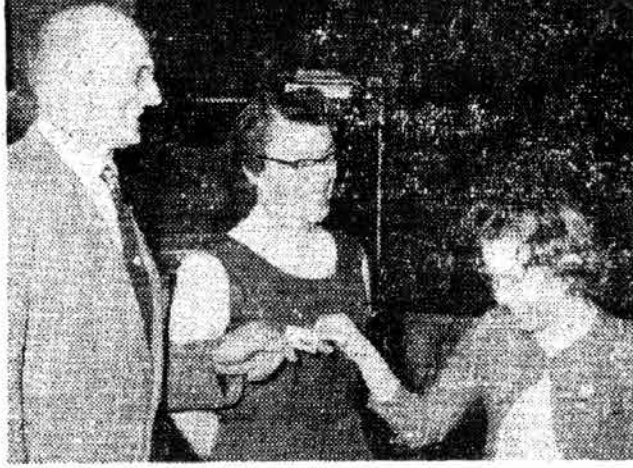

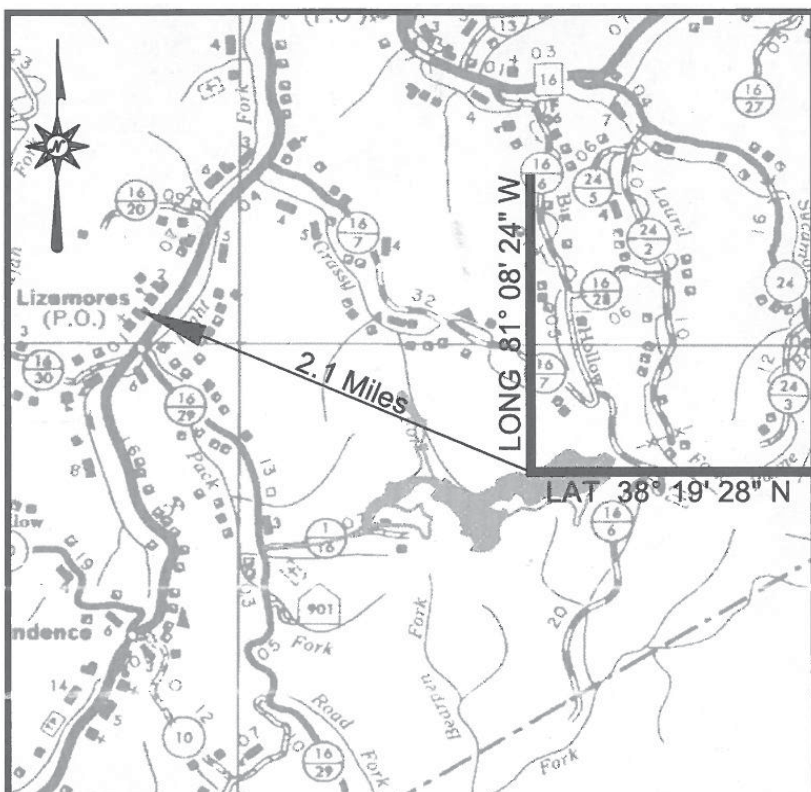
