## The fate of two elementary schools up in the air

"How do they expect our kids to ride on a bus for over an hour, when there is a perfect school two miles from our house?"

Area resident Mikayla Ramsey expressed her concern on the possible closing of one of two elementary schools in the county. The two smallest schools in Clay County, H.E. White Elementary School in Bomont and Lizemore Elementary School in Lizemores, are both being considered for closure following a special circumstance review initiated by the WV Board of Education earlier this year.

H.E. White Elementary is a school that has taken pride in being the center of the community in Bomont. From annual ramp dinners, fall carnivals, dances, and more, it acts as not just a school, but a community center.

Enrollment numbers have decreased for the little school over the past few years, leaving the fate of this school in the School Board's hands. Numbers have decreased, but why? Could it be because one bus runs the entire school's route? The transportation is just one of the issues that have aided in the registration drop. With neighboring Kanawha County opening a brand new school in the coming year, many have made the switch out of county all together.

Does that mean that these smaller schools are any less important that the larger elementary schools in the county?

There are many questions being voiced by area parents, with few answers currently available, making it a frustrating situation for many. Overcrowding is one of the biggest areas of concern, with parents voicing opposition to their children joining the students at Clay Elementary School should H.E. White shut its doors. That, coupled with a long bus ride to get to Clay Elementary, doesn't instill confidence that this is the best decision for the students the closures will be affecting.

Interim Superintendent Joan Haynie said that no decisions have been made at this time, but "they are trying to cover all of our bases."

### Secretary of State Mac Warner Reports 1,535 New WV Business Registrations for January of 2023

The WV Secretary of State's Office registered 1,535 new businesses statewide during the month of January according to Secretary of State Mac Warner.

Wetzel County led the state in the percentage of new business growth through January with a total of 19 new business registrations, a 3.58% increase. The Secretary of State's Business & Licensing Division reported that Clay, Morgan, Taylor, and Tyler Counties also experienced notable growth during the month.

A total of eight new business entities were registered in Clay County in January of 2023. Morgan County successfully registered 34 businesses. Taylor County reported 19 registrations for the month and Tyler County registered eight new businesses with the Secretary of State's Office.

Counties that lead the state in total businesses registered for January were Kanawha, Berkeley, Monongalia, Jefferson and Cabell. Kanawha County successfully registered 155 businesses while Berkeley County reported 136 new registrations. Monongalia County had 133 businesses register. Jefferson County had 84 new businesses register while Cabell County totaled 74 new registrations for the month.

Statewide, West Virginia registered 13,096 new businesses in the previous 12-month period, from February 1, 2022, to January 31, 2023. Summers County led all 55 counties with a 21.18% growth rate during the one-year timespan. To review county-by-county growth, visit our Busi-

## **WV Division of Forestry** urges caution during dry winter conditions

Spring Fire Season begins March 1

The West Virginia Department of Forestry (WV DOF) urges West Virginians to be cautious of burning amid dry, windy conditions this winter.

"Our winter hasn't seen as much precipitation as we would like, and the warmer temperatures and higher winds tend to dry out the fine fuels like leaves and grass,"

said Assistant State Forester-Fire Jeremy Jones, WV DOF. "We have seen an uptick of fires in the past few days, with 30 fires burning 150 acres, so we urge caution at this time. Hopefully, this next system coming through will bring some needed precipitation with it. Until then, we ask that you please listen to the weather report, and if high winds are called for, please refrain from burning."

### **Safe Burning Tips:**

A summary of forest fire laws and safe fire practices can be found on the state Division of Forestry website here.

Before leaving any fire for any length of time, the fire must be completely extinguished.

Clear at least a 10-foot area (safety strip) around the fire and make sure all burnable material has been removed.

Any equipment that can throw sparks and operating on land subject to fire by any cause must be provided with an

adequate spark arrestor.

If your fire escapes, you are liable for the costs of fighting the fire and any damage the fire may cause.

Spring Fire season begins March 1.

The Division of Forestry protects nearly 12 million acres of forestland across West Virginia. More information on fire safety and programs such as forest legacy, logging and landowner assistance, visit the website wvforestry.com.



### A Key Chain



### **Elementary My Dear**



After a tough case, Sherlock Holmes and Dr. Watson decide to take some time off, get away from the city, and go camping in the remote wilderness. They set up their tent and camp. After a relaxing evening sitting by the fire, they hit the hay. In the middle of the night, Holmes wakes Watson up and asks, "Watson, look up at the stars and tell me what you deduce." Dr. Watson thinks for a moment and says, "I see millions of stars. And it's likely that many of those stars have planets. And it's likely that one of those planets are like Earth. I deduce then, there may be life out there, somewhere" Holmes said, "No Watson, you idiot. Someone has stolen our tent!"

Sometimes, we just miss the point. We are looking for deeper meaning and significance and looking past the obvious to get there. We contemplate the mysterious and bypass the plain, in-your-face truth that benefits us more.

First John is a book where so many people miss the point. I heard a famous, nationally known preacher give an introduction to First John. Rightly, he noted 1 John 1:4 as a purpose statement, "And these things write we unto you, that your joy may be full." He also pointed out 5: 13, where John says, "These things have I written unto you that believe on the name of the Son of God; that ye may know that ye have eternal life, and that ye may believe on the name of the Son of God." Very good. But oddly, he spent the next hour telling everyone in earshot that they probably weren't saved and that he was deceived for a long time. Why? Because John tells us how to know if we really know Jesus. It's evident from the text that false teachers were spreading their terrible doctrine, and Christians were in danger of imbibing the rot. But we can get so focused on the "tests" that we forget John's stated point. There are many commands in the book, and many are troubled when they read it (maybe because they need to be). But John's point is to settle the saints in Christ. Don't let someone rob your tent.

### This Week in **West Virginia History**



The following events happened on these dates in West Virginia history. To read more, go toe-WV: The West Virginia Encyclopedia at www.wvencyclopedia.org.

Feb. 15, 1898: Musician John Homer "Uncle Homer" Walker was born in Mercer County. Among the last in a tradition of Black Appalachian banjo players, he played the five-string banjo in the clawhammer style.

Feb. 15, 1930: Sara Jane Moore was born in Charleston. On Sept. 22, 1975. Moore attempted to assassinate President Gerald Ford in San Francisco.

Feb. 15, 1975: Elizabeth Kee, the state's first female member of Congress, died in Bluefield. Keewas elected to Congress in 1951 after the death of her husband, John. She retired in 1964 and was replaced by her son, James.

Feb. 16, 1821: Morris Harvey was born near Prosperity in Raleigh County. Harvey's gifts to the Barboursville Seminary led to its name being changed to Morris Harvey College in 1901. The institution is now known as the University of Charleston.

Feb. 16, 1917: The legislature established the West Virginia State Colored **Tuberculosis** Sanitarium for the care of Black TB patients. It was built at Denmar in Pocahontas County.

Feb. 16, 1951: Second

Lieutenant Darwin Keith Kyle died during an intense exchange against Chinese forces in Korea. He was awarded the Medal of Honor.

Feb. 17, 1735: Morgan Morganof present-day Berkeley County was commissioned a captain of militia in the 201st Field Artillery, which is considered the oldest military unit in the United States.

Feb. 18, 1843: Ritchie County was created from portions of Wood, Lewis, and Harrison counties. The county was named Virginia journalist politician Thomas Ritchie.


Feb. 18, 1890: Ellison Mounts, a cousin to the Hatfield family, was hanged for murder, ending the Hatfield-McCoy

Feb. 18, 1969: Hundreds of miners in Raleigh County went on strike over the issue of black lung. Within days, the walkout spread throughout southern West Virginia.


