Charles Bird First to Receive 80 Year Pin

On March 30, 2023, Charles E. Bird of Lizemores was honored by the United Mine Workers of America with an 80 Year Pin. UMWA President Cecil Roberts had the honor of pinning Mr. Bird, who was the first person to ever be recognized for this length of membership.

Mr. Bird worked in the coal industry from 1943-1983 and still pays his dues to the organization each month to this day. He started shoveling coal while on his knees because that was all the room there was, he had to crawl to get anywhere, and he had to hold his

dinner bucket in his teeth. From there he worked his way to running the coal feed and cleaner in the coal tipple. He has had held many different titles in this industry. He was blessed to have only broken his nose and one finger during his time in the mines.

Mr. Bird left the mines from 1943-1946 to protect his country in WWII, where the UMWA covered his dues while he was defending America in the European Theater. Mr. Bird landed in Normandy on D+46 where he was a jeep driver and drove in England, France, Netherlands, Belgium, Luxemburg, Czechoslovakia, and Germany. When peace was declared he



helped occupy Hitler's Hideout in Berchtesgaden for three months.

Mr. Bird is celebrating 98 years and loves to talk daily on his ham radio. Congratulations Mr. Bird, and thank you for your service.

Mitchell of Pine Grove, Marine Lance Cpl. John Mitchell of Bomont, Air Force Airman 1st Class Edward E. Michell of Bomont (1934-2009), World War II Veteran Charlie J. Mitchell (1910-1971) of Dry Ridge was an Army Master Sergeant, Army Spec. E-4 Calvert Mitchell Clendenin served from 1957-1960 along with Samuel Mitchell of Bomont. Andy Mitchell aided in the mission to bring home POW, Jessica Lynch, in 2003 where he was recognized by President, George W. Bush.







When we pray, we should remember that God is Almighty and Sovereign. As AW Pink put it, God does as He pleases, when He pleases, and whenever He pleases. God's will is done in Heaven. God's will is done on the Earth. What do you think about that? That bothers some people, I know. It concerns some Christians because they bristle against anything that seems to take away their liberty or freedom. Others don't like it because they believe that God only does things we like or find acceptable. For example, it is God's will when we get a promotion, but not God's will if we get fired. God provides the beautiful sunset, but not the thunderstorm, unless there is no damage. But that's not how God has revealed Himself to us in Scripture. God rules all. All things have a purpose, whether we can see or understand it or not.

What's the alternative? No God, and nothing is in control? That's foolish talk (Psalm 14:1; 53:1). God is powerless to stop evil? That's not the God of Scripture (Daniel 4:35). God does as He pleases. God has ordained the end from the beginning (Isaiah 46:10). To deny God's sovereignty is to deny the God of Scripture. Of course, some things come to mind that we may have questions about when meditating on the perfections of God. Scriptures answer some questions, and others are not. We go as far as Scripture takes us, and when we get to the end, we stop, worship, and adore the infinite majesty of the Lord of hosts.

Jesus taught us to pray that God's will is done because it's an adoration of God and also a comfort to God's people. God is in control. I love how the Heidelberg Catechism puts it in the sections from the Lord's Day 9 and 10. "I trust God so much that I do not doubt he will provide whatever I need for body and soul, and will turn to my good whatever adversity he sends upon me in this vale of tears. He is able to do this because He is almighty God; He desires to do this because He is a faithful father...We can be patient in adversity, thankful in prosperity, and for the future we can have good confidence in our faithful God and Father that no creature will separate us from His love. For all creatures are so completely in His hand that without His will they can neither move nor be moved."

No matter what I face today, I can trust in the God who does all things according to His pleasure and loves me with everlasting love. An almighty, faithful, loving Father whose will is always done.

This Week in

West Virginia History

May 3, 1843: U.S. Postmaster General William Lyne Wilson was born in Smithfield, Jefferson County. Wilson joined President Cleveland's cabinet as postmaster general in 1895. The following year, he introduced Rural Free Delivery in Jefferson County, an experiment which was quickly instituted nation-


May 3, 1917: Fire destroyed the West Virginia Preparatory School in Keyser. The school was rebuilt, and it evolved into the institution now known as WVU Potomac State College.



May 3, 1948: The plane of test pilot Howard "Tick" Lilly, a Raleigh County native, crashed on takeoff in California. Lilly was the first of many government test pilots to die in the line of duty. Six weeks earlier, he had become only the fourth person to break the sound barrier.

May 4, 1896: The Children's Home Society of West Virginia was formed by a group of Charleston ministers. Their goal was to place orphaned and neglected children with caring families rather than crowd them into county poorhouses.

May 5, 1923: A fire started by welders working on a new swimming pool destroyed most of Luna Park, an amusement park in Charleston. Although Luna's owners announced they would rebuild, the park never reopened.



May 5, 1923: Golfer Bill Campbell was born in Huntington. He won more than 30 championships over a seven-decade career and is considered one of the best amateur players in history.

May 6, 1812: Activist and physician Martin Robison Delany was born in Charles Town. In February 1865, he was commissioned as a major in the U.S. Colored Troops. He was the only Black Civil War officer to be given a field command.

May 6, 1968: A continuous miner machine at the Gauley Coal & Coke Saxsewell No. 8 mine at Hominy Falls, Nicholas County, cut into an adjacent mine, which was filled with water. The resulting flood drowned four miners and trapped 21 others.

May 6, 1968: Newspaper publisher and Bluefield native John S. Knight received the Pulitzer Prize for his long record of service and his series of columns opposing the Vietnam War.

May 7, 1824: Logan County was created by the Virginia General Assembly from parts of Giles, Tazewell, Cabell and Kanawha counties. The county seat was first known as Lawnsville, then Aracoma, and finally Logan.

May 7, 1857: William A. MacCorkle was born in Rockbridge County, Virginia, on his father's plantation. He served as West Virginia's ninth governor.

May 7, 1928: The Keith-Albee Theater opened in Huntington. The opening program featured a comedy called "Good Morning, Judge," a newsreel, and five stage acts. But the theater itself, with its elaborate interior, clearly was the star of the evening.

May 7, 1983: The New River Gorge National Park and Preserve began operations when the first visitor center opened near Fayetteville.

May 8, 1864: Clarence Wayland Watson was born in Fairmont. Watson was a prominent coal baron and served in the U.S. Senate from 1911 to 1913.



May 8, 1998: Former U.S. Senator Jennings Randolph died at the age of 96. He was first elected to the House of Representatives in 1932 and served a total of 40 years in Congress.

May 9, 1800: Abolitionist John Brown was born in Torrington, Connecticut. His 1859 raid on Harpers Ferry galvanized the nation, further alienating North and South in the lead-up to the Civil War. May 9, 1843: Confederate spy "Belle" Boyd was born in Martinsburg. On July 4, 1861, Boyd shot a Yankee soldier and started her spy career.

May 9, 1863: Confederate raiders arrived at Burning Springs, Wirt County. There they set fire to 150,000 barrels of oil, oil tanks, engines for pumping, engine houses, wagons, and oil-laden boats.







USDA Offers New Funding to Promote the Expansion of High-Speed Internet in Rural West Virginia

\$20 million in Technical Assistance Funding is Available to Plan High-Speed Internet Projects in Rural Communities



U.S. Department of Agriculture (USDA) Rural Development West Virginia State Director Ryan Thorn has announced the availability of \$20 million to deliver broadband technical assistance resources for rural communities, and to support the development and expansion of broadband cooperatives.

USDA is offering the funding under the new Broadband Technical Assistance Program. The program supports technical assistance projects such as conducting feasibility studies, completing network designs and developing broadband financial assistance applications. Funding is also available to help organizations access federal resources, and to conduct data collection and reporting.

DHHR's Bureau of Child Support Enforcement Receives Nat'l Recognition

Rankings are based on five incentive measures used by the federal Office of Child Support Enforcement to determine each state's yearly incentive payment. During the previous reporting year, West Virginia was ranked 26th out of the 54 U.S. states and territories.

"I am extremely pleased by the progress that has been made in the past year," said Garrett Jacobs, Commissioner of DHHR's Bureau for Child Support Enforcement. "The Bureau has been focusing

on improving collection rate for current support and payments on past due support. For many families, this support is a significant part of their budget to provide shelter, food, and amenities for their children."

BCSE serves 80,000 children and families statewide by establishing paternity, child support, and

enforcing support, and collected \$171.6 million for West Virginia's child support program in the 2022 federal fiscal year.


