Two hundred fifty years - an American dream turned reality



On farms and streets, our independence was born.

And so it began two hundred fifty years ago in January, the descent into what some call the great revolution and others a war cry for self-preservation. This year is the 250th Anniversary of these United States, and this January marks the anniversary of the beginning of the race to sign a Declaration of Independence,

a free break from England's kingly hold on our right to self-govern. A flag was formed, a tapestry of stripes and stars full of ideals and the crisp feeling of freedom. It was more than just a bunch of stitches, but a vow hurled into the faces of the old empire controlled by the dictates of a few. It was the people's cry that their destiny could be in their own hands, that cour-

West Virginia Secures \$199 Million in 2026 from Rural Healthcare Transformation Fund

Governor Patrick Morrisey has announced that West Virginia has secured \$199 million for 2026 from the Trump Administration through the Rural Health Transformation Fund, marking the beginning of a historic effort to rebuild and modernize healthcare across the state. The award, almost double the guaranteed minimum for the first year, reflects the strength, depth, and statewide focus of West Virginia's plan to modernize rural healthcare delivery and improve outcomes for families and communities across the Mountain State.

"The \$199 million investment for 2026 provides a transformative foundation to improve health outcomes, expand access to care, and strengthen families and communities throughout West Virginia," Governor Morrisey said. "This award positions our state to deliver better care closer to home and build a healthier future for generations to come. It is also the highest per capita award of any state that West Virginia touches."

The funding for this program was made possible by President Trump's "One Big Beautiful Bill," which provides sustained resources over five years, positioning West Virginia as a national leader in rural healthcare. West Virginia's plan will focus on strengthening healthcare infrastructure, expanding access to primary and specialty care, addressing workforce shortages, improving coordination among providers, and developing innovative delivery models designed specifically for rural communities.

"I want to thank President Trump, Secretary Kennedy, and Dr. Oz for recognizing the unique challenges facing rural communities and for supporting state-driven solutions that deliver real results," Governor Morrisey said. "Their leadership helped make this transformational investment possible for West Virginia families. Hopefully, we will be able to

retain those numbers for all five years of the program."

As part of the development process, Governor Morrisey traveled across West Virginia to hold regional roundtables, gather public input, and host a statewide tele-townhall with more than 17,000 participants. The application, approved on Monday, incorporates those local perspectives and has received endorsements from more than 40 healthcare organizations across the state.

The approved application provides solutions to address:

- The distance between patients and providers.
- The lack of access of rural healthcare providers.
- Resources to support rural healthcare providers.
- Connecting West Virginians to the workforce as they become healthier.
- Preventing adverse health outcomes through nutrition, exercise, and lifestyle changes.

"This investment is a long-term commitment to building modern healthcare systems that work for rural communities and support economic growth across West Virginia," added Dr. Arvin Singh, West Virginia Secretary of Health.

The \$199 million investment for 2026 - more than the amount neighboring states Maryland, Virginia, and Pennsylvania will receive next year - will be deployed strategically to enhance access to care, support the recruitment and retention of the healthcare workforce, expand telehealth services, and strengthen rural health systems statewide. The \$199 million for the first year of the five year award period is also the highest per capita award of any state that West Virginia touches. The initiative is designed to deliver measurable improvements in health outcomes while supporting community stability and economic vitality.

CCHS AP Government & Politics Class Wins "We the People" State Championship

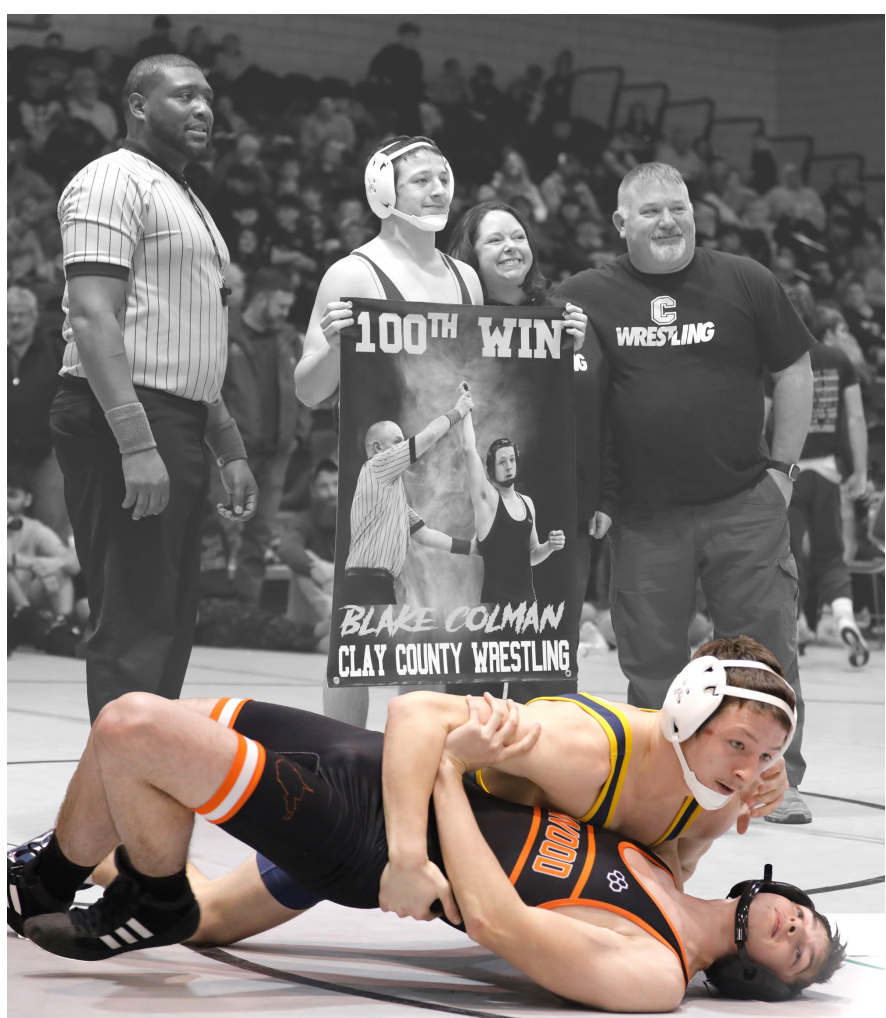
Congratulations to the West Virginia "We the People" State Champions. Clay County High School's Advance Placement Government & Politics class, taught by Mr. Ronald Starcher, competed at the Robert C. Byrd Federal District Courthouse on Dec. 17, 2025, in the "We the People: The Citizen and the Constitution" State Competition. This is a competition where students demonstrate their knowledge of the Constitution and current issues in mock congressional style hearings. Each school participating must divide its classes into six teams. These six teams prepare a four-minute verbal response to a constitutional question and then are asked follow-up questions by a panel of three judges for six minutes. Teams are scored on their knowledge of the Constitution and their ability to apply the concepts to their everyday lives as Americans.

This year's Advanced Placement Government and Politics class is made up of juniors and seniors with strong interests in the United States Constitution and the inner workings of national, state, and local governments. These students are eager to discuss controversial issues and are

well adept at taking and defending their positions among peers as well as judges at district and state competitions. The students illustrate that hard work and dedication pay off.

Classes can have individual unit winners and overall class winners. CCHS won three out of six individual unit championships and won the overall class state championship, defeating the champions from congressional district one, Robert C. Byrd High School, and wildcard, Woodrow Wilson High School. By winning the state championship, Clay County High School has earned a spot in the National Finals in Washington D.C. in April 2026. Dual-unit winners included Ariel Dobbins, Alivia Gilliland, and Lillian Starcher. Single unit winners were Sophia Berberich, Christian Bryant, and Juliann Gallaher. Gallaher was also recognized by the judges as an outstanding performer. Members of the class are Sophia Berberich, Christian Bryant, Ariel Dobbins, Juliann Gallaher, Alivia Gilliland, Dakota James, Jakoby Nichols, Justin Nida, TJ Pritt, Lydia Shamblin, Lillian Starcher, and Owen Tinney, and Cadence Williams served as timekeeper for this year's team.

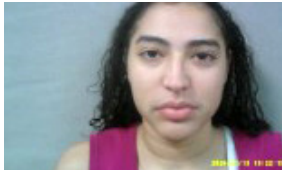

The West Virginia First Foundation (WVFF) convened its Annual Meeting today at Oglebay Resort, located in Region 1, where the Board of Directors elected officers, approved the 2026 meeting calendar, and advanced the Momentum Initiative Grant (MIG) with a total funding allocation of nearly \$18 million.

Final MIG award determinations will be released publicly once all required documentation is completed, and all applicants will receive their status on or before the end of the year.

“Today’s meeting reflects the continued momentum of the Foundation and the impact we are striving to create across West Virginia,” said Chairman Greg Duckworth. “It is an honor to be elected to serve as Chair for the year ahead. As we set our course for 2026 and advance major grant funding, we remain steadfast in our commitment to responsible stewardship and strengthening the communities we serve.”

In the meeting, WVFF Board Member and Treasurer Jeff Sandy stated, “The wisdom and foresight of the then-Attorney General, now Governor Patrick Morrisey, to help establish the West Virginia First Foundation is what led to this momentous decision today to provide \$18 million across all of West Virginia, and for that we are truly grateful.”

“We are deeply appreciative of our Board of Directors, our Expert Panels, and our staff for their dedi-

cation throughout the Momentum Initiative Grant process,” added Jonathan Board, WVFF Executive Director. “This represents one of our most significant investments to date, and we look forward to sharing final award details soon.”

Following the meeting, the Board continued its Hold the Line Tour with a visit to the Wheeling Police Department, an Initial Opportunity Grant (IOG) recipient, to learn more about the department’s Crisis Intervention Team (CIT) program and its impact on community safety.

WVFF’s Annual Meeting concludes a year of statewide engagement, grantmaking, and collaborative partnerships aimed at preventing substance use disorder, supporting recovery, and building a healthier future for the Mountain State. Updates will continue as MIG documentation is finalized.

Judge Greear Named Chief Judge of Intermediate Court of Appeals for 2026

The Intermediate Court of Appeals of West Virginia today announced Judge Daniel W. Greear has been selected to serve as the Court’s chief judge during 2026.

This will be Judge Greear’s second tenure as the Intermediate Court’s chief judge; he served as the Court’s inaugural chief judge from July 2022 through December 2023. Judge Greear succeeds current Chief Judge Charles O. Lorensen, who has been serving in the role throughout 2025. Judge S. Ryan White also serves on the three-member Court.

“The ICA has been well served by Chief Judge Lorensen,” Judge Greear said. “I look forward to working with Judges Lorensen and White to ensure that the ICA continues to function to meet the needs of West Virginia and to continue to improve our judicial system.”

The Intermediate Court of Appeals is an appellate court created by the West Virginia Appellate Reorgani-

zation Act of 2021 (Senate Bill 275). It officially opened July 1, 2022.

The Court’s jurisdiction includes appeals of final orders or judgments in civil, family court, workers’ compensation, administrative and guardianship/conservatorship cases.

The chief judge is chosen by members of the Court and serves a one-year term. In addition to Judge Greear’s designation for 2026, the Court has also designated Judge White to serve as chief judge in 2027. Judge White will also serve as the Court’s acting chief judge in 2026 in any instance when Chief Judge Greear is unavailable.

THIS WEEK IN West Virginia History

Jan. 7, 1910: A fire destroyed everything on Main Street in Bramwell from the train depot to Block Street with the exception of two buildings. The town quickly rebuilt, creating many of the beautiful Victorian houses that stand today.



Jan. 7, 1955: The Cedar Lakes Conference Center officially opened, though it was not named until 1957. The name was chosen for its two lakes and an abundance of native cedar trees.

Jan. 8, 1866: William Gustavus Conley was born near Kingwood (Preston County). Conley was West Virginia's 18th

governor, serving from 1929 to 1933.



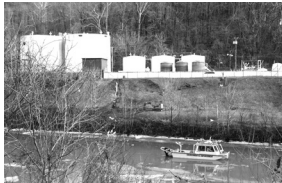
Jan. 8, 1919: The West Virginia legislature ratified the U.S. constitution's 18th Amendment in the Senate, 26-0, and in the House, 81-3. West Vir-

ginia was the 21st state to ratify the amendment. National prohibition went into effect under the Volstead Act on January 16, 1920.

Jan. 8, 1926: Comedian Soupy Sales was born Milton Supman. Raised in Huntington and graduating from Marshall College (now University), he achieved fame as a wacky television personality.



Jan. 9, 1911: Louise McNeill was born on the family farm in Pocahontas County. She was appointed poet laureate by Governor Jay Rockefeller in 1979, holding that title until her death in 1993.



Jan. 9, 2014: Hazardous chemicals were discovered leaking into the Elk River, contaminating the water supply for a nine-county region.

Jan. 10, 1925: Judge Elizabeth Virginia Hallanan was born in Charleston. She was West Virginia's first female federal court judge.

Jan. 10, 1928: Gov. Howard Gore appointed Minnie Buckingham

Harper of McDowell County to fill the unexpired term of her husband, E. Howard Harper. She was the first Black woman to serve in a state legislative body in the United States.

Jan. 10, 1940: The Pond Creek No. 1 mine at Bartley in McDowell County exploded. The blast killed 91 miners, with another 47 escaping. Rescue teams worked five days to retrieve the bodies but found no additional miners alive.

Jan. 11, 1865: Confederate forces under General Thomas Rosser burned the covered bridge at Beverly. Bridge builder Lemuel Chenoweth rebuilt the damaged span in 1872-73.

Jan. 11, 1893: U.S. Senator Harley Martin Kilgore was born in rural Harrison County. Kilgore served as a senator from

West Virginia from 1940 until his death in 1952.



Jan. 12, 1869: Newspaperman Herschel Coombs Ogden was born near Fairmont. In 1888, he relocated to Wheeling and entered the newspaper business.

Jan. 13, 1905: Joseph H. Diss Debar died in Philadelphia. A supporter of the movement to create West Virginia, Diss Debar was commissioned in 1863 to design the Great Seal of West Virginia.

courage would overshadow the cause and unrest that would sure follow. It would prove to be a shroud for fallen heroes and a cloak for the shattered. So, while the years pass into history and our flag becomes tattered and faded and the stars seem to shine less, the entwined threads will always endure.

Now, 250 years later, our flag, our Declaration of Independence and our constitution have flaked off some of the luster that once was as the friction of history has taken its toll. Our flag is a testament, a living archival proof that a nation's true glory is not found in the gales and hardship but in the courage to still fly while bearing them up. Our founding fathers threw themselves against the ancient thrones to form a new standard to which all men should live free so we could walk

on this Earth in our own country unyielding and relentless in our pursuit of justice and a way of life.

In January of 1776, Thomas Paine published Common Sense, a pamphlet which simply said, and not with flowery language, "A long habit of not thinking a thing wrong gives it a superficial appearance of being right," telling people that the ways of the past are not necessarily a good idea for future growth. Two hundred fifty years later, here we set in winter as we also live in constant political upheaval and a fog overshadows the USA, keeping us from seeing the path forward.

Common Sense was the first shot fired for the beginning of our independence, and by its own words is what fuels our path ahead in 2026 for the next 250 years. Common Sense of yesterday is no longer

enough to fill the dreams of now...common sense.

We have seen thousands of sunrises with a heartbeat that has never straight lined. We have swelled in times of success and shrank in times of anxiety - the Great Depression,

wars on our own soil, sacrifices made in the name of our future - yet here we are. Why? Perhaps it's because we are not held together by a king or by limited boundaries of thought and reality, but by a single piece of paper that holds us all together, daring us to be a better person than we were yesterday.

So, as the months of 2026 lead us up to July 4th, we have to ask ourselves if we are just pawns of history or are we creators of the history ahead of us. The ink on the documents of 1776 is dry, but the ink of 2026 is still waiting to be feathered. America is still like a lightning bolt caught and held in a safe place and we are the keepers of it. America continues 250 years later and the most important history is the history we are about to write, after all its Common Sense.
