Town Council approves contract that will bring franchise hotel to Vinton

"Another drawing card bringing people to the Town of Vinton," was Councilman Mike Stovall's response to the news at the July 20 council meeting that the town has found a purchaser for six parcels of land in downtown Vinton for the purpose of building a ho-

Vinton is home to many wedding and special events venues, Rosie's Gaming Emporium, the Lancerlot Sports Complex, and Vinyard Park and its soccer fields; it is within shouting distance of Explore Park and the Blue Ridge Parkway, and in close proximity to Smith Mountain—with nowhere to house visitors.

The hotel property is located within the intersection of South Pollard Street, Cedar Avenue, and 1st Street at the Virginia Avenue Gateway into the town. The parcels were purchased by the town

Saint-Lô. The Sister Cities program was established in 1964 in an alliance between Roanoke and Wonju, South Korea. Dr. Young Kim, who trained at Roanoke's Jefferson Hospital from 1956-58. felt so welcomed and loved by the community that he vowed never to forget Roanoke. After he returned to South Korea, his city asked for suggestions for an American city to partner with in its new Sister Cities initiative and

he proposed Roanoke. The program's mission statement affirms, "Sister Cities is committed to promoting mutual understanding, friendship, and peace through cultural, medical, economic, educational and professional exchanges among the people of the Roanoke Valley and the citizens of seven sister cities on four continents." Saint-Lô in France became one of those sister cities in 1998.

Saint-Lô is a medieval city in Normandy dating

back to the ninth century with a population of about 25,000. The town was the scene of a violent, decisive World War II battle between American Armed Forces and entrenched German forces after the Allies landed on D-Day on June 6, 1944. In the years since 1998, students and teachers from Saint-Lô have come to Roanoke to visit during the school year, while groups from Roanoke have visited Saint-Lô during the sum-

mer—until the pandemic. The McCaskills volunteered to host Constance and Clothilde for a week in 2019 when they learned of the need for families through Emilie's French teacher. (Emilie's brother had been an exchange student through Sister Cities

in 2015.) The two girls had many scheduled activities with the Sister Cities organization while they were here in 2019, but spent the mornings and evenings with the McCaskills, plus two days to do whatever they wanted.

Emilie and her family took them to visit the Mill Mountain Star, a pumpkin patch, and a UVA football game, in addition to everyday destinations, like the grocery store. The exchange students spent another week traveling in the United States visiting landmarks, including Washington, D.C.

Vinton Library hosts Roanoke Valley Astronomical Society

The Roanoke County Library theme this summer is "Find Wonder at the Library." Ray Bradley from the Roanoke Valley Astronomical Society brought the wonder of the night skies to the Vinton Library on Saturday night, July 17.

His presentation included the basics of astronomy and the equipment helpful in stargazing. Bradley said that beginning astronomers "just need your eyes to start with." With your naked eye, you can see the moon, stars, constellations, meteors, and comets. He suggested first studying the constellations as a way to develop a mental roadmap of the

Once the sky has become familiar to the unaided eye, it's time to progress to binoculars, which are less expensive than telescopes and offer a large field of view. Many night sky targets can actually be seen better with binoculars rather than a telescope.

Binoculars are especially useful in viewing the moon. Bradley noted that the earth and moon at one time were just one planet. He explained the maria (seas) on the moon are craters once filled with lava flows. He explained that the moon space missions so far have landed selectively on the maria.

He continued with a brief explanation of telescope basics and their inventors.

Bradley recommended

a free app called Stellarium for the cell phone or computer, which shows exactly what you see when you look up at the stars (and can be upgraded at a cost). You can identify stars, constellations, planets, comets, satellites (such as the International Space Station), and other deep sky objects in real time in the sky above you in just a few seconds, just by pointing the phone at the sky. Stellarium has become recognized as one of the best astronomical applications for adults and children who want to explore the night sky. You can view an accurate night sky simulation of stars and planets for any date, time, and location. His most exciting news

of the evening was the announcement of the November 2021 debut of the Artemis Program by NASA which plans to return astronauts to the surface of the moon by 2024. The Apollo Program



in 2018 and 2019 for the purpose of recruiting a much-needed hotel to be constructed on the site. (One parcel was donated by nearby Wells Fargo Environmental Bank.) assessments and hotel market studies were completed, structures on the properties were demolished, and a conceptual plan was developed for the site.

The town issued a Request for Proposals in May 2021 and received two formal proposals to develop a limited-service hotel. After review by the town's Economic Development Committee, the town selected The McDevitt Company as the developer.

McDevitt has agreed to terms of a Contract of Sale that provides a sixmonth due diligence period (similar to the Gish Mill agreement). It includes negotiating terms of a performance agreement with development incentive grants (with the town, Roanoke County, and the Roanoke County Economic Development building plans, making site improvements, and securing a hotel franchise for the property.

The purchase price of the property is \$10, with an estimated \$12 million investment expected. The hotel is expected to generate \$490,000 in annual revenue for Vinton and Roanoke County.

The hotel development will help diversify Vinton's economy by generating Transient Occupancy Tax; support further development of Explore Park; support Vinton and East County wedding venues, restaurants, and the service industry; support regional sports marketing efforts; and retain visitor spending from regional events, area attractions, the lake, and the parkway. A hotel will keep dollars

in the town. Town Manager Pete Peters says McDevitt "can walk" if franchising doesn't work out, but this contract sale "gives a green light to the project."

A public hearing was held at the July 20 council meeting to solicit public input on the project with no comments received.

The Contract of Sale states that McDevitt intends to develop the property into a mid-scale hotel with between 90 and 120 rooms, consisting of a limited-service hotel brand such as a Hilton, Marriott, or Wyndham property. The contract does not obligate McDevitt to any particular franchise. The hotel is expected to include amenities such as a swimming pool, business center, rooftop deck or lounge, meeting space, a fitness center, and outdoor landscaped green spaces. The hotel is expected to fit with the aesthetics of the town established by the Vinton Library and Vinyard Sta-



It was determined that there was a need for a hotel in Vinton—not because of corporate or commercial travel as in most communities—but because of the social event and recreation venues in the town or close by, varied industry and technology in close proximity, highly developed commercial corridors, and the opportunity for strong family and business referrals.

The hotel study recommended a national brand hotel, situated on 1.5 to 2 acres (the selected site is just shy of two acres), in a high traffic/high visibility area. Eight sites were initially evaluated. The study indicated a "very good to excellent potential" for the success of a hotel venture in Vinton.

Free meals program continues in Roanoke County schools

The free summer meals program continues at Herman L. Horn Elementary School in Vinton, and also at Burlington Elementary and Cave Spring Middle Schools.

Drive-through pickup of meals is available at Herman L. Horn on Wednesdays through July 28 from 10 to 10:30 a.m.

Nutrition associates, substitute teachers, and volunteers wait for families to pull up to the curb and pick up 10 freshly prepared breakfasts and lunches each for children 18 and un-

The meal bags contain fresh fruits and vegetables, milk, vegetable and fruit juices, shelf staples like Goldfish, applesauce, cereal, muffins, and bagels, ham and cheese sandwiches, PB & J sandwiches, and cheese sticks.

There are no forms to fill out and no income restrictions. Addresses are not checked. No questions are asked. The workers serve meals until they run

Roanoke County Public Schools Director of Community Relations Chuck Lionberger says that Roanoke County has distributed approximately 1.25 million meals since March 16, 2020, when schools closed for the pandemic. Herman L. Horn has been providing about 100 meals each Wednesday this


"Even if just one child is fed, that is one child whose needs have been met," said Lionberg-

Because of an extension of the federal COVID program which has provided free breakfast and lunch to all students since the pandemic struck in March 2020, free meals will continue for all students through the 2021-2022 school year, resuming on August 12. Meals for younger siblings not in school may be picked up curbside once again beginning on that date.

Those distributing the meals

say they do tend to see the same faces picking up meals from week to week. The families have expressed their gratitude for the meals program; some have said they did not know how they would have fed their families without the assistance from the school program.

The three Roanoke County Schools were selected as distribution sites using a variety of criteria. Some other area school systems are also operating similar programs.

"Mayor Grose has been a great asset to the organization during his time as leader," the Commission noted.


In 1968, Virginia was divided into planning districts based on the community of interest among its counties, cities, and towns. A Planning District Commission is a political subdivision of the Commonwealth chartered under the Regional Cooperation Act by the local governments of each planning district. As such, they are a creation of local government encouraged by the state. There are 21 Planning Districts in Virginia.

In 1999, the Fifth Planning District changed its name to the Roanoke Valley-Alleghany Regional Commission. The Commission is made up of elected officials and citizens appointed by member local governments (now numbering 11 governments).

Mayor Grose and Town Manager Pete Peters represent Vinton on the RVARC currently.

The purpose of Planning District Commissions, as set out in the Code of Virginia is to encourage and facilitate local government cooperation and state-local cooperation in addressing—on a regional basis—problems of greater than local significance.

This cooperation is intended to facilitate the recognition and analysis of regional opportunities and to take into account regional influences in planning and implementing public policies and services. The planning district commission also promotes the orderly and efficient development of the physical, social, and economic elements of the district by planning, and encouraging and assisting localities to plan for the future. One important duty of planning districts is to create a strategic plan for the region of service.

travel to France in the summer of 2020, but CO-VID delayed those plans until this year.

In the almost two years since the students visited Vinton, Emilie has kept in touch with them through social media and texting, with her mother, Angela, emailing their parents.

With so many health guidelines and restrictions–here and abroad– the Sister Cities program was not involved in facilitating the trip for Emilie this summer; the McCaskills made the arrangements for travel on their own.

While the pandemic did not stop her from traveling to France this summer, there were still ramifications from CO-VID. She had been fully vaccinated in February but was required to take a COVID test before she left and to fill out "lots of paperwork." She was required to show her vaccination documentation

Her mother says that while France has opened its borders to American tourists, the United States has not reciprocated to permit the French to visit here. On her way back home, Emilie had to endure another COVID test and sign an attestation stating that her results were negative.

Emilie had hoped to be in France for four weeks, but ACL surgery due to a basketball injury shortened her stay to two weeks—one with each family. She left for France on June 28 and returned on July 12.

The Gosseleins-Con-

stance, her parents, and her two older brothers–are

a middle-class family who own a vegetable distribution company in Barfleur, which is located along the English Channel. While in Normandy, Emilie and Constance, on their own, visited D-Day sites and the medieval Mont-Saint-

Michel Monastery.

The Mahés family-Clothilde, her parents, an older brother and a brother-also younger live a typically middle-class life. They use cell phones at the table, play games, and spent a good deal of time watching

sports on TV while Emilie was there, including the Tour de France and Euro League Soccer.

The Mahé family asked Emilie to choose their itinerary for the week, which included historic Saint-Lô, a zoo, and her favorite-Paris. Emilie says they saw everything-the Louvre, the Eiffel Tower, Notre Dame, and every other landmark that time allowed. In fact, they "walked it all," with 23,000 steps that day.

Emilie says she felt very at ease with the Mahé family who did their best to make her feel at home. While she was there, Emilie spoke French with the families and their friends.



decal for 121 West Lee was created by graphic designer Paul Griffin, with suggestions on what to include from Chasity Barbour, the Vinton Director of Planning and Community Programs. Once the design was complete, Sun

Solutions printed out the vinyl sheets and transported them just down the street. Employee Nancy Rogers spent parts of three afternoons installing the vinyl-in a process similar to installing adhesive shelf paper (by peeling off the backing), but on a much larger scale, and requiring scaffolding and ladders.

Rogers has been involved in the sign industry since 1998. While the installation looked a little tricky, Rogers says that after over 20 years of working with vinyl, she isn't intimidated by the process anymore. Installation can be difficult since the vinyls are quite large, and she typically works alone. "The tricky part is not letting it slip and knock everything out of alignment." The process involved taping the vinyl, smoothing it continuously with a squeegee, retaping, and trimming with an Exacto

Rogers says the vinyl is "a little more delicate" than shelf paper since it is per-

forated. The "ideal" temperature for installation is between 60 and 65 degrees. Hotter temperatures and higher humidity make the vinyl softer, stretchier, and harder to work with.

The vinyl and images appear to be solid from the outside but are transparent from inside the building. They will typically last about a year depending upon exposure to the sun and weather. The West Lee Avenue location doesn't get a lot of direct sunlight so it should last longer than most, Rogers says.

The project has been funded under a façade grant program in the Town of Vinton Economic Development Marketing Account which is allocated to promote the town in various manners. "I've been very impressed with Jeff

and his team's effort and creativity to make this project a reality," said Peters. 'The business owners have also been very supportive and agreeable to participate. All in all, it's a 'win/win' for everyone involved and I think it really helps sell the town in the sense of better visualizing some of the progress of buildings being updated for future businesses, and this whole idea simply helps reinforce the theme of being 'In Vinton' all throughout our down-

"With Council's vision and support, the downtown has come a long way in the last several years and is popping with new energy and activity in every direction," Peters added. "Although the most exciting aspect is that we aren't even close to reaching our full potential and there are so many more amazing projects yet to come."

Janney said the town notified him of the possibility of being part of the business window decal program and he "couldn't be happier with the result," especially with the town picking up the cost. He had thought that the decals might make the interior of the building too dark, but that's definitely not the case. Janney commended the town leadership and staff for all the improvements in Vinton in the past several years.

Next up on the window decal list is most likely the former Star City Playhouse building at the corner of Washington Avenue and Pollard Street. Their decals will feature dining scenes, in addition to the "InVinton" brand-

Five dangerous backyard activities for kids; precautions parents should take

Research indicates that over 60 percent of all summer-related injuries occur among children ages 2-11.

A new SafeHome.org study, the 2021 Summer Home Safety Report, indicates that the five most dangerous backyard activities for children involve:

Trampolines—the most emergency room visits per year. Children account for about 85,000 of the 100,000 trampoline-related injuries treated in the U.S. each year. To avoid injuries, check that bolts are tight, install a safety net enclosure, put padding over the frame and springs, and set jumping rules with adult supervision.

Monkey bars. To avoid injury, make sure the child has enough upper body strength to swing, place padding under-neath to soften falls, and check for loose bolts and

Open porches and balconies. To avoid injury, install safety netting or plastic guards to cover spaces between rails. Use safety gates at the top and

bottom of stairs. Check porches for loose boards or shaky handrails.

Slides. To avoid injury, do not go down the slide with your child in your lap, teach your child to go down feet first, and remove any dangerous debris from the landing Swing sets. To avoid

injury, tighten equipment before use, ignore pleas from your child to push them too high.

A swimming pool is one of the top 10 riskiest areas in the backyard. Drowning is the No. 1 cause of death for kids 1 to 4 outside of birth defects. To avoid injury, develop house rules, have an adult chaperone, and install fencing to avoid young children falling into the pool by accident.

Built-in pools have been found to be more dangerous than above ground pools, due to the fact that in-ground pools have larger pool decks and accessories on which more injuries could occur. Diving, whether off the deck or a diving board, is a leading cause of swimming pool injury.




Graduated William Byrd High School senior Tyler Dean will be pitching for Virginia Tech in the spring. Dean was on the bubble for the recent Major League Baseball Draft but was not selected by a big league team.

That wasn't totally unexpected. The draft was cut to just 20 rounds in an MLB money saving move and that hurt Tyler's chances of being drafted. In past years the draft was around 60

"The clubs are very adamant about drafting guys that they will sign and not lose players by drafting and not signing them," said Tyler's dad, Steve Dean. "We decided since he was not going to

be a top two or three round pick that our agent would put a high bonus figure out there to all the scouts. We felt like unless he could get X amount, it would be better for him to go to Virginia Tech and have a shot of going in the first couple of rounds three years from now and signing for a whole lot more. It's a bit of a risk, but we felt worth the gamble."

Tyler's every start this spring was chronicled by MLB baseball scouts. In his first home start over 20 scouts

crowded around the backstop at Walthall Park to watch him pitch and chart his speed with radar guns. He didn't disappoint, striking out seven Northside batters in five shutout innings. Tyler finished the season with an 0.70 earned run average with 50 strikeouts in 30 innings pitched. He allowed just 15 hits while pitching against some of Byrd's top opponents, including six innings of one-hit ball against a powerful Abingdon team in the Region 3D final. He left the game after 109 pitches, one away from the VHSL limit, and Byrd lost in the seventh inning, 2-1.

After the season Dean received an invite to the inaugural MLB Combine at the USA Complex in Cary, NC. He pitched against other top prospects from high school throughout the country and pitched two innings, striking out four and getting two lazy fly balls to right field. He gave up no hits and no runs.

This summer Tyler is playing in the Coastal Plains League for the Tri-City Chilipeppers, based in Colonial Heights, Va. He's the only upcoming freshman on the team with all the other players being either upcoming juniors or seniors in college. All his teammates reported at the end of May but with the high school season being delayed, along with playoffs and the Combine, Dean was not able to join the team until June 30th.

When Tyler reports to Virginia Tech he'll be teammates with Byrd batterymate Dylan Hatfield, who is also headed to Blacksburg.

HOME RUN DERBY SET FOR JULY 31

The annual Home Run Derby for William Byrd baseball alumni will be held at Walthall Park on Saturday, July 31. Former players who would like to participate are asked to contact former Byrd coach Gary Walthall so he can finalize plans.

After the derby there will be a game if there are enough players to participate. If there aren't enough pitchers Doug Pence has volunteered to feed the pitching machine.

"If it rains, come to the hitting building and we will do some things inside," said Walthall. "Let me know who plans to just attend, who wants to do just the Derby, or play in a game so we can have some water for everyone."

WEST TAKES THE SILVER

The West team took the silver medal in last weekend's Commonwealth Games baseball tournament at Liberty University in Lynchburg. The West was coached by former Byrd player and coach Rodney Spradlin and former Byrd player and current coach Neil Zimmerman was an assistant.

The West opened on Friday with an 8-6 win over the Central team. The West then beat the East team, 12-1, and the North, 6-2, on Saturday to advance to Sunday's championship game against

the North. In the Gold Medal game the West lost a heartbreaker, 6-5. The North team scored four unearned runs in the second inning. West battled back to tie the game at 5-5 but the North scored the deciding run in the seventh on a pop up that was lost in the sun, a sacrifice bunt and a two out single.

The West outhit all four opponents, including a 9-8 edge over the North in the Gold Medal game. Sully Tibbs of Jefferson Forest led the West team, going seven-for-14 at the plate for the weekend. Lord Botetourt twins Owen and Nate Prince were a combined 10-for-21 at the plate with eight runs batted in.

WWII vet celebrates 100th birthday

World War II veteran Earl Childress celebrated his 100th birthday at the Vinton War Memorial on July 17, along with his wife Shirley, who was celebrating her 89th. The couple has been married for

Earl Childress was born on July 27, 1921, and grew up in Greensboro, N.C. He was drafted into the United States Army in August 1942 and served with the 630th Anti-Aircraft Artillery Automatic Weapons Battalion in North Africa and Italy.

In an oral history recorded in 2016, Childress shared some of his experiences from the war. His basic training was at Camp Hulen in Texas, where he learned to fire a 40mm "ack ack" gun, a 50-caliber machine gun, and his Tommy automatic machine gun. He was assigned to duty as a truck driver.

His division shipped out from Boston in April 1943 and arrived in Oran, North Africa, in May. They immediately set up in the harbor to provide air protection. While in Oran, he was assigned to guard German and Italian prisoners of war. His outfit spent the next several weeks training for the invasion of Italy in September 1943. Childress was trained in the use of machine guns.

They landed on the beaches of Italy in flat bottom boats, but the ramps could not be lowered, so the soldiers were forced to go over the side—a problem for Childress, who said he couldn't swim. When he made it to the beach, his first action was to dig a foxhole with his helmet with a German tank firing in their direction.

Eventually Italy surrendered and his division left for Naples where they set up on a racetrack, assigned to protect American artillery from the German planes. He recalls Mount Vesuvius erupting at the time in 1944 with planes damaged by the eruption. The Germans bombed nightly.

They were located for quite a while at Monte Cassimo, the site of a monastery, where quite a few Purple Hearts were won. Childress finished out the war in Rome. They returned to the states in November

1945. Childress said he was scared from the time he arrived in North Africa until he left for home; he spoke of friends and fellow soldiers who did not return. His mother was waiting for him in the street in front of their home when he arrived. Soon after, he married his first wife Mildred Cockman, who he had known before the war.

Childress lived in Greensboro for many years and then moved to the Roanoke area when he married his second wife Shirley, who is from Vinton. One of the stories shared at the birthday party was how they met. Apparently, both were on dates with other people. Earl saw Shirley across the room, and it was love at first sight. He went over to Shirley and asked her to stay there while he took his date home. They have been together ever since.

He worked for many years as a salesman for Johanson Electric, traveling during the week, but home on weekends.

The Childresses were surrounded by family and friends at the birthday celebration. Their family includes daughters Jeanne Griffith, Debbie Bray, and Karen Gilmore, four grandsons, four great-grandsons, and a large extended family.

Many shared their memories of Earl and Shirley. Almost everyone who spoke talked about the enormous vegetable gardens he planted, the food he shared over the years with friends, neighbors, and family, and the canning they did. He continued to raise gardens up until recently when he and Shirley have moved to assisted living.

He was applauded as a good father, a great provider, and a devout Christian.

The family reminisced about trips to the beach, and trips to Costa Rica, the Bahamas, and Montego Bay; Earl's famous sense of humor ("he's a hoot," one said), and the hospitality always found in the Childress home.

Larry Cockman, a retired firefighter and battalion chief in Greensboro, and brother to Earl's first wife, thanked him for always being a haven for him as a child, for letting him drive Earl's car on his first date, and for being a great influence on his life. He also reminded those attending that Earl is one

of the few World War II veterans still living and that "we wouldn't be here today if not for people like

Earl's daughter, Jeanne, recalled her dad taking her hunting (she with a BB gun) as a child. She thanked Shirley for coming into her dad's life.

Stepdaughter Karen, who organized the celebration, recalled some laughable mishaps involving a lawnmower blade replaced upside down and brake pads put on backwards as they did attempted repairs together.

Neighbor Bill Reynolds talked about their swaps—Earl gave him food from the garden in the summer; he kept Earl's driveway cleared in winter.

Several talked about the countless birdhouses Earl built. Son-inlaw David Griffith said that "people all over North Carolina have Earl's birdhouses."

A former neighbor, whose father was a minister, said that his father walked the straight and narrow until he met Earl. In one memorable incident, the two went turkey hunting and then decided to hunt for mushrooms. The resulting tickets from a park ranger for \$75 apiece for possessing guns overshadowed the one mushroom Earl was able to find in the woods.


