The Class of 2023 has 268 graduates, with 49 Valedictorians earning GPAs of 4.0 or higher. There were 169 Honor Graduates wearing gold tassels symbolizing GPAs of 3.5 or higher. Advanced Studies Diplomas were awarded to 128 students.

Of those 268 graduates, 177 will be attending a two- or four-year college or university or a Trade/Technical college in the fall. The Class of 2023 has accepted over \$3,649, 859 in grants and scholarships.

The Town of Vinton hosted a ribbon-cutting ceremony dedicating a new Valley Metro bus shelter on Hardy Road at Lake Drive Plaza on May 17 and another one on Virginia Avenue near the Precision Fabrics Group (PFG). Vinton Assistant Planning and Zoning Director Nathan McClung opened the dedication ceremony with comments on the intrinsic value of public/private/ non-profit partnerships which make projects such as these possible.

The bus shelters had their beginnings when a Vinton Breakfast Lions Club member noticed people standing in the rain waiting to catch the bus – and took

action. He suggested to his fellow Lions that they fund a project to build shelters to protect transit users in Vinton from inclement weather. The club reached out to the town in developing the project, with Lions Chris McCarty and John Dyer as facilitators.

According to McClung, these two sites were chosen because they have the highest frequency of use in the Town of Vinton. The other two Valley Metro bus shelters are located at the Vinton Municipal Building and near Rosie's Gaming Emporium.

Work on the project began over two years ago and came to involve not just the Lions Club who funded the pad

Ironman Triathlon returns on June 4



Ironman 70.3 Virginia's Blue Ridge Triathlon will be returning to the Roanoke Valley once again on Sunday, June 4. Participants will swim at Carvins Cove, bicycle on the Blue Ridge Parkway, and run along the Roanoke River Greenway.

The event, which first came to Roanoke in 2021, showcases the area's outdoor recreation and brings millions of dollars in regional tourism to the local economy.

The race begins with a 1.2 mile, 1-lap swim in the water at Carvins Cove Reservoir.

The 56-mile bike portion of the race then leaves from Carvins Cove and continues along Route 11 through Roanoke County and Botetourt County, before reaching the historic Town of Buchanan, located along the banks of route shows the bike the James River.

WBMS puts SpongeBob on trial for murder of Mr. Krabs

As a culmination of the school year, Tracy Addison's seventh grade English classes at William Byrd Middle School prepared for and presented the "Trial of SpongeBob SquarePants" on May 17.

According to Addison, "SpongeBob was accused of murdering Mr.

Using skills including evaluating clues, inferencing, questioning techniques, persuasion, and the elements of formulating a thesis and conclusion, the classes chose their attorneys and witnesses, prepared their case, and welcomed guest judges to oversee the trial. Their trial also involved public speaking, improvisation, and even some skills in drama.

Students were all given the same crime scene evidence. They were instructed to research the evidence and use context clues, then decide which side they wanted to representthe prosecution or the defense. That established their legal teams.

They chose attorneys and assembled their cases. They decided what witnesses would be included and they took volunteers to portray the witnesses. They had only two half-days and one full class day to organize and prepare.

On May 17, our guest judges came, and each block independently held a trial," Addison said. "The judges were fabulous, and each

offered great feedback to the students along with their verdict. In the end, out of three class blocks, SpongeBob was found innocent twice and then once was convicted. The students learned a lot about preparedness, public speaking, improvisation, and cooperation along the way."

Addison's first block guest judge was Bedford County Commonwealth Attorney Wes Nance. The second block judge was Assistant Principal Katie Hutchison, and third block judge was Ryan Hutchison, head football coach and Tech Ed teacher.

"To be supported by such outstanding adults was especially meaningful to the classes," Addison said. "The students did an incredible job summarizing the evidence and putting on an impressive trial.

"I've done this end-of-the-year project for three years, but it gets more elaborate each year," Addison noted. "I can't take credit for coming up with the lesson plan itself, just the implementation of it with my

"In the end, I explain to the students how the trial and the preparations all relate back to their skills in inferencing, context clues, citing sources, persuasion, and other language arts elements we have practiced throughout the year. After completing their testing for the year, it's a fun way to use their skills in a

creative manner."
Addison said, "I am so proud of all of my students and their ability to work hard and try something new. My hope is that the skills we have learned this year will translate into life lessons for years to come."

Valley Metro funded the fabrication and installation of the bus shelters; the First Four Petroleum Group donated the bollards, and Town of Vinton staff (especially McClung) assisted in managing the project and worked as a liaison with stakeholders.

Other contributors include Renaissance Contract Lighting & Furnishings, Joseph Wall with Prestige Building & Renovation, and Grand True Value Rental of Vinton.

According to Valley Metro, the new bus shelter at Kroger has shopping cart corrals to enable shoppers to

park carts before boarding the bus. Both shelters are covered, have benches, trash cans, and solar-powered Speakers at the ribbon-cutting included Vinton

Breakfast Lions Club President Hal Mabe, Roanoke City Vice Mayor and Council member Joe Cobb, who also serves as board president of the Greater Roanoke Transit Company (GRTC), and Vinton Mayor Brad Grose. Kevin Price, the general manager at GRTC,





Edmondson recognized with Golden Apple by Thrasher Preschool

In 2017, Erin Edmondson received the coveted Red Apple Award at the elementary school level from the Roanoke County Public Schools Education Foundation. At the time she was teaching third grade at W.E. Cundiff Elementary School. The Red Apple is a prestigious award– only one is given in the entire county at the elementary level.

Edmondson was described as "inviting, inventive, innovative, and creative; she teaches with passion and humility," by the colleague who nominated her.

"Erin is a teacher because of all of the right reasons," said Sherry Bryant, then principal at W.E. Cundiff. "She values all of her students and is willing to go above and beyond to make certain they are successful. She has high expectations for her students, and they learn to believe in their abilities. Erin provides activities that require students to create, problem solve, and work collaboratively with others. The children rise to her expectations because they know she cares for them as individuals.

On May 18, 2023, Edmondson received another special Apple award-this time a Golden Apple from the families of students in the Thrasher United Methodist Church Preschool.

The idea for the Golden Apple first came up when the parents were brainstorming end-of-the-year gifts for Edmondson, in just her first year as preschool director (her dream job).

Ashley Buck says she was approached by a church staff member who filled her in about the previous Red Apple Award and mentioned how there was a Golden Apple Award.

"He explained it was a dream of Mrs. Ed's to win the Golden Apple. Since she left the county schools, she wouldn't be able to win one with them, but she has done incredible things for the program at Thrasher. It was a no brainer that this would be the perfect end to her first

Buck ordered the golden apple and then began working on the logistics of arranging the surprise. She and teacher Rhonda Walls secretly sent home letters to preschool families making them aware of what was going to happen, what the award stood for, and asking parents to send a word that came to mind when they thought of Mrs. Ed."

"The timing ended up working out perfectly with the last day of school celebration," Buck says. "We had a carnival for the preschoolers and families. Following the carnival, they gave class awards to each student. Mrs. Ed had finished up with her class awards and was getting ready to pray for pizza and I quickly jumped in and told her there was one more award that needed to be given.

"As this year is coming to an end, I think we can all agree that this year has been one of the best and it's all thanks to the amazing staff here at Thrasher," Buck said in her speech that followed. "This year was a year of transitions in many ways and one of those being gaining a new director, teacher, and friend in Mrs.

"Mrs. Ed has proven to be a fearless leader, a devoted educator, and compassionate friend to all. Her dedication to her staff, this program, and our kids has not gone unnoticed. She's the one who, when you drive by long after the school day is over, you'll still see her office light on and her car in the parking lot.

"She's the one who has instilled a love of learning in all the kids she's worked with and who has helped set our kids

up for academic success, even if it took a little Swedish Fish bribery for some. She's the one who has gone the extra mile for the families here, in the good times and in some difficult times.
"The families here at Thrasher

describe Mrs. Ed as humble, generous, patient, extremely loving, enthusiastic, professional, friendly, kindhearted, devoted, compassionate, creative, caring, helpful, inspiring, funny, and a positive role model, full of love and acceptance. She radiates warmth and kindness.

We gained Mrs. Ed from the county schools, and in 2017 she won the Red Apple Award. There is also the soughtafter Golden Apple Award given in the county to a teacher who has demonstrated accomplishments in the classroom and with individual student performance. It is based on effectiveness as a role model, making learning fun, mentoring students, and making an impact on students' lives.





Nick Jones is among five in Salem-Roanoke Baseball Hall of Fame Class of '23

Five area baseball players and contributors have been selected for induction into the Salem-Roanoke Baseball Hall of Fame for the 31st induction ceremony, scheduled for Sunday, July 23rd, at the Salem Civic Center. The Class of '23 includes Roy Clark, Nick Jones, Randy Lawrence, Reggie Poff and Matt Trent, and Gary Oyler will receive the Wayne LaPierre, Sr. Community Service Award.

Jones is a Roanoke native who played his high school ball at William Byrd High, where he was a key player on three Blue Ridge District champions, three region champs, a state runner-up team in 2000 and a state championship team in 1997. A two time all-state selection, he was Blue Ridge District and Region Player of the Year and a recipient of the Ray Bellamy Award, presented by the Salem-Roanoke Baseball Hall of Fame, in 2000. Jones left Byrd as the school career leader in runs scored and was in the top five all-time in seven hitting categories.

After graduation Nick played at Virginia Commonwealth University, where he was a part of three NCAA Regional teams along with two CAA Regular Season and Tournament Champions. Nick was selected in the 11th round of the 2003 Major League Baseball Draft by the Chicago Cubs and, while in the Cubs Organization, he was a member of three league championship teams. He resides in the Roanoke Valley and is active in coaching youth

Clark is a Martinsville native who made a name for himself in baseball as a player, scout and administrator. He was a first team All-American infielder at Ferrum College in 1977 and is a member of the college Hall of Fame.

Roy went to start at the University of North Carolina and was drafted by the Seattle Mariners in the MLB draft. After playing four years of Minor League ball he began scouting in 1985 with Seattle, then Cleveland followed by 20 years with the Braves, including 10 as Scouting Director. After four years with Washington as assistant GM he spent time with the Dodgers, then went back to Atlanta and he is currently a Senior Advisor for the Kansas City Royals. Roy is a member of the Georgia Scouts Association Hall of Fame and the Mid-Atlantic Scouts Association Hall of Fame.

Lawrence is a native of Montgomery County and a 1989 graduate of Christiansburg High School,


where he held 13 athletic records in three sports, baseball, basketball, and football. In baseball he received all-state honors as a pitcher, twice, and also as a firstbaseman along with numerous all-district and all-region honors. Randy was the AA State Player of the Year in 1988 after leading Timesland in both pitching and hitting.

Lawrence began his college baseball career at Ferrum in the spring of 1990 where he played on a nationally ranked team for three seasons, was named two time Dixie All Conference Pitcher, Dixie Conference Pitcher of the Year in 1992 with a 9-0 record, and was an All-American. He was drafted by the Boston Red Sox in June '92 and played for three seasons with the organization's minor leagues in Florida and New York. Randy was inducted as an inaugural member of Christiansburg High School's Sports Hall of Fame in April 2023.

Poff played high school baseball for Glenvar under coach Joe Davis, where he was a teammate of fellow S-R Baseball Hall of Famers Sandy Hill and Scott Atkins. He gained his fame as an official, and umpired baseball for 47 years before retiring in 2022. He also officiated basketball, volleyball and softball. As an umpire Reggie could be found on the high school, American Legion, AAU and recreation league diamonds. He was a crew chief for VHSL finals at several levels and umpired the Virginia Commonwealth Games for over 25 years.

Trent is a Roanoke native and Cave Spring High School graduate, where he was a standout outfield and pitcher. As a walk-on at Wingate University Matt earned a scholarship and led the Bulldogs in saves and strikeouts per nine innings before undergoing Tommy John surgery as a sophomore. Upon returning, he led Wingate again in saves and strikeouts and in 2005 Matt was drafted round by the St. Louis Cardinals.

In his first professional season, Trent led the New Jersey Cardinals of the NY-Penn League in saves before being promoted to Class A and finished his first season with an ERA of 2.51. In his second season for Ouad Cities Matt was a leader out of the bullpen where he maintained a 2.61 ERA. 


Mitchell is in his 15th season guiding the Maroons softball program. This is his second ODAC top coaching honor. Mitchell currently owns a 352-220 (.615)


William Byrd grad Jada Karnes won two games in the NCAA tournament and finished with a season record of 18-6, garnering first team all-conference honors.

Byrd girls win BRD soccer title, open Region 3D play at home

The William Byrd girls added a Blue Ridge District tournament championship to their regular season title last week, and this week they begin a quest for a Region 3D championship. The region tournament opens this week and Byrd will be home Friday against Carroll County for a 6 pm game on Highfill Field.

The Terriers come into the tournament with a 14-1-3 record but that only gets them the third seed. Simmons scored her third goal of the night for the game winner, heading in a corner kick from Glass, and Byrd keeper Sophia Chrisley sealed the win with a big save just before time ran out. Chrisley had 13 saves.

"It was an exciting game," understated Byrd coach Molly Cox, who was named BRD Coach of the Year after the tournament. Simmons was named BRD Player of the Year and four other girls made first team as well, Glass, St. Clair, Chrisley and Claire Glover. Second team selections included Madeleine Wolters-Argenio, Ellas Ashworth and Anna Martin.

If the Terriers play Lord Botetourt again it will end the season for the loser. Friday's winners will meet in the Region 3D semifinals next Tuesday, and LB and Byrd will play for a fourth time if they both survive Friday games. As the higher seed LB would get to be home for that game.




undecided who would start on the mound for the Terriers Thursday. He indicated either righthander Blake Glover or lefty Brogan Dent would get the
