### Vinton Town Council considers Full-Depth Reclamation process for Mountain View Road rehabilitation

Several members of Vinton Town Council and the town leadership team took a field trip to Pitzer Road in the Mount Pleasant area of Roanoke County on July 18 to learn about Full-Depth Reclamation (FDR), a process recommended by VDOT for the rebuilding of about a half mile of Mountain View Road in Vinton.

for all ages - from infants to seniors. police handled 17 drug cases and wall, along with pickleball courts and a half basketball court.

Phase 1 of the project will get underway soon with site preparation, demolition work, and filling (closing) the existing pool. The work on the park will be completed in phases.

The town must meet certain grant requirements from the VOF, including undergoing subdivision with five acres being designated as open-space land. Substantial components of the park are to be completed by July 2025.

Council was next briefed by Vinton Deputy Police Chief Tim Lawless on the 4th Quarter Police Report for April through June. In that time period, the department received 3,910 calls for service with 293 reports written, and made 836 traffic stops with 540 traffic summonses issued. There were 104 traffic accidents.

There were 115 arrests overall. The

Plans include a playground, a picnic 12 DUI's. Officers completed 787 shelter, and a planting and seating security checks. Lawless explained that citizens may request security checks on the Vinton Police website for their homes for instances such as going on vacation.

Animal control received 175 total calls - 37 for animal ordinance violations, 10 for an animal attacking a person, 33 dealing with wildlife, 17 for animal cruelty, 25 for dogs at large, 19 to report strays, and nine for code enforcement.

The Criminal Investigations Division received three new criminal cases in the fourth quarter with two cases under investigation, four cases made inactive, and one case pending lab results. Two search warrants were obtained; two arrests were made; and two items were sent to the crime lab.

As far as records management, 283 warrants were entered into RMS, along with 539 summonses. There

different bird species along with several species of mammals.

The land was originally part of the Vinyard Farm, owned by Vinton's founding fathers in the 1700s. The trail started out as a footpath and was turned into a greenway trail by the Pathfinders for Greenways Midweek Crew.

Formerly known as the Gladetown Loop Trail, the pathway came to the town's attention in October 2005, when community leader Joe Banks asked the Town of Vinton to consider building a trail from the Gladetown community to Niagara Road – not only for recreation and eventual connection to the Wolf Creek Greenway, but also to give residents the option of walking via a shortcut to Lake Drive Shopping

Due to its own limited resources, the town submitted a grant application to the Virginia Department of Conservation and Recreation in 2007 for funding to complete the part of the proposed trail which is on town-owned property and used for a stormwater management

In the FDR process, existing pavement is pulverized and mixed with cement powder and water to form a stabilized base for the roadway.

That's what the town is planning for Mountain View Road - solving the problem of the base.

Full-Depth Reclamation recycles materials from a deteriorated asphalt pavement and, with the addition of cement and water, creates a new stabilized base. There is no need to haul in aggregates or haul out old materials for disposal.

The FDR process saves costs and time in comparison to other methods of road rebuilding and is also more friendly environmentally conventional construction techniques.

According to Town Manager Pete Peters, council wanted to see the process in action before making a commitment to using the FDR process on Mountain View. No formal action will be required by council, as funds have already been authorized for the \$1.1 million project, which will require \$550,000 from the Town of Vinton (coming from CIP funds) and \$550,000 from VDOT funding. VDOT will take the lead in the Vinton project.

The project is tentatively planned for June or July of 2024, once schools are out for the summer, depending upon scheduling with contractors and subcontractors.

The Mountain View Road project will involve road rehabilitation from Washington Avenue to the town limits, about a mile in length, or two lane-miles.

Peters said the FDR process, in addition to being more economical, is more of a long-term solution than traditional repaying and is a trending technology with VDOT. The FDR pavement is expected to have a life of

Vinton Public Works Director Bo Herndon says that the FDR process is fairly new to the area and not widely used up to this point - although it was developed in the 1960s.

According to David Stowell with Southeast Čement, the process was initially used along the I-95 corridor in eastern Virginia and now has moved west for use on I-81.

During the Town Council visit to the Pitzer Road site, Herndon and representatives from general contractor Boxley and subcontractors Southeast Cement and New Field were on hand to answer questions. Several VDOT and Federal Highway Administration officials were there to observe and learn about the FDR process as well.

In simplest terms, the FDR process involves a train-like formation of vehicles, hooked together, that recycle the existing roadway on-site.

The first truck lays down a thin layer of cement powder (the concentration is predetermined by analyzing core samples beforehand). It is followed by a water truck hooked to a pulverizer/reclaimer



roadway (pavement, dirt, rocks) to a depth of about eight inches at the Pitzer Road project (this can vary) and mixes it with the cement powder and water to form a new stabilized base which is spread on the roadway to the depth required. Afterwards, a compactor (roller), so heavy and powerful that bystanders can feel the ground shake, uses a foot roller to compact the mixture forming a bond. Paving and sealing follow.

The process requires fewer trucks for hauling, less equipment, and produces

vehicle which mills/grinds up the existing fewer materials to be hauled away than traditional methods. This process shortens the construction schedule and reduces traffic disruption. The Pitzer Road project took about two days followed by another day of paving. One lane of the roadway remained open each day during the road construction process to provide access for

Town Council members and staff were impressed with what they saw on their visit to the Pitzer Road project and the benefits and savings with the FDR process.



were 35 weapons permit checks, 113 FOIA requests, 88 officer subpoenas processed, and 50 criminal histories checked.

One new officer, Andrew Hagy, was sworn in. According to Lawless, Hagy was just released from field training. "He has a great work ethic and wants to spend his career here.'

Lawless detailed several community events the police were involved in - the Blue Ridge Marathon, the Little Feet Meet, the Murph Challenge, the Chamber of Commerce Golf Tournament, the Torch Run, and the Vinton Library Summer Reading Kick-

There was overtime work with DMV traffic enforcement and several trainings - RADAR, Evidence Technician School, Police Background Investigation, SWAT School, CIT training, a Violent Crime Conference, and Drug Interdiction training.

The Vinton Police have applied for and received grants that paid for the Traffic Enforcement overtime and will provide needed supplies for the department. One block grant will be used to purchase gym equipment (\$4,716) and an ARPA grant in the amount of \$158,000 will fund additional equipment, upgrade the weapons system, upgrade rifle accessories, purchase a less lethal weapon as a tool for officers, purchase a new CID vehicle, pay for a TruNarc Handheld Narcotics Analyzer, and more.

Vinton Historical Society President Randy Layman updated council on events at the Vinton History Museum and Historical Society. He expressed his appreciation to Public Works Director Bo Herndon and the Public Works employees who have resolved rainwater intrusion problems there.

Layman and Peters revisited the project "most pressing" to the museum - the installation of a cargo

lift to upgrade access to the second floor of the museum. The lift will enable the staff and volunteers to reposition large displays from one floor to another and make exhibits and artifacts more accessible to all. The pending plan is to use museum funds, seek grants, and solicit donations through a formal fundraising effort.

Peters noted that the Historical Society has approximately \$60,000 on hand to contribute to the project and that grants exist across the state to fund projects such as this. Town Council agreed to make the cargo lift a priority and to meet with the Historical Society board to come up with methods for generating additional funds.

Assistant Planning and Zoning Director Nathan McClung updated council on Town of Vinton Community Rating System and Hazard Mitigation Projects. These were set forth in the 2019 Roanoke Valley-Alleghany Regional Hazard Mitigation Plan. Under this plan, localities are tasked with revisiting specific mitigation projects denoted for their specific jurisdiction and annually update local governing bodies - in this case, Vinton Town Council.

Some specific projects completed in the past year include providing an informational brochure on emergency or weather events (by mail), the addition of the CodeRED Alert System, and ensuring that water and sewer service can be operational during hazardous events. For example, the town has elevated the generators behind the 3rd Street Pump Station so that they are above the flood plain. Generators have been added throughout town facilities.

Other projects McClung highlighted include retaining Class 8 certification in the National Flood Insurance Program which gives a 10% discount to those qualifying, maintaining an inventory of

flood prone residential properties and repetitive loss properties and FEMA's efforts to initiate new flood maps over the next three years.

The Streambank Restoration Project at Woodland Place has been completed; the town has upgraded and repaired elements of the stormwater system and drainage system; and a new flood gauge has been installed on Glade Creek.

Herndon briefed council on the latest Public Works Committee meeting. The Cleveland Avenue Water Line project is complete, and all lines are functional. Paving is also complete on the street. The town is working to design a striping plan for Cleveland which will be completed in the fall for both the roadway and parked vehicles. Consideration will be given to slowing traffic with selective striping.

Stormwater projects on Holiday Road and Shalon Circle are in the works. Glo-Fiber construction is still underway within the town. The fall paving schedule will be underway in August and September, mainly in the neighborhoods behind Kroger and Oakey's, but also on Walnut Avenue once that Phase 1 project is complete.

Herndon spoke enthusiastically about the Pitzer Road Full-Depth Reclamation (FDR) Project in Roanoke County that council members visited earlier in the day and its application to the rehabilitation of Mountain View Road in Vinton. The Pitzer Road project is only the third of its kind in Virginia and drew quite a crowd of spectators. The FDR process saves time, money, and especially fuel.

There will be no council meeting on August 1 as council members will be attending National Night Out from 6 to 8 p.m. at the Vinton War Memorial to meet informally with citizens.

### **Been There; Done That**

Read Ecclesiastes 1:1 through l4:16

The familiar phrase "been there; done that" is often said by those who feel they've seen it all and done it all, and they're bored by it. This appears to be the outlook of the author of Ecclesiastes.

He concluded that everything he had experienced was meaningless, including the pursuit of wisdom and pleasure—things many in our modern culture seek. Even the hedonistic lifestyle of "wine, women, and song" proved to not be satisfying. These indulgences created only fleeting enjoyment.

Much of happiness depends on attitude.

I know that there is nothing better for people than to be happy and to do good while they live. That each of them may eat and drink, and find satisfaction in all their toilthis is the gift of God (Ecclesiastes 3:12–13).

Once we determine to find satisfaction in life's simple things, including what God has given us to do, we will no longer base our worth or our hope in the accumulation of more things.

is the second year that Red Valley joined the group from Thrasher.

Thrasher took 23 youth and adults on this year's trip. Red Valley, located in Boones Mill, added nine more, making a team of 32. The team members were commissioned at the 8 a.m. worship service at Thrasher on July 9, just before they started their journey.

Team members included: Aaron, Adam, Ania, April, Bonnie, Cary, Chelsea, Dave, Drew, Ginger, Ilgha, Isaac, Izzy, Jacob, Jae, Jo. B, J.R., Karen, Levi, Luke, Madison, Marty, Mary Ann, Mayzie, McKenzie, Megan, Molly, Nick, Sean, Shane, Stella, Tyler G., and Tyler W.

They were housed at First United Methodist Church in

ASP, created in 1969, brings thousands of volunteers from around the country to Central Appalachia annually to repair and replace homes for low-income families. It is meant to be a transformational service experience for volunteers as well.

More than 25 communities are served by over 15,000 ASP volunteers each year, impacting over 350 families. More than 3,000 repair projects are completed each

ASP repairs roofs, walls, floors, foundations, and bathrooms, in addition to making homes accessible through porch and ramp repairs or additions. Those were the jobs the Thrasher and Red Valley youth took on this

"Our jobs were repairing floors, siding, insulation, and more floors," Jones said.

Several participants shared their experiences and testimonies during the three worship services at Thrasher on July 16, including Nick Edmondson.

"This past week, our church's youth (along with some adults) participated in Week 5 of the Appalachia Service Project, otherwise known as ASP," Edmondson explained. "We arrived in Prestonsburg, Kentucky last Sunday to continue the work of previous churches who had been there before us. Alongside our church, we were there with three other churches. River Road Presbyterian Church from Richmond, First UMC from Belvedere, Illinois, and Red Valley UMC, from Boones Mill. Despite the large crowd, my team consisted of people from Thrasher only - those amazing people being Marty Crowe, Madison Crowe, Levi Anderson, Mayzie Jones, and Karen Hemming.

'Our team was given the house of Ms. Renee and her daughter, Sara. Renee and Sara lived in an area that was greatly affected by the floods in Kentucky back in February. Our team was assigned to start (and hopefully finish) the crown molding/trim in the living room and

"Our second objective was to put a girder (a long support beam that goes underneath the sub-floor of a house) under one of the bedrooms in Renee's house that had been washed out from underneath due to the flooding. We started this by clearing out the room, removing a custom closet that was built onto the room, and tearing up all the carpet.

"By this time, it was Wednesday afternoon, meaning we only had two more days to finish the rest of the trim and get the girder into place under the house. Thursday morning, Levi and I pulled nails out of the plyboard flooring on the far side of the room so that we could get under the floor to put in the girder. After we removed all three pieces of plyboard from their respective place in the floor, we noticed that underneath them was a layer of rotted wood.

"At this time, it was only Levi, Karen, and myself in the room. So, jokingly, I said to Levi: 'You know, we could probably throw our hammers at this wood, and it would break.' We chuckled about it as we set the last piece of plyboard off to the side.

"As the three of us stood there looking at the rotted wood before us, Karen said: 'It needs to come out anyways!' So, Levi and I had the time of our lives knocking rotted wood down to the ground beneath, using our hammers, prybars, and sudden karate skills.

"After eating lunch Thursday afternoon, Levi and I worked on our ceiling trim a little longer while everyone else got the room ready for us to put the floor joists in. We left Thursday afternoon with three pieces of trim missing from the kitchen and a room that was (for the most part) ready for floor joists.

'We arrived Friday morning ready to work, and while everyone else worked on putting in the first of four floor joists, Levi and I finished putting in our three missing pieces of trim.

"Afterwards, all six of us signed the backside of the last piece of trim and we attached it to the wall; Levi and I joined everyone else in the room to work on the remaining floor joists.

"We ended up getting all the floor joists in, the girder set on the ground in the room, and we even started digging the holes for the concrete that would go underneath the girder. Renee was especially happy about her newly trimmed rooms and how nice the whole place was starting to look

"Leaving Renee and Sara was a difficult experience for all of us. We talked about the day on the way back to the church and how we were going to miss Renee and Sara, as well as their dog Scooby and their cat Greyson. However, as we started driving home on Saturday morning, as I watched Kentucky's rocky cliffsides slowly morph their way back into the familiar rolling hills of Virginia, I realized just how lucky I was to be able to go on this trip; how lucky I was to be able to meet these people and build new relationships with people not only from different churches, as well as Renee and Sara, and, of course, my own teammates.

"How lucky was I to be able to be a part of something so big that will be remembered by not only Renee and Sara, but also all the other homeowners that were blessed by the other teams that I never got the chance to meet.

"This trip has truly been a blessing all the way around, not only for the people whose houses were worked on, but also for the people who worked on the houses. And for that, I would like to thank many people for making this experience possible.

Thanks to all of you in the congregation today for helping by donating money, snacks, and some construction experience. Thanks to Bonnie and Dave for coordinating this whole trip and supplying tools that were used during the process. Thanks to the people at ASP for making this whole thing possible to begin with. Thanks to all of the adults who went to assist all of the youth while working. And last, but certainly not least, thanks to God for guiding all of us this week as we worked and drove and played all week long."

Luke Hemming shared that this year was his second ASP trip, along with his brother, Aaron. His job was to install insulation (an itchy task) and a vapor barrier underneath a house in the crawl space; along the way he learned to use a staple gun.




Hemming especially recalled a powerful speaker who





pond, built in the years after the flood of 1985. The construction of the town's industrial park on Third Street and the Lake Drive Shopping Plaza on Hardy Road had led to some flooding issues in the area. At one time it was estimated that two-thirds of the town's water drained into the Gladetown section.

When the grant did not receive approval, the town decided to seek assistance from the Pathfinders for the Greenways in building

When siting the trail in the fall of 2009, town staff discovered that, in order to be out of the wet area, a portion of the remainder of the pathway proposed would have to be built on property owned by Woodland Place.

Town staff met with Tommy and Karen Wood, then owners of the Woodland Place property, to ask for an easement. Instead of granting an easement, the Woods generously donated a triangular portion of their property to the Town of Vinton for the trail. The trail was completed in 2012.

The Pathfinders for Greenways built not only the trail, but a picturesque wooden bridge across stream.

The Town of Vinton completed Streambank Restoration Project at the Woodland Place end of the trail with the assistance of grant funding from the Virginia Department of Environmental Quality (DEQ) Stormwater Local Assistance Fund (SLAF).

are complete in the gym. The retracting goals have been installed as well, awaiting the electrical wiring hookups.

The main office of the school is expected to be completed by August 1, also the completion date for the cafeteria. The front entrance is finished.

As for other Roanoke County schools, Kageals informed board members that the NESHAP asbestos reports on Glen Cove and W.E. Cundiff Elementary Schools are due on July 17 (undertaken to avoid the asbestos situation encountered at William Byrd).

Site surveys are almost finished at Glen Cove; those at W.E. Cundiff are expected within a couple of weeks. A pre-proposal meeting for the two elementary schools was held on July 12 with multiple contractors attending.

Work continues on seven playgrounds in the school system. Materials have been delivered to W.E. Cundiff with installation scheduled. Mount Pleasant equipment is yet to be delivered.

The Request for Proposals for the Vinton Bus Lot project was published on July 11.

At the work session, School Superintendent Dr. Ken Nicely presented a new policy to the School Board, formally clarifying expectations about the primary role of educators as focused on student learning, and the manner in which the school system demonstrates care and inclusivity and creates a sense of belonging for students. This is accomplished through daily activities by showing kindness and respect to everyone in the school

care about students," Nicely said.

The new policy focuses on acceptable décor

and displays within the schools' classrooms. Nicely presented some background information on the policy prior to discussion:

"The policies of the Roanoke County School Board support the establishment and operation of schools focused on the educational goals and objectives of the school division, and committed to the principles of nondiscrimination, equal opportunities, and tolerance, including for all protected classes of individuals as enumerated in to the curriculum and instructional goals of the state and federal law and School Board policies. "The Roanoke County School Board strives

to maintain a learning environment in which all students can reach their highest potential. The School Board believes that this is best achieved in supportive and respectful environments in which teachers focus on the curriculum and learning objectives for their particular courses

The Roanoke County School Board recognizes that preparation for effective citizenship is one of the major purposes of education, and that the preparation for effective citizenship includes the school and classroom decor and displays may study of issues that are controversial. Such study will be carried out in an atmosphere free from bias, prejudice, or coercion.

"Personal beliefs about political views, sociopolitical issues, or religion are often deeply held and personal to many members of the school community and their families. Out of respect for the diversity of personal beliefs represented in their students, or that students who do not share

the school community, the school and classroom decor and displays should contribute to, and not distract from, a school environment free from bias, prejudice, or coercion."

Dr. Nicely also defined the purpose of classroom "Our teachers and staff are good people, who décor and displays as supporting "the curriculum and learning objectives of Roanoke County Public Schools and contributing to a learning environment in which all students are valued and supported, regardless of their beliefs about political views, sociopolitical issues, religion, or their status as a member of any protected class of individuals as enumerated in state and federal law and School Board policies." The RCPS policy on classroom décor and

displays reads: All classroom displays must directly relate

courses of study conducted in that classroom. Employees may not use their position or use

school or classroom decor and displays to advocate for their personal beliefs about political views, sociopolitical issues, or religion, to students. The School Board recognizes the right of employees, as citizens, to engage in political activity and advocacy on issues important to them outside of the classroom. School division time, resources, property, or equipment, however, may not be used for such purposes by any employee. The School Board recognizes that

communicate multiple intended and unintended messages. A sticker, sign, flag, or other display hung by a teacher may be intended to show support and affinity for a subset of students, but it can unintentionally imply that other teachers who do not display such messages or symbols in their classroom do not support inclusion for all

the same identity are unwelcome. All teachers and other employees are expected to demonstrate care, respect, and support for all their students. All classrooms must be safe for students' physical, intellectual, emotional, social, and psychological growth and well-being and, therefore, no subclassification system will be implemented within the school except as authorized and designated by approved school safety and emergency response plans.

Nothing in this policy should be 4. interpreted:

to preclude an employee from wearing symbols on discreet personal jewelry or having small personal items that are meant to be viewed by the employee, rather than by students; nor

b. to contravene RCPS policies promoting school rules, student behavior expectations, patriotism or character education; nor c. to preclude displays the sole purpose of

which is decorative, rather than an expression of political, sociopolitical, or religious views, or a cause of disruption; nor to preclude decor and displays related

to school-sponsored clubs, athletic teams, or extracurricular activities, or special events; nor

to preclude decor and displays related to accredited colleges and universities or the United States military. An addition is also proposed to the Employee

Standards of Conduct Code "unacceptable conduct" section: "Use of position or use of school or classroom decor and displays to advocate for personal beliefs about political views, sociopolitical issues, or religion to students. School division time, resources, property, or equipment may not be used for such purposes by any employee."

Action will be taken on the policies at the next



# 2019 champs are still close four years later

Four years ago the William Byrd girls were queens of the diamond as they won the Virginia High School League Class 4 state softball championship. It was a special year for the Terriers and coach Greg Barton as the girls finished 20-6 and had walk-off wins in both the semifinal and final games at the James I. Moyer Complex in Salem.

"Special team, special young ladies," said Barton. 'The 2019 team was a team that bought into what we were coaching and never questioned us. The girls were a tight knit group of kids that trusted and believed in each other."

The season didn't start out like anything special, as Byrd was 2-3 after the first five games. However, they returned from spring break with three big wins and started rolling. After they lost in the Blue Ridge District tournament to Lord Botetourt they wouldn't lose again, winning the Region 4D championship and the state crown.

"Everything went our way," remembers Barton. 'We beat Woodgrove in the final and they were big favorites to win the whole thing. They were threetime defending state champs."

The Terriers beat Great Bridge in the state semifinal, coming back from 2-0 behind to win 3-2. Mo Sydney Burton with the winning run. Burton had the James I. Moyer Complex in June of 2019. doubled to lead off the inning.

In the championship Byrd came from behind time it was Burton's bloop single with the bases loaded that scored Megan Grant with the winning run and another walk-off win, setting off a wild celebration on the field.

"We were the home team in all three state games, and that's big," said coach Barton. "You always want to have last at bat in big games like that."


After the season Burton, Grant and pitcher Jada Karnes, all seniors, were named Class 4 All-State, and Barton was named Coach of the Year. Several of the girls went on to play in college, and four years later several of the girls have had continued success on the ballfield.

Grant went on to play at Elon University, where she's had an outstanding career. Megan will be a fifth year senior next spring, having an extra year to play due to COVID. She was the CAA Rookie of the Week on March 3rd before the season was shut down in 2020. In 2021 Megan was an All-CAA second team selection and this past season she was CSC Academic All-District.

In four years on the varsity Grant has a career batting average of .278 while playing in 161 games, 160 of which she was a starter. She has 122 totals hits with 17 doubles, eight triples and a home run. Her on base percentage is .425 with 94 walks and 20 times she was hit by a pitch. Megan has a slugging percentage of .360 for the Phoenix. As a junior she tied an NCAA Division I softball record with three triples in one game against Providence.

Karnes went to Roanoke College where she's had an outstanding four years career. Jada will continue her softball career as a graduate assistant with the Liberty University softball program in the coming school year.

Jada was the horse the Terriers rode to the state championship in 2019. Karnes finished the season at completed her second year on the Bluefield College

she allowed just three hits to one of the best hitting teams in the state, fanning five.

In four years at RC Jada was the undisputed ace for Mike Mitchell's Maroons. She won 54 games in four years while losing just 23. As a junior she was 20-7 and this past season she posted an 18-6 record to lead the Maroons to a 29-14 record and a bid to the NCAA Division III tournament.

Jada started 76 games in the past four years and struck out 422 batters with 58 complete games and 493 innings pitched. She finished with a four-year earned run average of 1.76. She also had 24 hits while playing first base on occasion and finished with a .276 batting average.

This past season Jada was named first team allstate by the Virginia Sports Information Directors, third team All-NFCA and first team All-ODAC.

Burton, Byrd's third senior all-state player in 2019, did not play college softball. Sydney was also a standout basketball player for the Terriers during her high school career.

Two juniors on the 2019 championship team went on to play at the University of Lynchburg, Lexi Powell and Bri Hodges. Powell was a second team all-state catcher for the Terriers but has played outfield an some corner infield for the Hornets. In 2021 she was VaSID second team All-State and second team All-ODAC when she hit .331 with 10 doubles and 25 runs batted in. In three years at Lynchburg Lexi has 90 hits, including five triples and a home

Hodges was Byrd's cleanup hitter in 2019 as a junior. In three years at Lynchburg Bri has 56 hits, including five home runs. She's an outfielder.

Hallie Cox was Byrd's second pitcher in the championship season as a sophomore. She recently

> 10 runs as a pinch-runner. Hoal was a backup infielder for the Maroons this year. She appeared in four games and batted three

> Icard, Erin Courtemanche, Morgan Webb, Logan Pekala and Rachel Cruff were also key members of the 2019 team but didn't play college ball.

> "Morgan Webb, Erin Courtemanche, Sydney Burton, Morgan Icard, Logan Pekala and Rachel Cruff all could have played college ball if that is what they chose to do," said Barton.

> Barton was assisted by Mike Andrews on the coaching staff in 2019 and both are still with the club. That year Greg also added a former Terrier player to the staff, Kassie Brammer. A couple years later Kassie got the head coaching job at Northside, and this past season she was named Class 3 state Coach of the Year after leading the Vikings to the state championship.

Four years later, the team remains close.

"They all remain close and in contact with each other," said Barton. "They believed we could win and never quit in any game or any inning. I'm proud to have been the coach of a group of girls I truly
