## New Vinton area school administrators introduced at School Board meeting

Five new Roanoke County school administrators were introduced at the Roanoke County School Board meeting on July 27. Four of them are assigned to Vinton area schools—Evan Noell, Crystal Bondurant, Heather Everhardt, and Abigail Barnes. Matthew Gouker has been named Assistant Principal at Glen Cove Elementary.

Evan Noell is the new principal at William Byrd Middle School, replacing Dana Stevens who retired. He was born and raised in Salem and graduated from Glenvar High School, where he was a four-year starter on the baseball team and captain his senior year. Playing catcher, he was voted Roanoke Times

All-Timesland his final two years with the Highlanders. He coached baseball at Hidden Valley High School for two years and at Roanoke College.

Noell earned his Bachelor of Arts Degree in History from Coastal Carolina University (where he played baseball for four years), his Master's Degree in Special Education from Radford University, and his endorsement in Educational Leadership from Liberty University. He has worked in education since 2010 across all three levels of instruction.

"I am passionate about fostering student growth in a positive school environment," said Noell. "Over time as a classroom teacher and a coach, I

## Construction projects galore ongoing in downtown Vinton

Griffin Contractors hope to finish up demolition work on the firedamaged properties on Pollard Street by August 4. On July 2, 2022, a fire tragically destroyed D.R. Music at the corner of Pollard and East Lee Avenue. Several adiacent businesses were severely damaged; it was eventually determined that those structures could not be saved.

Due to the extensive damage sustained by D.R. Music at 101 East Lee Avenue, and the collapse of its roof, the primary structure was determined to pose a public hazard and was ordered by the Roanoke Building County Officials office to be taken down on the day of the fire.

The former Edward Investments Iones building at 103 East Lee Avenue and Rustic

Creations at 107 East Lee were demolished in April 2023 along with a structure at the rear of the

buildings. The contractors have been working with excavators, bobcats, hand tools, and dump trucks over the past two weeks to complete demolition of 206 South Pollard, which housed Faith's Hair Studio and 208 South Pollard, home of Anita's Alterations. The contractor worked to ensure preservation of the former Red Jasmine restaurant on Pollard by hand-detailed demolition, before bringing in the heavy equipment on July

The Edward Jones building, hair studio, and alterations building, all constructed in 1920, shared walls which affected one another structurally when it came to planning safe demolition.

The plan initially was to complete the



## Rewinding the clock: High school memories from William Byrd

The original plan was for August 9, 2023, to be a celebration of the completion of the Renovation and Expansion Project at William Byrd High School. Unfortunately, due to the discovery of some pesky asbestos, that grand re-opening will be postponed until the spring of 2024.

The delay hasn't dampened the spirits of William Byrd alumni, nor lessened the nostalgia they feel for their high school days. There has been a lot of reminiscing going on in person and on social media about the good old days at Byrd.

A topic that almost always comes up in those conversations, at least for those who were students between 1965 and 1999. is Bob Patterson, their beloved principal at WBHS for 34 years.

Patterson was only 29 years old when he was named William Byrd's principal. When he retired, he was Virginia's high longest-serving school principal.

Black The 1966 Swan yearbook said, "Enthusiasm and spirit resounded through the halls of William Byrd this year as the students endeavored to carry the banner of a proud heritage. This enthusiasm was generated by the leadership of our new principal, Mr. Robert Patterson.

Patterson proved to be a principal who merited respect from the entire student body through his zeal and diligence. He evoked cooperation from students by his willingness to listen to their suggestions, while at the same time reminding them of and expecting them to conduct themselves in a manner that would bring honor to William Byrd."

Byrd. "He had a strong faith which was always evident," said Trent. "He had incredible integrity. Standards were quite high for athletes in the '70s and '80s and Mr. Patterson supported his coaches enforcing the rules and living by high standards themselves. He was very fit and encouraged others to do the same – although he never saw a hospitality room he didn't like.

"I ran across him once in the courtyard at William Byrd sowing grass seed," said Trent. 'It's just the kind of guy he was - no job was too

"Bob was one of the finest human beings I have ever met in my life," said Coach Norm Lineburg. "He never cursed, never said a bad word about anyone. He was a loyal friend. I have never been around a classier person. He was not an 'I' person; he was a 'we' person. He was always helping someone. He was as close to a perfect person as I have ever been around."

Patterson's son, Robert Patterson, Jr., paid Greenway a visit on July 31 to present the school system with a painting of William Byrd High School which hung on the wall in his father's office. It was painted in 1987 by art teacher Martha Lalka. Greenway hopes it will be displayed at the high school once renovations are complete.



The first Tuesday in August has been celebrated across the nation and around the world as National Night Out since 1984. That first NNO involved 2.5 million neighbors across 400 communities in 23 states. After 39 years, the event now includes 38 million neighbors in 17,000 communities with 162 of those being in Virginia.

demolition process by July 28, but the expected time has been extended due to engineering required to safely demolish the adjoining buildings.

Plans are shaping up to include building back some mixed-use buildings with both residential and commercial space available.

Businesses in the surrounding area have been able to remain open downtown despite the demolition process, with one lane of traffic closed on Pollard Street and one on East Lee Avenue and fencing installed to protect motorists passing by.

The Town of Vinton does not own the properties involved in the

demolition, but has been working with the property owners, nearby businesses, and private contractors since day one to keep the project on track and provide accurate information about the process. Property owners are currently exploring plans for redevelopment of

The demolition is being conducted and paid for by the owners of the properties and their insurance companies, not the town. Damages were estimated at \$1.5 million by the Roanoke County Fire Marshal.

Some businesses directly affected by the fire have relocated to permanent addresses and are still in operation.

D.R. Music is now located at 128 N. Pollard and Rustic Creations relocated to 116 S. Poplar Street. The George Lester Edward Jones Investments office is currently located at 10 Walnut Avenue (behind the fire station), with plans to eventually return to their location on E. Lee Avenue.

Once the demolition is complete and debris is loaded on dump trucks and hauled away, the rebuilding process is set to begin.

However, the demolition work on East Lee Avenue and Pollard Street is not the only project involving machinery and construction crews in the downtown area.

New Design Stone has been working this week on creating an area of pavers, benches, flower beds, and more at the new Town of Vinton Annex building at the corner of Pollard and Jackson Avenue, which also houses the Vinton/ Roanoke County Health Department.

Contractors continue to work on Walnut Avenue to add pedestrian/ bike lanes and sidewalks to make the roadway safer to travel.

Invitations to Bid have gone out for the 81-space downtown parking lot on Walnut Avenue as well, near the Vinton Farmers' Market.

And in August, the annual street paving project will get underway.

## From the pulpit

#### The Sermon on the Mount - The Beatitudes

The Sermon on the Mount can be found in Matthew 5-7. It is the first public sermon given by Jesus. This incredible sermon begins with a series of "Blessed are those who" statements. Matthew 5:6 brings us to the next characteristic expected by Jesus Christ of all His followers.

This verse tells us, "Blessed are those who hunger and thirst for righteousness, for they will be filled."

I am from Indiana and there was a time in my life when I followed the Indianapolis Colts extremely closely. I hungered and thirsted (if that's even a word) for all things Colts. Every news article, every trade or rumor of trades, every play, and every win/loss (mostly losses some years). But no matter how much "info" I gathered/read

or how many games I watched, it was never enough and I was never satisfied with what I had.

Today's passage tells us very plainly, IF you hunger and thirst for righteousness (true Godly living) THEN you will be filled.

I have found that many people that call themselves Christians have very little hunger or thirst for true Godly living. How do I know? Bibles that are only opened on Sunday mornings at church. A lack of knowledge of what Scripture says about nearly any topic. Little or no personal Bible study.

The Sermon on the Mount ends in chapter 7 with this phrase, "Therefore everyone who hears these words of mine and puts them into practice is like a wise man who builds his house on the rock." Let's be doers of the Word, not just hearers!

## Villa Heights to celebrate 100th anniversary

In 1989, the church moved into the present building in the Bonsack area of Roanoke County at 4080 Challenger

## RECIPES OF THE WEEK

## Homemade Ketchup

A vivid memory I have from my childhood summers is going with my mother to the local cannery at the high school in Wytheville and making homemade ketchup.

Community canneries originated with the Victory Garden era of World War II in the 1940s and were historically supported by the local school systems where they were typically used as educational tools for home economics. There is still a cannery in Wytheville today and in many rural counties that surround Roanoke.

My dad would pick bushels of tomatoes the night before. We would get up and be on our way about 4:30 a.m. as making ketchup from scratch was quite a long process, involving giant kettles, a pulper, strainers, and more.

Here is the basic recipe - which my mother multiplied many times over to make enough ketchup to see us through

Tomato Ketchup by Alice Holpp 1 cup Heinz white vinegar

1 and 1/2 tsp. whole cloves

1 and 1/2 tsp. coarsely broken stick

1 tsp. celery seed

8 pounds (32 medium) tomatoes

1 Tbsp. chopped onion 1/2 tsp. powdered red pepper

1 cup sugar

4 tsp. salt Combine the first four ingredients and bring to a boil. Set aside for vinegar to absorb spices. Cook tomatoes, onion, and red pepper until soft - about 15 minutes. Run this mixture through the

Combine the tomato juice and sugar and boil, stirring frequently until volume is cooked down to half - about 45

Strain vinegar and spice mixture. Combine salt and vinegar and add to boiling tomato mixture. Continue boiling for about 30 minutes longer or until as thick as you want it. Pour in jars and seal under pressure or in a boiling water bath.

Makes 2 pints!

## Vinton Public Works Dept., Community Programs and Facilities Dept. issue monthly reports for June

Vinton Department and the Community Programs and Facilities Department remained busy in the first month of

The Vinton Public Works Director's Report for June 2023 has been released and indicates that 306 tons of Municipal Waste and Wood Waste were collected in that month, along with 3.88 tons of curbside recycling; 44.75 tons of Residential Waste and Wood Waste were disposed of. The streetsweeper cleaned 75 miles of roadway, collecting 10.41 tons of debris.

As for Fleet Maintenance, during June, six police vehicles were serviced, along with six Public Works Light and Medium Duty Vehicles, and 10 Public Works heavy duty vehicles. State Inspections were completed on four vehicles. Maintenance work was completed on eight public works vehicles and trailers.

A total of 54 work orders were completed by the Vinton Public Works Dept. in June.

Public Works employees completed seven work orders involving removal of dead animals and seven jobs involving sign installation and signal repair. They completed 21 work orders for utility markings. Approximately 10.5 tons of asphalt were used on road repairs in June. Thirty-two tons of asphalt were used in storm drain road repair.

Five Public Works staff assisted with support for the Ironman Triathlon race on June 4. Downtown flower-watering totaled 22.5 hours.

Public Works delivered and picked up four town dump trucks through the town's Adopt a Truck program in June. Any Vinton resident may schedule the parking of a dump truck at their home overnight so that the resident may load items to be discarded from cleaned out basements, attics, storage sheds, etc., not to include construction materials, brush, or hazardous materials. The truck is dropped off at approximately 3:15 p.m. and picked up the next morning at 7:30 a.m. This service is available to town residents no more

than four times per year; it is not available to businesses or commercial In other Vinton Public Works news,

Town Manager Pete Peters announced that staff has increased the 2023 paving allotment to \$1.5 million for August/ September due to an approximate \$100,000 increase in state funding for highway maintenance. Cleveland Avenue paving is now

complete and temporary markings will be placed soon to test the engineered striping plan. ADA ramps are planned.

Public Works completed demolition of the abandoned house on Cleveland Avenue as part of the town's support of the redevelopment of the Cleveland Public Works also assisted the

Pathfinder for the Greenways Midweek Crew to remove sediment from Wolf Creek Greenway near Route 24.

The Community Programs and Facilities Department report shows that the Charles R. Hill Community Center had 17 rentals in June with 1,290 attendees and rental revenue of

There were two in-kind programs in June with 50 guests in attendance—the Vinton Area Chamber of Commerce and the Vinton Booster Club.

Senior programs using the Community Center in May included five classes of Line Dancing #1, five classes of Line Dancing #2, two Monday Music Jams, three Tai Chi classes, and three cards classes.

The Vinton War Memorial hosted two wedding/receptions in June with 500 in attendance bringing in revenues of \$5,650. There were 18 room rentals at the War Memorial in June with attendance of 3,455 and revenues of \$10,850.

The Community Events and Programs at the Vinton Farmers' Market in June included Mingle at the Market concerts on June 10 (attendance 1,000) and 24 (attendance 500). Vendors in June included Gabby Rueda of Rueda Produce.

William Byrd shot a team score of 346. David Foster, a


freshman, led the team with an 81 and also scoring were Nathan Carter at 86, Andrew Kiker at 88 and Blake Austin at
