## W.E. Cundiff Elementary celebrates 50th anniversary

Cundiff Elementary School celebrated 50th anniversary with a "Cheers to 50 Years" open house on April 21. Guests were invited to "Rediscover the Past, Embrace the Present, and Discover the Future."

The school (originally named Hardy Road Elementary for its location) first opened in August 1972 with 732 students and Frank Stone as principal. Stone served until 1988 and was followed by Jackie Glover until 1988, then Sherry Bryant until 2017, when Ashley McCallum was appointed. In fact, Stone was McCallum's principal when she attended the school.

Stone and Bryant were

able to attend the open house, along with Lorraine Lange and Deanna Gordon who served at Cundiff as teachers and assistant principals before advancing to become Roanoke County school superintendents. Former students colleagues were delighted to see teacher Mary Neal, who opened the school with Stone in 1972 as a first grade teacher.

School Board member Tim Greenway noted that he attended Hardy Road Elementary, as did Tammy Shepherd who currently represents Vinton on the Roanoke County Board of Supervisors. Laurie Mullins, who serves on Vinton Town Council, was also a Cundiff student.

The gym, cafeteria,

## Vinton welcomes Murrill's Lady Appalachia mural

Local artist Jon Murrill has noted that a mural can have more than one purpose. It can be purely visual, tell a story, or enrich a community. His newly completed mural in downtown Vinton accomplishes all of these. It is the first in a series of murals he plans throughout the region and state, entitled "Lady Appalachia."

Vinton Town Council and staff and other members of the community gathered at the Town Annex Building on Pollard Street on April 22 to welcome Lady Appalachia to Vinton. Deputy Town Manager Cody Sexton said that while it is somewhat difficult to "unveil" a mural that is some 22 feet tall and whose creation has been watched by the entire town, the town can "launch" Lady Appalachia to the world.

Vinton Mayor Brad Grose noted that art says a lot of different things to people and this piece says a lot about the Town of Vinton and its willingness to participate in





## William Byrd athletes sign letters of intent to continue academic and athletic careers at collegiate level

Thirteen William Byrd High School student athletes in six different sports signed letters of intent to continue their educations and athletic careers at the collegiate level during a commitment ceremony at WBHS on April 23.

They are football players

Brayden Andrews (Roanoke College), Lane Shoemaker (Roanoke College), Bricen Lancaster (Catawba College), Cooper Minnix and (Shenandoah University); track athletes Wyatte Bailey (William & Mary), Reagan Lilley (Emory & Henry), and Donald Mullins (Emory & Henry); swimmer Michael Hoyos (Roanoke College); lacrosse player Julian Pantoja (Virginia Wesleyan College); softball player Abbie Fitzgerald (Eastern Mennonite); and cheerleaders Emma Kageals (Virginia Tech), Sheradyn O'Neill (Roanoke College), and Gracie Mick (Roanoke College). Principal Tammy Newcomb

congratulated the athletes and their families, noting that only about 1% of high school athletes advance to play at the next level. Football coach Brad Lutz

introduced members of the football team. He expressed his pride in the group for their hard work and "representing us well" and thanked their families for their support. He reminded students to be thankful for those who have had pivotal roles in their success. Brayden Andrews had 164

carries for 827 yards and 12 touchdowns in rushing yards and 12 catches for 123 yards, and 1 TD in receiving. He made 2nd Team All-Blue Ridge District

and 2nd Team All-Region 3D as a running back and had "one of the most impactful touchdown runs in school history at the regional championship game." His parents are Laurel and Ryan Andrews.

Lane Shoemaker was a leader

"on the best defense in school history," with 23 carries for 130 rushing yards and 4 TDs, 23 tackles, 5 TFLs (tackles for loss), 2.5 sacks, and one fumble recovery in defense. He was named to 2nd Team All-Blue Ridge District as a linebacker. His parents are Christina and Tim Shoemaker. Bricen Lancaster made five

out of six field goals (the longest was 33 yards), 70 kick-offs with 30 touchbacks and 36 in which the opponent was pinned inside the 20, and a punting average of 35.7 yards. He was named to 1st Team All-Blue Ridge District as a kicker and punter and 2nd Team All-Region 3D as a kicker. His record makes him the second in school history for field goals in a season (five). His parents are Lori and Chad Lancaster. Cooper Minnix had 27

catches, 365 yards, and 3 TDs. He made 2nd Team All-Blue Ridge District as a wide receiver. He is the ninth all time in school history for yards in a career. "His touchdown against the red team was the biggest catch in his career." His parents are Heather and Allen Minnix.

Coach Junius Pannell introduced students signing letters of intent to continue in

track at the college level. "Wyatte Bailey is gearing up to head to William & Mary to continue his academic and

is currently the school record holder in the pole vault for indoor and outdoor. He is the fourth fastest guy in 400m- all time. He is an Adidas indoor track All-American in the sprint medley relay. He has traveled to Vegas to compete; he has won a state championship during indoor, and Wyatte still finds the time to help teammates achieve their goals of clearing the bar for the first time when they are newcomers to the event. I have always appreciated Wyatte's ability to remain humble and his ability to take coaching." His parents are Angela and Jeremy Bailey. "Reagan Lilley is preparing

to go to Emory & Henry to compete in cross country and track & field while studying business administration. He has shown nothing but hard work since his freshman year. He fell in love with running and improving himself. For instance, Reagan was a 23-minute 5K runner and now he is a 17 minute, 49 seconds 5K runner freshman to senior year. Freshman year he was a 2:41 800m runner and at our home invitational in the freezing cold he ran a 2:13 personal record in the 800m. Reagan is an all-region, all-district, state qualifier, who works hard at his craft. His parents are Jamie Powell and Larry Lilley.

"Donald Mullins is also going to Emory & Henry to run cross country and track & field, studying exercise science. Donald was never interested in running when he first got to WBHS; it was all basketball, basketball, and more basketball. I remember asking Donald

about running track, and he

laughed at me. He finally

decided to come out and told me he was sprinter. After a meet at Staunton River, he came to me and said that sprint life was not for him, and he wanted to run the 800m and he just missed state qualifying and that is when he fell in love with the sport and doing what it takes to get better. Donald is an Adidas All-American, state qualifier, allregion and all-district athlete." His parents are Mercedes and Donald Mullins. Swim Coach Krista Martin

introduced Michael Hoyos. "Michael was our team

captain this year with a great season. He was our Blue Ridge District champion in the 200 freestyle, and he finished fourth at Regionals in the 200 freestyle where he advanced to state. Michael was also an integral part of our state relays. I have been lucky enough to coach Michael for the last five years. He is a very proficient swimmer and he's always been willing to do our longest distance events anytime we needed him to (which was quite often). Michael always had a plan for a race whether it was an individual race or a strategy for a relay. I appreciate everything Michael put into this team. He plans to go into pre-law and swim at Roanoke College next year. You have a promising career and life ahead of you, Michael." His mother is Candice Hoyos.

Boys lacrosse coach Will Satterfield introduced Julian Pantoja and expressed his heartfelt gratitude for Pantoja's impact on the team. "Julian has

worked harder than any player

I have ever coached." He noted

that lacrosse is a "tough sport

where the student attempts to

get in the way of a solid rubber

ball with a steel core." Julian's parents are Kelly and John Hickey.

Softball coach Greg Barton introduced Abbie Fitzgerald, saying that "she had a dream and fulfilled that dream through setbacks, adversity, and injuries. She is big in church and her faith has kept her on track." Her parents are Mary Barnett and Donald Fitzgerald. Cheer coach Dee-Anne

Dillon introduced three cheerleaders who will continue their sport in college.

"Emma Kageals started on the varsity sideline beginning her freshman year- one of only two freshmen to make the varsity squad that year. She has also been on the competition team all four years. She served as captain of both teams her senior year. She is one of the most well-rounded student athletes we have. She not only excels in athletics, but in academics as well. She will be graduating with honors as a valedictorian. Emma strives for excellence in everything she does. She puts in the work in the classroom and in her extra-curricular activities. She is a multi-sport athlete with many honors. She holds the school record in the 55m hurdles and long jump. She was named All-Region in track for three years, and has received All-District, All-Region, All-State, and All-American honors in competition cheer. Virginia Tech is lucky to have her as a student athlete and we are excited to see her continue to wear maroon and orange.'

## Happy 35th Birthday, Vinton History Museum!

The Vinton History Museum celebrated its 35th anniversary on April 22, combined with the kick-off of a fundraising campaign to add a cargo/accessibility lift to the museum. The party included cake, hourly door prizes, free Christmas ornaments, and museum tours.

Museum staff and "churned volunteers it up" by accepting donations for the "Rising to New Heights Cargo/ Accessibility Lift" in an antique rocking butter churn throughout the afternoon. Their goal is to collect \$60,000 for the project.

The project aims to enhance accessibility, safety, and community engagement by addressing the current challenge of access to the museum's second floor. The second floor is now accessible only via a steep set of stairs, original to the Upson home built in 1906.

The lack of accessibility creates a significant barrier for senior and physically challenged individuals, hindering their ability to view and use historic items on the second floor. The cost of the

project is estimated to be approximately \$170,000. The museum has about \$60,000 set aside in funds accumulated throughout the years, along with some grant funding, leaving about \$60,000 to raise.

As an active participant in the town's revitalization efforts, the Vinton

Historical Society dedicated to the realization of the town's 2020-2025 Strategic Plan concerning enhancing the town's infrastructure and livability.

The Chicago area native is a well-





## Eichelman, Carolyn Harr

Mrs. Eichelman, a retired

Roanoke County teacher turned author, is survived by her beloved husband, Dr. Fred R. Eichelman; two children, Carol Lyn Eichelman Webster and Fredric Roger Eichelman, II; as well as five grandchildren, James William and Michael Fredric Patrick Webster and Anne Marie, Josiah David, and Fredric Charles Eichelman; and one great-grandchild,

Lilly Mae Webster.

Mrs. Eichelman was well loved as a teacher and was also called "the hostess with the mostest" for looking after a number of film and TV stars as well as politicians who came to the Roanoke

Carolyn Eichelman was born in 1936 in Argo, Ky., the only child of Everett and Ida Harr, and raised in Vansant, Va. She attended Grundy High School where she was a member of the Beta Club and played basketball. As head of the Girl Scouts, she succeeded in getting the town council to build a new bridge for the safety of children. She was also active in the Thespians. Her college work was at Radford College, now university, and her training was as a teacher with a business minor. She later did graduate work at the University of Virginia, and received a Master's in Elementary Education and Supervision from Virginia Tech and State University.

Mrs. Eichelman began her teaching career in Roanoke City with Preston Park Elementary. She married Fred R. Eichelman in 1960 and transferred to Roanoke County Schools where Dr. Eichelman was a teacher. Carolyn took a leave of absence while her two children were small and then returned to education as one of the first teachers in the Roanoke City Total Action Against Poverty (TAP) Head Start program. She later transferred to Salem where she was assistant head teacher for the Salem Head Start center. Working with her husband she was instrumental in the integration of the county school system.

After returning to public elementary school education Carolyn Eichelman taught at Conehurst, Academy Street,

On Sunday, April 21, 2024, of Salem G.W. Carver, and her final teaching graduated to be home with the Lord. years, when Salem created its own school system, at Mason's Cove.

While in Salem, Carolyn received the Salem Jaycees Outstanding Teacher Award and in a statewide competition placed as second runnerup. Her work in creating "interest centers" drew many observers from around the state and in the 1970s, she headed a University of Virginia

run team to write the first state wide curriculum guide for kindergarten. Carolyn Eichelman was a life member

of the National Education Association serving many terms as a faculty representative and as a delegate to state and national conventions. She was one of the organizers and early officers in Salem's Jaycettes and active in the Beverly Heights Civic League.

Her activities also extended into politics where she was a delegate to state Republican conventions, was one of the founders of Salem's Republican Women organization and a worker in many political campaigns. She also hosted local Republican gatherings while active within the party.

For over 40 years Mrs. Eichelman was very active as a chairperson for various committees associated with local media conventions. For RoVaCon she was deeply involved in the scholarship program which provided scholarships for dozens of high school seniors. For Rising Star, Starz 2000, Point North † and Happy Trails Virginia Style she was in charge of guest relations in working with film and TV stars. During the last few years Carolyn was very much involved in programs supporting cancer research, something she wrote published articles about, as well as raising money. She also hosted a number of social events in connection with the conventions both at the event itself and the Eichelman home.

In later years, she was a director for Point North † Outreach, Inc. the international Christian media organization. With her husband she encouraged young Christians to go into film and wanting to "walk the walk and



## HopeDriven sponsors another successful HeRow Expo event in Vinton

The non-profit HopeDriven organization held its fourth annual HeRow Expo at William Byrd High School on Saturday, April 13–a car, truck, and powersports show where all proceeds are donated to a child with a life-threatening illness.

According organizers, they are "driven" essentially to help children and their families "find hope in their darkest moments and most difficult of times." The HopeDriven goal is to have a significant impact on the financial burden these families endure and to "provide them with another reason to fight when they see so many people within their community come together to support them in their time of need. We also know that we can't possibly help every single family in need, but we can do our part to help as many as we can."

Each year Mandy Price helps HeRow Expo select the sponsored child for the fundraising event. She lost her daughter, Rowan, in 2019 to leukemia. Rowan's spirit and enthusiasm led to the formation of HopeDriven. The HeRow Expo is held each year to honor the impact she had on the community.

This year, the fundraiser benefits 8-year-old Tripp Poats of Roanoke, who was originally diagnosed with leukemia in September 2019 at the age of 3 and underwent 2-1/2 years of chemotherapy. Tripp and his family enjoyed a cancer-free year and a half until his leukemia relapsed in September of 2023. He began treatment locally and suffered some major complications that caused him to be admitted to the hospital and eventually the PICU in Roanoke. His family made the decision to have him transferred to Cincinnati Children's Hospital to recover from complications and to

continue treatment.

Tripp returned home recently after an inpatient stay of 142 days. He's doing much better but is still dealing with some of the side effects from the complications around his treatment. He will return to Cincinnati periodically to receive stronger chemotherapies but can take many of the medications at home. He will receive a total of 2-1/2 years of treatment yet again.



## A Study of Ephesians – 'God's Marvelous Plan'

Our focus at Lynn Haven Baptist Church for 2024 is on Discipleship. Discipleship is the process of becoming more like Christ tomorrow than you were today.

We have been going through the Book of Ephesians as a starting point in our discipleship journey. By

chapter 3 we find Paul explaining his "personal calling" to the Gentiles, a "mystery that's been revealed" to him. In Acts 9 we find this personal calling to the Gentiles and the associated mystery. Saul (Paul's previous name) met Jesus face-to-face on the road to Damascus where he was blinded and led to a man named Ananias. Saul was one of the greatest persecutors of Christians at the time. The Lord told Ananias that Saul was God's "chosen instrument to proclaim my name to the Gentiles and their kings and to the people of Israel" (v.15). Once Saul could see again, he was baptized immediately and

"I am excited about where we are and how we are growing," said Grose. "Lady Appalachia shows our roots in the past– where we have been- and where we are

Murrill thanked the Town of Vinton for "making this happen."
"This is something that I wanted to do

as a gift to the area where I grew up," he said. "This is the first mural in the Lady Appalachia series and an embodiment of the region, how we see the valley, the Blue Ridge Mountains, and Mill Mountain from Vinton's perspective, and provides a new 'vibe' in the area."

He said that he has learned a great deal about creating murals in the past three years and feels that this is one of his best pieces so far, one that "showcases" his

Murrill says the other murals in the series will be different in each location, relating to the land and region, but with close ties to the mountains, particularly the Blue Ridge Mountains.

He says he wanted the face of Vinton's Lady Appalachia to be "front and center. I am not sure how large her face is in comparison to other portrait murals in the state, but it has to be up there with the largest. Most murals represent more of the

human figure when going this large." The background of the new mural features the mountains surrounding the Roanoke Valley using unique shades of blue and green.

The question mark for many who have viewed the mural is "What is she thinking about or looking at with her hand on her cheek?"

He declined to give away his own

thoughts about the meaning of the mural, leaving it to others to "form their own narrative, to decide what each Lady Appalachia is trying to say."

The gesture of her hand relates to the expression on her face," Murrill says. "She is contemplating something. I wanted this gaze to allow the viewer to determine what she is thinking for themselves. I have my own opinions of what she may be contemplating, but I think the unique nature of this pose allows each of us to see something slightly different within the

'The freckles were inspired by deer spots on a fawn. This piece directly relates to our surrounding area so the more natural elements I could introduce into her character the better.

"The beauty about Lady Appalachia is that she is a representation of the land we love so much. Her features, expression, and ethnicity will change amongst the variety of murals she is in. This relates directly to the history of our area and the many, many people groups that built our culture over the last few centuries.

'When I designed Lady Appalachia, I was greatly inspired by Lady Liberty and her pose at the Statue of Liberty. I wanted to create an image that seemed iconic for our area by representing a unique character holding a walking staff amongst the Blue Ridge Mountains. This gradually evolved into representing her not just as an individual, but as an embodiment of the land. By depicting her with moss growing up her fingers, deer-spotted freckles, and a bird's nest crown, I wanted people to see her differently than a traditional portrait. She is meant to symbolize our relationship to the land both in the past and present."

This is not Murrill's first outdoor artwork in Vinton. He collaborated with art teachers and students last year to create the parkway scene on the Vinton Veterinary Specialty Services Center on East Washington Avenue. That mural involved mainly paint brushes and rollers. For Lady Appalachia, however, Murrill used spray paint to a great extent, despite the winds of March and early April.

'Spray paint is such an interesting medium to use," he says. "I have only been using it for three years and it is a steep learning curve! I enjoy creating soft blends and hard edges so spray paint is the perfect tool for me to use as long as it is not too windy!"

Murrill will be starting his next mural in the Lady Appalachia series soon in Stuart, Va.

"I will be painting on the side of a local restaurant, Pickle & Ash, who are great supporters of the arts and have a very creative vision. We designed a piece that will definitely grab everyone's attention in the area!

"Aside from my Lady Appalachia series, I will be traveling to paint a large community-based mural in Craig County. New Castle was awarded a grant to build not only a new farmers' market, but also to beautify the area even more with a mural. The mural will feature the landscape of Craig County and a variety of wildlife seen

"As someone raised in Vinton it has been so special for me to bring my artwork to my hometown," Murrill said. "I have been drawing and painting since a very young age and always enjoyed creating unique characters. Now that I paint publicly, my style may be different, but my passion for creativity remains the same. Once I complete a mural it then is no longer mine. I hope that Vinton enjoys my own creative take on our area for years






Mia Martin sends the ball downfield in Monday's soccer game with Cave Spring.

## Byrd baseball team picks up big wins against Eagles, Knights




