William Byrd's Israel Hairston signs with Virginia Tech

William Byrd High School multi-sport athlete—football, baseball, basketball, and track—and valedictorian Israel Hairston signed his national letter of intent with Virginia Tech on May 22 as a “preferred walk-on” in the football program and as an engineering student.

Hairston was recently named Class 3 VHSL Scholar Athlete of the Year—a first in William Byrd history. He was also named Blue Ridge District Offensive Player of the Year, Region 3D Offensive Player of the Year, Crunch Co-Player of the Year, and Second Team All-State.

This past season he helped lead the Terriers to their first-ever state semifinals game and regional title and winning 12 games in a season.

Byrd football Coach Lutz commented that Hairston has rewritten the history book at Byrd, holding the record for most passing yards in a career, most passing touchdowns in a career, most passing yards in a season, and ranking fourth in total yards.

Career statistics total 304 carries, 2,264 yards, and 32 touchdowns; 248 completions in passing with 430 attempts, 3,398 yards, and 29 touchdowns; 5,662 total yards and 61 total touchdowns.

Hairston was joined at the signing of his letter of intent ceremony by his family, teammates, and coaches in football (Lutz), track (James Pannell), baseball (Jason Taylor), and basketball (Brad Greenway).

Principal Tammy Newcomb spoke first, thanking Hairston “for all the memories you have provided us. We are so proud of you.”

Football coach Brad Lutz noted that the recruiting process had been a long process, working hard “to find the right fit” for Hairston, who “made academics a huge priority” and wanted to attend a university with a top-notch engineering school. Several other colleges and universities made offers; Lutz noted that the commitment to Virginia Tech is “a huge deal.”

Both Newcomb and Lutz praised Hairston for

participating in multiple sports while maintaining excellent grades. He earned a 4.16 GPA, taking Pre-AP, AP, and Dual Enrollment Classes, and was on the A or A/B Honor Roll every nine weeks throughout his high school career.

“Israel will be a tremendous student athlete at Virginia Tech, just like he has been here,” Lutz said. Lutz joked about Hairston being able to keep the same school colors from Byrd in his career with Tech. The coach also touched on Hairston’s stellar character and

team-minded attitude, recalling him “sweeping the floor” after their annual football banquet.

He also reminded Hairston and his other teammates who had signed letters of intent to “remember where you came from.”

Hairston said that playing football at VT “has been a childhood dream, like a lot of kids in Virginia.” He will be playing as a defensive back. His brother,

The Town of Vinton joined forces with BoomTown Crossfit in Vinton to observe Memorial Day on May 27 with a Murph Challenge fundraiser.

Murph Workout heats got underway at 8 a.m. with a one-mile run through local streets, followed by 100 pull-ups, 200 push-ups, and 300 squats at BoomTown, followed by another one-mile run.

Lt. Murphy, a United States Navy SEAL, was killed in combat with Taliban fighters in Afghanistan in 2005 as part of the Operation Red Wings four-man reconnaissance mission. Danny Dietz and Matthew

Axelson were also killed during the mission. Marcus Luttrell survived, thanks to the actions of Murphy, after wandering the mountains and being taken in by friendly local Afghan villagers.

Murphy is credited with risking his own life to get a message out to friendly forces to save the lives of others. He was posthumously awarded the Congressional Medal of Honor.

The Murph Challenge is held annually around the world on Memorial Day to honor not just him, but all who have given their lives in service to their country.

Vinton Community Resource Officer Will Holland was on hand with the Vinton Police Department Mobile Unit to cook hot dogs for the crowd and their families. First Citizens Bank sponsored the cook-out and Smooshed provided sweet treats.

The BoomTown Crossfit gym and fitness center is located at 703 Tinker Avenue in Vinton near Cargill (formerly Southern States).

Vinton Town Council holds budget hearing

Vinton Town Council held a public hearing on the proposed FY2025 budget during its meeting on May 21. Council and citizens present were briefed on the document by Deputy Town Manager Cody Sexton before the hearing began.

Sexton noted that this year's budget is balanced with a "moderately optimistic outlook," and based on the town's strategic plan.

The proposed budget for the General Fund totals \$13,610,991, which represents an increase of 8.6% or \$1,078,028 over the previous year. The proposed FY2025 budget for all funds totals \$14,879,829, which represents an overall increase of 4.19%.

Highlights of the budget for the upcoming fiscal year include:

- a 3% Cost of Living Adjustment for all employees (the town has 69 on staff)
- an end-of-year gratuity bonus
- no change to Employee Health Plan Premiums

Town Council did not increase tax rates this year; any increases in tax bills are due to increases in assessed values.

Sexton stated that in the proposed budget, the fund balance will be used for several one-time projects, such as the Gish Mill Performance Agreement, the town's upcoming development of its Comprehensive Plan, and increased paving.

The FY2025 Capital Improvements Projects budget includes the purchase of a new refuse truck and "lots of paving."

Sexton noted during the discussion that Vinton has a "robust business community" which is also quite diverse. He emphasized how fortunate the town is to have several sources of revenue and is not dependent primarily upon real estate taxes as some localities are.

Mayor Brad Grose praised the staff for their diligence in developing a budget based on "what we can do for our citizens to improve their quality of life." He, too, commented on the advantages of the diverse revenue streams which the budget is based on. Vice Mayor Mike Stovall described the document as "a solid budget."

There were no comments from citizens concerning the FY24/25 budget.

The proposed budget was presented to council in detail at the meeting on May 7 by Town Manager Pete Peters. Final action will be taken on adopting the final budget at the June 4 council meeting. The proposed budget can be viewed online at <https://www.vintonva.gov/100/Budgets-Reports>.

In other action during the May 21 meeting, council declared May 19-25 as National Public Works Week, thanking the Public Works Department for outstanding contributions to the citizens and town with street maintenance, sidewalk repair, solid waste collection, recycling, traffic signal and sign maintenance, snow and ice removal, stormwater collection, and invaluable assistance with special events.

Public Works Director Bo Herndon recognized employees Jason Davison, Chris Lawhorn, Andrew Critcher, and Billy Robb for participation in the recent Mid-Atlantic American Public Works Association WRX Rodeo at the Berglund Center on May 1. Davison placed second in the bucket truck competition; Lawhorn placed second in Zero Turn Mower; and Robb placed third in bucket truck. They have been invited to compete at nationals in Atlanta in September.

Council adopted a resolution declaring May as GBS/CIDP Awareness Month in the Town of Vinton. These are two disorders of the peripheral nerves with the cause unknown and the effects of the illnesses unpredictable. Rick Forney, GBS/CIDP Mid-Atlantic Regional Director and Southwest Virginia Liaison, accepted the proclamation.

Peters updated council on the Mountain View Road Full Depth Reclamation (FDR) project that will, in effect, rebuild the roadway. Construction will get underway in mid-June and is weather-dependent. The markings on the roadway visible to motorists now indicate the current location of utility lines, not changes to be made.

A group of citizens who live on Lynn Haven Circle addressed council about their concern that their street might become one-way, and the inconvenience that might involve. Council and the town manager said that town staff would be casually polling citizens in the area to get a broader sampling of opinions and report back to council.

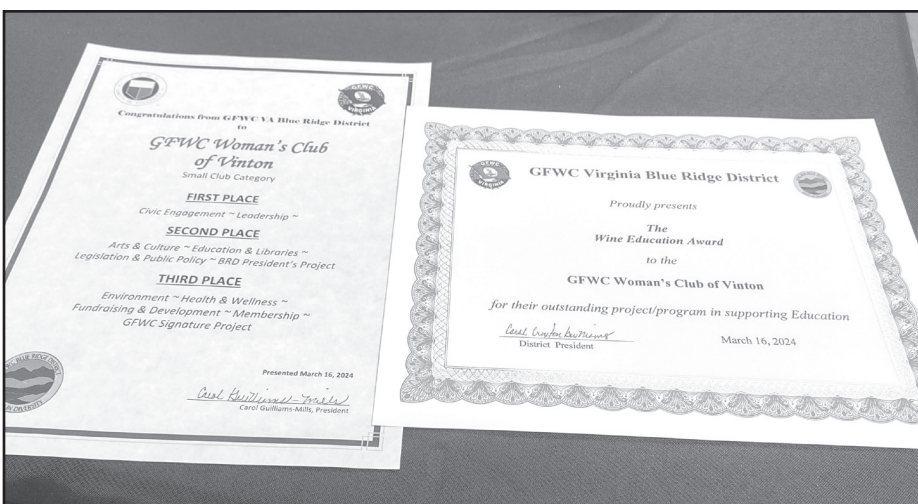

The club won third place in "Environment—Health and Wellness," "Fundraising & Development—Membership," and the "GFVC Signature Project."

Remembering Vinton

Fifty years ago in 1974

with the Vinton Historical Society

In May 1974 the Vinton Town Council election included 14 candidates—the most hotly contested in the town's history, according to The Vinton Messenger. Most of the newspaper was taken up by political ads.

Dick Horn and Rufus Hall were running for a seat on council to fill the vacancy left by the passing of Norman Dowdy. Four candidates were running for mayor—

incumbent Gus Nicks, Shirley Crowder, Russell Meador, and Stafford Meador. Eight candidates were running for two seats on council—Bobby Altice, Henry Brabham, Lee Brock, Elmer Cox, Bobby Hall, Roy McCarty, Jr., Marvin Parsons, and Donald Smith.

On May 7, Nicks, Horn, Brabham, and Cox were victorious and made their first pledge to voters—to battle against annexation.

Town Manager Ron Miller recommended the Town of Vinton set its budget for fiscal year 1974/75 at \$1,181,333, an increase of 9% over the previous year.

The Roanoke County School Board was recommending cuts of teacher salaries by 1.4%. Beginning teachers would earn \$7,600; those with 12 or more years of experience would earn up to \$11,870. Teachers were not taking the reduction well and promised to take their case to the Board of Supervisors.

The Roanoke County Board of Supervisors reportedly met in secret to balance the county budget without increasing taxes or levying new taxes.

The Virginia Department of Highways authorized \$50,000 to be spent on “four-laning” and improving the road between Vinton and Route 460—Vinton Mill Road—from the town's northern limits to Pollard Street.

The 19th annual Dogwood Festival (which lasted two weeks) had been held at the end of April and drew a huge crowd of approximately 20,000 spectators. Judi Stowers from Galax had been crowned Dogwood Queen, back when the queens were chosen from visiting bands.

The State Wrestling

Champions from William Byrd were honored at a banquet at the Vinton War Memorial, including Dale Sparks, Jeff McGrath, Ronnie Wood, Anthony Amos, Peter Kline, Barry Trent, Tim Semones, Adam Phlegar, Chuck Eanes, Joe Gray, Mike Gribble, Marvin Martin, and Bruce Palmer.

An escaped convict from North Carolina was arrested for breaking into a residence on Mountain View Road by forcing out a bathroom window. He was armed and had escaped from a road crew near Asheville. A man was also shot in front of a grocery store on Washington Avenue after a shoving match.

The Town of Vinton reminded property owners of the mandatory grass and weed cutting deadlines between May 15 and June 15, and again between August 1 and September 1. Fines for the offense ranged from \$2.50 to \$50.

Hardy Road Elementary celebrated May 1 with the traditional dance around the May Pole after a welcome by Principal Frank Stone.

H&H Supermarket was advertising chuck roast for 79 cents a pound, corn on the cob for five ears for 59 cents, and a quart-sized jar of JFG Mayonnaise for 89 cents.

VINTON HISTORY: The Banjo Clock

The Eight-Day Banjo Clock is an American wall clock with a banjo-shaped case. It was invented by Simon Willard and patented in 1802. The banjo clock normally lacks a striking mechanism and indicates time only by its hands and dial.

The banjo style of the wooden case usually features a round opening for a painted dial, a long-waisted throat, and a rectangular pendulum box with hinged door. Both the throat and door are ornamented with reverse-painted glass panels, and the case is usually flanked by curved and pierced brass frets. Willard's banjo clock was accurate and dependable and would run for eight days—which is how it got its name. For ease of maintenance, its pendulum was hung in front of the movement, not behind, an arrangement that American clockmakers soon widely adopted.

The Eight-Day Banjo Clock with brass eagle on display at the Vinton History Museum was donated by Grace Overacre.

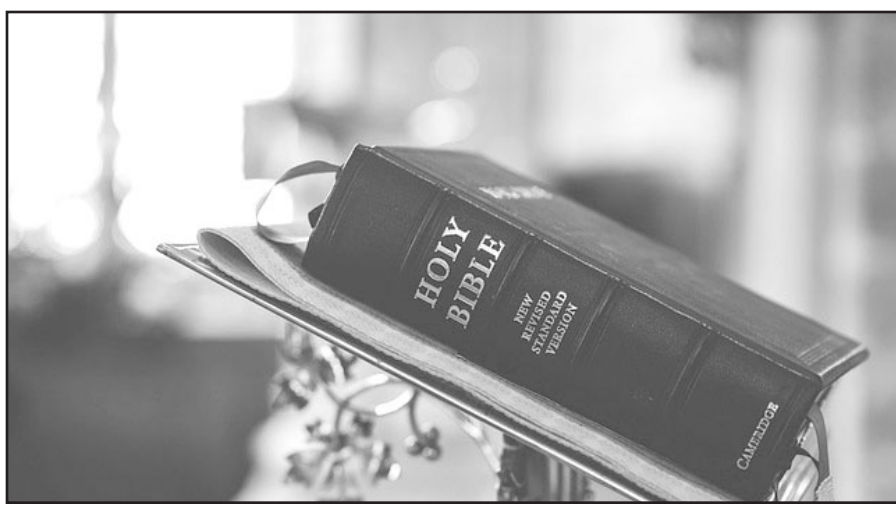

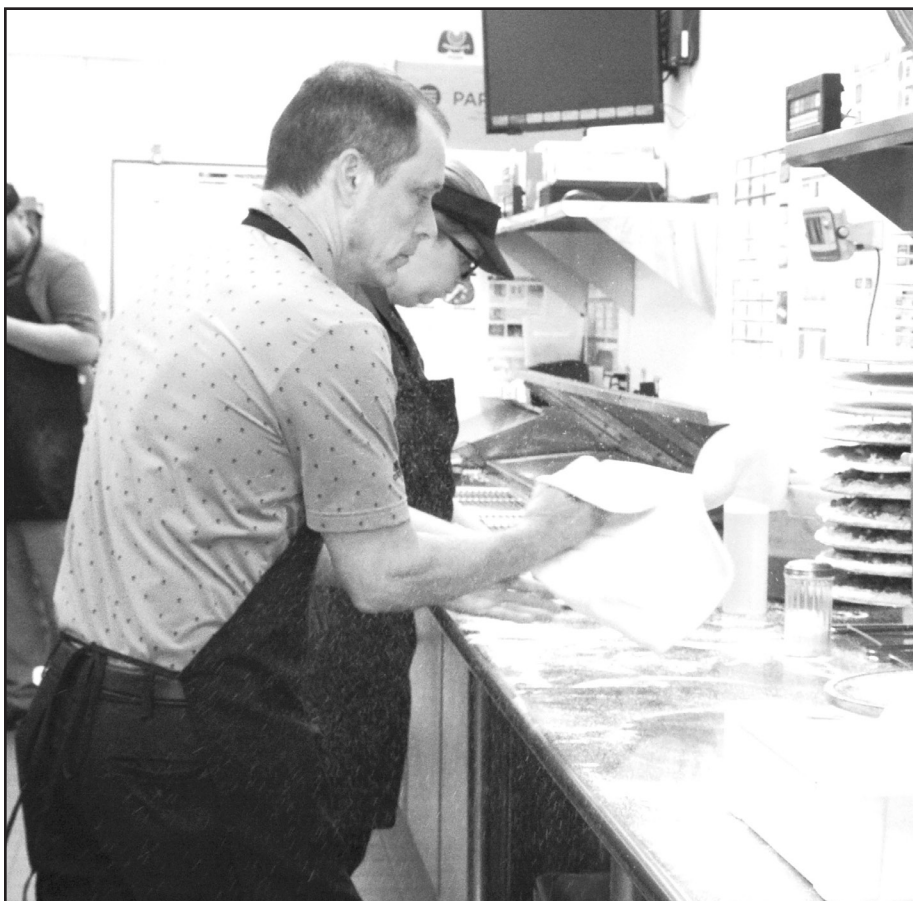

along with Mason, said that Vinton “embodies the community feel and has the same values that Marco’s holds dear. The close-knit atmosphere here aligns perfectly with our commitment to quality and service. We believe Vinton is an ideal place to grow and connect with our customers.” Their plan is to build out in the valley, with four or five locations eventually.

They also “plan to engage with the Vinton community through various initiatives, such as sponsoring local events, supporting schools and sports teams, and partnering with local charities,” Hudson said. Through their business, they have become involved in giving back to the community with the Salvation Army, the Boys and Girls Clubs, and at-risk youth.

“In the few weeks we have been open, we have already partnered with a church (Rescue Mission Ministries) to feed the homeless once a month. We believe in giving back and in being an active part of the community we serve.”

Hudson and Mason have been friends since college and business partners for several years.

“We are proud to be one of the brand’s largest African American multi-unit operators and are excited to expand further in the Roanoke and Lynchburg

areas,” Hudson says. “We believe in the importance of trust and partnership in business, which has been key to our success. The Vinton location is our eighth location; we have our ninth location opening in Richmond in less than 30 days.” (Marco’s Pizza now has 1,200 locations in total.)

A recent article in “Nation’s Restaurant News” explains the history of their partnership which has resulted in a recent “International Franchise Association Franchisee of the Year Award” for “operational excellence and leadership in the Black entrepreneurial community.”

Hudson and Mason met as students at Virginia State University, where they joined the same fraternity. After graduation, Hudson began working for the USDA and quickly realized that wasn’t the path he wanted to take career-wise. Mason first worked for accounting firms and determined that wasn’t his career of choice either.

Hudson opened his first company— a mental health organization— and began learning about entrepreneurship. He helped Mason and his wife to open their own company, and now they have been business partners for about 15 years in various industries, including the soon-to-be-nine locations in Virginia.

Hudson, originally from Chicago and somewhat of a pizza “connoisseur,” discovered a Marco’s Pizza near his home and loved the food. The two did some research, which led them to Marco’s corporate headquarters in Toledo and opening their first location in 2018. Their long-term plan is to help Marco’s become the fourth largest pizza brand.

“I believe in the brand, and I love the food,” Hudson says.

The Vinton Marco’s will employ approximately 20-25 staff members, providing both part-time and full-time opportunities.

Marco’s Pizza was founded in Toledo, Ohio, in 1978 by Pasquale “Pat” Giammarco, an Italian immigrant who named the restaurant after himself.

“The name reflects our founder’s heritage and commitment to authentic Italian quality,” Hudson says. “Under CEO Jack Butorac’s leadership since 2004, Marco’s has grown significantly with that focus.”

As for how Marco’s differs from other pizza restaurants, Hudson says, “Marco’s stands out because of our dedication to authentic Italian pizza. We use fresh, never-frozen dough made daily on-site, a proprietary cheese blend, and a secret original pizza sauce recipe

from our founder, Pat Giammarco. This commitment to quality ingredients and preparation methods ensures a delicious and unique pizza experience.

“Our specialties include our classic Pepperoni Magnifico, White Cheezy, and Deluxe, All Meat, Garden, and Hawaiian Chicken pizzas. Marco’s recently launched the Pizzoli, which is a fan favorite. Our CheezyBread and CinnaSquares are also customer favorites.”

The general manager of the Vinton location is Emily Chastain; the area supervisor is Chuck McCellop; and the operations director is Mark Wentzel, “who brings extensive experience in the food service industry and a passion for customer service.”

Marco’s is open from 11 a.m. to 11 p.m. Sundays through Thursdays, and 11 a.m. to midnight on Friday and Saturday. They offer both take-out and delivery within a five-mile radius around Vinton “to ensure prompt and fresh delivery,” as well as third party delivery. 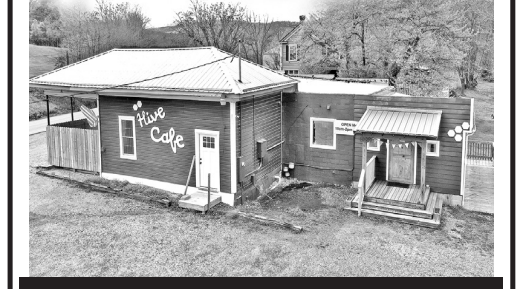

Boys 2nd in region track, state meet this weekend

Liberty University in Lynchburg will be the site of the Class 3 and 4 state track meets this weekend and William Byrd will be well-represented. The meet will begin with selected events and sprint trials on Friday at 12:30 pm, then return for a full day of events Saturday at 9 am.

The William Byrd team competed in the Region 3D meet in Abingdon last Thursday and the host Falcons won both the girls' and boys' team titles. The William Byrd boys were second with 102 points, just two fewer than Abingdon, and the Byrd girls were third with 72.4, three points behind second place Christiansburg.

Byrd's DeShawn Austin was a two-time Region 3D champion. DeShawn won the 110 hurdles with a time of 15.03 and won the 300 hurdles in 40.12. He also took second in the triple jump, third in the long jump and ran on the second place 4x400 meter relay team with Brady Reachy, Wyatt Bailey and Isaiah Board. They finished in 3:32.29.

Two other relay teams also placed. The 4x800 team of Donald Mullins, Reagan Lilley, Shaun Gower and Reid Anderson finished second with a time of 8:33.00, and the 4x100 foursome of Cooper Minnix, Reachy, Lane Shoemaker and Israel Hairston finished third with a time of 43.90.

Minnix also took thirds in both the 100 and 200 meters while Bailey was third in 400. Wyatt took a third in the pole vault as well with Ethan Haston clearing 13'6" to take a second place medal in that event. Haston and Hairston were fifth and sixth, respectively, in the long jump and Titus Beatty state qualified in the shot put with a throw of 43' 5.75".

In the girls' meet Emma Kageals swept the hurdles, winning the 100 in 16.01 and the 300 in 47.98. Emma also ran on the third place 4x400 relay team with Emma Matthews, Lily Perez and Taylor Spangler.

Perez won the triple jump with a hop, step and jump of 34'9.5". Lily also placed second in the 100 hurdles, took second in the long jump and was fourth in the high jump.

In the girls' pole vault competition Spencer Peters finished third with a height of 8'6" while Gracie Mick and Makenzie Scott finished fourth, clearing 8'. All three made it to the state competition in Lynchburg this weekend.

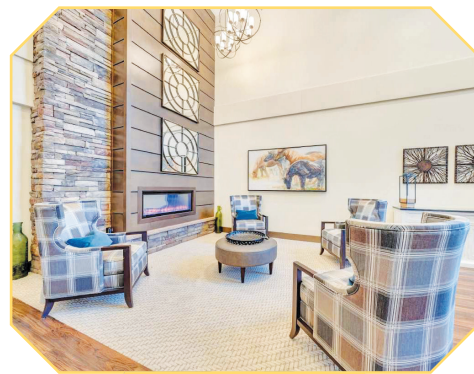

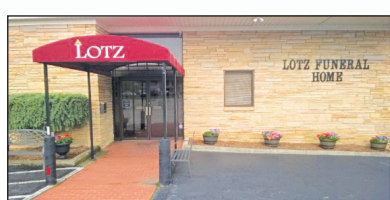

Byrd boys earn spot in state soccer tournament

The William Byrd boys saved their best soccer for the best time as they won three region games in seven days to qualify for the Virginia High School League Class 3 tournament. Byrd will play at either Magna Vista or Christiansburg Friday for the Region 3D championship, and that result will determine where they open state play next week.

The Terriers came into the region tournament as the number seven seed among 10, needing a win over 10th seeded Bassett to reach the quarterfinal round. They hosted the Bengals last Wednesday and took a 4-1 win on Highfill Field in Vinton.

"We opened the season with Bassett so we were familiar with them, but the concern was possible changes through the season as well as the fact it is the region and you need to expect the unexpected," said Byrd coach Russell Dishman.

Byrd controlled the match from the start. Just five minutes into the match Sergio Leon opened the scoring off a cross from Ben Guertin. Then, in the 23rd minute, Cole Kovacevic was able to take the ball down the left side and play a ball across the face of goal for Shaun Gower to finish, putting Byrd up 2-0. Bassett had a one-on-one with the keeper shortly thereafter but Bricen Lancaster made a big block save to stone the attempt.

"That moment pretty much put the momentum in our favor for the rest of the night," said Dishman.

Kovacevic scored to put Byrd up 3-0 at the half and Ian Sigmon combined with Tyson Brady on a free

kick to put the Terriers up 4-0 in the second half. Bassett was able to score in the final minute off a free kick to ruin the shutout, but that was of little concern as the Terriers moved to a Saturday game against second seeded Abingdon on the road.

Coming in as big underdogs, the Terriers took a bite out of the Falcons when they scored just nine minutes into the game. Ben Guertin crossed the ball to Sean Minnix on the back post and Byrd had the early lead, setting the tone for the game.

In the 30th minute Kovacevic served a corner kick in for Sigmon to finish, and just three minutes later Guertin took a ball to the left corner and played it back to Kovacevic who nailed a left footed strike to put Byrd up 3-0. Leon was able to score off an unassisted run and the last goal came from Sergio off a cross from Kovacevic as the Terriers shut out a stunned Abingdon team, 5-0.

That win put the Terriers in Tuesday's Region 3D semifinal at Northside, with a berth in the state tournament on the line. Byrd had split with the Blue Ridge District rival Vikings during the season, a 3-2 win and a 2-1 loss, so fans were expecting a close game.

They weren't disappointed. As they had in the other two region games, the Terriers drew first blood. Just seven minutes in the Terriers had a free kick that Sigmon played short to Daniel Britts. Daniel took a couple touches forward then played a 40 yard ball on frame that went over the keeper to give Byrd a 1-0 lead, and that was the

only score of the game in a 1-0 Terrier win. "It was back and forth and we had three balls go across their goal but could not finish," said Dishman. "We did well to prevent their build up in the middle and we were able to create in the width."

With about 11 minutes to go Northside had a big chance with a shot that Lancaster was able to push away with his right hand before it made it in the top corner. That was the Vikings last real chance as Byrd won by shutout for the second game in a row. In the three region games the Terriers outscored their opponents 10-1.

"The boys were excited to get the tough win, make the region final and qualify for

the state playoff," said Dishman. "Even though we are the seven seed, this has been the expectation all season. We had the tough run after spring break where we lost six matches by a single goal each. The guys stayed focused and were able to keep composed and put it together as we hit the play off."

Byrd is now 10-8-3. Magna Vista and Christiansburg were scheduled to play in the other region semifinal on Wednesday and the survivor will host Byrd Friday. The region champion will get a first round home game in next week's state tournament and the runnerup will go on the road to the Region 4C champion.

Blue Demons knock Terriers out of region girls' soccer

As the 10th seed in the Region 3D girls' soccer tournament the William Byrd girls opened with a "play in" game against seventh seeded Christiansburg last week, and the Blue Demons survived with a 3-2 win on their home pitch.

The visitors scored first when Eva Brown played a through ball to Logan Andrews, who was able to dribble around the Christiansburg keeper and score just 10 minutes in the game. However, the Demons answered quickly when a handball was called in the box and they were awarded a penalty kick, which they converted to level the score at 1-1.

Christiansburg took the lead with seven minutes remaining in the half when they scored off a corner kick, and that was how the game stood at the break. Then,

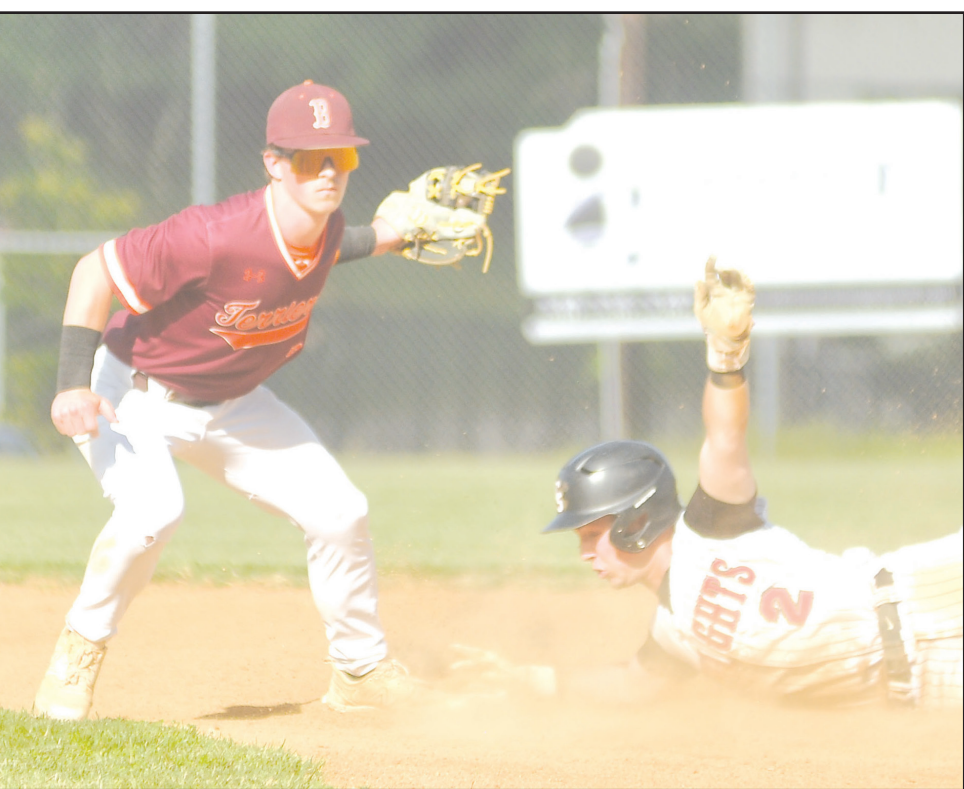
coming out of halftime, Christiansburg scored a goal three minutes in to go up 3-1.

Byrd cut the lead to 3-2 with five minutes on the clock on an "own goal," but the Demons were able to regroup and hold on for the win.

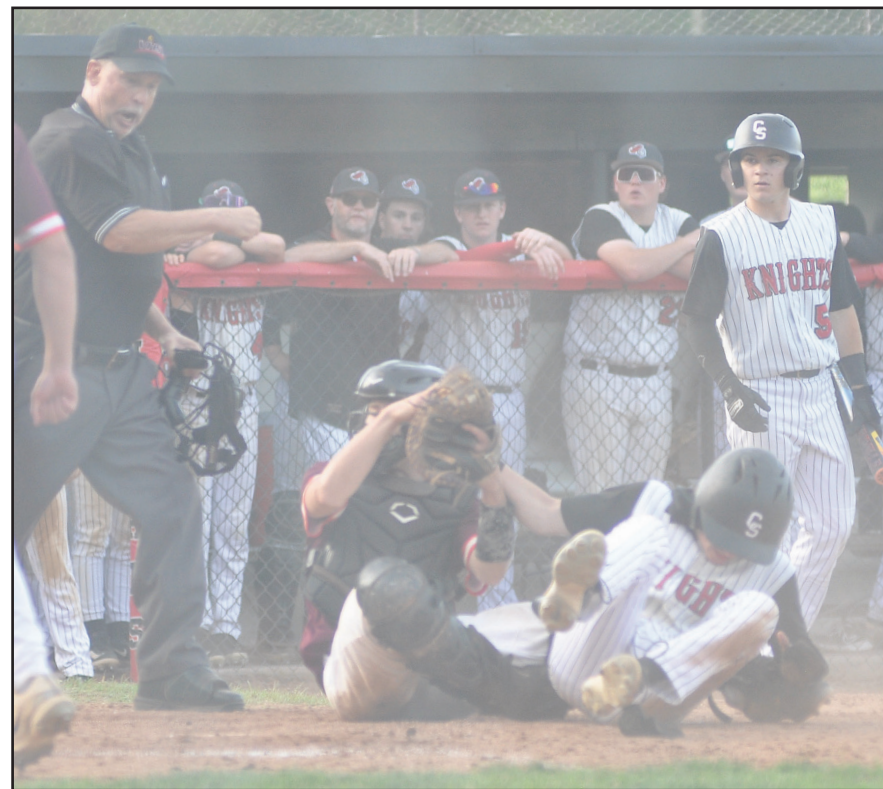
"While we had chances, we could not convert for the majority of the second half," said Byrd coach Molly Cox.

Knights end Byrd baseball season in region quarterfinal game

The William Byrd baseball team saw their season come to an end at Cave Spring High School last Friday. After beating the Knights twice during the regular season the Terriers dropped a 10-1 game and were eliminated from the Region 3D tournament.

"We did not play well defensively nor did we hit the ball well," said Byrd coach Jason Taylor. "Our pitching was good enough to keep us in the game but we made seven errors in the infield. You can't do that at this time of the year."

Cave Spring took a 2-0 lead in the first inning with two unearned runs and never trailed. Byrd scored a run in the top of the second to cut the lead to 2-1 but the Knights answered with two more in the bottom of the inning to go up 4-1. They put three on the board in both the fifth and sixth to put it away.

"I liked our matchup and the bracket," said Taylor. "Cave Spring had not played in two weeks and we were coming off the BRD championship. I thought we had all the momentum. I thought we were ready, but maybe the distractions of last week were too much. We did not have a practice that all the players attended. Graduation, end of the school activities, some students still taking exams, play-

ers running in the regional track meet and other appointments made it tough. But, it is my responsibility to make sure we are ready.

"Cave Spring had 10 seniors that have done that already. We did not handle it well. You must be committed as a group this time of the year and we were not."

Cooper Minnix started on the mound for Byrd and took his first loss of the season, giving up four runs, two of which were earned, in three innings. Brogan Dent pitched into the sixth and Brenin Witcher got out of a bases loaded, no out jam in that inning but the Terriers were too far behind by that point. Israel Hairston, Kam McKee and Jerrett Shepherd each had a hit and Eads had Byrd's RBI.

"I would note that the kids did not quit," said Taylor. "That was shown by (catcher) Noah Thompson's hustle play in the bottom of the sixth on a passed ball. He ran to the back stop and beat the kid to the plate to save the slaughter rule. He could have easily just let it go.

"That gave me the opportunity to let a few kids get an at bat, which I had decided to do prior to that play. I had told players they would hit in the seventh. They had been at practice all week and

deserved it, but that created an issue at the end of the game which has been a constant for this year. Another parent and player was upset and said I took a players' last at bat away from him. It had nothing to do with that player but more about the other players getting an at bat. Coaching is hard. You can never please everyone. People see it how they want to see it, not how it actually is."

With the loss the Terriers finished the season at 15-9. They won eight of their last 11 games and won the Blue Ridge District tournament. Byrd will lose seven seniors, Minnix, Thompson, Hairston, Witcher, Ian Burnett, Blake Glover and Keller Spraker.

"Moving forward the players, parents, and coaches all have to be committed to the end result and process," said Taylor. "We were not this year. The team, players and coaches overcame a lot of adversity and found a way to win 15 games and be competitive in 20 of the 24 games. We were not consistent but found a way.

"The coaching staff did get two compliments, which came from two former head coaches toward the end of the season. They gave praise to our coaching staff for sticking it out, keeping the kids together and finding a way to win games."
