# Vinton real estate tax rates remains the same

Vinton Town Council members, including Mayor Brad Grose, Vice Mayor Laurie Mullins, and Council members Sabrina McCarty, Keith Liles, and Mike Stovall, adopted an ordinance leaving the current real estate property tax rate at \$0.07 per \$100 of assessed value. Deputy Town Manager Cody Sexton briefed council on the ordinance at a public hearing held prior to the vote. No public comments were received. Real estate taxes for 2025 are due on June 5 and

Council also adopted an ordinance setting personal property and machinery and tool tax rates at \$1.00 per \$100 of assessed value in 2025. No change was recommended for either tax. Council members voted to keep the tax levy at \$0.50 per \$100 of assessed valuation for one motor vehicle owned and regularly operated by a disabled veteran, subject to qualifications. Personal property taxes are due on May 31.

Prior to the regular council meeting, a work session was held to discuss the Fiscal Year 2026 budget. Sexton provided a "snapshot" of current FY26 budget preparations which department heads and staff have been working on diligently for several months. With the work session, they were seeking council's input on what the final budget should look like.

Sexton noted that revenue in the Town of Vinton has seen significant growth in recent years, due to consumer activity (mainly from the host of

# Appalachia Training Institute founded by three partners not interested in retirement

Interested in a job in the security field? Need to recertify for a security job already held? Want to learn the basics of handguns? Talk to Tom Akers and Selma Ferris, CEOs of Appalachia Training Institute (VA DCJS #88-10749) in Vinton. They are licensed by the Virginia Department of Criminal Justice Services.

"Bridging the Gap between Knowledge and Wisdom" is the core principle behind their business. (Their business sign is a photo of a bridge in Appalachia, one of Akers' favorite places.)

They say they believe in "delivering toptier training to both new and experienced security professionals. Whether they work as security officers, private investigators, or special conservators of the peace, it's essential to ensure they are receiving the

best training possible.

Akers is the Senior Instructor and Training School Director for the company; Ferris is the Chief Information Officer. Akers' wife, Sharon, is the Chief Financial Officer. They incorporated their business in February 2024, located at 227 S. Maple Street in downtown Ferris and Akers met when she signed

up for a recertification class he was teaching. She was "impressed by how great an instructor Tom was; I learned so much-more than in any other class

I had taken."

At the time, she was a private investigator and security officer. She graduated in 1990 from Blue Ridge Community College with an Associate of Applied Science Degree in Engineering Technology but eventually began working as a security officer. Her boss suggested she enhance her experience by training in investigations, so she took the course to become registered and kept it renewed through the years.

Later she moved to Roanoke and began working for a private investigation firm handling personal injury cases. Her husband retired, and she chose to be voluntarily unemployed until October 2019, but still signed up to renew her registration for investigations in a training school, where Akers was her instructor.

Akers, a Navy veteran, was working as a fraud investigator for a local bank headquarters. Previously he had conducted investigations with retail and private security and was also a Special Conservator of the Peace (SCOP) at Roanoke College. He had also been the administrator of campus security at Virginia Commonwealth University, where his father had been a police lieutenant. He had served as a regional jail officer. He had also been a truck driver on and off since 1981 off and on, a photographer.

# Herdman shares her knowledge of Native

American culture, and Tai Chi as well as before the

Appalachian Cherokee Tribe is a 501(c)(3)community-based educational tribe. CAC members are descendants of the Cherokee people who once thrived in the area of what is today East Tennessee, East Kentucky, Southwest Virginia, parts of North Carolina, and southern West Virginia.

Their website defines their purpose as helping to support the communities the central Appalachian region through volunteerism and philanthropy and to keep the memory of their ancestors alive. "We want to remember them, as we know that their life was hard, and their true identity was considered shameful in this time of

American history." Since many descendants of the Central Appalachian Cherokee assimilated or died before the Indian

organization of the Dawes Rolls from 1899-1907 listing those accepted as Native American (a paper genocide), tribal membership is based on Native American blood quantum and/or family history (oral or documented).

Ren Herdman, who grew up in Vinton and graduated from William Byrd High School in the 1980s, is the CEO "Chief" of the tribethe first female to hold that position. Her interests and careers have expanded through the years. She started off as a radio and TV reporter and broadcaster (including as a meteorologist), magazine writer, movie actor, educator, martial arts instructor, member of the military, chaplain, author, and speaker living and working in many parts of the country.

Her goal seems to

make a difference in the world."

Although she now lives in South Carolina, Herdman frequently visits Southwest Virginia to share her knowledge, most recently through her program on "Native America: Tribes, Journeys." On March 29, she presented the program at the Charles Hill Community

Center in Vinton. Not only is Herdman an educator on Native American culture, she is also the highest-ranked, multi-ethnic martial artist in the world in her form of hand-tohand combat having earned a 7th-degree black belt. That led to another appearance at the community center in Vinton on March 31 for a class in Defensive Cane Tai Chi, adapted for the elderly in the community

where she lives. See **Herdman**, page 5

In 1995, the Town of Vinton celebrated the 40th anniversary of the Vinton Dogwood Festival. Attorney Bruce Mayer served as the president of the festival that year. The 1995 Dogwood Festival was held on a warm, sunny Saturday – April 29.

Mayer said that the trick to a successful Dogwood Festival was "the right mix of tradition and change. The Dogwood Parade is an expression of the American spirit."

In the early years of the festival (which originated in 1956), the Dogwood Queen had been selected from visiting bands by their student bodies. Then for a time, the Miss Dogwood Festival Pageant had been affiliated with the Miss Virginia and Miss America Pageants, but that relationship ended in 1994. In 1995, the Dogwood Committee decided to honor a William Byrd High School senior as queen, a tradition which has continued from then

In 1995, the queen was one of 10 seniors at WBHS selected by the Senior Class. The girls were interviewed by a panel of judges, who then named the new Dogwood Queen. Judges that year were former Vinton Dogwood Festival Queen and Miss Virginia 1984 Lisa Aliff, Vickie Damico, and designer Alberto de Bobe.

Christine Marie Grecus, the daughter of Robert and Marie Grecus, was chosen as the Dogwood Queen in 1995 and crowned by Parade Grand Marshal and country music recording star Tom T.

Her activities included interning at WSLS Channel 10 News, serving as anchorwoman of WBHS Video News, and running cross country as captain of the team. She was the MVP of the

track and field team at WBHS for two years, served as the high school newspaper editor, and was a member of the Beta and German Clubs. Her future plans were to major in communications at Virginia Tech and enter the field of broadcast journalism.

Grecus was crowned at noon at the Vinton War Memorial and honored with a luncheon.

Grand Marshal Tom T. Hall got his start in the Roanoke Valley. He moved to Roanoke in 1957 after serving his time in the Army, worked as a radio copy writer, and studied writing at Roanoke College. He wrote his earliest successful songs while living in Roanoke.


The Tootin' Terriers from William Byrd High School led the parade. The band from Staunton River High School won first place in the competition. The parade also featured some 200 members of the Kazim Marching Patrol in 40 vehicles with clowns from six states.

Dogwood Day activities included not just the crowning of the queen and the parade, but the traditional Antique Automobile Show, festival rides (a new addition at the Vinton Farmers' Market), and the Festival Foot Race (with 200 entrants).

The 1995 festival brought back the Art Show which had been on hiatus for several years. Fifty artists entered, including Vintonites Ethel Dickerson, Jim Reynolds, Patsy Crowder, Dorothy Doss, and Lois Boitnott Poff.

All weekend, Roland E. Cook Elementary sponsored the Franzen Brothers Circus, featuring elephants, lions, tigers, clowns, jugglers, and aerial

The parade was followed by a "jam session" featuring the "Load," meant to attract a young adult crowd, at the request of Mayer's 19-year-old daughter, Julie, who wanted to make the festival attractive to all age groups. Live music was also

# Vinton Oakey's hosts **Employee Appreciation Day**



The Wilbourn Saddle housed in the Vinton History Museum's collection was made by John Miller Saddlery Co. in Louisville, Ky., and was owned by Dr. Robert Hunter Garthright.

Born in Henrico County, Va., on April 4, 1858, Dr. Garthright studied medicine at the Medical College of Virginia and was regarded as one of the leading physicians in Southwest Virginia. He moved to the Vinton area in 1889 and faithfully served the Vinton community and surrounding areas as a physician for 55 years. Dr. Garthright was often referred to as the "Daddy of Vinton." Shortly before his death on May 2, 1944, he was credited with delivering his 1,939th baby! The bridge over the NS Railway tracks on Gus Nicks Boulevard was dedicated in his honor in 1952 by then Virginia Governor John S. Battle as the Garthright Memorial Bridge. Commission and Town Council, a former council member and former regional stormwater committee member. They are a diverse group of individuals offering a mix of backgrounds and experiences to ensure a well-rounded and inclusive approach to developing

Advisory Committee members are Keith Liles (a member of Town Council and the Planning Commission), Seth Wilkinson (property manager for the Roland E. Cook Lofts), Stephanie Brown Mead (property and business owner, property management company); Anthony Conner (property/business owner of the Conner Group), Jonathan Murrill (resident/property owner/ artist), James Wright (Vinton resident/ property owner/Star of Bethlehem Baptist Church), Ray Sandifer (longtime Vinton resident/property owner/ former Town Council member/citizen rep for RVTV), Tiffany Rawling (property owner/resident), and Kerry Werner (resident/property).

After a year of meetings and discussions, the consultants have zeroed in on 10 "vision elements" for the 25-year plan focused on the needs of the community, land use planning, and improvements to transportation. During their sixth official meeting on March 26, the Advisory Committee focused on prioritizing the "big, impactful" elements of the plan.

3TP Consultant Mike Callahan chose four potential actions for each vision and the committee prioritized them using the mentimeter app on their phones for polling.

Priorities chosen by the Advisory

- Vision 1: For "Keeping Vinton as a sociable and welcoming town" the vote was for "developing a master plan for town-owned properties both downtown and around the Vinton War Memorial" as the highest priority. There was an intense side discussion on modernizing the Charles R. Hill Community Center.
- Vision 2: For "Developing a thriving and authentic downtown" the top choice was "moving the post office and fire and rescue station out

of downtown." It was pointed out that the Post Office does not generate any revenue for the Town of Vinton as it is operated by the United States Postal Service.

- Vision 3: For "Making Vinton an Outdoor Recreation Hub," committee members considered building the greenway between Gish Mill and Vinyard Park as the top priority.
- Vision 4: For "Housing for All Phases of Life," members ranked modernizing zoning to support more housing townwide as most impactful.
- Vision 5: For "Safe Streets for All," committee members favored a "fill the gap" program for sidewalk construction. However, the exorbitant costs of sidewalk construction was a focus of the discussion.
- Vision 6: For "Becoming an Environmental Stewardship Leader," members ranked investing in landscaping, trees, and green infrastructure downtown to "reduce stormwater run-off and summer heat" as most important for inclusion in the plan.
  - Vision 7: For "Parks for All,"

developing a master plan for Gearhart and Glade Creek Parks was ranked as the highest priority.

Vision 8: For being "Adaptable," Advisory Committee members chose updating the town's zoning code to provide more flexibility of land uses in the areas on the vision map designated as "transform" and "revitalize." This zoning reform is a nationwide trend to remove obstacles from development.

Vision 9: For "Exceptional Town Services and Infrastructure," the committee's choice was to invest in green infrastructure to reduce stormwater runoff. There was discussion of the aging underground pipes in Vinton, many of which need to be replaced sooner rather

Vision 10: For "Connected and Collaborative with the Region," supporting improvements to streets connecting Vinton and downtown Roanoke was selected as most impactful to the future of Vinton.

Callahan sees the plan as "coming down the homestretch" and hopes to have the Vinton 2050 draft plan completed by the end of April.

During the presentation on Native America, Herdman spoke of her multi-ethnic background (she is Cherokee on her father's side of the family, Asian on her mother's), why so many who believe they have Native American ancestry are unable to prove their lineage, and her Christian faith. She brought with her many artifacts, some archaic, and talked about what they were used for and where they were found.

She brought feathers, which are considered to be very spiritual in Native American cultures, because birds fly closest to the creator. She brought a buffalo hairpipe bone chest protector, worn by warriors and a bone choker necklace, also representing warriorship. She displayed and explained a war club, a box turtle powwow shaker, Cherokee regalia and the

European influence on Native American clothing through

brought projectile points, gaming stones, scrapers, and innumerable rocks formed into many shapes with many uses. Stone was the one hard and easily found material the Indians had. Herdman says there are rock preforms (unfinished tools) scattered all around the area which "people don't know exactly what it is, but they know it's something."

She talked about the importance of blankets in Cherokee culture as related to the Trail of Tears. Native Americans used what they had so Cherokee jewelry generally used beads from seeds, nuts, shells found in the Eastern United States - not from turquoise found out West. Shells were also used as money.

Herdman noted that Native

Americans in the Roanoke area lived in longhouses, not tepees, adding sections as a family grew. She explained that Native American cultures are matriarchal - the women are in charge. And most of the roads throughout Southwest Virginia began as Native American hunting trails.

She said that in Virginia for many years it was actually "illegal" to be Native American you had to be classified as black or white.

As for the Cane Tai Chi session on March 31, Herdman visited the Community Center's "Eight Immortals Tai Chi Cane and Defensive Cane Class" several months ago, taught by Steve Garay. That visit inspired her to develop a form of the program which she is now teaching to the elderly in her tribe, a combination of Cane Defense and Korean Hapkido.

Herdman, with the assistance of Garay, demonstrated several different defensive using the cane, beginning with bringing the cane tip down on top of the assailant's foot, in their solar plexus or on their head. She emphasized the use of the waist in twists and thrusts, and urged participants in the class to vocalize while responding to an attack with screams, "ughs" and other frightful sounds.

She and Garay pointed out the advantages of always carrying a cane, which can go places a gun can't – and are legal on airplanes.

Herdman will be back in Vinton again at the end of April for the Vinton Dogwood Festival with the CAC Tribal Summit 2025. The organization will be setting up on the greenway by Glade Creek behind the Billy

Byrd Apartments for tours along the creek "where Native Americans have left their mark.' Local artifacts will be on display, some found in the Glade Creek

The dates are Friday, April

25, with tours at 10 a.m.,

1 p.m., and 5 p.m. and on Saturday, April 26, with tours at 10 a.m. and 12 noon, with presentations by members of the tribe after the tours. At 2 p.m. on Saturday, the 26th, CAC members will be

participating in the walking Dogwood Festival Parade. There is ample parking in the lots and by the walking path. Also, on the day of the

Dogwood Festival, Garay and his class will be doing a Tai Chi performance in observance of World Tai Chi Day at 10 a.m. in the parking lot behind Vinton Baptist Church.

He holds a VA DCJS instructor certification as well as a VA DCJS registration for private investigator.

Sharon Akers studied accounting and banking and finance at Virginia Western. They met Ferris and began the discussion about opening a business together.

In Virginia, becoming private investigator is primarily about meeting DCJS requirements. Applicants must be at least 18 years old, clear a background check and pass a 60-hour private investigator course with at least a 70% score. After completing the course, they can receive their registration and begin working in the field. Opening a private investigation agency requires additional steps, including securing a business license and registering with the State Corporation Commission. After much discussion, in late

2019 the three decided to go into business together as private investigators. Unfortunately, that was just when the COVID pandemic hit, bringing with it lockdowns and quarantines. However, the pandemic also

increased the need for moving goods, so they modified their plans to fit the situation they were presented with. In lieu of obtaining their CDL licenses they decided to open a business (Tea2Sea Transport) using a cargo van-a 2019 Mercedes-Benz sprinter van.

They partnered with a secondary company to provide "last mile delivery" service transporting office goods to homes and businesses. There was little traffic on the road during the pandemic, but it was hard to find an open restaurant. Fuel prices were increasing; the challenges were mounting, so the discussion was revived about private investigation work.

They sold the van and started Tea2Sea LLC (VA DCJS Business License #11-19986) in May 2022, mainly doing background investigations, quick clean deed scans, skip tracing for attorneys and creditors, fraud investigations, and heir vetting. (Ferris is a genealogist and used to researching family trees.) They used the Akers' home in Vinton as their base to bypass costly office rent. The Town of Vinton assisted with rezoning.

They have retained the Tea2Sea, LLC, private investigation business, addition to establishing the Appalachia Training Institute in

Appalachia Training Institute provides proper security personnel education and offers the most up-to-date, instructorled training, which includes real-life experiences and roleplay scenarios. İnstructor-led sessions

provide personalized feedback and hands-on experience, allowing students to learn directly from veteran security professionals. Role-playing allows students to experience real-life scenarios in a controlled setting. These exercises increase awareness and improve decisionmaking skills under pressure.

Their game plan with the training institute is to offer courses not only in Vinton (there are two training rooms in their building on Maple) but throughout Southwest Virgina. Akers says that is what sets them apart from other training schools—their willingness to travel and teach courses after hours (on weekends and evenings), either at a business or another venue, enabling students not to be absent from

work for training. They have a mini-academy

coming up starting on April 7, for those interested in entering the private security field who would like to become an armed security officer. The academy includes: Unarmed Security

- Officer Entry-Level Core Subjects, scheduled for April 7-8 from 8 a.m. to 6 p.m. each Armed Security Officer
- Arrest Authority, scheduled for April 9 from 8 a.m. until 5 p.m. Security Officer
- Handgun, scheduled for April 10-12, from 8 a.m. until 5 p.m. Courses they currently offer are Security Officer Core Subjects (entry and in-service

level), Private Investigator (entry and in-service level), Arrest Authority, Special Conservator of the Peace (entry and in-service levels), Entry level Handguns, Handgun Re-qualification, Shotgun (entry and re-qualification) and Security Officer Handgun Course (entry level). They also have a new night

course coming up on April 23. The class, titled "Advanced Report Writing," will be held from 5 p.m. to 9 p.m. This course is not just for security; it is also beneficial for those in other employment sectors, particularly to enhance your

Appalachia Training Institute also conducts trainings that are not Division of Criminal Justice Services, such as how to prepare for emergencies, classes for concealed carry firearms, what to do during a natural disaster, or preparing home security checklists. Ferris and Akers set up a booth at the recent 2025 Vinton Senior Expo to make senior citizens and their caregivers aware of the services they provide.

Akers says they generally require a group of five to arrange a class which usually costs \$50 for four hours.

## Dent strikes out 11 Titans in win




