William Byrd Middle School students enthusiastically shared their science projects with families, friends, and the community at the second annual Science Showcase on Jan. 22. The showcase is preliminary to the Roanoke County Science Fair held in early spring.

WBMS Science Dept. Chair and life science teacher Erin O’Donnell said that the showcase “features advanced science students who research and design experiments based on topics of their own selection, sharing them with the community.” This year approximately 140 students participated in the event. The experiments themselves are all conducted outside

of school. Many adults remember science fairs with tall display boards which demonstrate the hypothesis, the scientific process used, the results, and the conclusions reached. This science showcase instead involved creating PowerPoint

presentations (in school) on laptop computers—more economical, manageable, and readily available to students than the displays.

At the Science Showcase, students set up their laptops on cafeteria

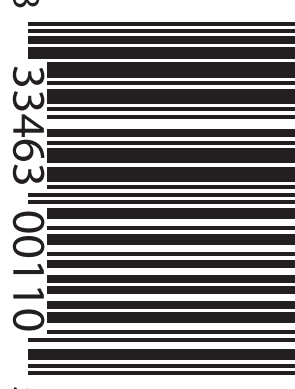
## Vinton First Aid Crew installs officers for 2026

## From the Pulpit

### The Battleship Series

There is a stark difference between a cruise ship mentality and a battleship mentality that goes on within the church. In the heat of battle, no battleship survives with idle crew. Every hand is needed—on the bridge, in the engine room, manning the guns, or even scrubbing the deck. One missing role can sink the ship.

The same is true in the church. God has placed you in a local church not as a passenger, but as indispensable crew, and He's entrusted you

with a specific gift to keep the mission moving forward. 1 Corinthians 12:22 declares a surprising truth: "those parts of the body that seem to be weaker are indispensable." The roles we overlook—the quiet prayer warrior, the behind-the-scenes helper, the one who sets up chairs or sends an encouraging note—are often the very ones holding everything together.

Jesus illustrated this in the Parable of the Talents (Matthew 25:14–30). The master entrusted different amounts to his servants—five, two, one—according to

their ability. The faithful ones invested boldly and doubled what they received. The fearful one buried his talent and lost everything. The master's praise wasn't for the largest return, but for faithfulness: "Well done, good and faithful servant!"

Your gift—however modest it feels—isn't for you to hoard. It's ammunition for the kingdom's advance. Use it this week: serve, encourage, give, pray, show up. The whole church grows stronger when every part does its work. You matter. Your role counts.

## Dollhouses galore

A walk through the upstairs of the Vinton History Museum will allow you to behold the sight of dollhouses galore—such as the cute two-story house from the 1950s pictured here.

Dollhouses have an interesting history, first being made in the 16th century as display pieces for wealthy families to make replicas of their homes.

It was only by the 18th to 19th centuries that the idea turned from wealthy replicas to toys for young girls. These toys were also valuable in teaching these young girls about household management and societal expectations.

It was after World War II, when

plastic became readily available, that dollhouses were mass produced and became a much-beloved children’s toy. These dollhouses were easy to assemble, functional, and featured bright colors and clean lines.

Visit the Vinton History Museum to see the many dollhouses on display every Monday, Wednesday, or Friday from 10 a.m. to 2 p.m. at 210 East Jackson Avenue in downtown Vinton. “Vinton History Museum – Preserving the Past for the Future”

# RECIPES OF THE WEEK



Rosemary Chicken Pasta with Focaccia Bread

We recently ate at Farina, an Italian restaurant in Raleigh, and had Rosemary Chicken Pasta. It was so good that I googled the recipe when we came home and found several variations, which I have combined, along with a shortcut recipe for Focaccia Bread.

### Rosemary Chicken Pasta

**Ingredients:**  
8 ounces Orecchiette Pasta (looks like little cushions)  
2 Tbsp. olive oil  
1 pound boneless, skinless chicken breast, cubed  
3 cloves minced garlic  
1 Tbsp. fresh rosemary chopped, or 1 tsp. dried rosemary  
1/2 tsp. red pepper flakes (optional)  
1 cup chicken broth  
1/2 cup heavy cream  
1/2 cup grated Parmesan (some recipes call for goat or feta cheese)  
Salt and pepper to taste  
(You can also add mushrooms, sauteing them with the chicken or a vegetable like peas or sautéed asparagus.)  
Cook the pasta according to package instructions until al dente. Drain and set aside. Heat olive oil in large skillet

and add chicken. Cook 5-7 minutes. Add garlic and herbs. Incorporate broth, let simmer for 3-5 minutes. Stir in cream. Cook on low for 2-3 minutes. Add parmesan cheese. Stir until melted and creamy. Combine with pasta in skillet. Season with salt and pepper to taste. Add red pepper flakes if desired. Garnish with parsley.

### Shortcut Focaccia Bread from refrigerated pizza dough

1 lb. refrigerated pizza dough (usually found in supermarket deli section)  
1/4 cup olive oil  
1 tsp. sea salt  
Grease deep cookie sheet with a tablespoon of oil and place dough on it. Stretch dough as best you can. Cover with plastic wrap in warm place for an hour (like in your oven with just the oven light on). Preheat oven to 400°. Remove wrap and stretch again. Add 2-3 Tbsp. oil on top of the dough and spread it around evenly. Dimple top of dough with your fingers. Add additional toppings if desired, (rosemary, minced garlic, Italian seasoning, sundried tomatoes, etc.). Bake for 22-28 minutes until golden brown with slightly crisp edges. Allow to cool 5-10 minutes. Cut and serve.

## Learn to declutter—join the Downsizers Club

The Town of Vinton is hosting a new program, the “Downsizers Club,” on the first Wednesday of each month for those hoping to create a simpler, more manageable living space in their homes. The group is meeting at the Charles R. Hill Community Center at the Vinton War Memorial complex from 10 to 11:30

a.m. Leader Beth Powell, Senior Home Coach with “Home with Heart” describes the club as a “monthly, supportive community designed for experienced adults who want to declutter, downsize, and plan their next chapter with confidence.”

The group will be meeting on Feb. 4, March 4, April 1, May 6, June 3, July 1, August 5, Sept. 2, Oct. 7, Nov. 4, and Dec. 2.

Powell hosted an introductory session on January 21. It was a “get to know you” time, more than a class. Everyone who attended had one thing in common: “too much stuff, that you can’t take with you.” As one member of the group said, “you don’t see too many U-Hauls behind a hearse.”

Each month the group will focus on a slightly different topic. Powell’s advice initially as the first step on the low-pressure roadmap to a downsized, decluttered home is “to get rid of trash and broken stuff.”

The first official session is coming up on Feb. 4 where the focus will be on a “decluttering reset”: start small, reduce the visual noise in your home, and set up routines that stick.

“Rightsizing your space” follows in March with tips on what to keep, what to let go, and how to match your home to this season.”

The task at hand in April is on “paperwork and peace of mind,” with suggestions on getting your important documents organized and easy for your family to locate. As one member of the group put it, “don’t leave a mess behind for

your family when you pass.”

The dilemma faced in May is “what to do with ‘the stuff.’” Donate, sell, gift, or toss? If your family isn’t interested in saving family keepsakes, perhaps you can find someone else who will appreciate them.

In June, group members advance to making their plan. July is all about “memories and heirlooms,” what to do with photos and keepsakes, how to pass things on to others while you can, and having a say in where your belongings go.

The topic for August is planning for “Aging-in-Place,” without pressure or deadlines.

In September, downsizers will be weighing their housing options—staying in place, moving to the “right-size” space, moving closer to family, or exploring supportive living.

In October, the group will concentrate on how to talk with your adult children without conflict or pressure.

November centers on staying clutter-free once you have achieved your goal; establishing simple systems so the clutter doesn’t creep back in again.

The year ends with a celebration, a reflection on gains, simplifying routines, and planning for the year ahead.

The group that met on January 21, was enthusiastic and came with suggestions for downsizing they had already discovered—digitizing photos instead of cluttering the house with paper ones, where to find recycling centers, which consignment shops had the best deals and were the most

honest, auction houses with the best reputations, selling online, where to find others with a passion for the collectibles you so love, how to provide for the care of your pets when you pass, the necessity for wills and powers of attorney, determining if you truly have a use for an item or is there someone else who can use it more?

Many in the group admitted to being paralyzed by facing the clutter in their homes and reluctant to tackle what seems like an “insurmountable task.”

Some might question why a “Downsizers Club” would be helpful—why not just take yourself in hand and declutter on your own. One answer is that being part of a group will help you stick to your goals; being accountable is part of the program, with monthly reports on the progress you have made.

Powell says what you will get is:

- A supportive peer community — you’re not doing this alone
- Personalized guidance and expert support
- Hands-on education and practical tips
- Simple monthly action steps to keep you moving forward
- Member wins and success stories for motivation and encouragement

In addition, if the first meeting is any indication, you’ll get to meet a lot of funny, feisty, well-spoken individuals who share a common interest.

# House passes transportation bill securing \$17 million for I-81 improvements

This week, the U.S. House of Representatives passed the Fiscal Year 2026 Transportation, Housing and Urban Development (THUD) appropriations bill, taking the next step toward securing \$17 million for long-needed safety and capacity improvements along Interstate 81. This latest investment, secured by Rep. Ben Cline, will support critical upgrades and potential widening along the corridor and reflects his advocacy for Virginia’s Sixth District through the House Appropriations Committee. The bill is awaiting final approval in the Senate.

“For years, residents of Virginia’s Sixth District have told me how dangerous and congested I-81 has become,” said Rep. Cline. “This bill’s passage out of the House puts us one step closer to critical improvements that will make I-81 safer, more efficient, and better equipped to serve commuters, families, and the truck drivers who keep our regional economy moving. This is a meaningful step toward delivering the reliable interstate our communities along the I-81 corridor deserve.”

The I-81 Corridor handles an enormous volume of freight and

passenger traffic. Each year, more than 12 million commercial trucks travel along the interstate, moving over \$300 billion in goods. As traffic increases, so does the need to modernize the highway to support on-time delivery and reduce disruptions that hurt both local businesses and national commerce.

Originally built over 50 years ago, I-81 has not kept up with growing traffic and freight demands. A 2018 state report identified urgent needs along the corridor, and while Virginia has taken important steps to address them, additional federal investment is

necessary.

Travel delays are becoming more frequent and unpredictable, impacting both freight movement and personal travel. To help fix this, Virginia’s Interstate 81 Corridor Improvement Program (CIP) includes plans to widen the road from two to three lanes in critical sections. These upgrades will reduce congestion, create more room for emergency response vehicles, and lower the risk of crashes by allowing more space for vehicles to maneuver.

tables, some bringing tangible objects they used in their experiments, and presented their research to those who attended, including the judges, explaining why their hypotheses were correct or incorrect.

Again this year, the judges interviewing participants were advanced science students from William Byrd High School. They assessed the projects and will help determine who advances to the next level.

Students selected to present at the county science fair will transfer their research from their computers to traditional display boards for that event.

In his project, seventh

grader Cormac Brady tested guitar picks made of different materials to determine if a metal or harder material would have the highest tone and give the guitar a tinny and echoey sound, while a felt or softer material would have the lowest tone and give the guitar a muffled sound, with other materials falling in between. His materials were his Yamaha acoustic guitar, a decibel meter, and a sound analyzer app, in addition to picks made of felt, rubber, plastic, wood, nickel, cardboard—and his thumb.

Brady says that he chose this project because he wanted his experiment to test something he loved and he loves music. He

determined the quietest room in his house and tested each pick 10 times. His results proved his hypothesis correct—harder materials had a brighter sound compared to softer materials.

Mia Hayslett (who won first place in sixth grade in last year’s WBMS Science Fair) swabbed various surfaces from around the community with Q-tips and cultured the samples in petri dishes to see which microorganisms, and how many, grew after five days. She was inspired by a discussion with her father about the cleanliness of her brother’s hands. She swabbed her dogs’ noses, her family’s noses, changing tables in public restrooms, public

play areas, escalators, water fountains, door handles, arcade games, claw machines, food court tables, shopping carts, self-checkouts, elevators, and mall trains. Hayslett says she has always wondered if there were bacteria on everyday items like door handles of bathroom stall locks or anything else. Results indicated that of all the surfaces she swabbed, changing tables and play spaces were the worst for bacteria presence and growth.

Eli Copening researched different types of fishing line to determine which is strongest and can hold the most weight. His answer: monofilaments more

so than fluorocarbons or braided lines. This seemed to be due to its diameter, high tensile strength, and superior abrasion resistance. He chose this project because he enjoys fishing.

Teagan Doss, a Floyd Ware tap dancer, tested different types of flooring (tile, plywood, carpet, cement, and soft dance flooring) to determine which one would cause the loudest sound in dancing wearing tap shoes. Jaxon Donnelly experimented with wood turbines to determine the effect of the number of blades on speed. Brenton Bailey and Abigail Schaefer in seventh grade tested the absorbency of several types of paper

towels. Schaefer’s results showed Brawny to be the most absorbent brand, while Bailey’s experiment found Bounty to be best.

The WBMS Science Showcase was once again impressive not only for the research conducted but the articulate explanations provided by the students participating.

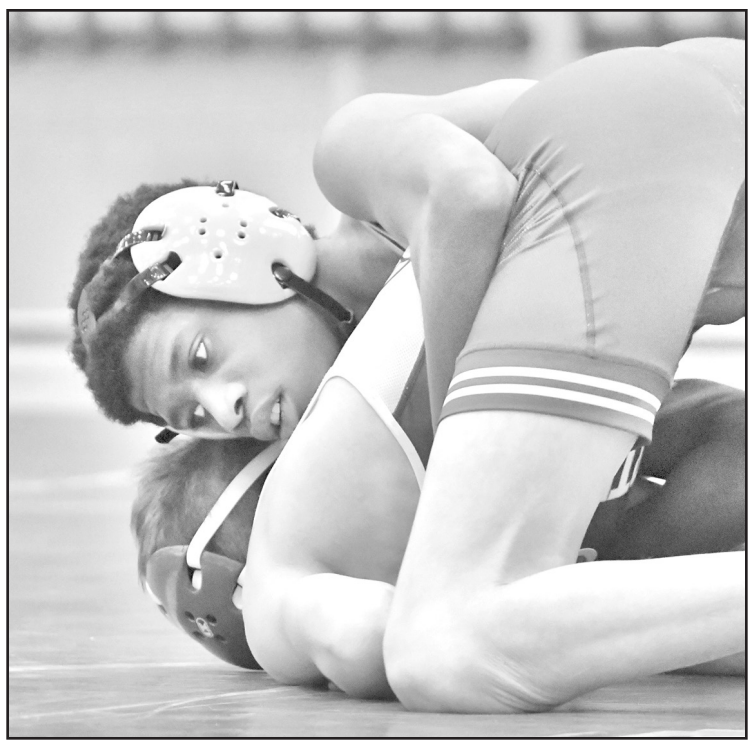

Others joining host Glenvar will be Christiansburg, Salem, Hidden Valley, Northside, Galax, William Fleming, Rural Retreat, Union High, Central of Woodstock, Holston, Lebanon, Chatham, Parry McCluer, Grayson County, Floyd County, George Wythe, Heritage of Lynchburg, Liberty of Bedford, Pulaski County, Grundy, Carroll County, Patrick County, Jefferson Forest, Martinsville, Radford and Washington High of West Virginia.

The Terriers haven't been on the mats this week with school closed due to last week-end's winter storm. Byrd was weathered out of a trip to Ocean Lakes, VA for the John Kelly Invitational last weekend and the last action for the Big Orange was on January 21 at William Fleming High School when the Terriers wrestled Northside and Staunton River on the Colonels' mats. Fleming also wrestled those two but did not wrestle Byrd.

The Terriers swept both Northside and Staunton River. The Eagles sent many backups to the mat so Byrd had an easy win there, but Northside was a battle to the end and then some. The match ended with the score tied at 42-42 and went to tie-breaking criteria. It went all the way to Criteria J after A through I, a total of nine different criteria, all came up tied. Byrd ended up winning the match by virtue of more "near fall points."

"In all my years in wrestling that's the farthest I've ever seen one go with criteria," said Byrd coach Thomas Kessler.

The Highlander Invitational is the last scheduled event for Byrd before the Region 3D tournament on February 7.

Last week the Terriers made the trip to Bedford to swim against Staunton River and Liberty High Schools at the Bedford YMCA. It proved to be a good trip for the Byrd swimmers as they swept both schools. The boys beat Staunton River 117 to 34 and Liberty 124 to 10 while the girls beat Staunton River 86 to 20 and downed the Minutewomen 82-58.

"It was a good meet," said Byrd coach Martin. "I was proud of my swimmers for cheering loud at the end of each other's lanes."

ning the 200 Medley, Keith Shult, Parrish, Madonna and Martin taking the 200 free and the foursome of Drayven English, Tristan Blevins,

Graham Payne and Ben Hoyos touching the wall first in the 400 free.

For the girls, Kayleigh Barber, Hadyn Terrell, Lindsay Murtaugh and

Gabby Romeo won both the 200 medley and 200 free relays. Individual double winners included Romeo in the 200 and 100 free, Terrell in the

## Terriers split two overtime games

*Foster's last second three sends game into OT for win over Glenvar*

William Byrd basketball fans got their monies' worth last week as the Terriers gave them extra basketball in two games. The Terriers split two overtime games, defeating Glenvar but falling to Staunton High.

Last Wednesday, January 21, the Terriers hosted Glenvar in an intra-Roanoke County battle and it took an extra period to decide before Byrd took a 78-71 win.

"Great game to watch," said Byrd coach Brad Greenway. "I was proud of the way we bounced back after a pretty rough game prior to that(20 point loss to Hidden Valley). We have some guys who are making strides as competitors and basketball players. That's a testament to their will to keep showing up on a season that has been filled with adversity so far."

Glenvar led 17-13 after the first quarter but Byrd outscored the Highlanders 20-12 in the second quarter to take a 33-29 halftime lead. Byrd led by two, 46-44, after three but the Highlanders went on a run and had a three point lead with five seconds to go. However, David Foster hit a three point shot out of a time out to send the game into overtime and Byrd pulled out the win in the extra minutes.

"One of those plays you'll never forget," said Greenway of Foster's shot. "Was great to see and happy for him. We played a solid overtime period and closed it out."

Foster finished with a game-high 31 points after having five at the half. He drained seven threes for the game and scored 12 points in the overtime period after tying the game with his big shot at the end of regulation. Luke Helton also had a big game, recording a "triple-double" with 13 points, 11 assists and 10 rebounds.

On Friday night the Terriers played Staunton High in the "Rock the Ribbon" event at Rockbridge County High School. It's a two-day event to raise money for the American Cancer Society with four games on Friday night and seven on Saturday.

Staunton came in at 12-2 but the Terriers were on a high after the big win over Glenvar and raced to a 27-15 halftime lead as Moises Leon scored 13 first half points. Byrd still led 42-34 after three periods before the wheels fell off.

"We controlled the game for three quarters," said Greenway. "They got it rolling in the fourth a little bit and then we helped them with an unfortunate and incorrect technical (foul) call, in my opinion. One of our guys Westwood the ball to a Staunton player after hitting a layup. The Staunton player caught the ball around his chest area and went to throw the ball in. The ref anticipated, or saw something that I just don't see, and called a tech on our guy for giving them the ball. Sometimes these things happen. Tough lesson to learn for all parties involved."

At the time Byrd was up six points with just 1:45 to go. Staunton hit the Technical Foul free throws, and on the ensuing possession they scored an "and-one" bucket on the inbounds play for a quick five points.

"We didn't respond well after that and Staunton finished it out in overtime," said Greenway. "That's on me. We should have found a way to respond better. I appreciate our guys grinding it out on the road against a good team."

Staunton outscored Byrd 12-5 in the overtime period for a 68-61 win. Jesus Leon, Moises Leon and Foster led Byrd with 15 points each, Foster with five threes, and Helton had 14.

With the loss the Terriers fell to 3-12 overall and a night later had a game at Staunton River postponed by bad weather, and this week they had home games with Northside and Christiansburg iced out. The next game is scheduled for Friday at home as the Terriers will host a doubleheader with the girls against William Fleming, weather permitting. The girls are scheduled to play at 5:30 pm with the boys to follow.

## Austin's long jump is fourth best ever for Roanoke College indoor team

T.K. Toney of the Roanoke College indoor track team won the high jump, DeShawn Austin was ninth in the long jump and the Maroons produced several other strong finishes in a loaded field at Liberty University last Friday.

Toney won his flight of the high jump with a mark of 2.00m. That height ranks second in Roanoke history, and Toney is currently tied for 18th in NCAA Division III. Cody Roupe logged a jump of

1.85m to finish in fifth place.

Toney also set a personal record in the triple jump, landing in 26th place at 12.72m. That mark ranks ninth all-time for the Maroons.

Austin, a freshman from William Byrd High in Vinton, came in ninth in the long jump with a leap of 6.68m. His mark ranks fourth in program annals, and he now sits in eighth place in the South Region.

Herndon placed seventh in the 5,000m with a personal-record time of 19:29.37. That mark ranks eighth in program history.

The Maroons' 4x400 relay team of Lindsey Hobin, Mae Kaufman, Maryrose Molina-Shuman and Ophelia Ladner landed in 13th place overall with a season-best time of 4:01.16, which is good for sixth in Roanoke annals. The quartet finished second among Division III relays in the race, and their mark currently leads

the ODAC and ranks third in the South Region.

William Byrd grad Sarah Fuchs came in 19th in the weight throw, logging a distance of 13.93m. She also finished 25th in the high circle flight of the shot put with a mark of 10.41m.

This weekend the Maroons are back home to host the Bast-Cregger Multi Invite at the Kerr-Cregger Indoor Fieldhouse in Salem. It's scheduled for Friday evening and Saturday.
