TERMS OF USE

Thank you for visiting the Movin'On Summit official website!

C2 International Inc. (the "**Company**") produces the event entitled "**Movin'On Summit**" on behalf of Le Fonds de dotation "Movin'On Sustainable Mobility Fund" (the "**MOSMF**") and for which Manufacture Française des Pneumatiques Michelin, acting for and on behalf of the subsidiaries of la Compagnie Générale des Établissements Michelin (collectively, "**Michelin**") is a founding partner, and related activities, programs and events (collectively, the "**Event**").

In connection with the Event, the Company operates the website <<https://summit.movinonconnect.com/>>, which is owned by MOSMF (collectively, the "**Site**"), including all information, documents, text, audio, visual, and graphics on the Site (but excluding Third Party Materials as such term is defined in clause 10 below) (collectively, the "**Site Materials**"), the whole available for your use subject to the terms and conditions set forth in this document, as may be revised from time to time (collectively, the "**Terms of Use**").

1. Parties; Complete Agreement. The Terms of Use, together with the Event Privacy Policy and the other agreements, guidelines, policies, licenses, disclaimers posted on the Site constitutes the entire agreement between MOSMF and you (the "**Complete Agreement**") regarding your access to the Site and Site Materials. If you are accessing the Site or Site Materials on behalf of a third-party (such as your employer or an organization), then you may only do so if you are able to bind that third party to the Complete Agreement.
2. Additional Contracts. Your purchase of goods or services (for example, access to the Event), is subject to additional contracts other than these Terms of Use, and those additional contracts prevail over these Terms to the extent of any contradiction or inconsistency.

21. Applicable Law; Exclusions of Codal Articles. These terms are governed by the law of Quebec, however the following articles of the Civil Code of Quebec are hereby excluded: 1468, 1469, 1473, 2125. The *UN Convention on Contracts for the International Sale of Goods* is totally excluded.

22. Third Party Beneficiaries. The following parties are third-party beneficiaries of the limitations of liability and disclaimers of warranty contained in these Terms: MOSMF and the Company's respective employees, volunteers, officers, directors, agents, licensees, partners (including but not limited to Michelin), sponsors, suppliers and advertisers. For greater certainty, this includes any event-production company and its staff who might be engaged by MOSMF or the Company to produce or run the Event.
23. Choice of Forum. Any dispute arising from or in connection with these Terms, your use of the Site or the Site Materials shall be submitted the exclusive jurisdiction of the Courts of Quebec sitting in the judicial district of Montreal.
24. Language. The parties have expressly required that the present Terms and associated documents be drawn up in the English language. Les parties ont expressément stipulé que le présent contrat et les documents connexes soient rédigés en langue anglaise.
