
#### LEBARON BRADFORD COLT.


#### ARTHUR LEWIS BROWN,


#### JOHN HENRY STINESS.


#### WILLIAM W. DOUGLAS.


#### EDWARD CHURCH DUBOIS.






#### THOMAS DURFEE.


#### CHARLES MATTESON.

HORATIO ROGERS.




CHARLES AUGUSTUS WILSON.


#### CLARENCE A. ALDRICH.


#### EDWIN PIERCE ALLEN.


#### SAMUEL W. K. ALLEN.


#### HERBERT ALMY.


#### WALTER F. ANGELL.


#### HARMON SEELEY BABCOCK.


#### ALBERT A. BAKER.


#### BENJAMIN BAKER.
