#### THE SOCIAL SECURITY SCAM

The purpose of Social Security.

Let me explain the social security act, the nexus agreement we all have with the king, you were told the social security number is for retirement and you had to have it to work. It sounds like a license to me...and it is. It is a license granted by the president of the U.S. and the queen of England to work in these countries with the U.S. under the trading with the enemy act, as amended on March 9th 1933, as you will see in a moment. The question is, was it for your retirement? What does FICA mean? Federal Insurance Contribution Act? What does contribution mean in law.

Bank - An organisation that is engaged in the business of banking. The term includes savings, banks, savings and loan associations, credit unions and trust companies. UCC 9-102 (a)(8)

Banker- In general sense, person that engages in the business of banking. A narrower meaning, a private person who keeps a bank.

Bar- A partition or railing running across a courtroom. The word BAR is also an acronym which stands for British Accreditation Registry, which means all attorneys in America are collecting money for the British Crown.

Don't believe... read for yourself, article 1 of the Constitution, an esquire is an English gentleman aka squire that collects money for the crown.

File number means the number assigned to an initial financing statement pursuant to subdivision.(a)Of section 9- 519.UCC 9 - 102. (a)36

Financing statement- A record or records composed of an initial financing statement, UCC 9-102(a)39, in some cases the county auditor that details the money / and or goods pledged by one party to guarantee the fulfilment of an obligation to another party.

Notice of Understanding and Intent and Claim of Right

Dear DVLA.

Please read the following notice thoroughly and carefully before responding. It is a notice. It informs you. It means what it says.

It is important that you consider and respond to the notice in substance. The 'nearest official form' will not suffice, and consequently is likely to be ignored by Myself without any dishonor on my part.

On the other hand, there is a time-limit on the notice served. It is reasonable, and if it runs out then I shall take the understanding that you are in agreement with the points herein stated and that you have no objections to any or all of the points contained herein in full accordance with my Rights in Law.

It is my understanding that notice to one is notice to all. Should you not be in a position to respond with clarity to the points stated herein it is my understanding that an officer of your choosing will be delegated the task of response and the name of said person will be made known to Myself.

For these reasons it is recommended that you carefully consider this notice and respond in substance, which means addressing the points raised herein.

Failure to respond to this offer and to do so completely and in good faith within 14 (fourteen) working days will be deemed by all parties to mean you and your principal or other parties agree in full to the points made herein and wholeheartedly accept this claim.

I now draw your professional attention to the following points wherein "DVLA" should be taken to read "the DVLA or any associated agency".

It is my understanding that when a thing becomes registered with a body, the body it is registered to, or with, takes title ownership of said thing. It is my understanding that in this case the thing in question is a device for use to aid roaming commonly called a vehicle by the DVLA.

It is my understanding that a person who registers a vehicle gives up the right to own the vehicle in exchange for equitable title, i.e. the right to keep, or look after, or store, or use what is now in point of fact, the property of DVLA.

It is my understanding that in doing so the keeper must abide by the rules of society or corporation or body to which the vehicle is registered.

Consequently it is my understanding that subsequent keepers are not owners. As stated in section C4c of the registration certificate which states: "The registered is not necessarily the legal owner."

It is my understanding that this vital information is not fully and plainly disclosed on the contract known as the V5 Registration Certificate. For a contract to be valid it must contain FULL disclosure. It follows that since this vital information is not shown clearly on the contract it must be deemed that the contract is null and void.

It is my understanding that upon 1st registration a vehicle known as JB13 BKZ was registered with DVLA

It is my understanding that DVLA took title ownership of the vehicle known as JB13 BKZ at the moment of 1st registration.

It is my understanding that when the vehicle came into possession of Myself, believing to be the new owner, I was in point of fact only buying the right to use and not the right to own the property of DVLA and that this vital information was kept from being disclosed to Myself on the contract.

#### In consequence:

I hereby serve notice and state clearly, specifically and unequivocally, that under the laws and customs of England, which Her Majesty Queen Elizabeth II has sworn to protect, I make claim to what is rightly, justly and lawfully mine.

I claim full lawful rights, allodial title and ownership of the conveyance known to DVLA as JB13 BKZ, in my possession and the use of it freely on roads and highways and on private land, acting with reasonable care and responsibility to 3rd parties so long as I am not acting or involved in commerce. (Commerce being defined as buying and selling of goods for the benefit of the operator of the conveyance).

I claim full lawful rights, allodial title and full ownership irrespective of any faulty understanding as expressed above.

This communication is in violation of the above rules of the postal union. Therefore this correspondence has now been forwarded unopened to the postmaster general for her to administrate the matter and she will be dealing with it in due course. Instruction 1- Go to www. Fedility.com. This page should look like the following page.

Instruction 2 - you will see a tab in the upper left-hand corner, the tab for RESEARCH. Click on it and then click on the QUOTE option

Instruction 3- at the top of the page you will see DELAYED QUOTES. Click on SYMBOL LOOKUP.

Instruction 4- Take the number of the court case, Birth certificate or the social security number and the red cusip number at the back of the social security card and place it in the box. Make the search by mutual fund and fund number,

Click on the Search button. For social security & red cusip numbers a new cusip number will appear on the page. This is the number that is on the bond the social security account is linked to.

Instruction 5- Write down the cusip number and then go back to the previous page that had delayed QUOTES at the duplication, the option that is spelled here. The sentence should read "to quote or look up a bond click here".

Instruction 6- You will be directed to a page that allows you to put the CUSIP number in a search on the left side of the page. Press go.

Instruction7-What will appear next is a page that says BOND RESULTS. Near the middle of the page, you will have 2 options. One is for contact to call a rep who can explain questions about the bond, click or call rep to get the phone number. The next one will tell you who is holding the bond. Click on this option that is below description

It will tell you whether the bond is annual or not, the maturity date which is when the payment on the bond or IOU is due, whether there is a call protection. A yes on call protection means you cannot call in on the bonds if you are owed. Social security bonds will always say this because you cannot collect until maturity, which is retirement or disability. Anyone on the movement for "sovereignty" giving you advice that you can in on this bond is directing you to trouble and

legal and lawful problems. Instruction 9- Next Click on the initial trading company Name SYMBOL this will give you all the trading information about who is trading on the fund your birth certificate is a part of this document was created when you were an infant. Commercial law allows for you to cancel and rescind this simple contract UCC3-203and to make a claim in recoupment [ Reparations] for fraud committed upon you when you were an infant [SeeUCC3-305].

Instruction 10- Next you can look up any court cases type in the court case numbers of the federal, state, or municipal entity. A cusip number will appear which tells you the bond is on record with a clearing house agency of the federal government most likely the depository trust clearing house corporation or one of its subsidiaries after you get the case click on the symbol to see the present trading.
