Week 1 - Camp Penuel Health Guidelines*

***Guidelines are subject to change**

Please note:

- Only **full-time** (Monday, August 2nd - Friday, August 6th) participants will be allowed to attend in person. We will not be able to accommodate part-time YP or serving ones.
- We request that each locality maintain a 4:1 ratio between YP and SOs of the same gender (ex. 4 YP sisters should have 1 SO sister)

Before Arrival

- Every participant (YP and SOs) must:
 - Complete the 2021 Northeast SST Registration Form
 - Complete with signature- the 2021 Northeast SST Medical Form
 - Bring proof of vaccination OR a negative COVID-19 Test Result.
 - COVID-19 Tests should be taken within 3 days (72 hours) prior to arrival
- **COVID-19 Vaccination** is NOT required to attend. All medical information will be kept confidential and managed by the medical team
- If a participant is not vaccinated for COVID-19, it is highly recommended that they wear a mask at all times other than eating, sleeping, or outdoors when social distancing is not possible.
 - Vaccinated participants are also welcome to wear masks in various situations according to their personal comfort level.
- A participant will not be allowed to attend in person if they are exhibiting any of the following symptoms:
 - Fever (>100.4 F) or chills
 - Cough
 - Shortness of breath or difficulty breathing
 - Fatigue
 - Muscle or body aches
 - Headache
 - New loss of taste or smell
 - Sore throat
 - Congestion or runny nose
 - Nausea or vomiting
 - Diarrhea
- **Please note:** If a participant exhibits any of the above symptoms during the SST, the parents/guardians will be notified immediately and asked to make arrangements to pick up their child as soon as possible and within 24 hours. Serving ones will also be asked to leave within 24 hours.

- Please be prepared to cooperate with subsequent testing according to local and state contact tracing guidelines.
- Please follow the CDC [guidance for travelers](#) before camp arrival to reduce exposure to COVID-19

Upon arrival to camp

- Every participant will be required to:
 - Complete a health questionnaire
 - Complete a temperature check, and health screening for symptoms
 - If any symptoms mentioned above are present, participants will not be allowed to stay

During the SST

- Every participant will undergo daily temperature screening
- Every participant should have well-fitting cloth masks with two or more layers of tightly woven, breathable fabric, or disposable masks while indoors. Masks should be non-distracting, and if patterned, should follow the dress code.
 - Outdoors: In general, participants do not need to wear masks when outdoors except during activities that involve sustained close contact with others.
 - All participants will be grouped by Townhouses for their housing, mealtimes, recreation, and meetings
- Mealtimes
 - Participants will eat with their Townhouse groups at assigned tables and will be socially distanced from the other groups.
 - Masks can be removed during meal times, however, masks must be worn when serving food, transferring food, or going through the food line.
- Housing
 - Beds are appropriately spaced to maintain social distance while sleeping inside the Townhouses
 - It will be up to the discretion of each participant whether or not to wear a mask while in the Townhouse
 - It is recommended for everyone to wear masks during activities when social distancing is not possible, such as loud singing
- Meetings
 - Participants will be seated according to Townhouse groups and socially distanced during the meeting

If a participant begins to exhibit any of the following symptoms, they MUST notify the First Aid Office IMMEDIATELY

- Fever (>100.4 F) or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell

- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea
- After examination, the First Aid Office will make an assessment and notify the parents/guardians.
 - If needed, the Medical team will arrange for the participant to leave the camp as soon as possible and within 24 hours.
 - Rapid tests will be available at KPCC and parents/guardians can give consent to have their child tested at KPCC
 - If the participant prefers to test off-site, they will be required to provide documentation of results to the First Aid Office
- Any participants in the same Townhouse group as the participant with symptoms will be quarantined until we receive the COVID-19 test results
 - If the COVID-19 test results are positive, the unvaccinated participants in the Townhouse group will need to be picked up by the parents/guardians within 24 hours.
 - Vaccinated participants will be allowed to remain.
- If the results are negative, we will continue to monitor for symptoms.
